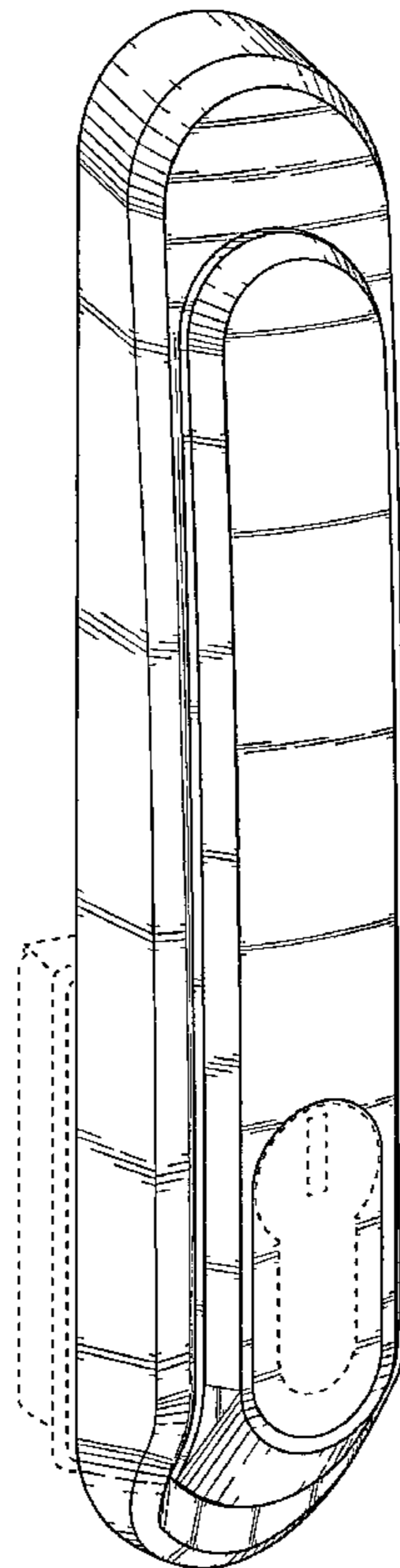
(57) **CLAIM**

The ornamental design for a lock assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a lock assembly showing my new design;  
FIG. 2 is a left side view of the lock assembly of FIG. 1;

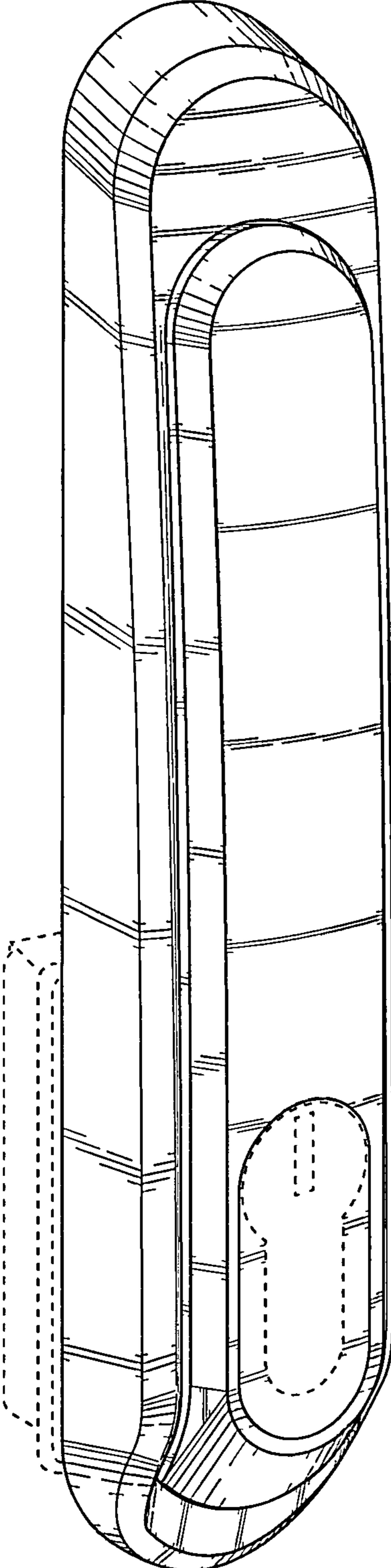

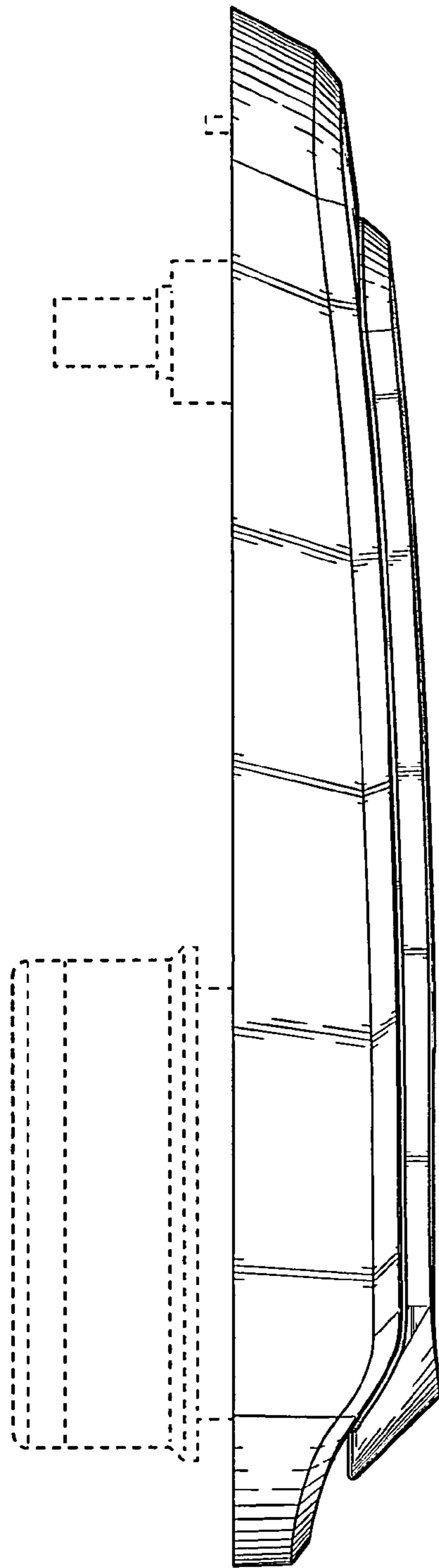

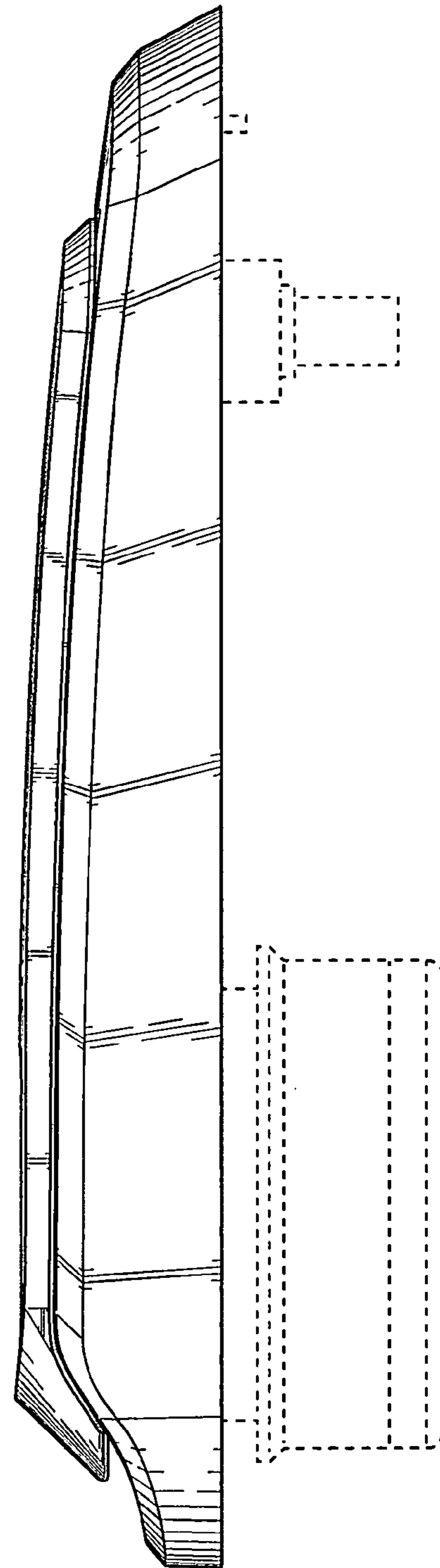

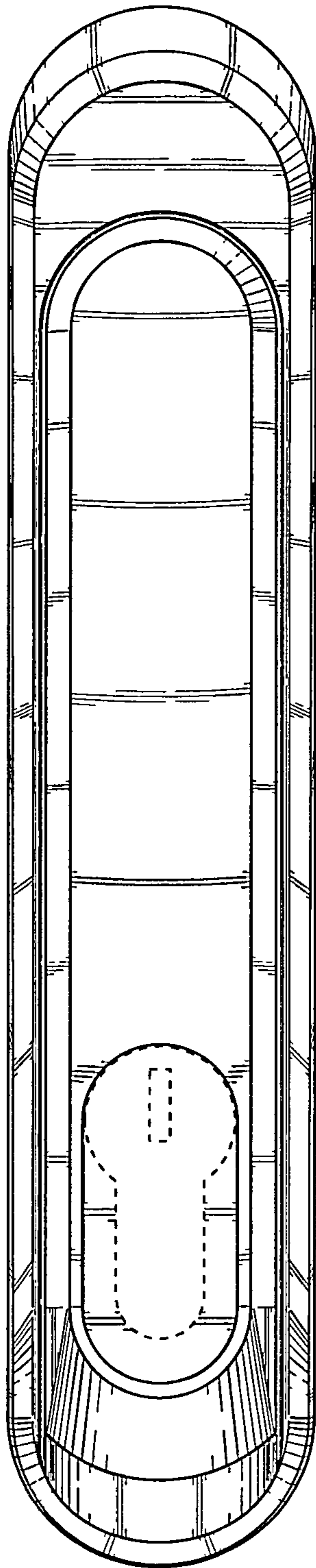

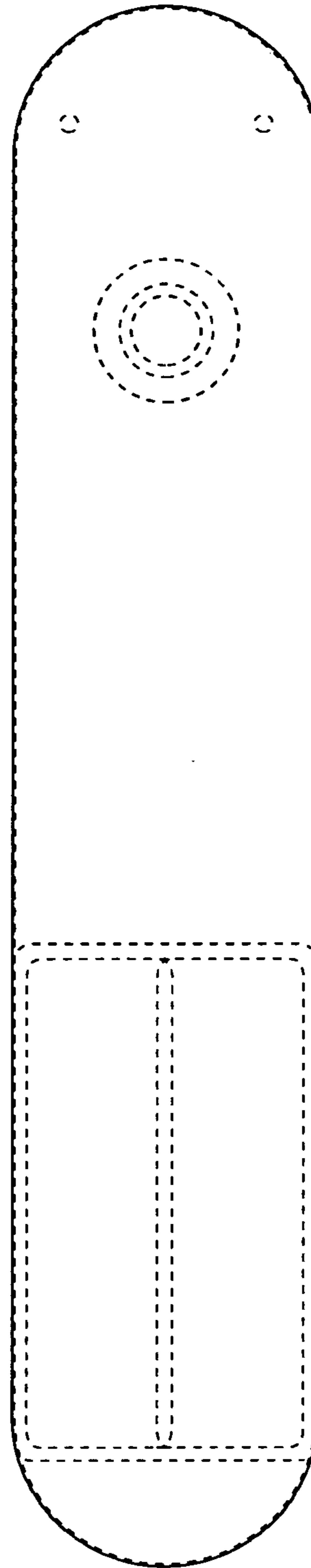

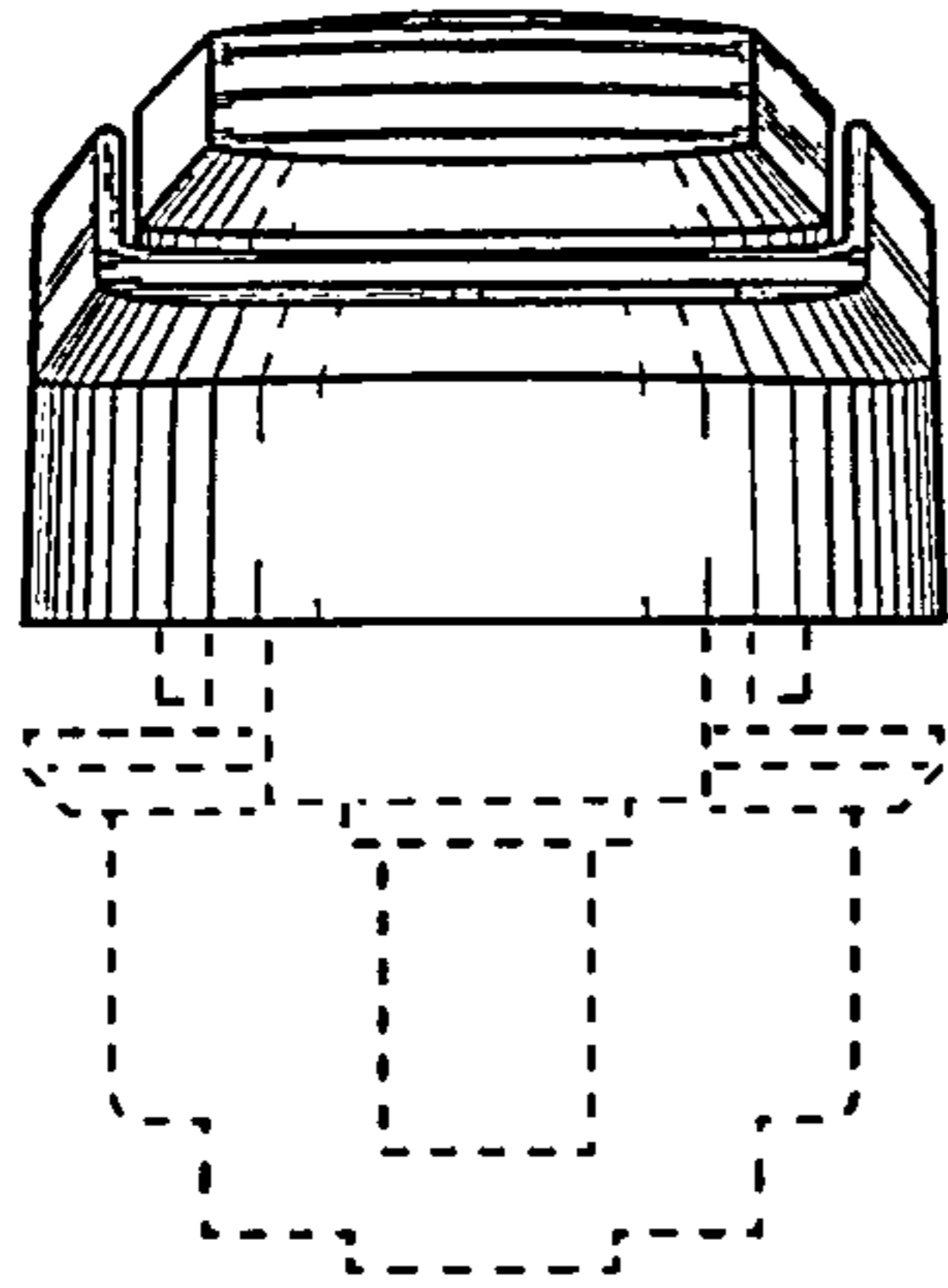

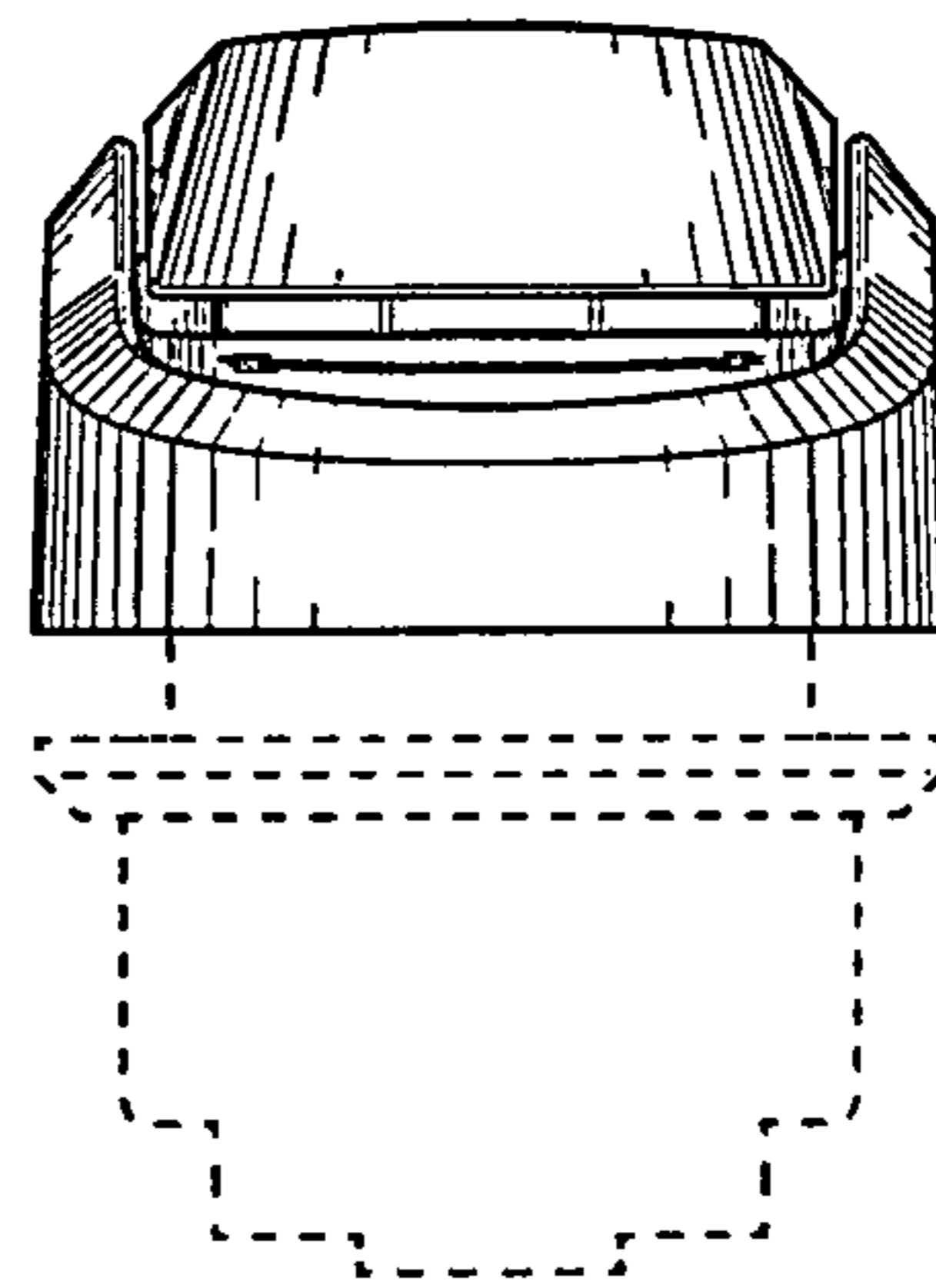
