FIG. 2 is a left side elevation view thereof;

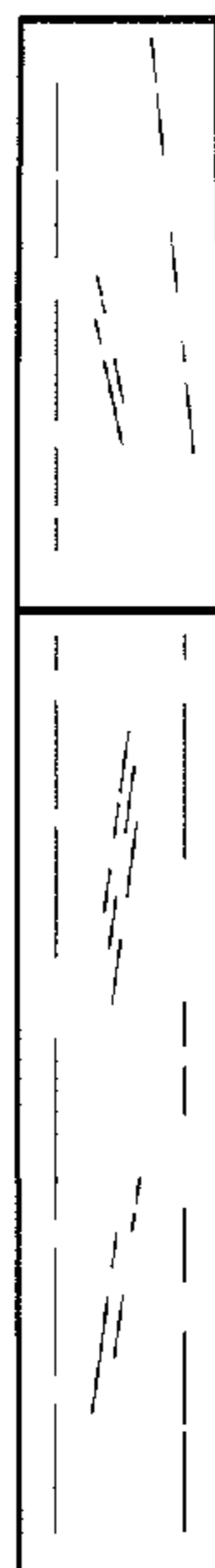
FIG. 3 is a right side elevation view thereof;

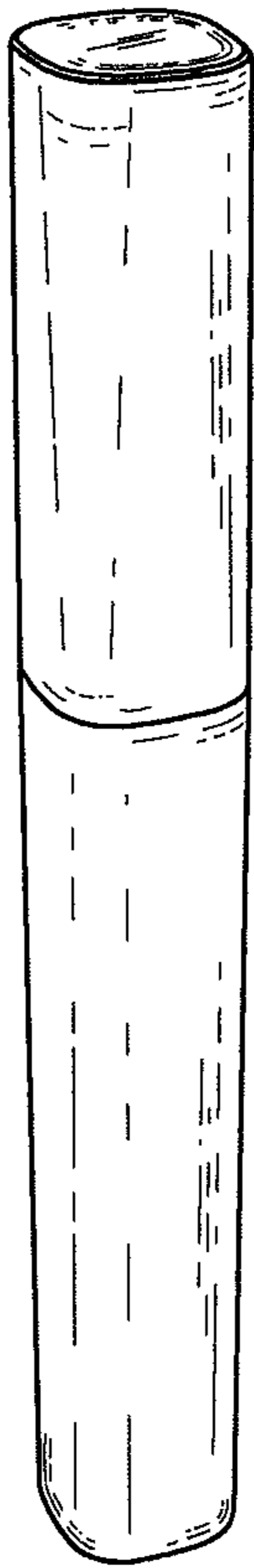

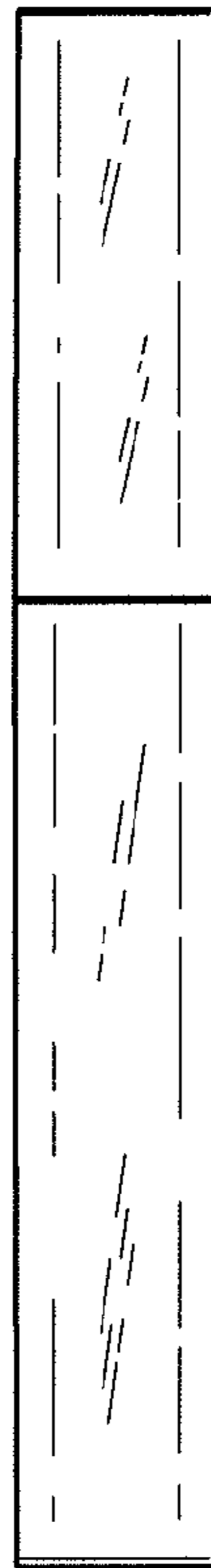
