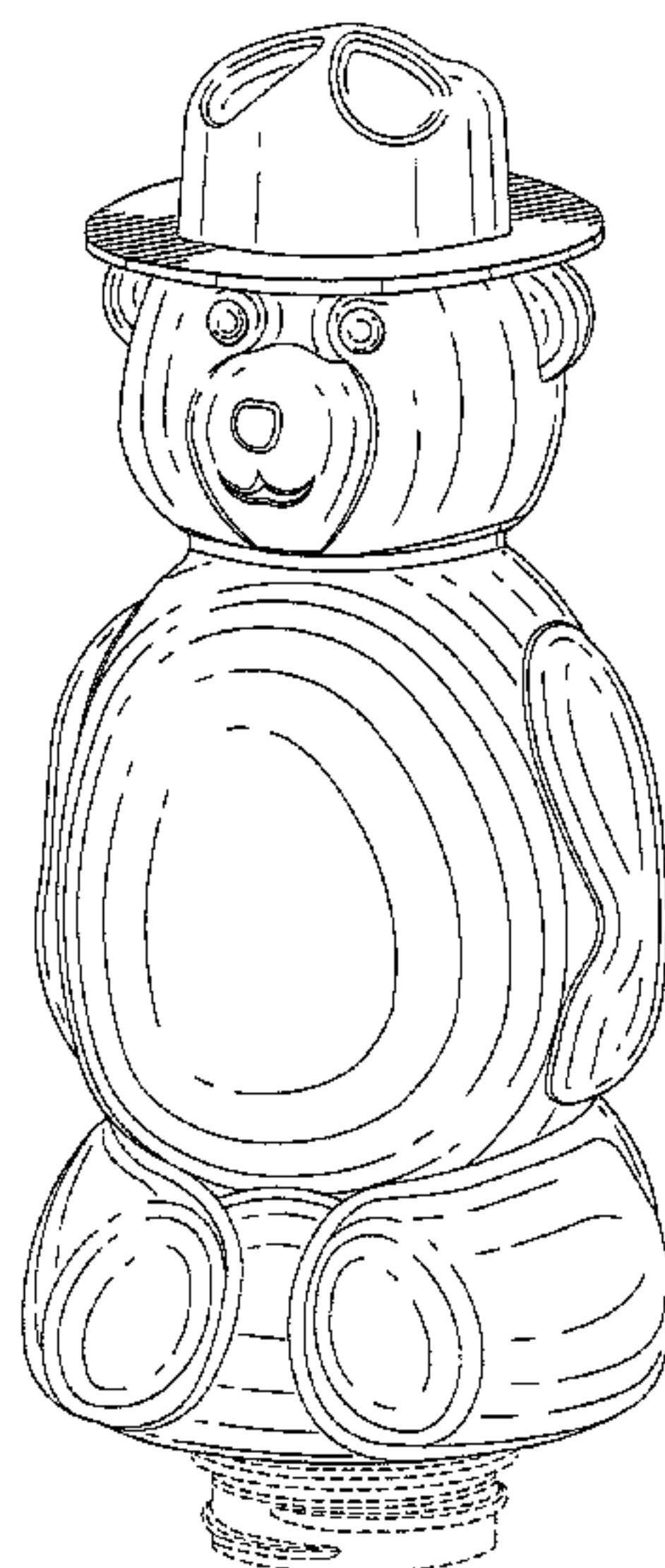
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a design of a bear-shaped bottle with hat as claimed herein;  
FIG. 2 is a front elevation view thereof;

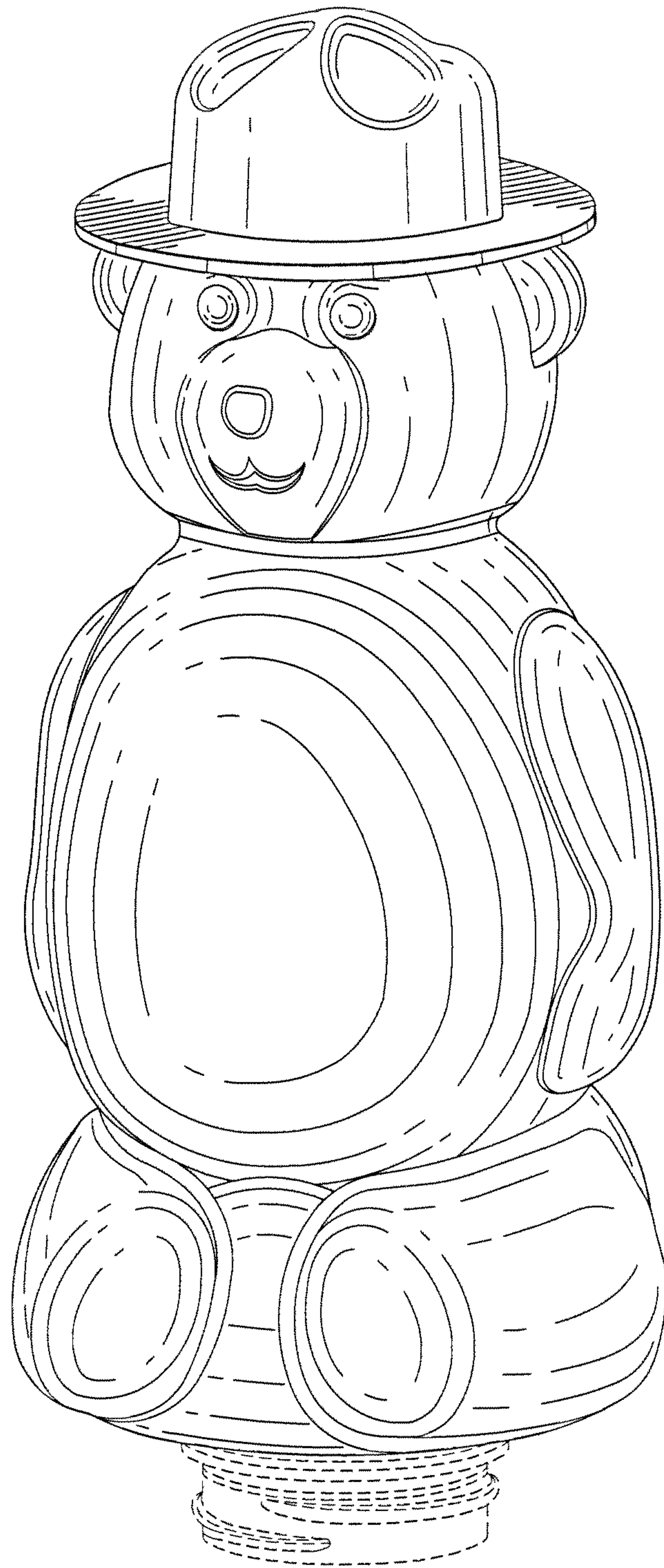

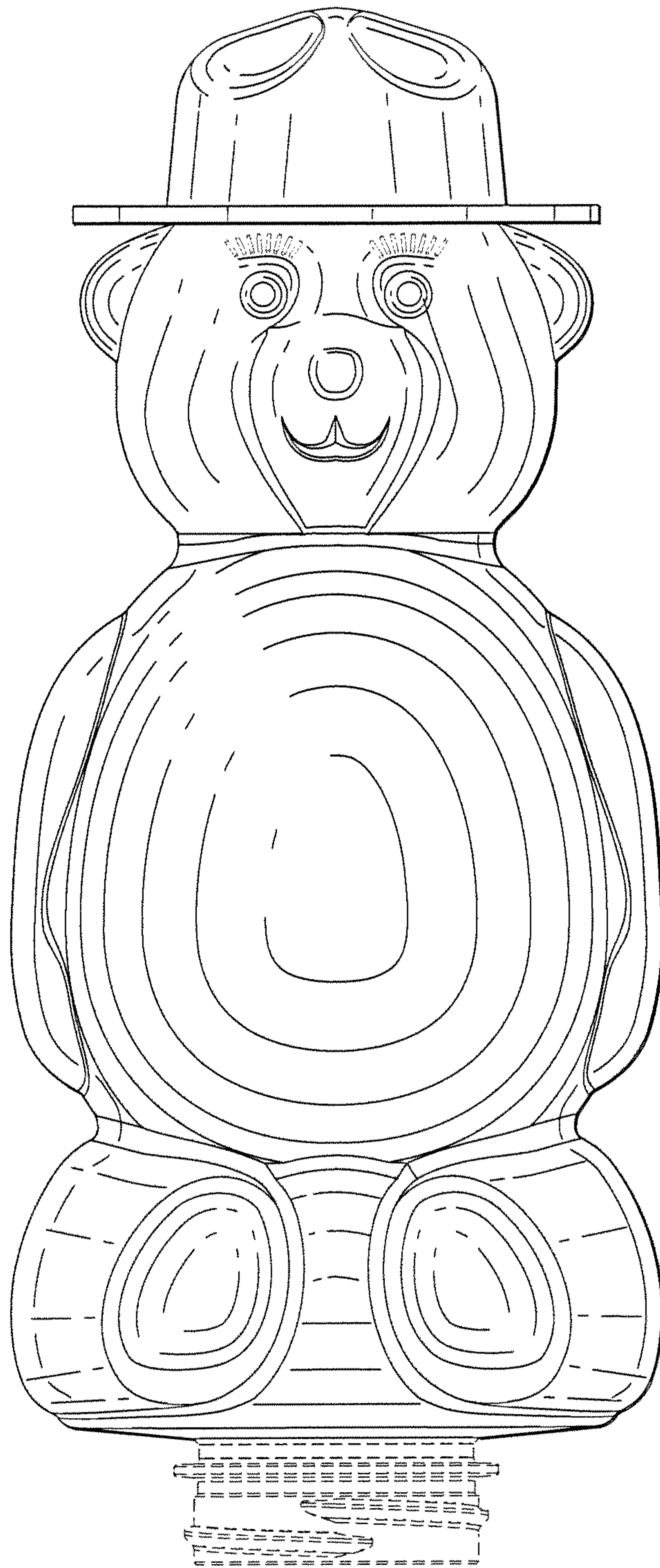

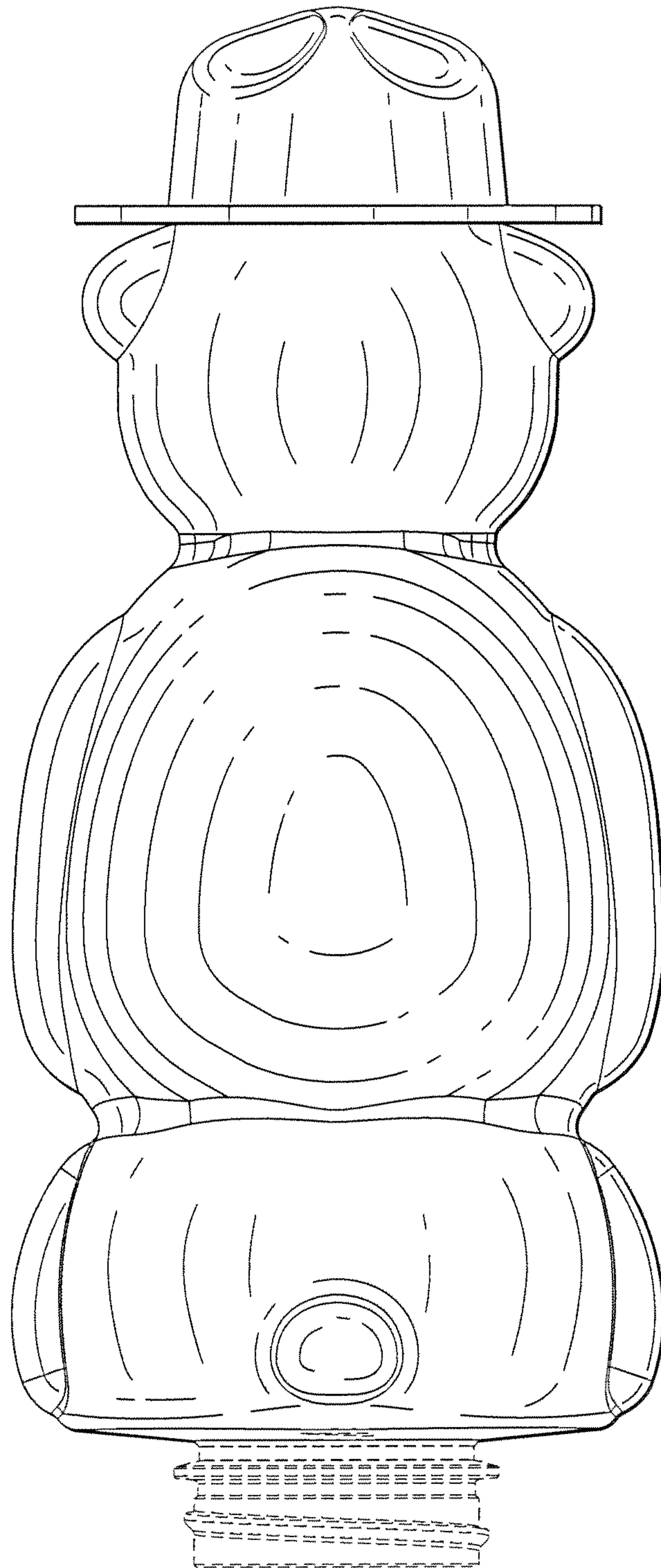

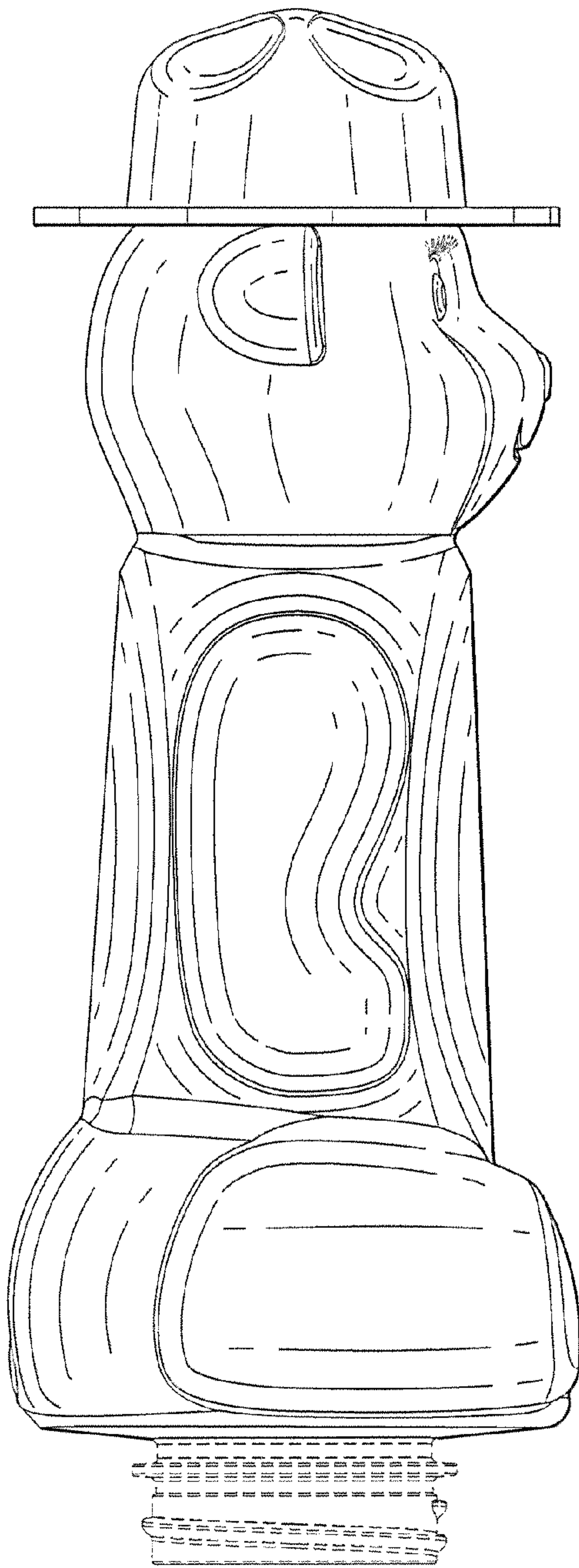

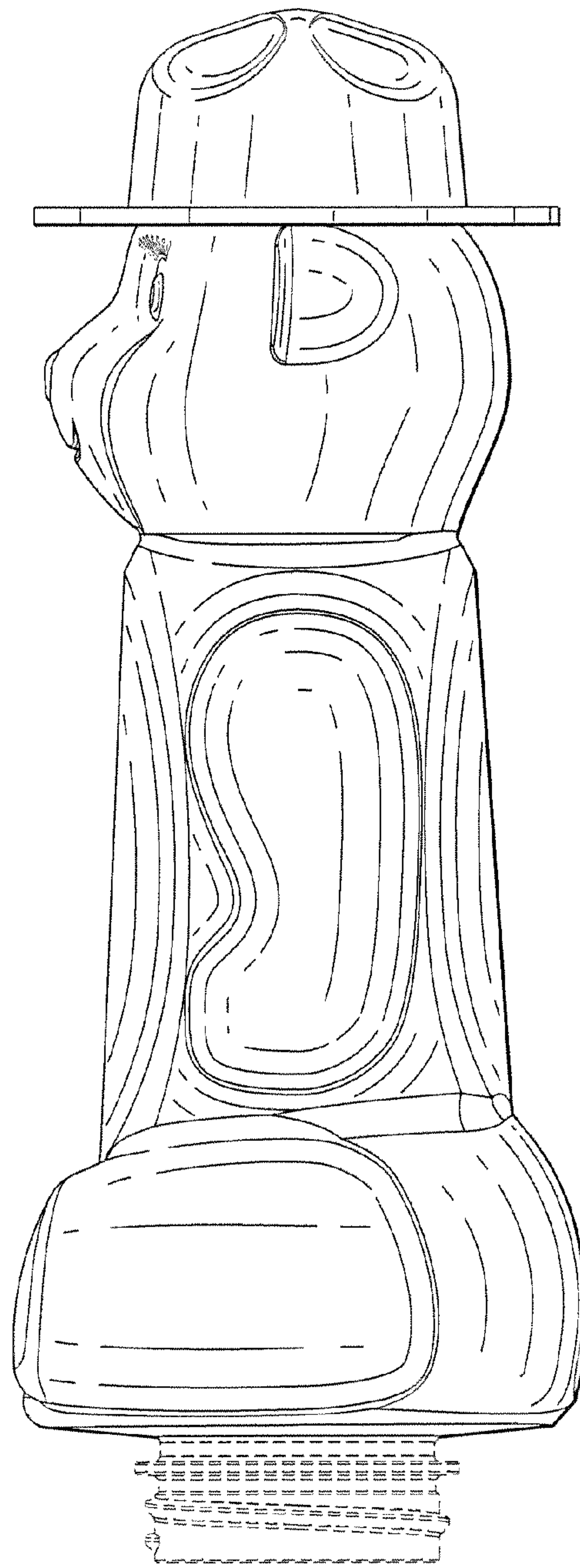

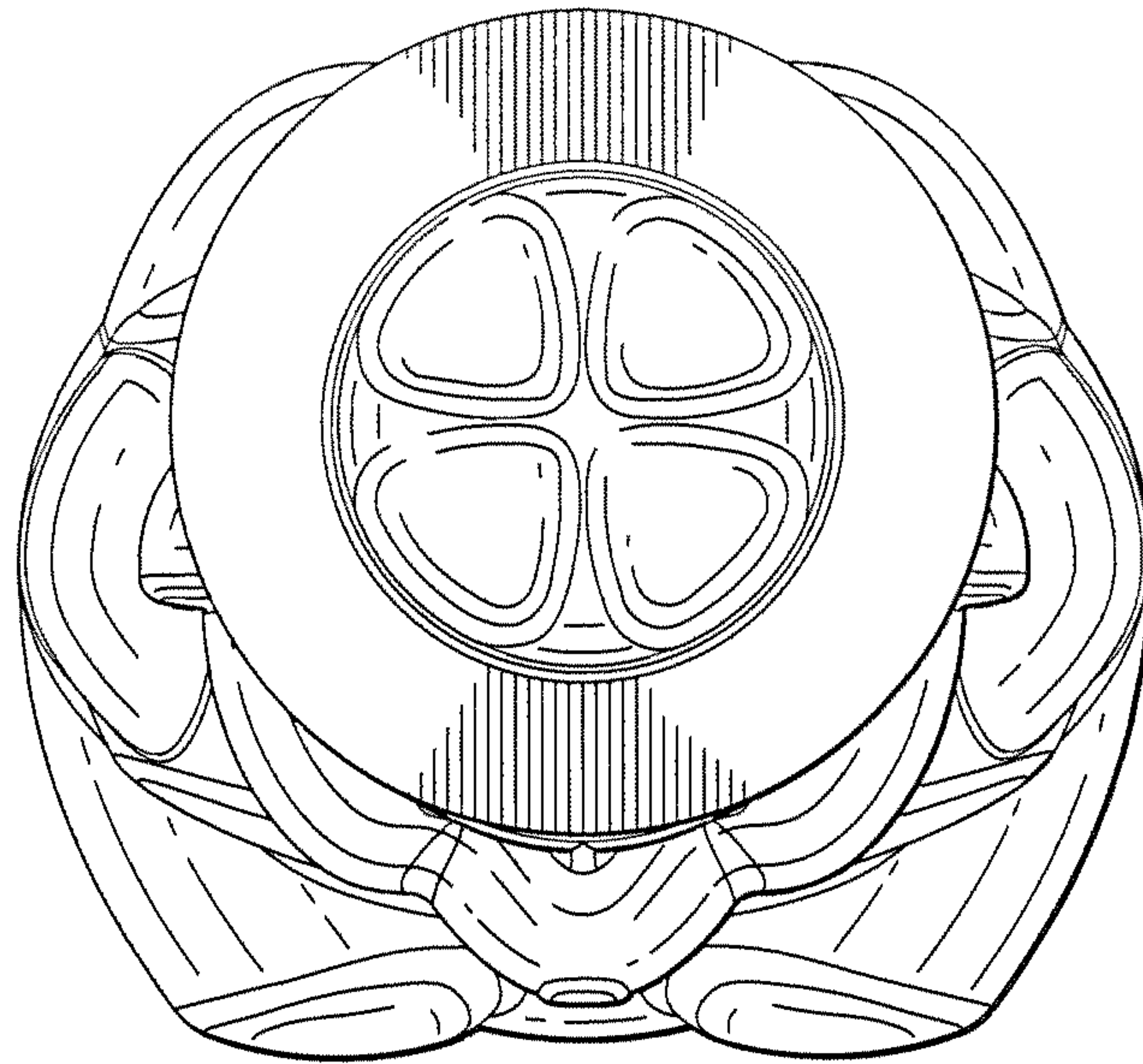

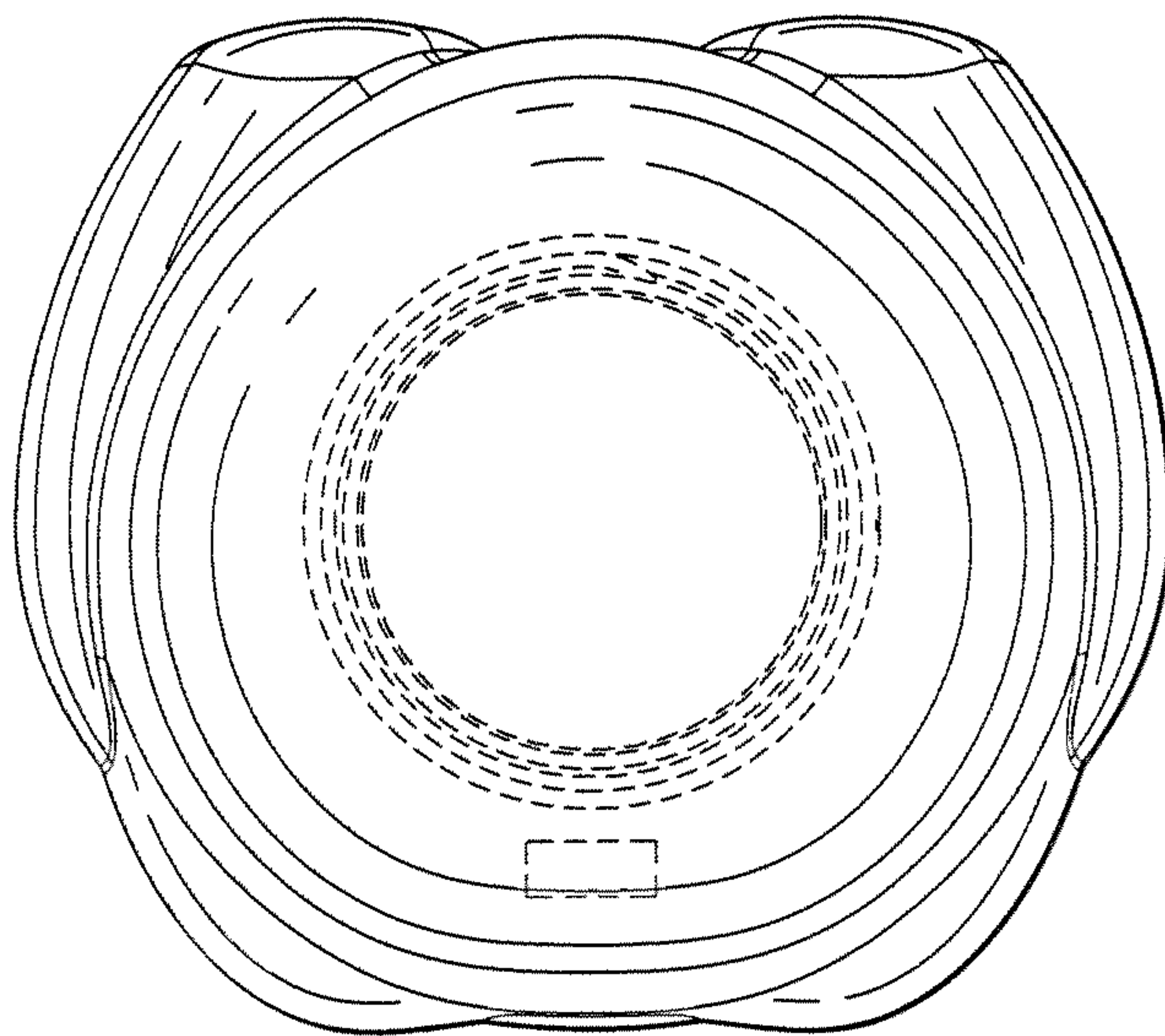
