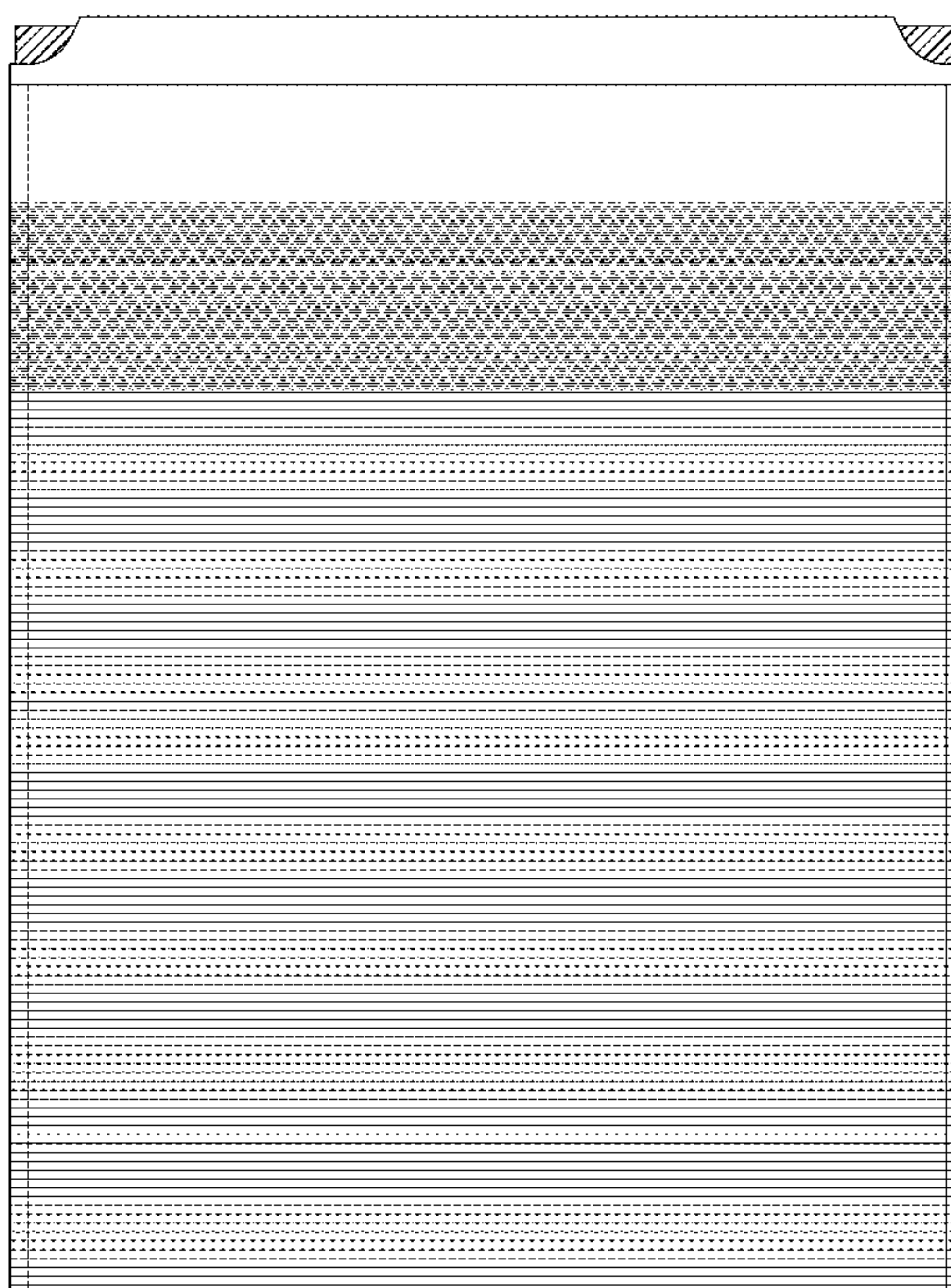

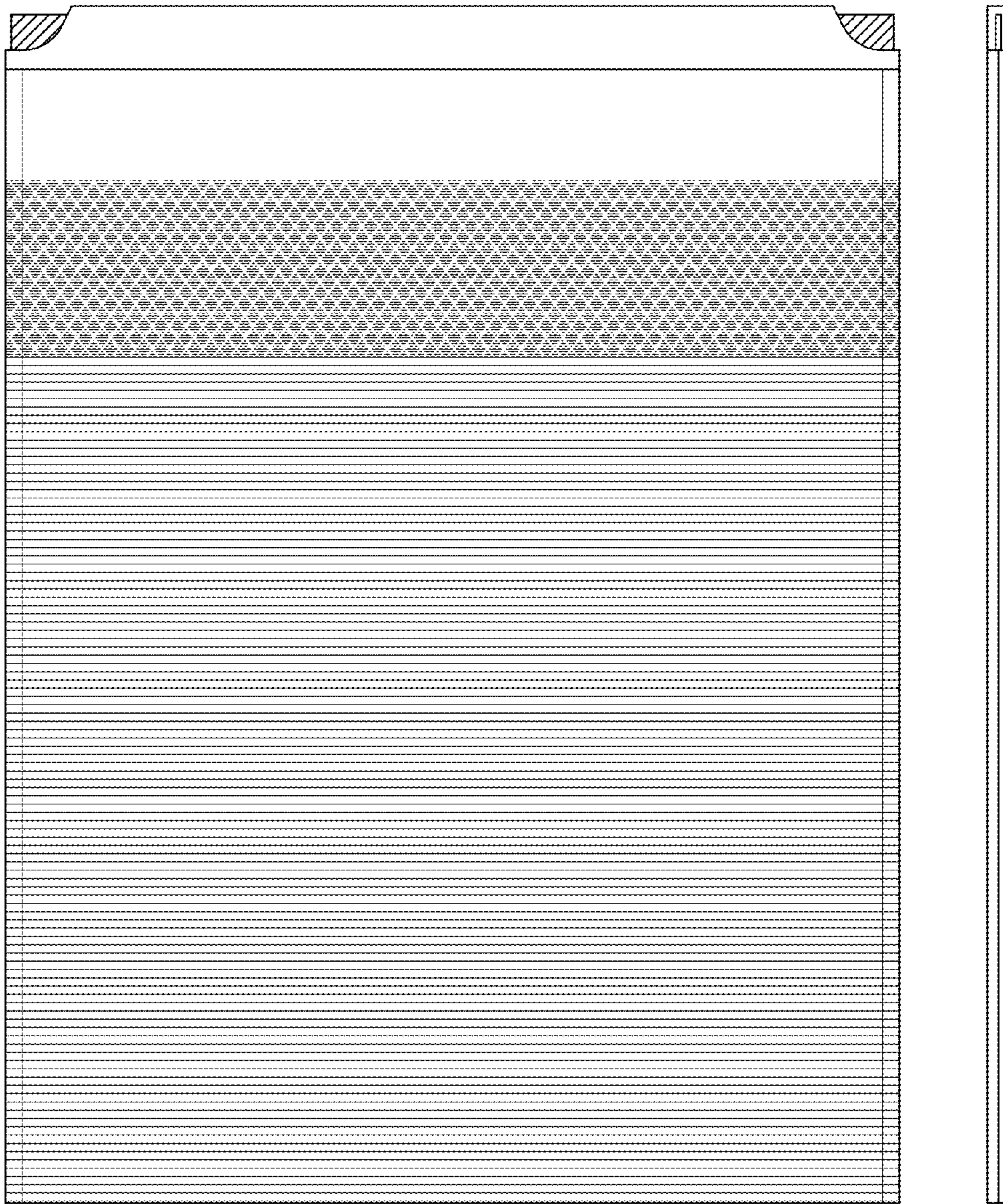
The ornamental design for a trash bag, as shown and

The broken lines shown form no part of the claimed design.

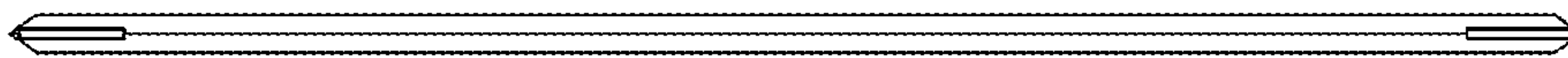

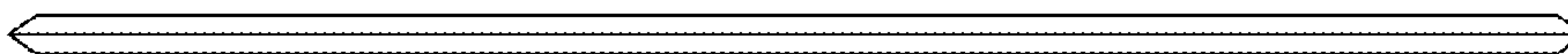
