DESCRIPTION

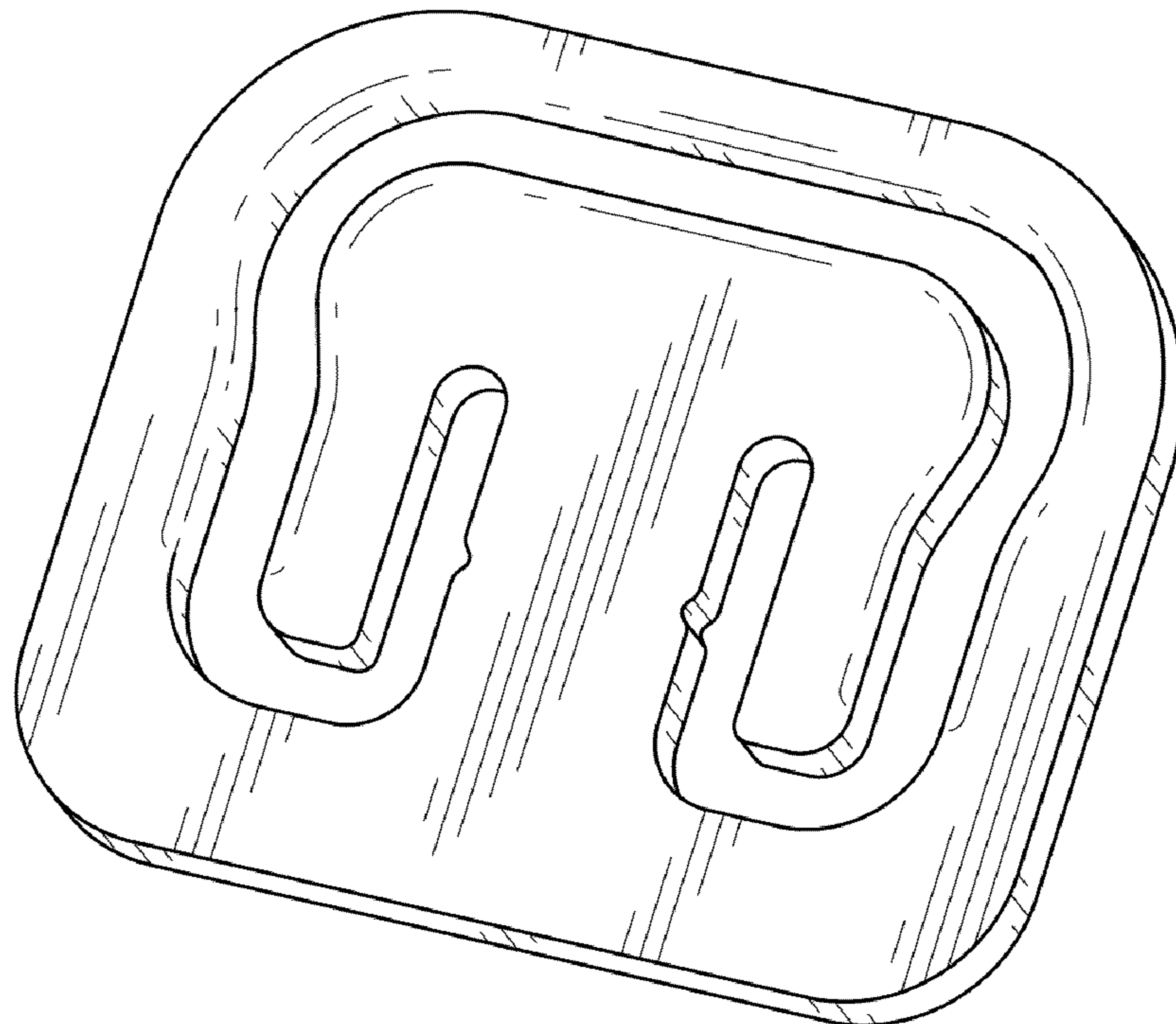
FIG. 1 is a perspective view of a load cell for a scale according to an embodiment of the invention;

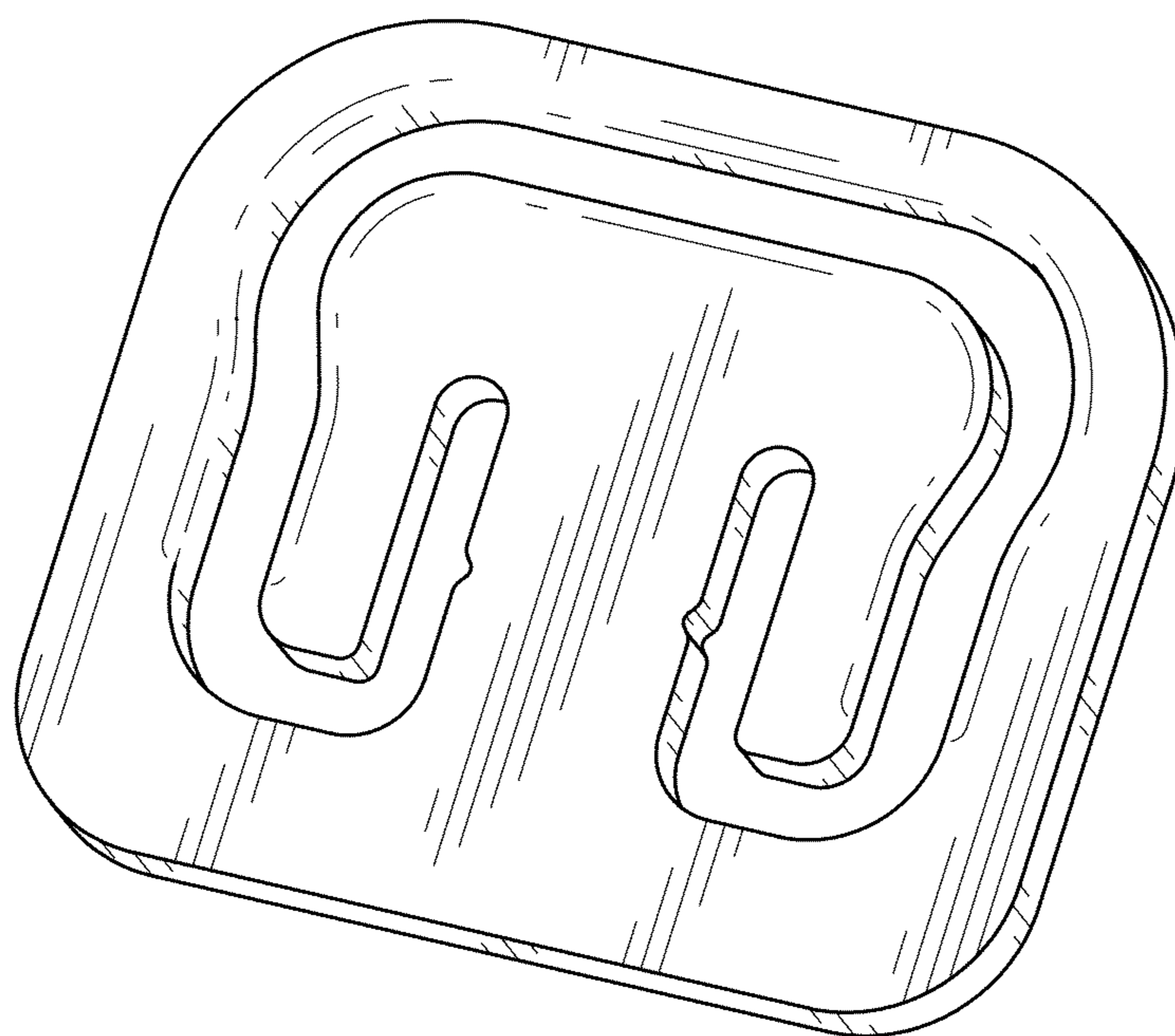

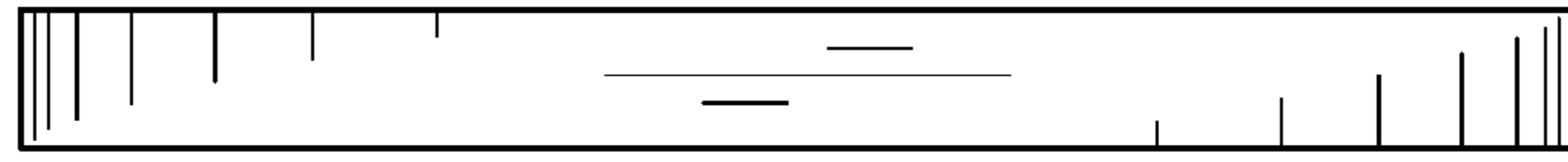

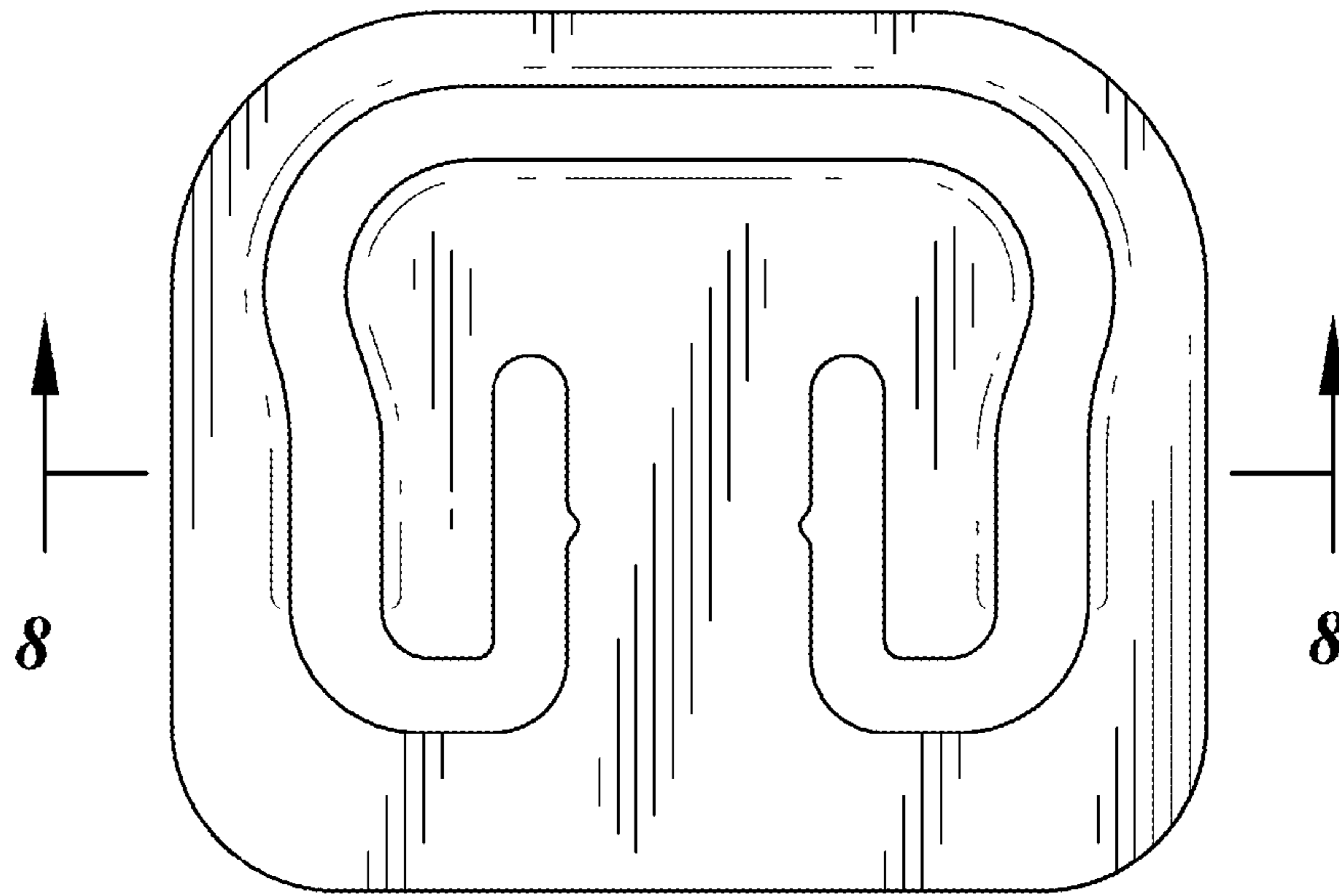

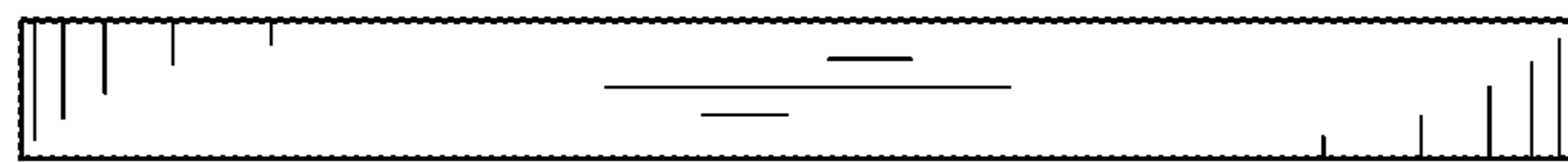

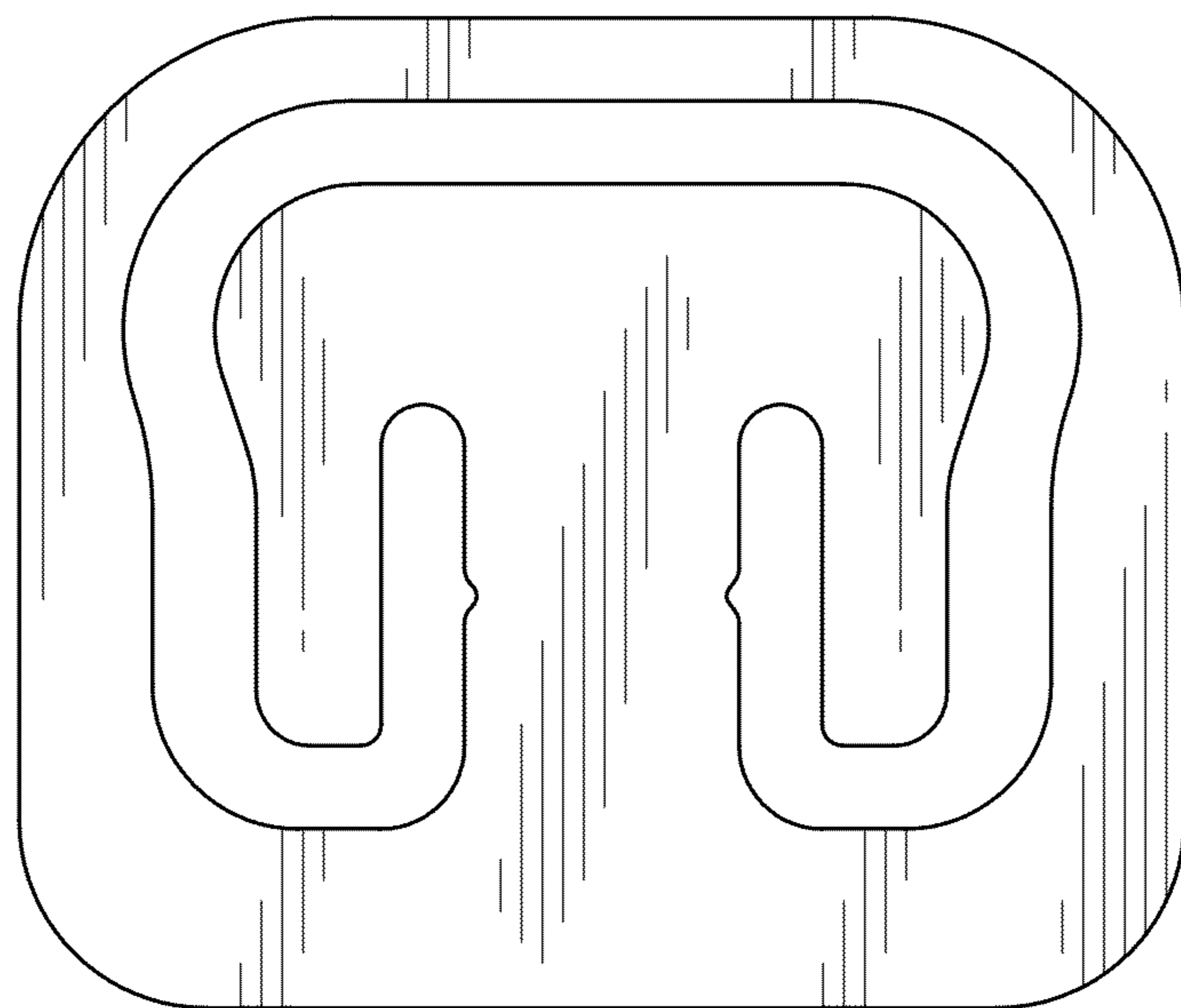

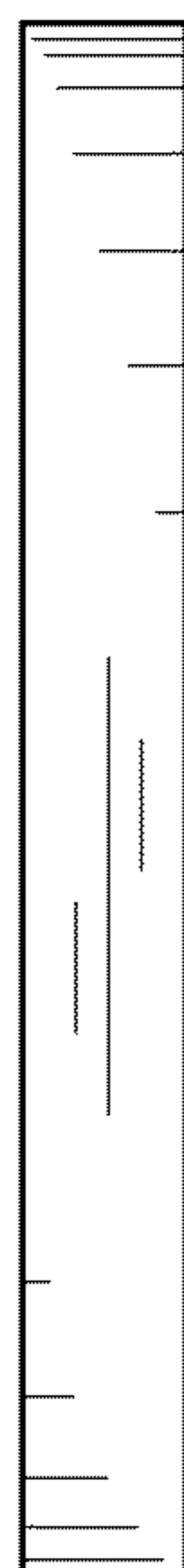

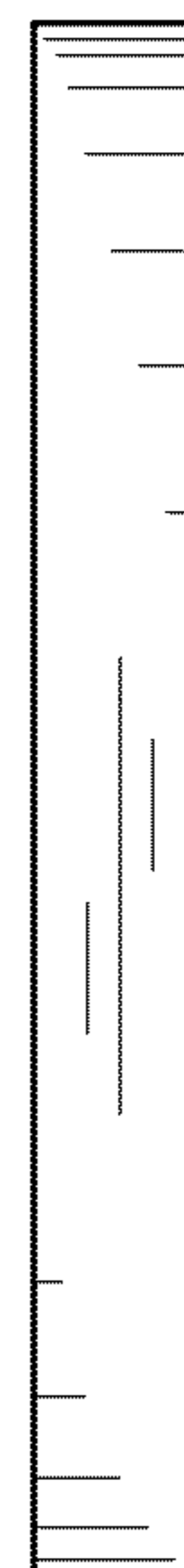
