(57) **CLAIM**

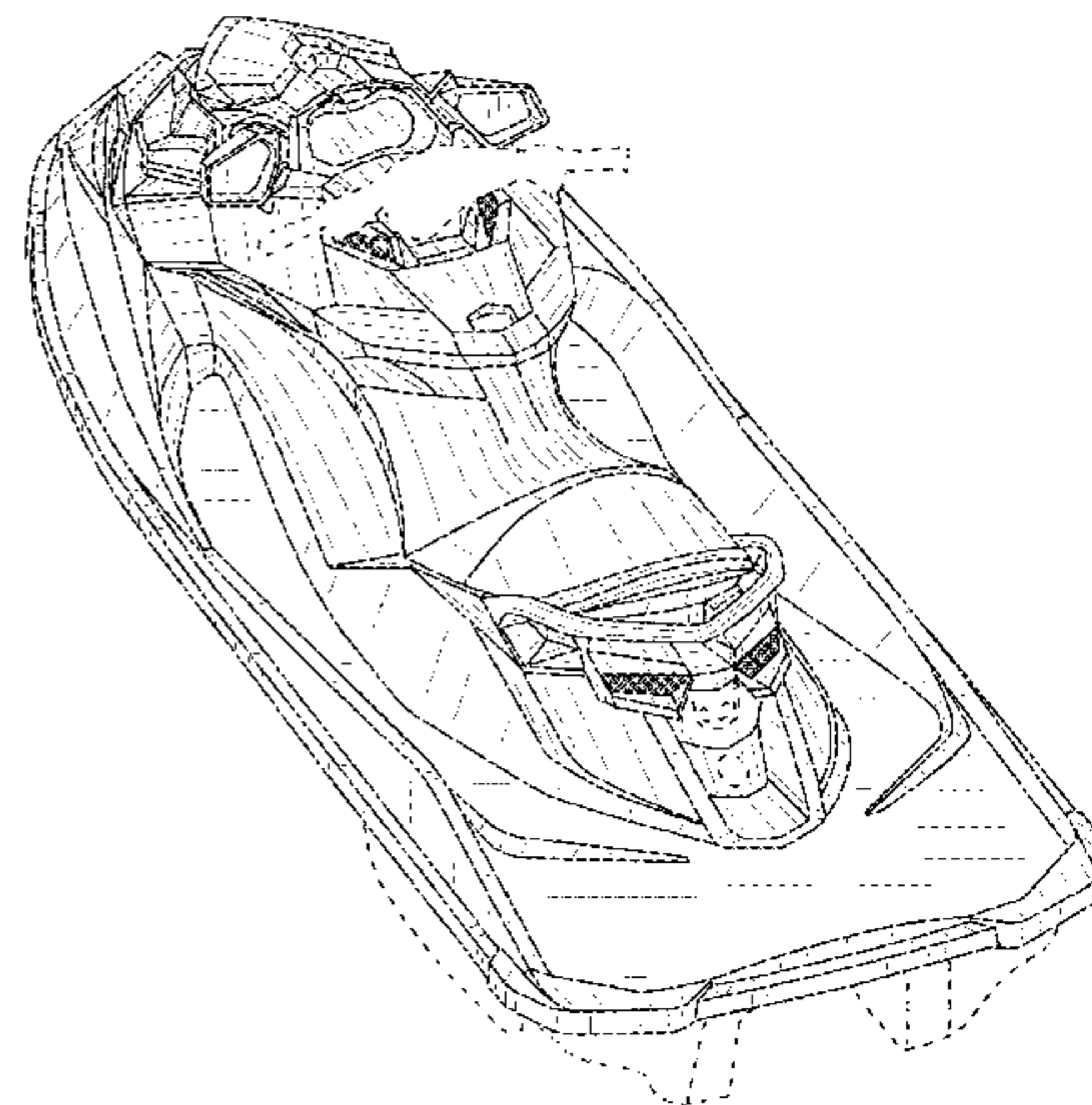
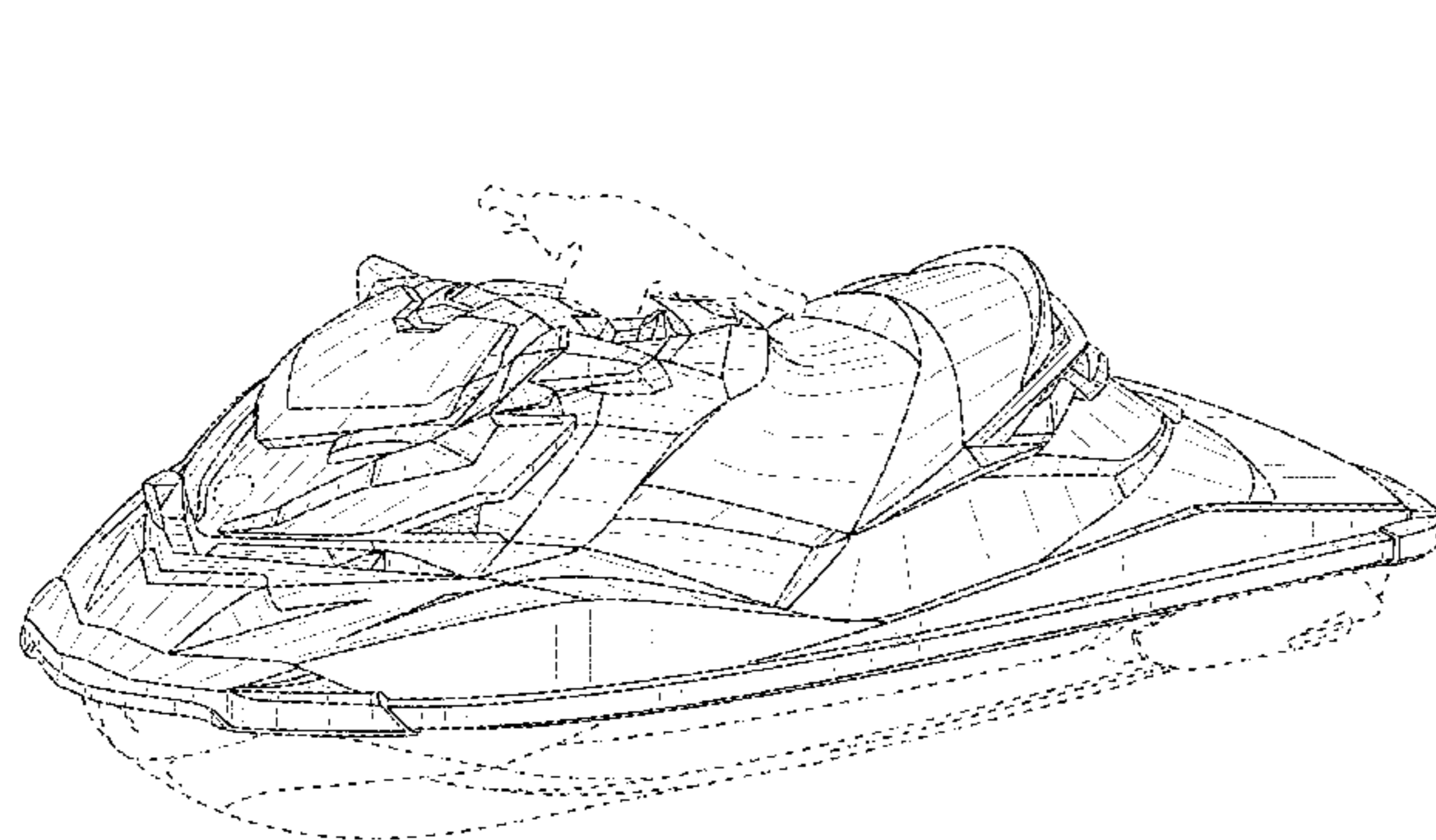
The ornamental design for a personal watercraft, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from a front, left side of a personal watercraft according to our design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom elevation view thereof; FIG. 8 is a perspective view taken from a rear, left side thereof; and, FIG. 9 is an enlarged portion of FIG. 6.

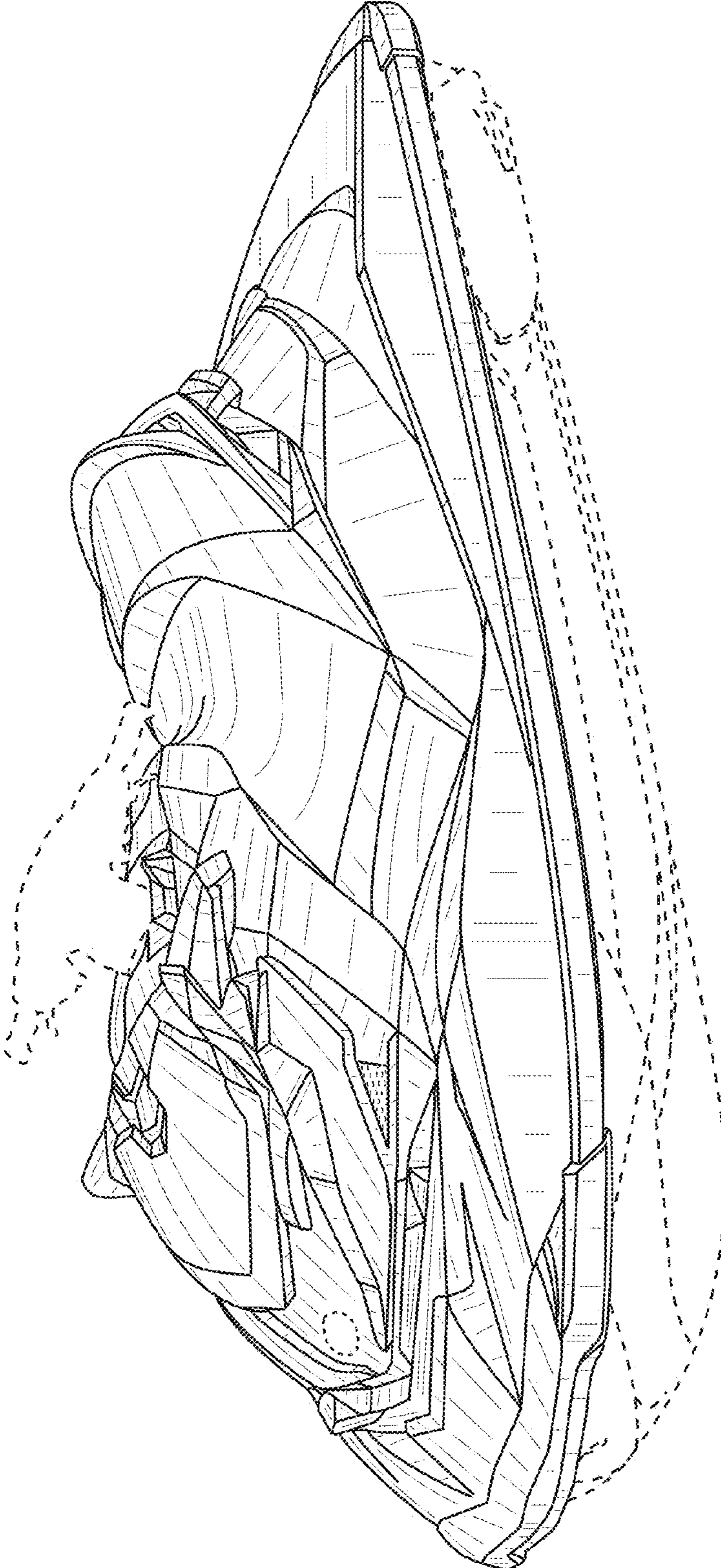

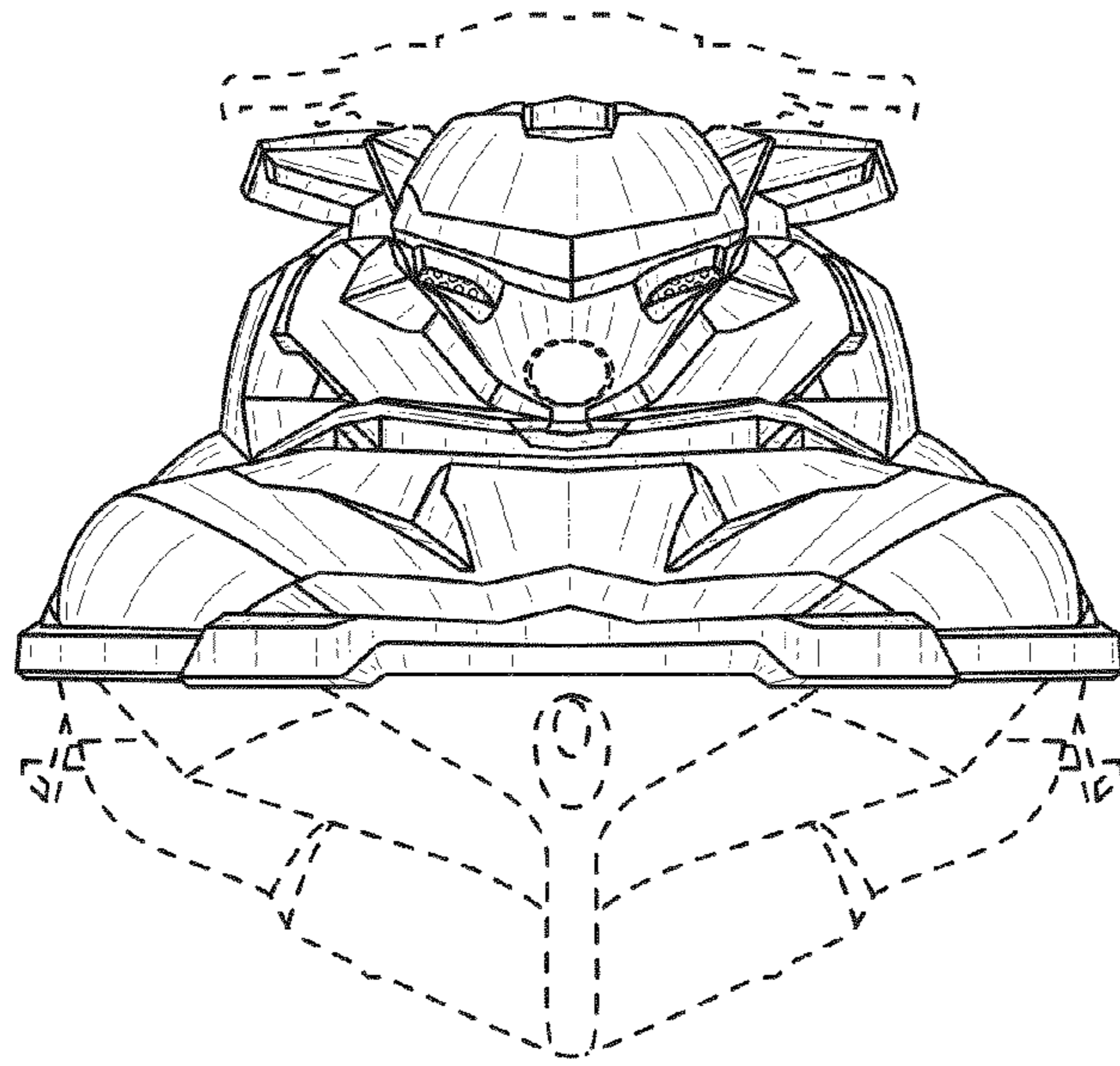

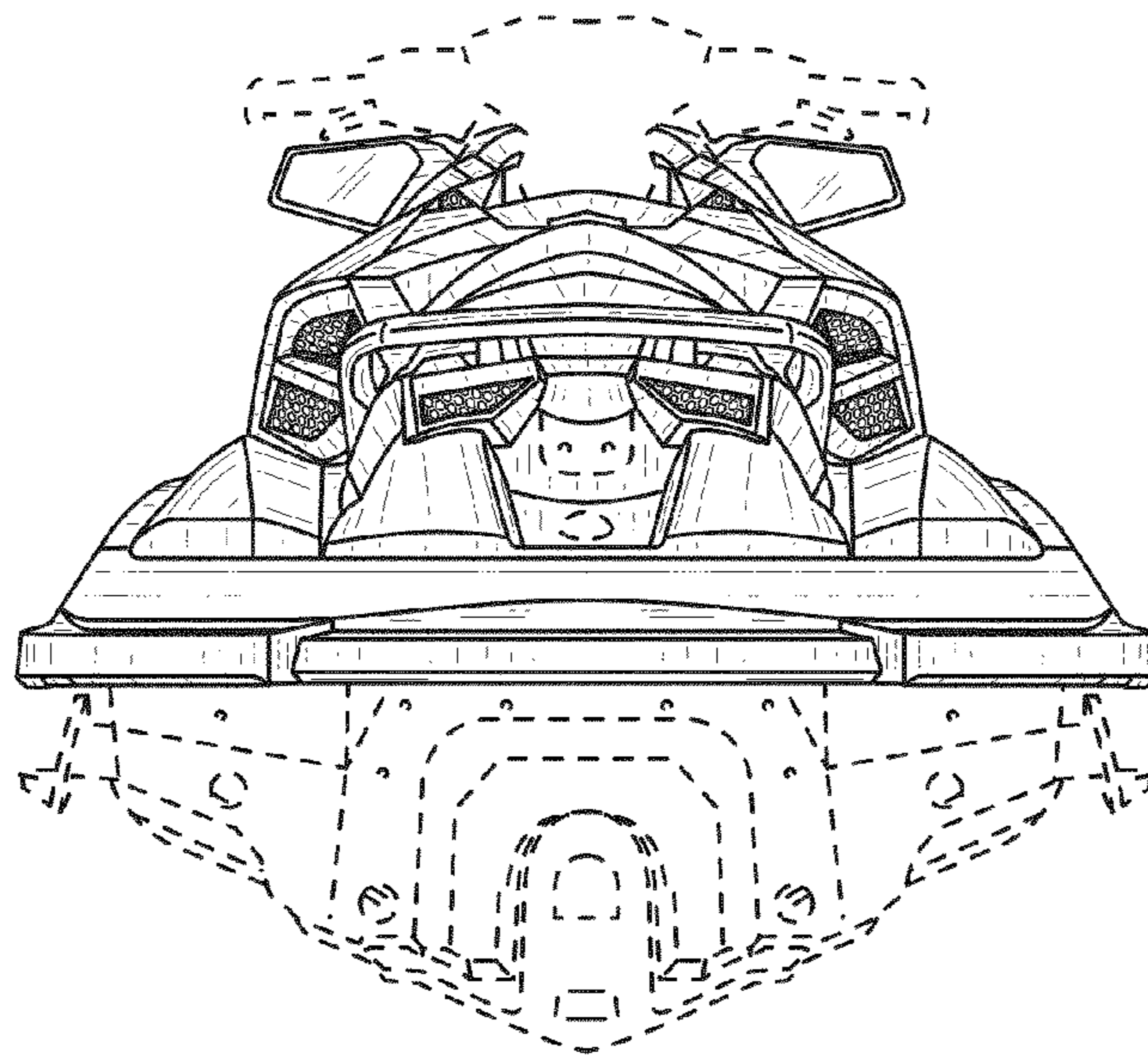

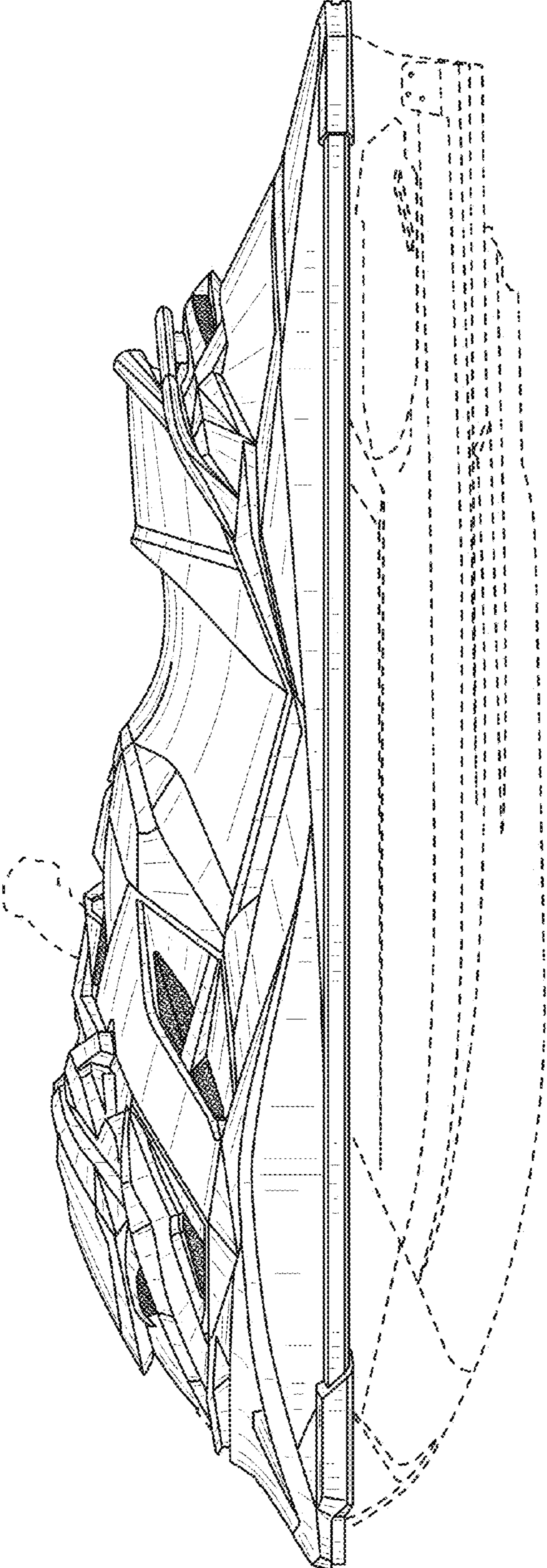

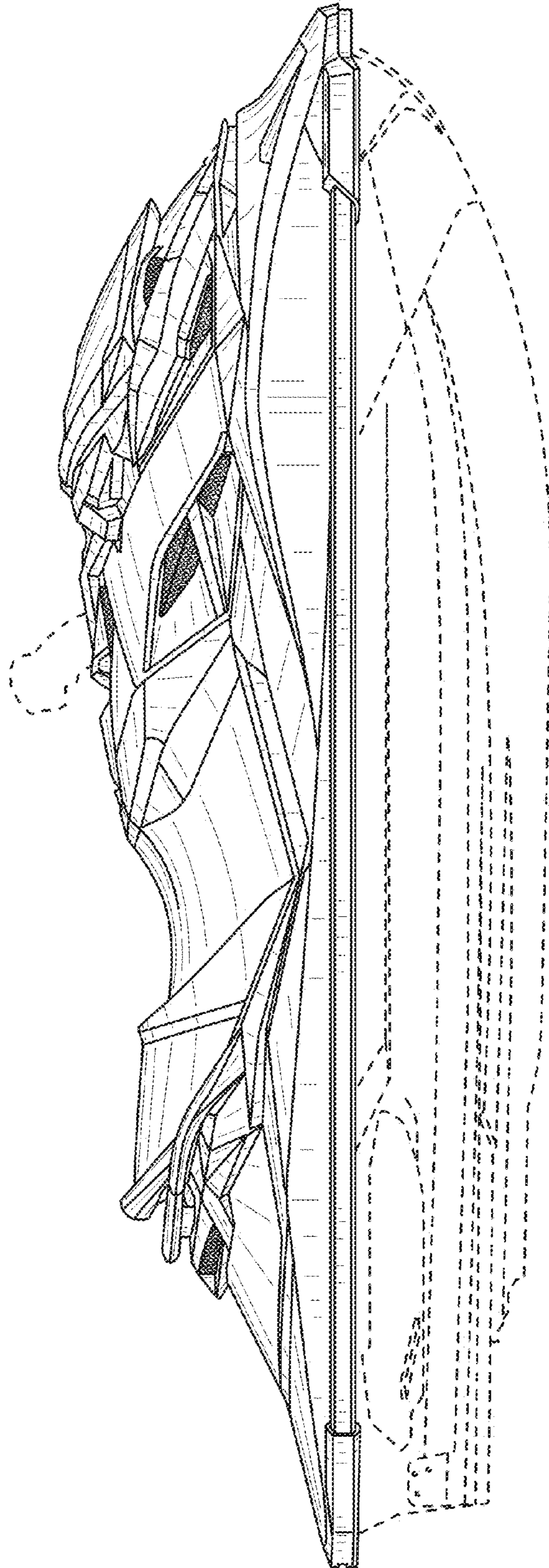

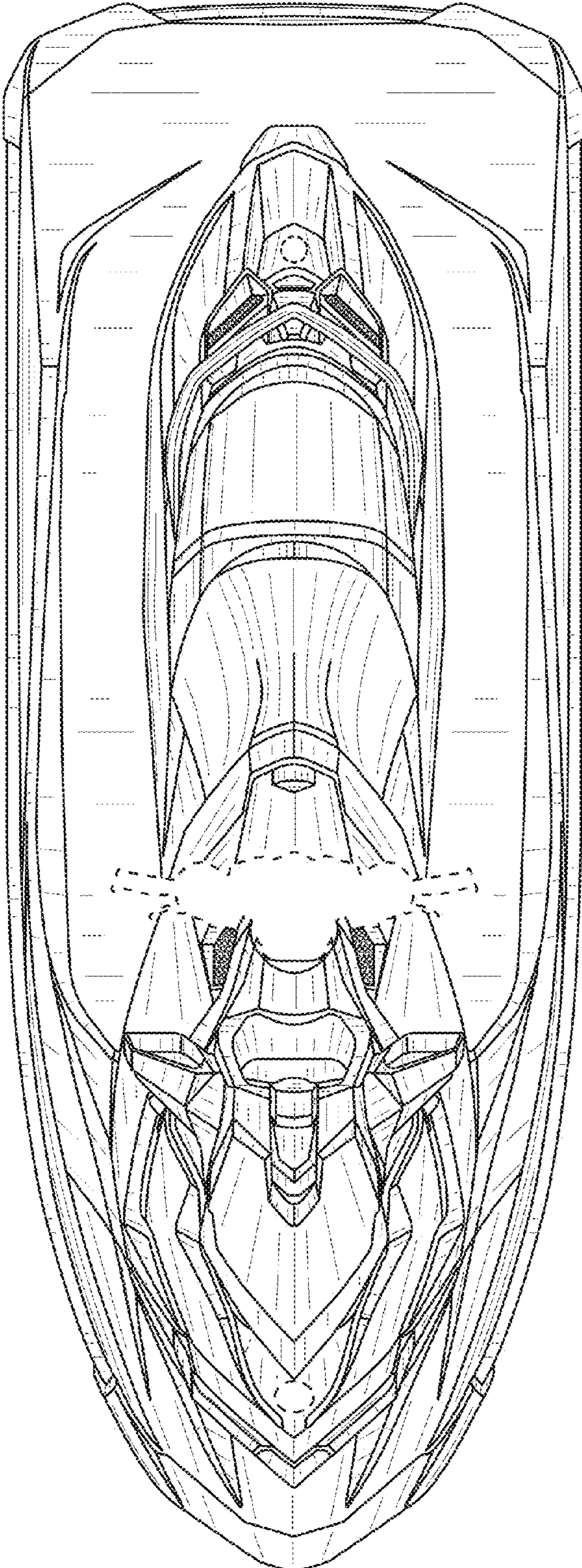

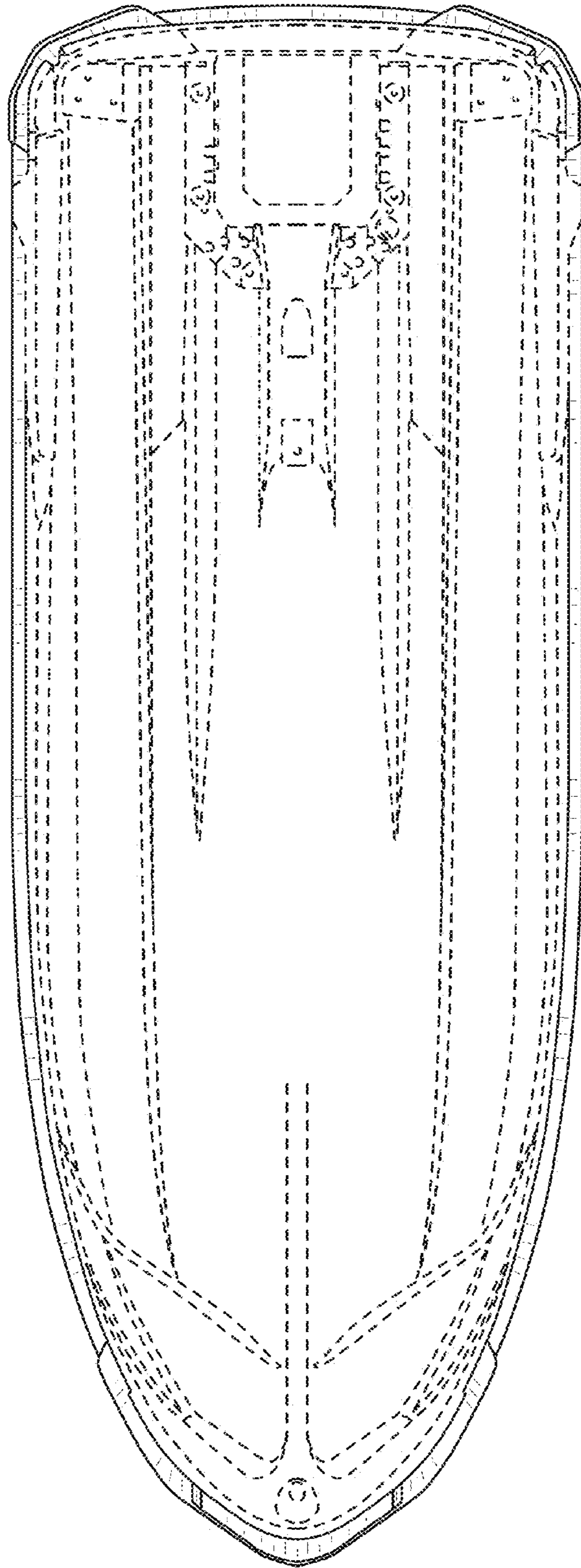

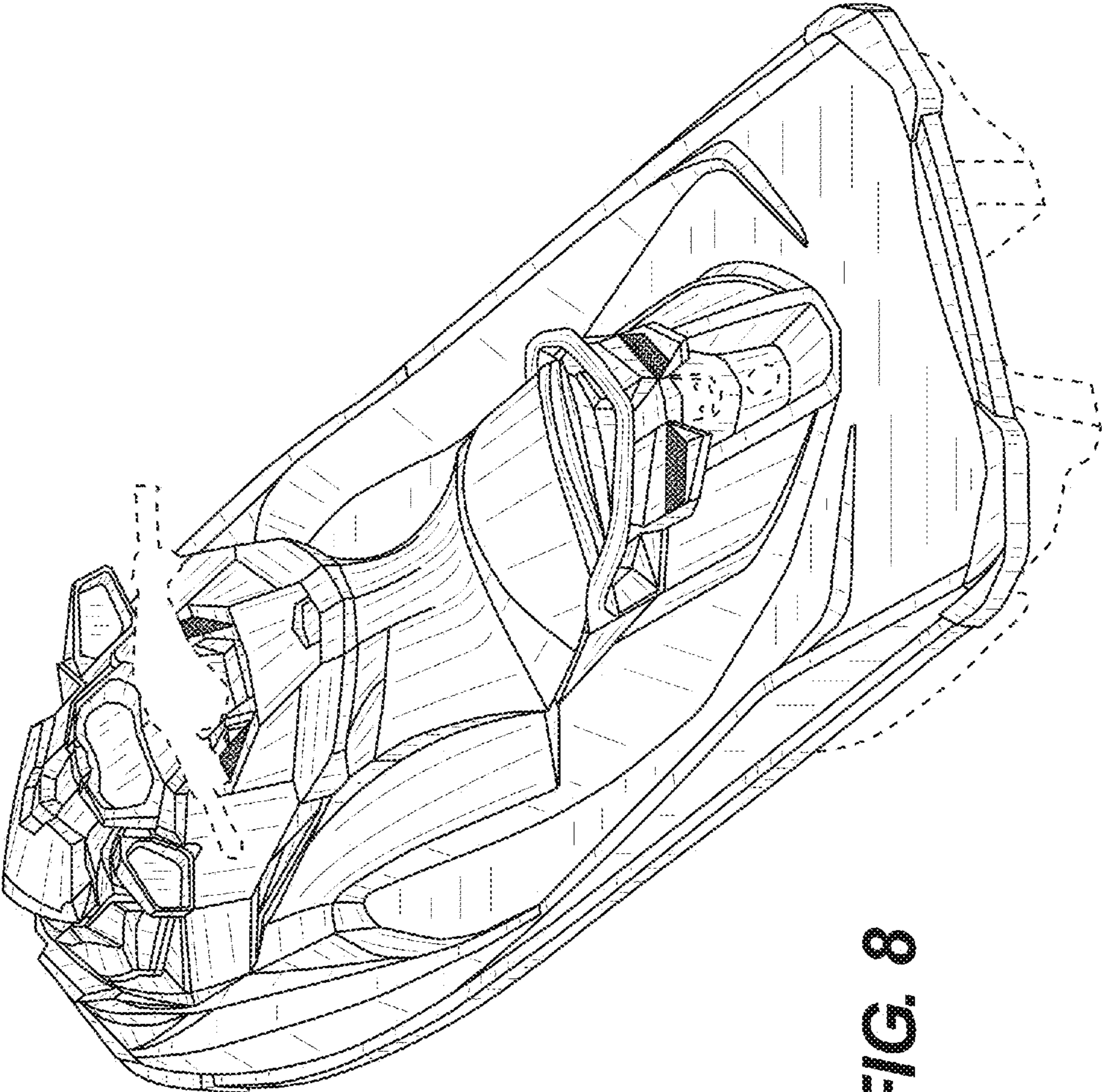

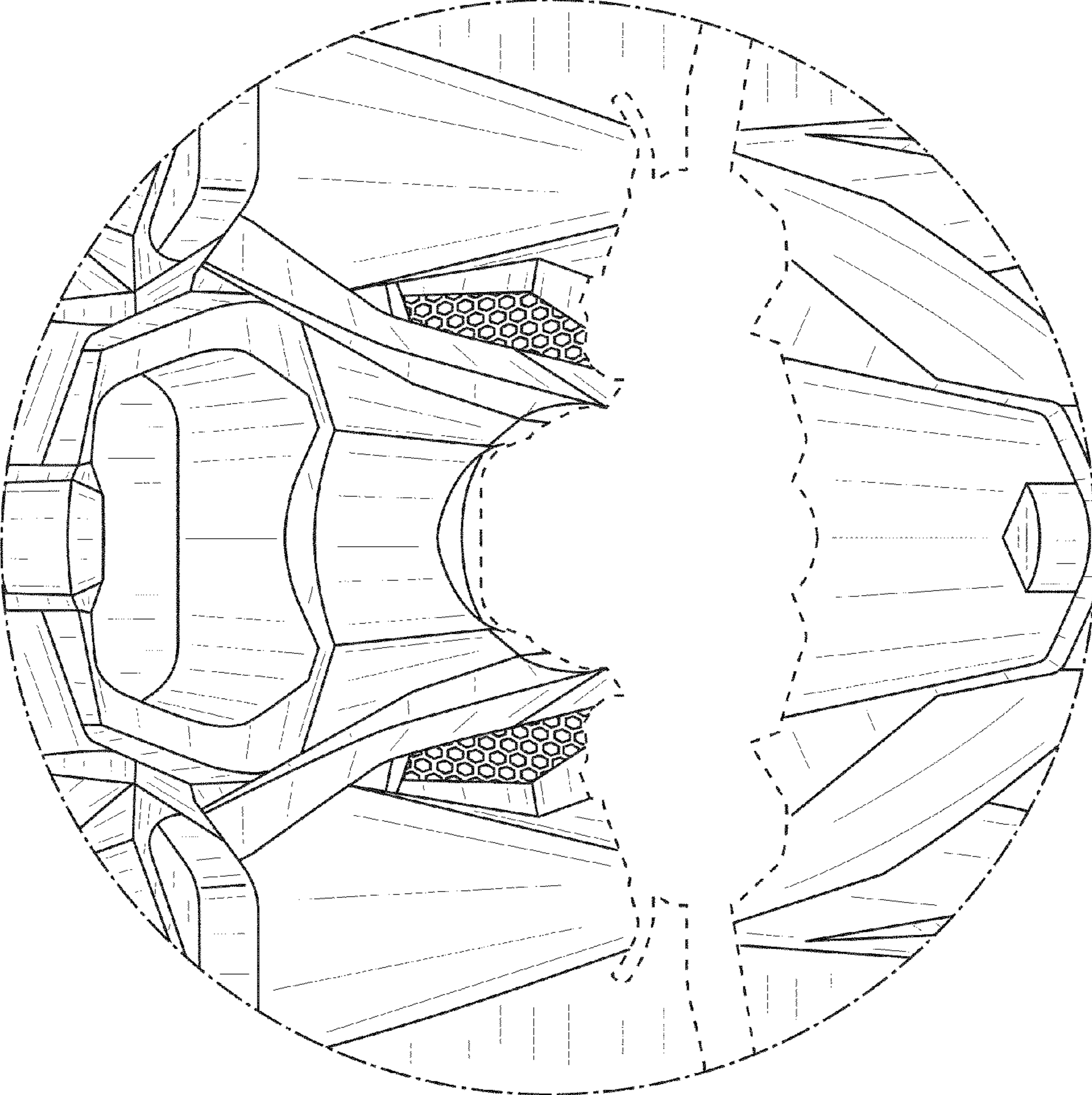
