**DESCRIPTION**

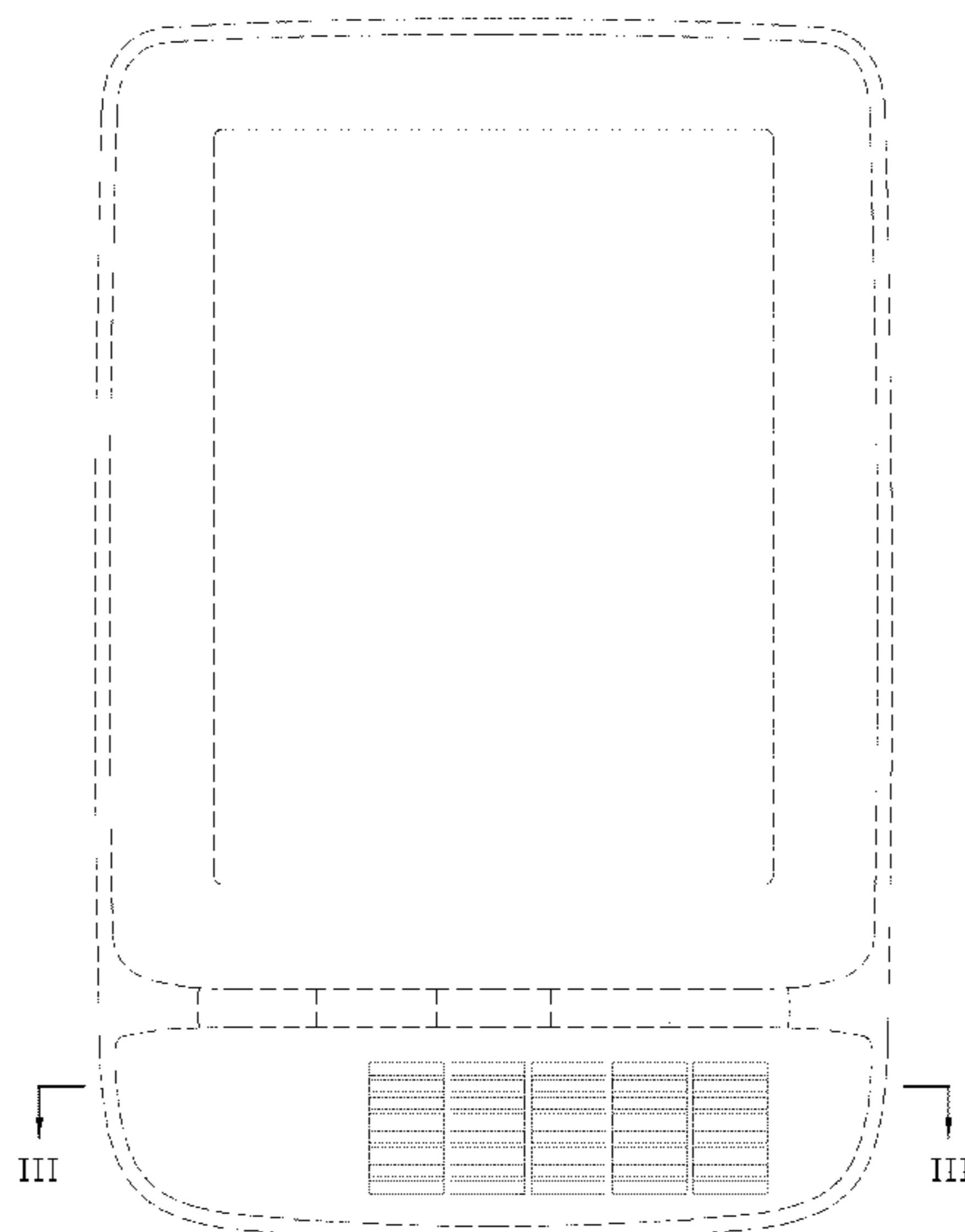
FIG. 1 is a perspective view of an electronic reader showing our design;

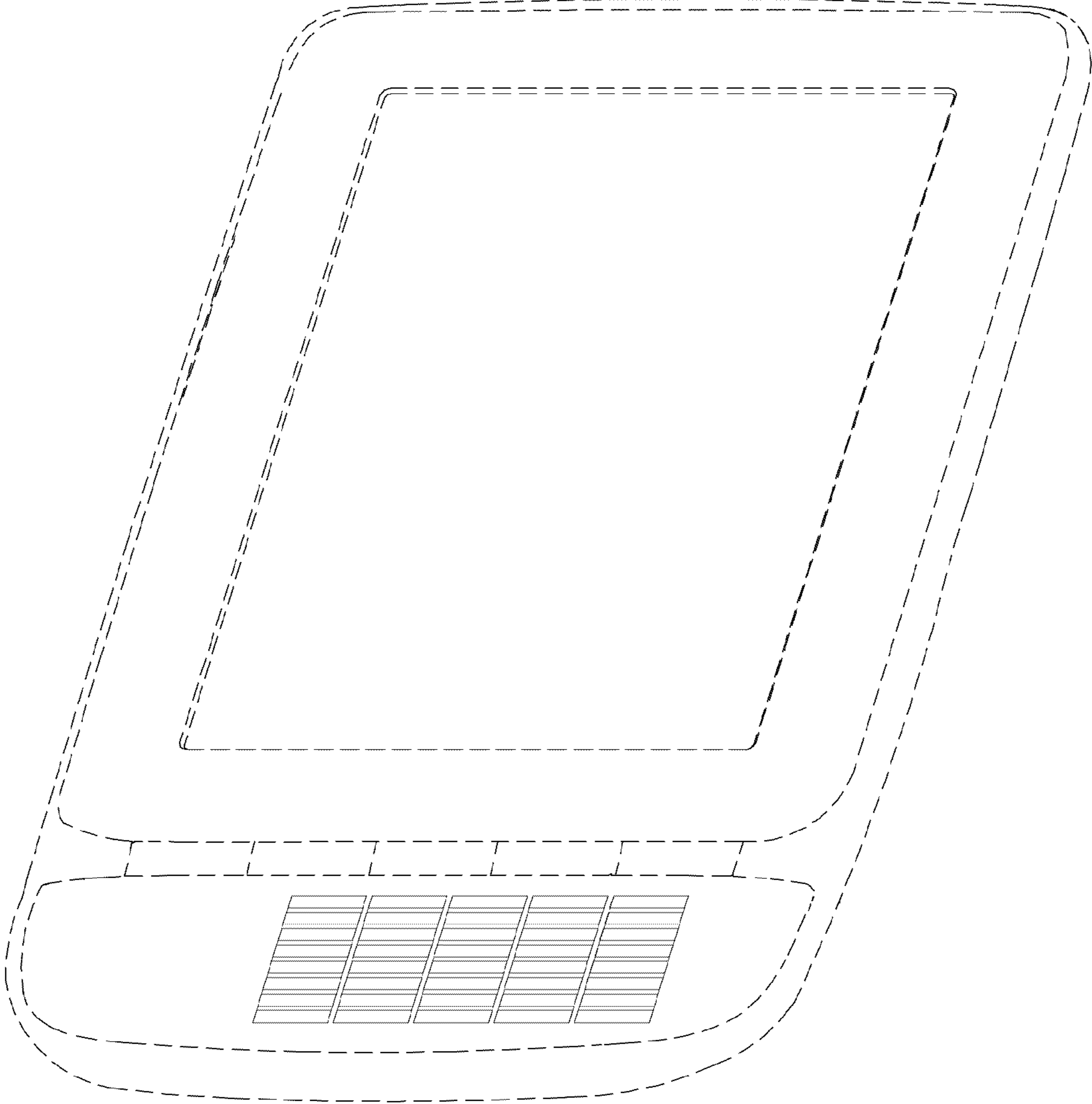

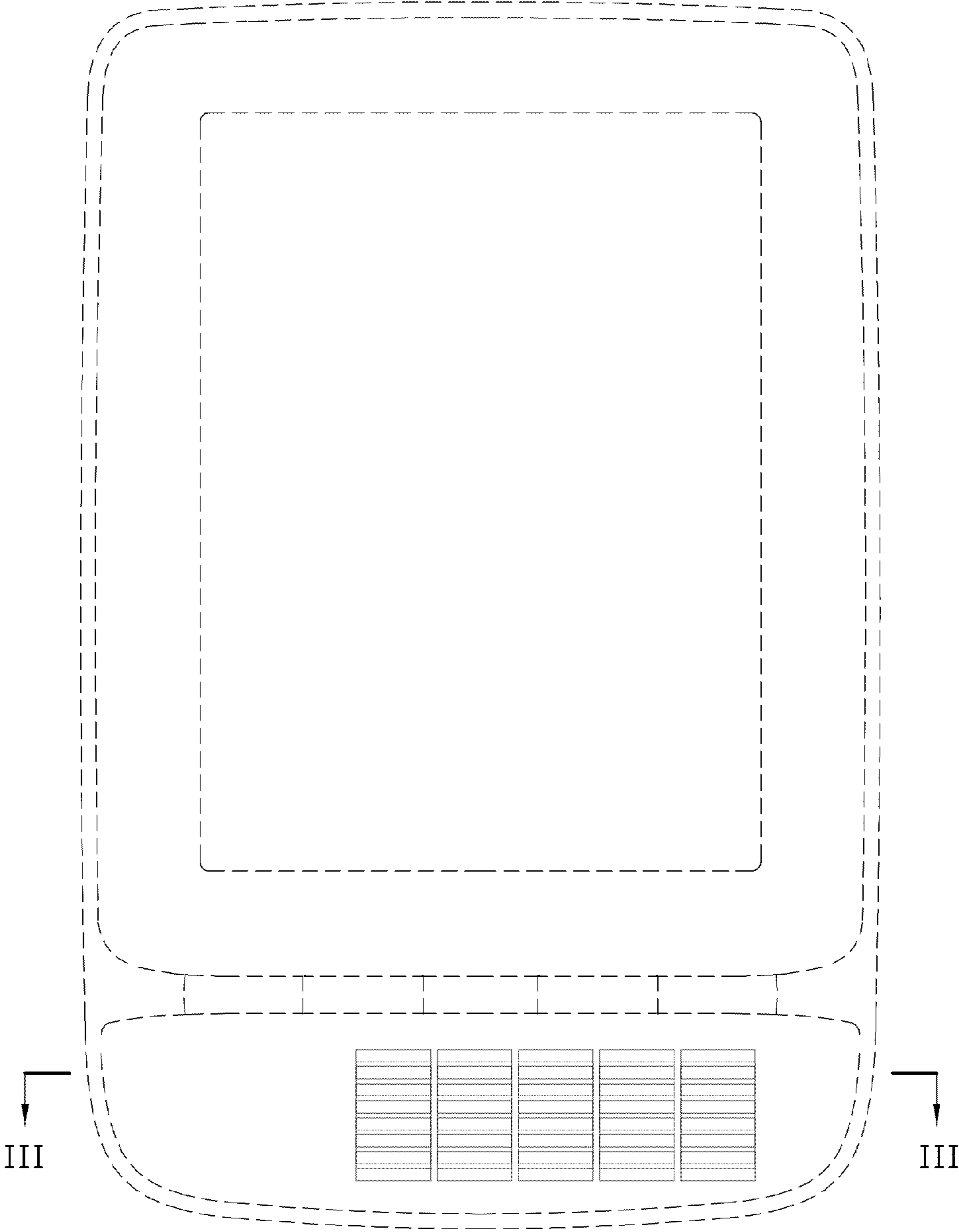

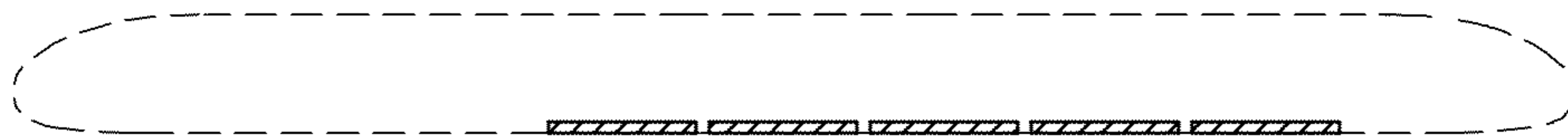
