(57) **CLAIM**

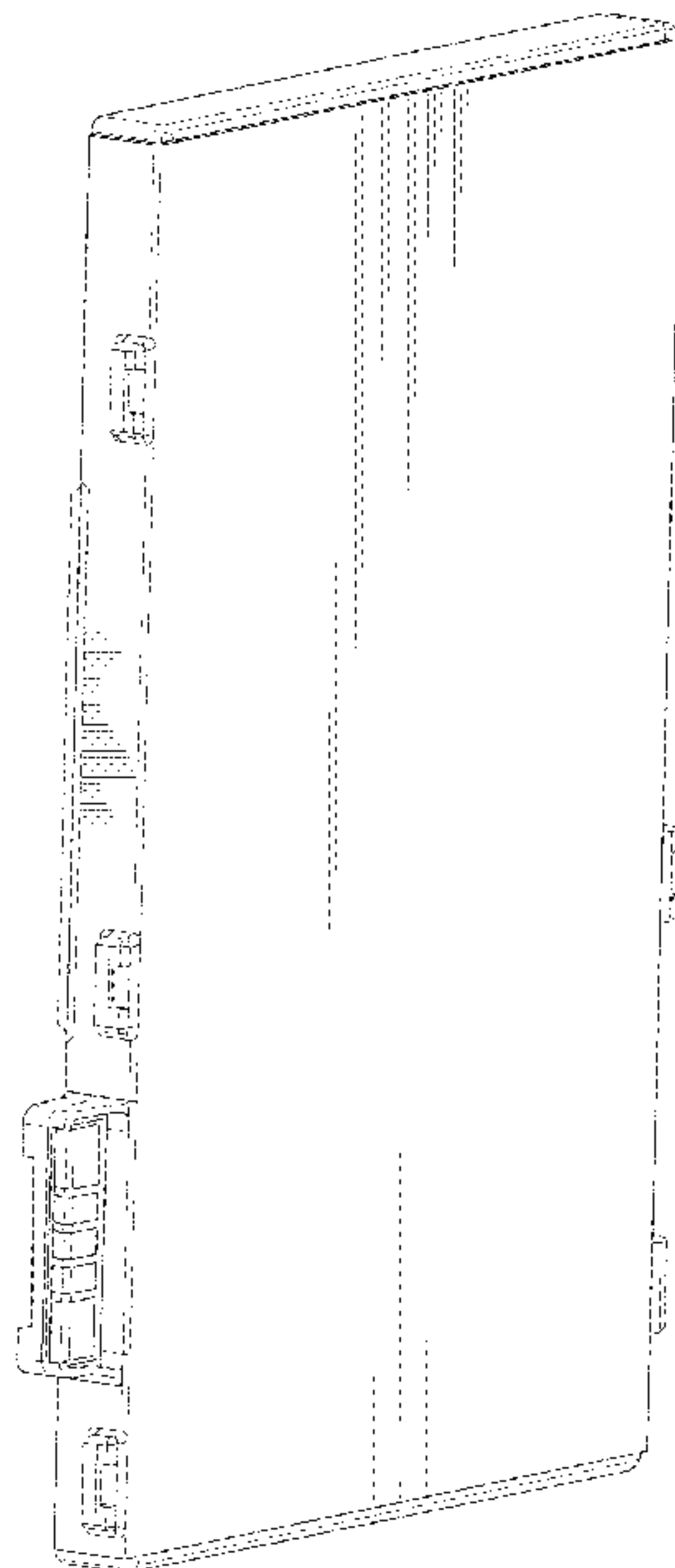
The ornamental design for an battery pack for mobile terminal, as shown and described.

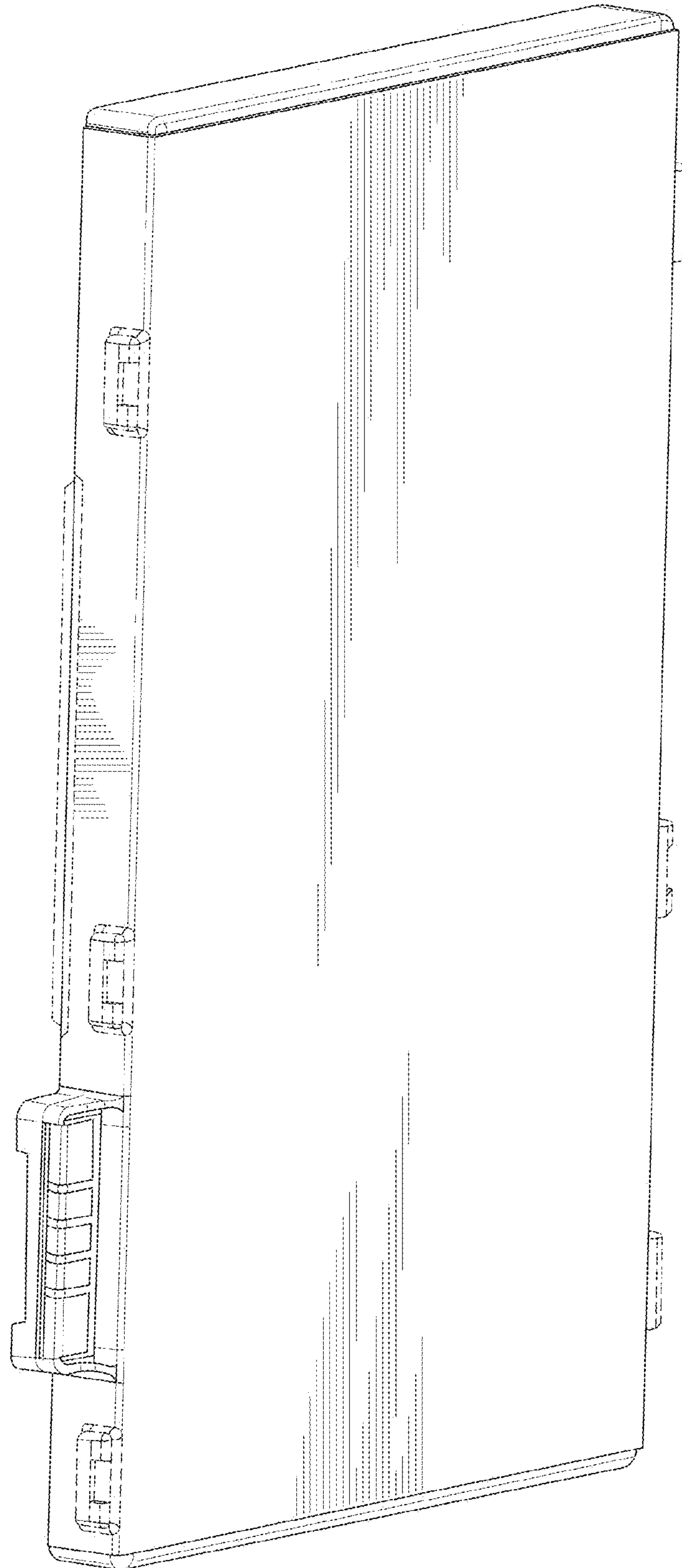

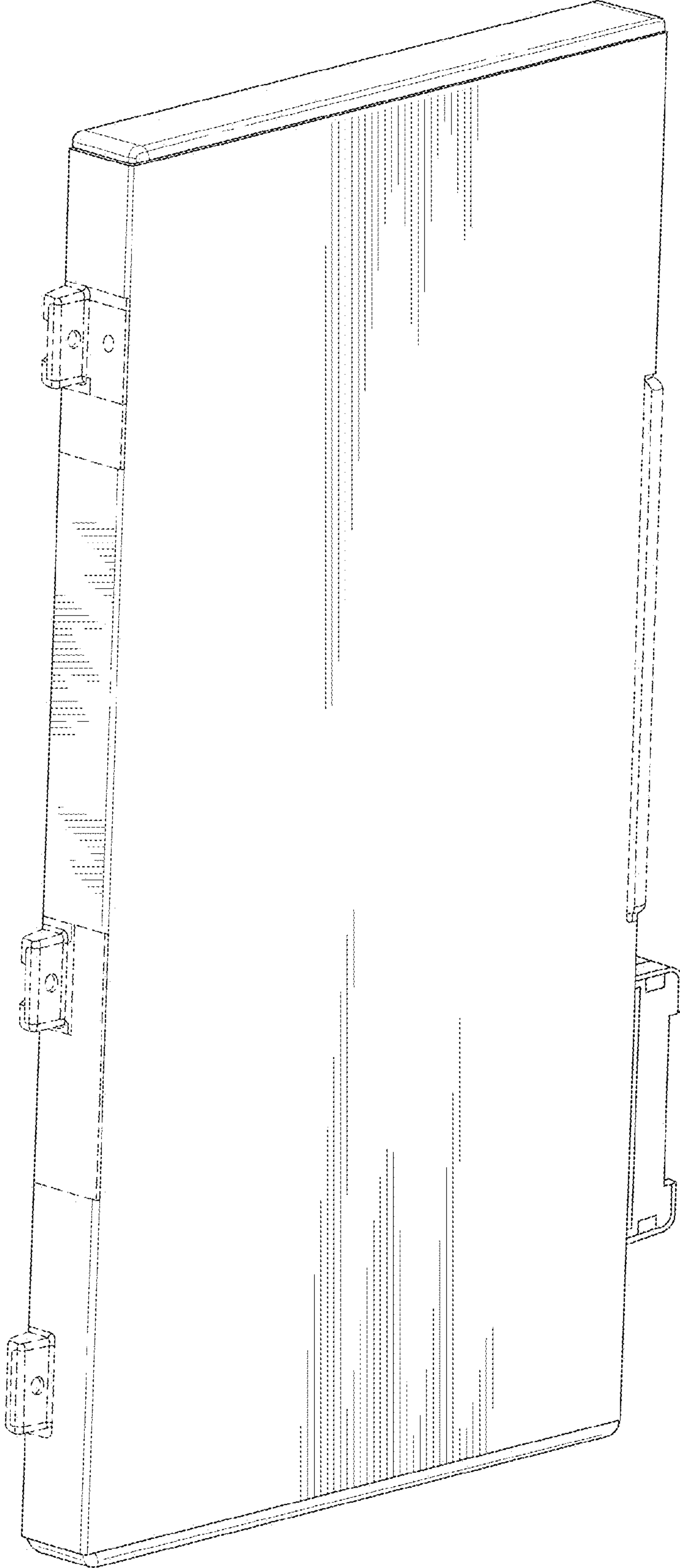

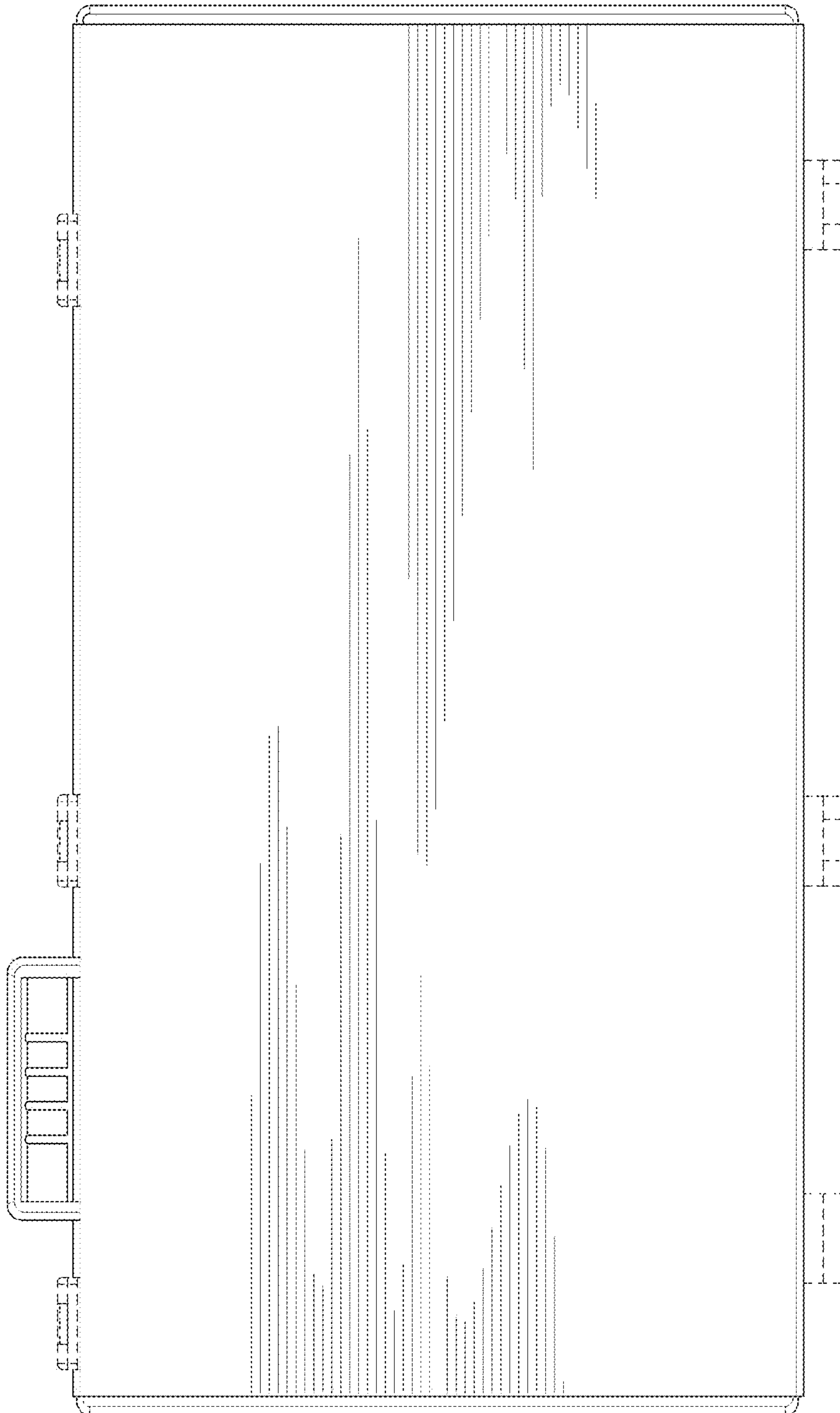

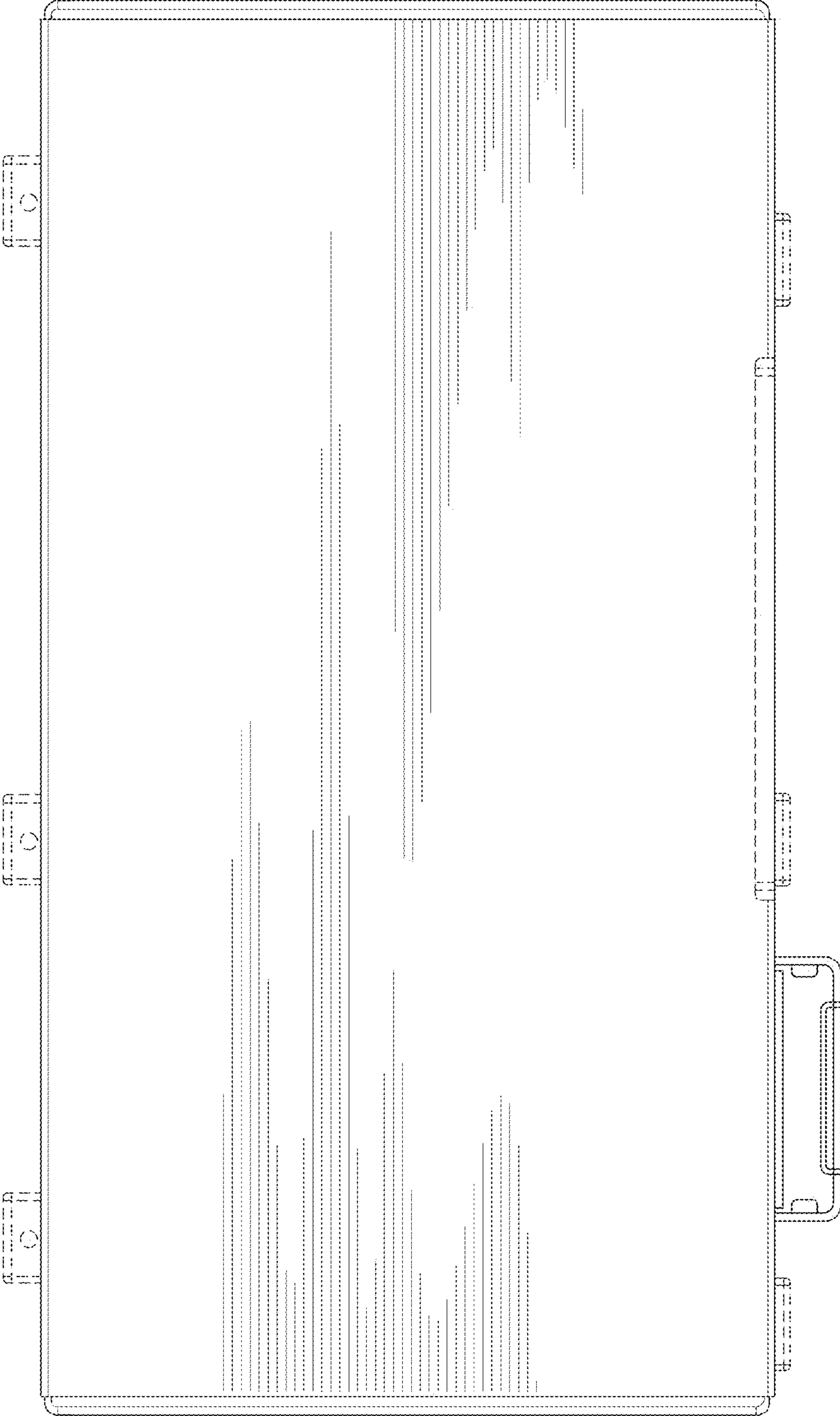

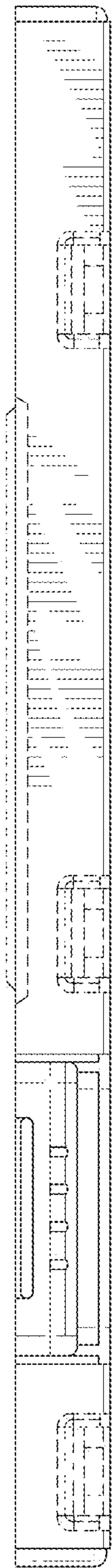

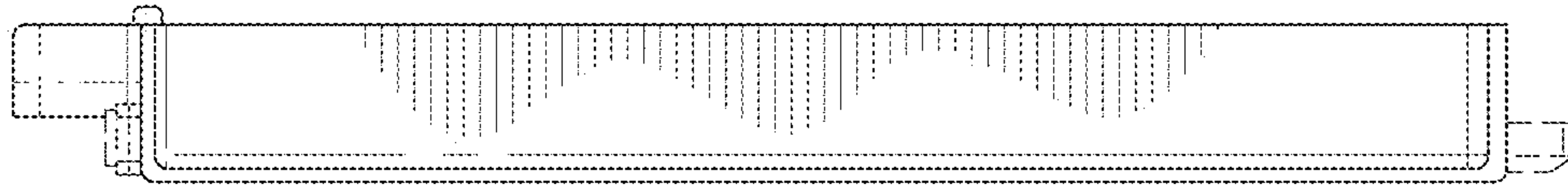

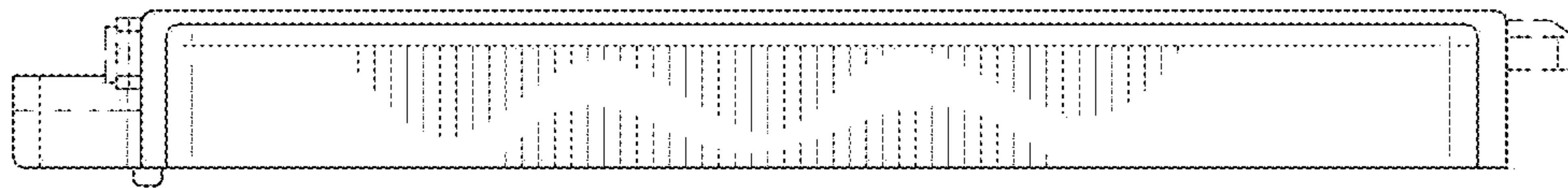
