FIG. 13 is a left side elevational view of FIG. 9;

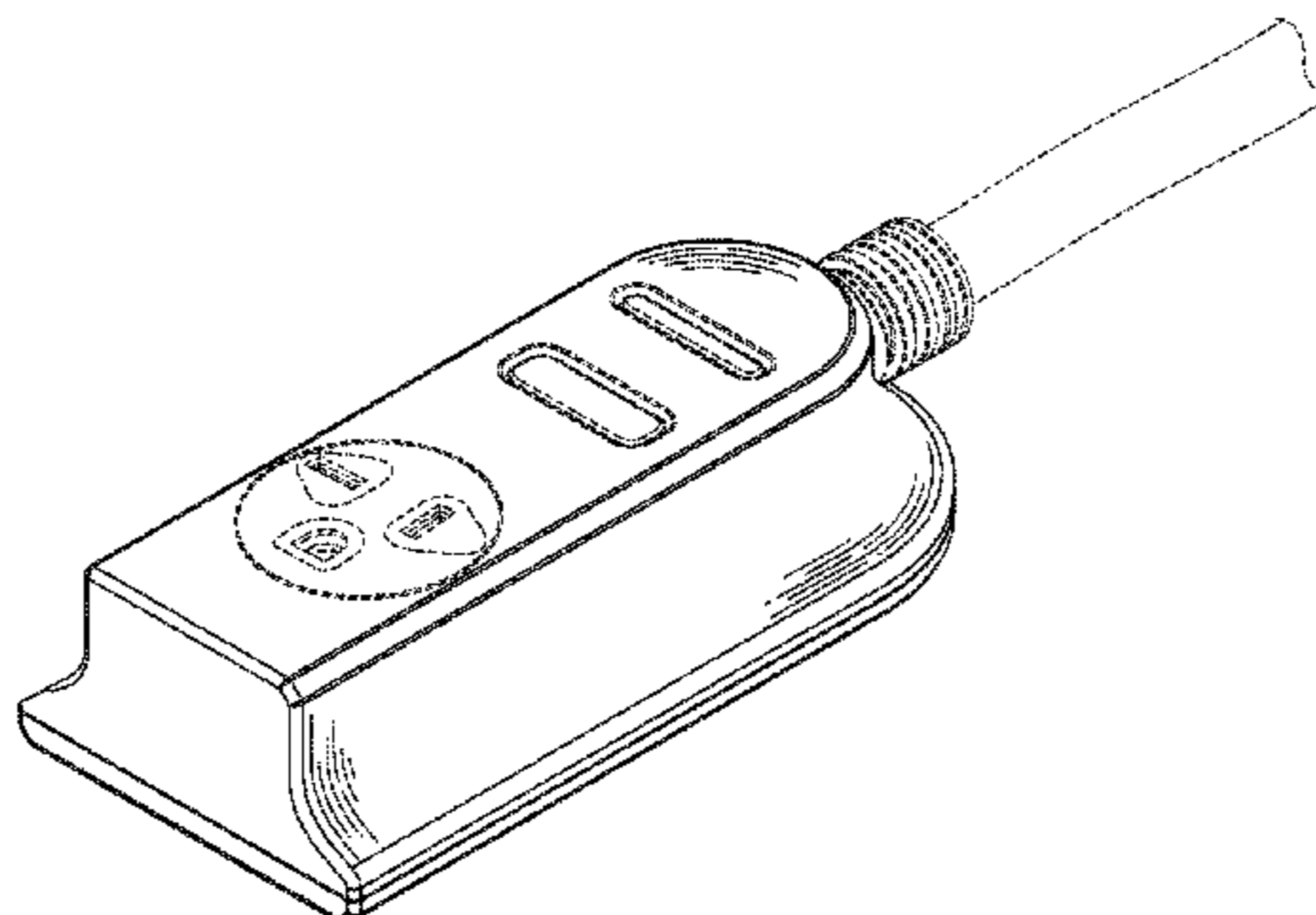
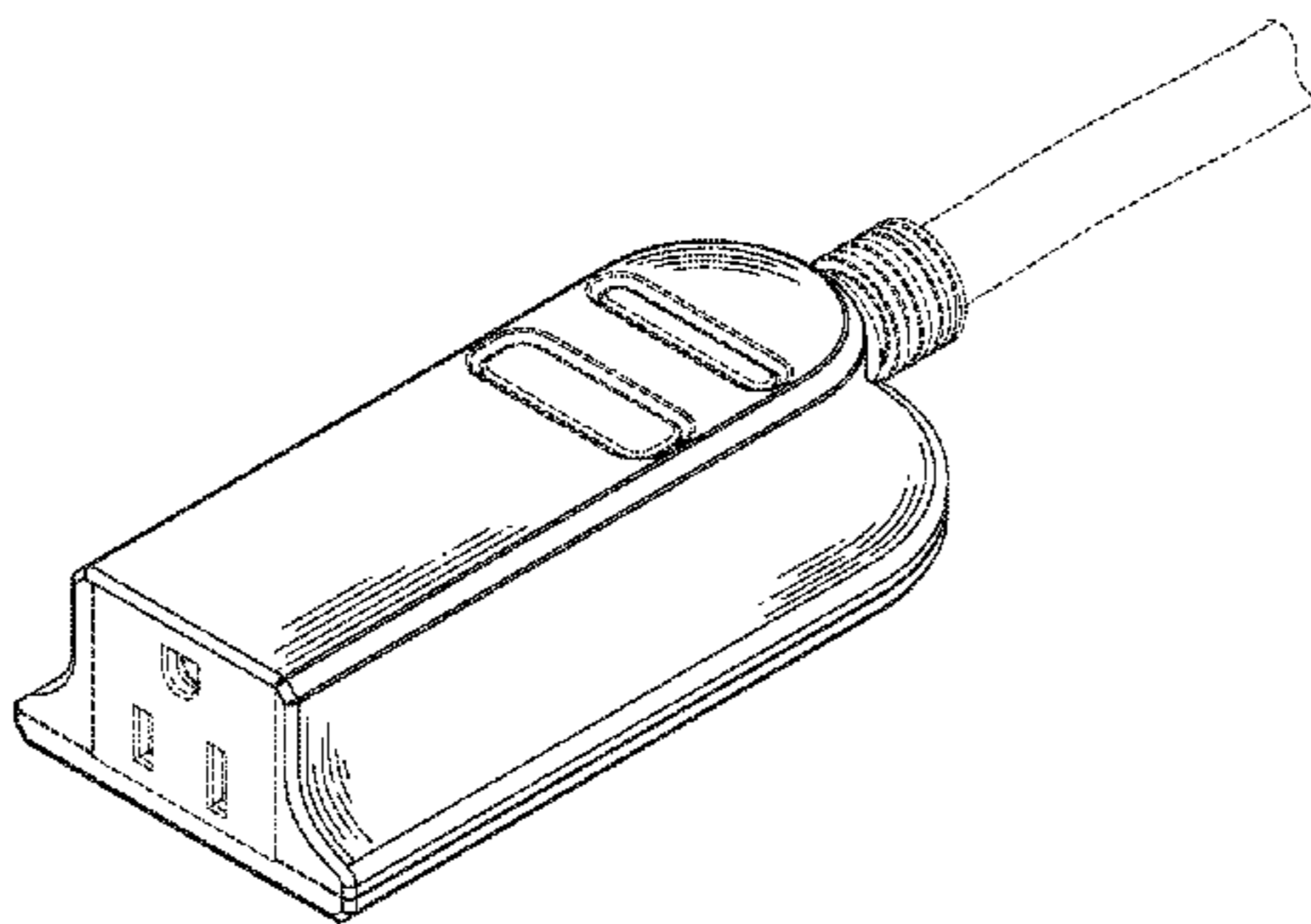
FIG. 14 is a right side elevational view of FIG. 9;

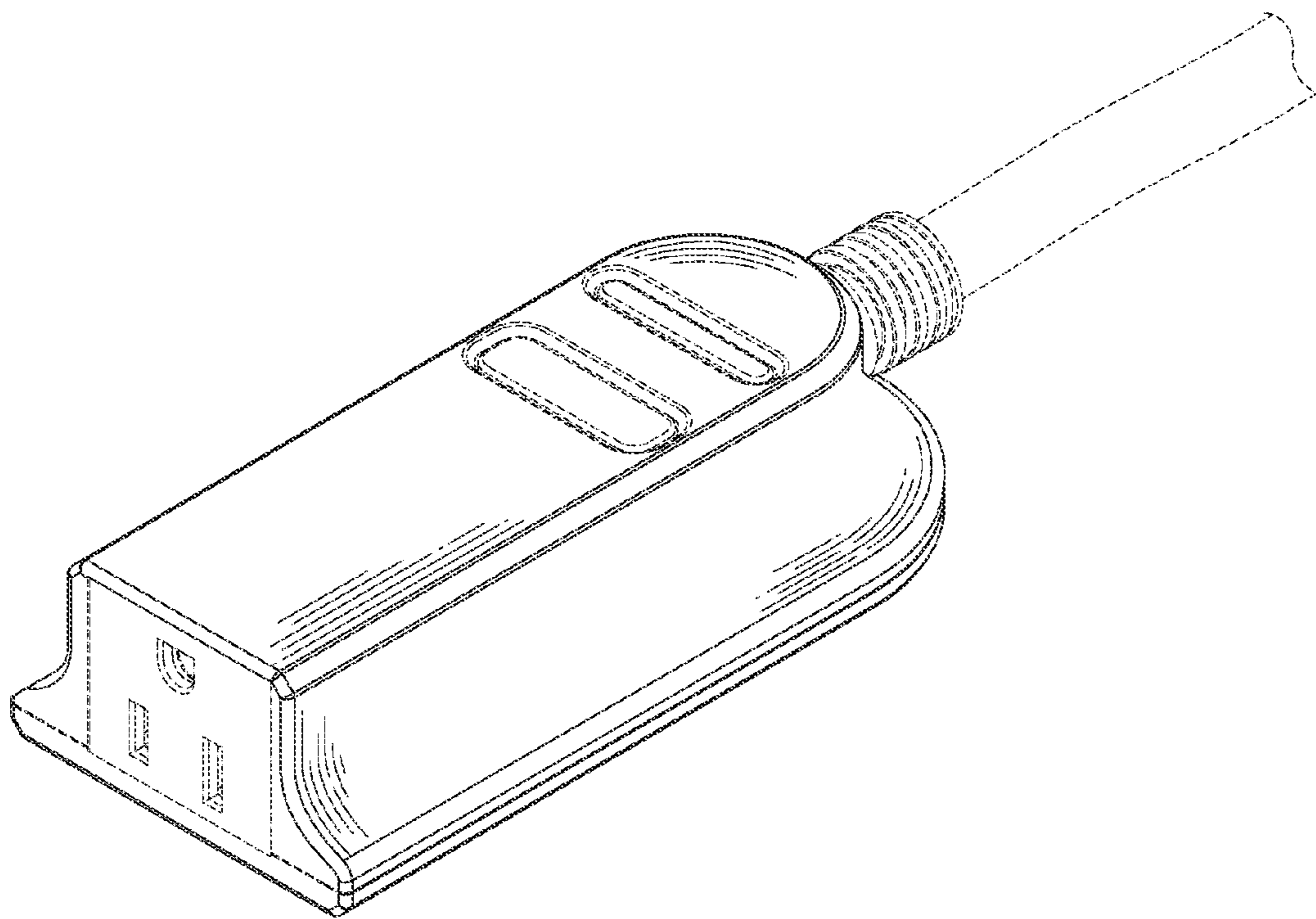

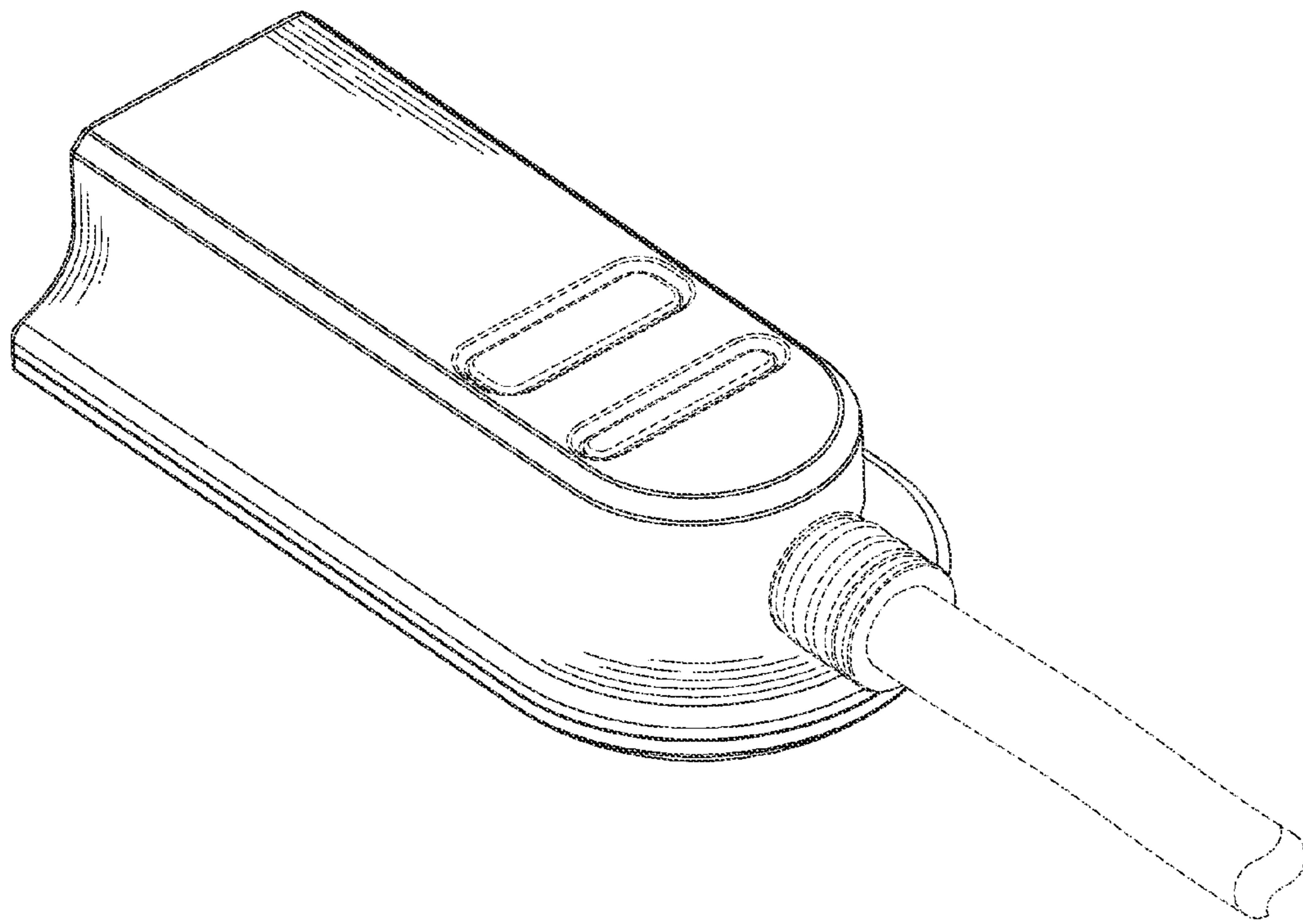

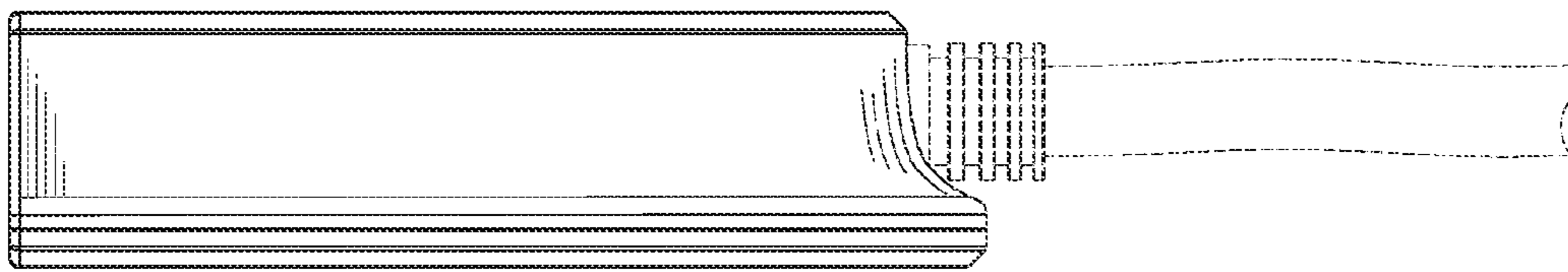

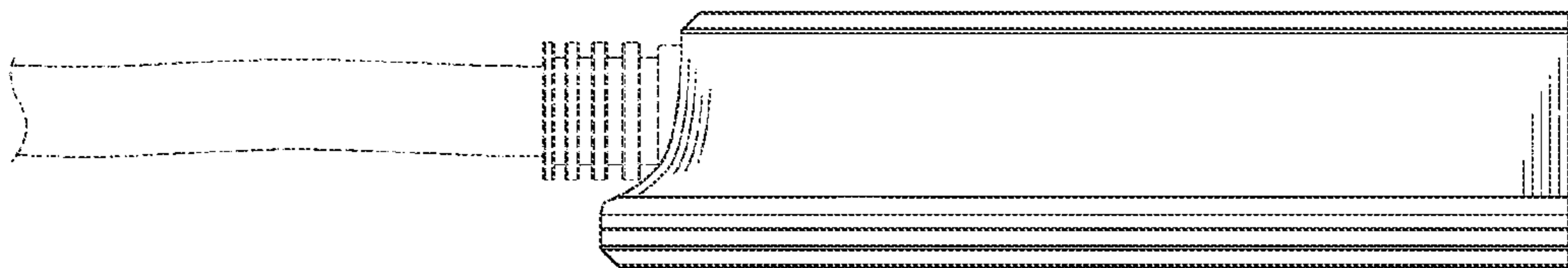

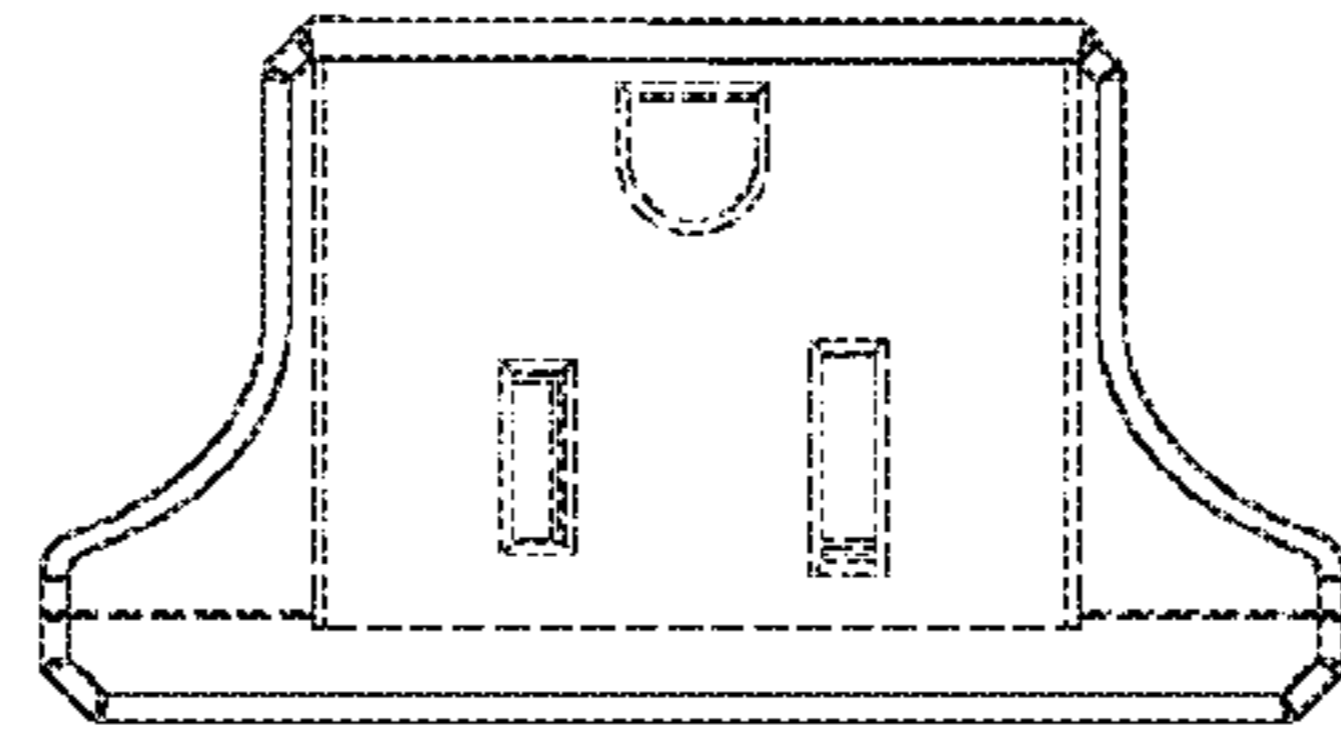

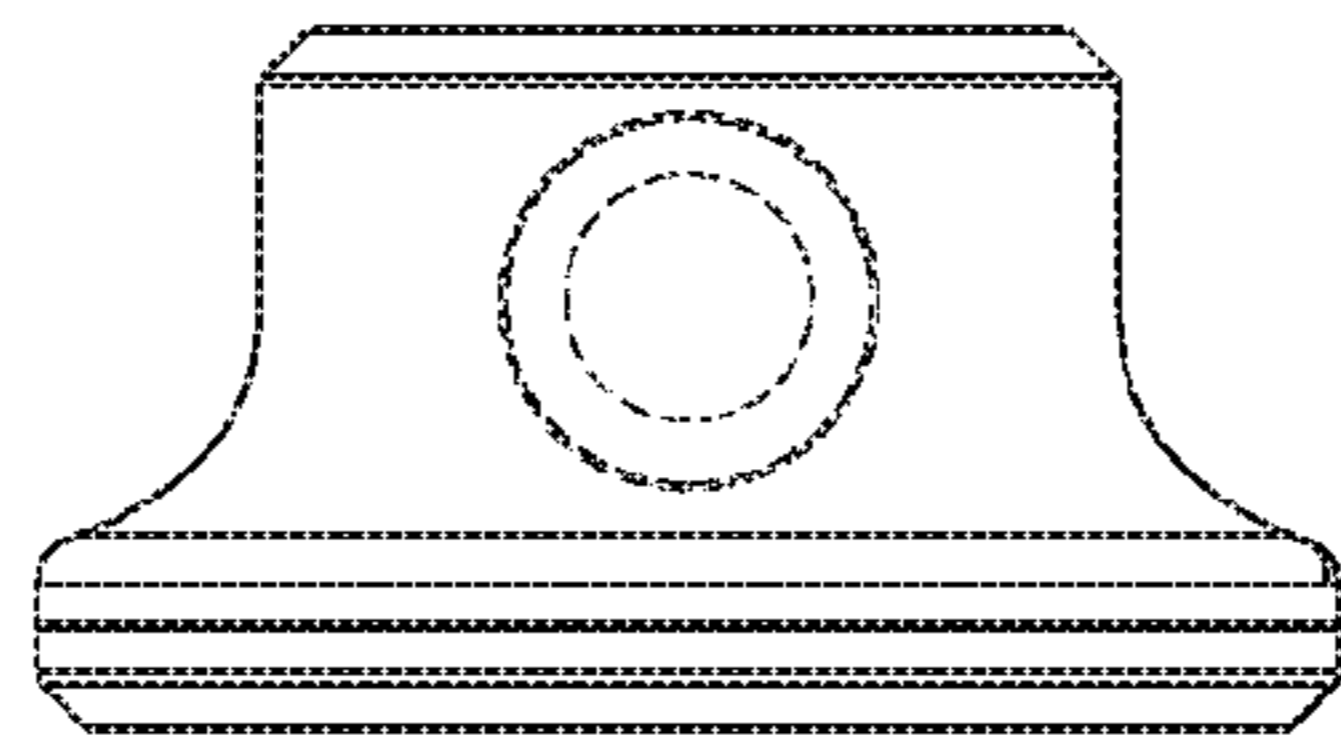

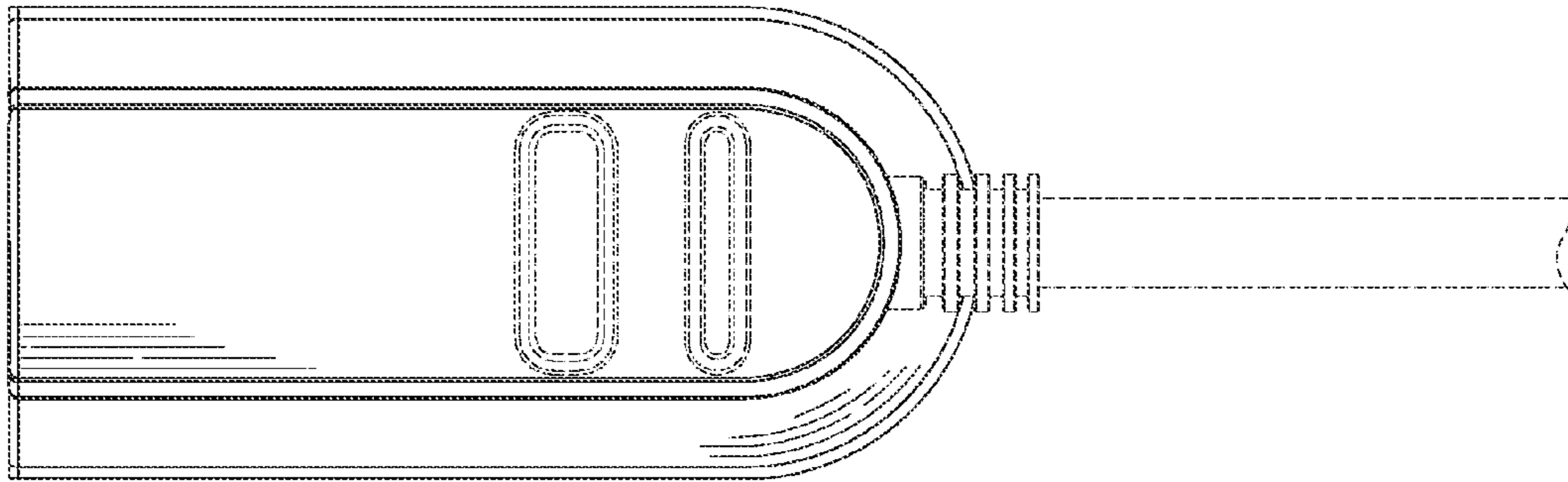

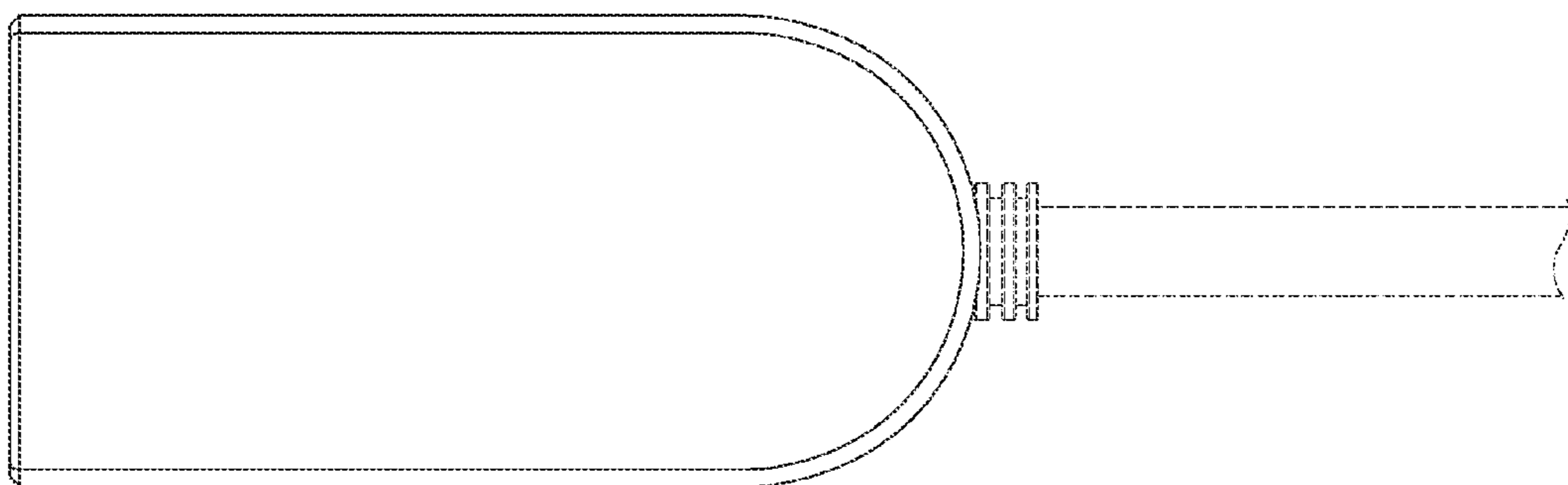

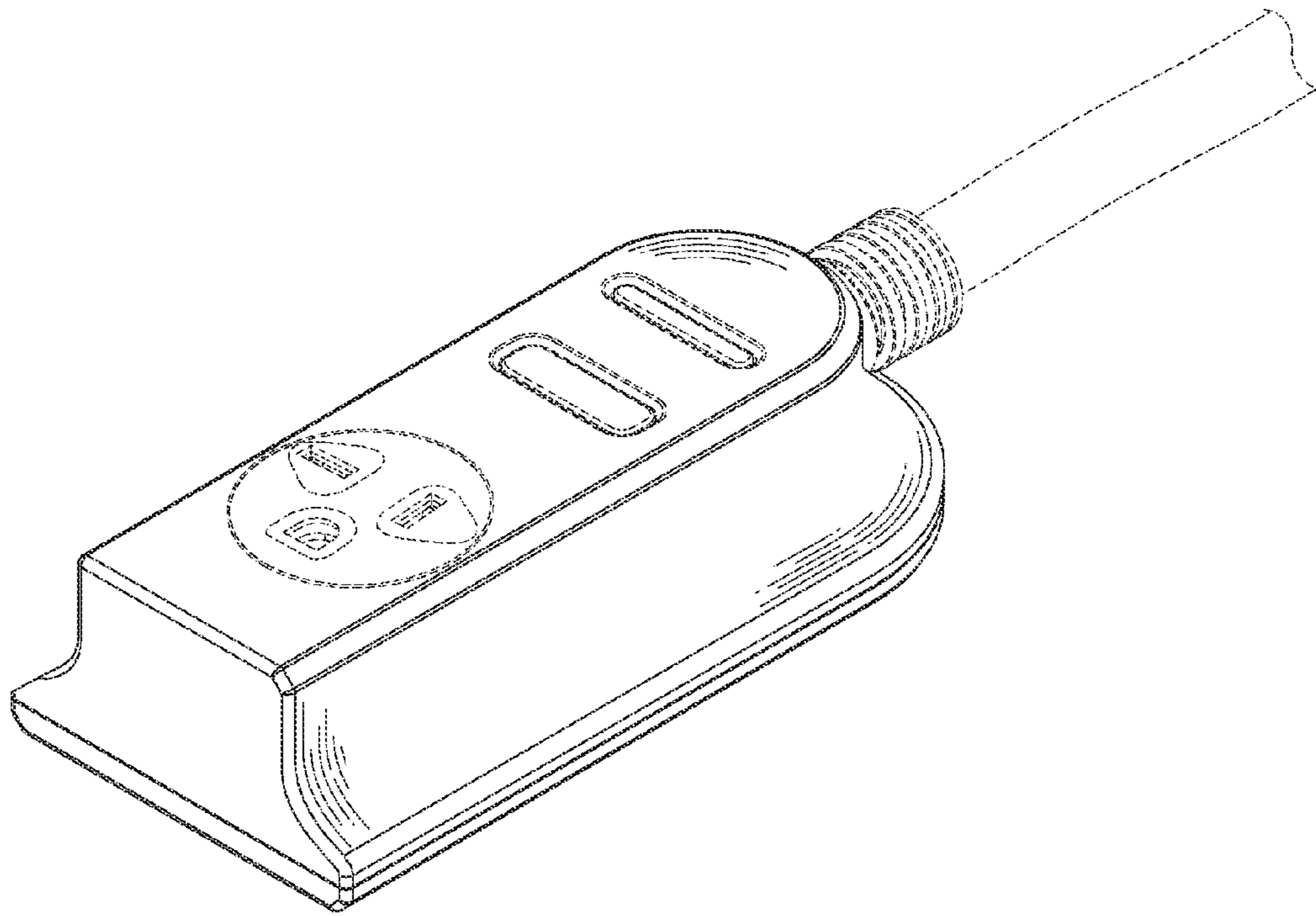

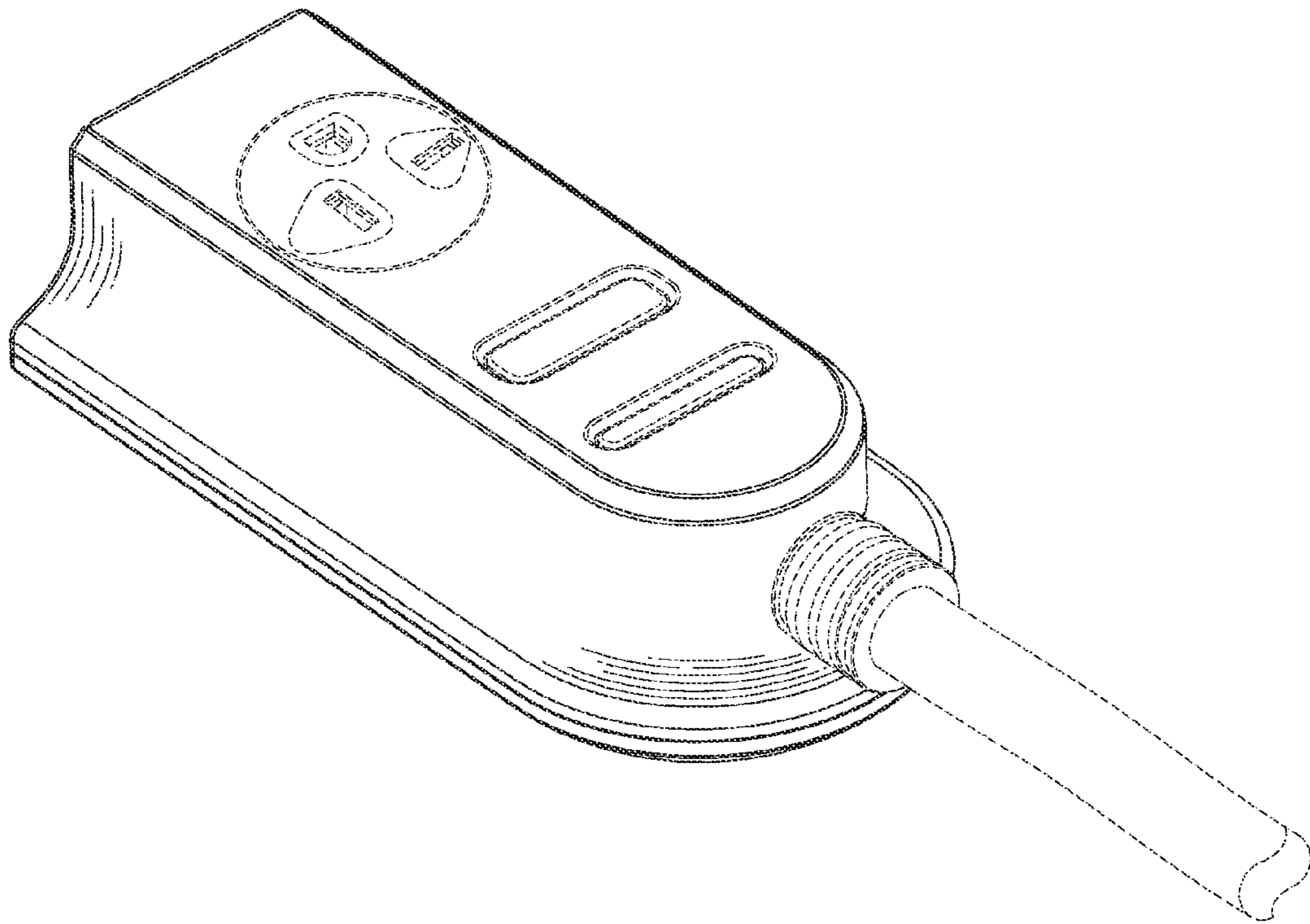

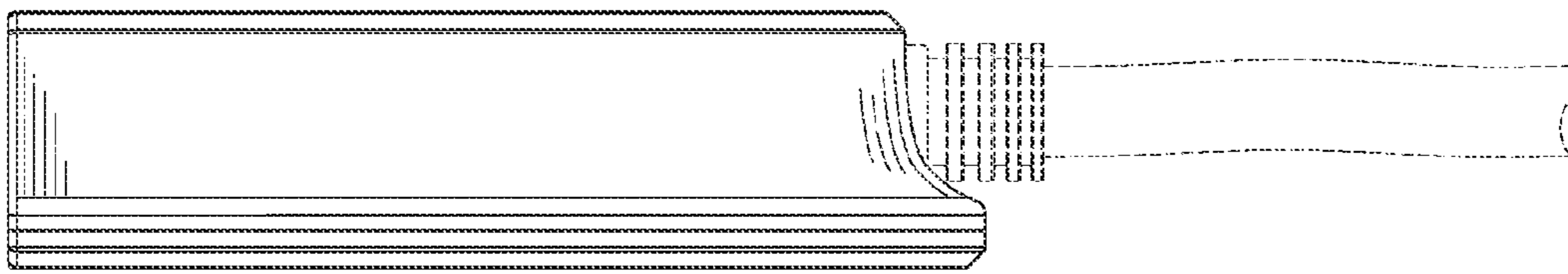

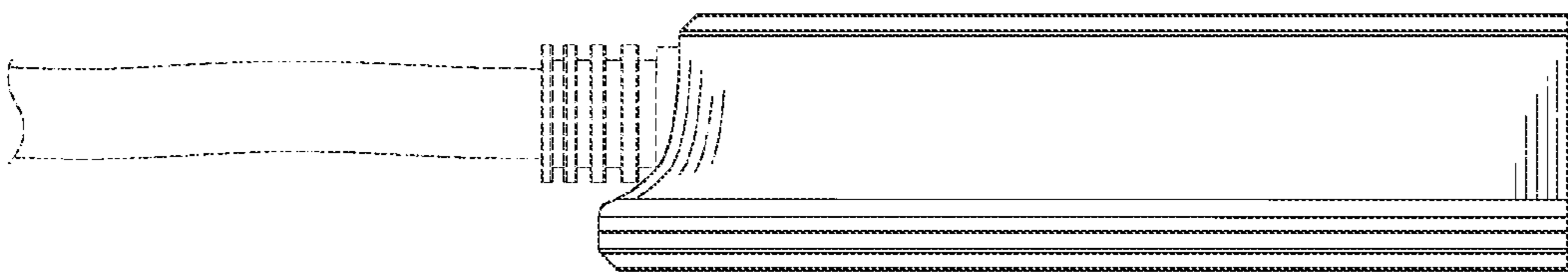

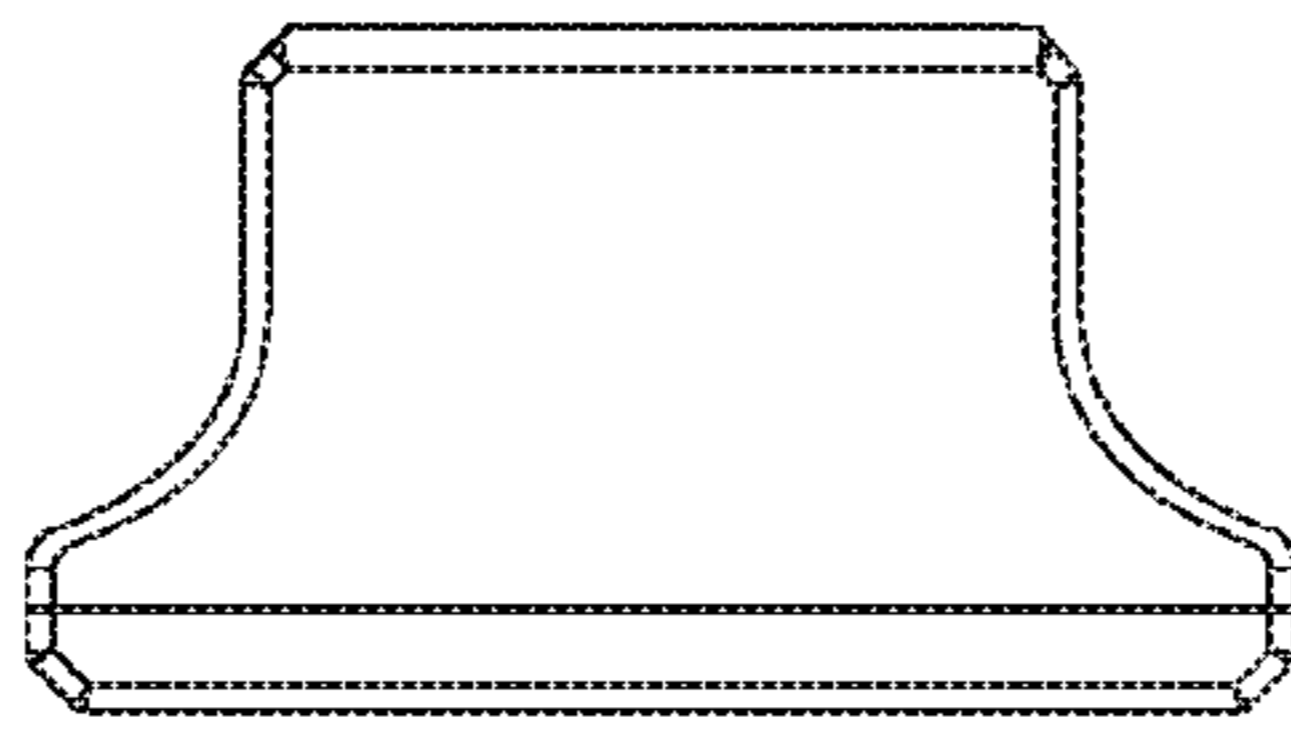

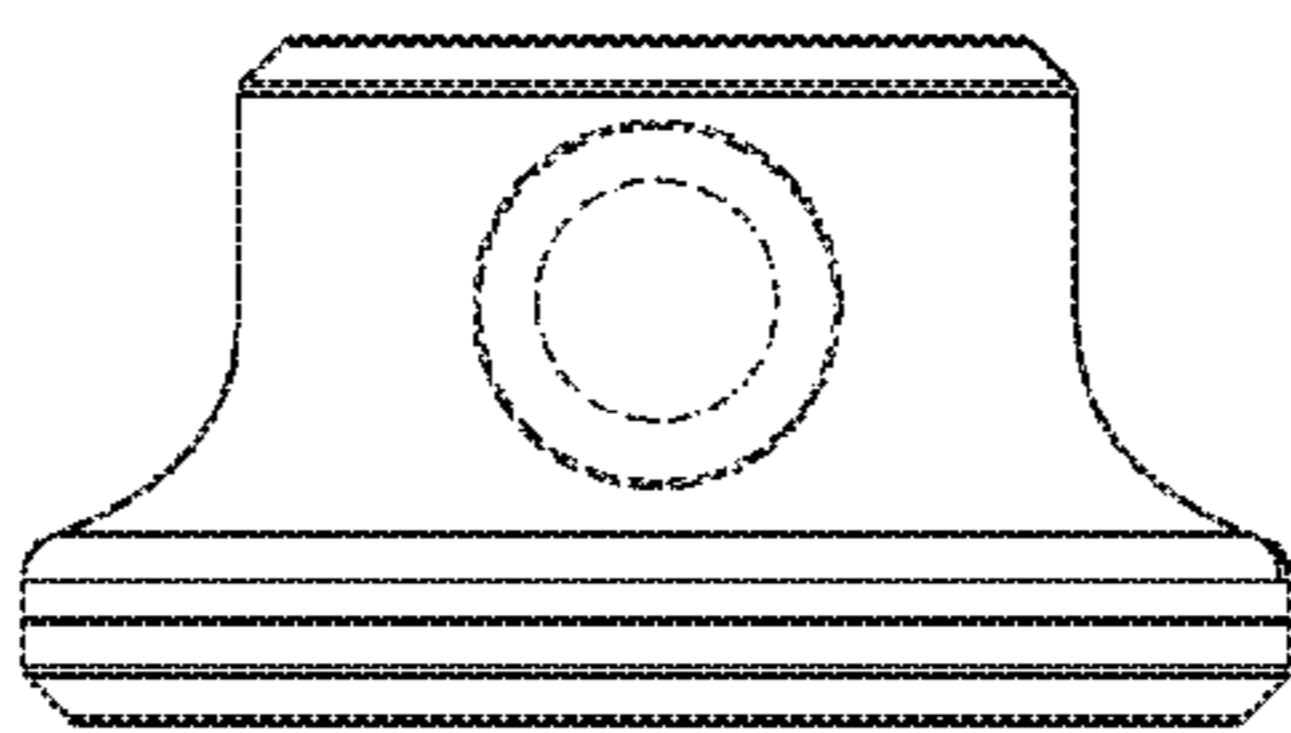

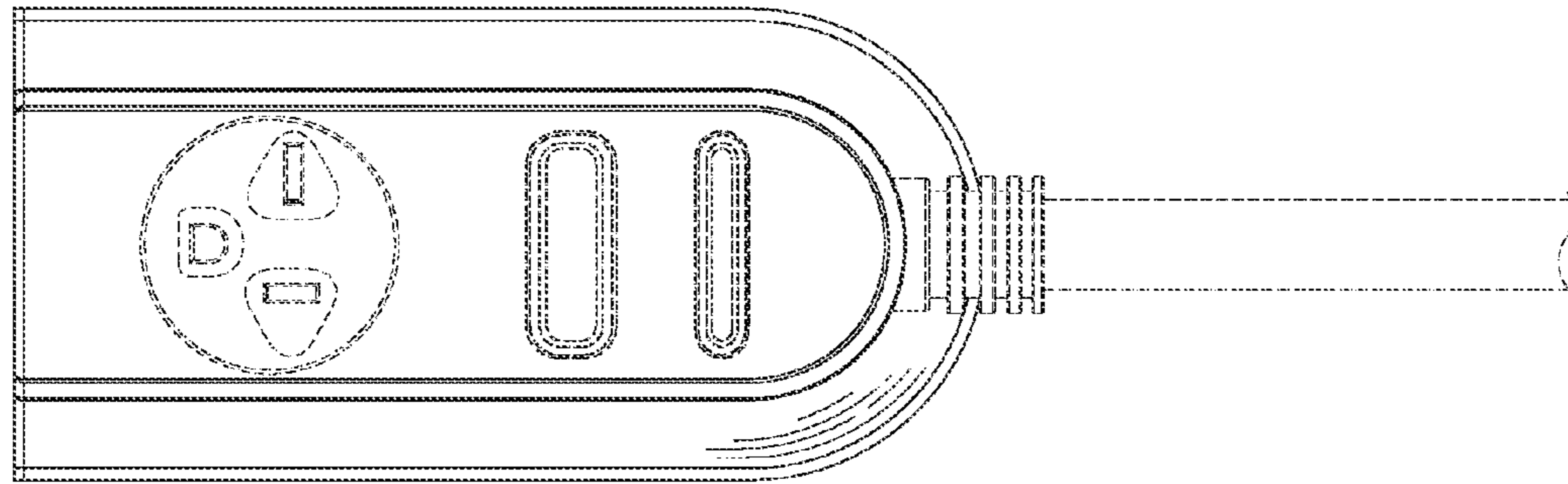

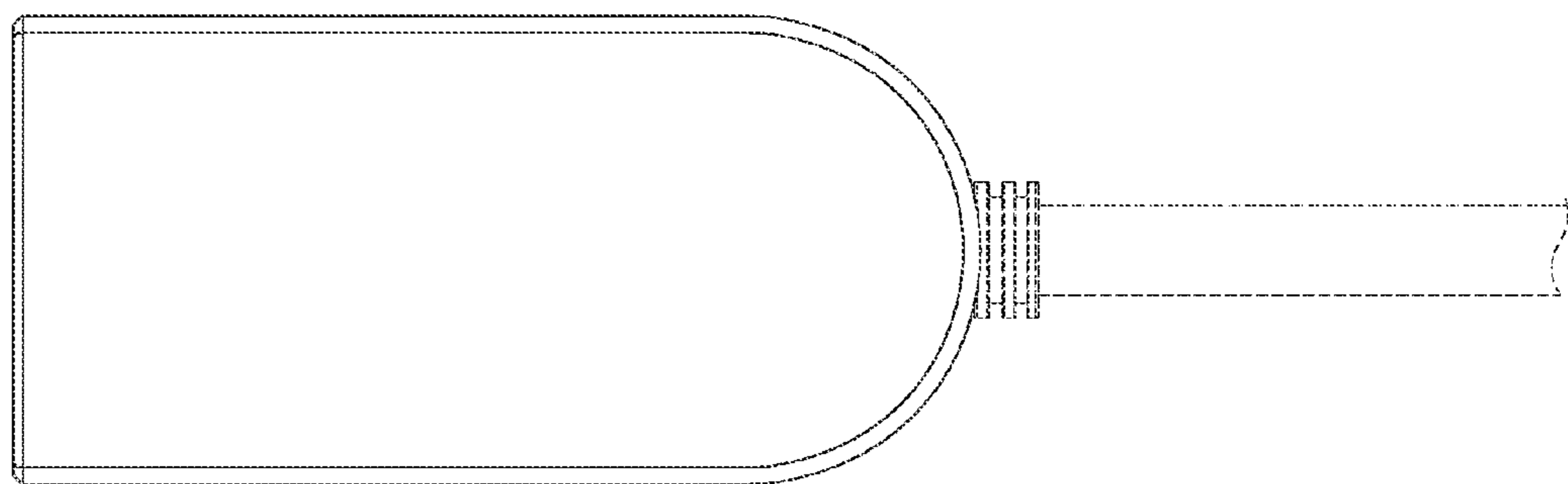
