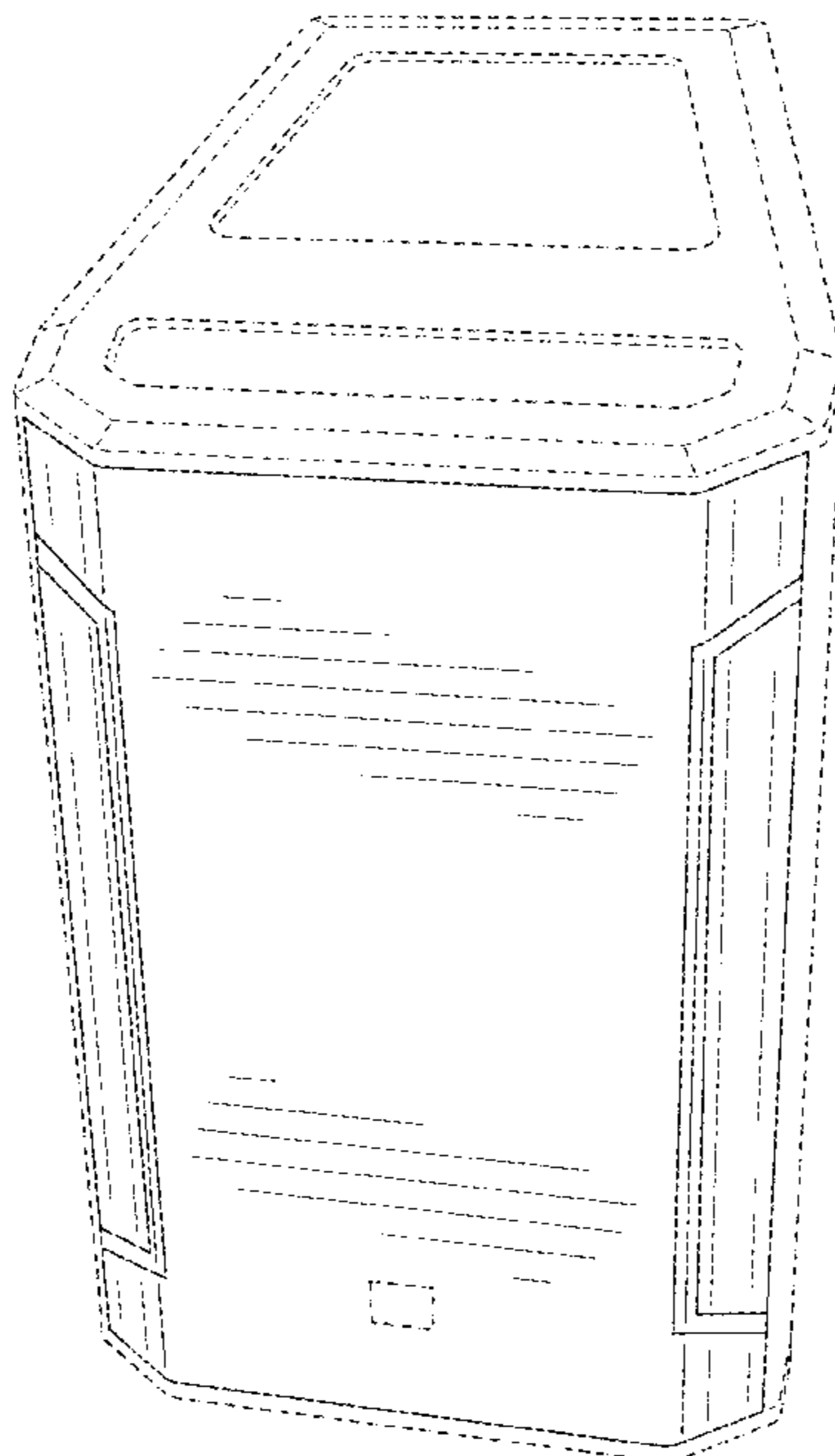
FIG. 1 is a perspective view of a loudspeaker grille showing our new design;

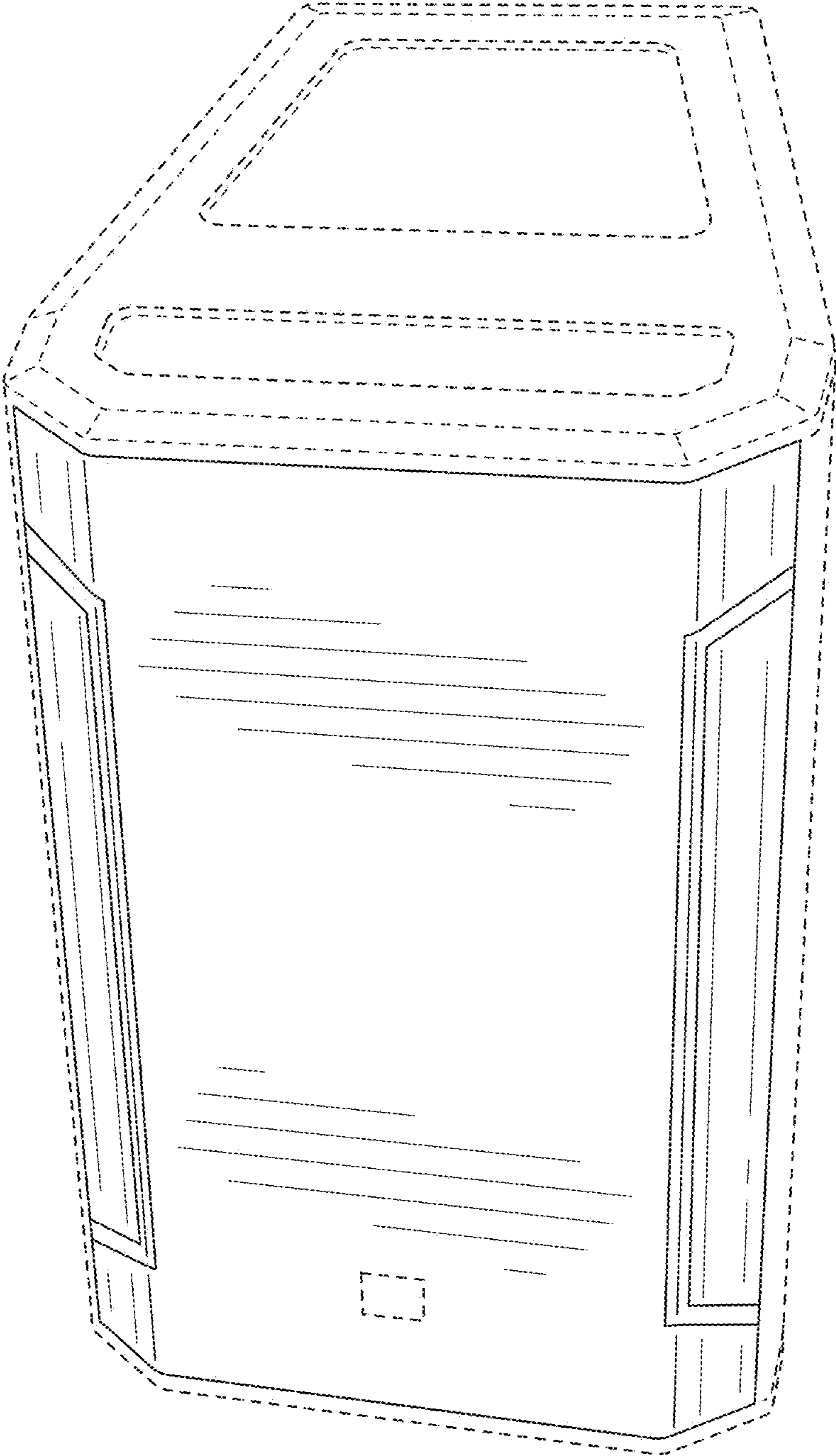

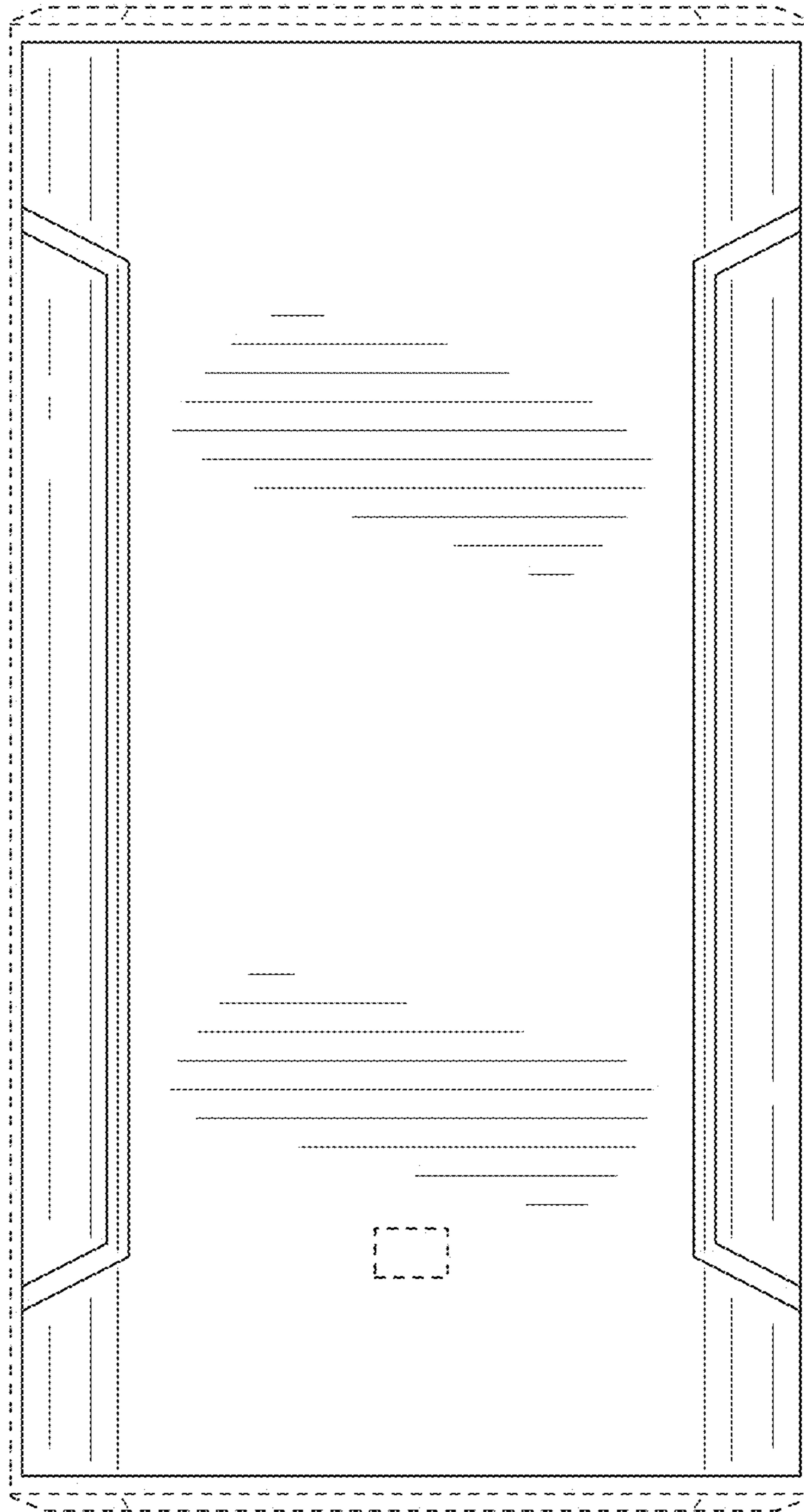

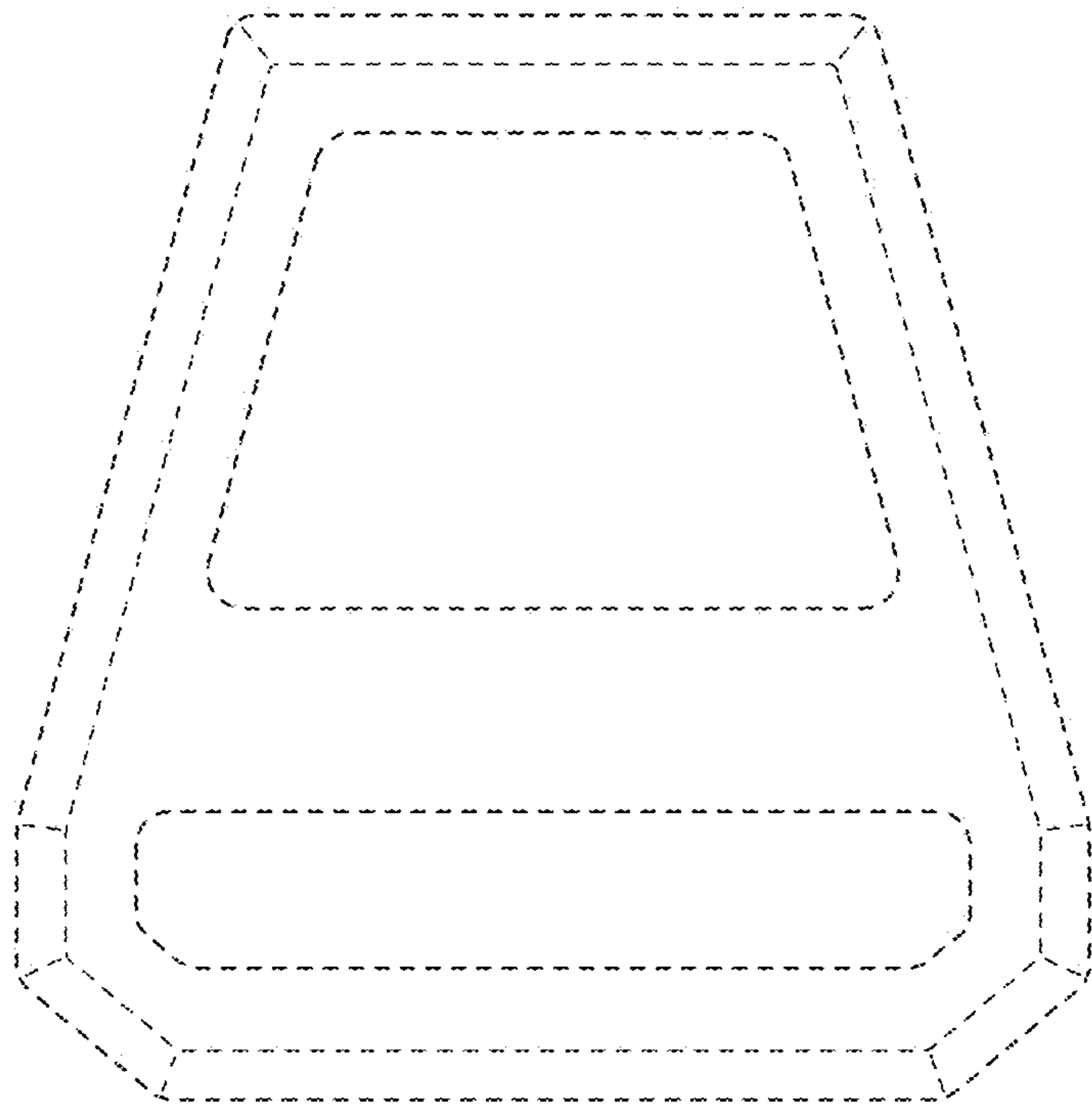

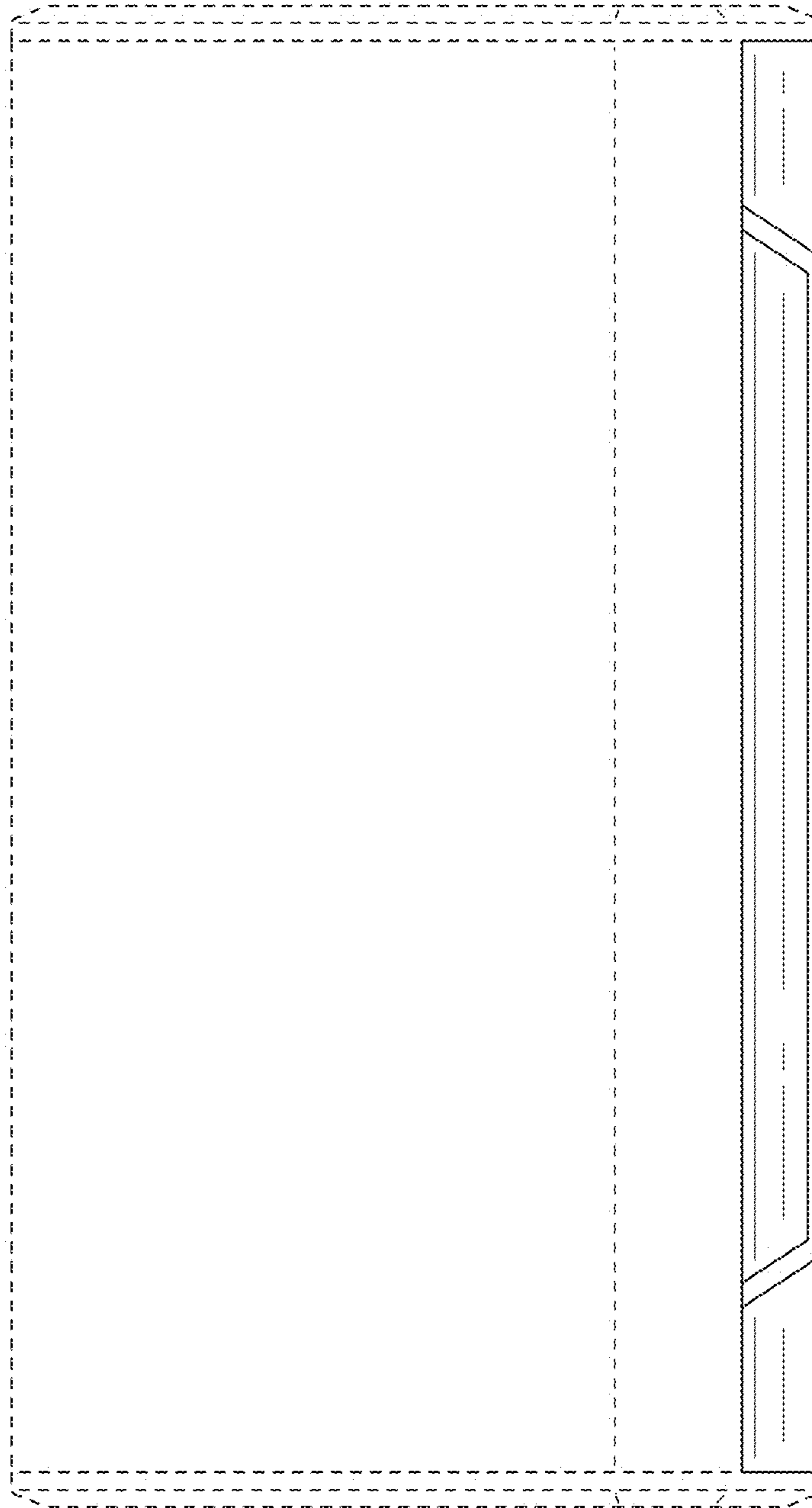

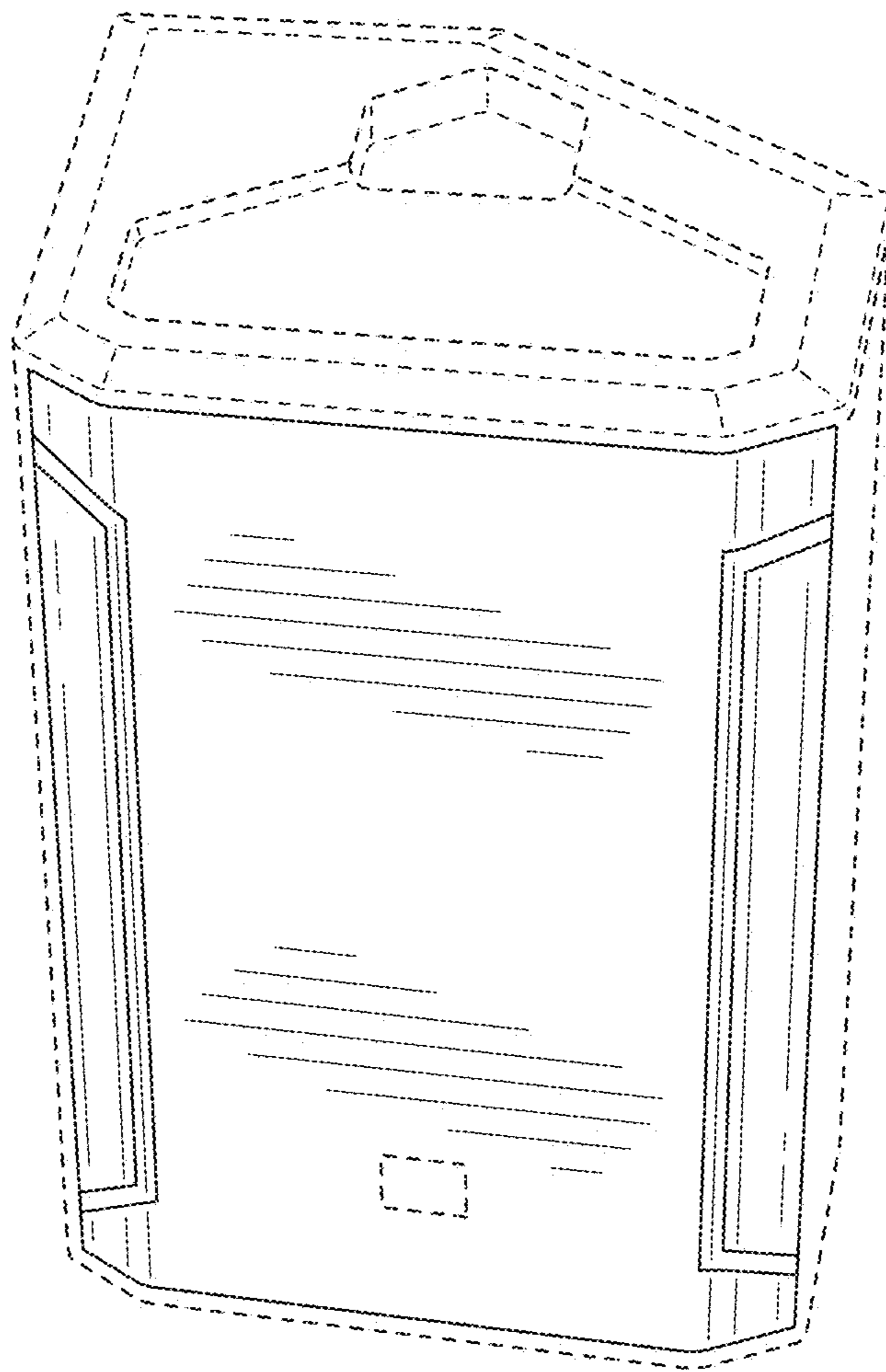

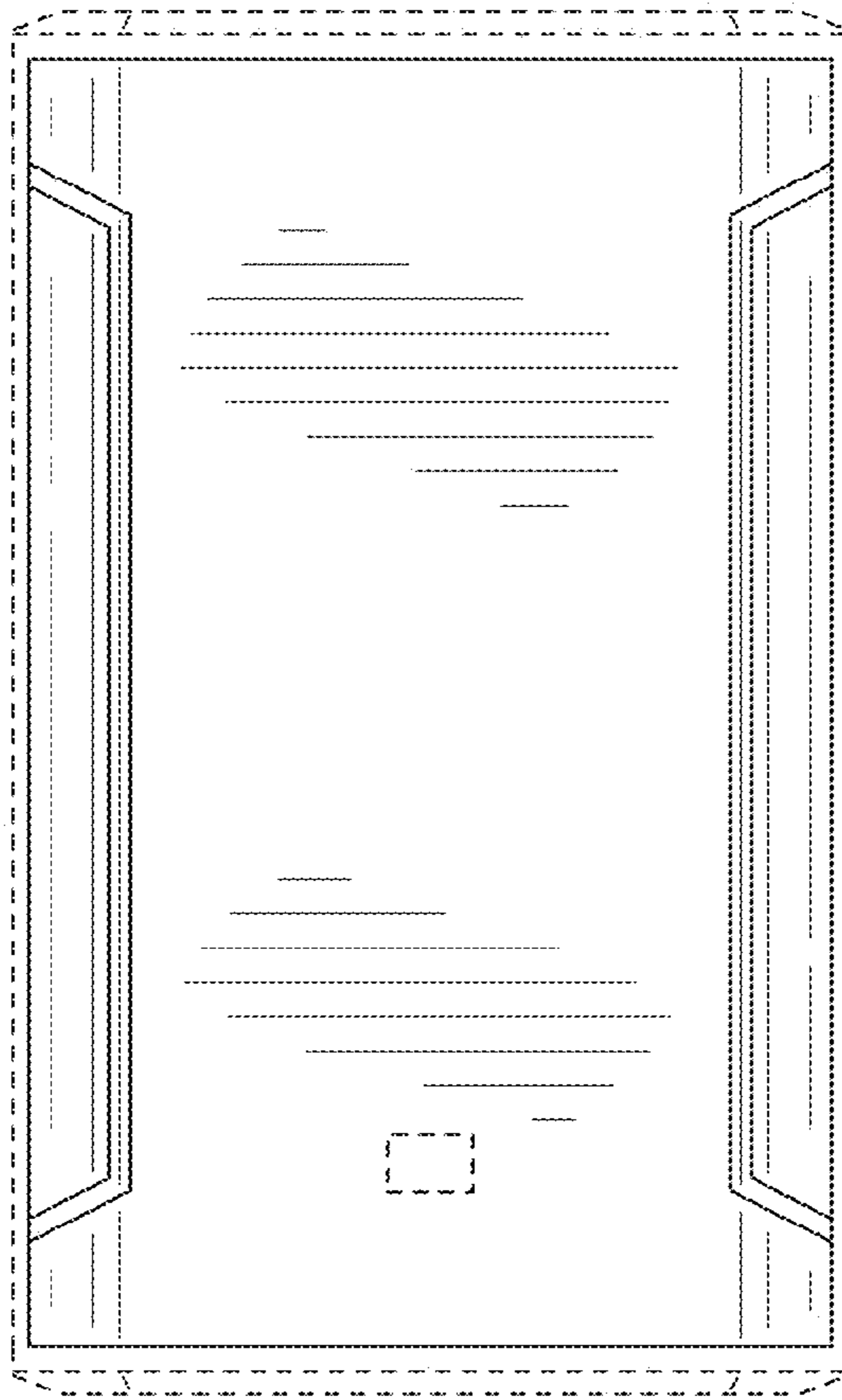

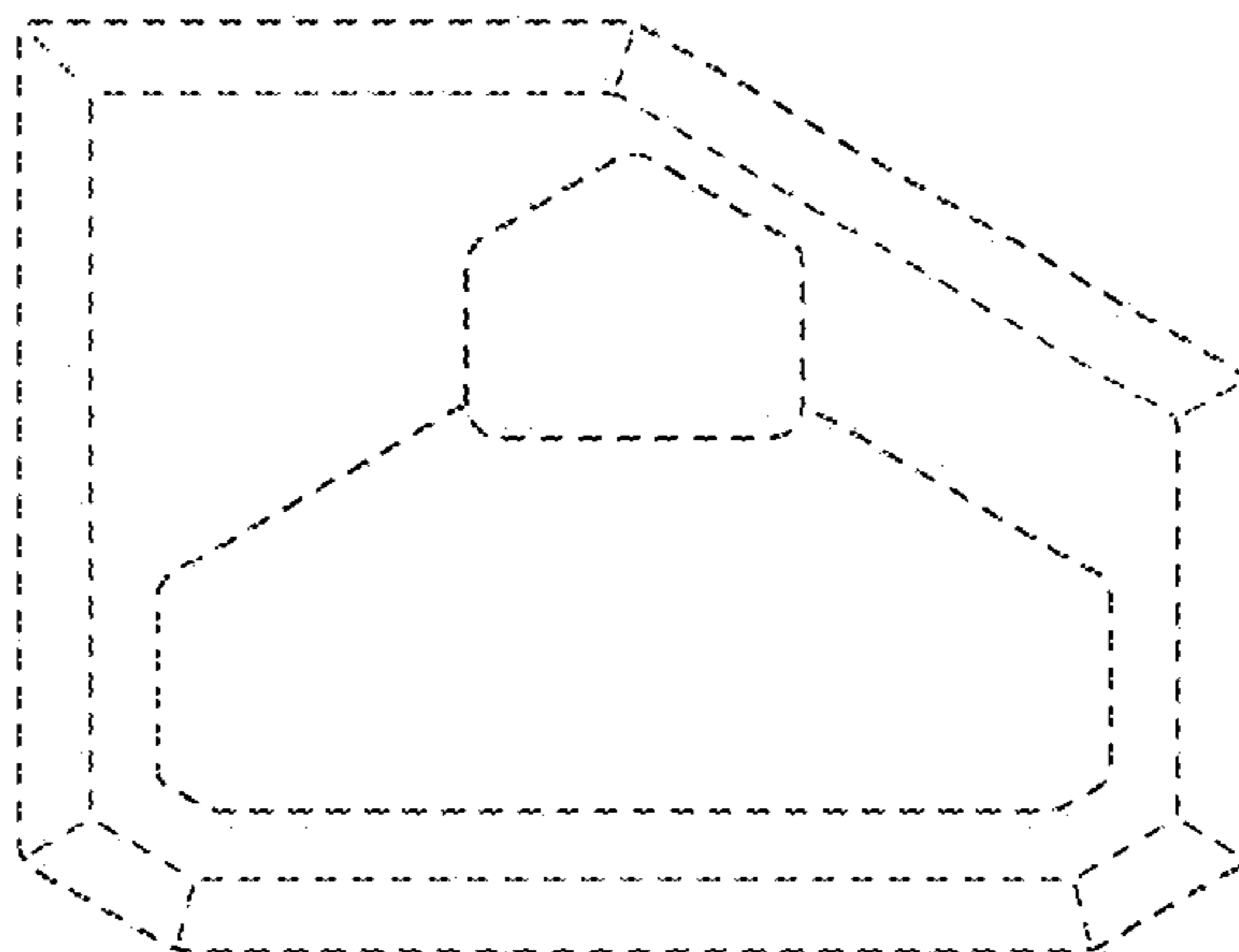

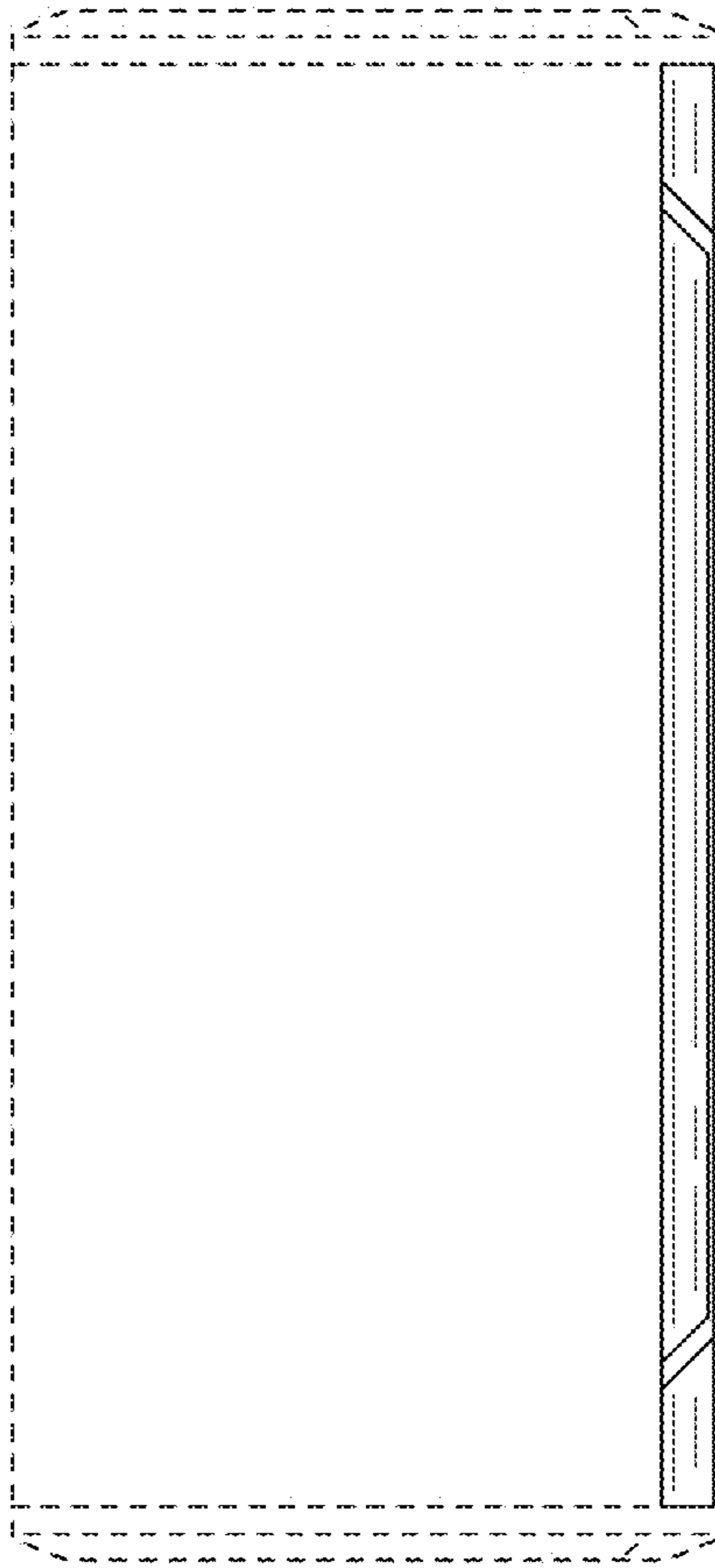

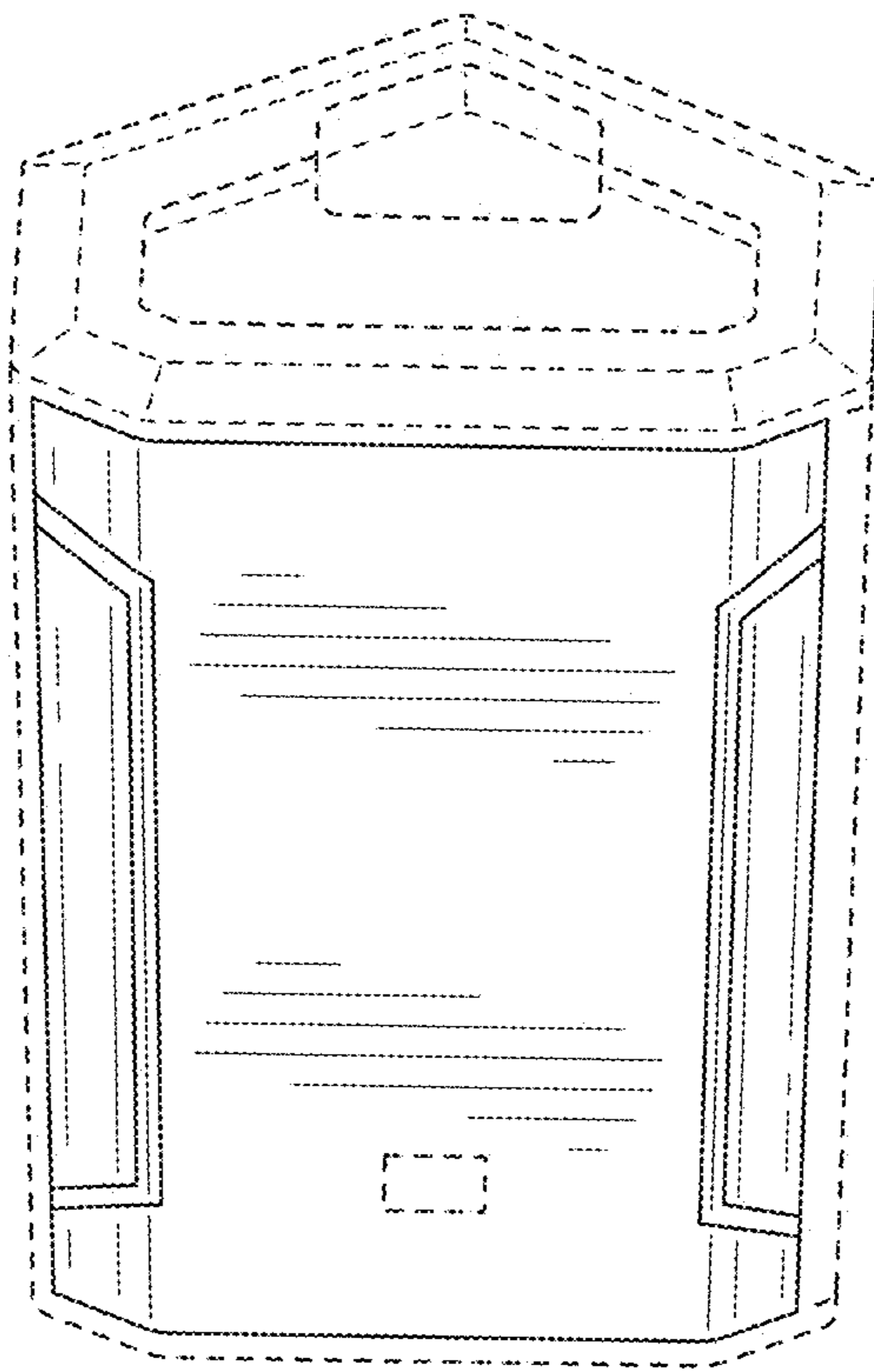

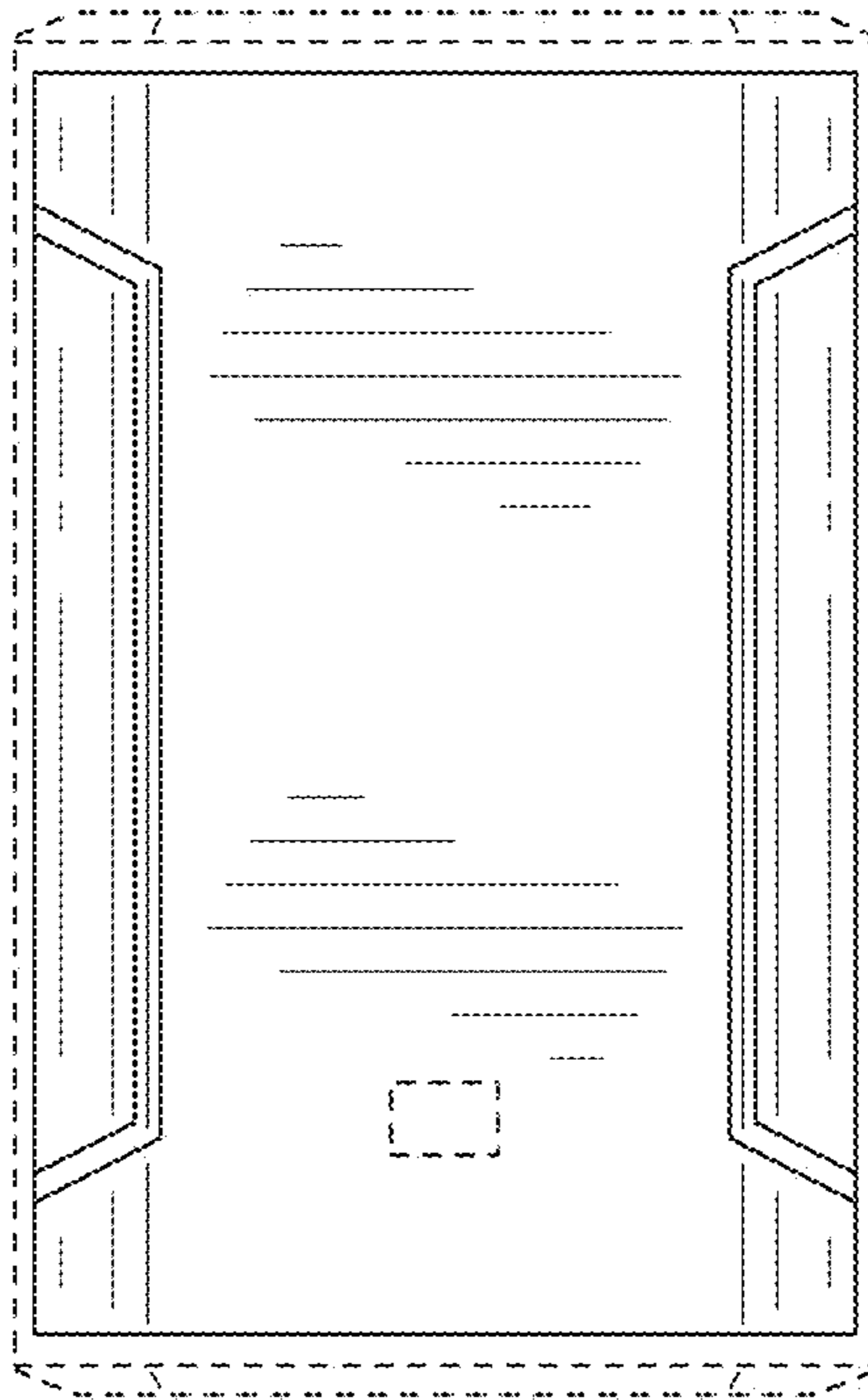

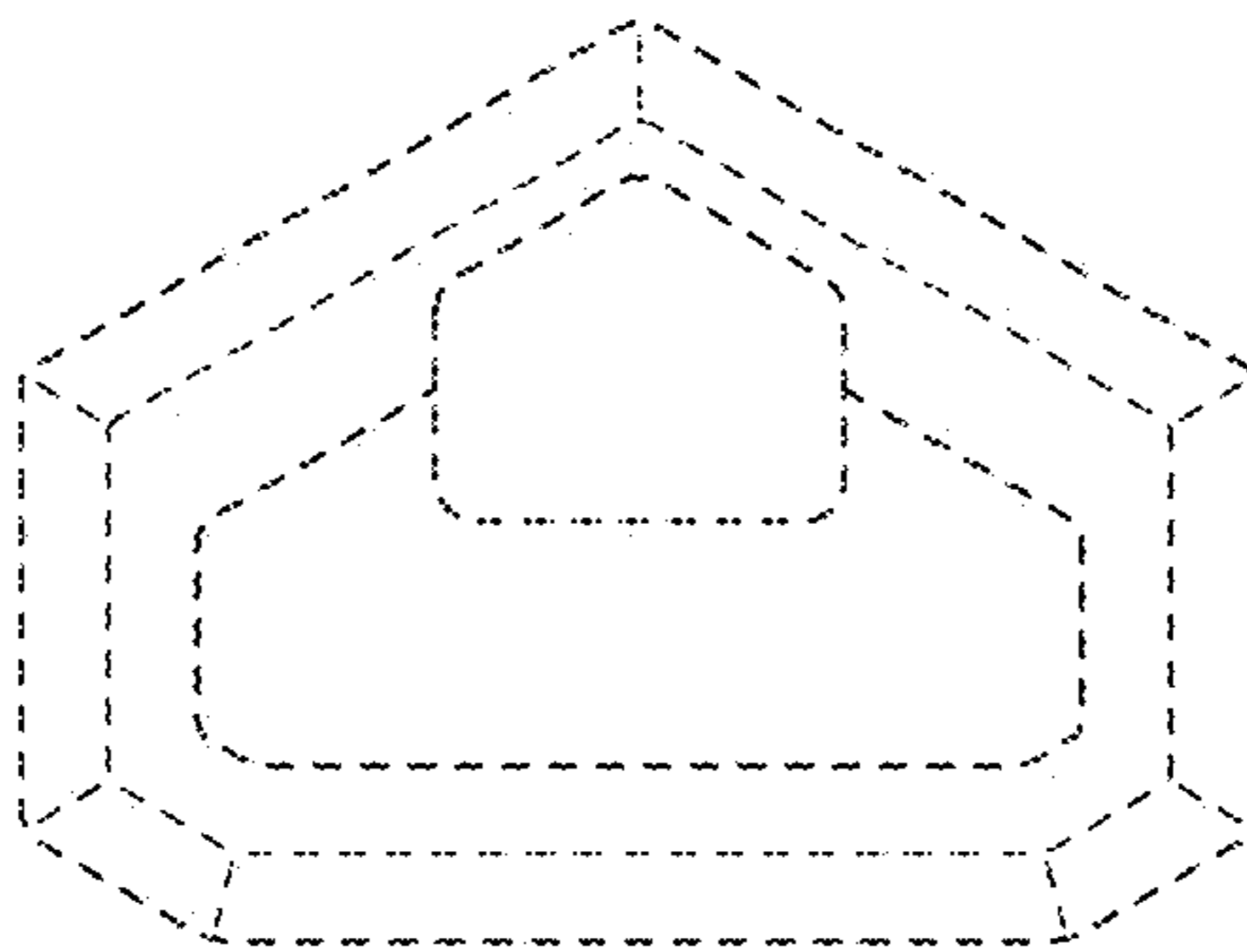

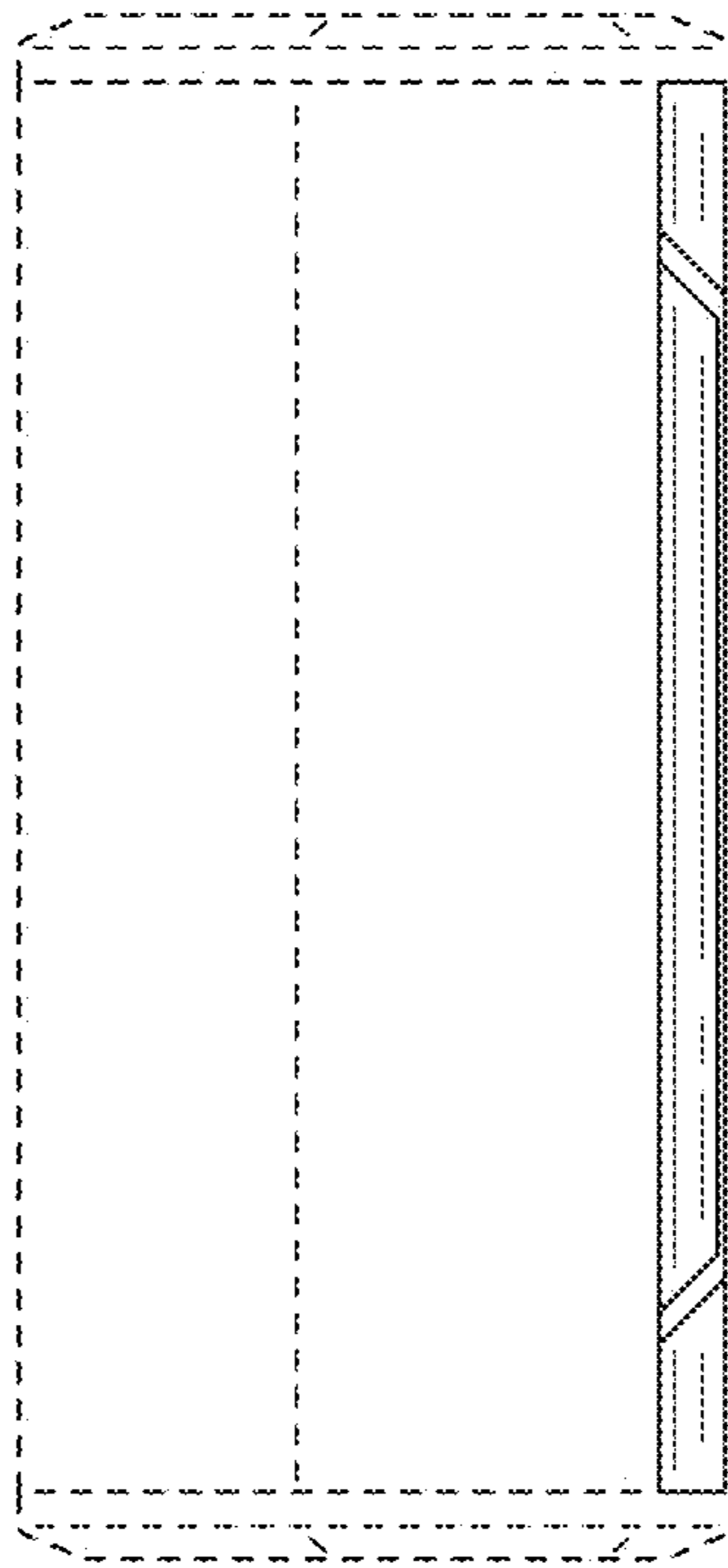
