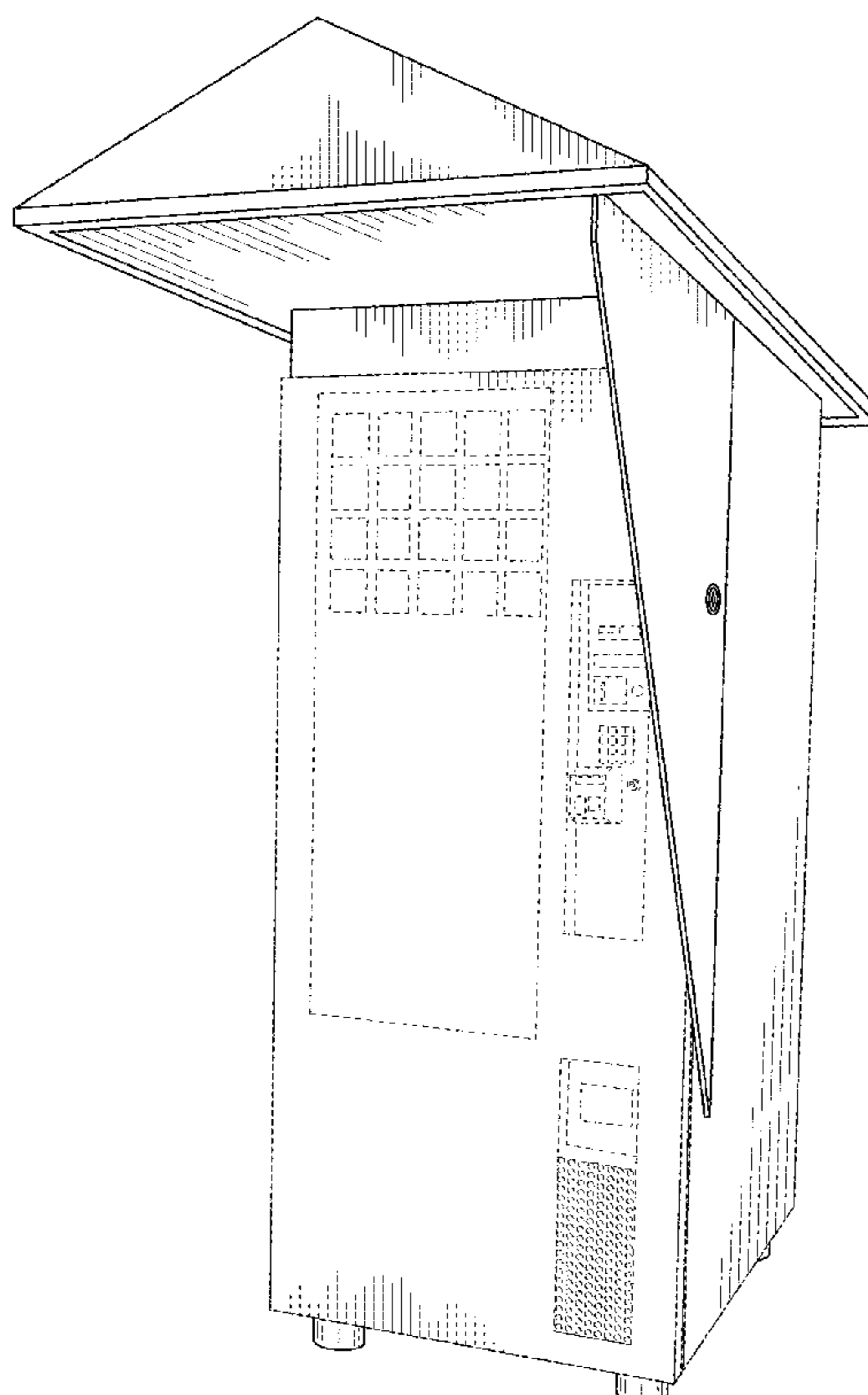
(57) **CLAIM**  
We claim the ornamental design for a vending machine cage,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a vending machine cage,  
showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a right-side elevational view thereof;  
FIG. 5 is a left-side elevational view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The broken lines showing a vending machine and mounting  
hardware in the figures depict environmental matter and form  
no part of the claimed design.

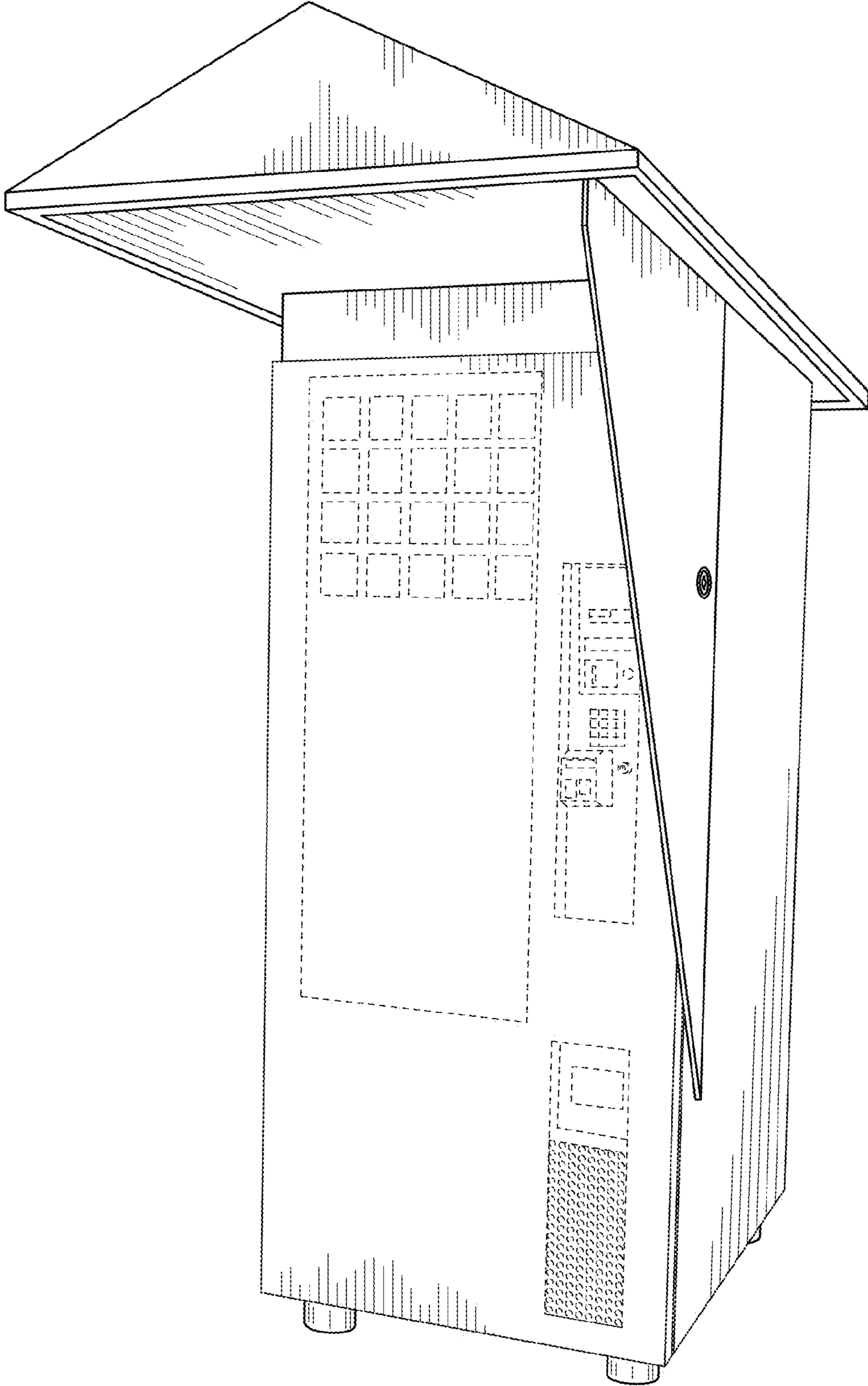

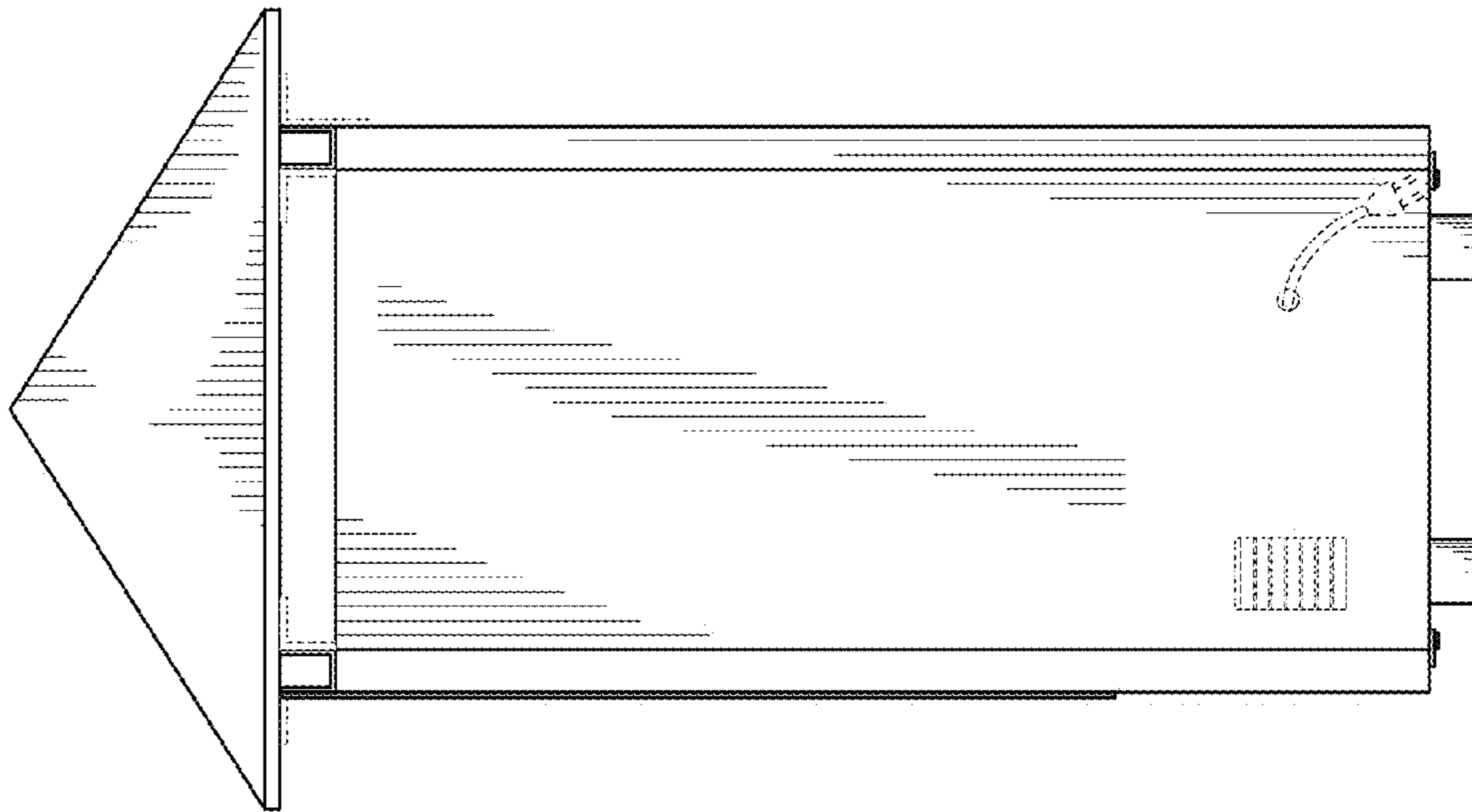

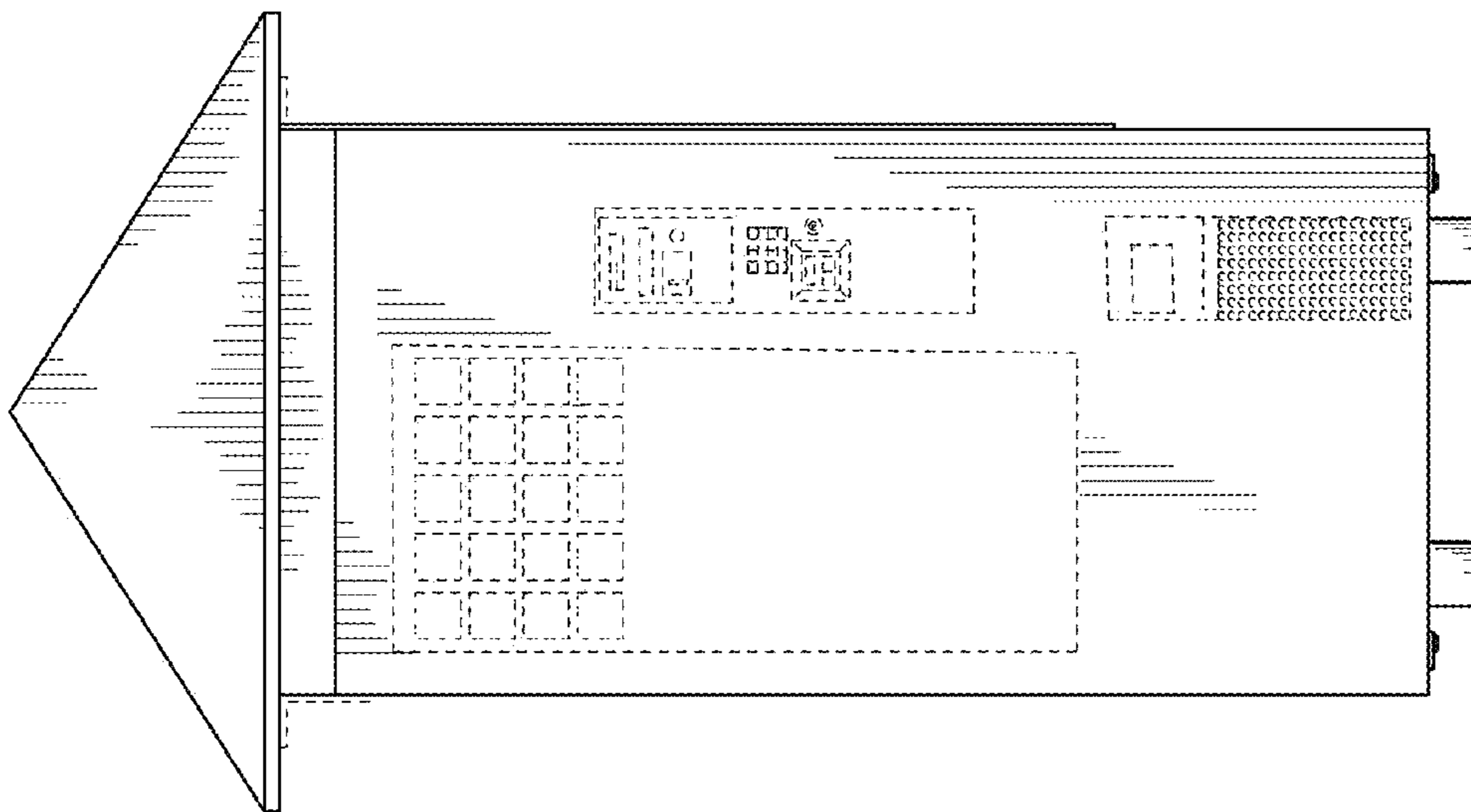

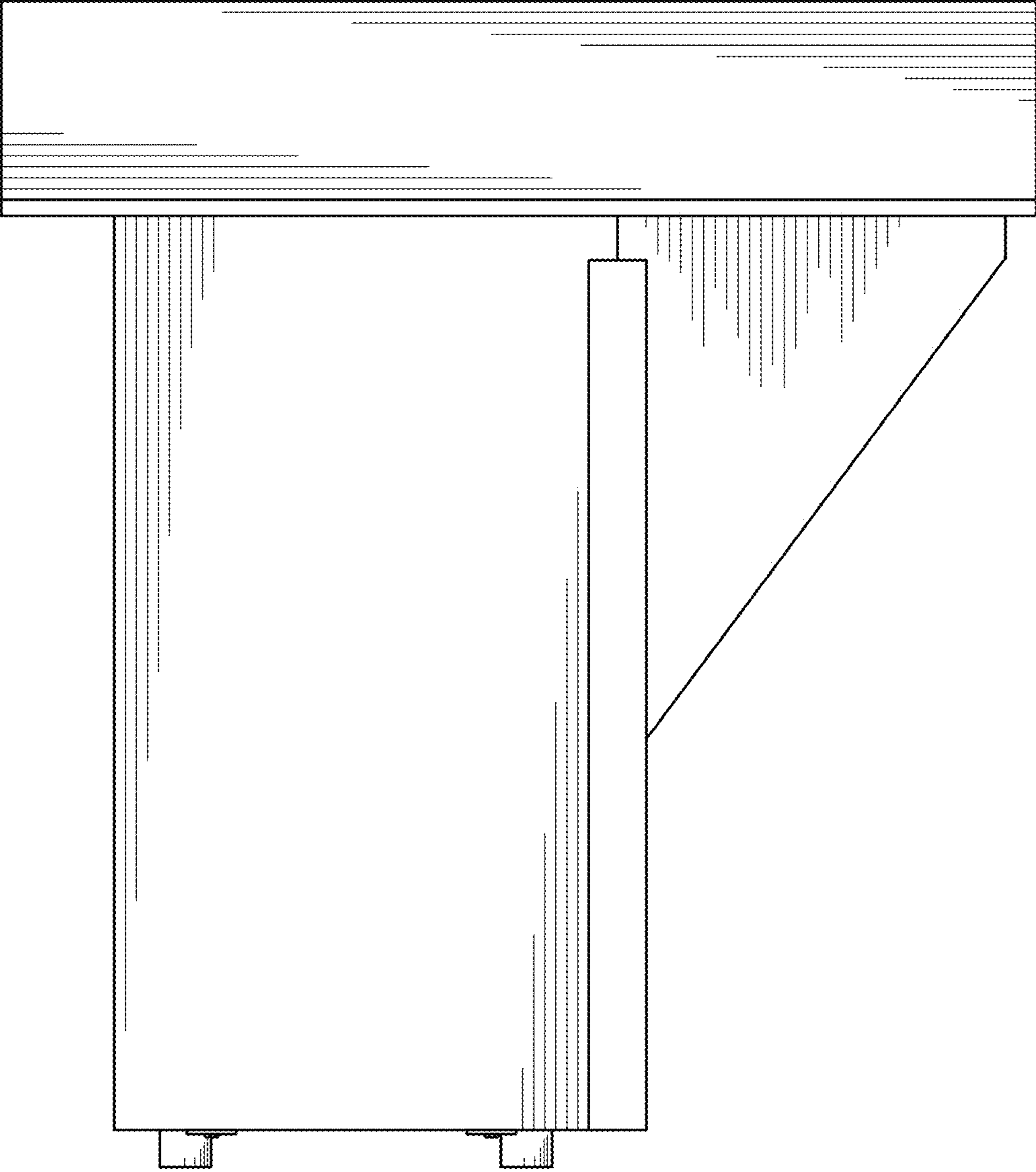

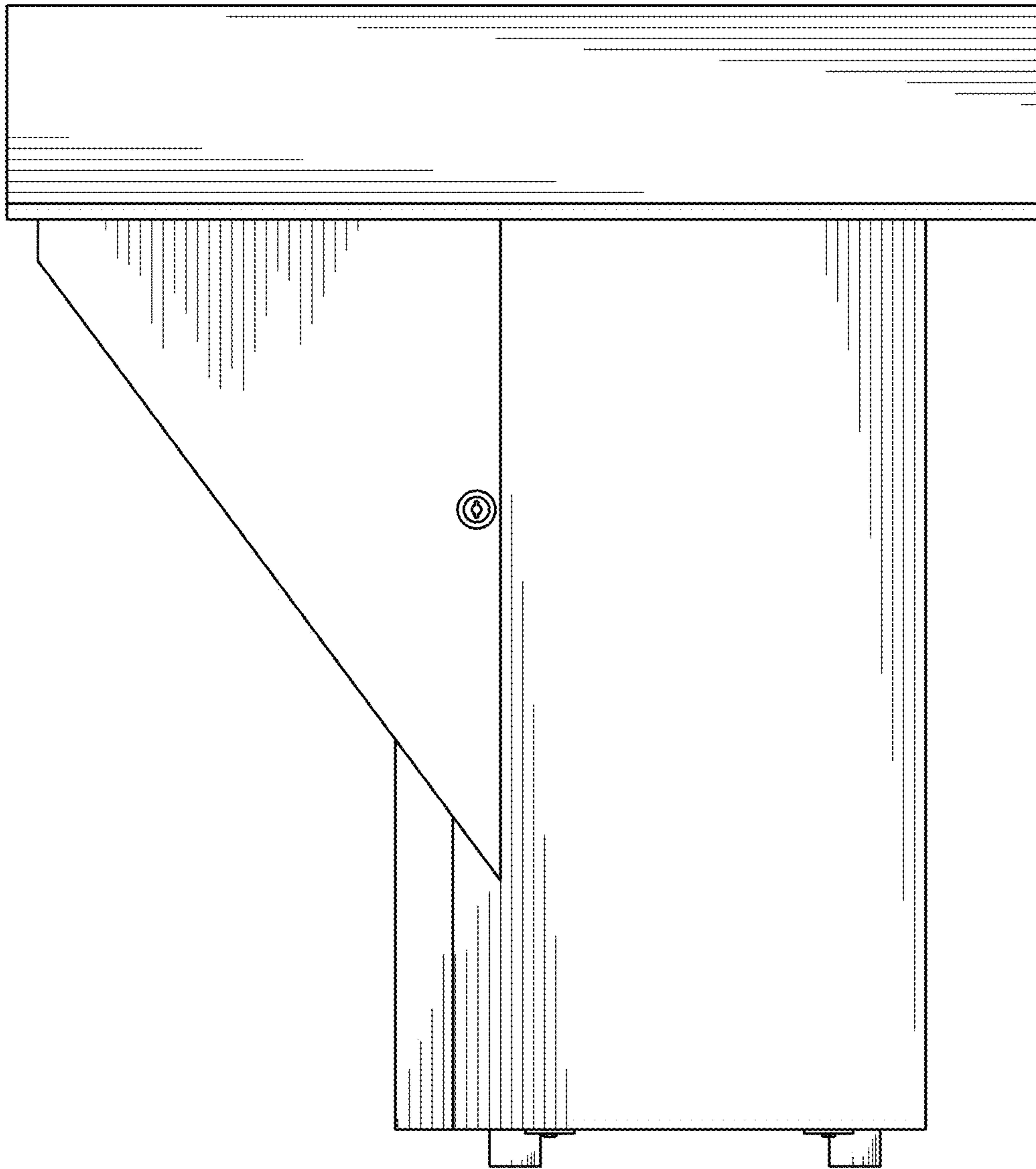

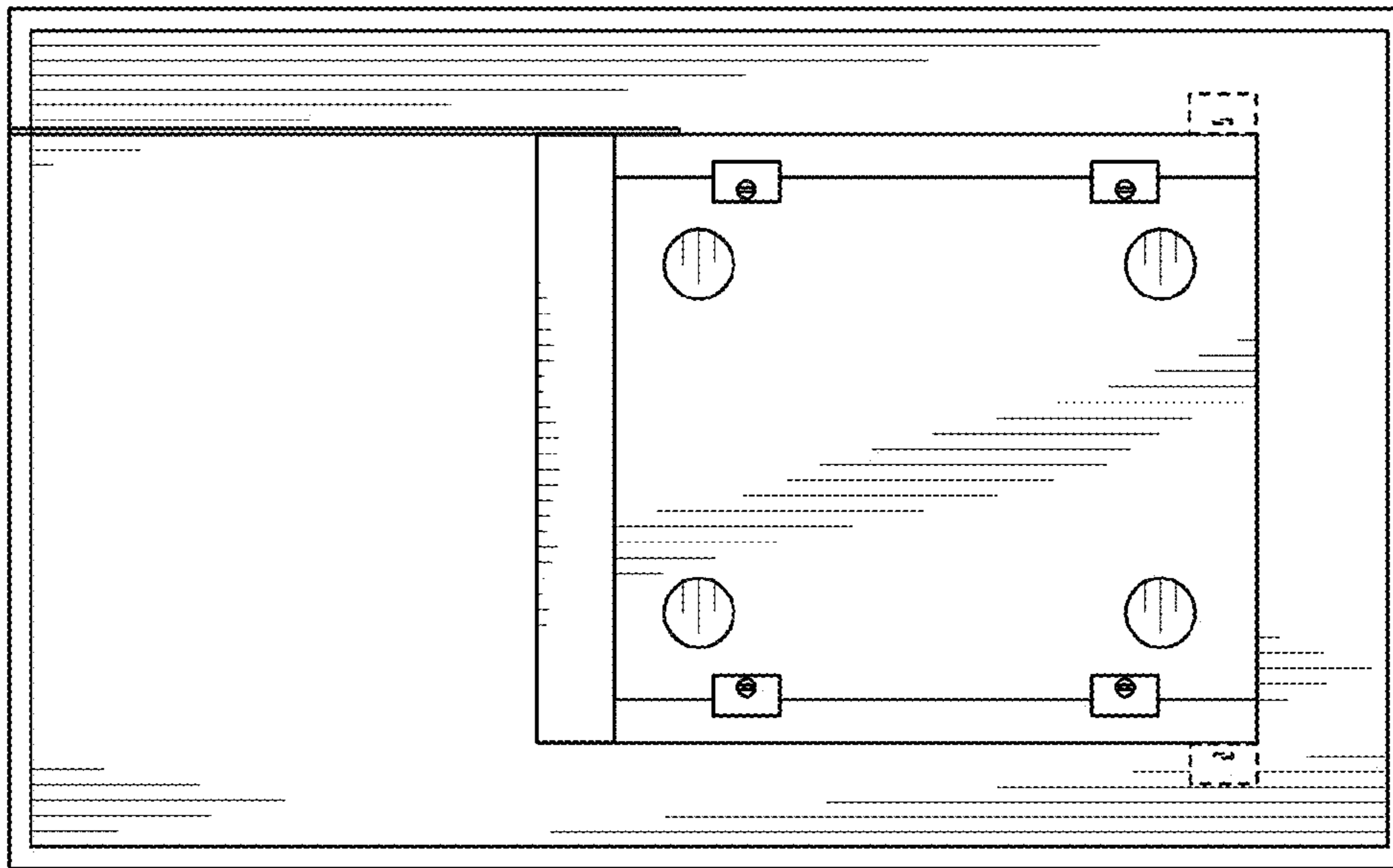

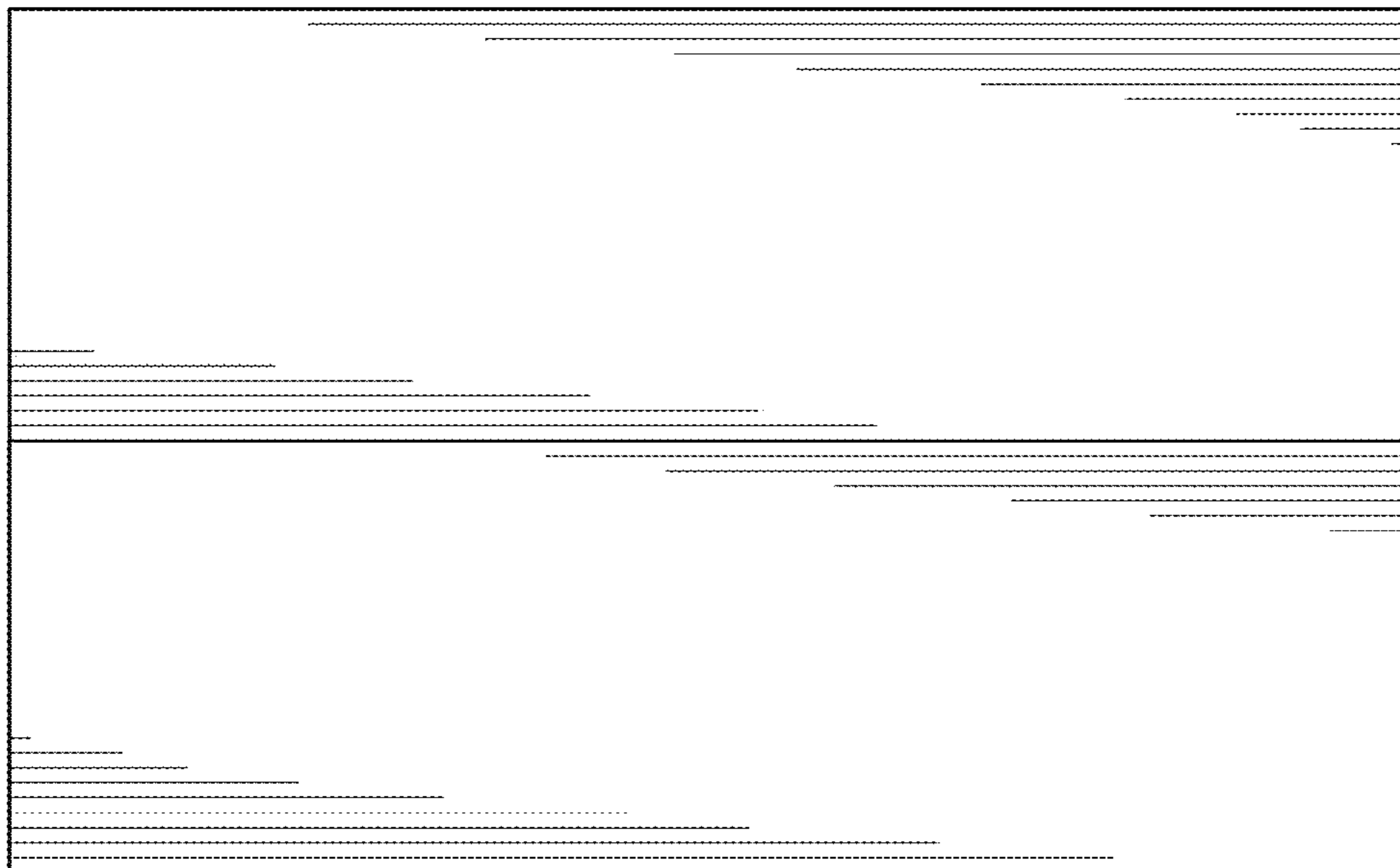
