(57) **CLAIM**

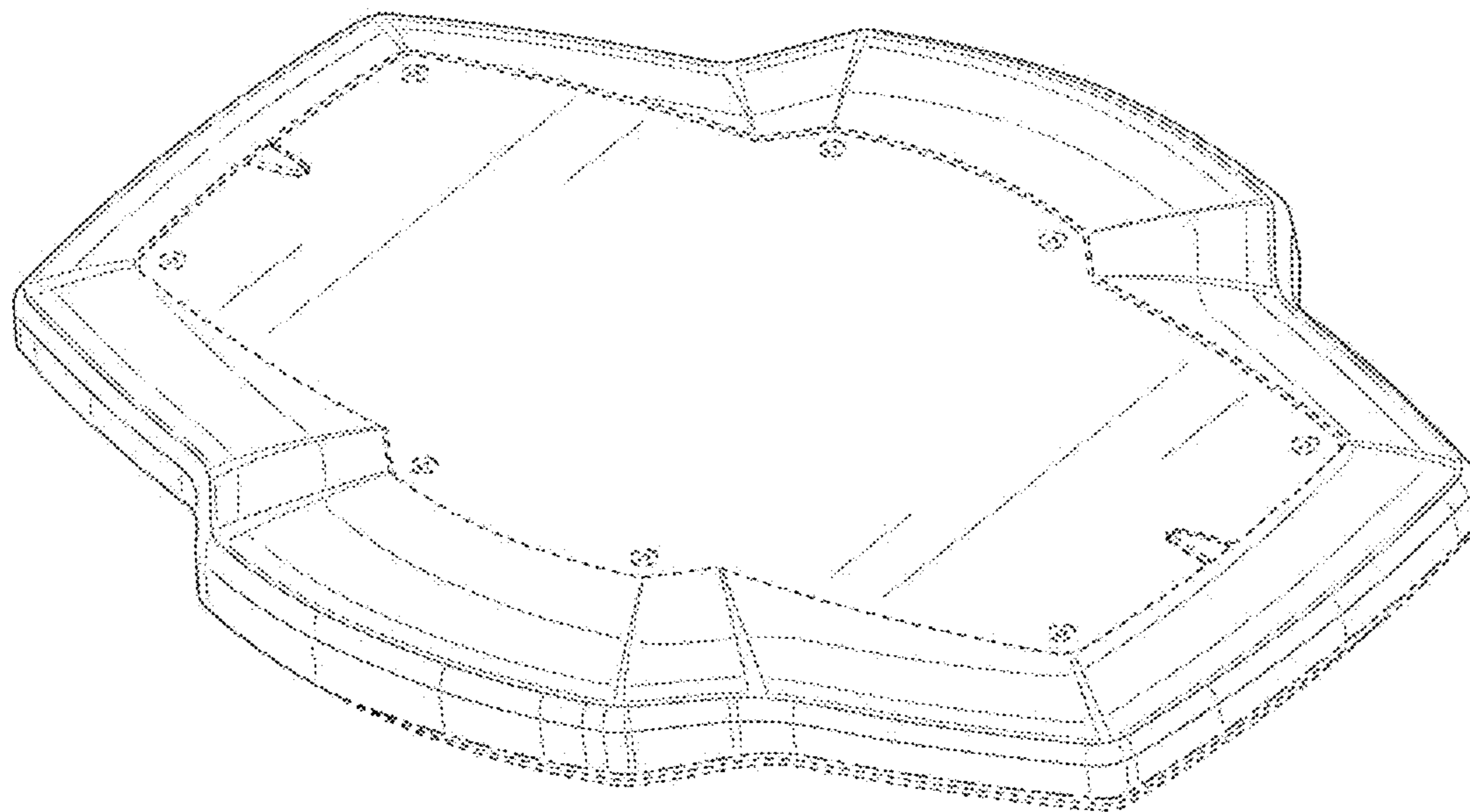
The ornamental design for a foot board, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view taken from a top, front, right side of a foot board, according to our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a right side elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is a front elevation view thereof; and, FIG. 7 is a bottom plan view thereof.

Throughout the figures, the dashed broken lines show unclaimed structure of the foot board, and form no part of the claimed design. The dash-dot broken lines represent the boundary between claimed and unclaimed areas and form no part of the claimed design.

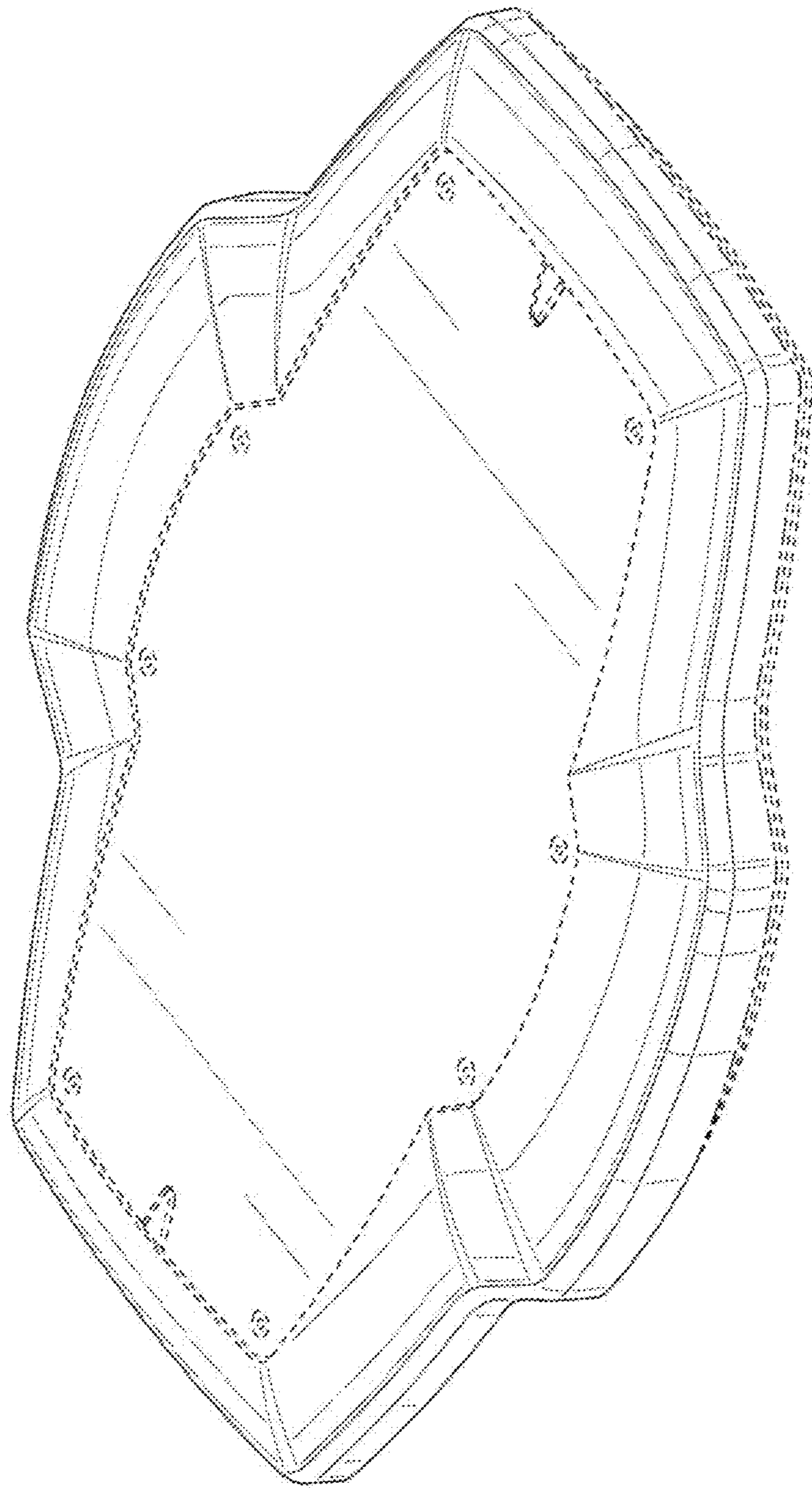

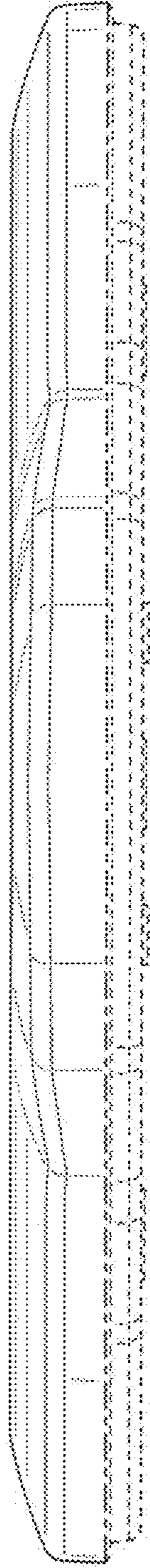

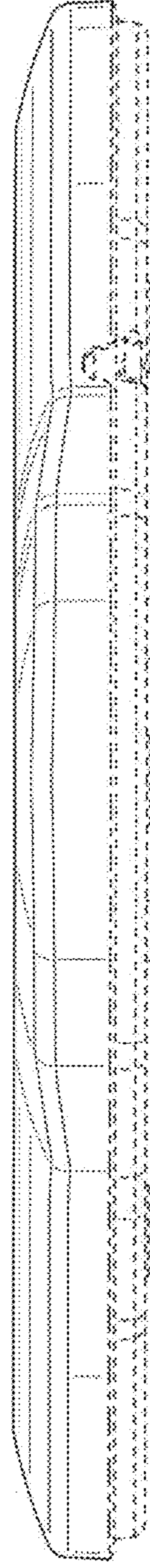

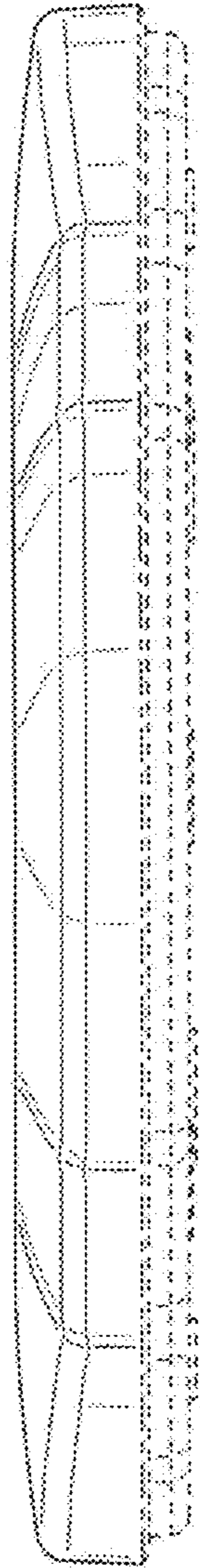

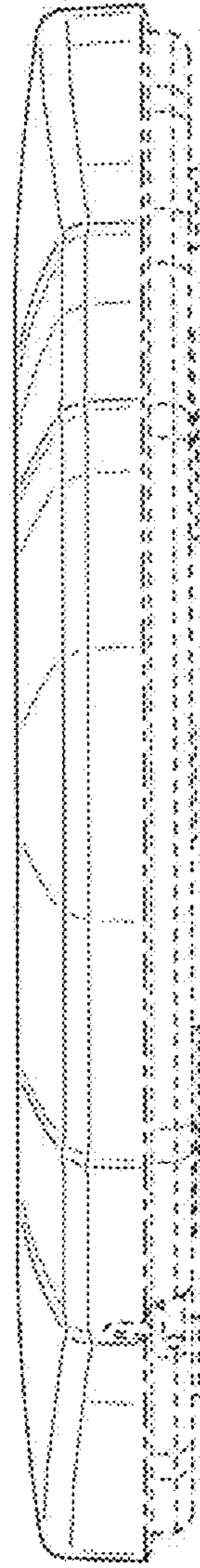

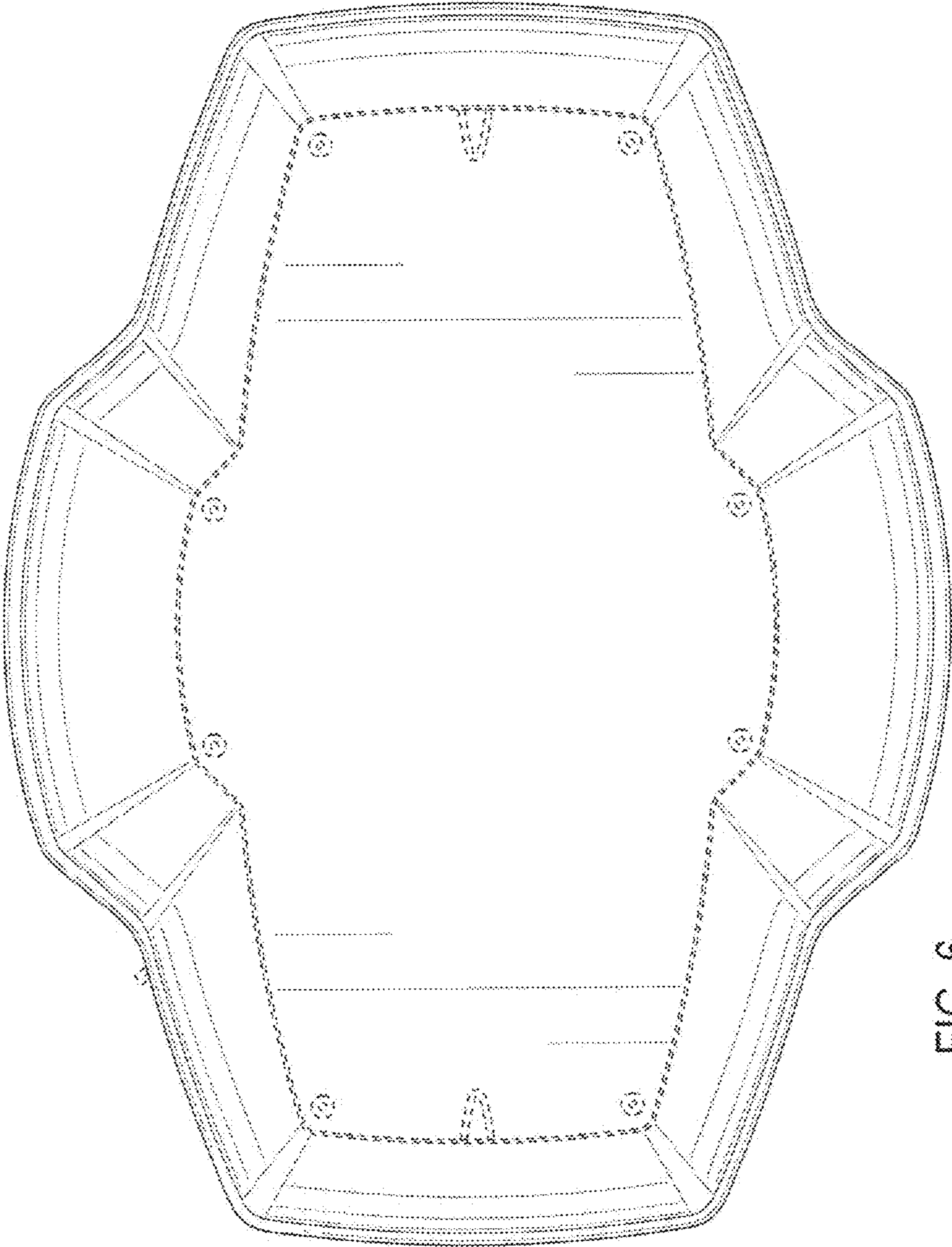

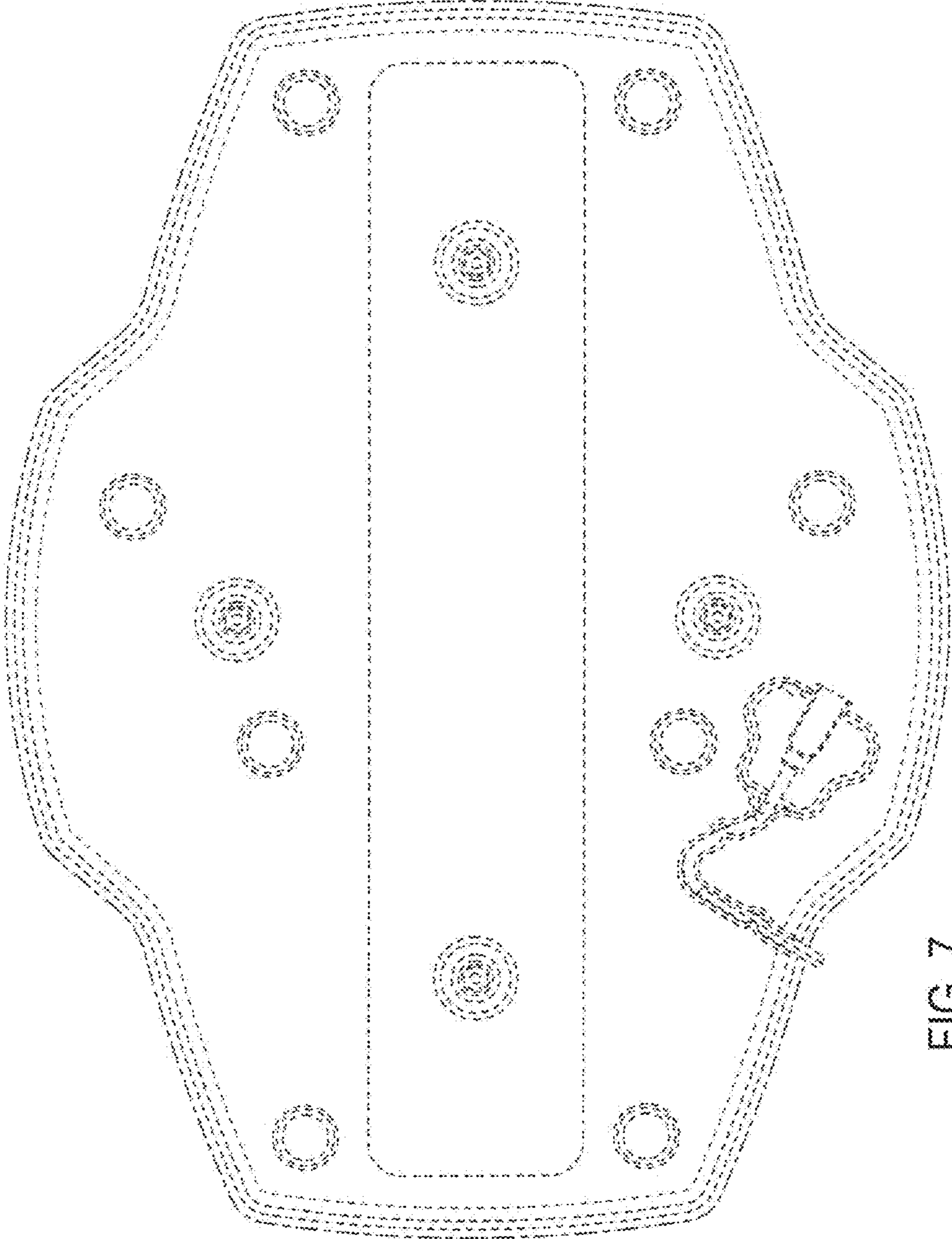
