FIG. 3 illustrates a side view thereof;

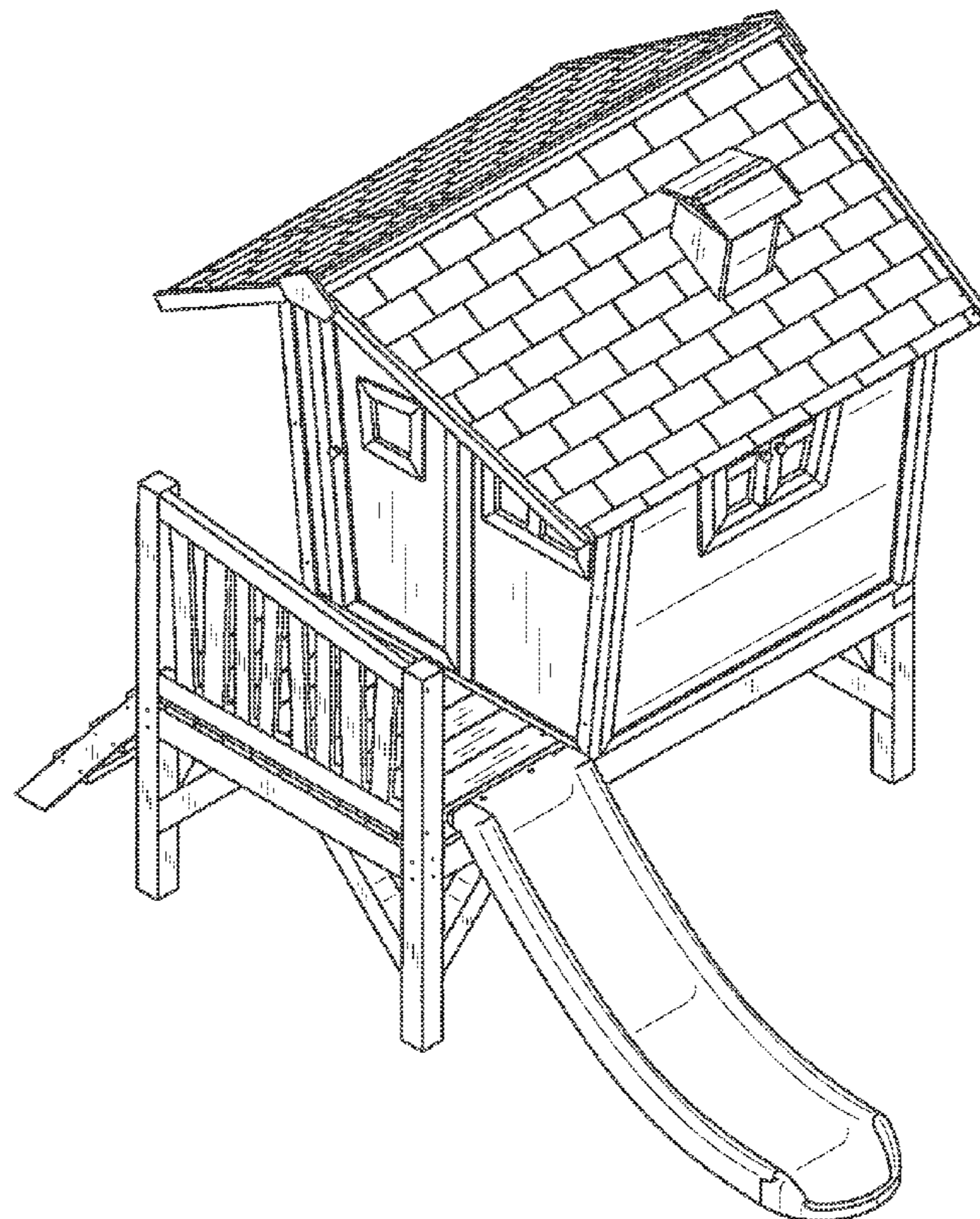
FIG. 4 illustrates a top view thereof;

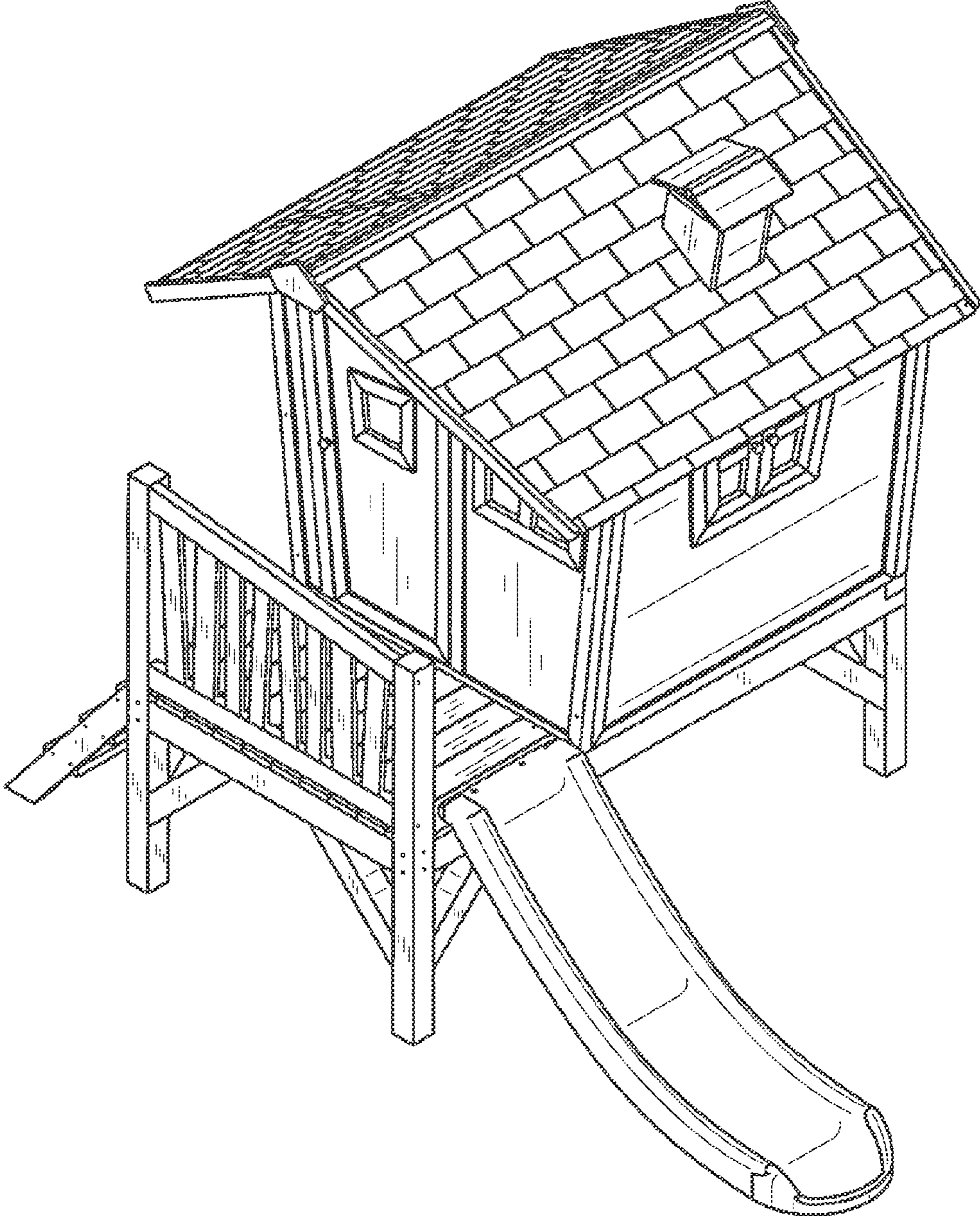

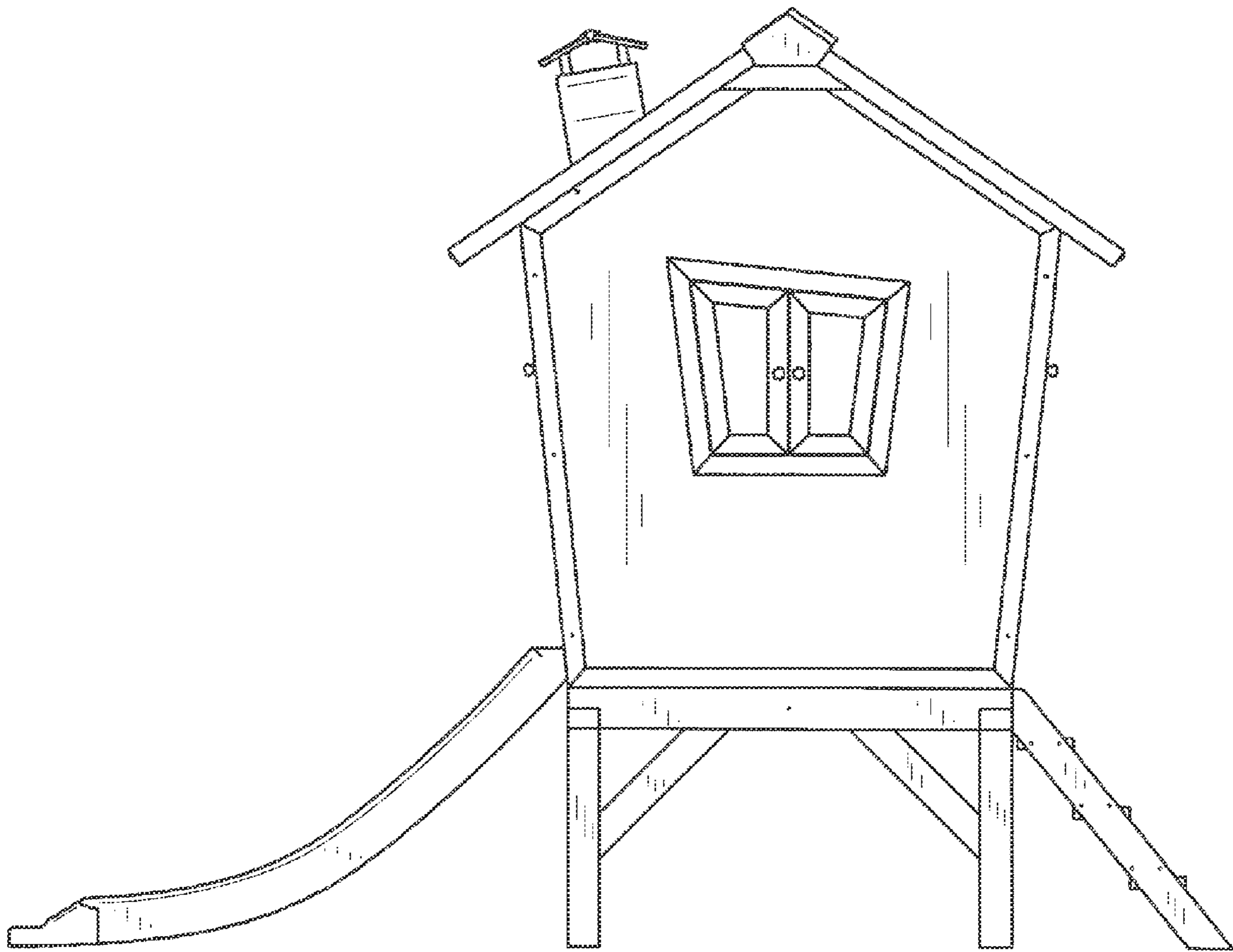

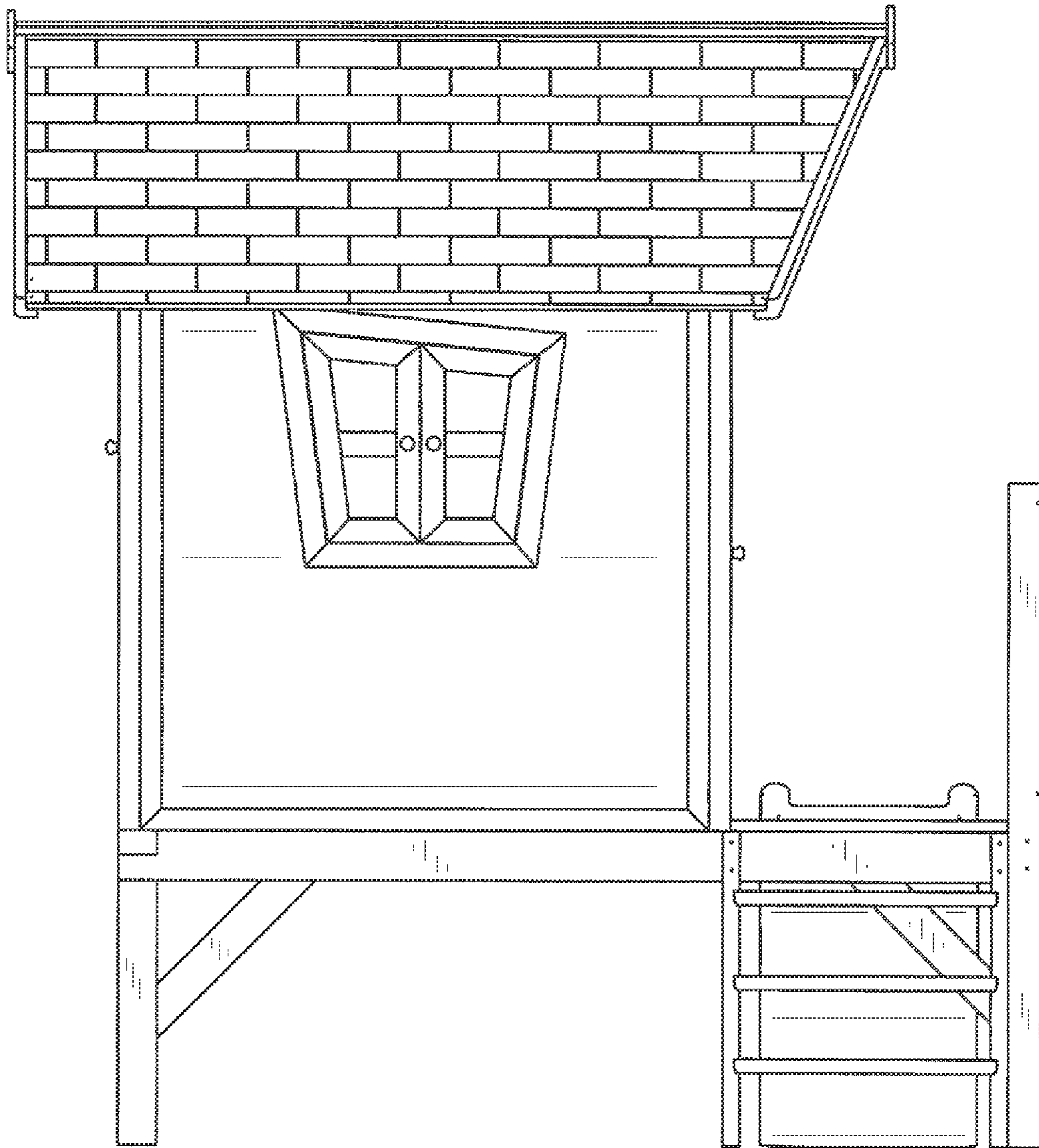

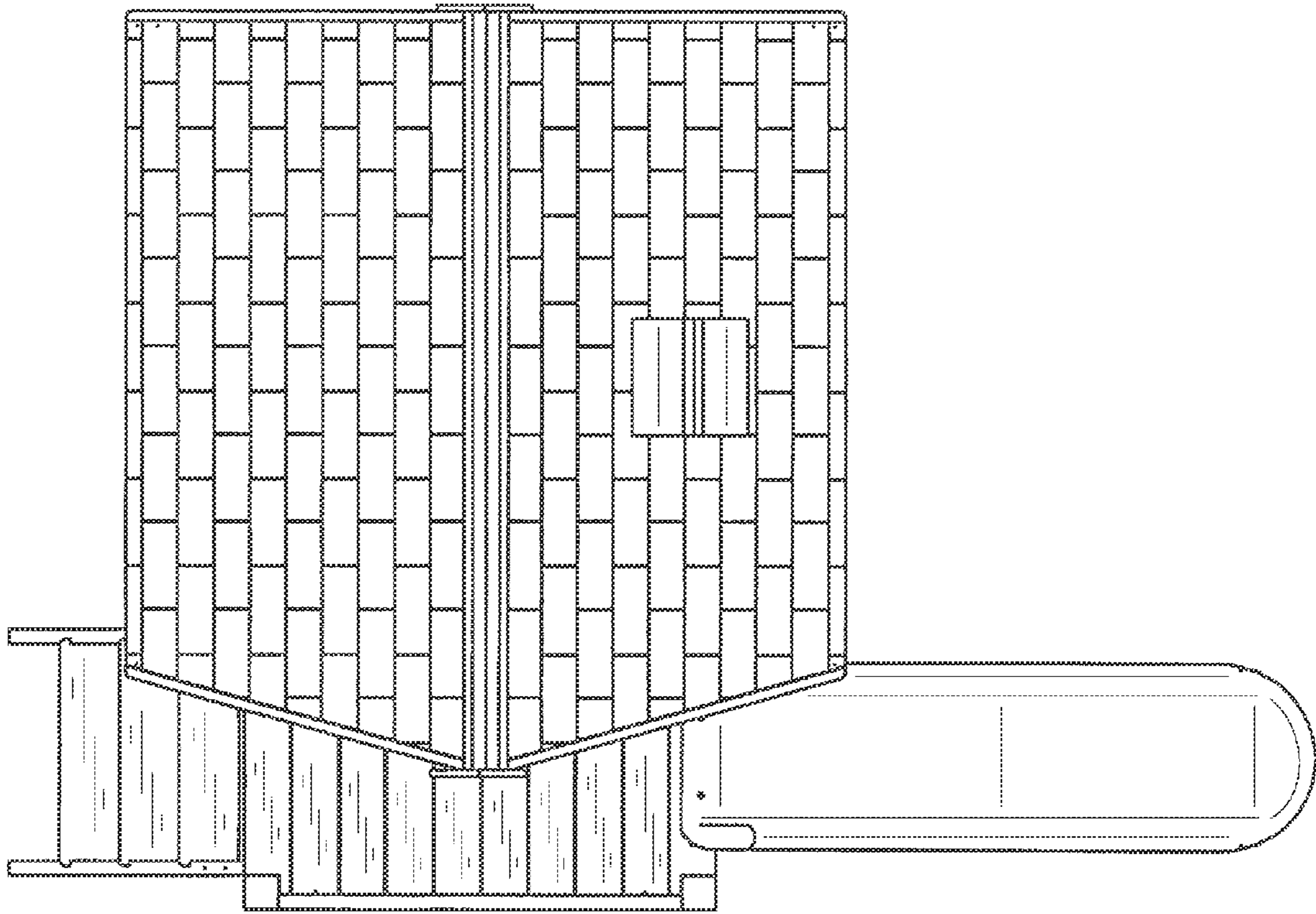

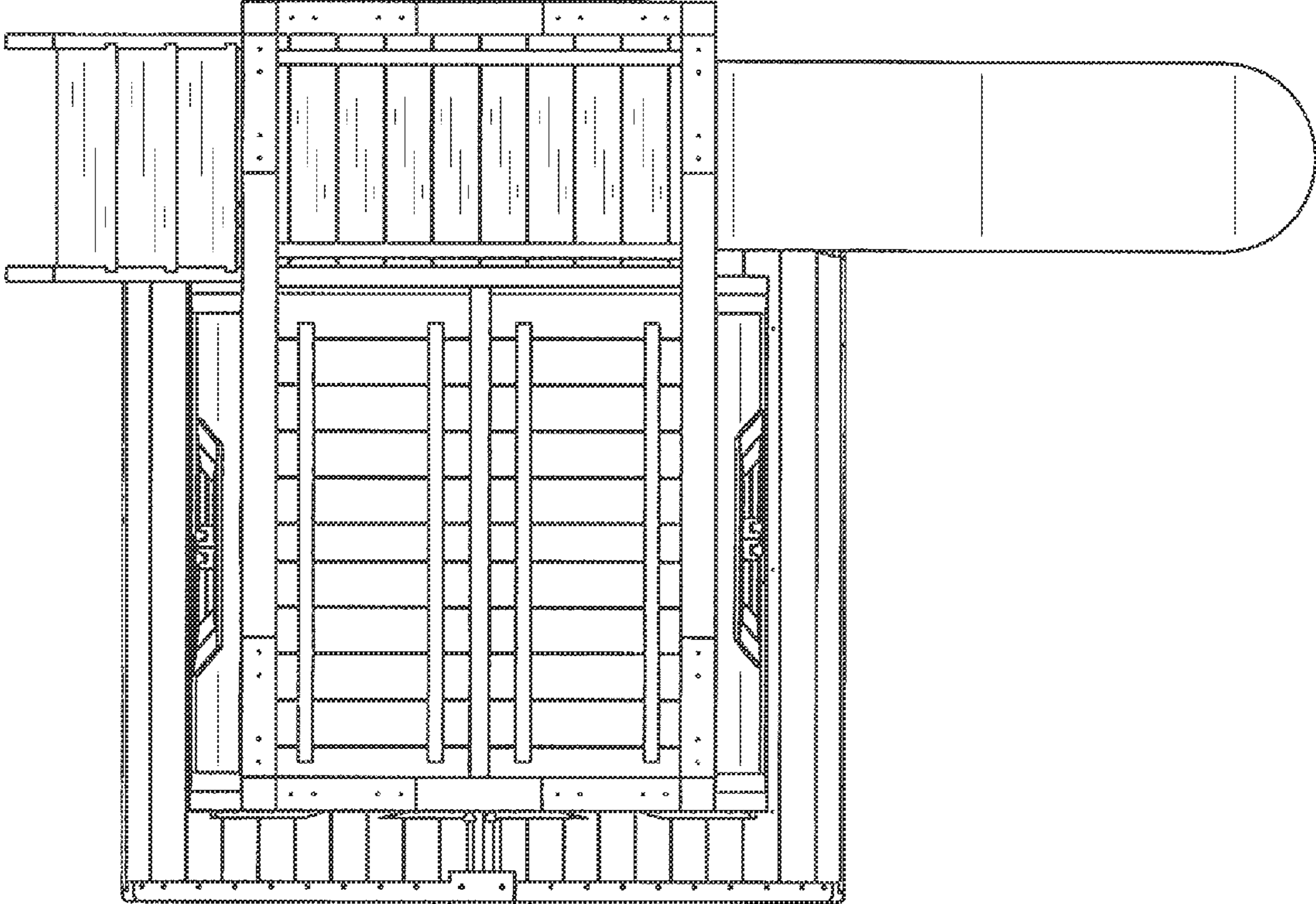

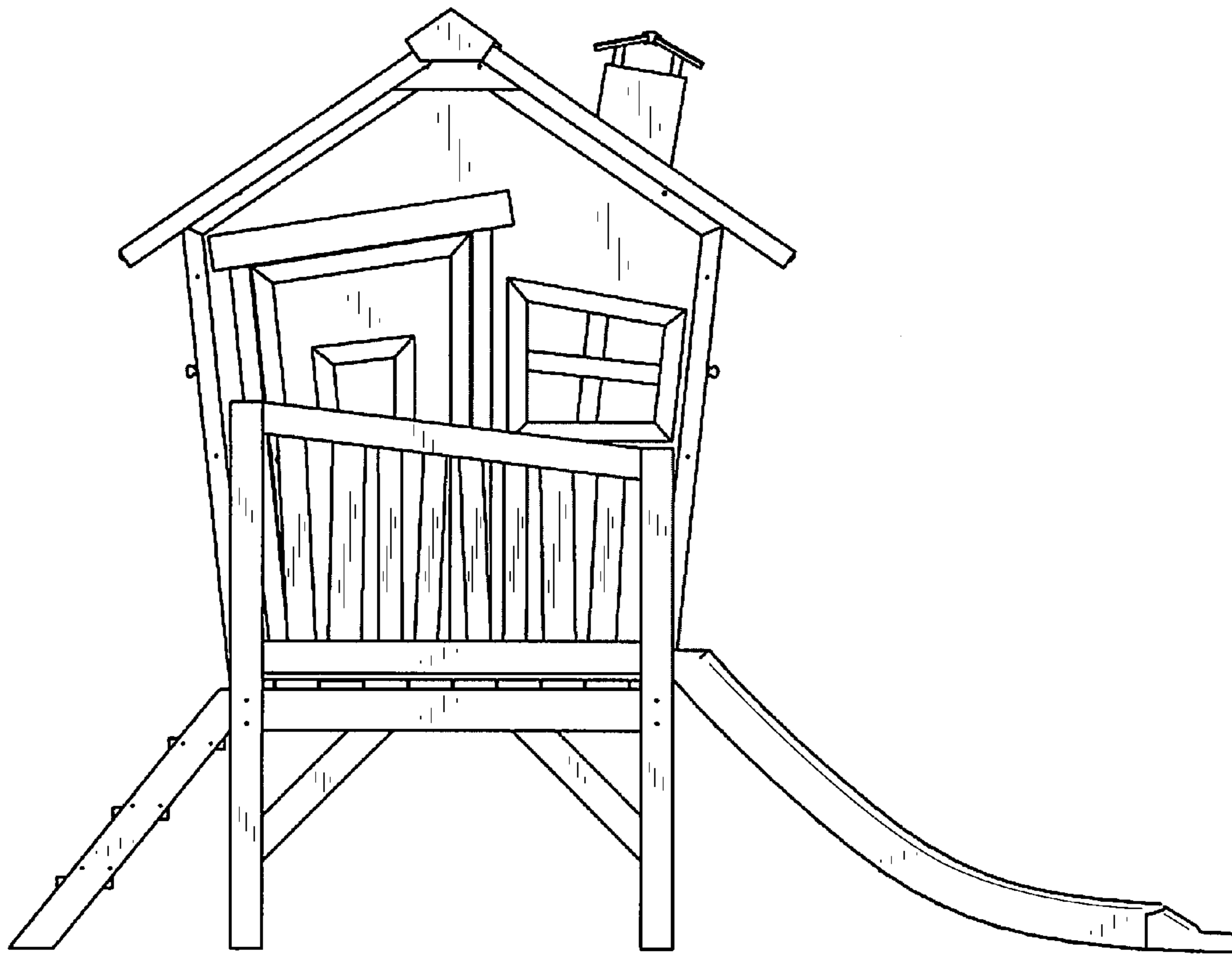

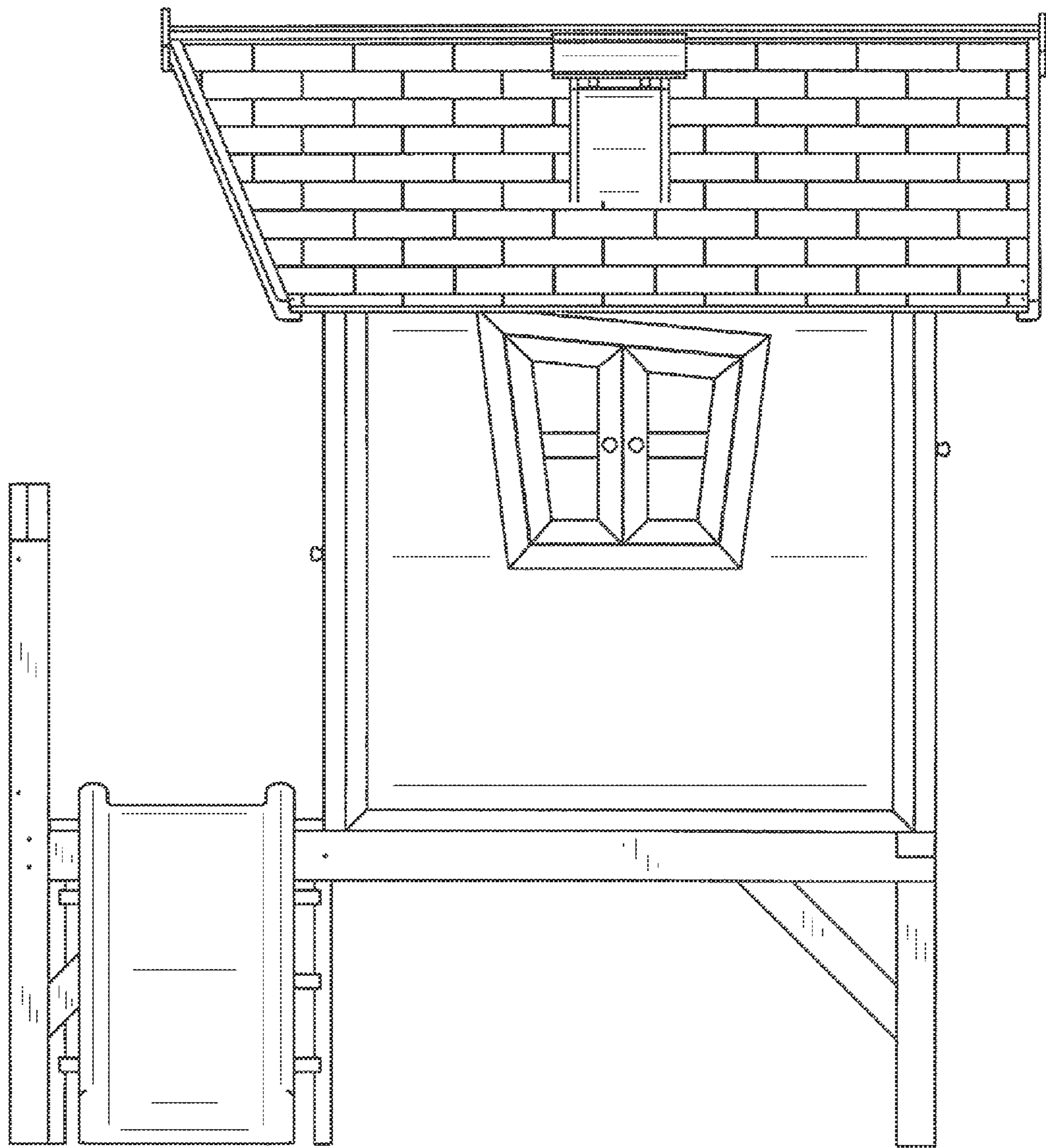
