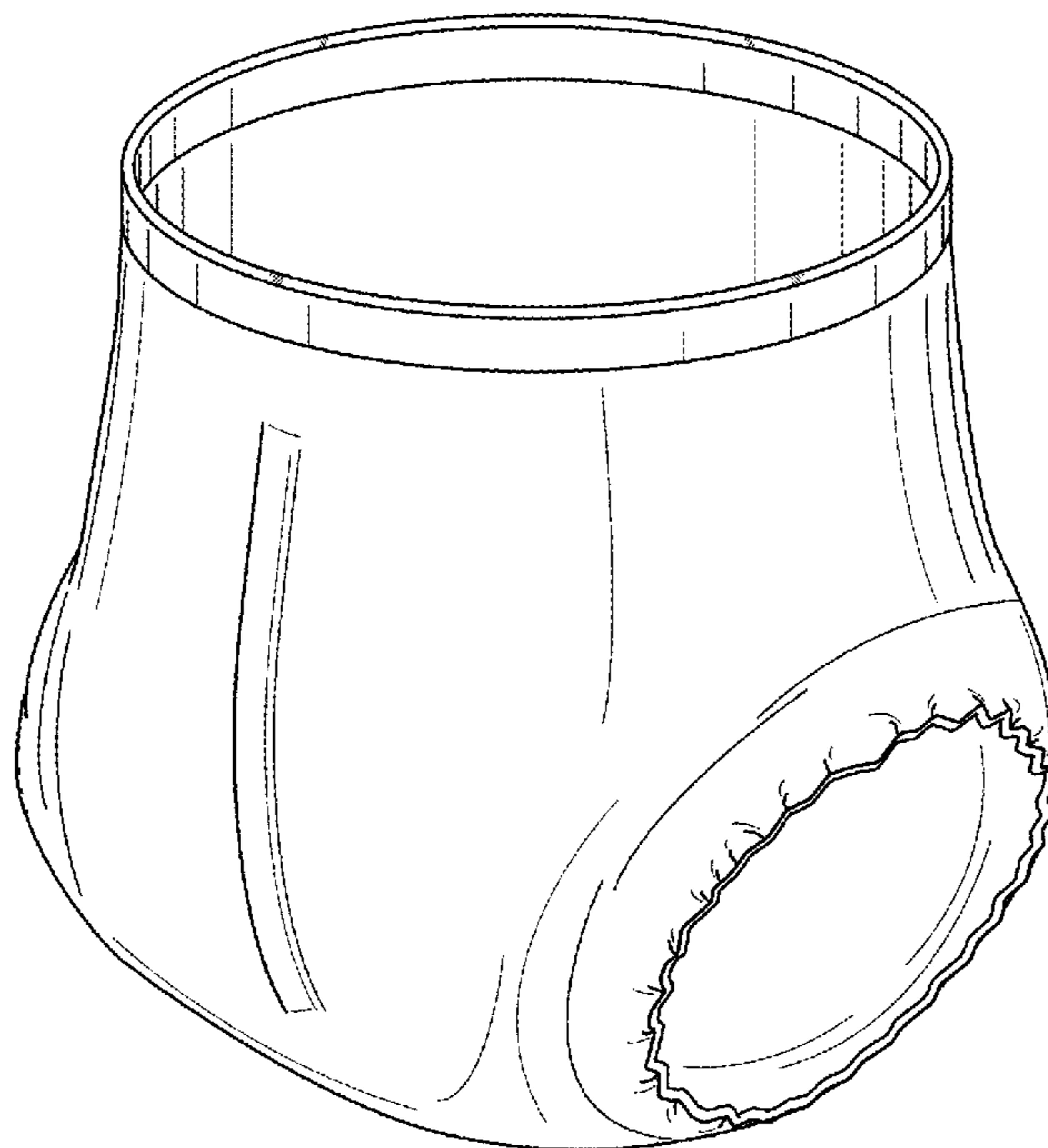
(57) **CLAIM**

The ornamental design for male incontinence underwear with a front opening fly, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective front view of male incontinence underwear with a front opening fly, showing my new design; FIG. 2 is a perspective rear view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a bottom view thereof.

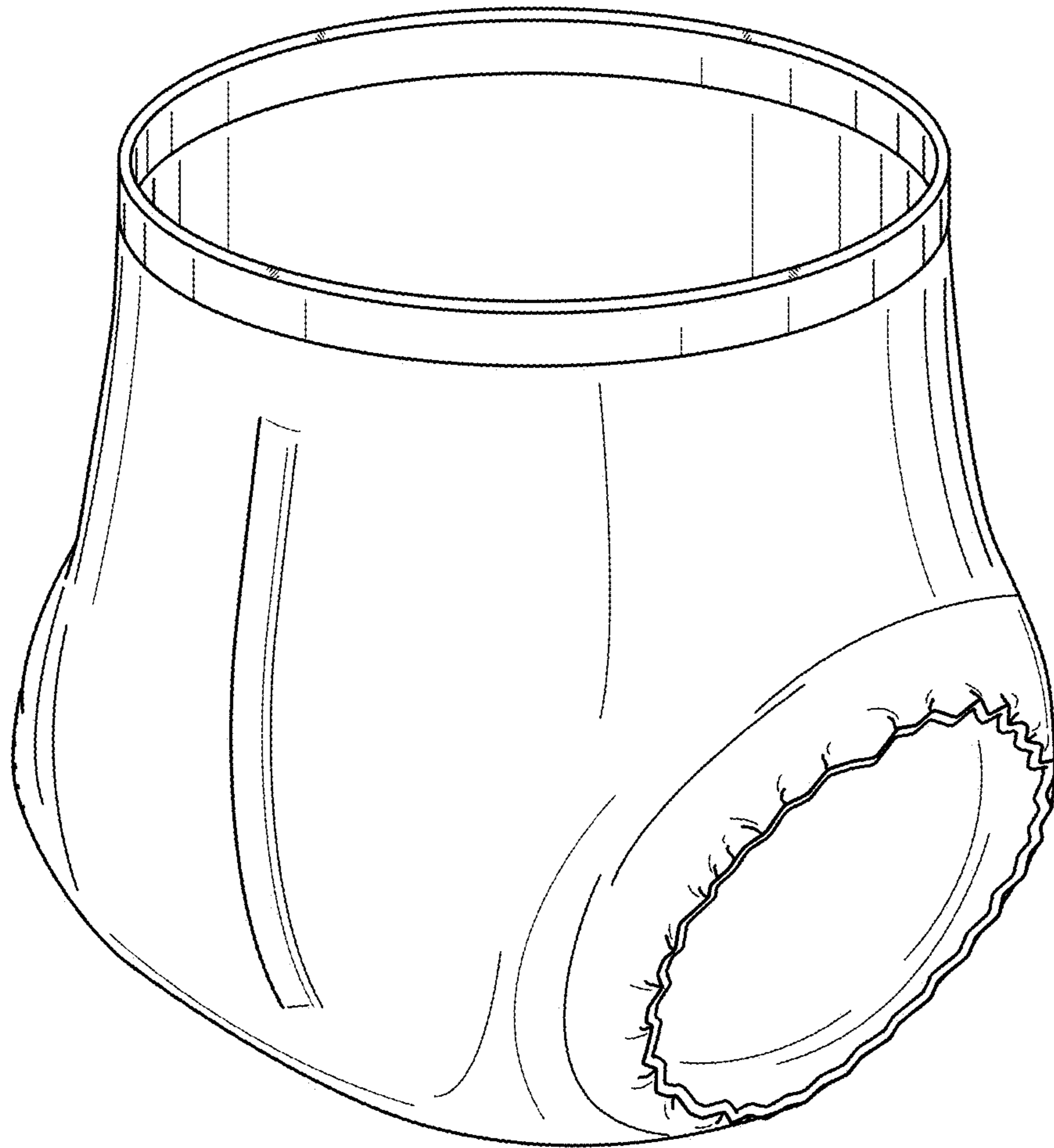

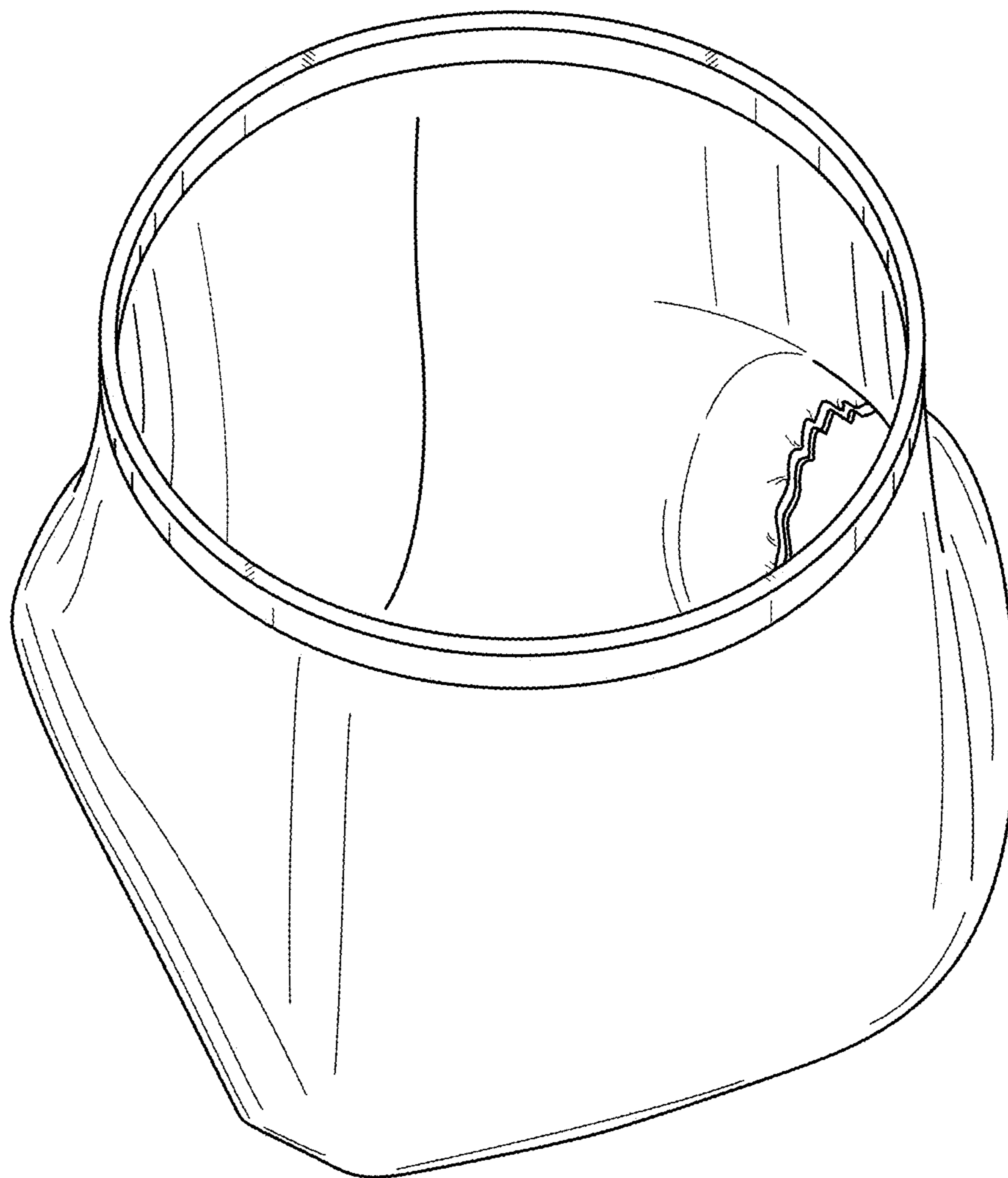

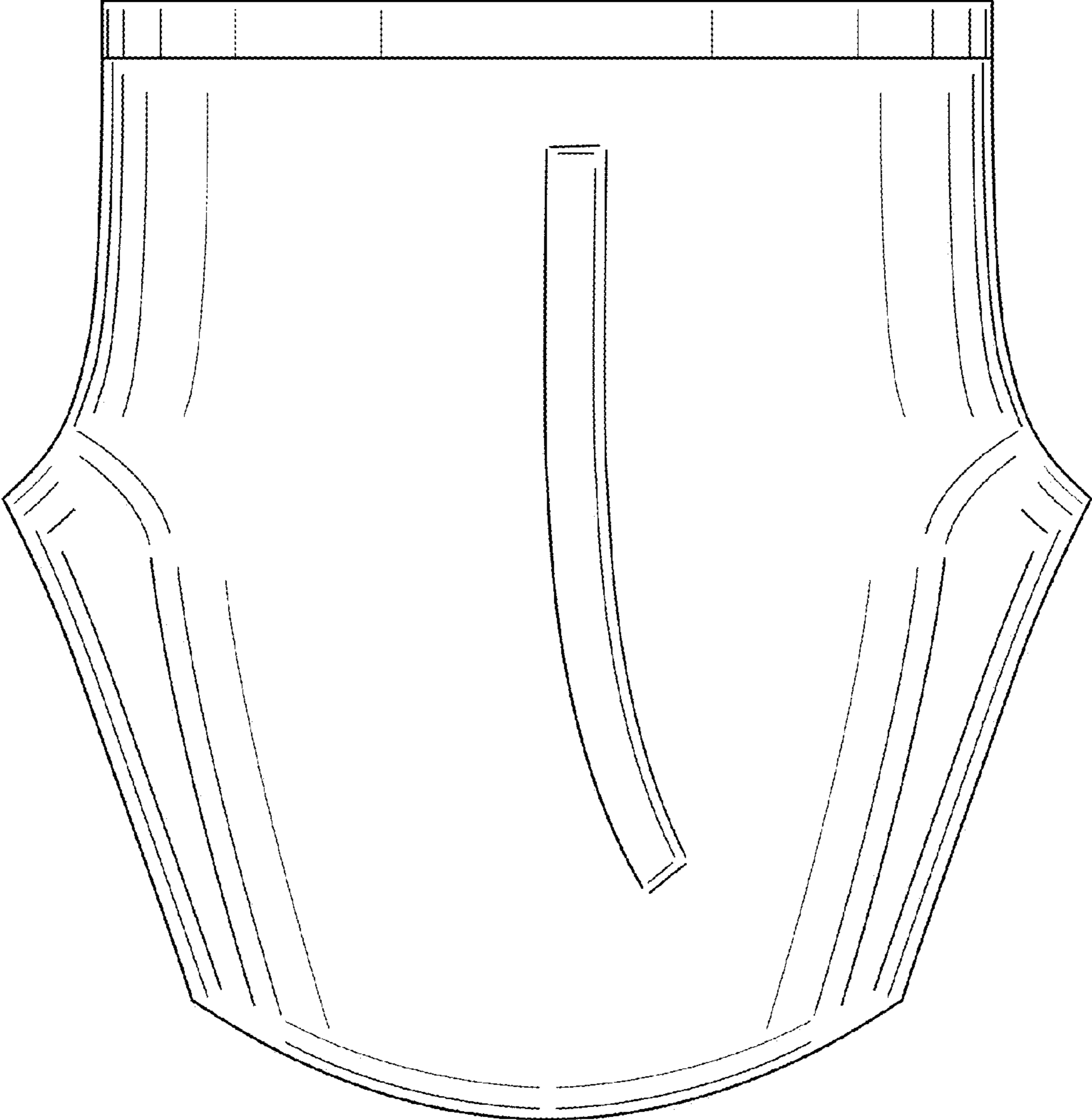

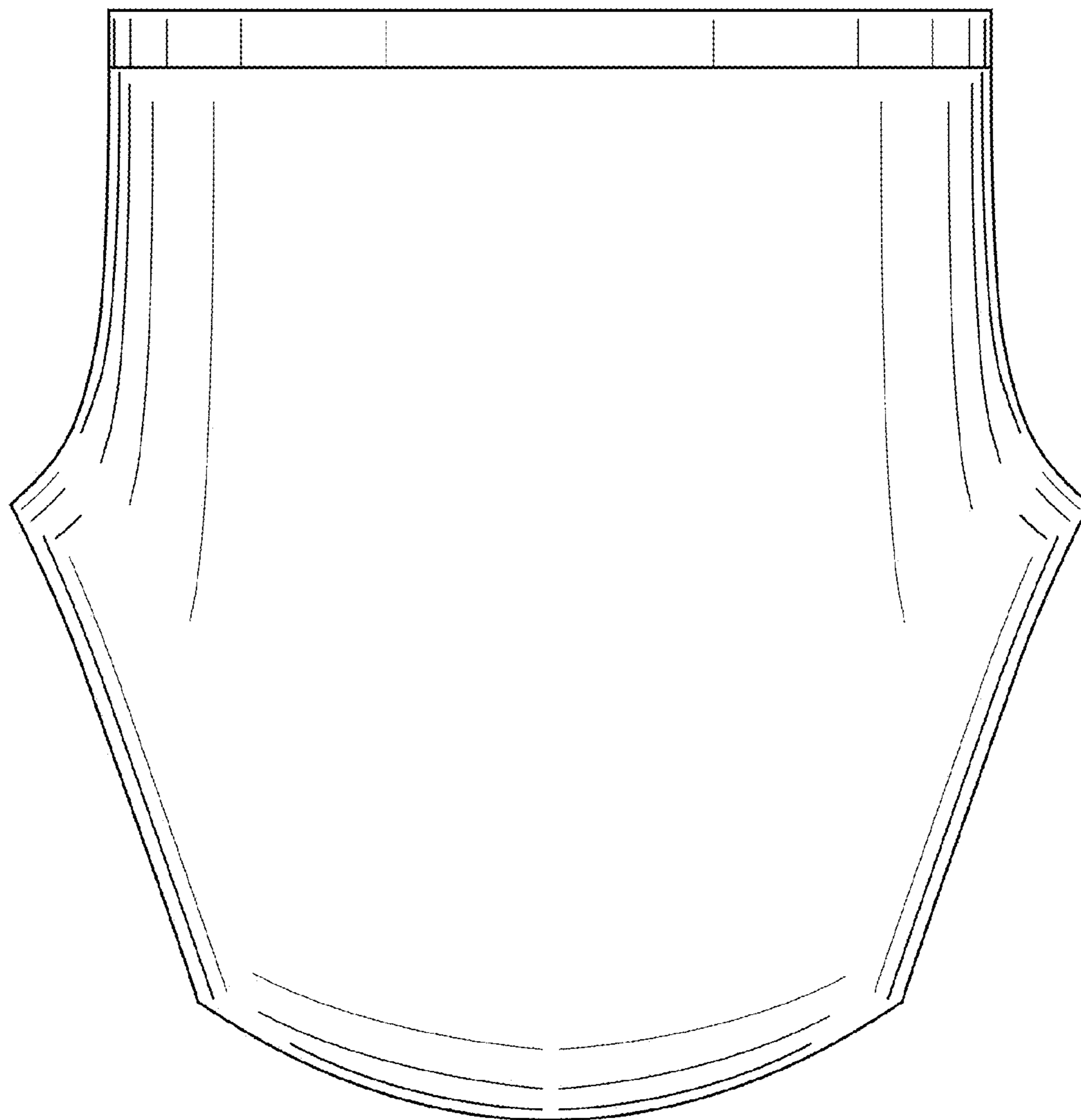

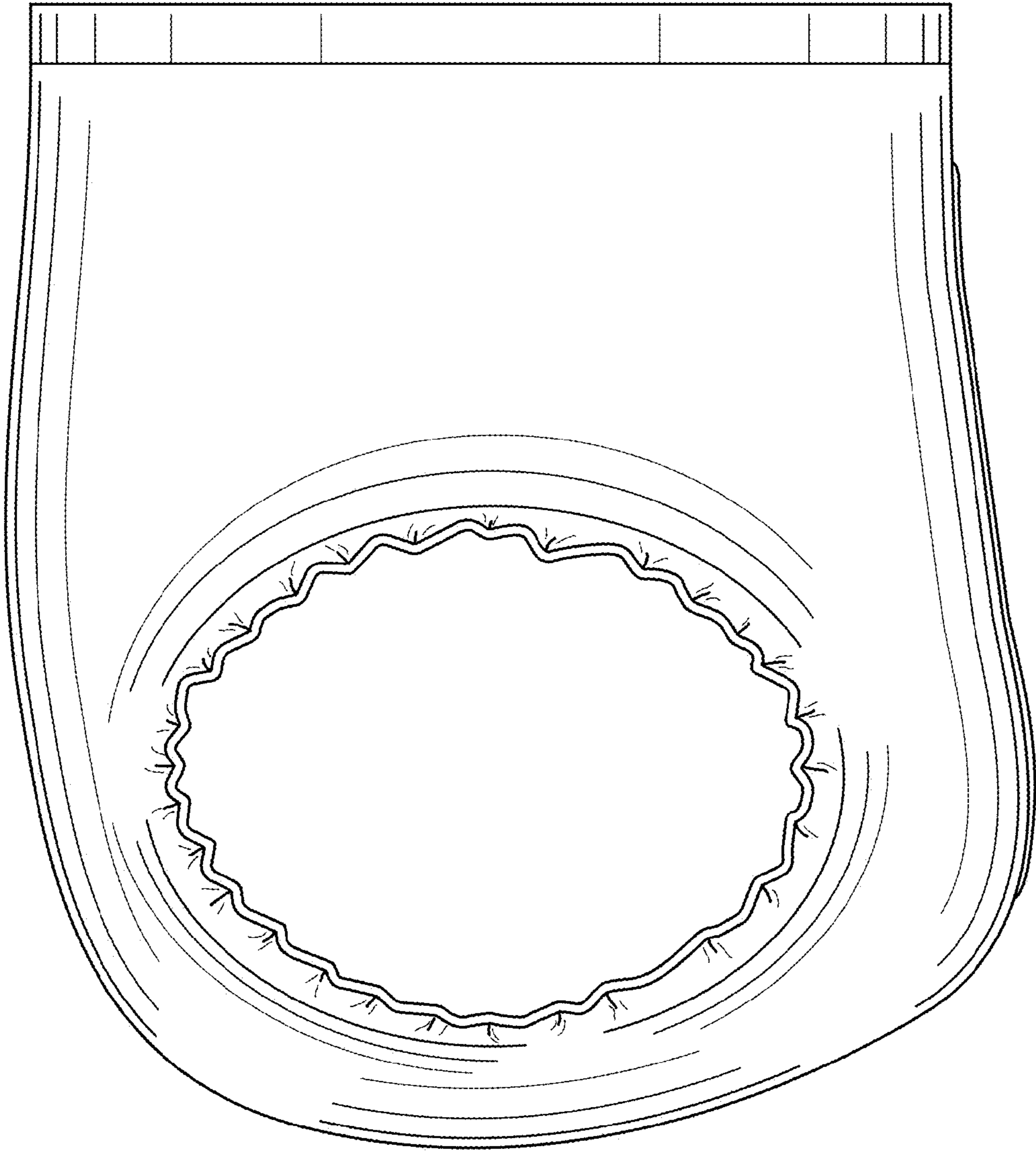

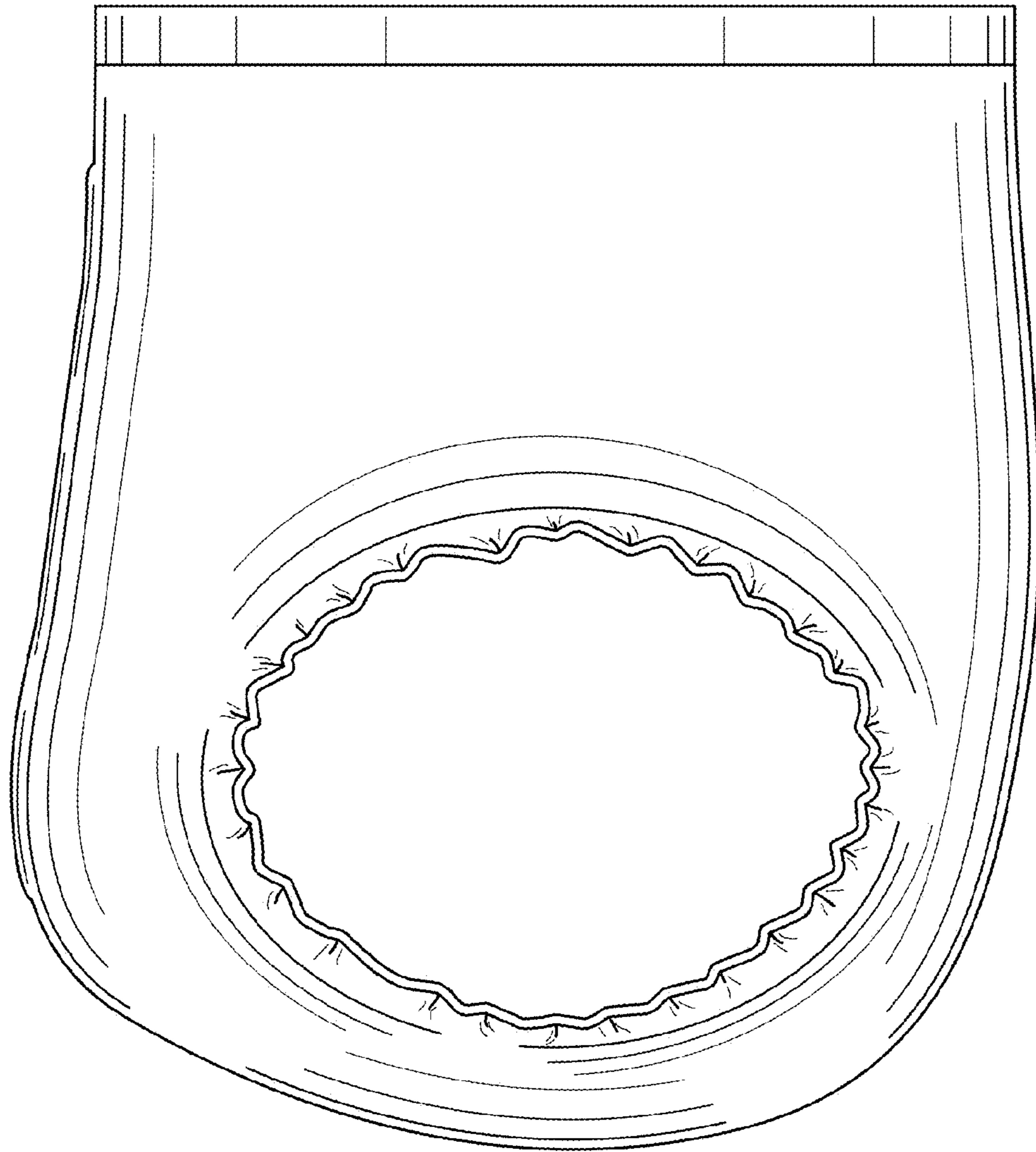

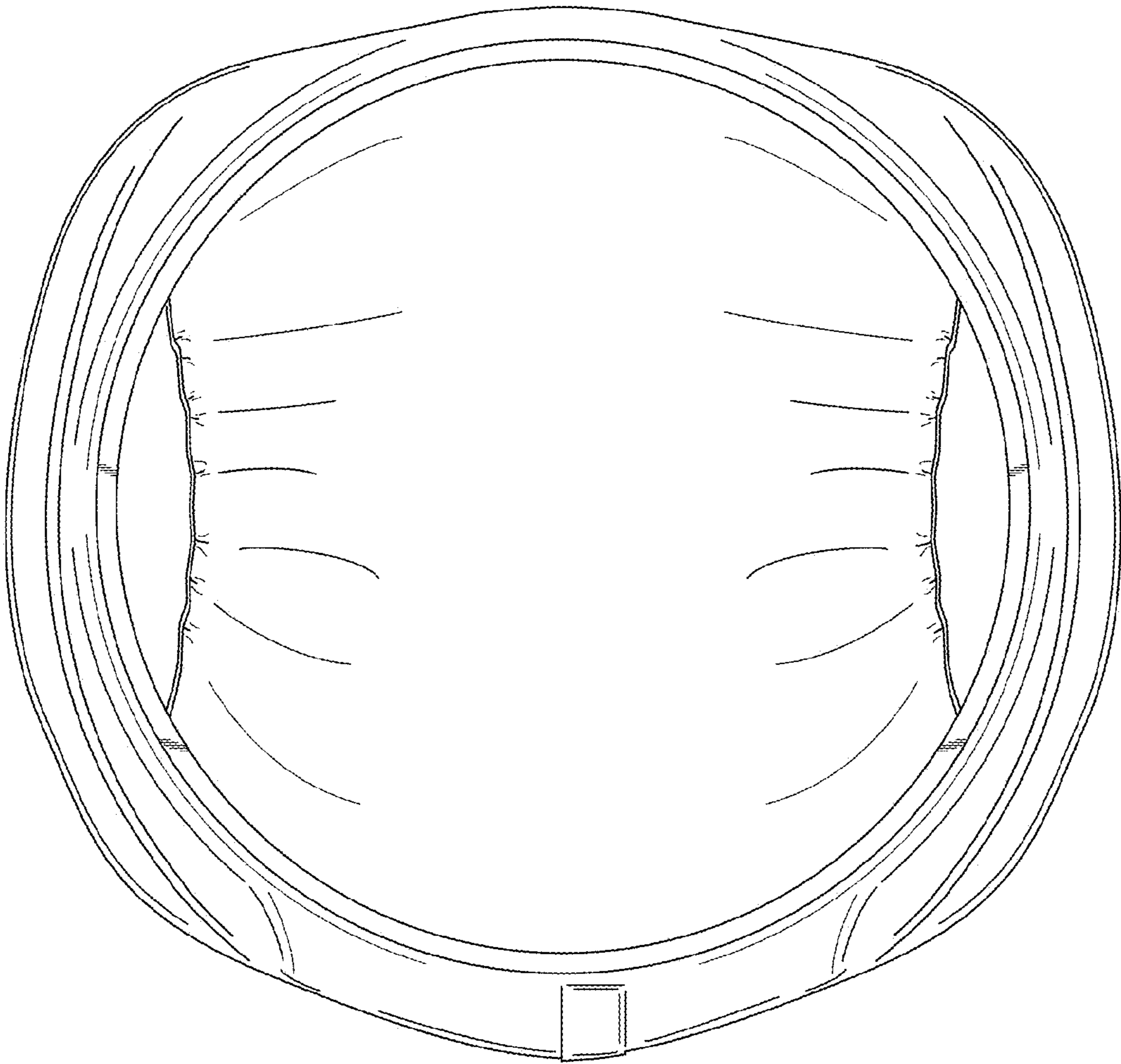

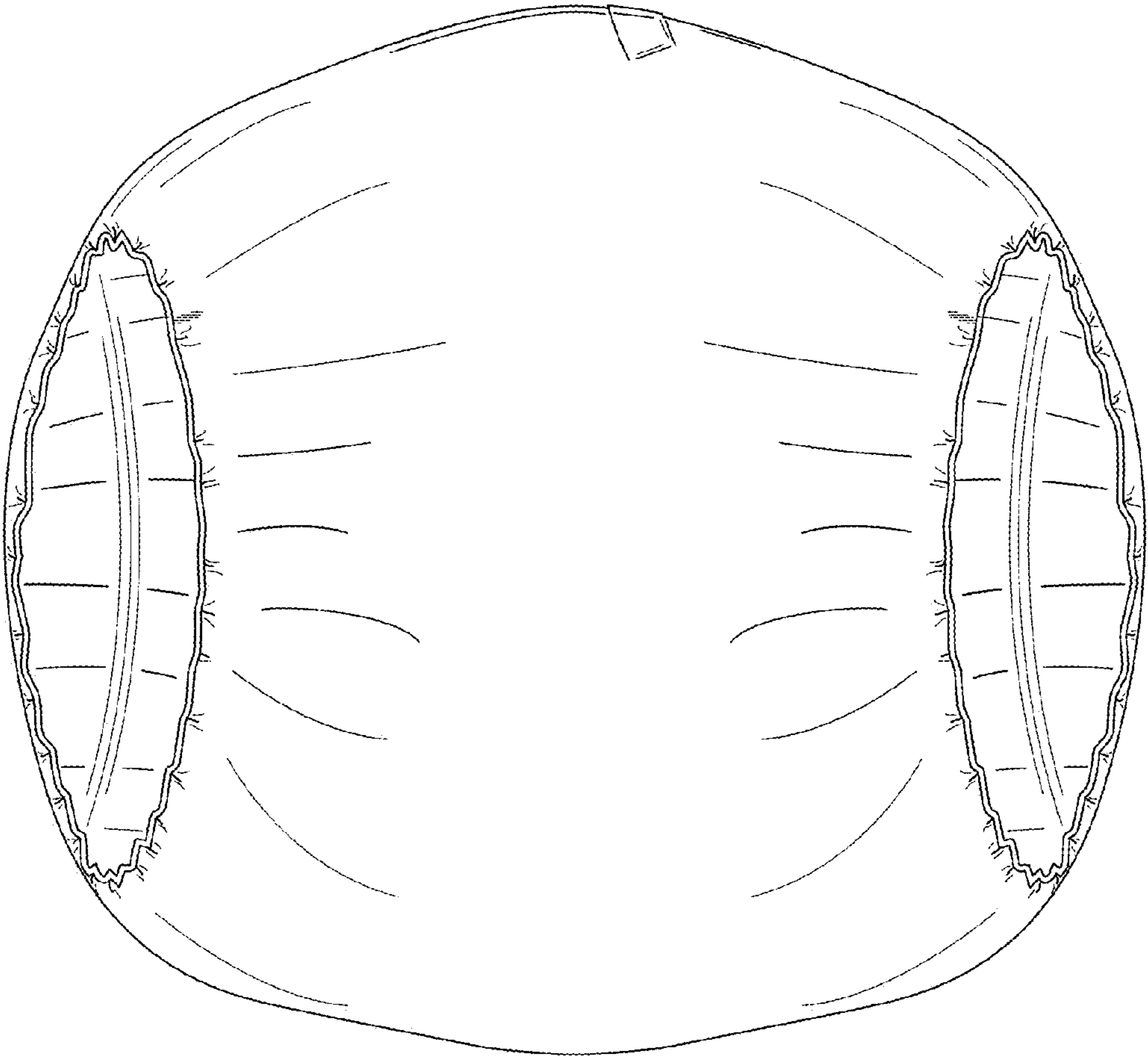
