(57) **CLAIM**

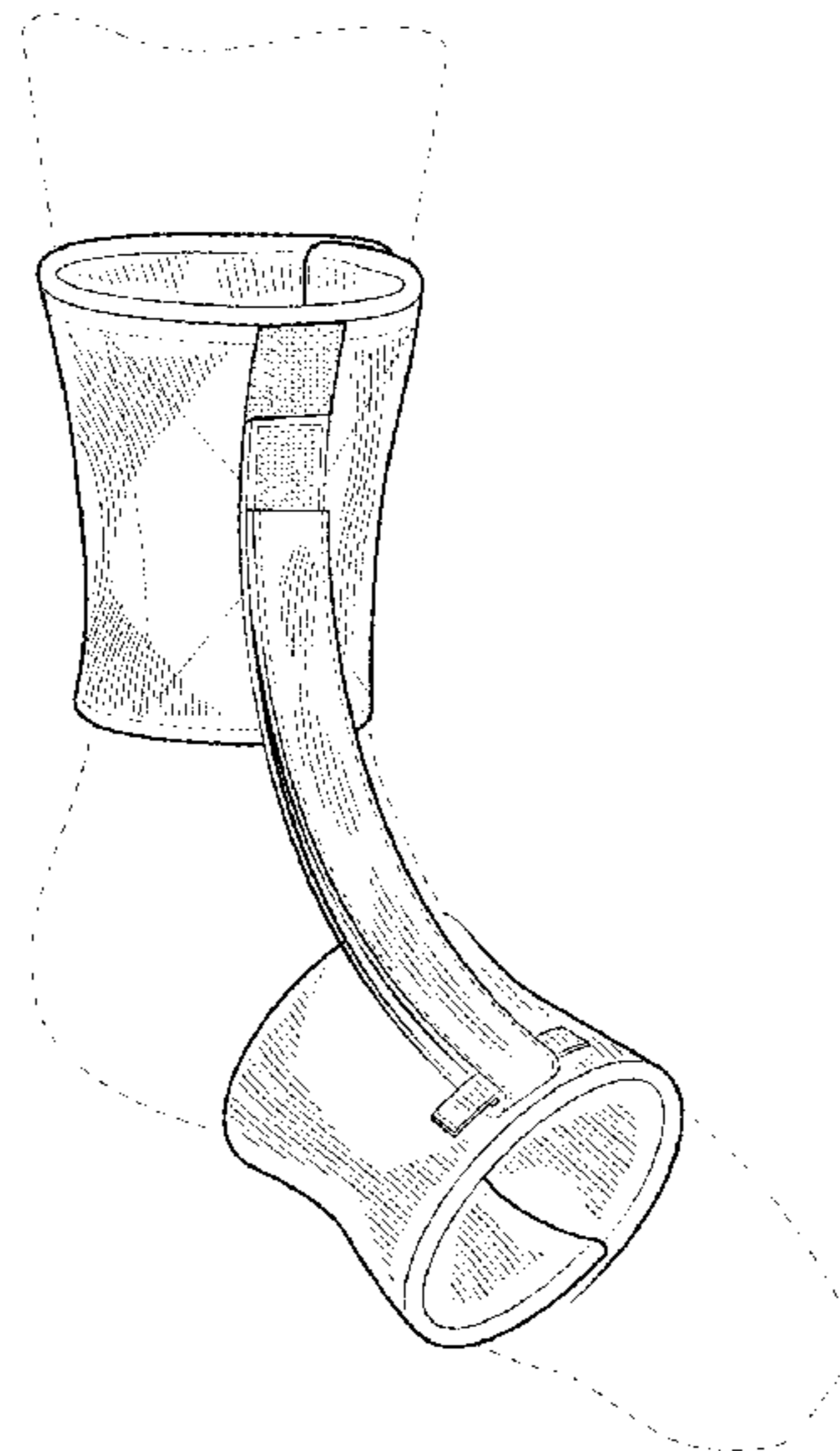
I claim the ornamental design for a plantar fasciitis night brace, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a plantar fasciitis night brace, showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a left-side elevational view thereof;
 FIG. 5 is a right-side elevational view thereof;
 FIG. 6 is a top plan view thereof; and,
 FIG. 7 is a bottom plan view thereof.

The broken lines showing a foot in FIG. 1 depict environmental matter and form no part of the claimed design.
 It is understood that the broken lines within the claimed design indicates stitch lines, which form part of the claim.

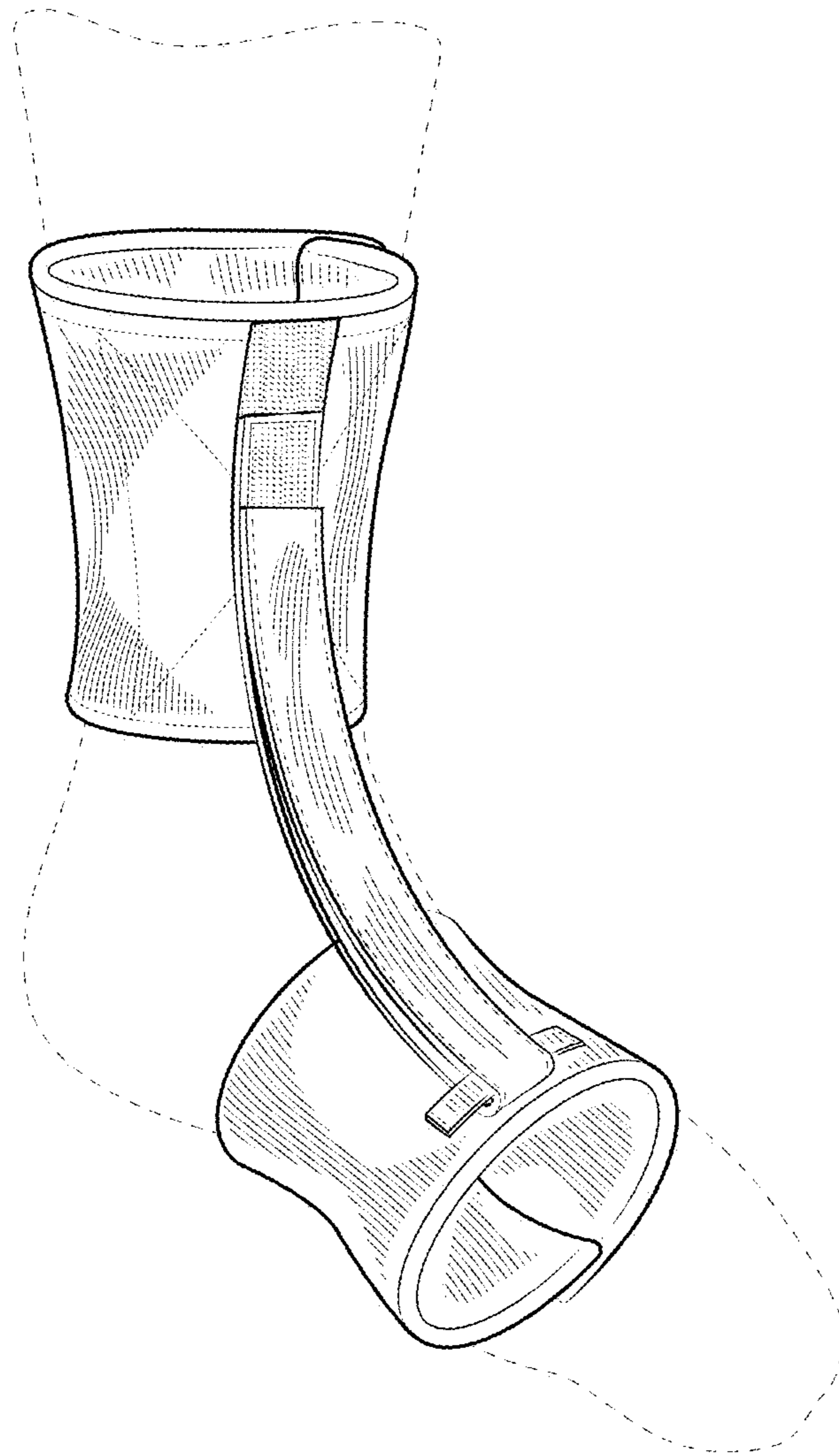

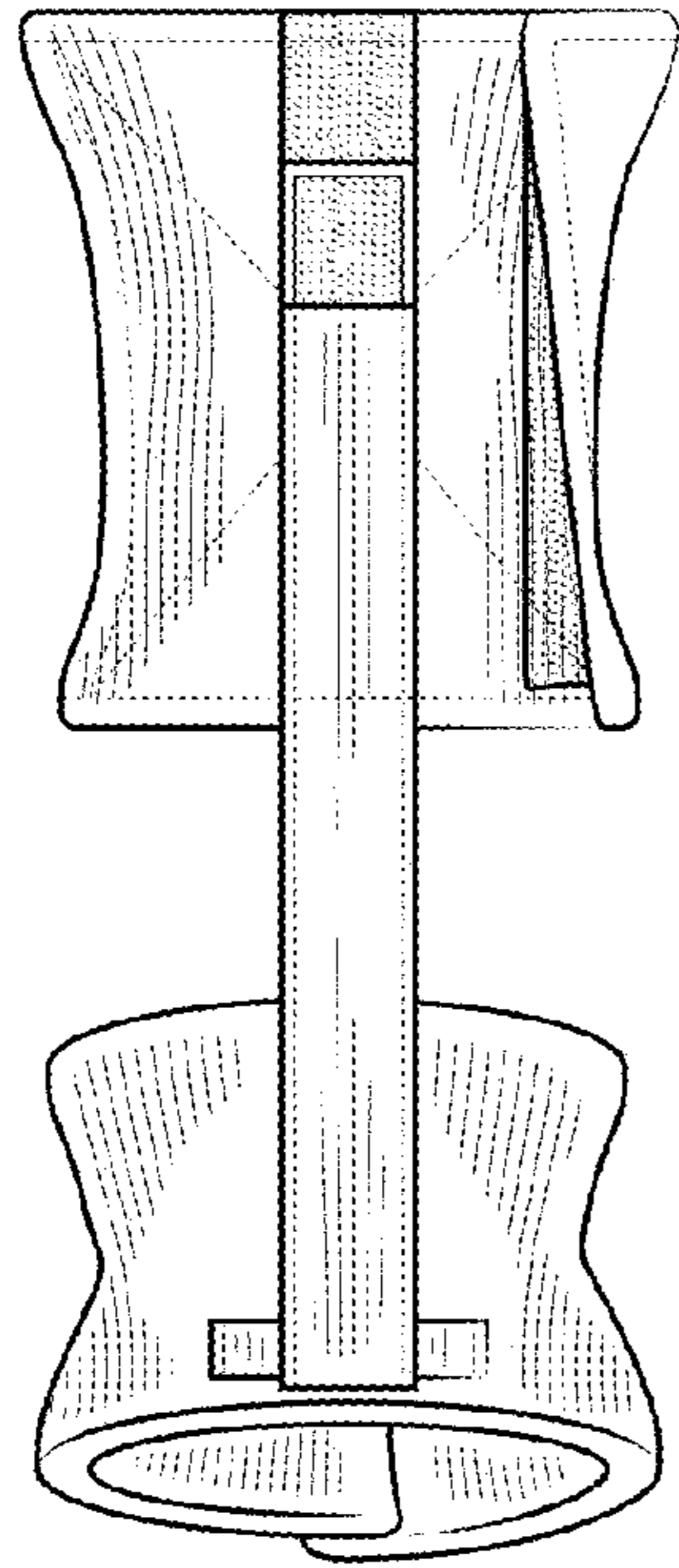

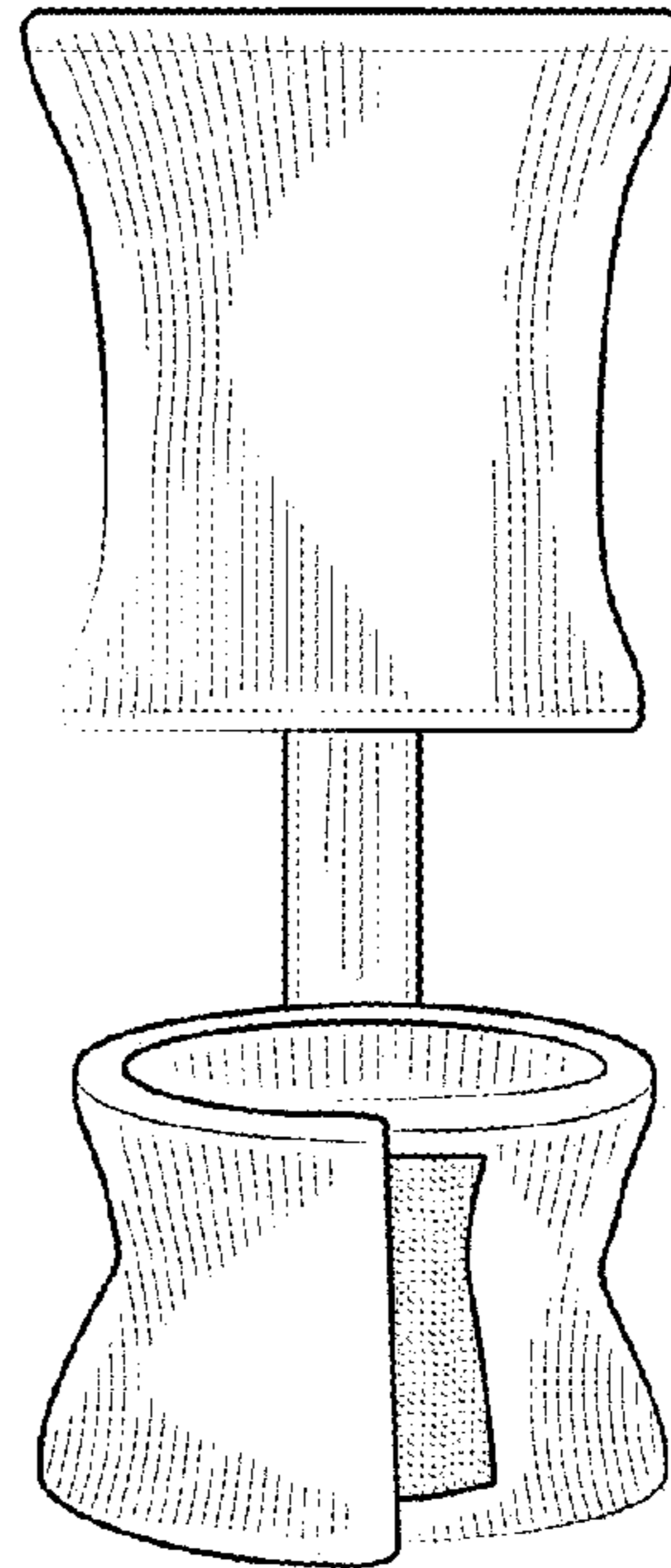

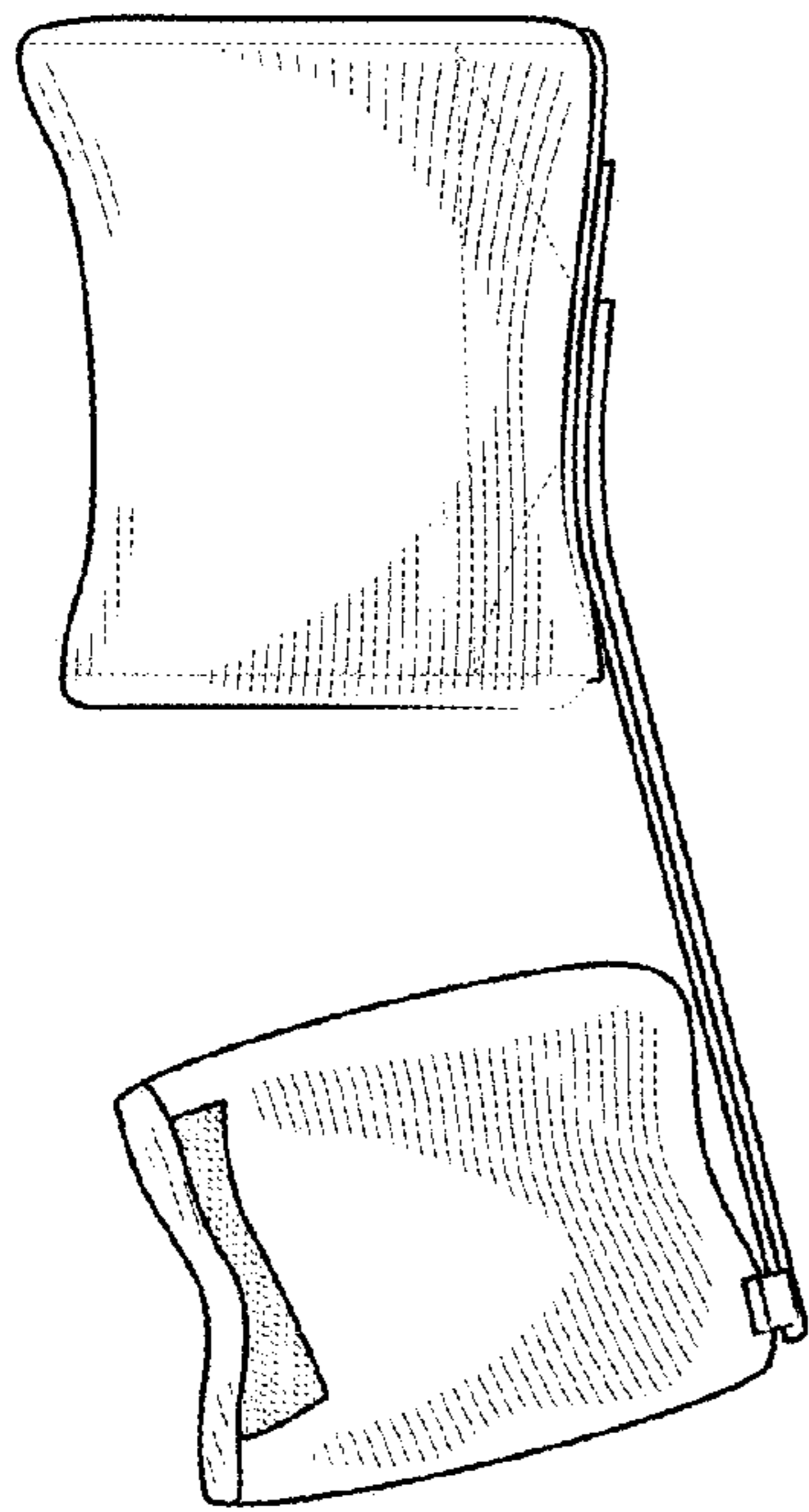

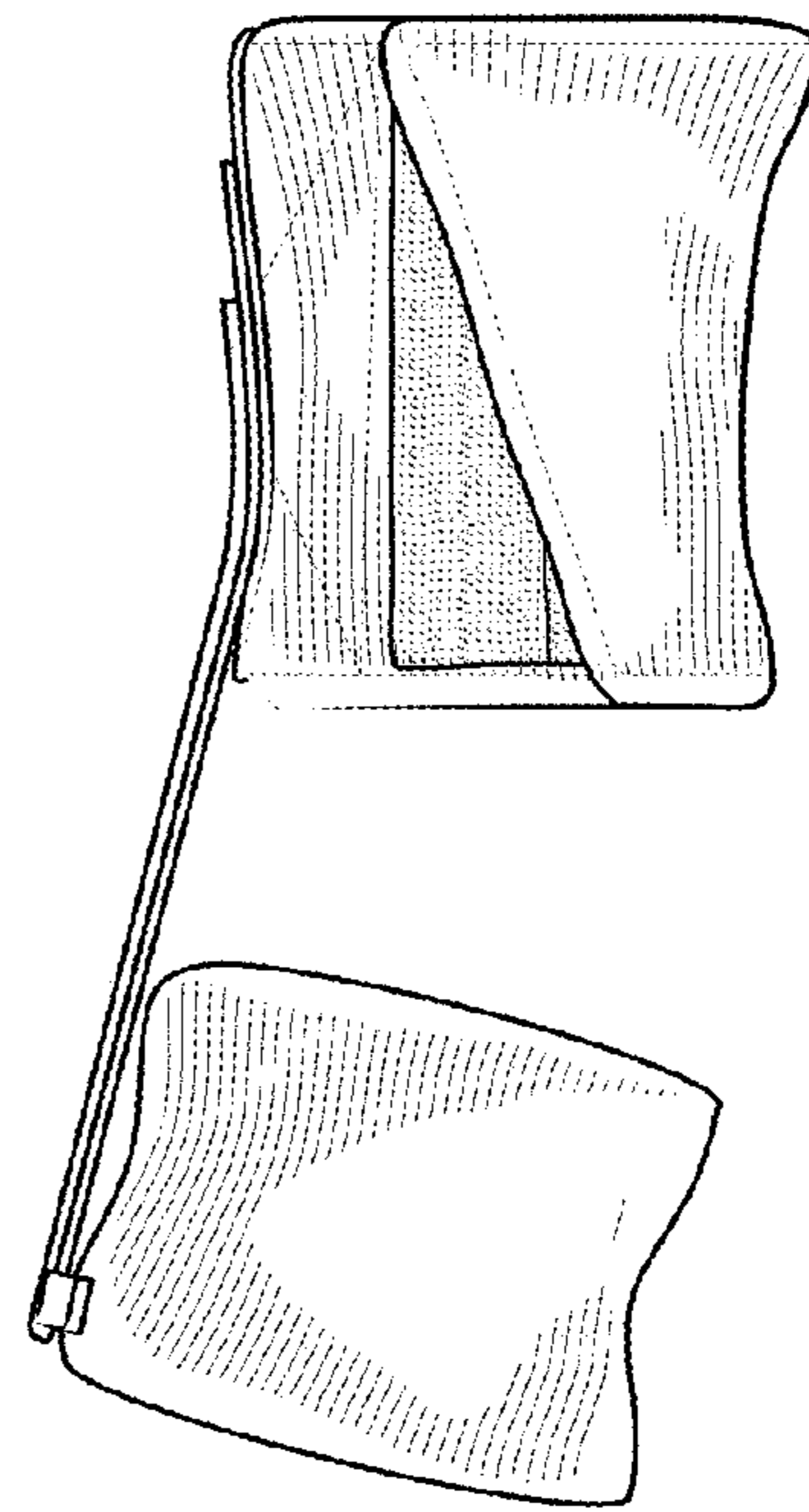

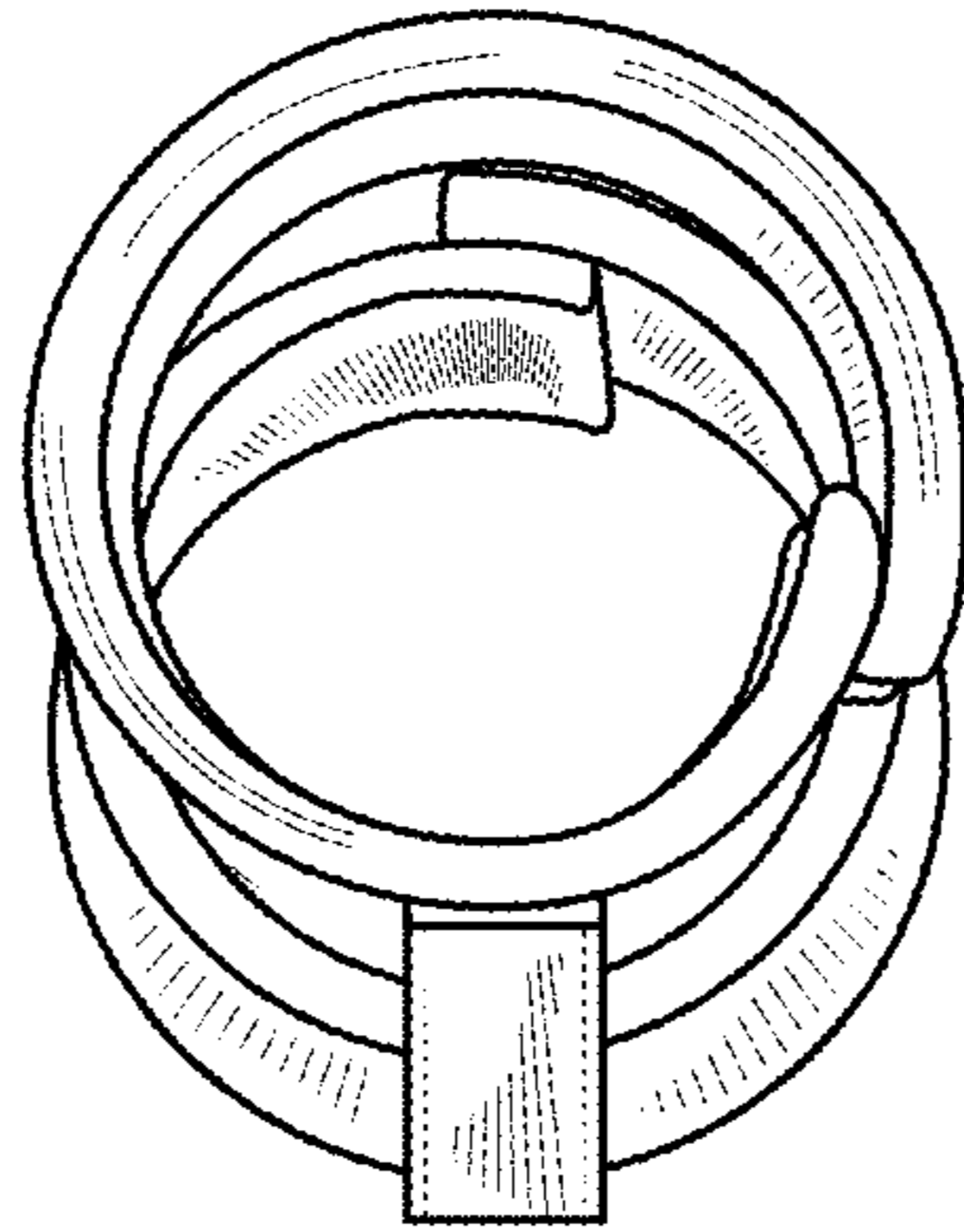

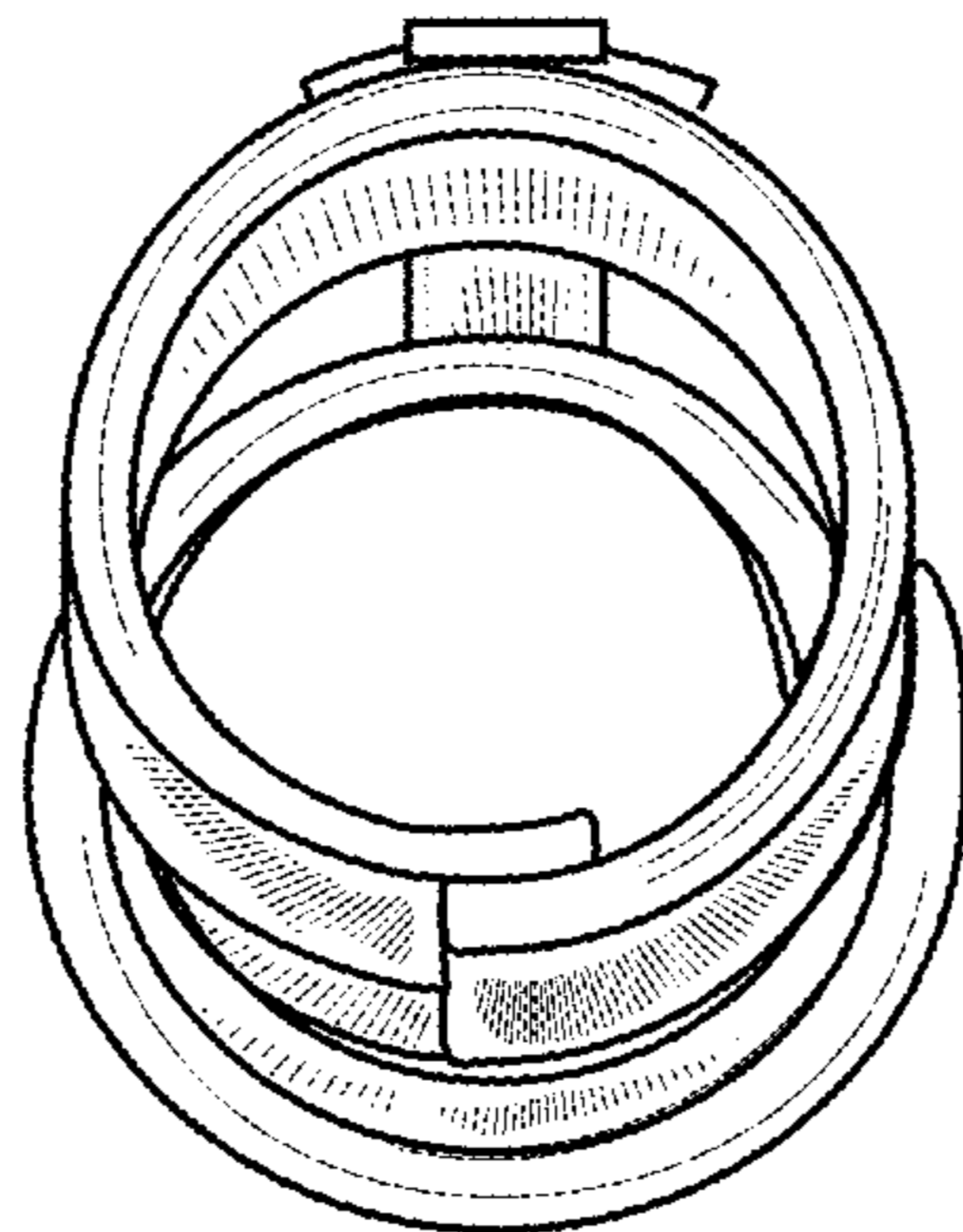
