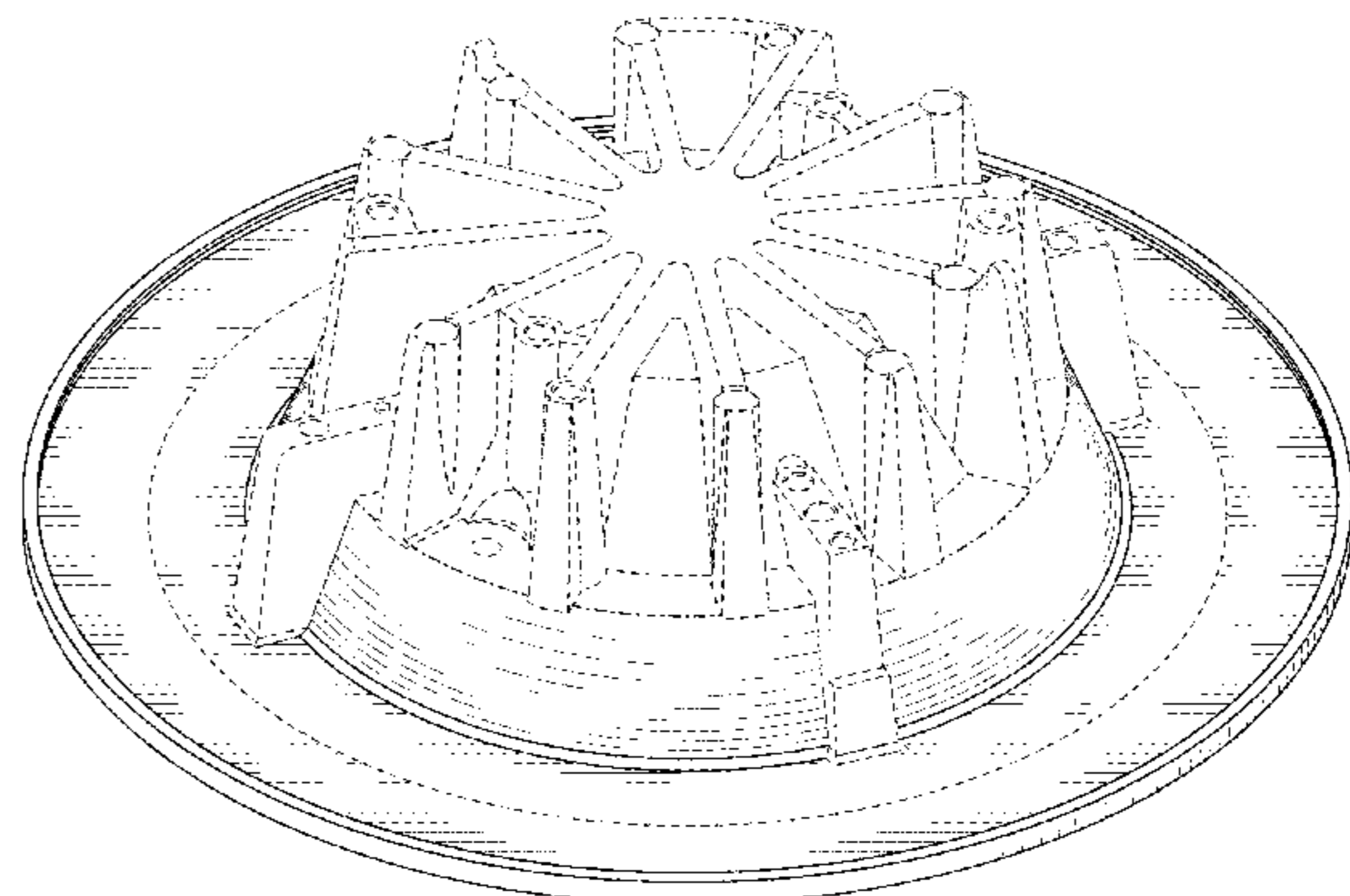
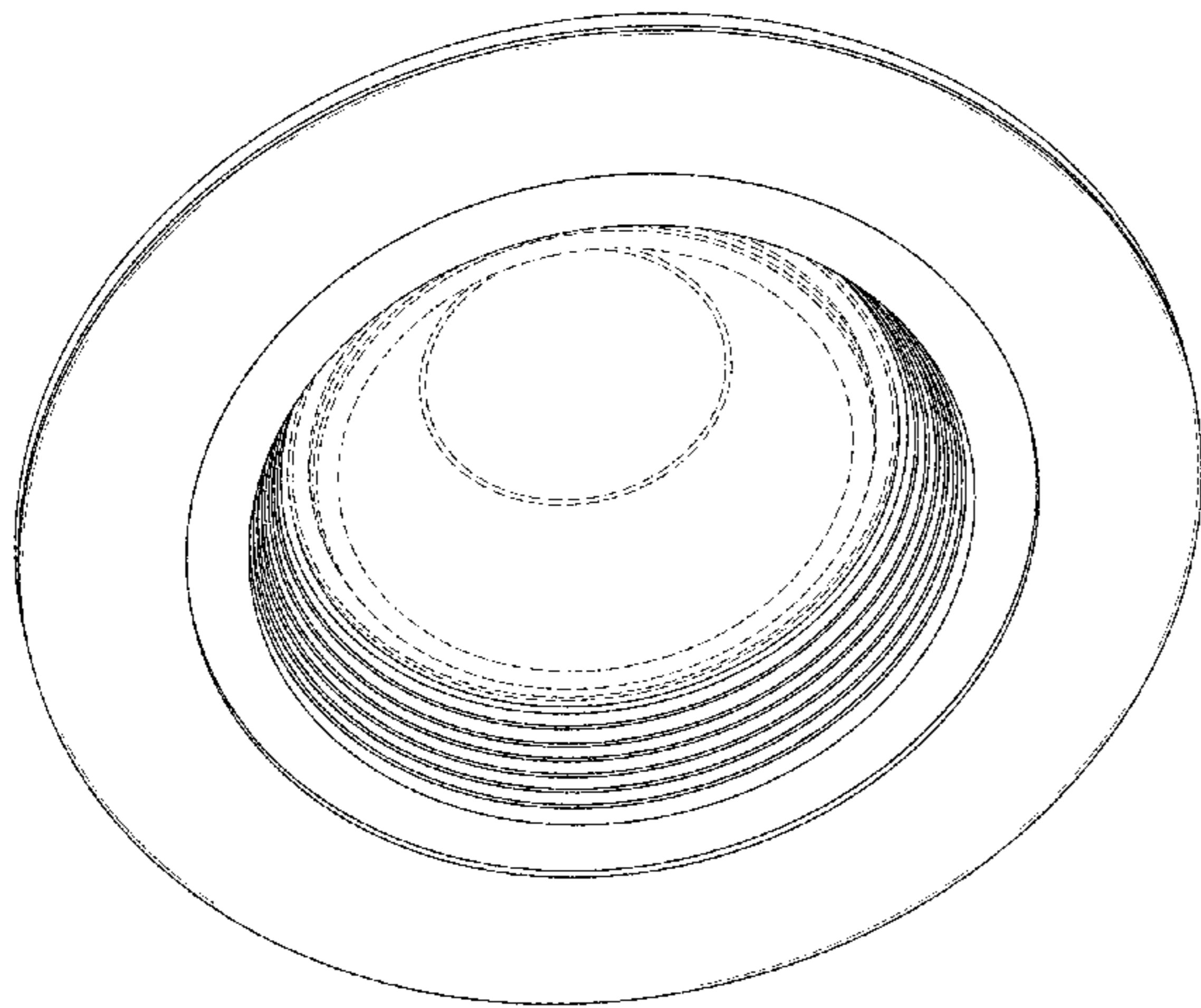
The ornamental design for a light module, as shown and described.

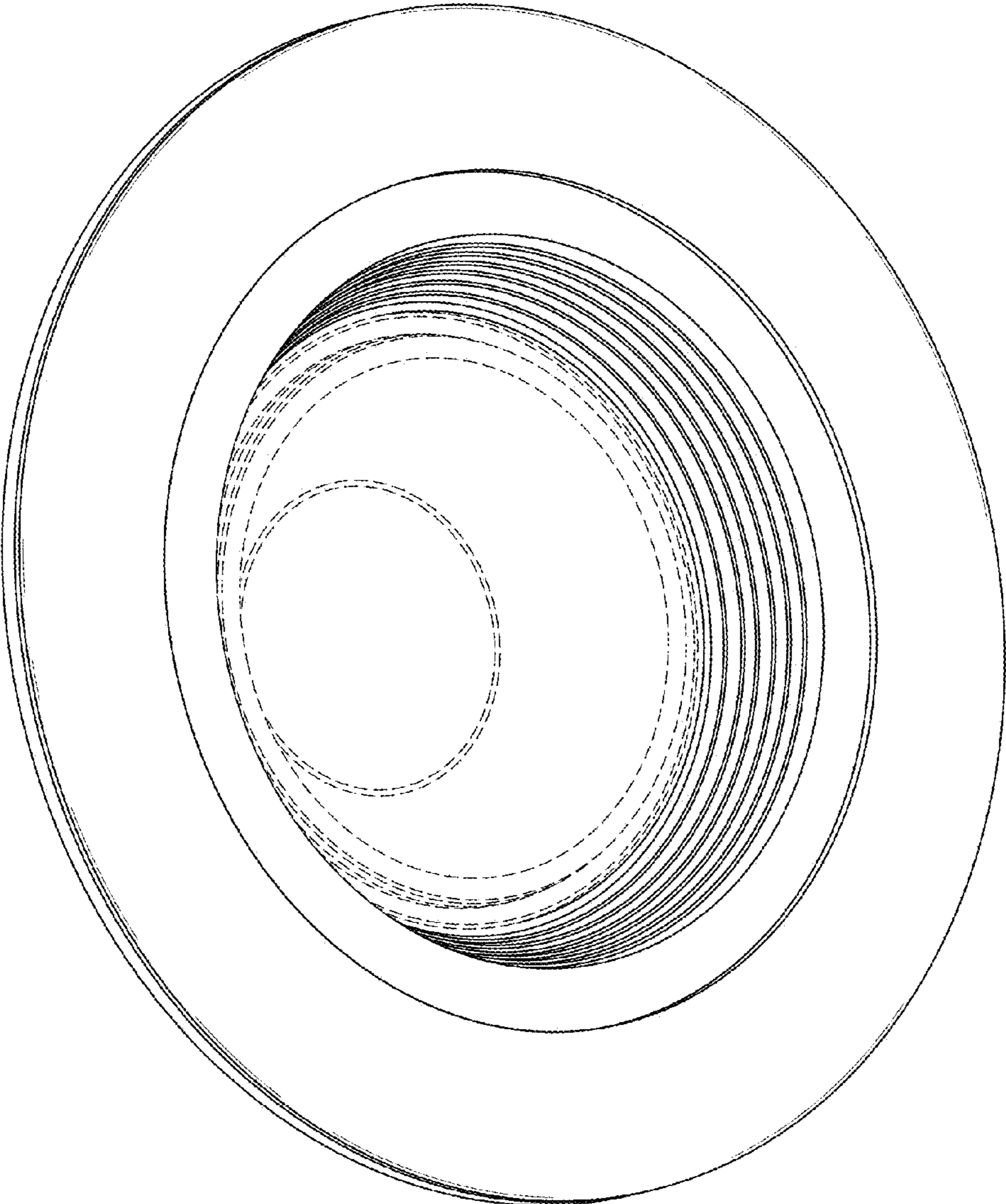

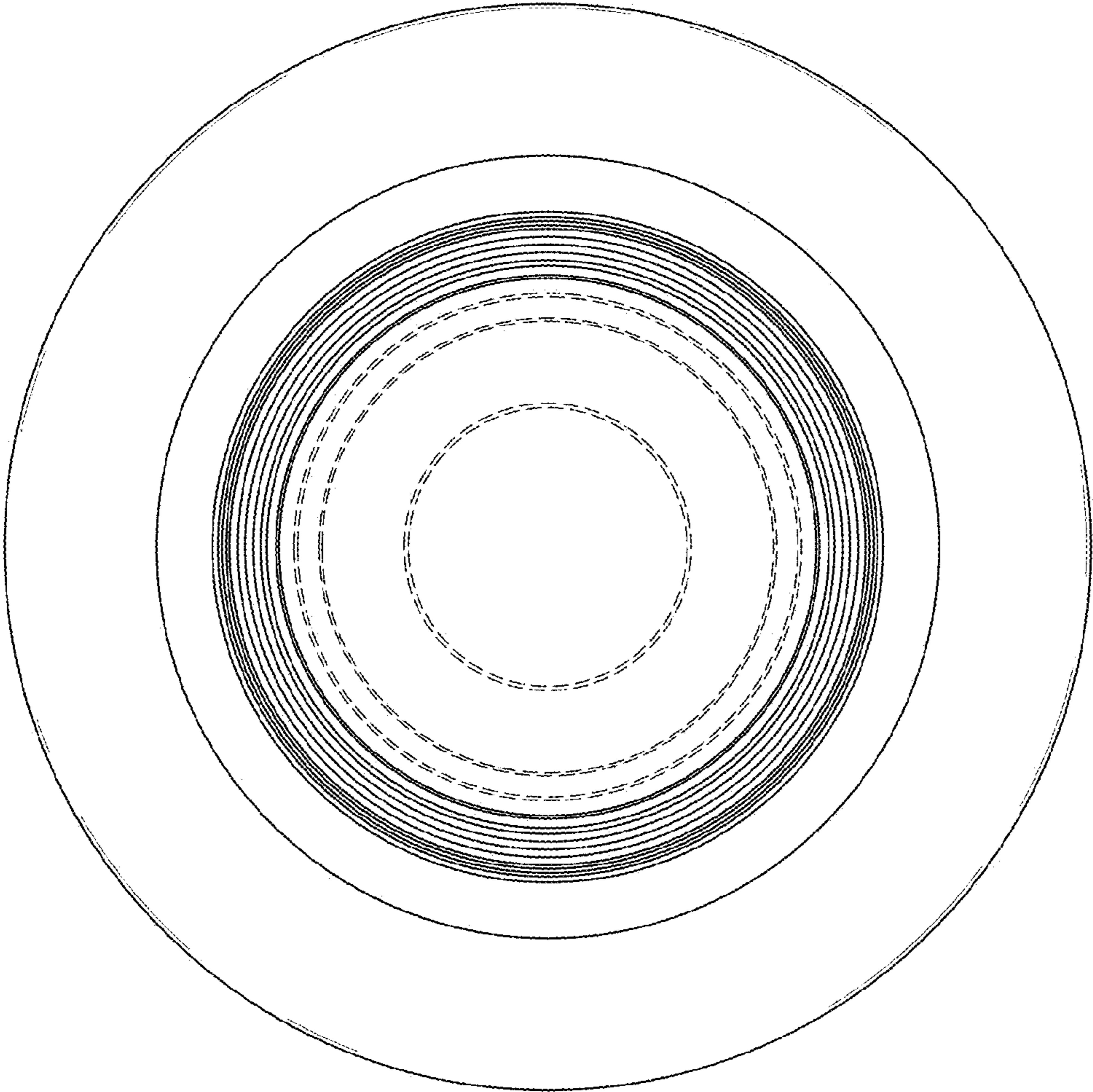

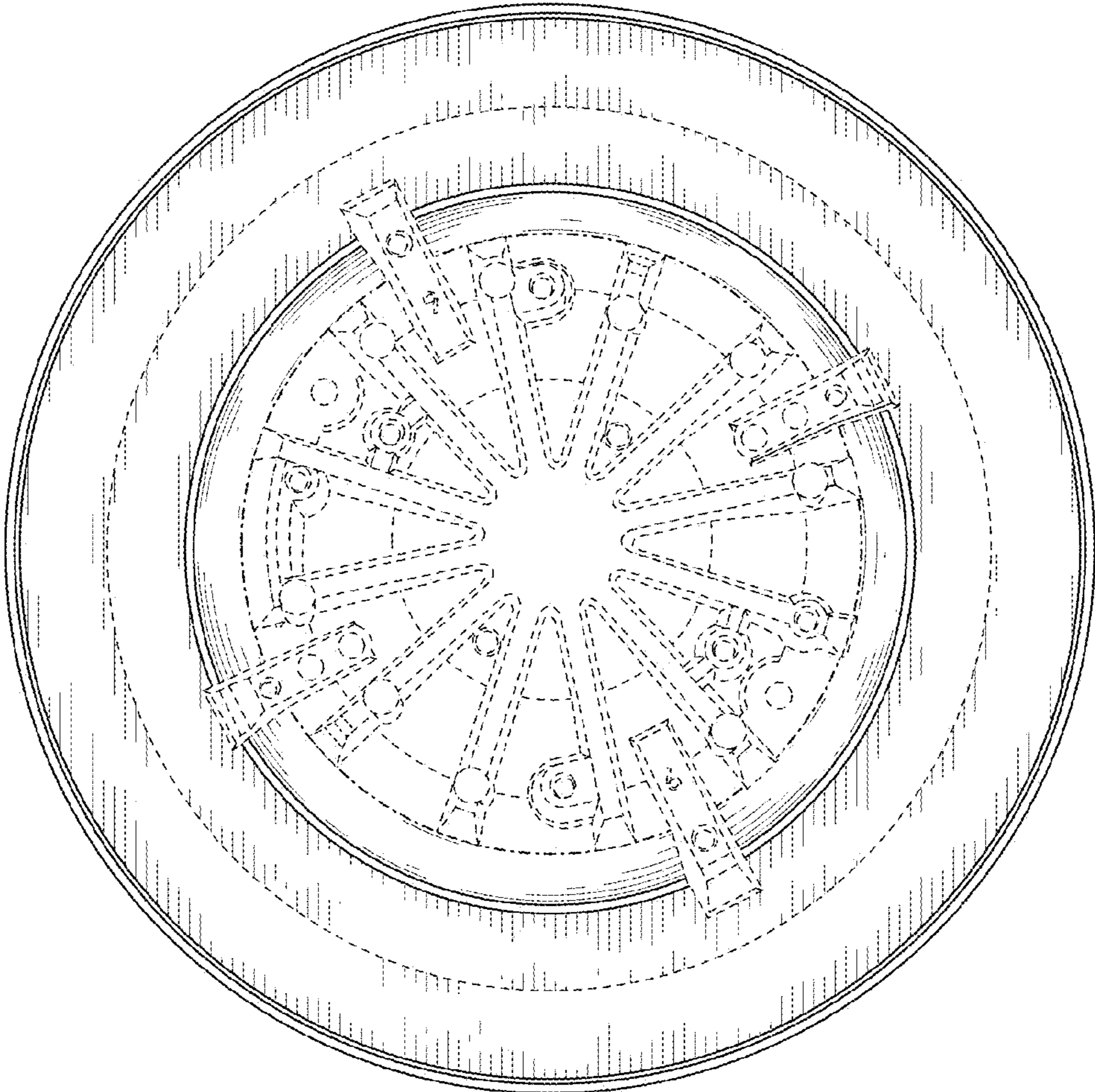

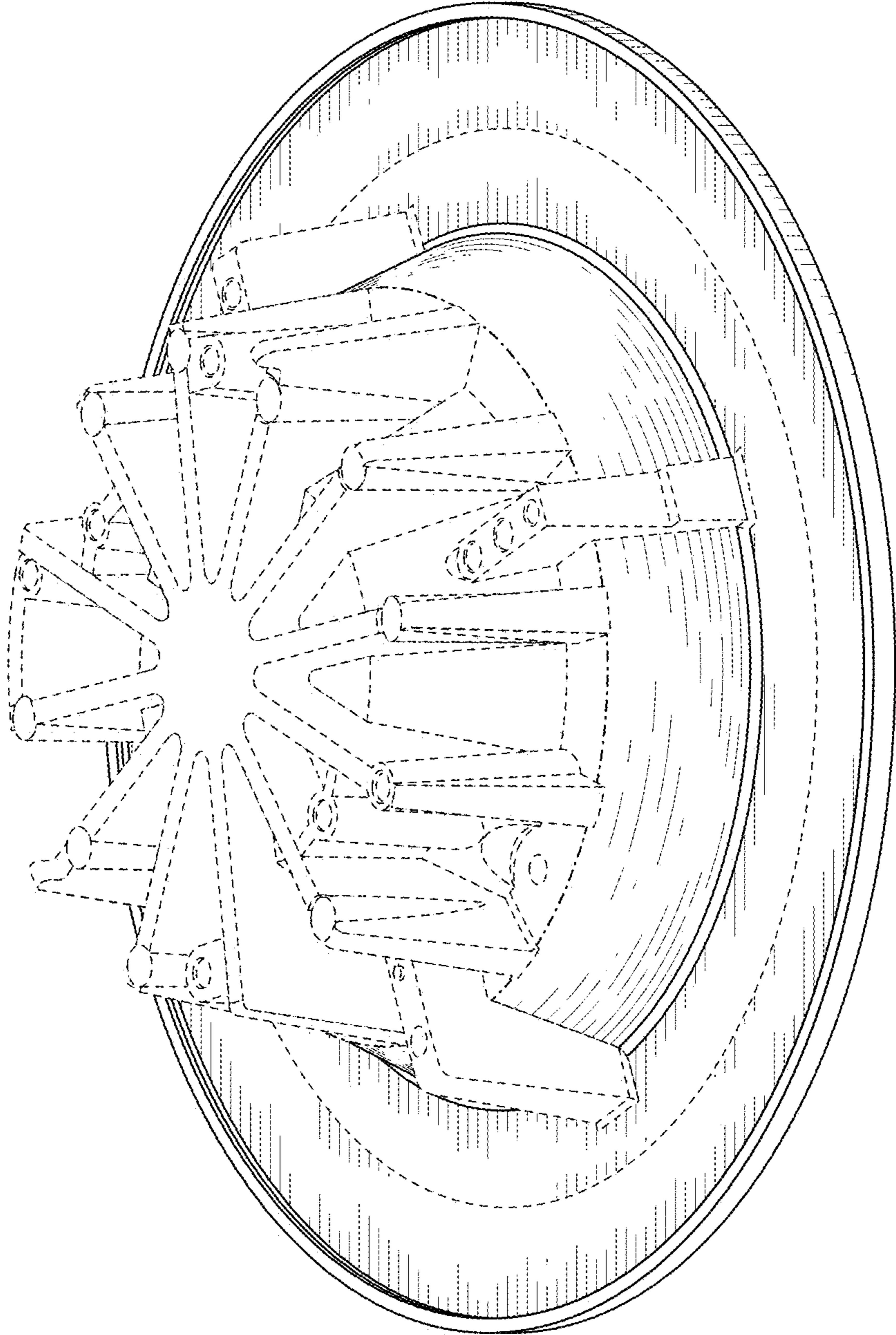

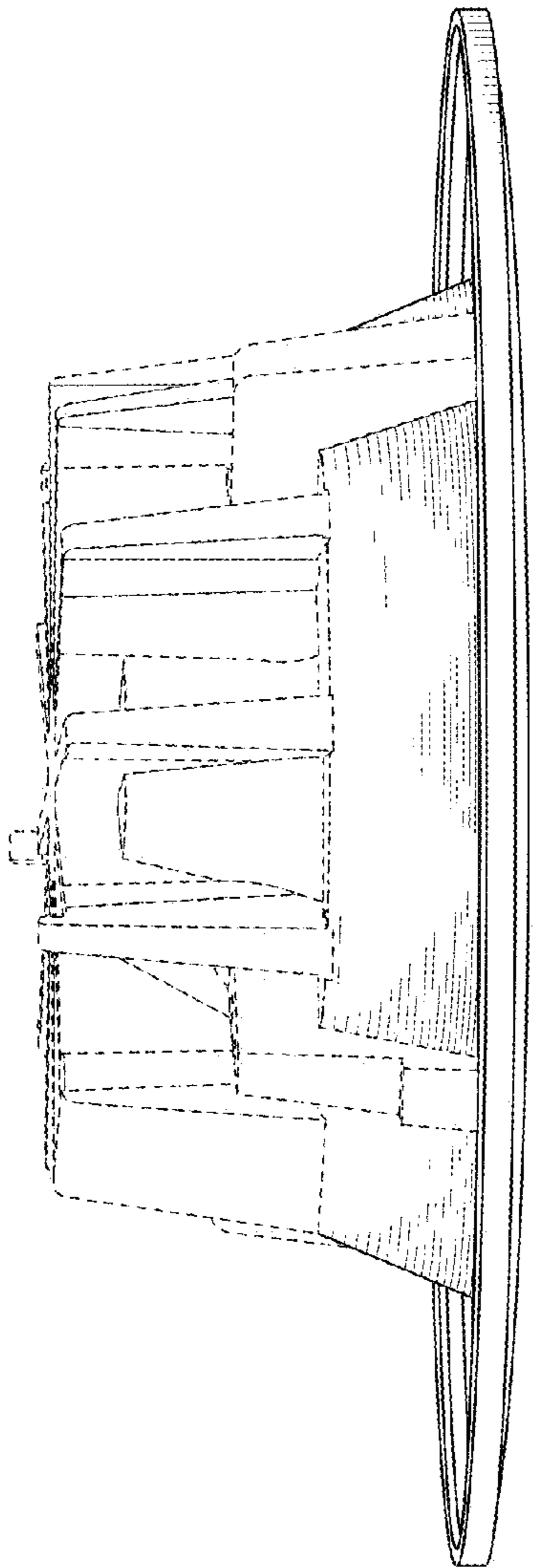

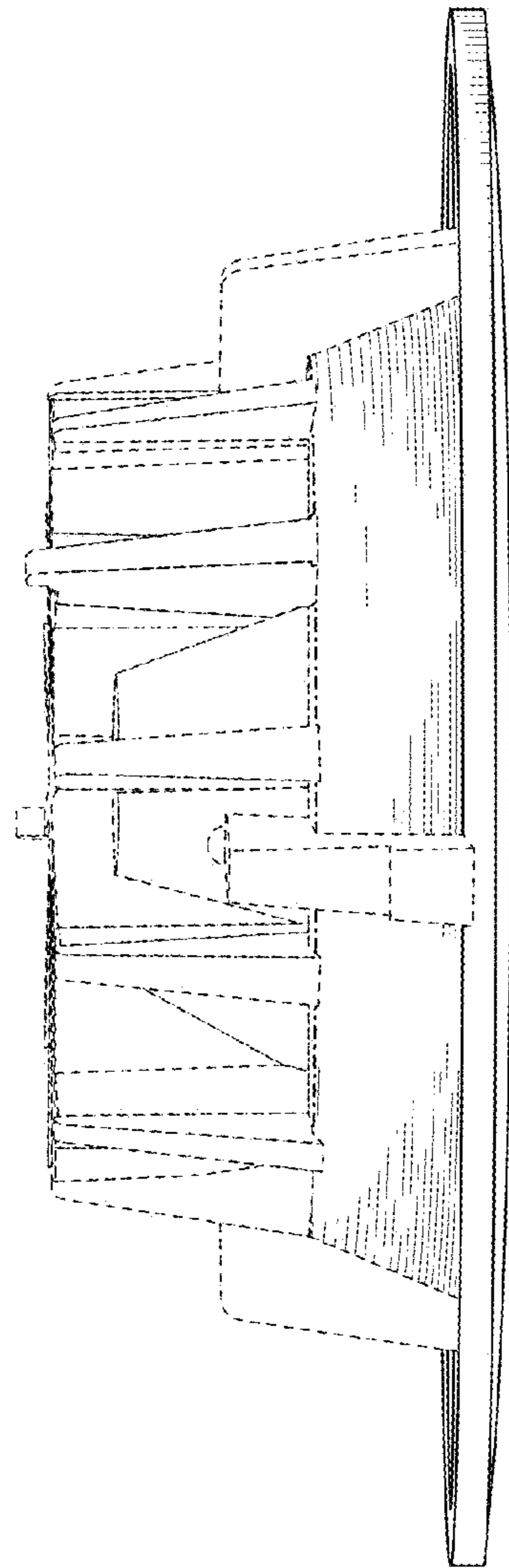

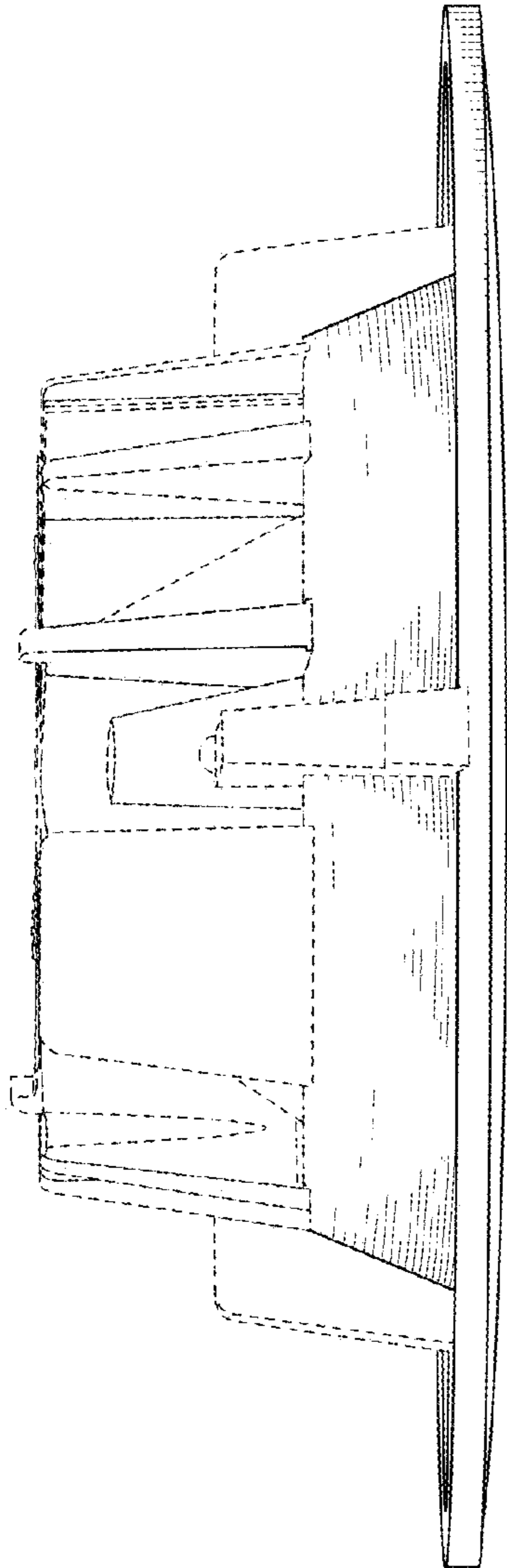

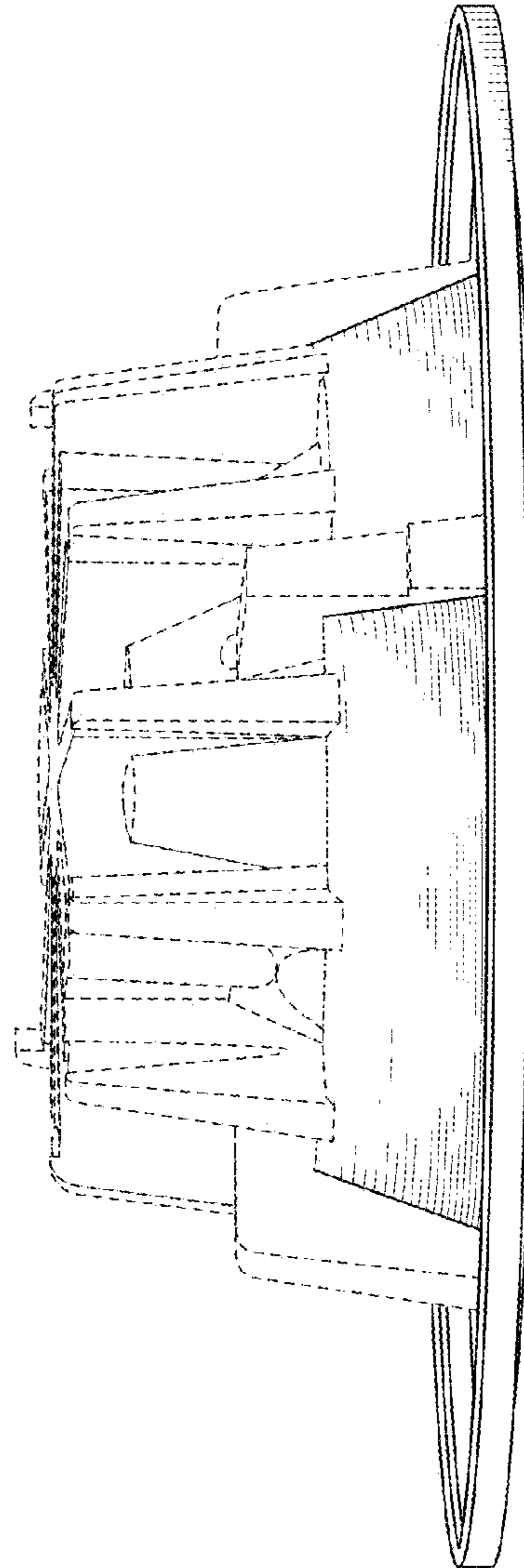
