The ornamental design for a medical pet shirt, as shown and described.

**DESCRIPTION**

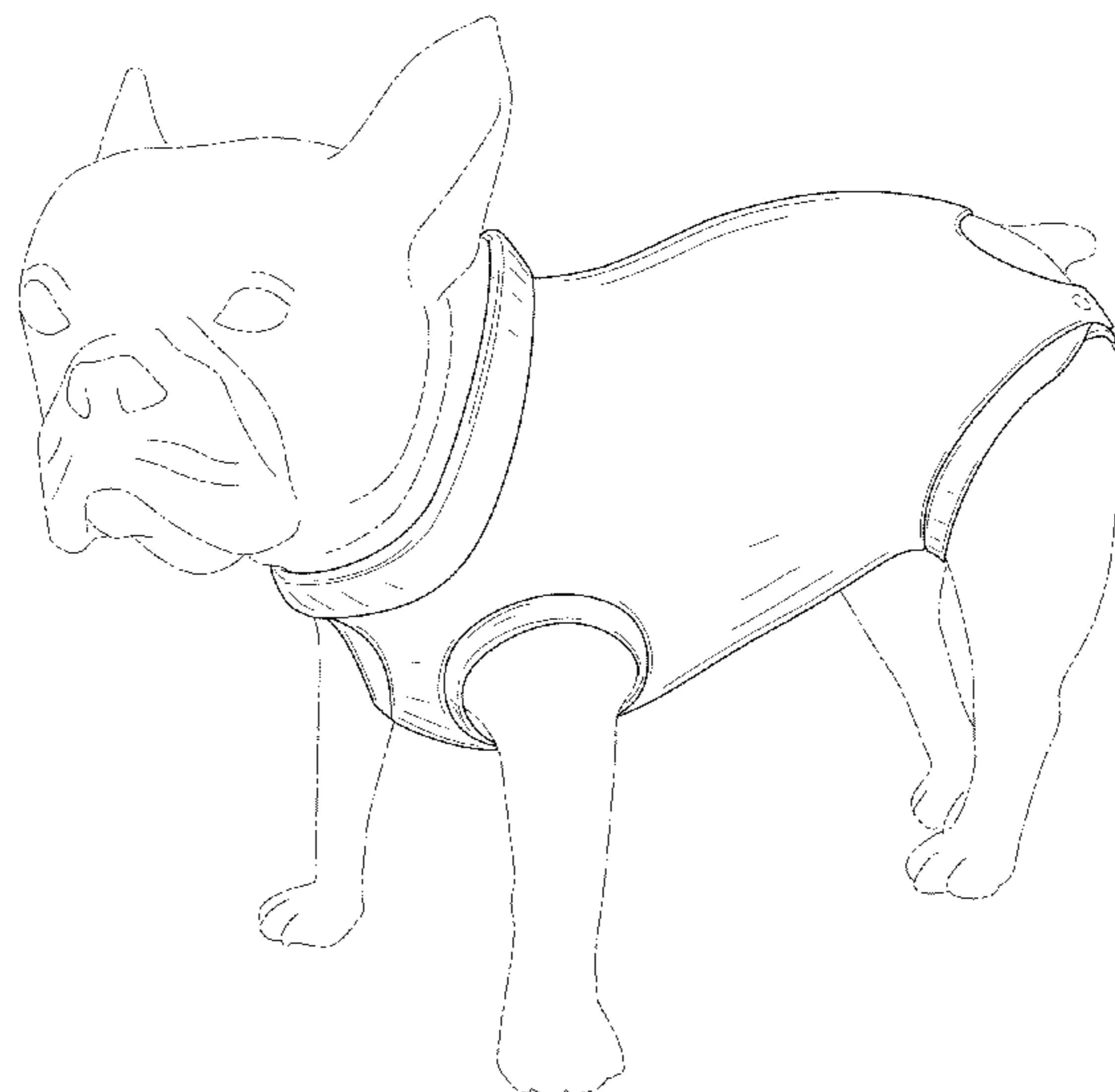
FIG. 1 is a front and right side perspective view of a medical pet shirt, showing my new design;  
 FIG. 2 is a rear and left side perspective view thereof;  
 FIG. 3 is a right side elevational view thereof;  
 FIG. 4 is a top elevational view thereof showing the attachment straps extending from the bottom panel in an attached position;  
 FIG. 5 is a bottom elevational view thereof;  
 FIG. 6 is a front elevational view thereof;  
 FIG. 7 is a rear elevational view thereof;  
 FIG. 8 is a cross-sectional inside view of FIG. 3 showing the attachment straps extending from the bottom panel being tucked in and an interior pocket and having a neck portion in a folded position;  
 FIG. 9 is a top plan view thereof showing the attachment straps extending from the bottom panel in an unattached position;  
 FIG. 10 is a bottom plan view of FIG. 9; and,  
 FIG. 11 is an interior plan view thereof including the pocket.  
 Broken lines and portions contained within broken lines are not claimed.

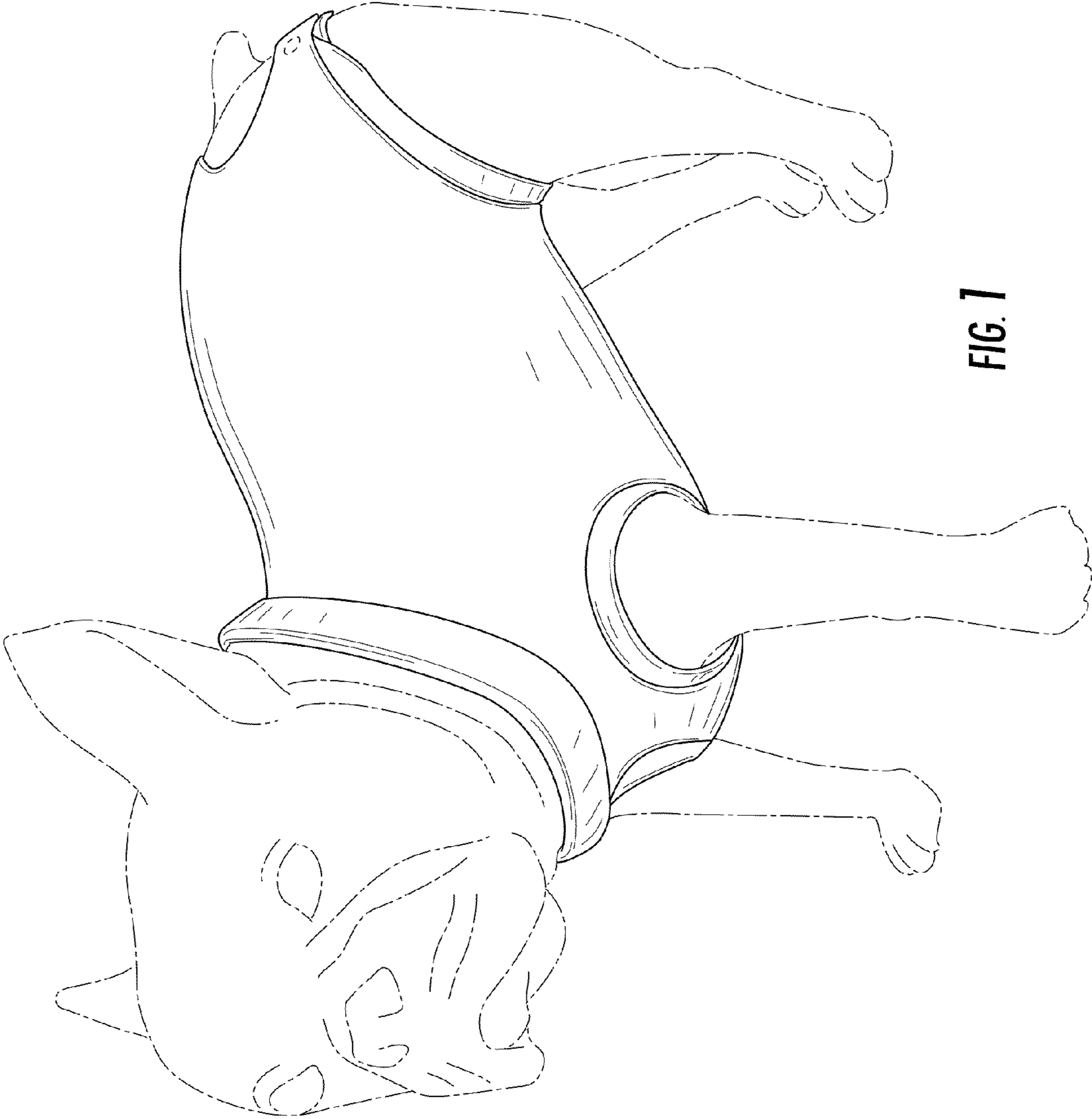

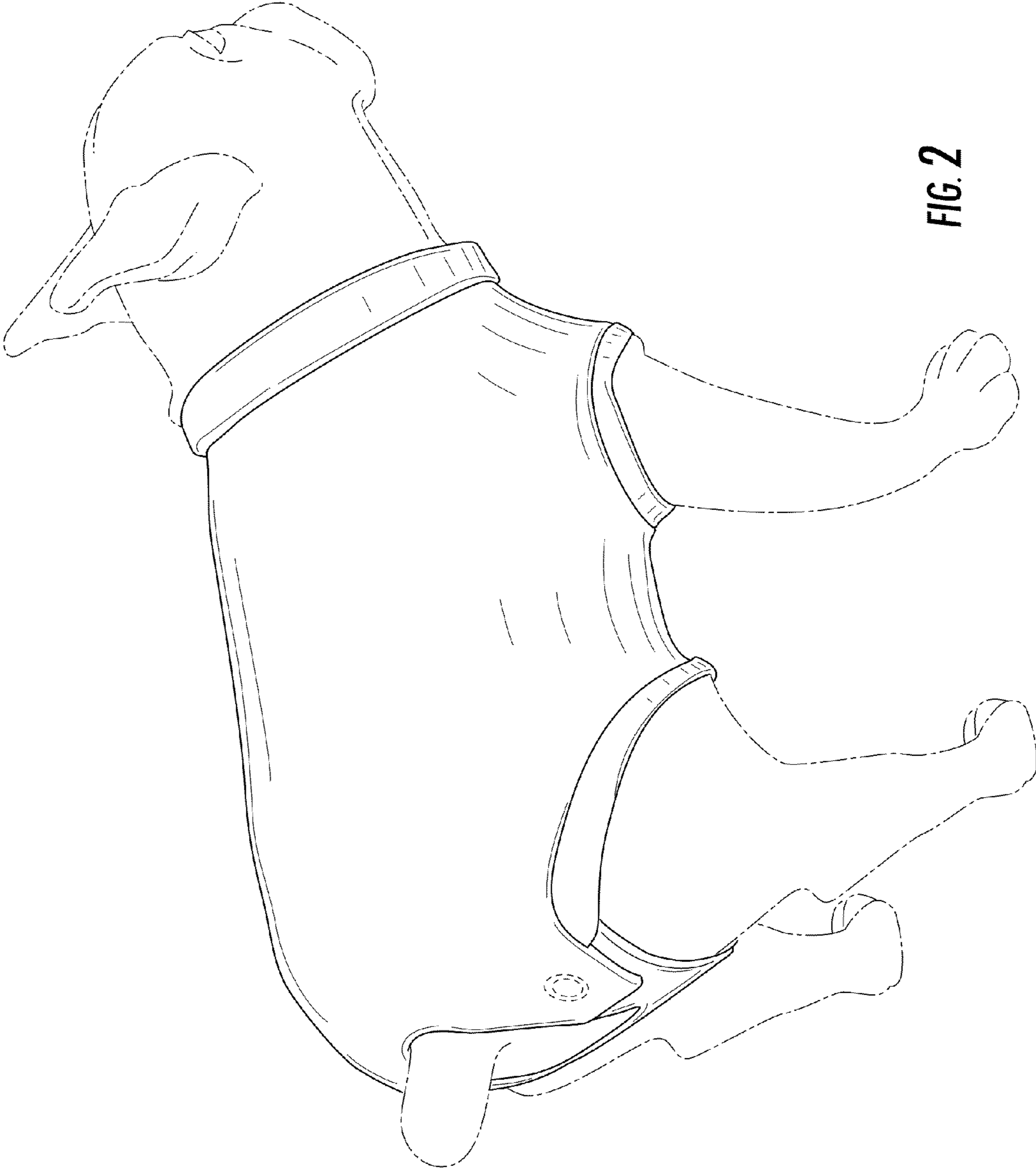

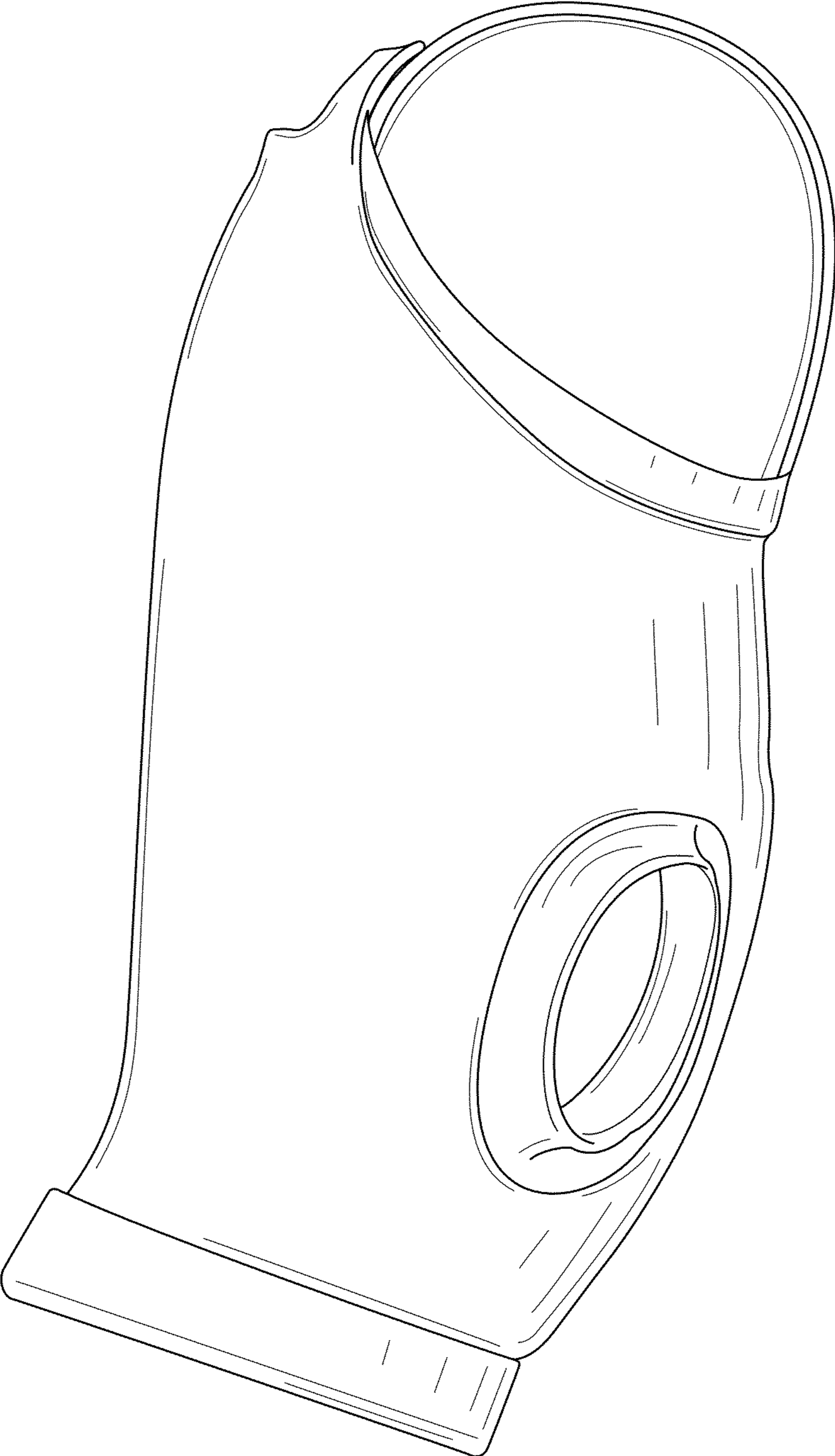

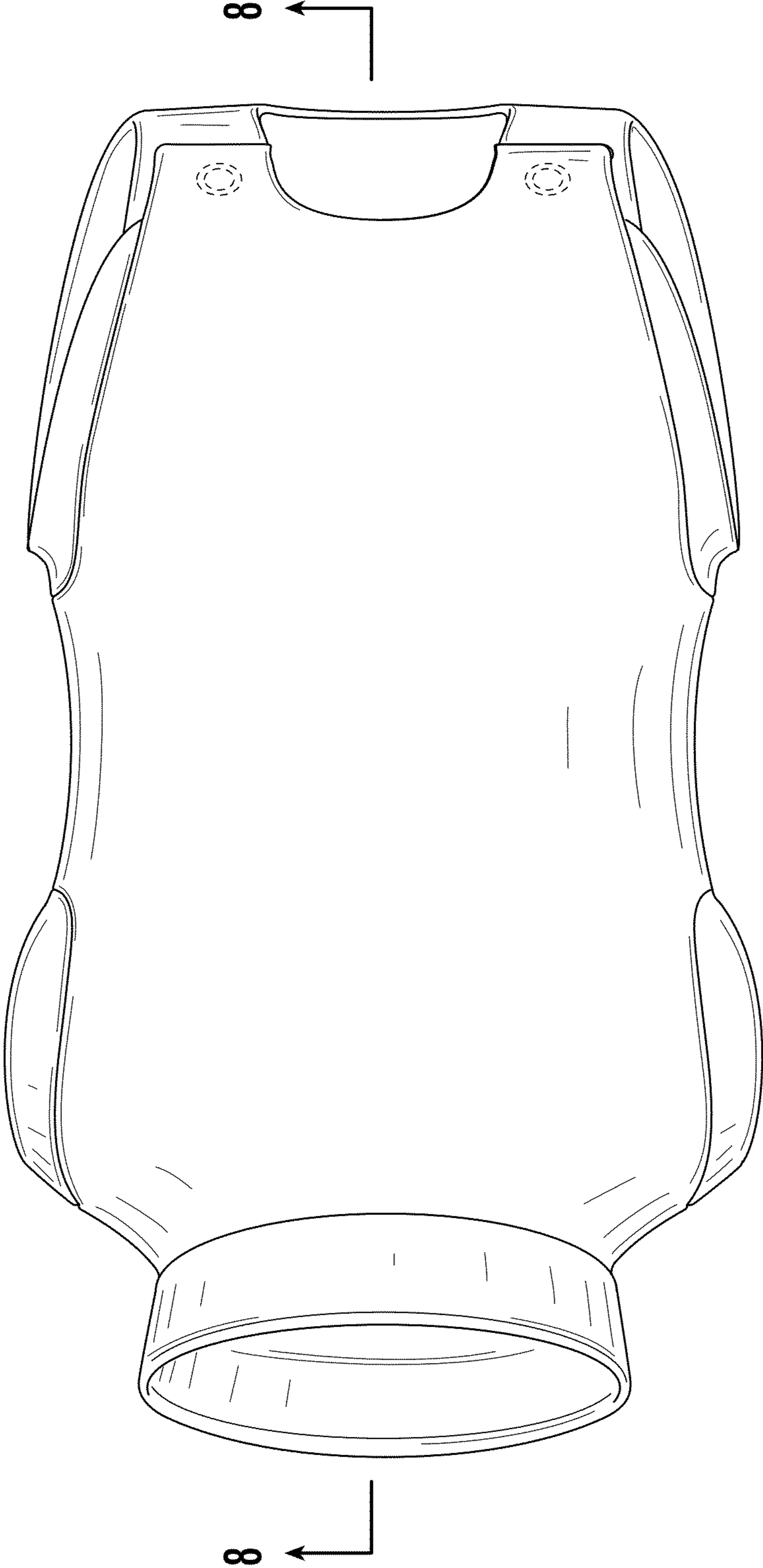

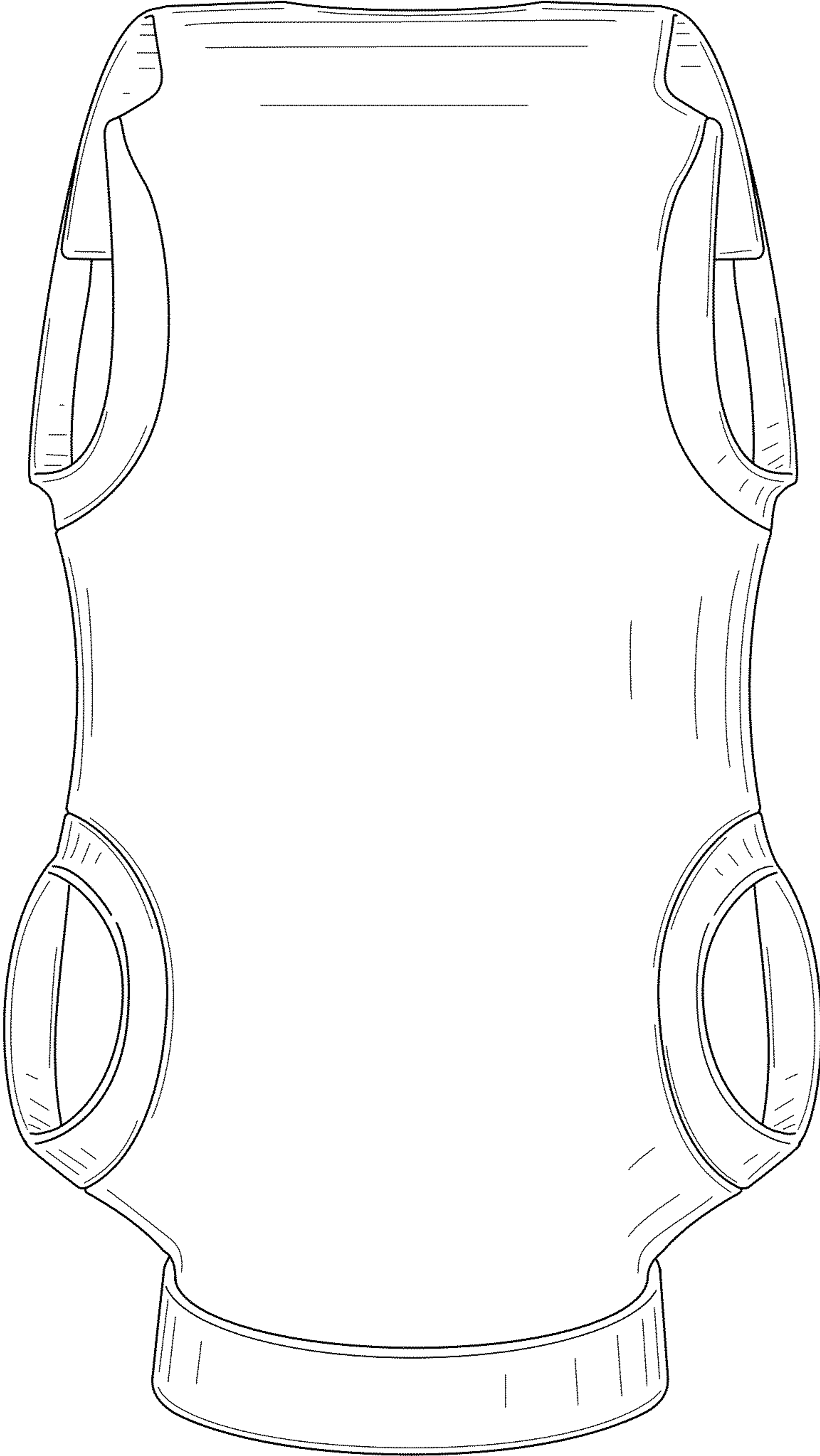
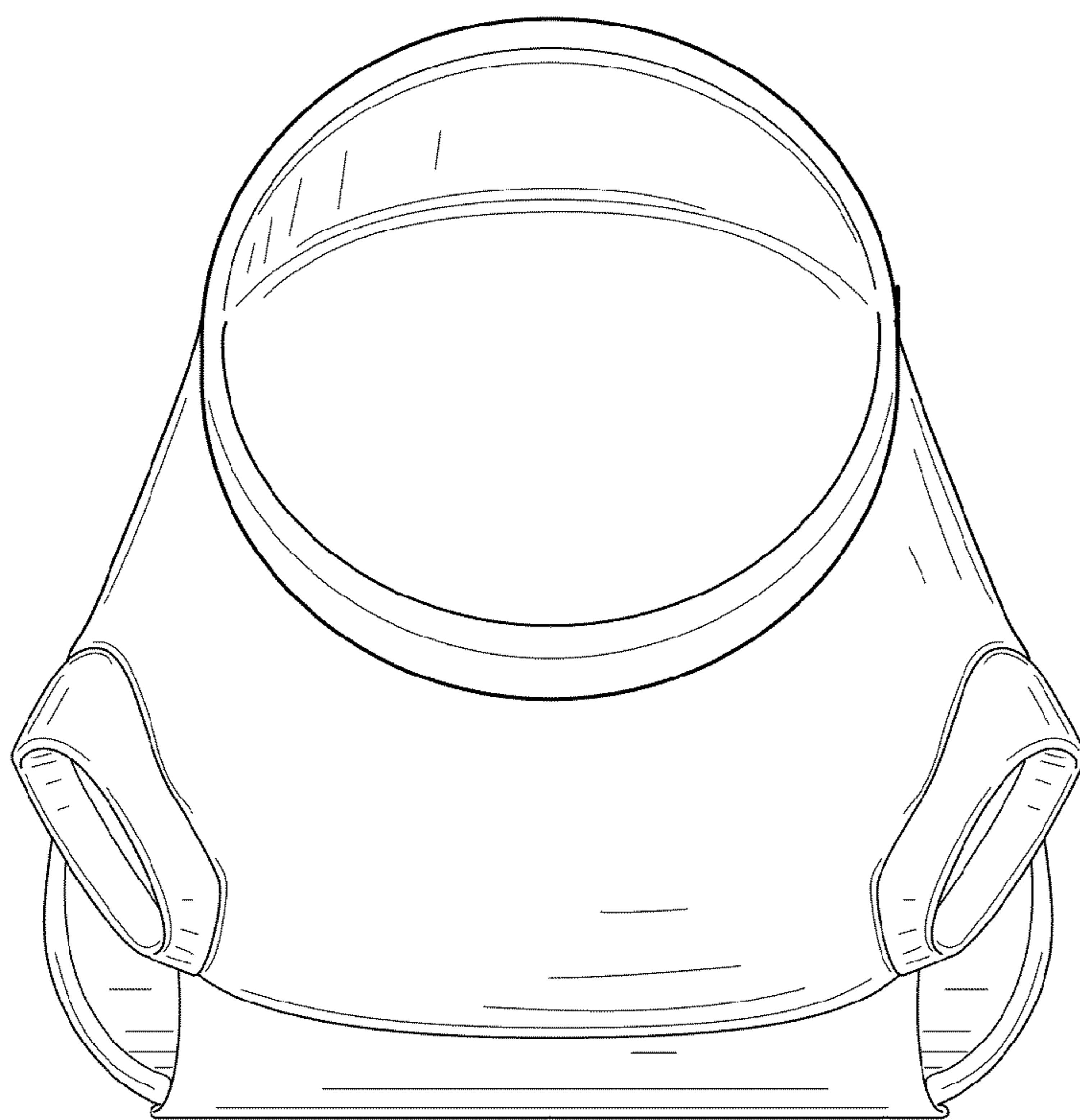
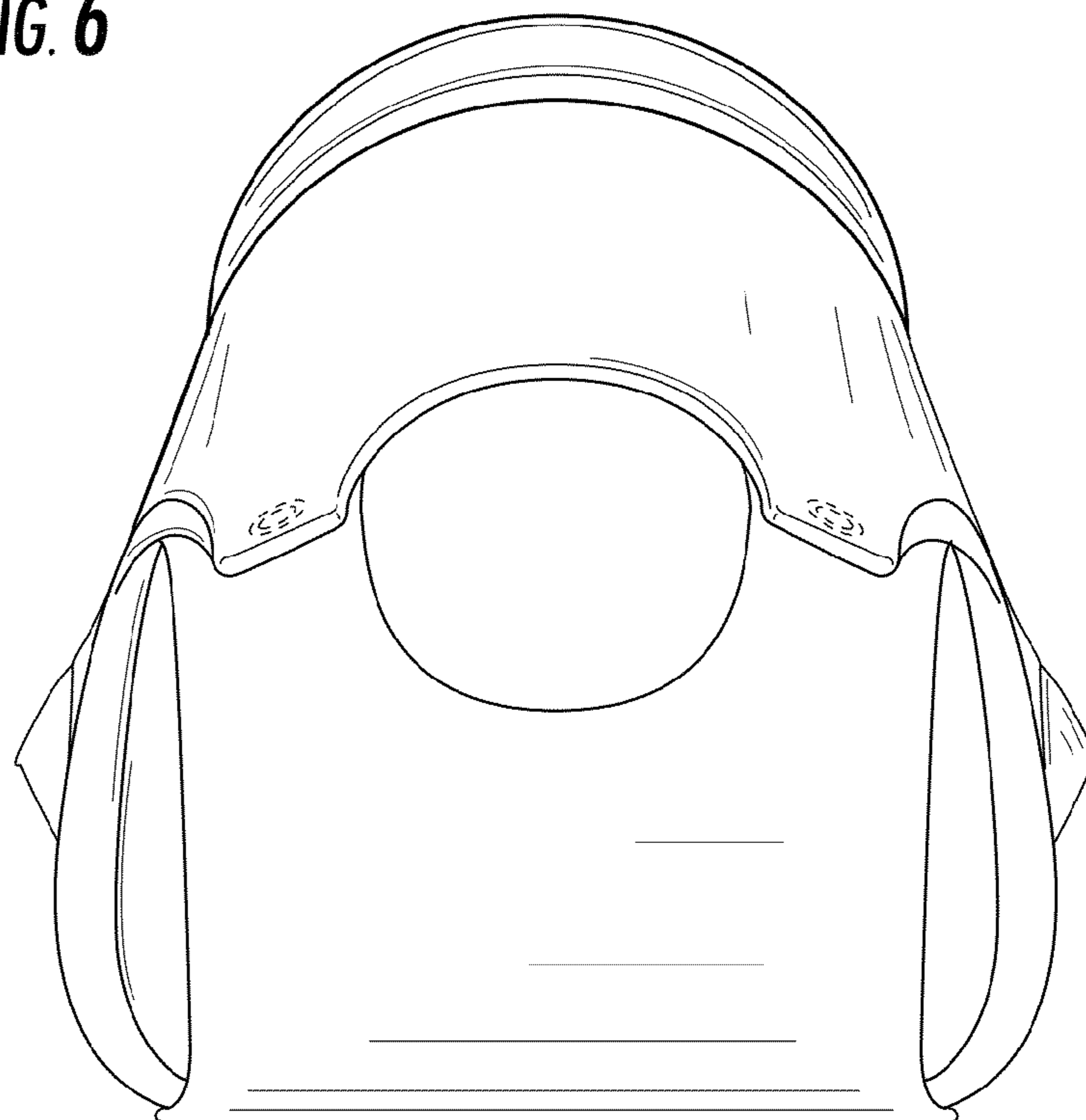

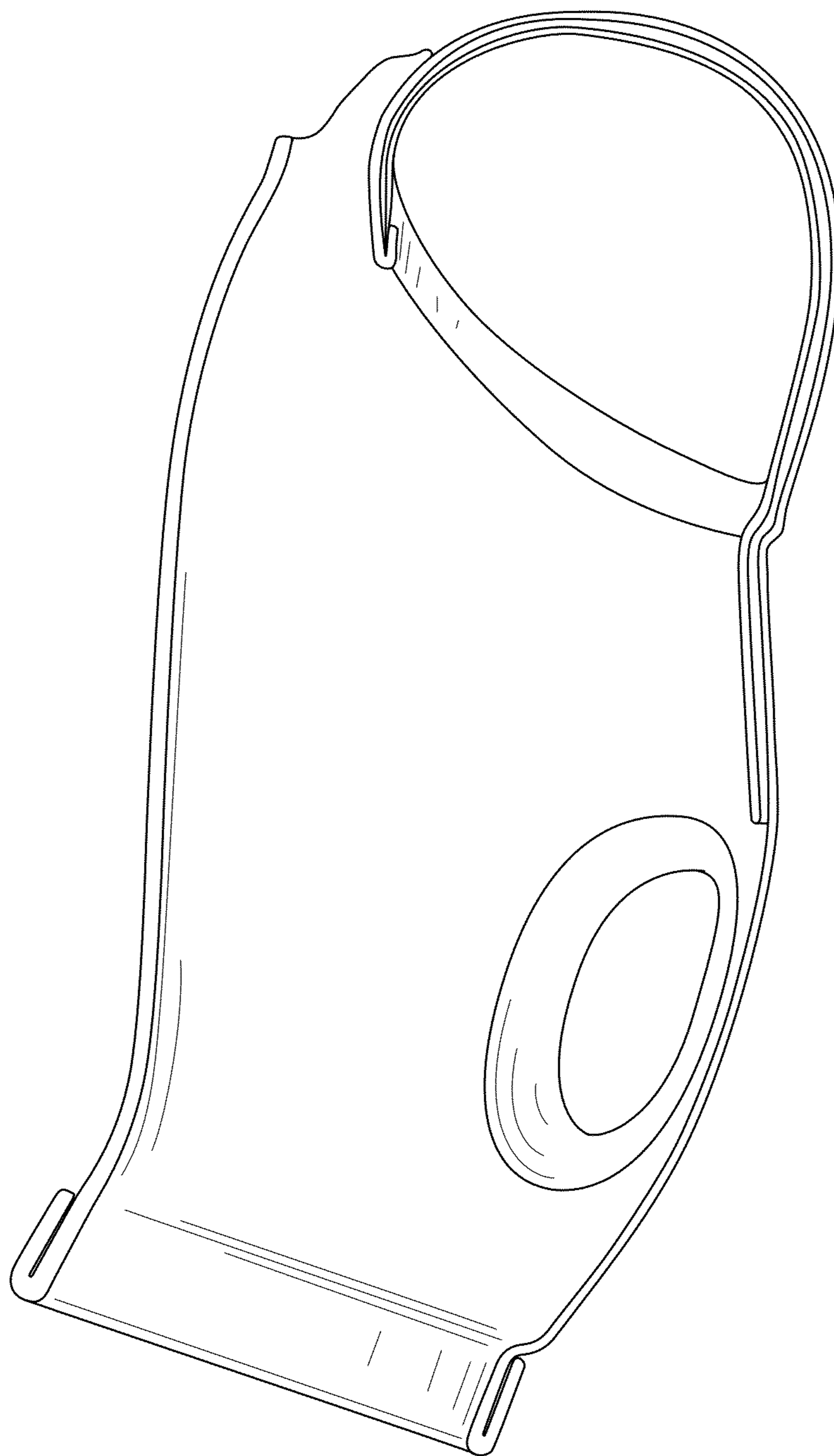

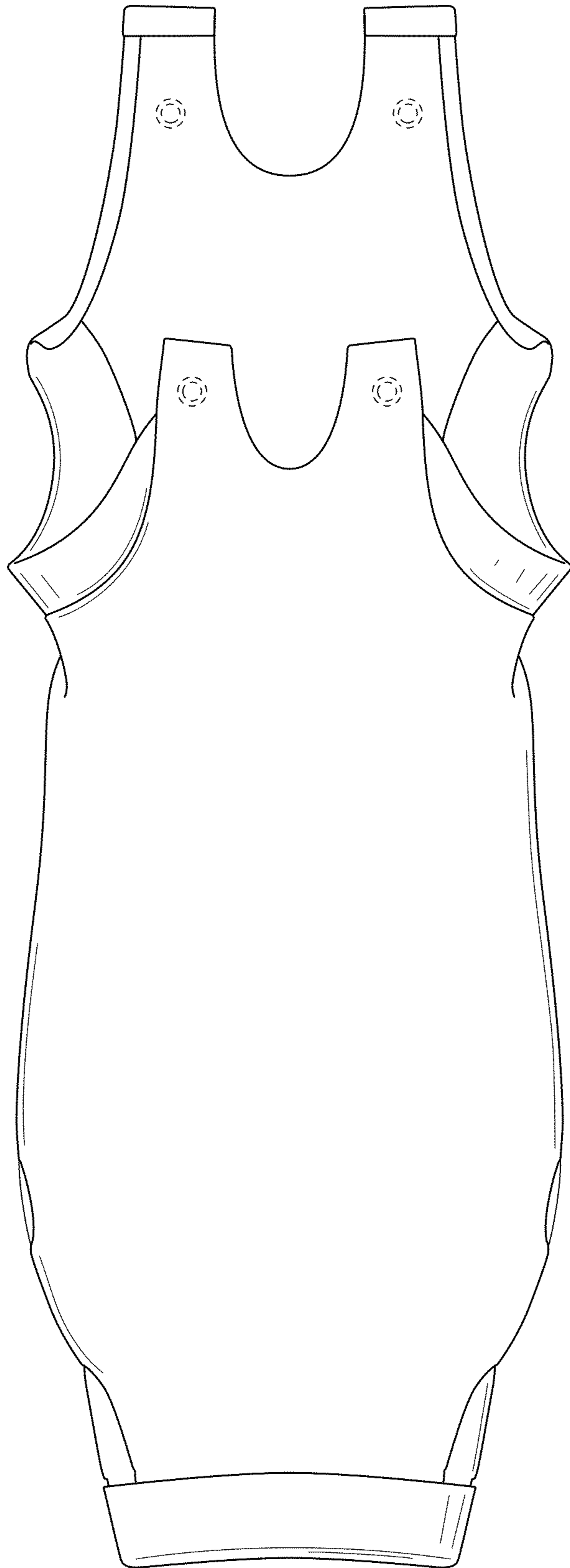
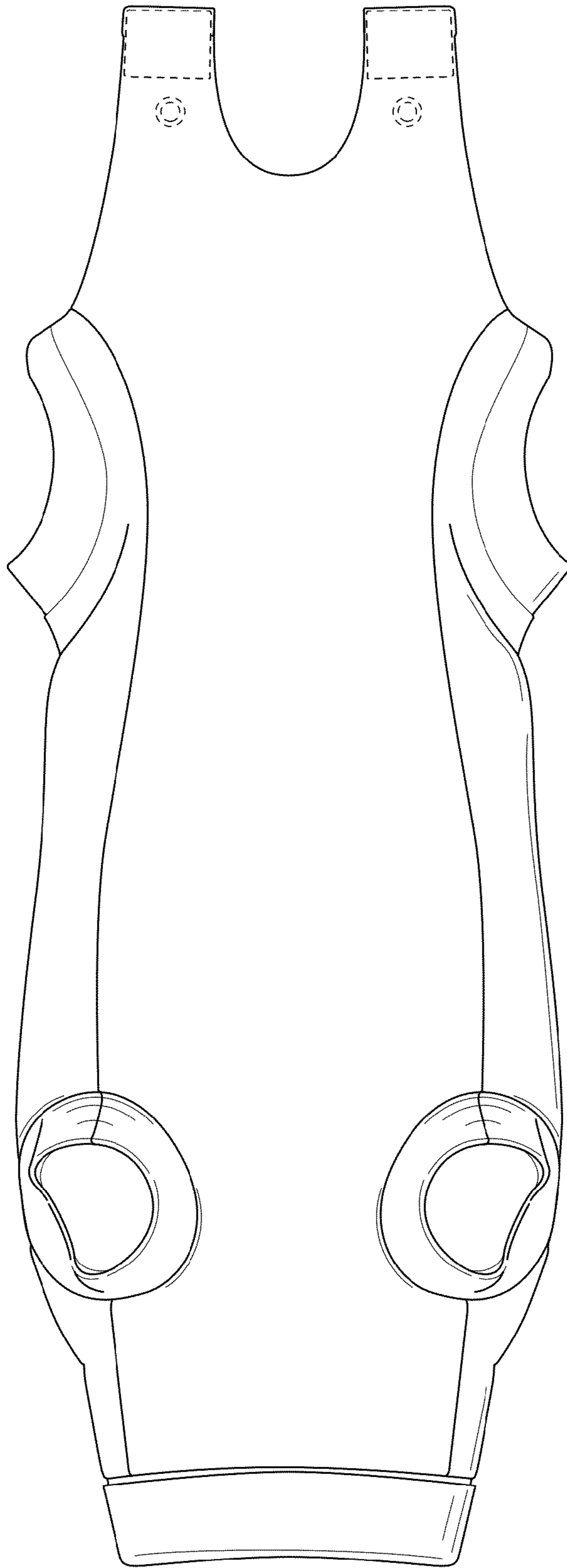

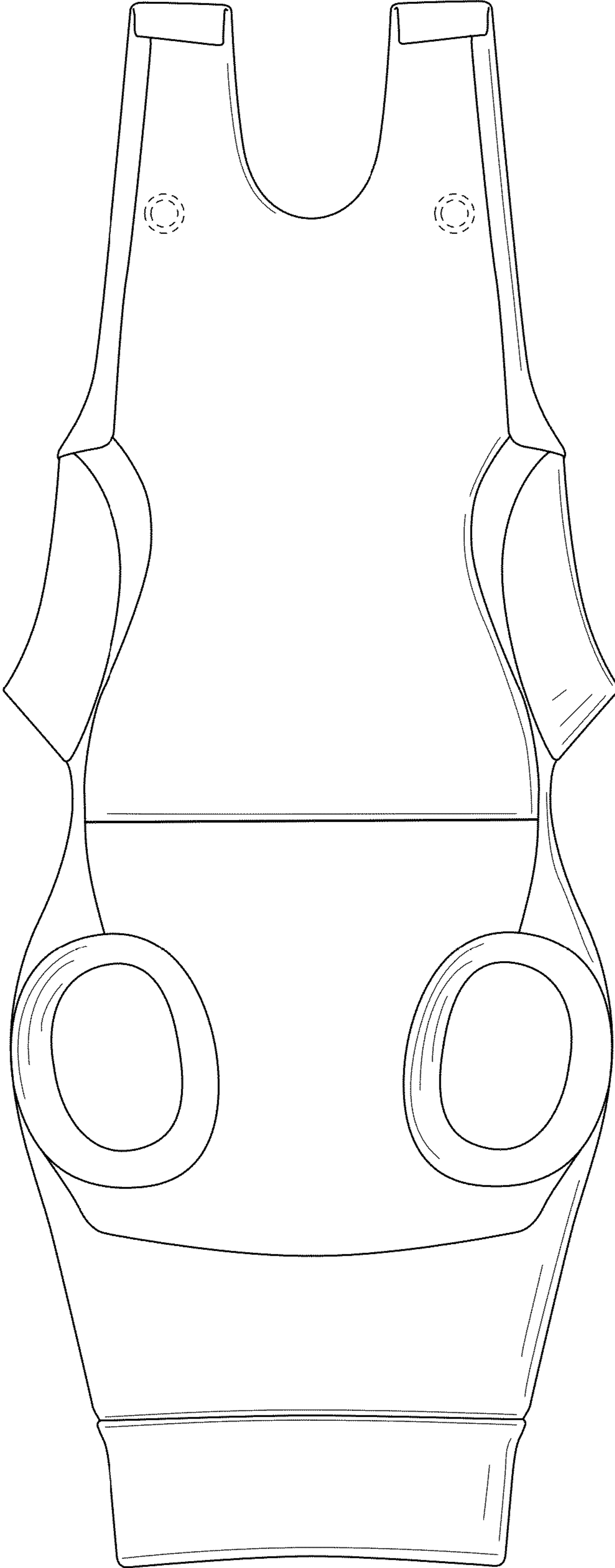
