(57) **CLAIM**

I claim the ornamental design for a swimsuit, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a swimsuit showing my new design according to a first embodiment of the present invention.

FIG. 2 is a front view of the swimsuit of FIG. 1.

FIG. 3 is a rear view of the swimsuit of FIG. 1.

FIG. 4 is a right-side view of the swimsuit of FIG. 1.

FIG. 5 is a left-side view of the swimsuit of FIG. 1.

FIG. 6 is a front view of the swimsuit of FIG. 1 wherein the skirt portion is in a partially retracted state.

FIG. 7 is a front view of the swimsuit of FIG. 6.

FIG. 8 is a rear view of the swimsuit of FIG. 6.

FIG. 9 is a right-side view of the swimsuit of FIG. 6.

FIG. 10 is a left-side view of the swimsuit of FIG. 6.

FIG. 11 is a front view of the swimsuit of FIG. 1 wherein the skirt portion is in a fully retracted state.

FIG. 12 is a front view of the swimsuit of FIG. 11.

FIG. 13 is a rear view of the swimsuit of FIG. 11.

FIG. 14 is a right-side view of the swimsuit of FIG. 11.

FIG. 15 is a left-side view of the swimsuit of FIG. 11.

FIG. 16 is a front view of a swimsuit showing my new design according to a second embodiment of the present invention.

FIG. 17 is a front view of the swimsuit of FIG. 16.

FIG. 18 is a rear view of the swimsuit of FIG. 16.

FIG. 19 is a right-side view of the swimsuit of FIG. 16.

FIG. 20 is a left-side view of the swimsuit of FIG. 16.

FIG. 21 is a front view of the swimsuit of FIG. 16 wherein the skirt portion is in a partially retracted state.

FIG. 22 is a front view of the swimsuit of FIG. 21.

FIG. 23 is a rear view of the swimsuit of FIG. 21.

FIG. 24 is a right-side view of the swimsuit of FIG. 21.

FIG. 25 is a left-side view of the swimsuit of FIG. 21.

FIG. 26 is a front view of the swimsuit of FIG. 16 wherein the skirt portion is in a fully retracted state.

FIG. 27 is a front view of the swimsuit of FIG. 26.

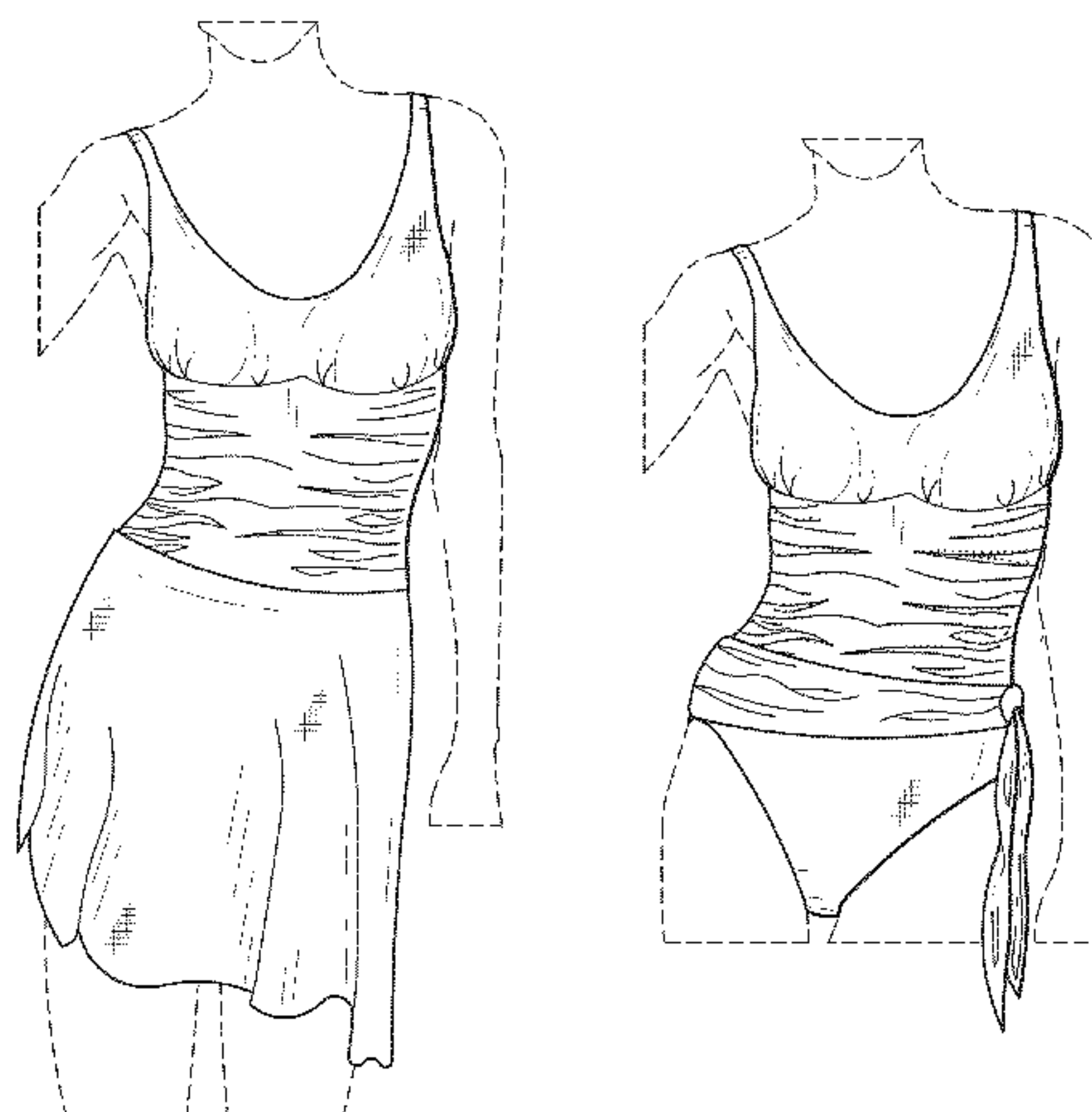
FIG. 28 is a rear view of the swimsuit of FIG. 26.

FIG. 29 is a right-side view of the swimsuit of FIG. 26; and, FIG. 30 is a left-side view of the swimsuit of FIG. 26.

In FIGS. 1-30, the curvy lines of varying lengths in the torso region of the swimsuit represent shirring.

The broken lines formed by linear segments of equal length are provided for environment only and form no part of the claimed design.

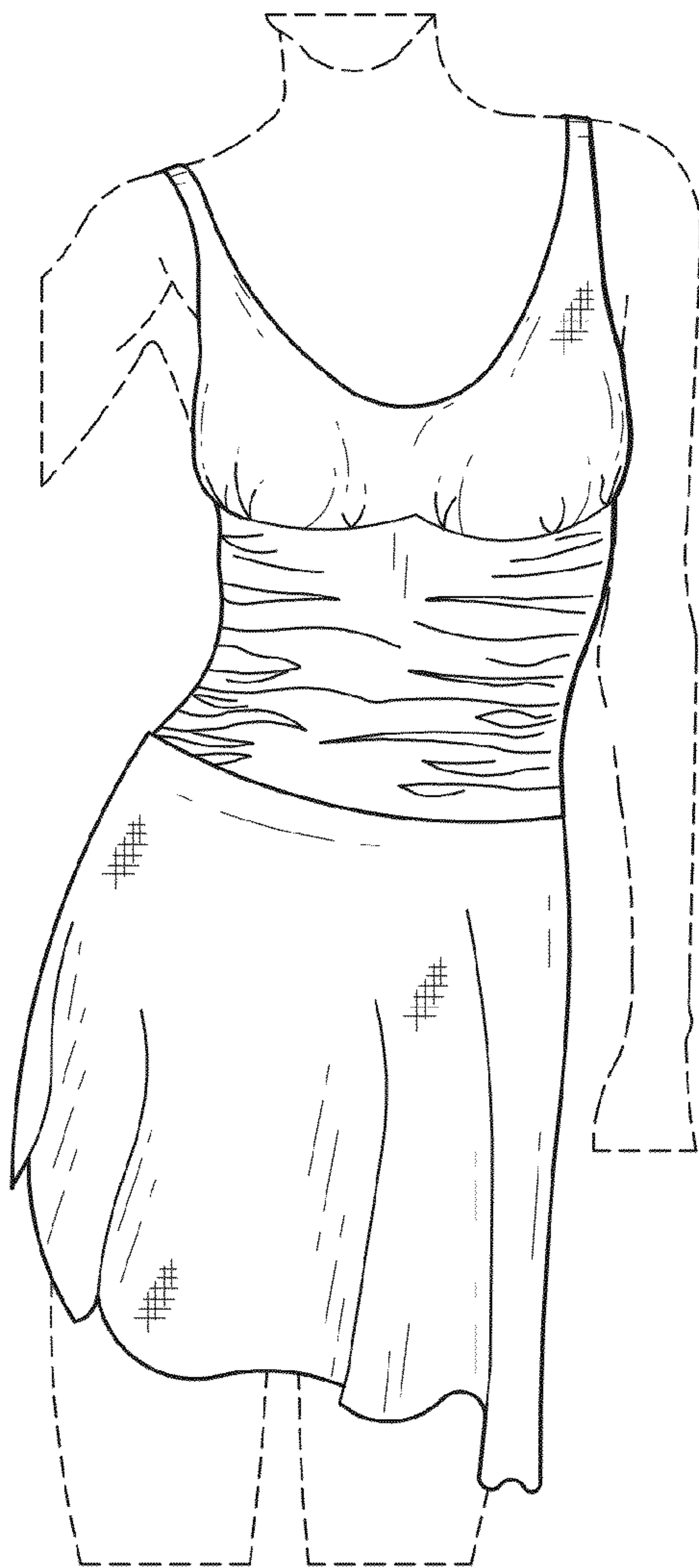

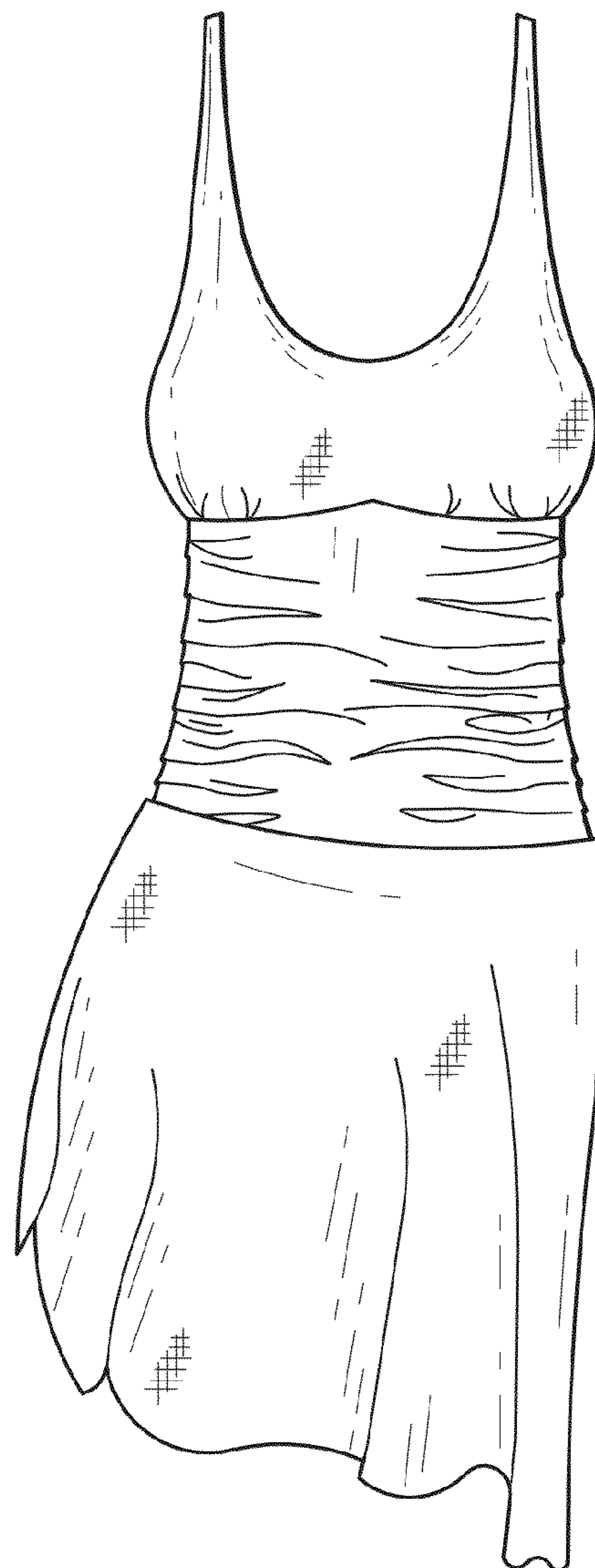
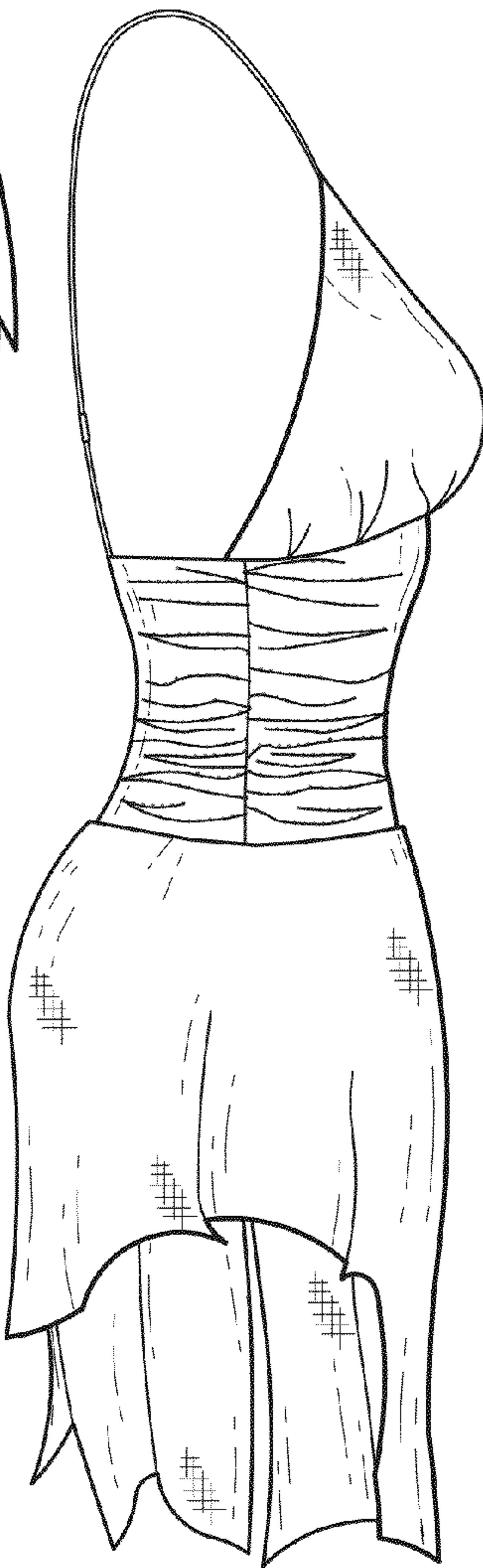
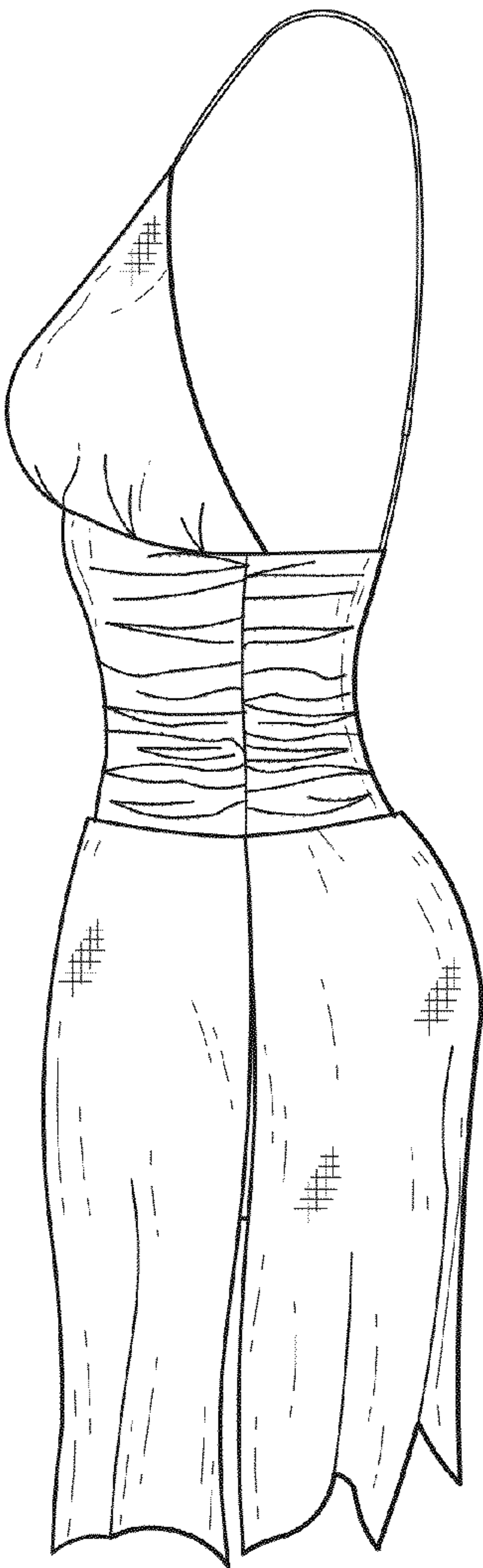
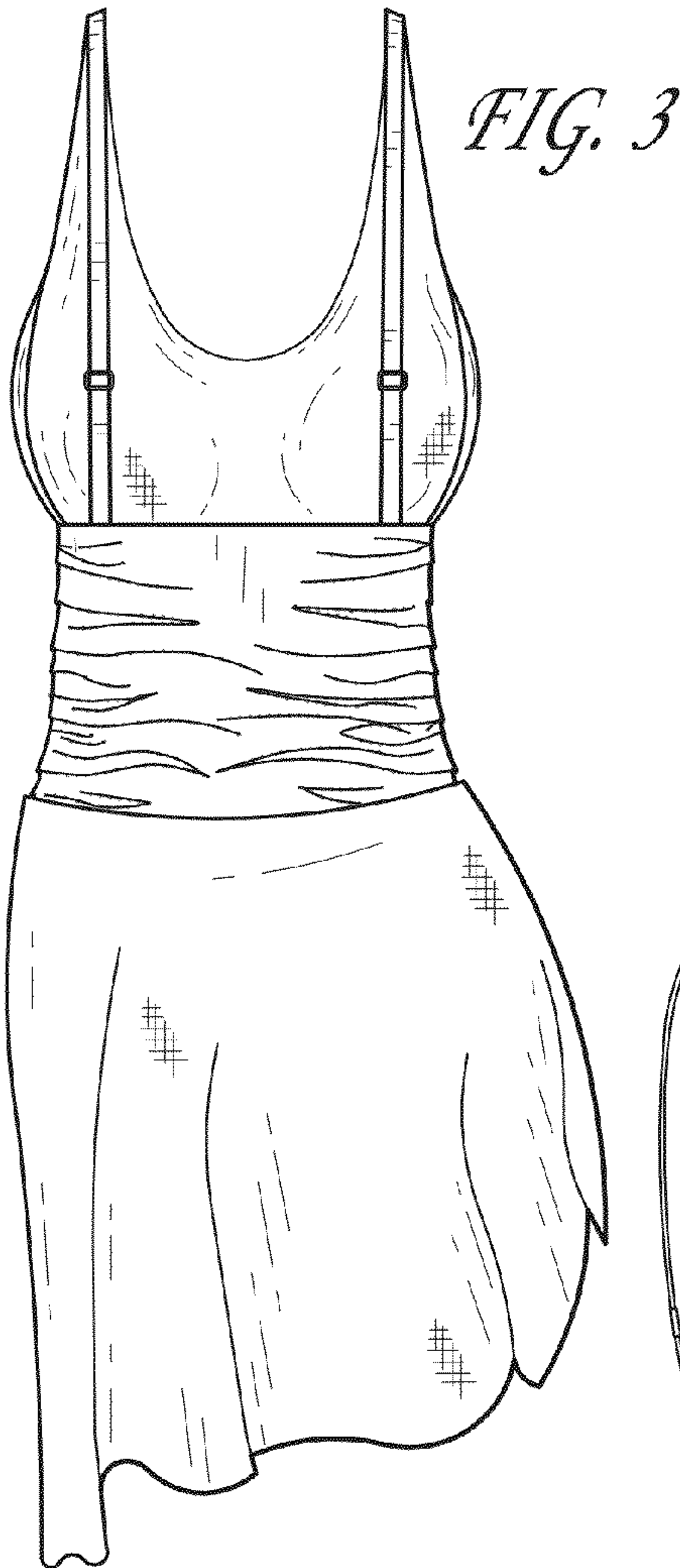

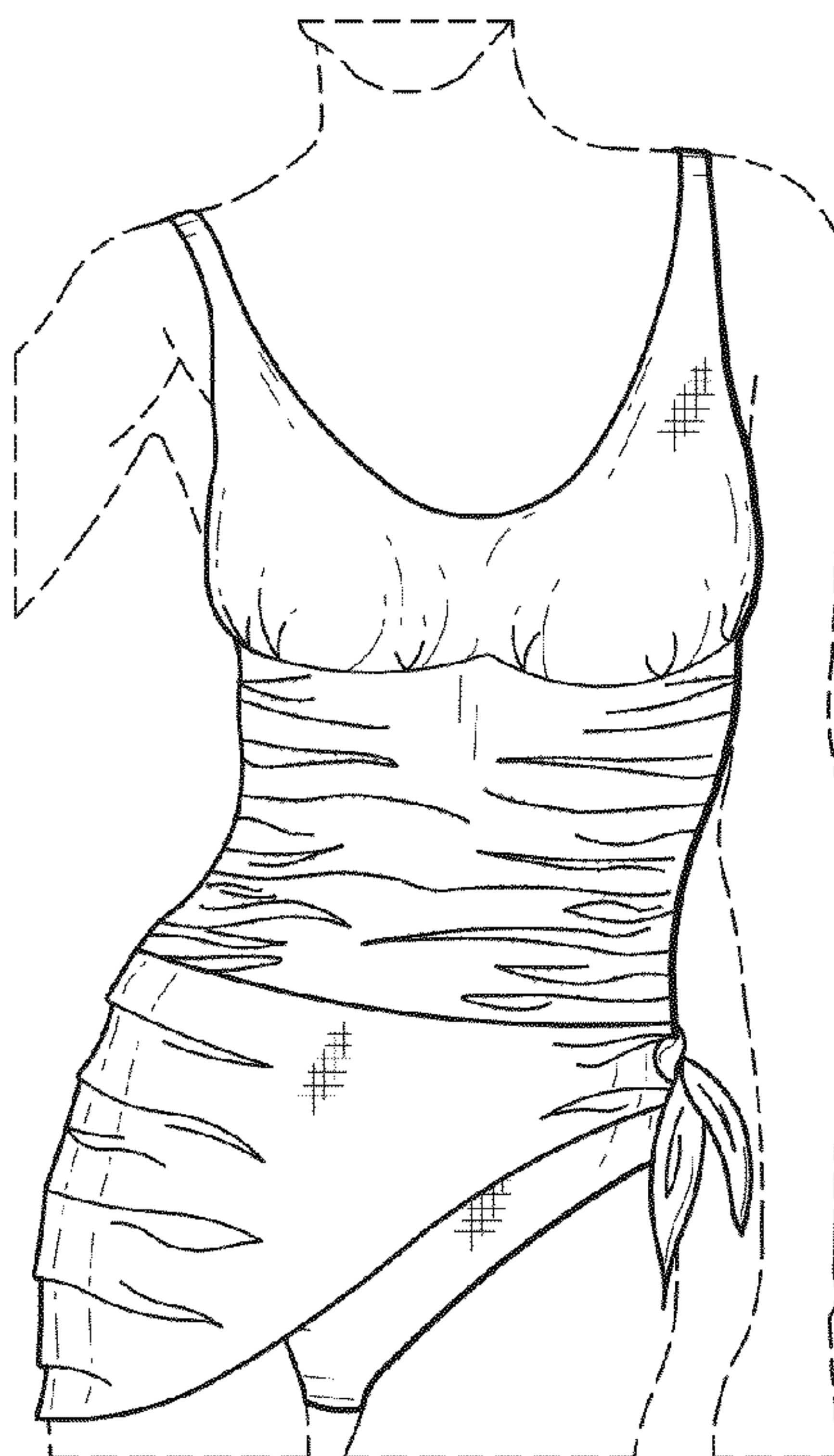

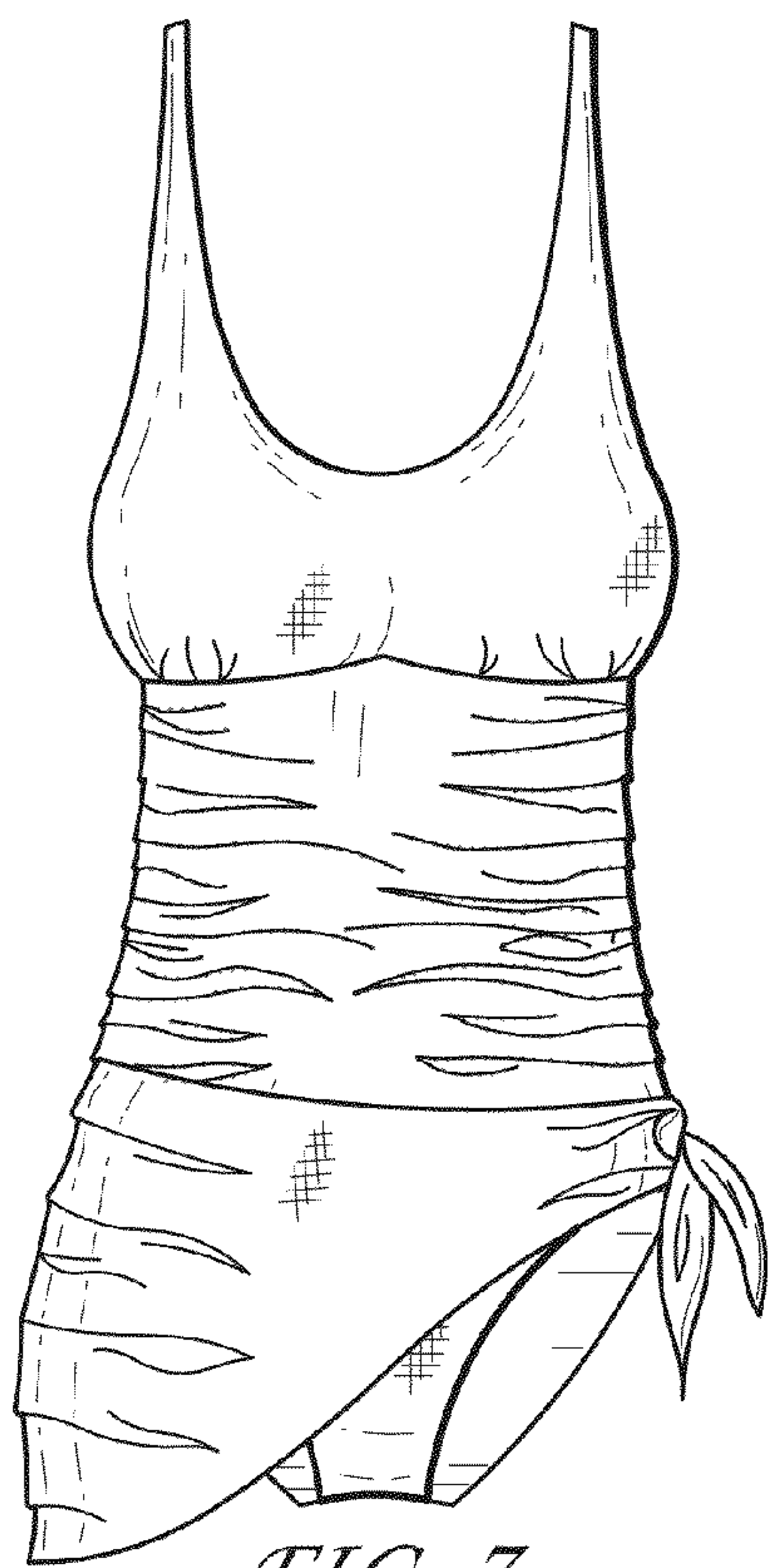

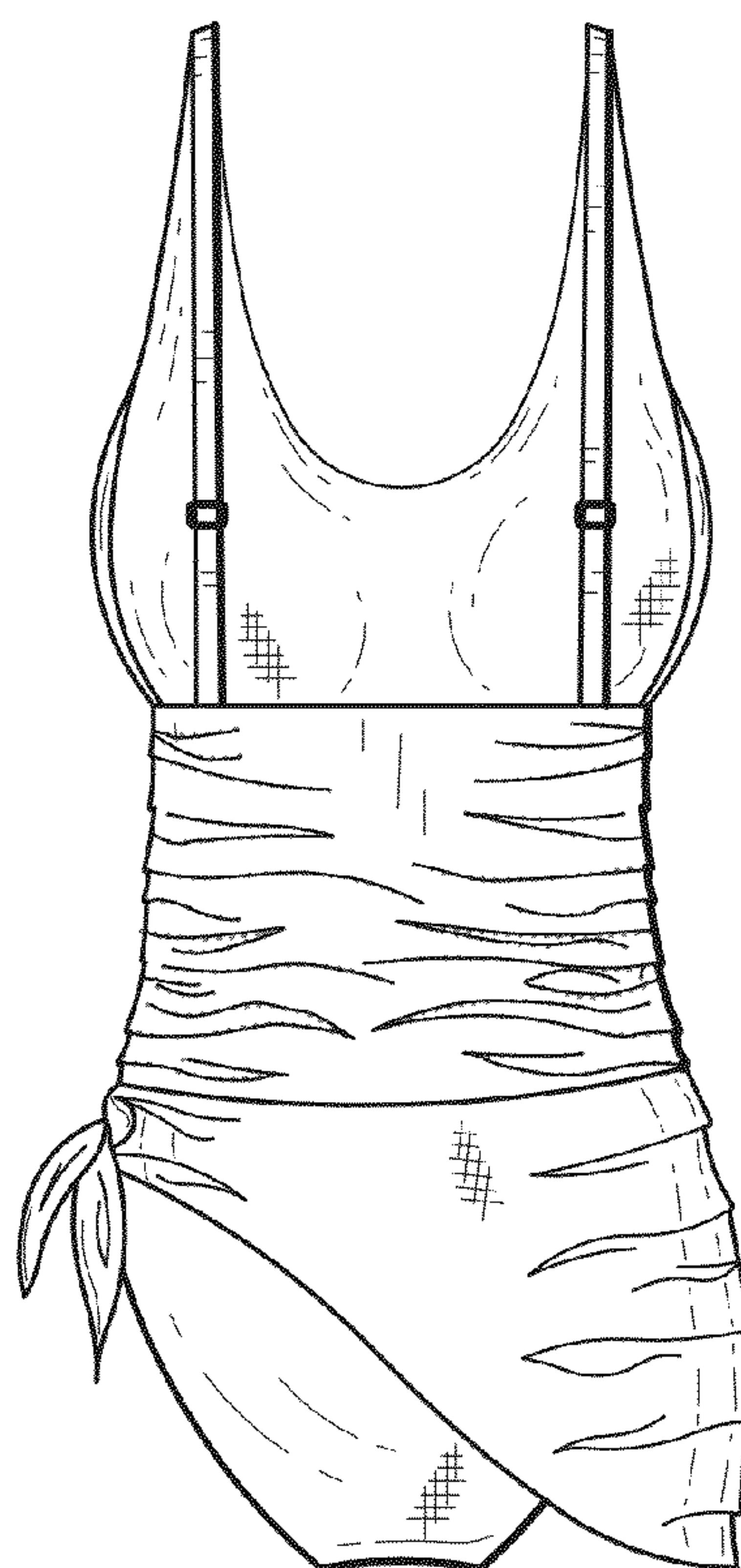

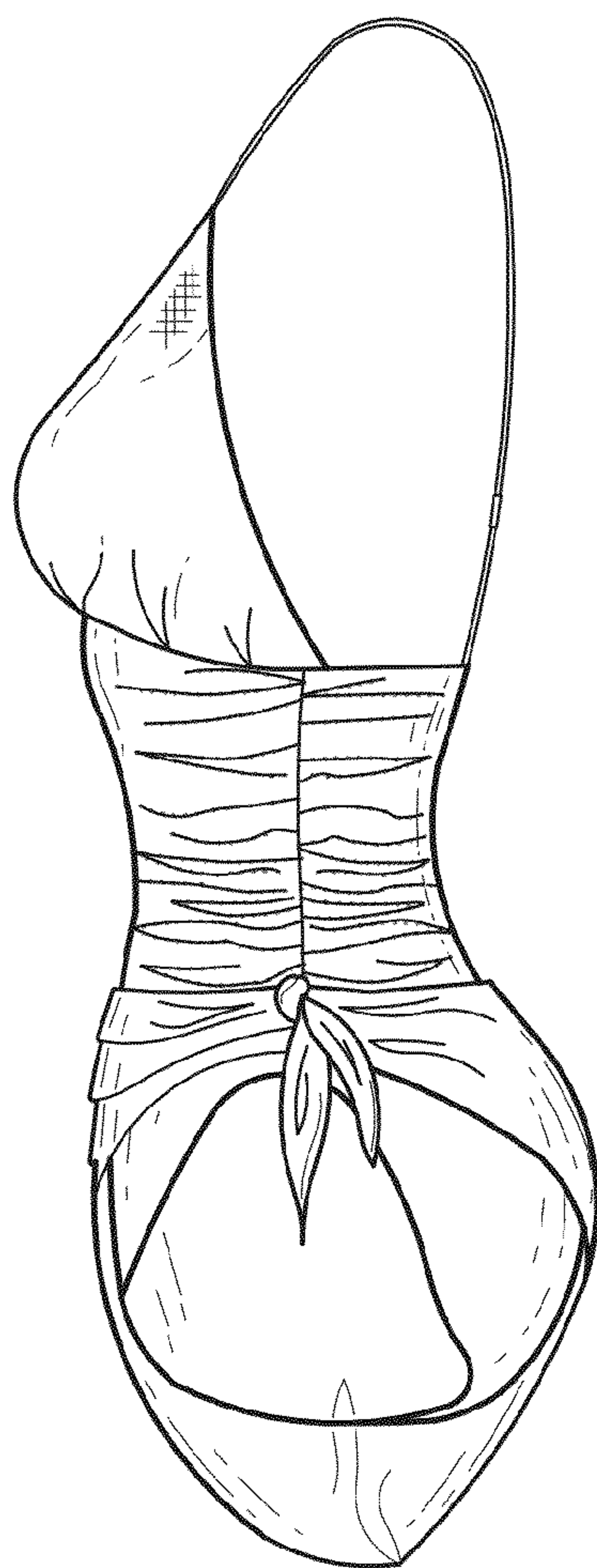

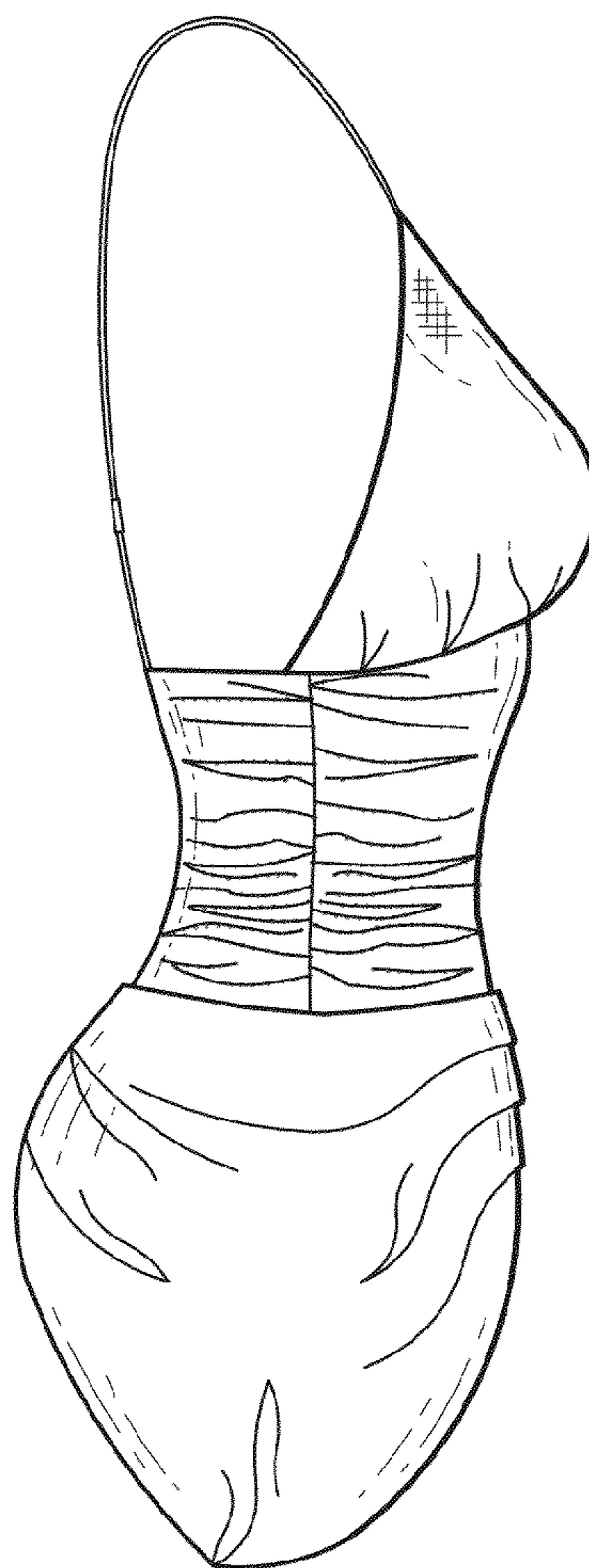

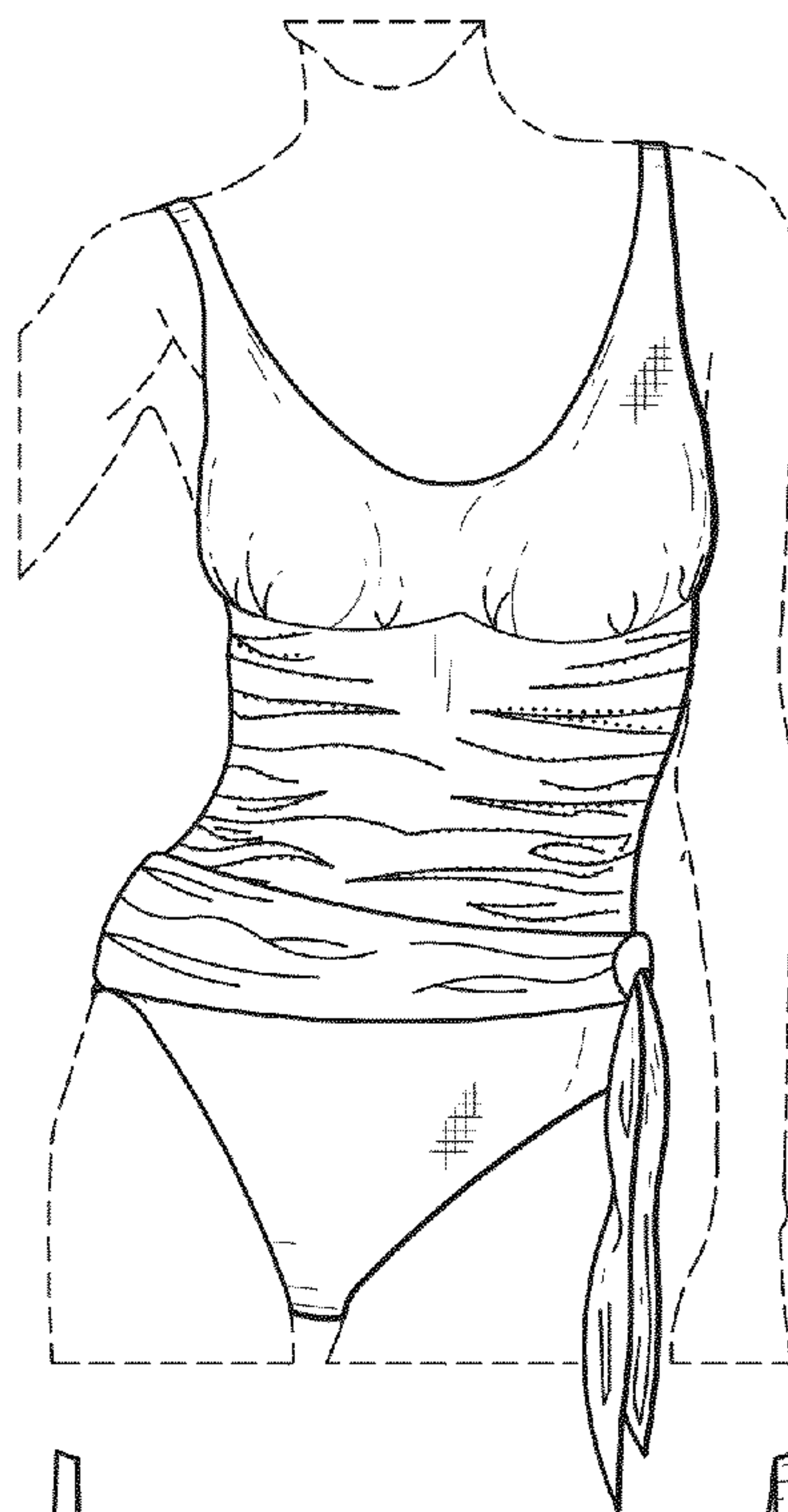

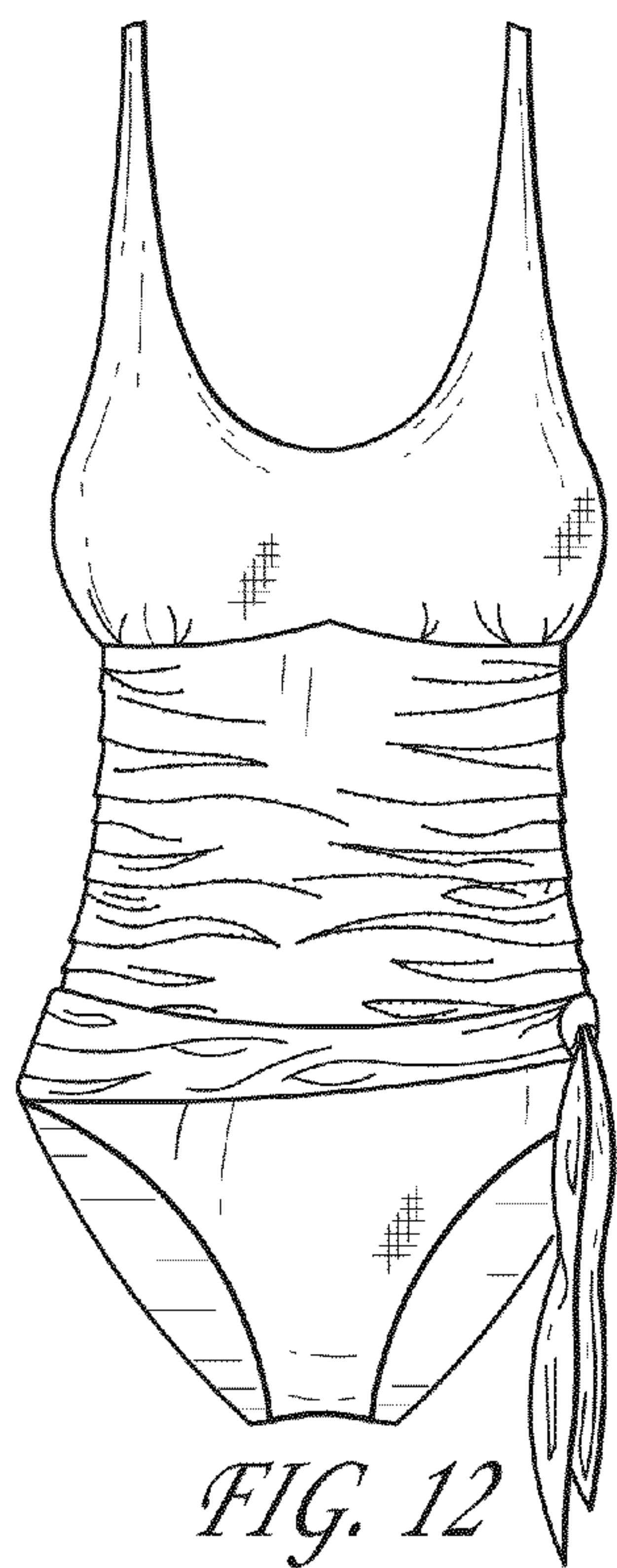

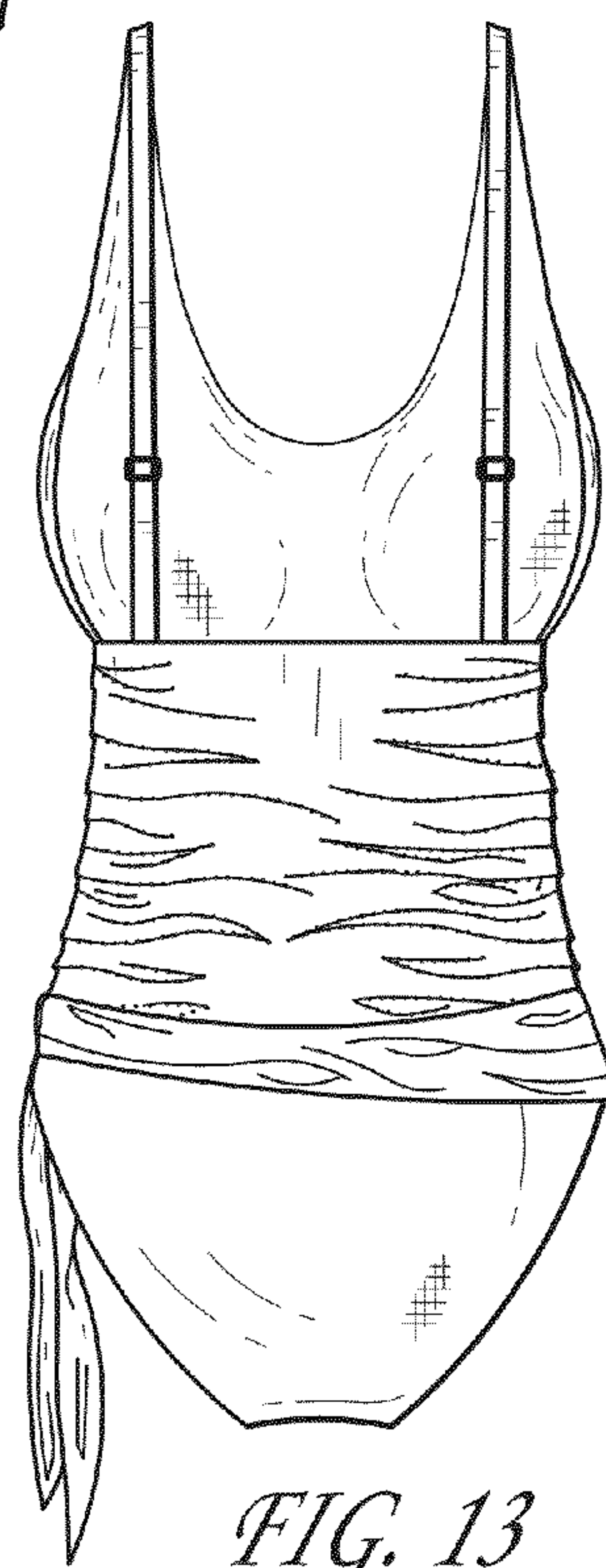

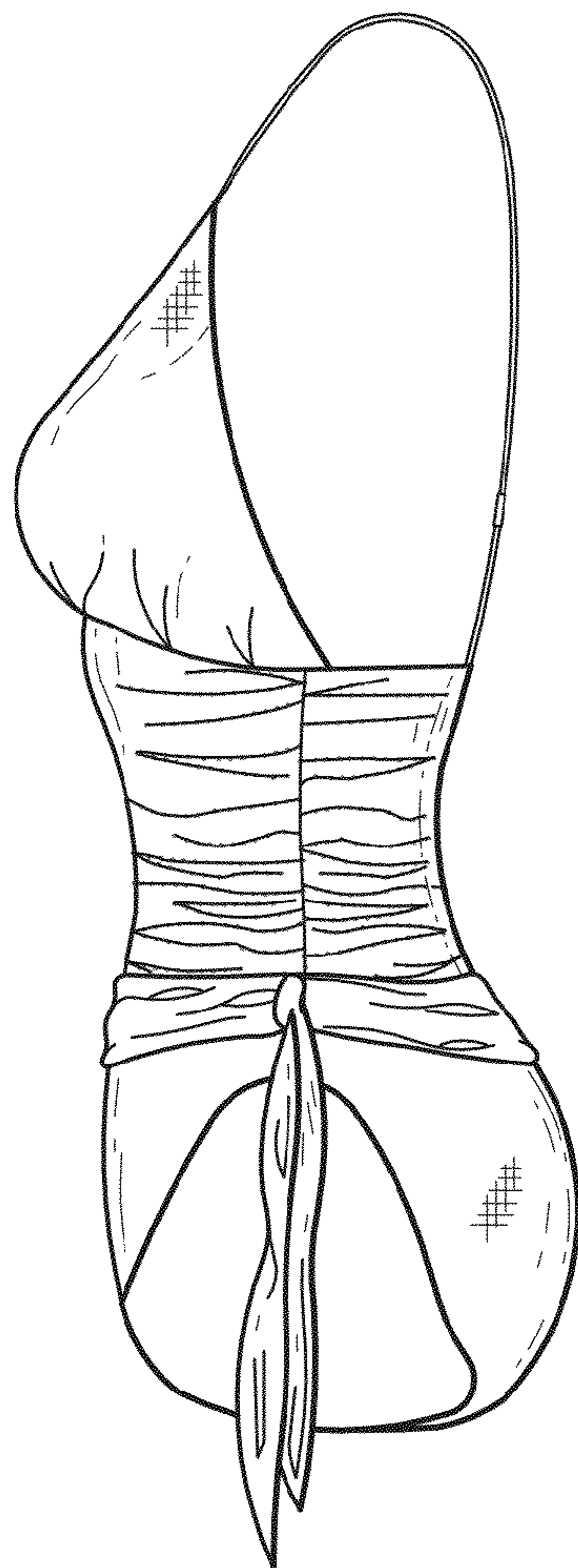

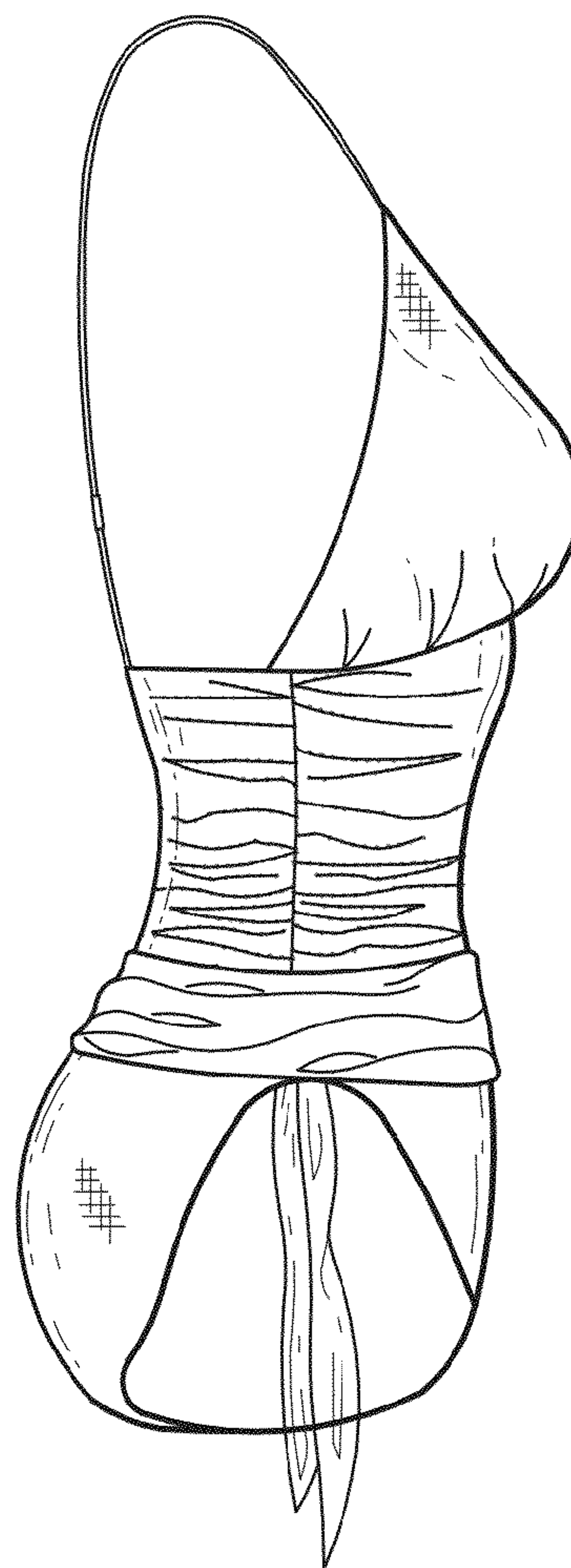

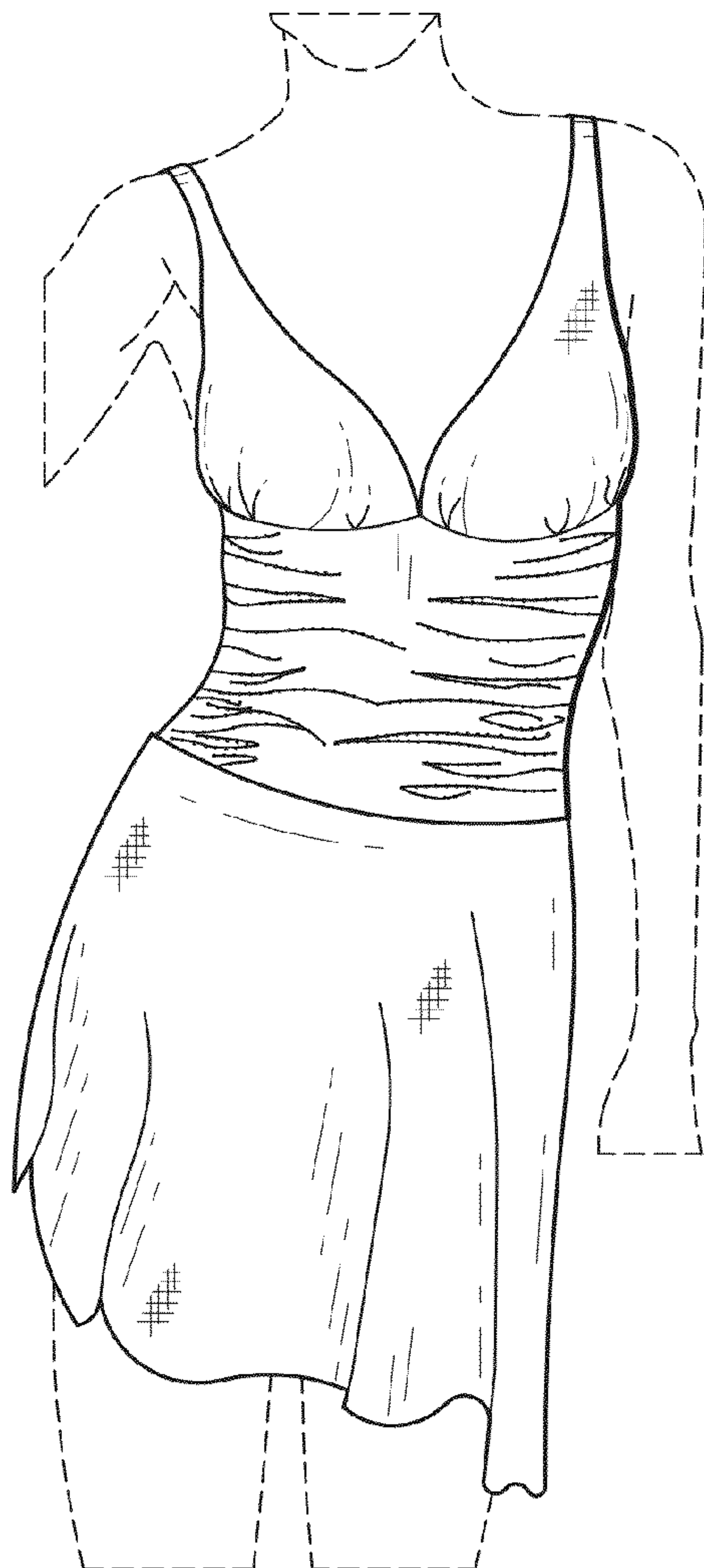

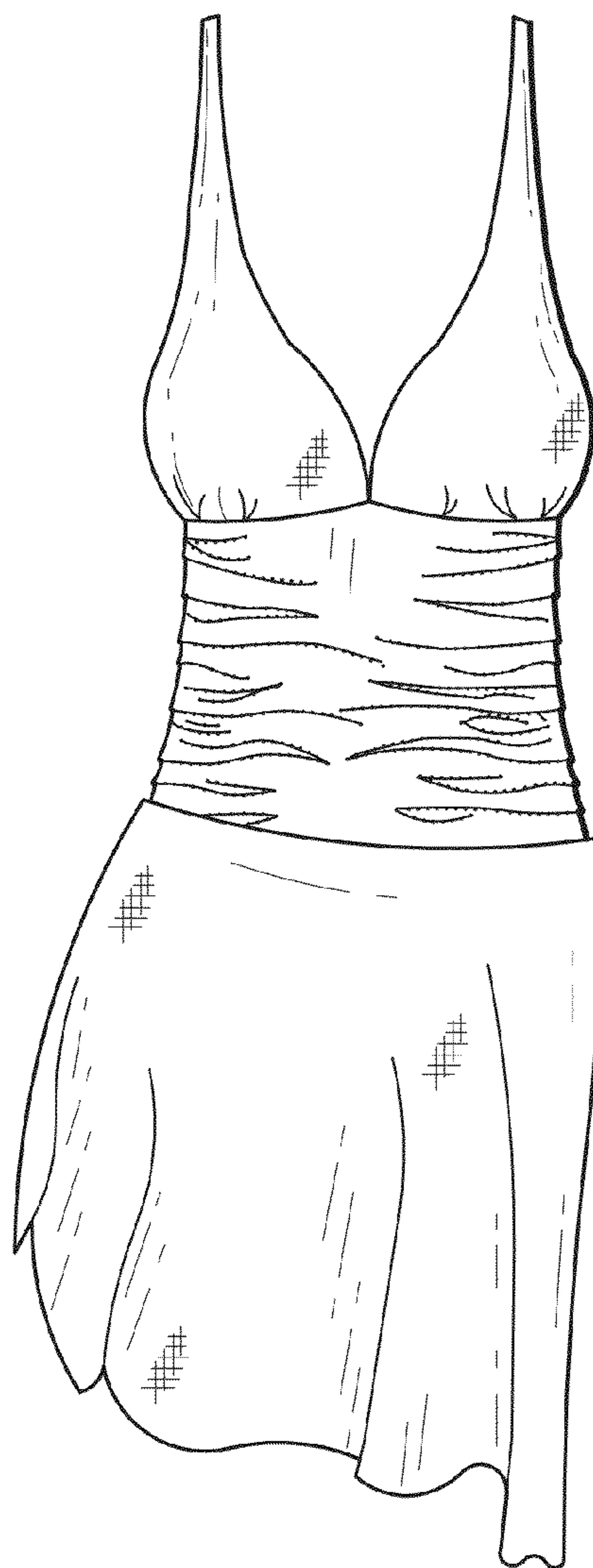
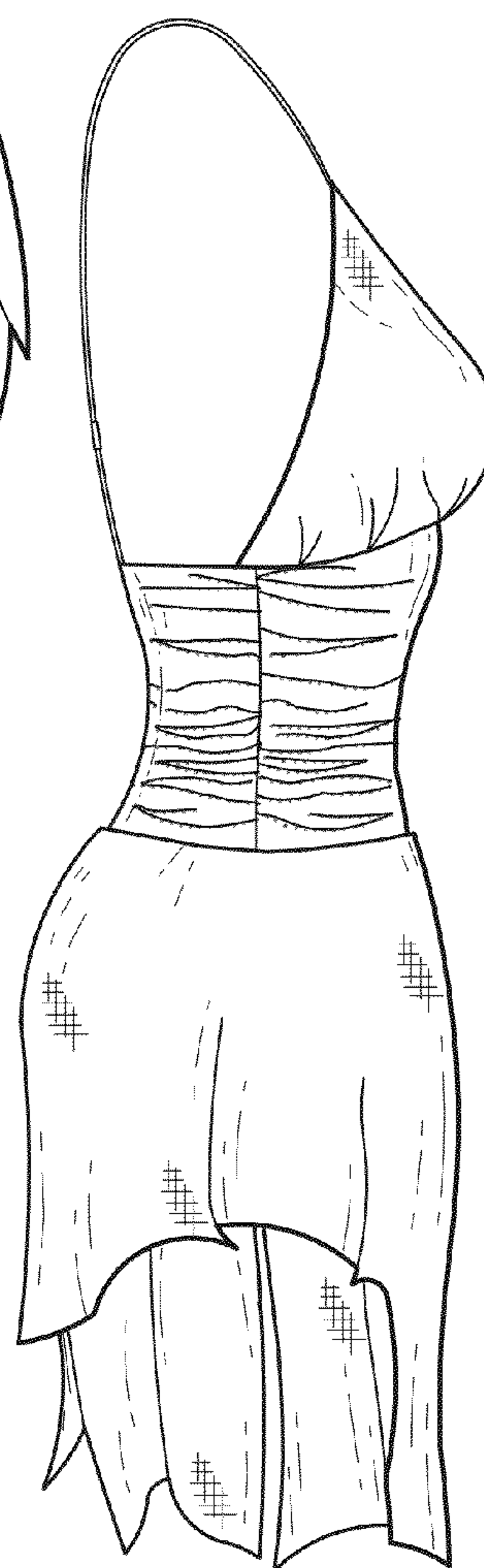
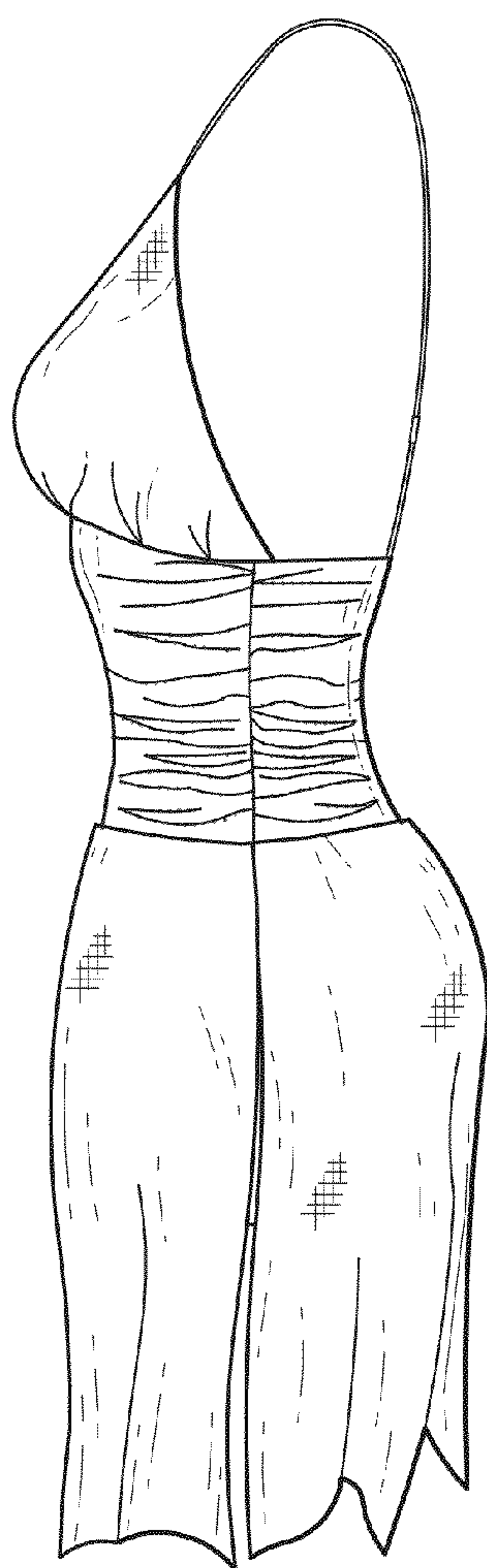
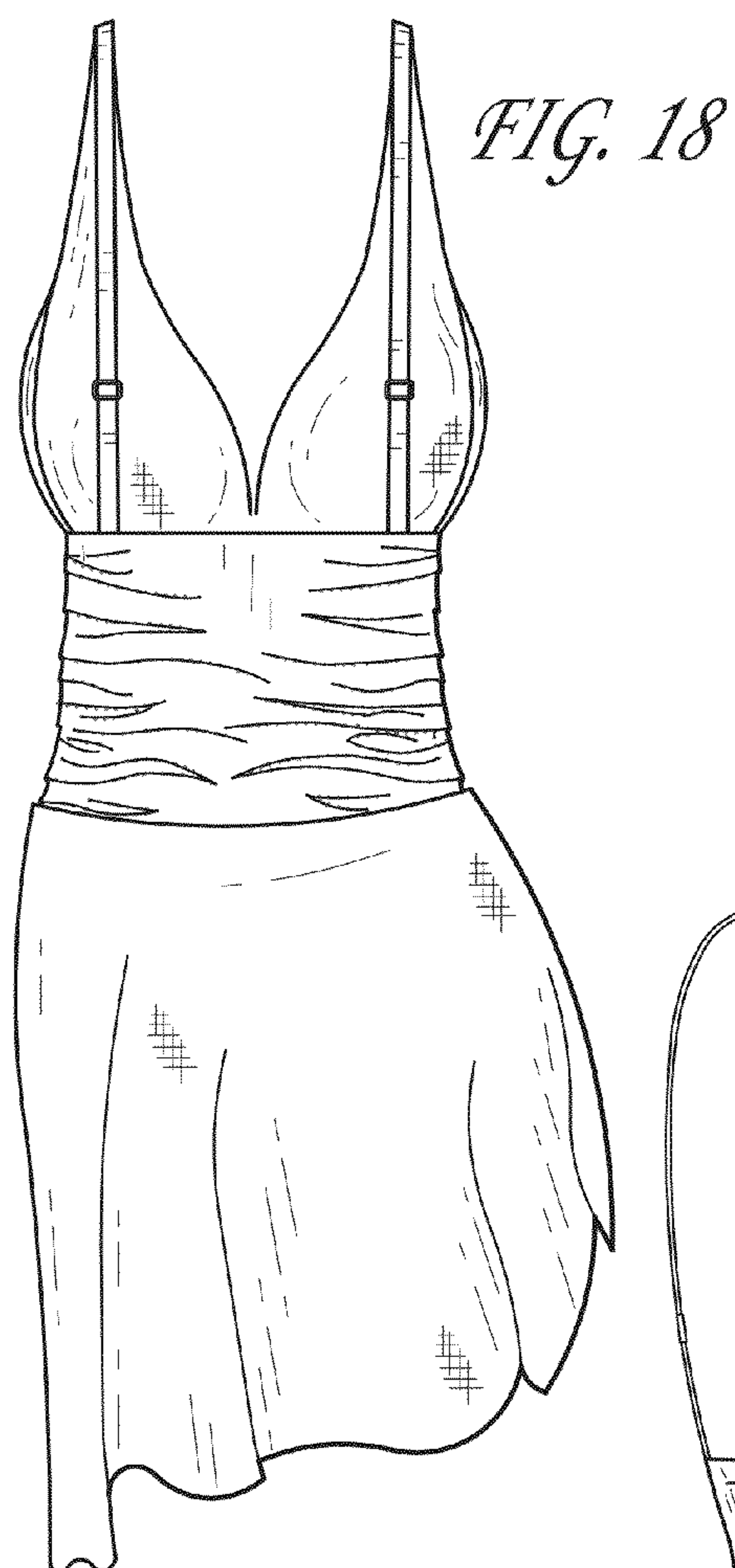

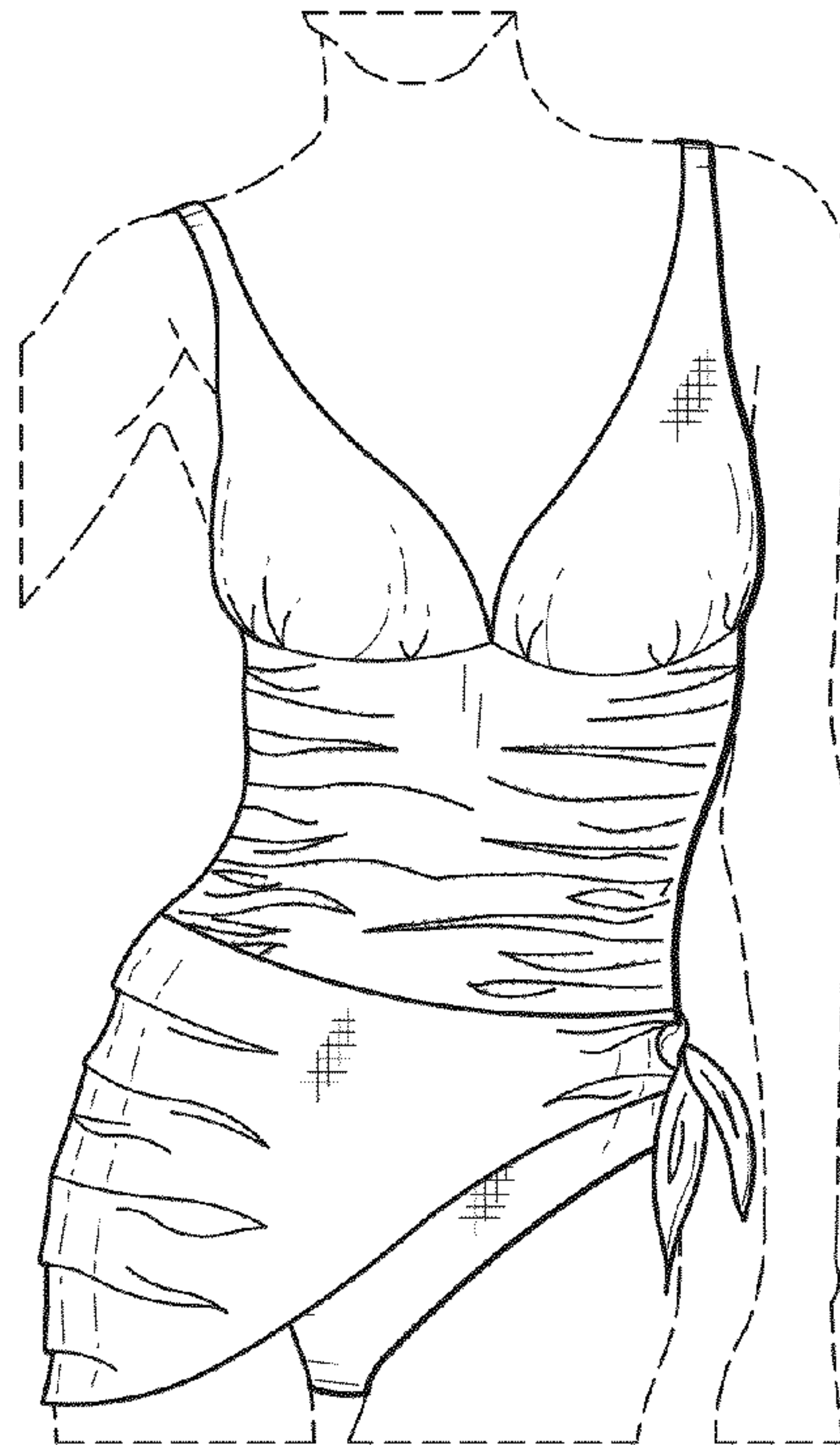

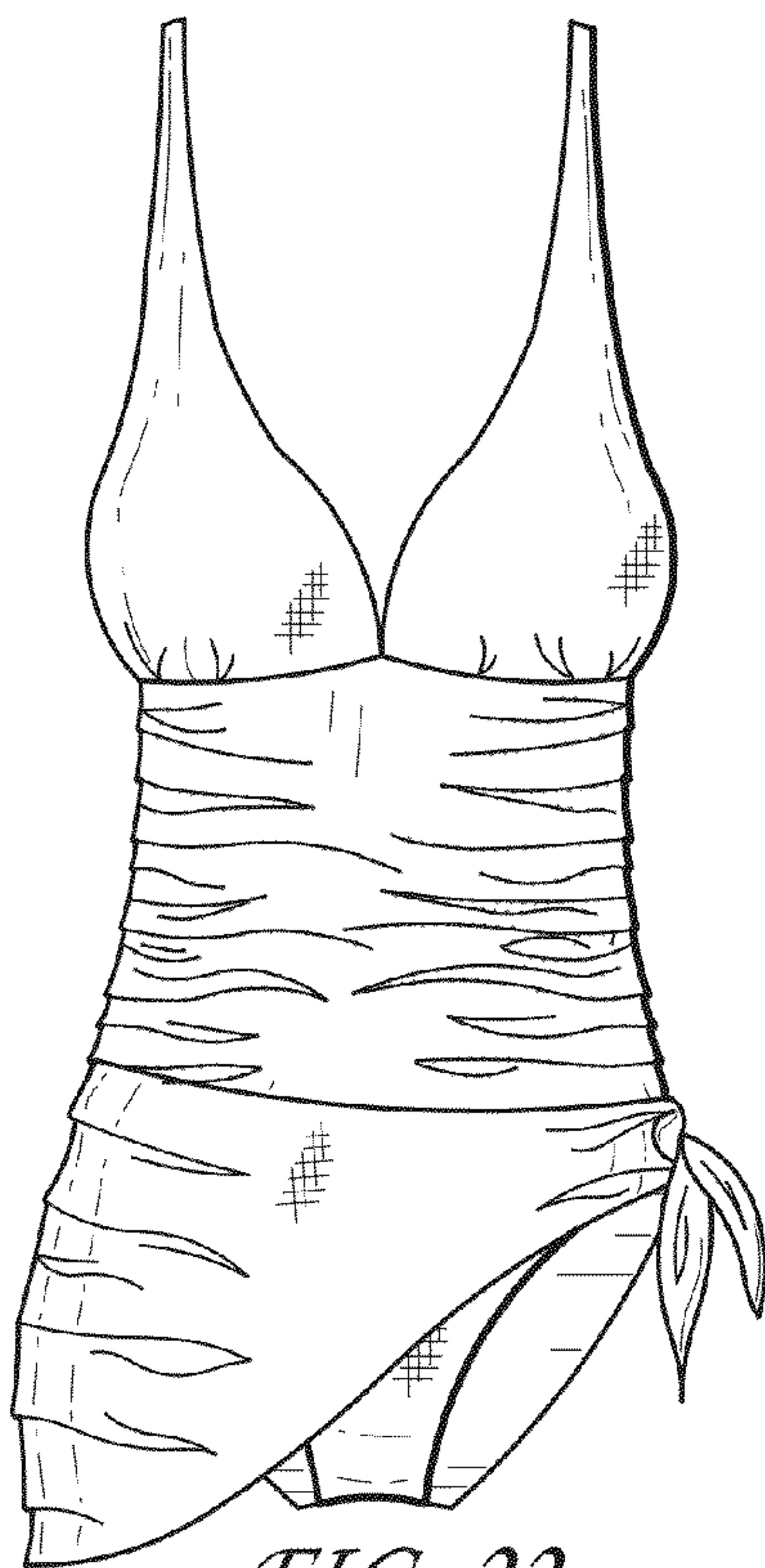

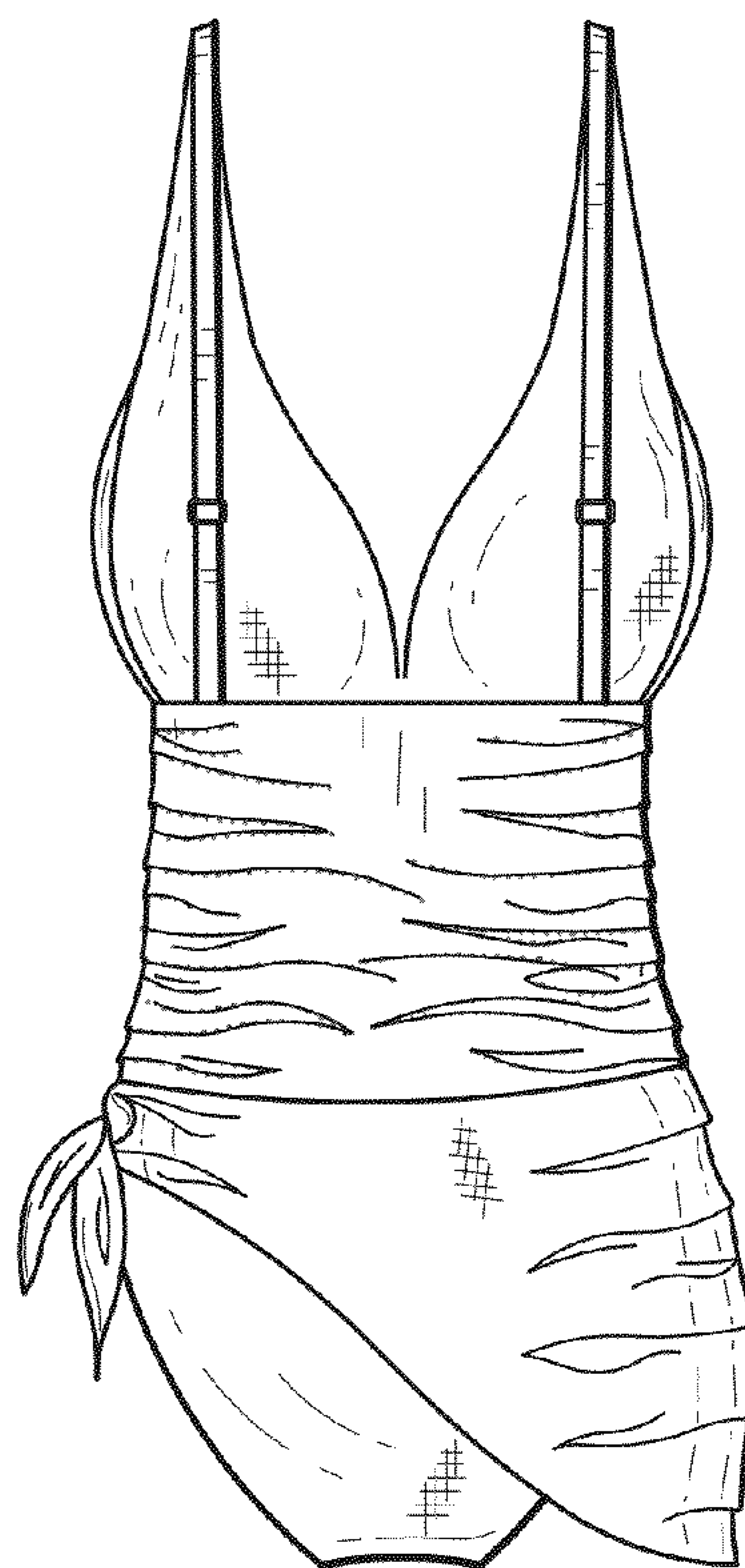

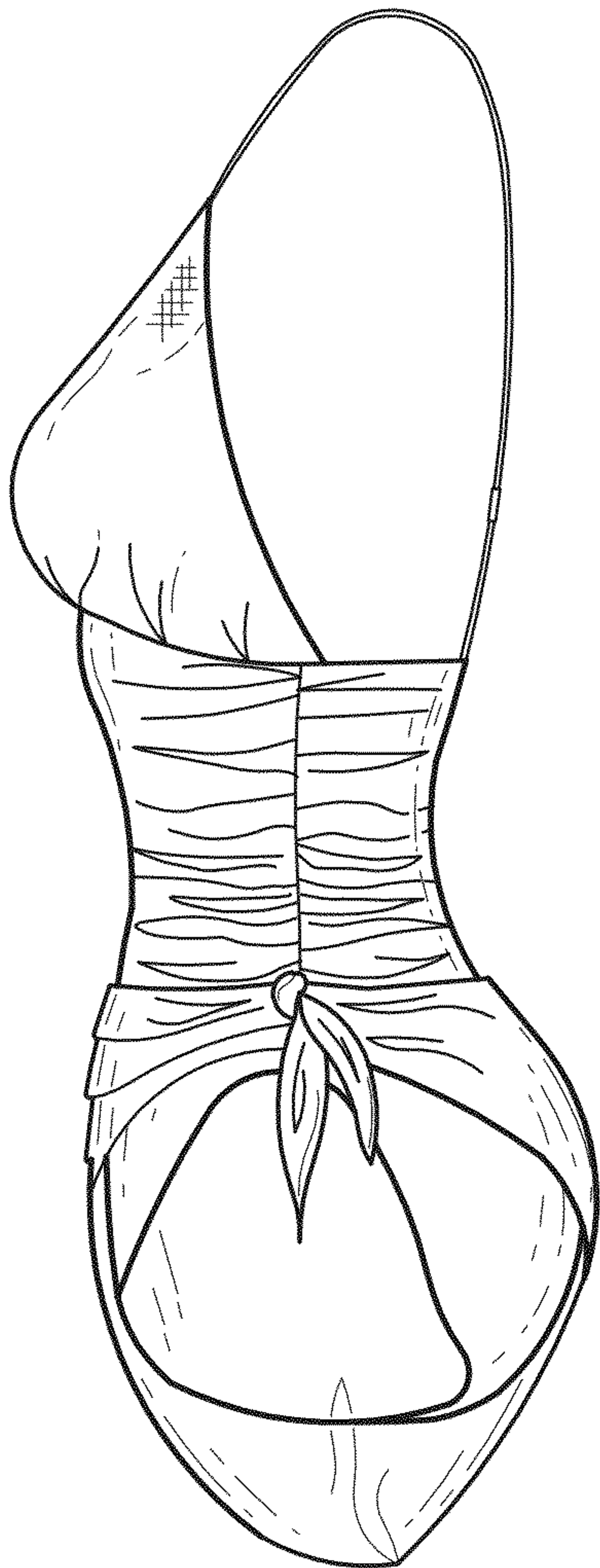

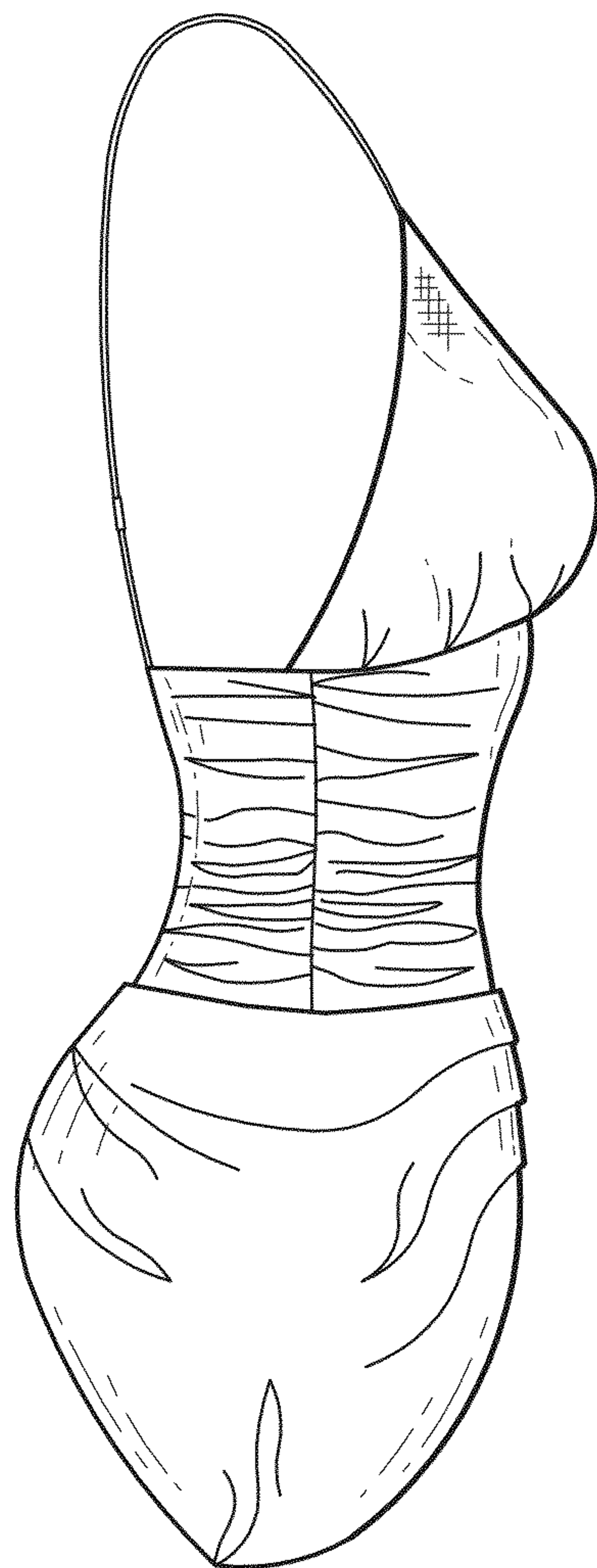

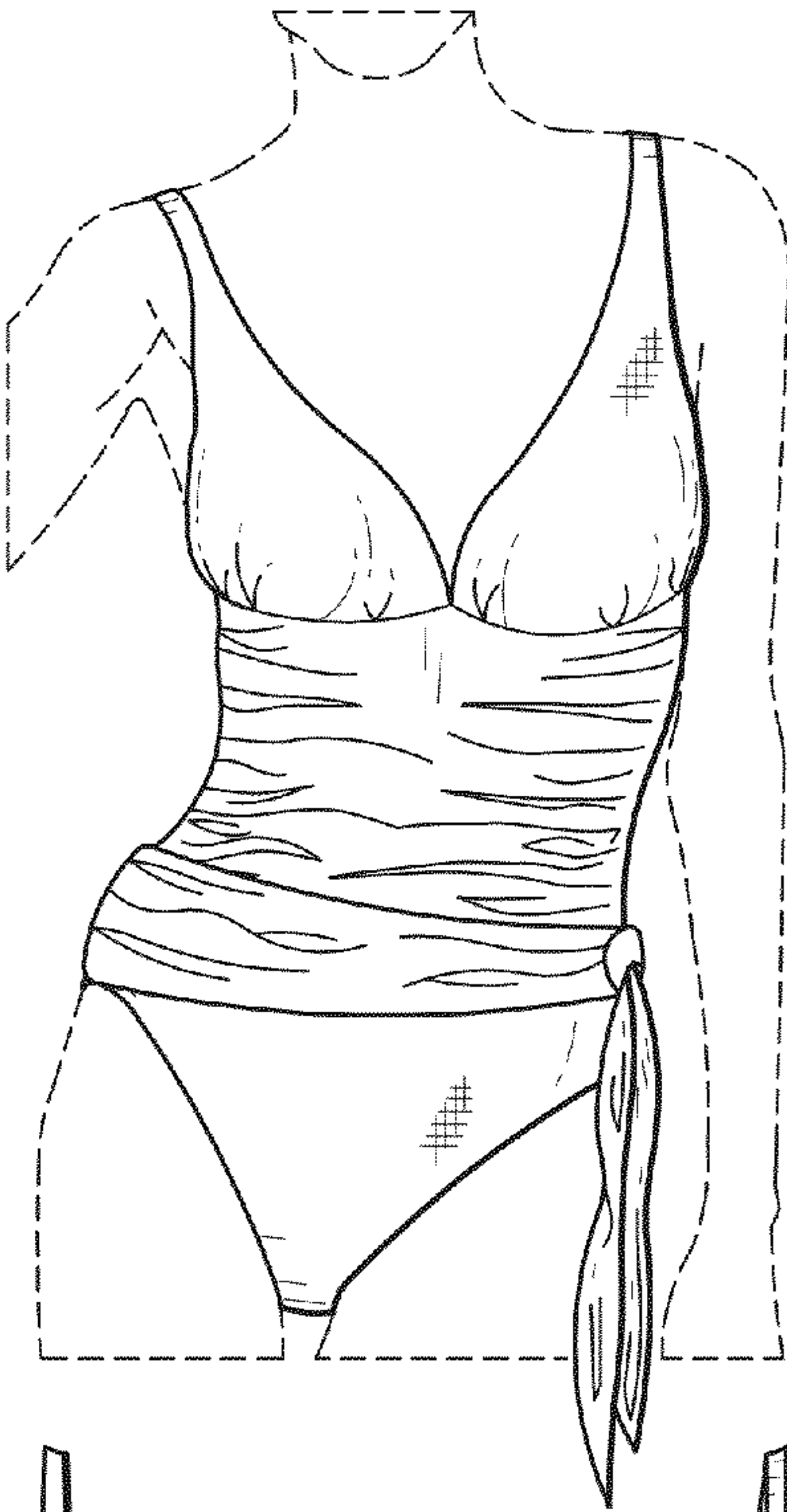

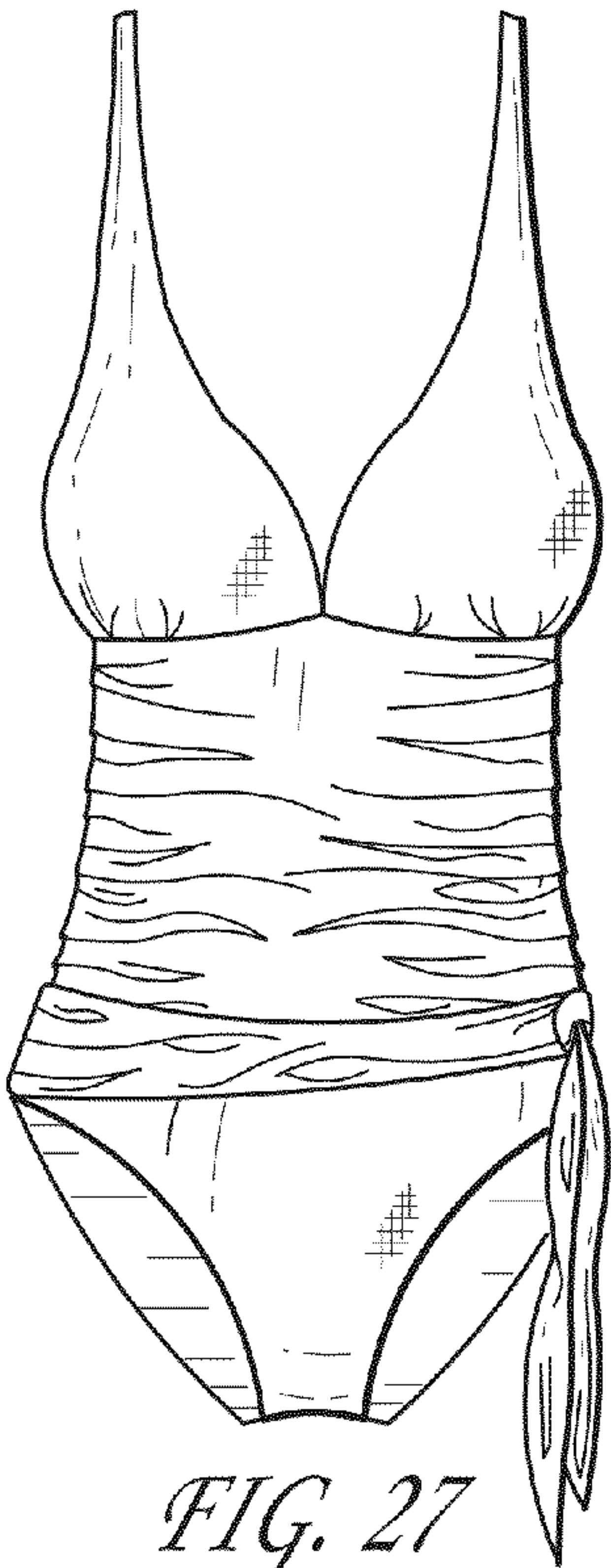

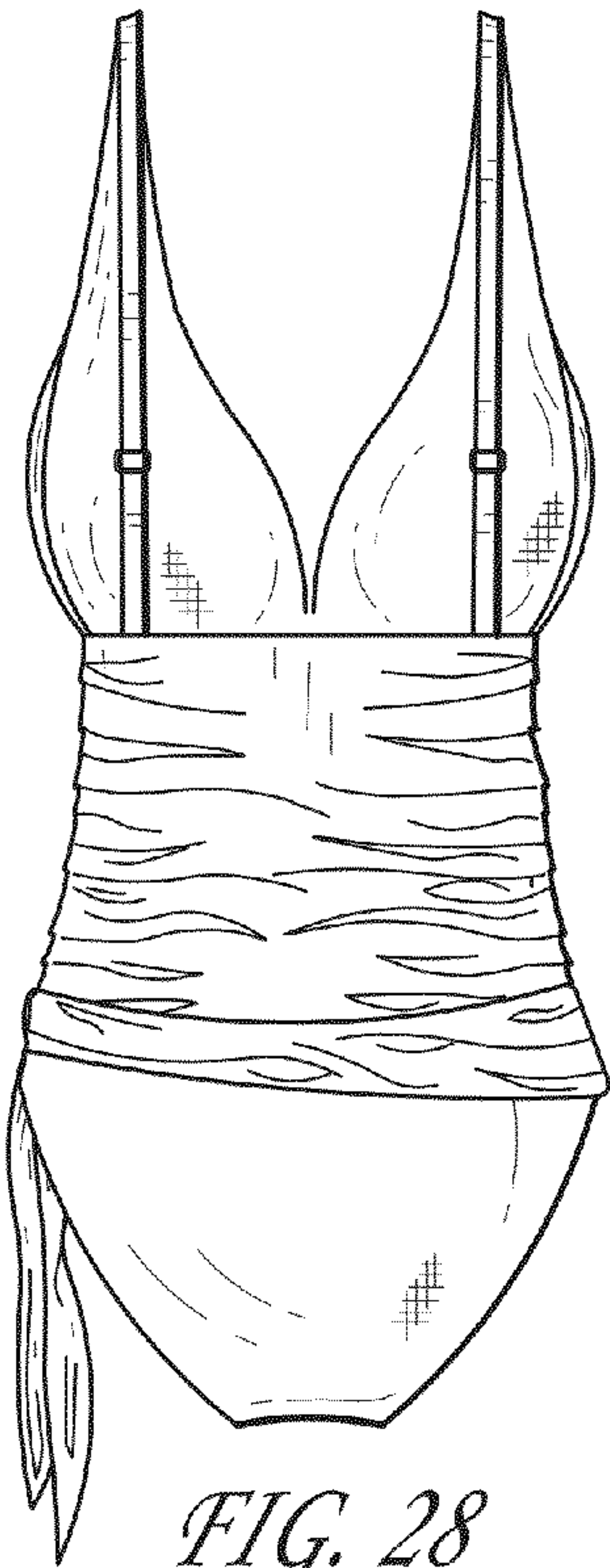

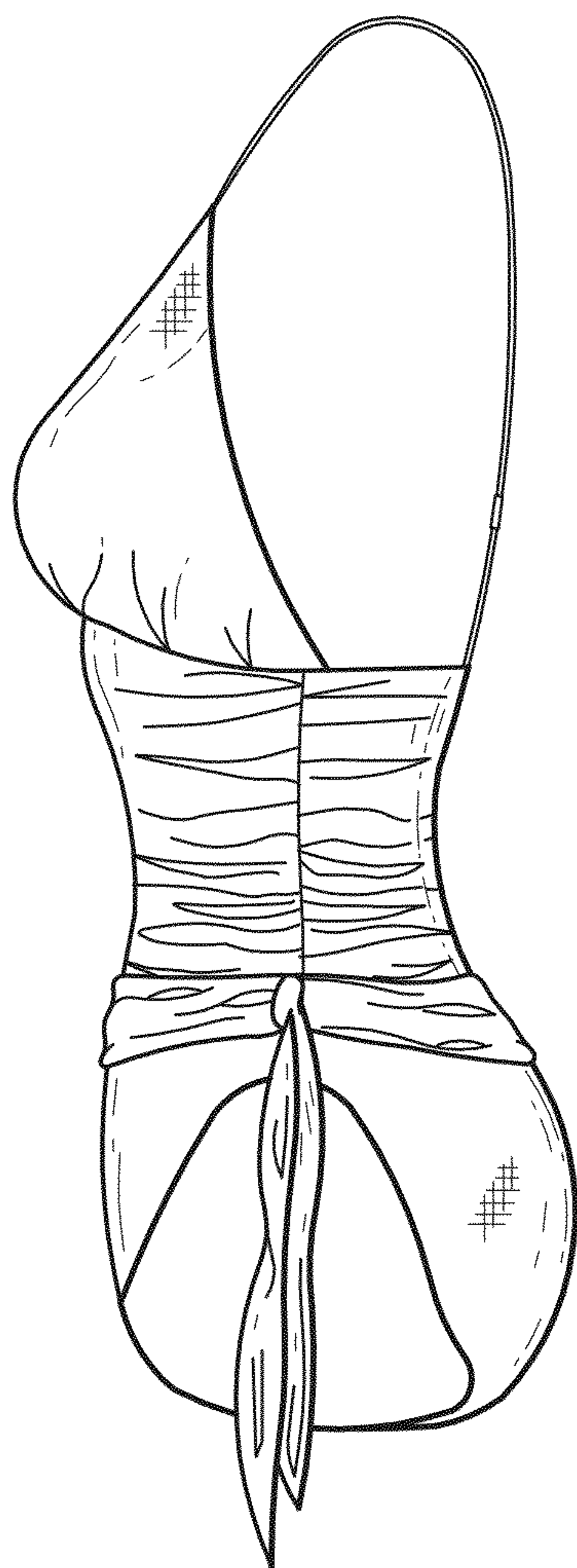

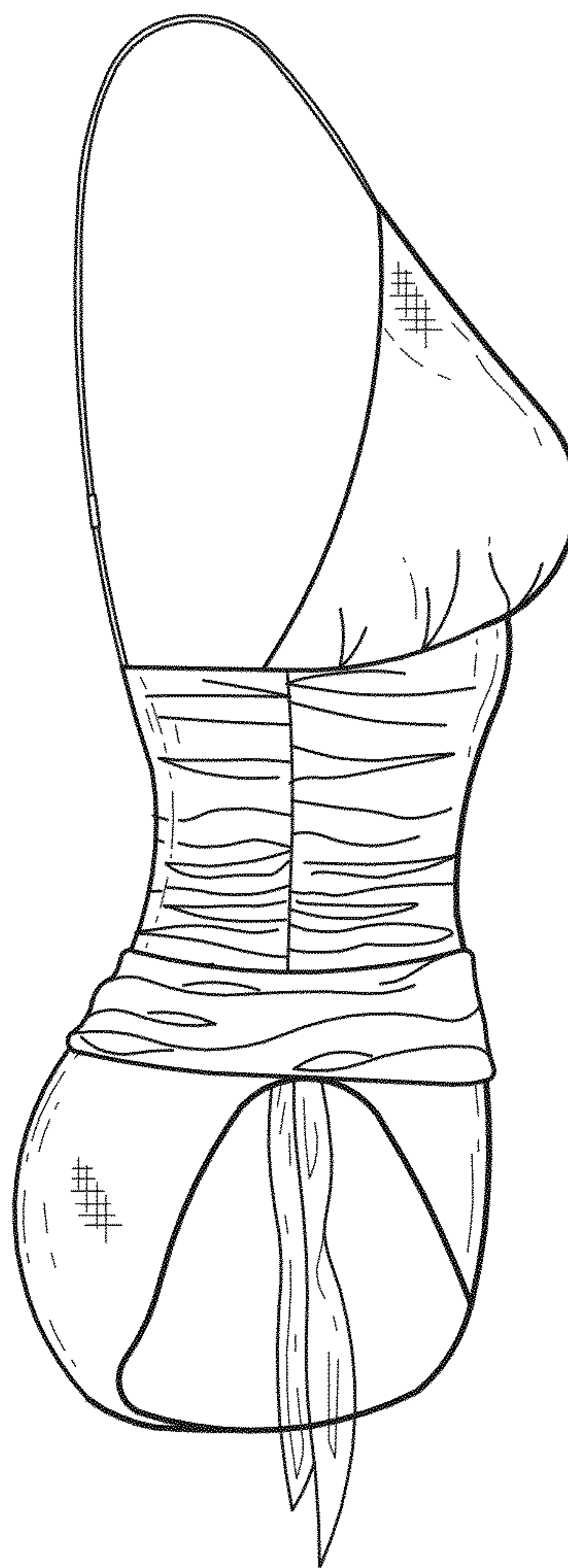
