(57) **CLAIM**

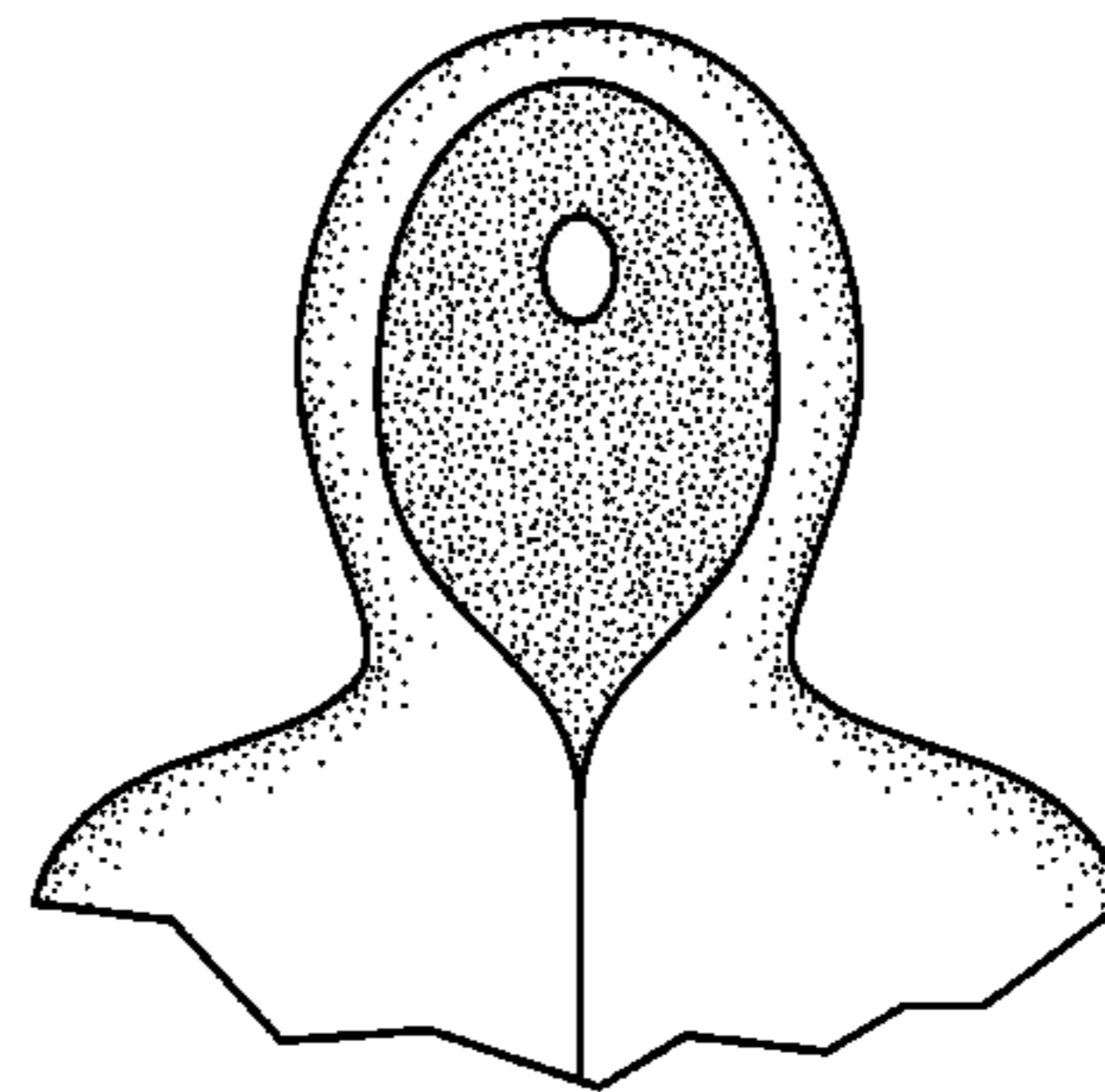
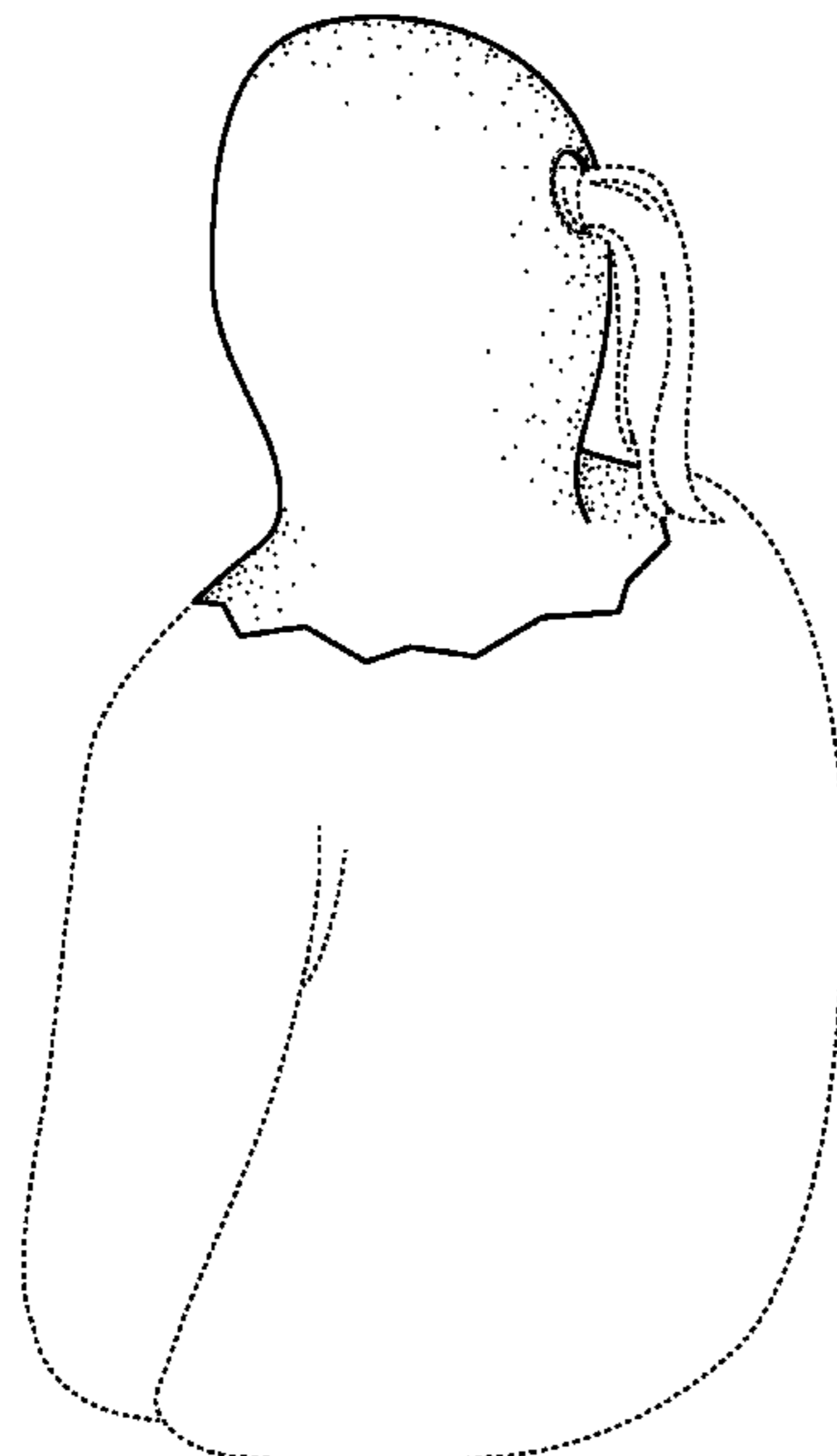
The ornamental design for a hooded sweatshirt with opening for hair, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view of the hooded sweatshirt with opening for hair showing my new design thereof;  
FIG. 2 is a partial front elevational view thereof;  
FIG. 3 is a partial rear elevational view thereof;  
FIG. 4 is a partial right side elevational view thereof;  
FIG. 5 is a partial left side elevational view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.

The broken lines around the perimeter of the ponytail hole in FIGS. 1, 3, and 6 of the hooded sweatshirt with opening for hair, represent stitching and are part of the claimed design. The broken lines showing hair and lower portion of a sweatshirt in FIG. 1 of the hooded sweatshirt with opening for hair are for the purpose of illustrating environment, and form no part of the claimed design.

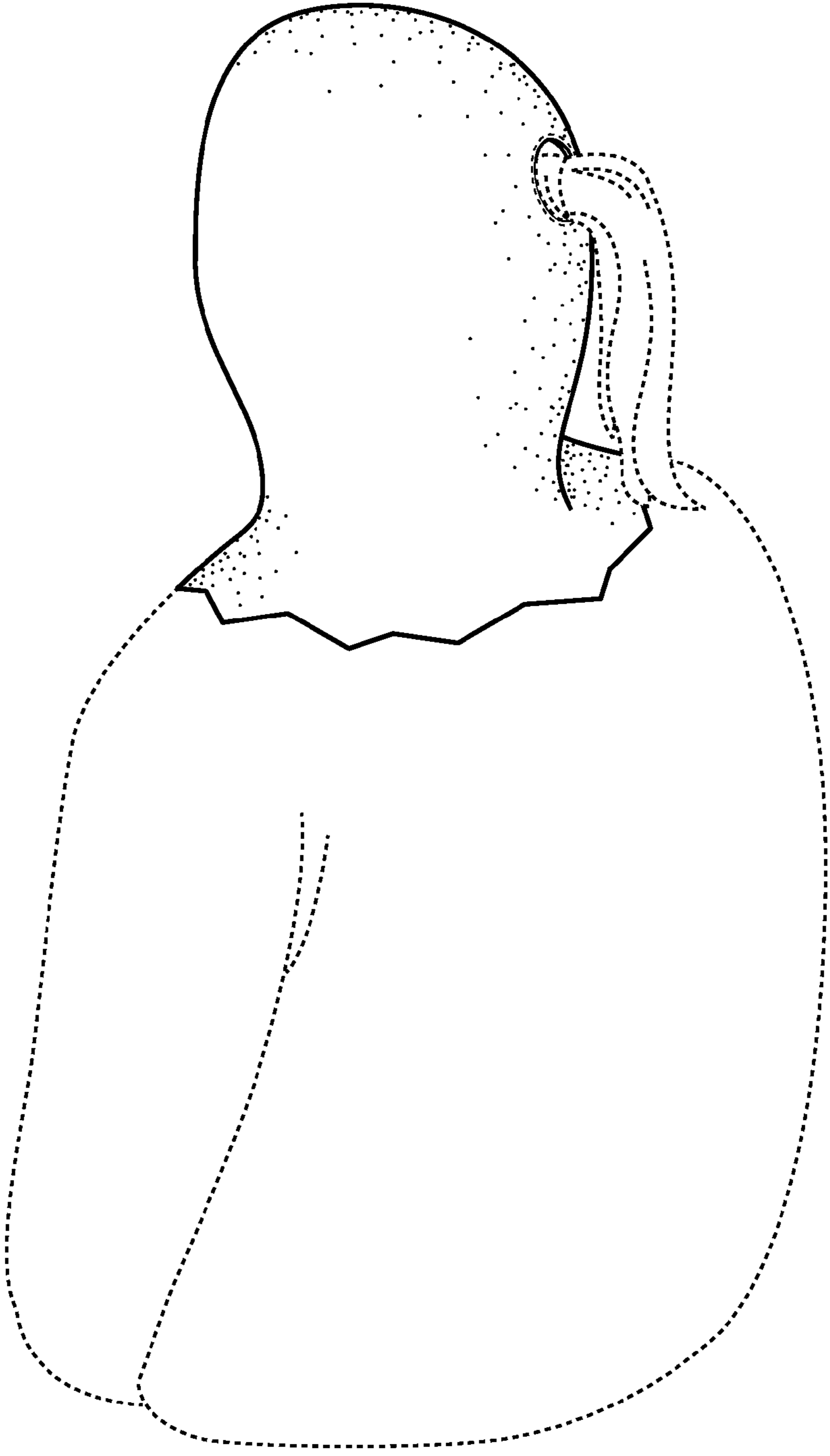

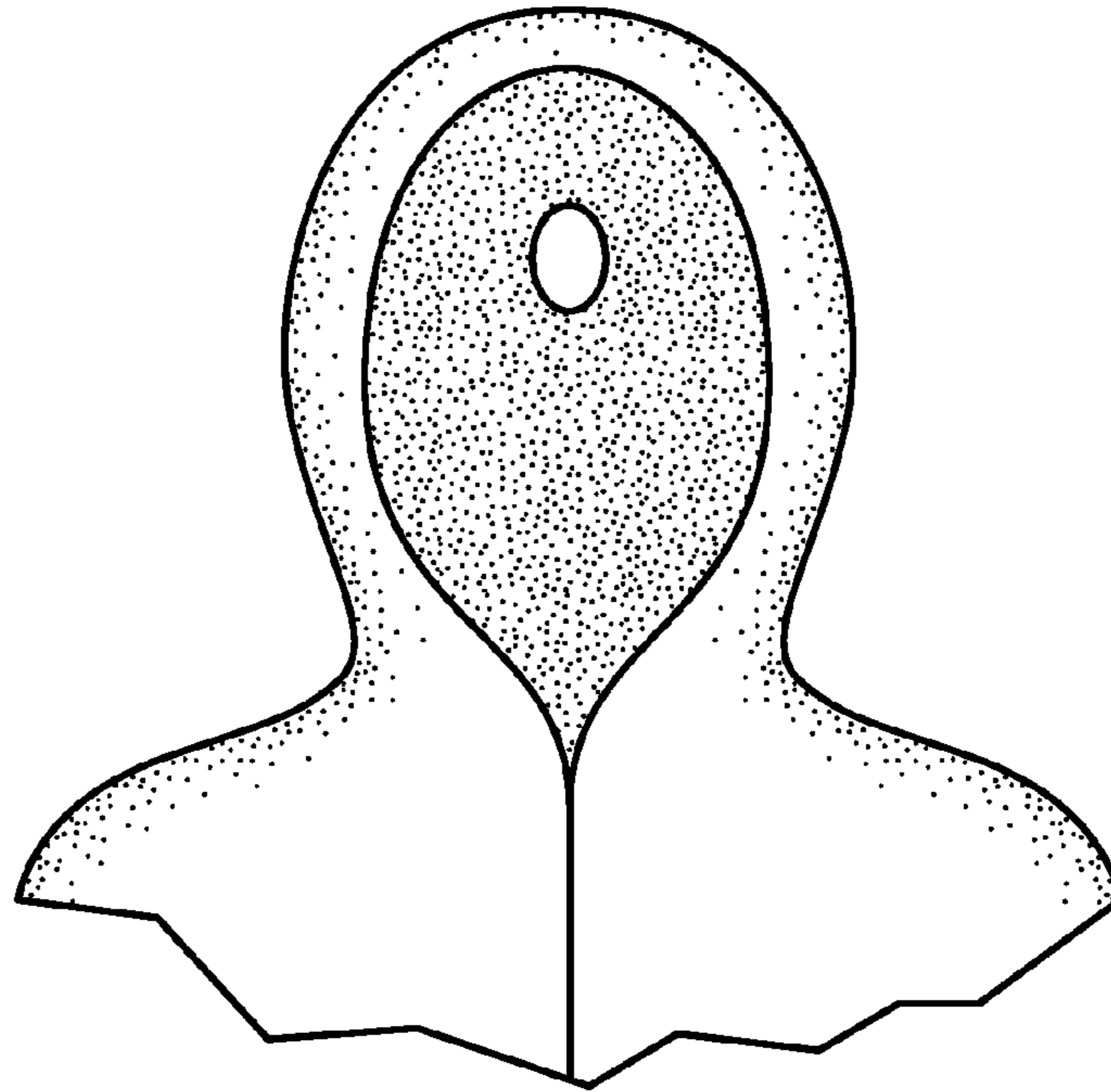

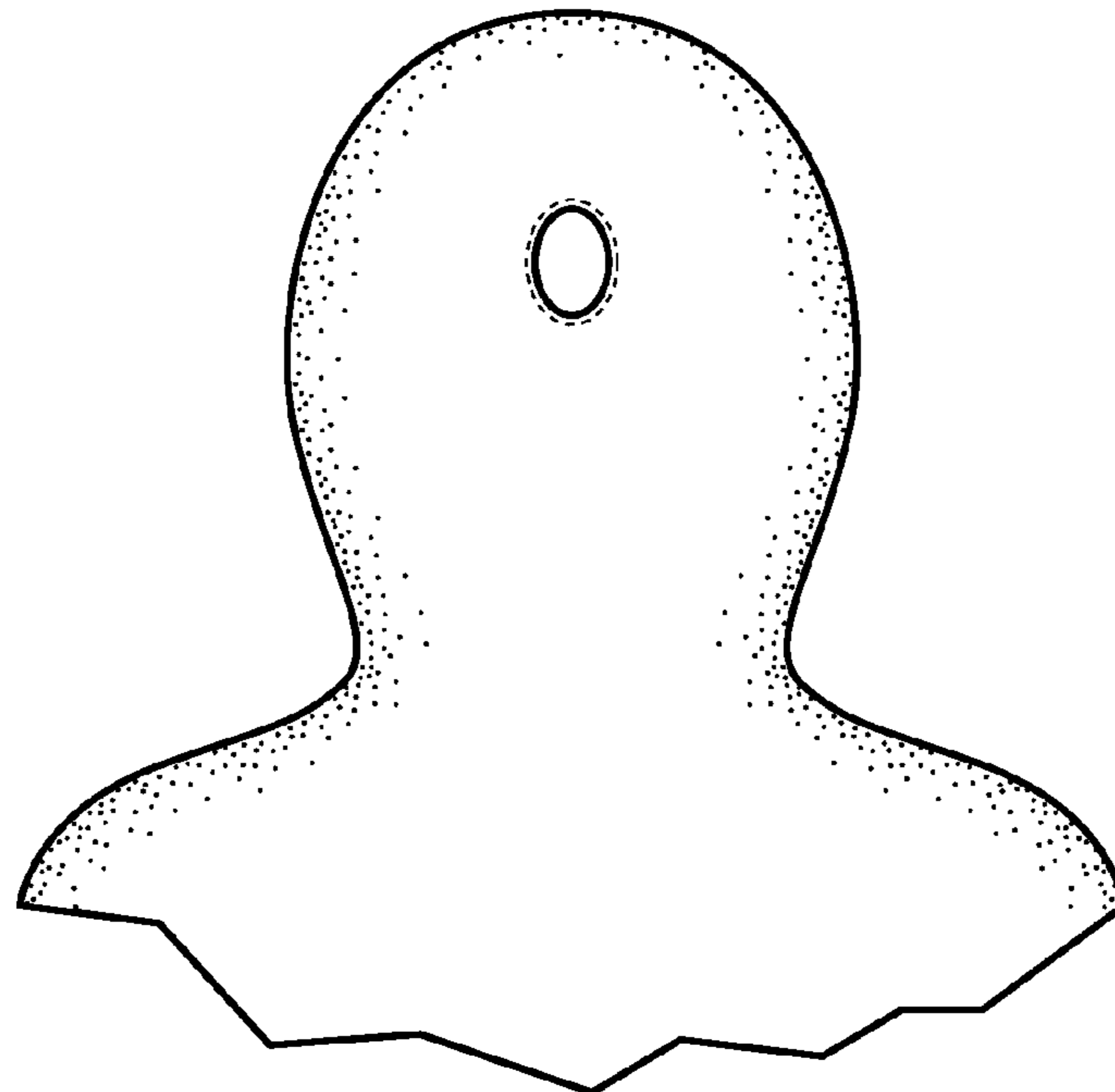

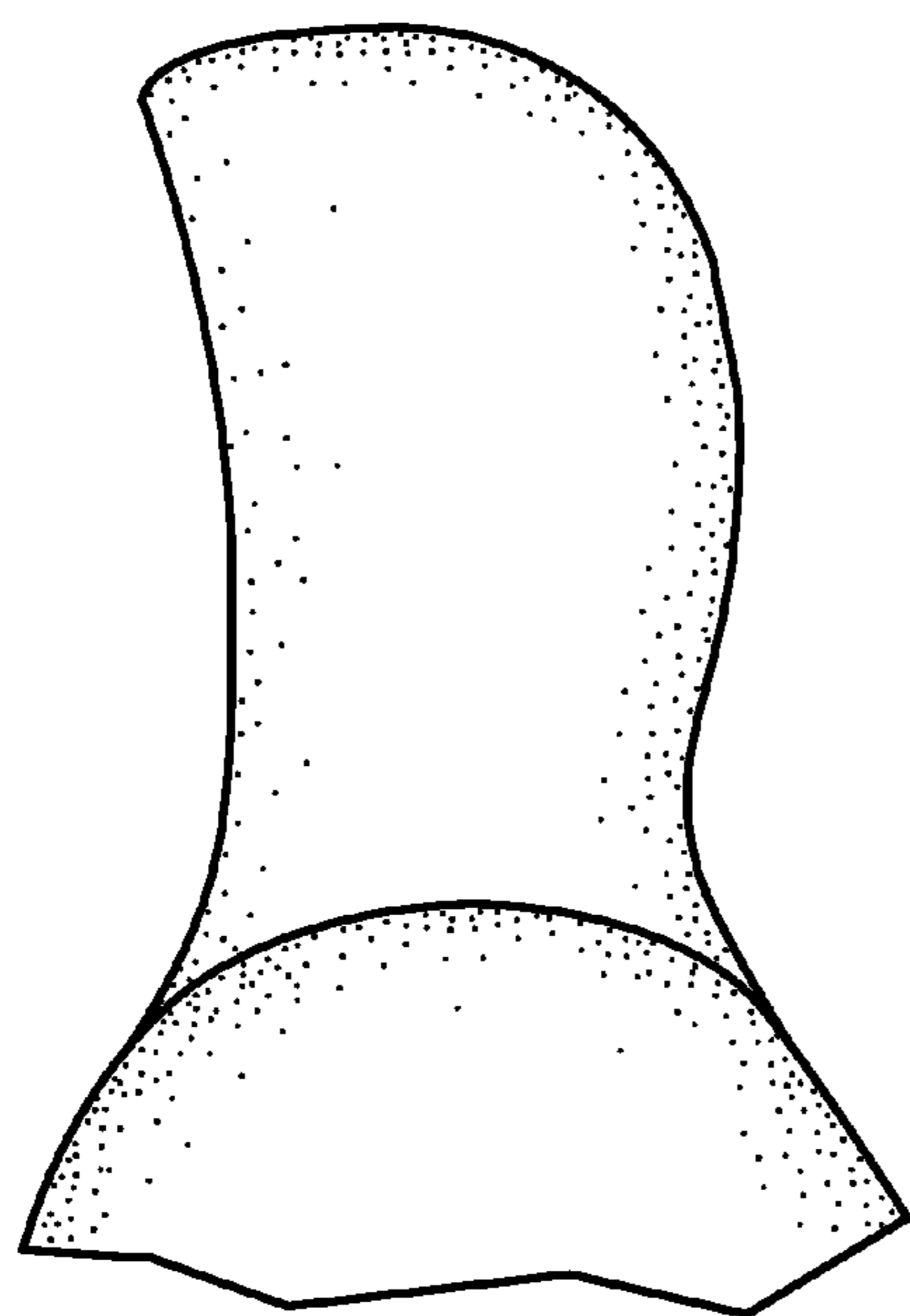

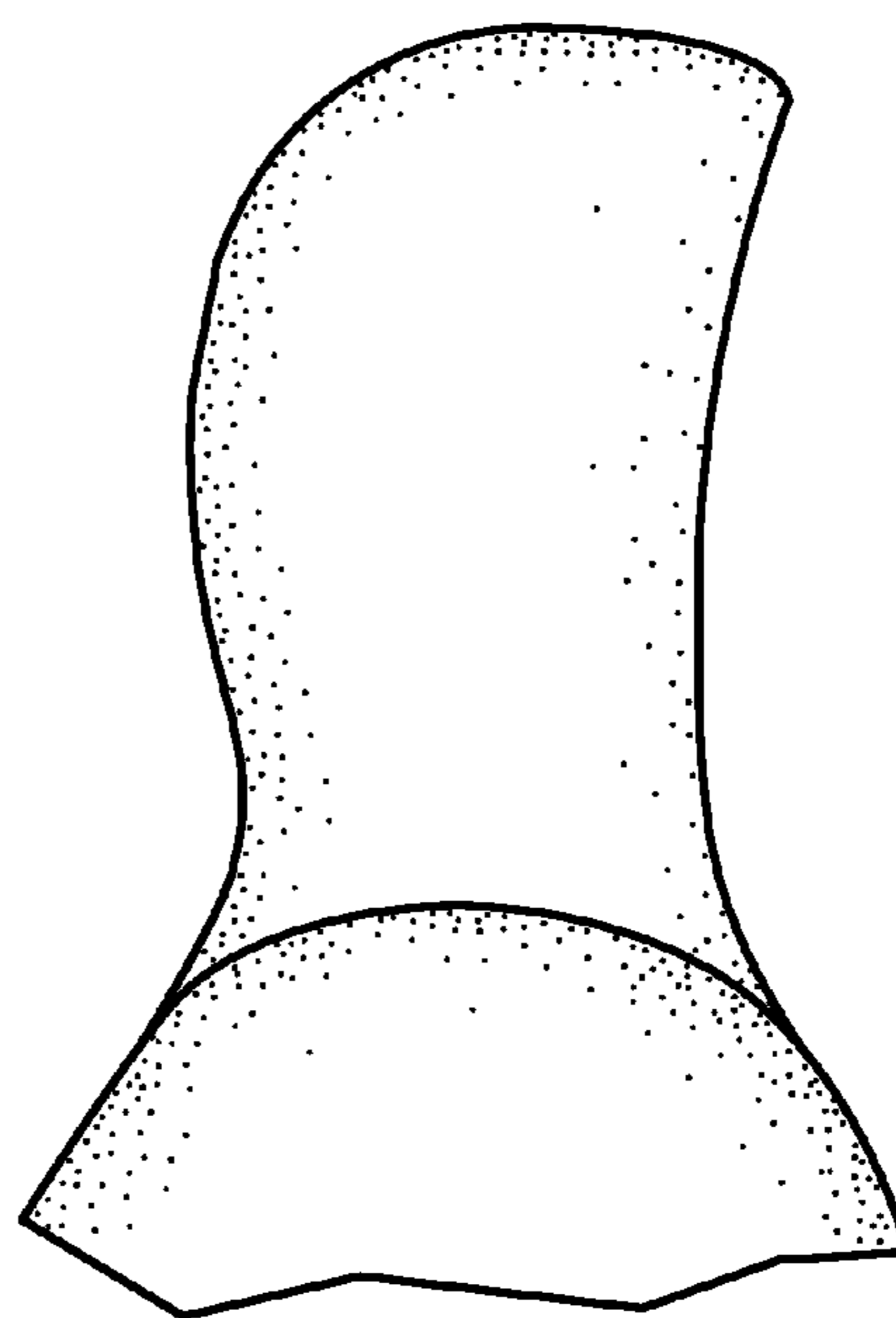

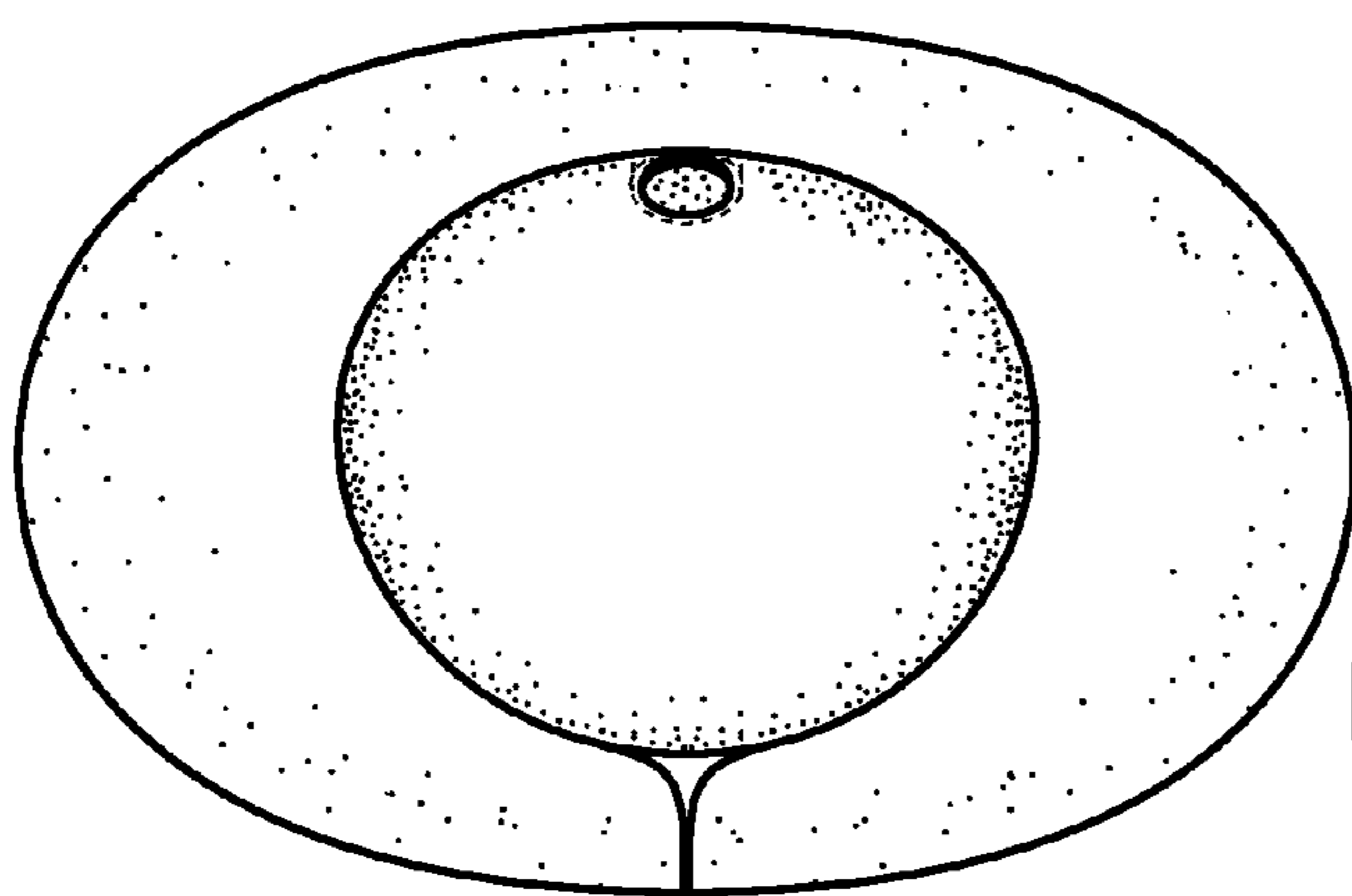

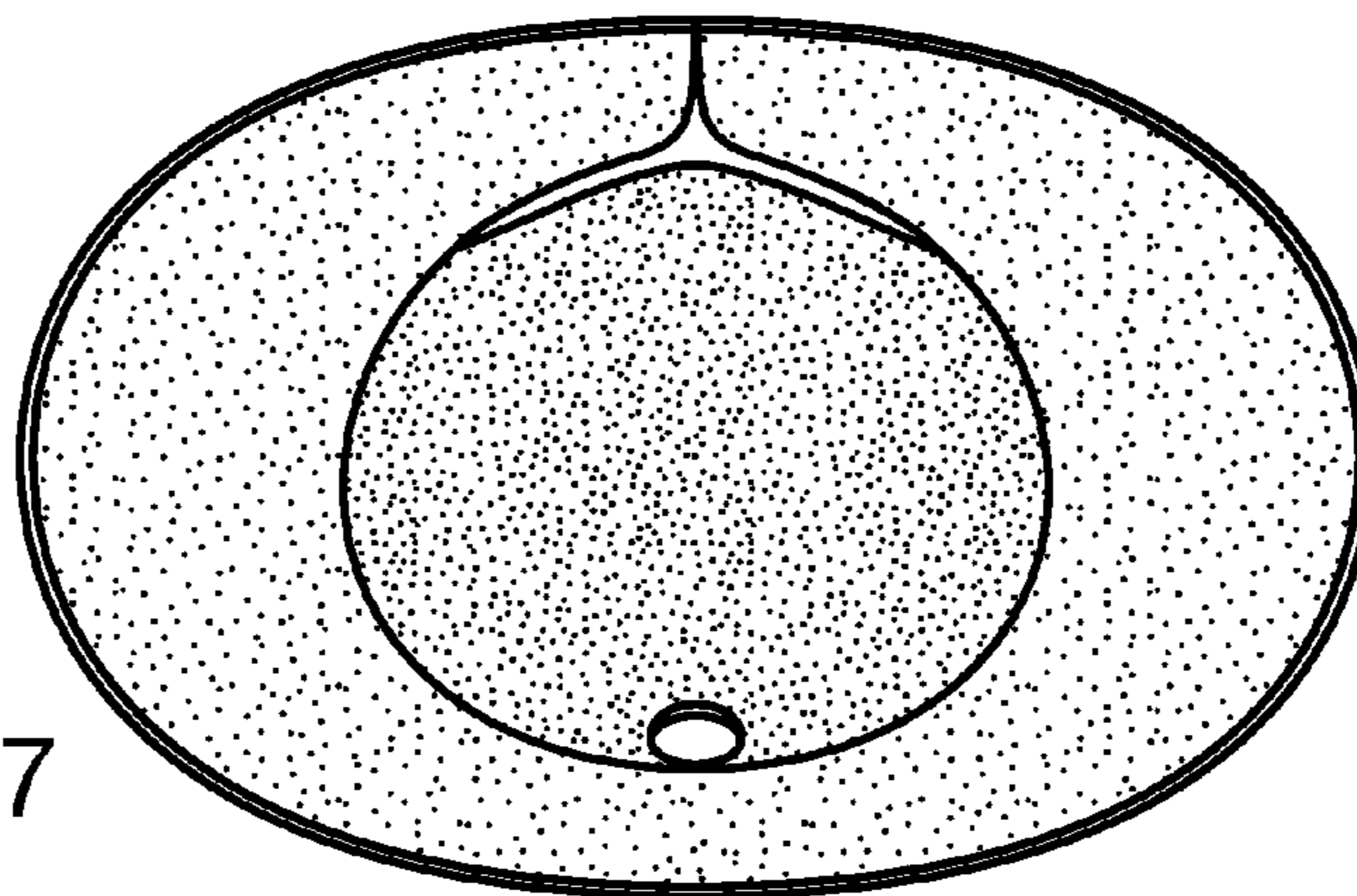
