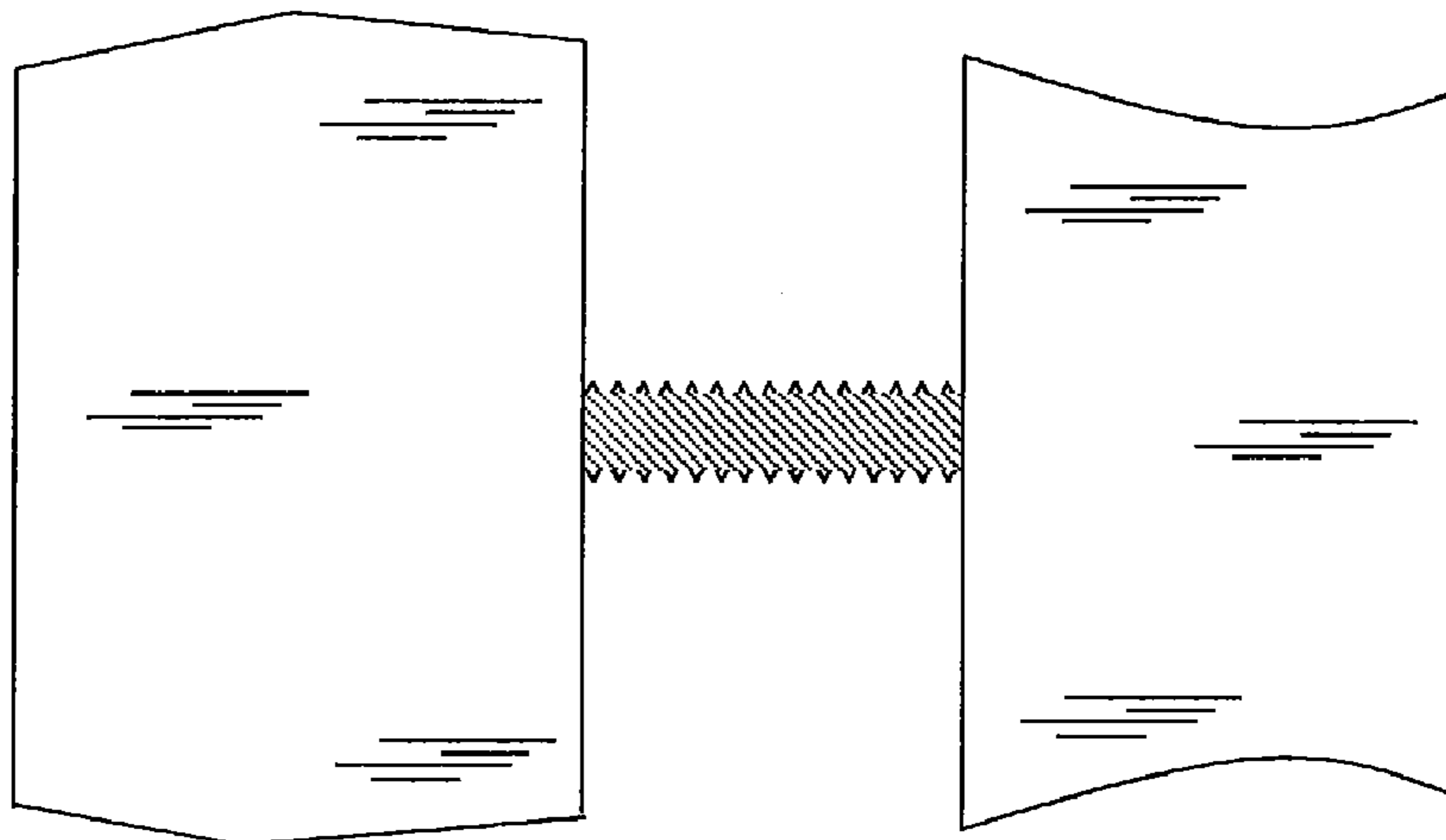
(57) **CLAIM**

The ornamental design for balance training footwear, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view showing the new design; FIG. 2 is a bottom plan view thereof; FIG. 3 is a left side elevational view thereof, and noting that the right side elevational view is a mirror of the left side; FIG. 4 is another left side elevational view thereof showing the balance training footwear following a positional adjustment for a different size; FIG. 5 is a front elevational view thereof; FIG. 6 is a rear elevational view thereof; and, FIG. 7 is a side elevational view showing the balancing training footwear in a position when being worn. The broken lines shown in the drawings illustrate portions of environmental structure and form no part of the claimed design.

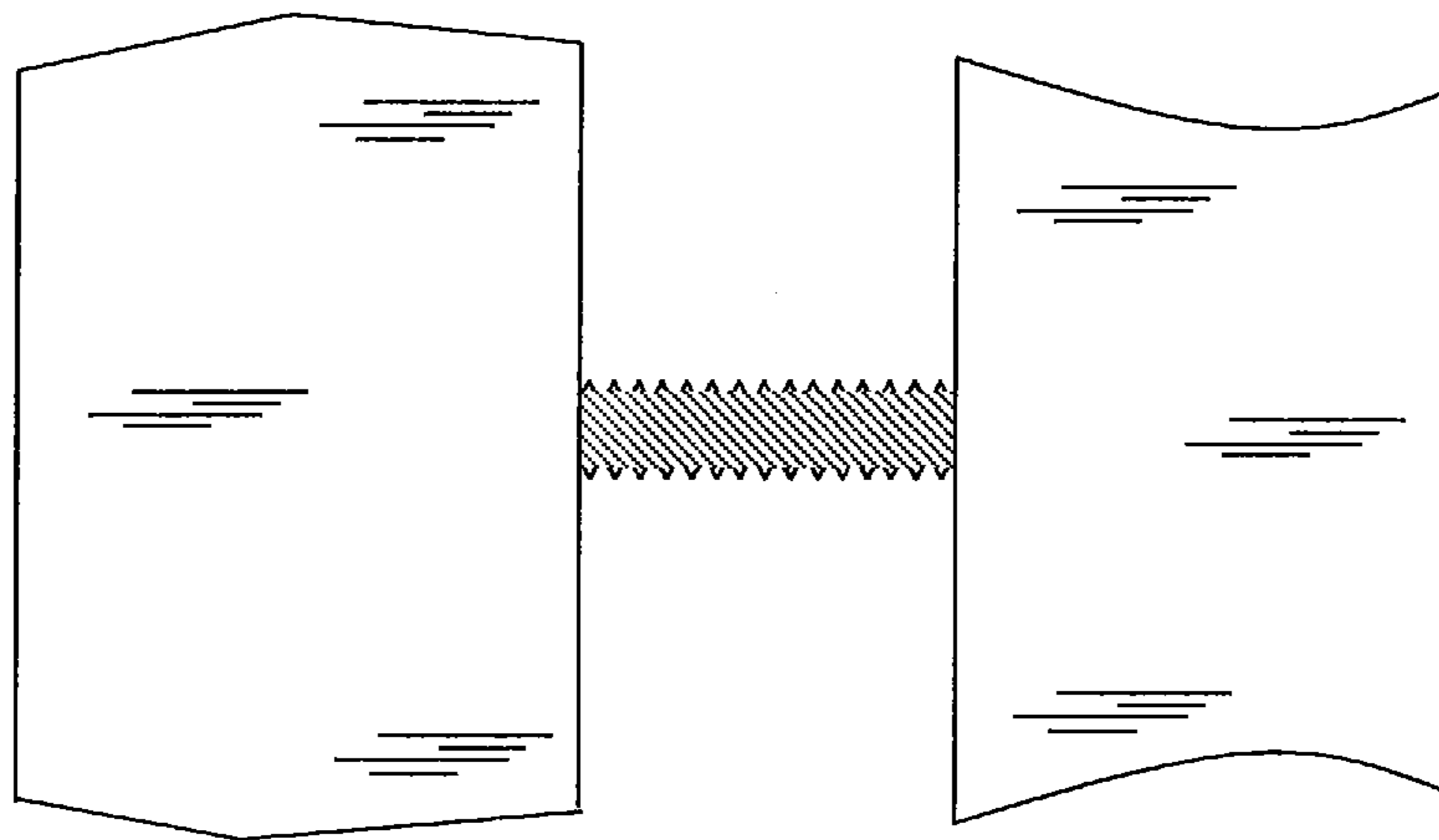

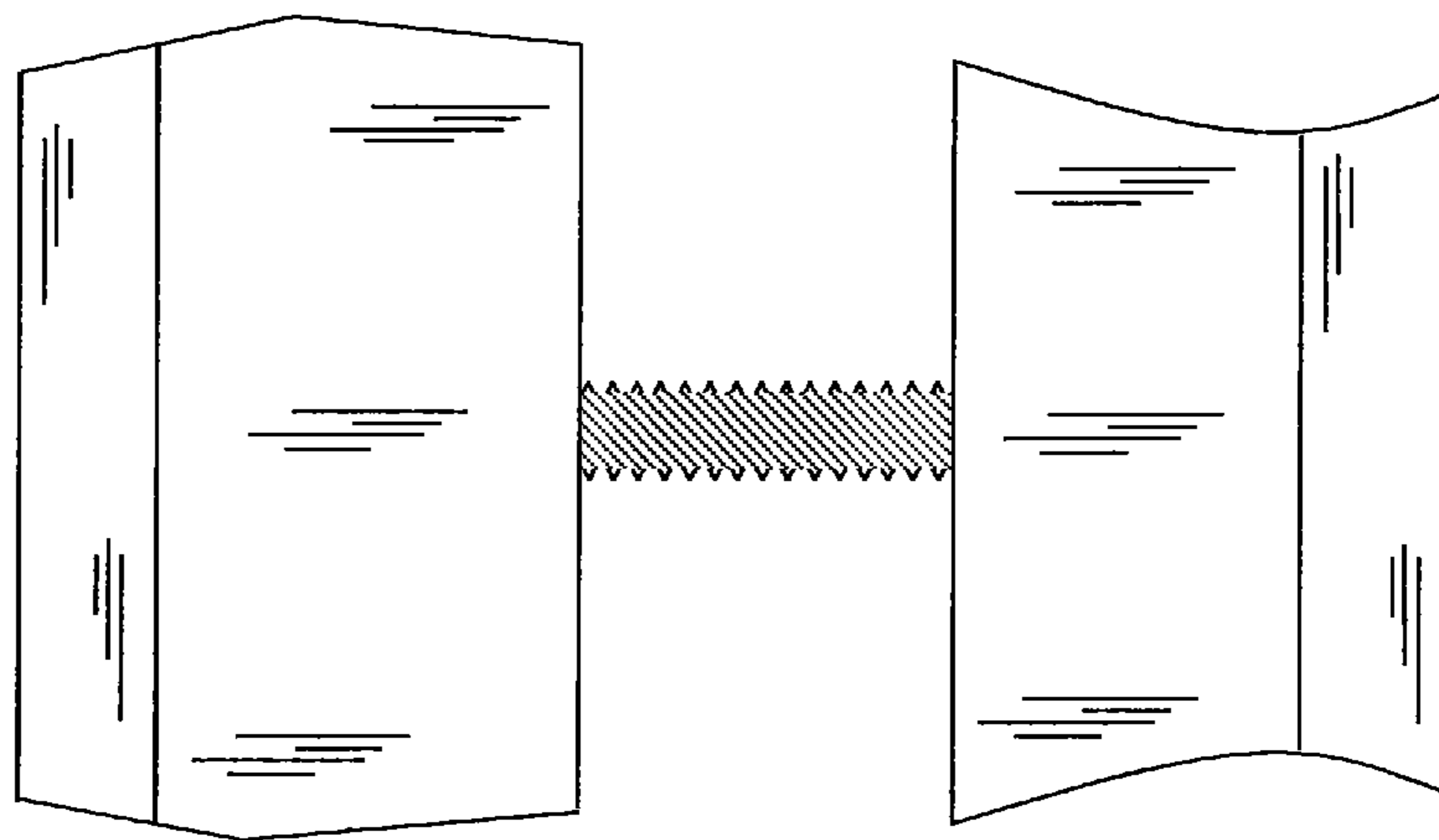

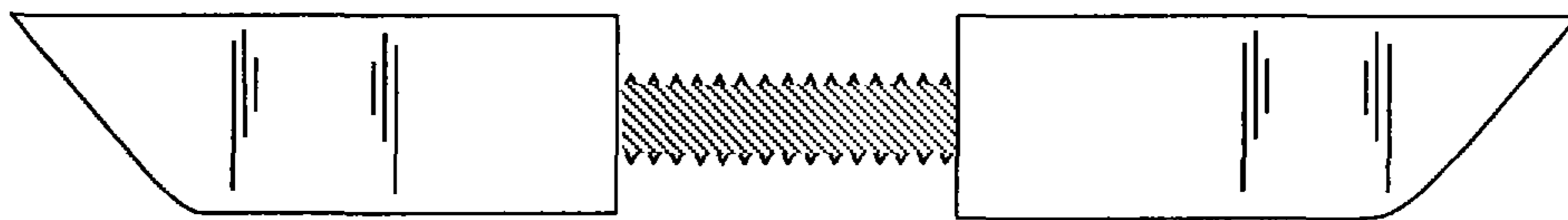

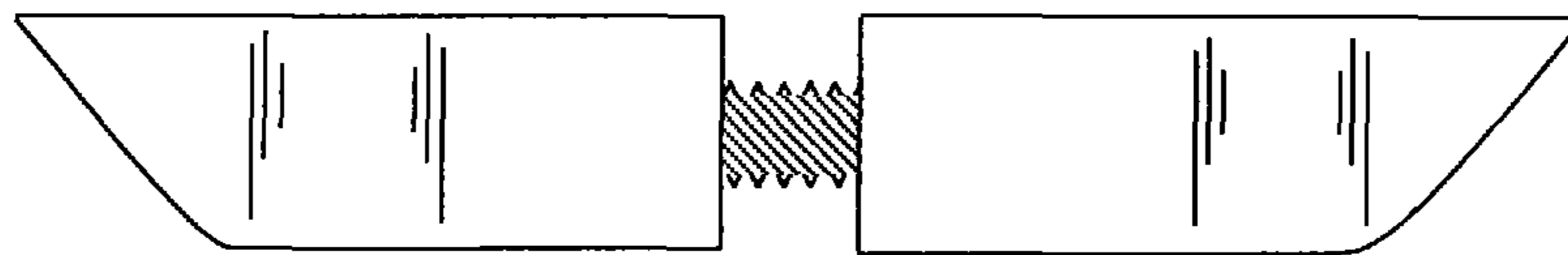

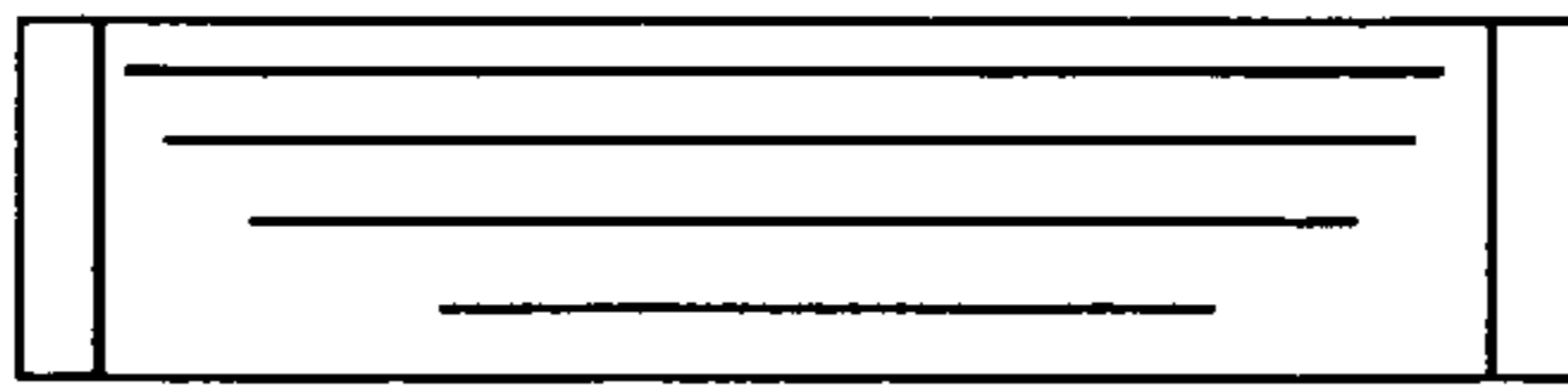

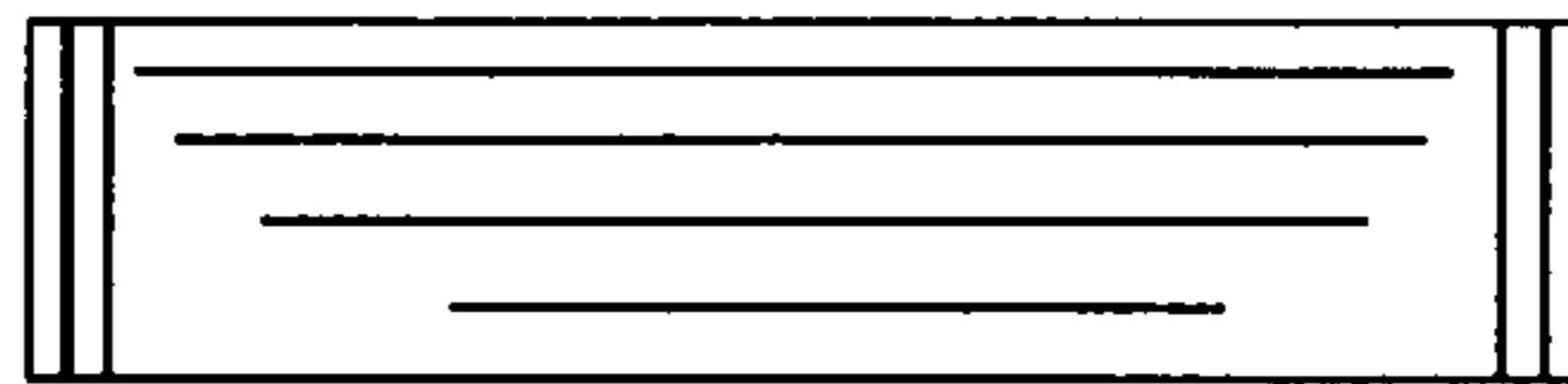

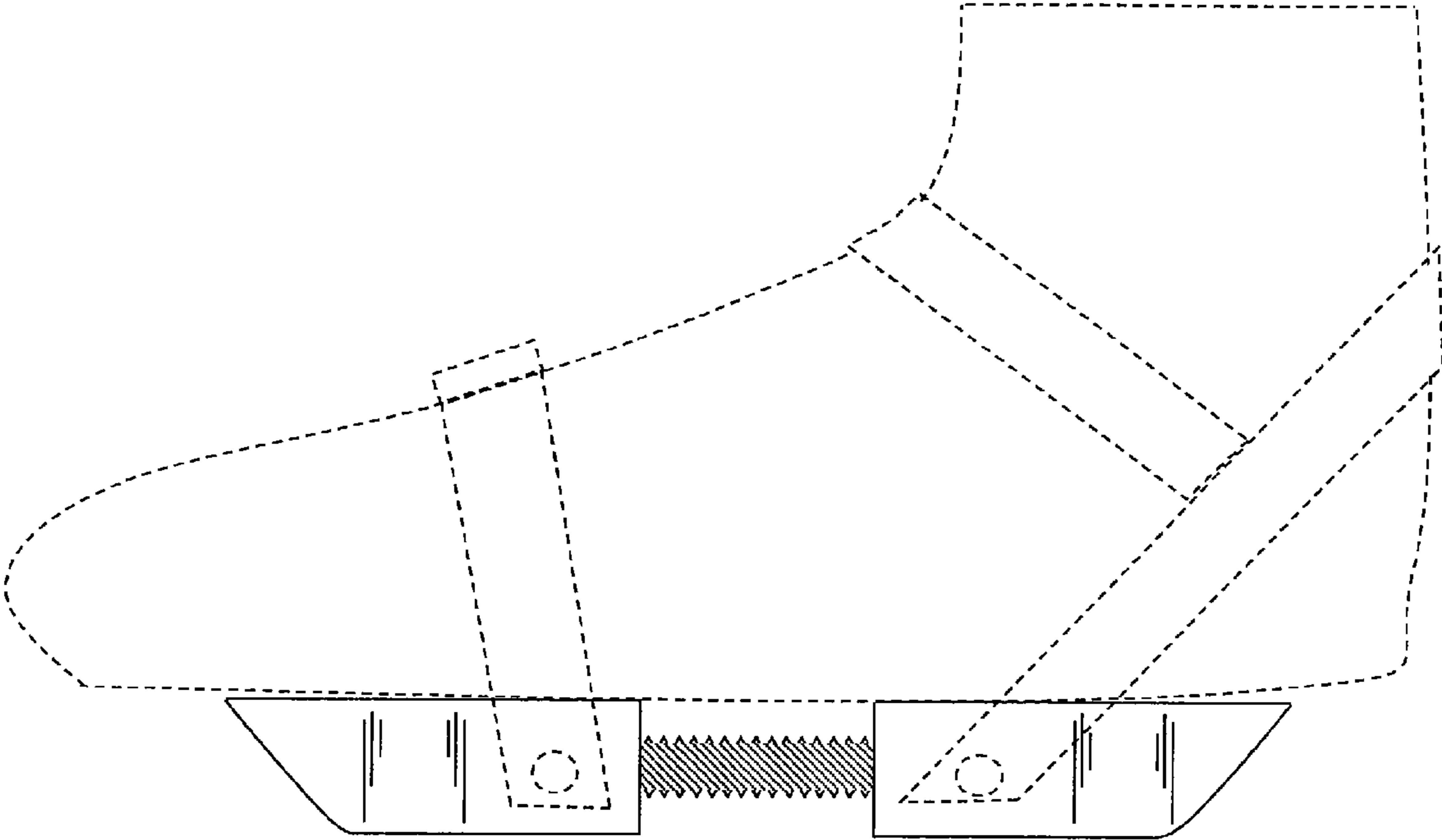
