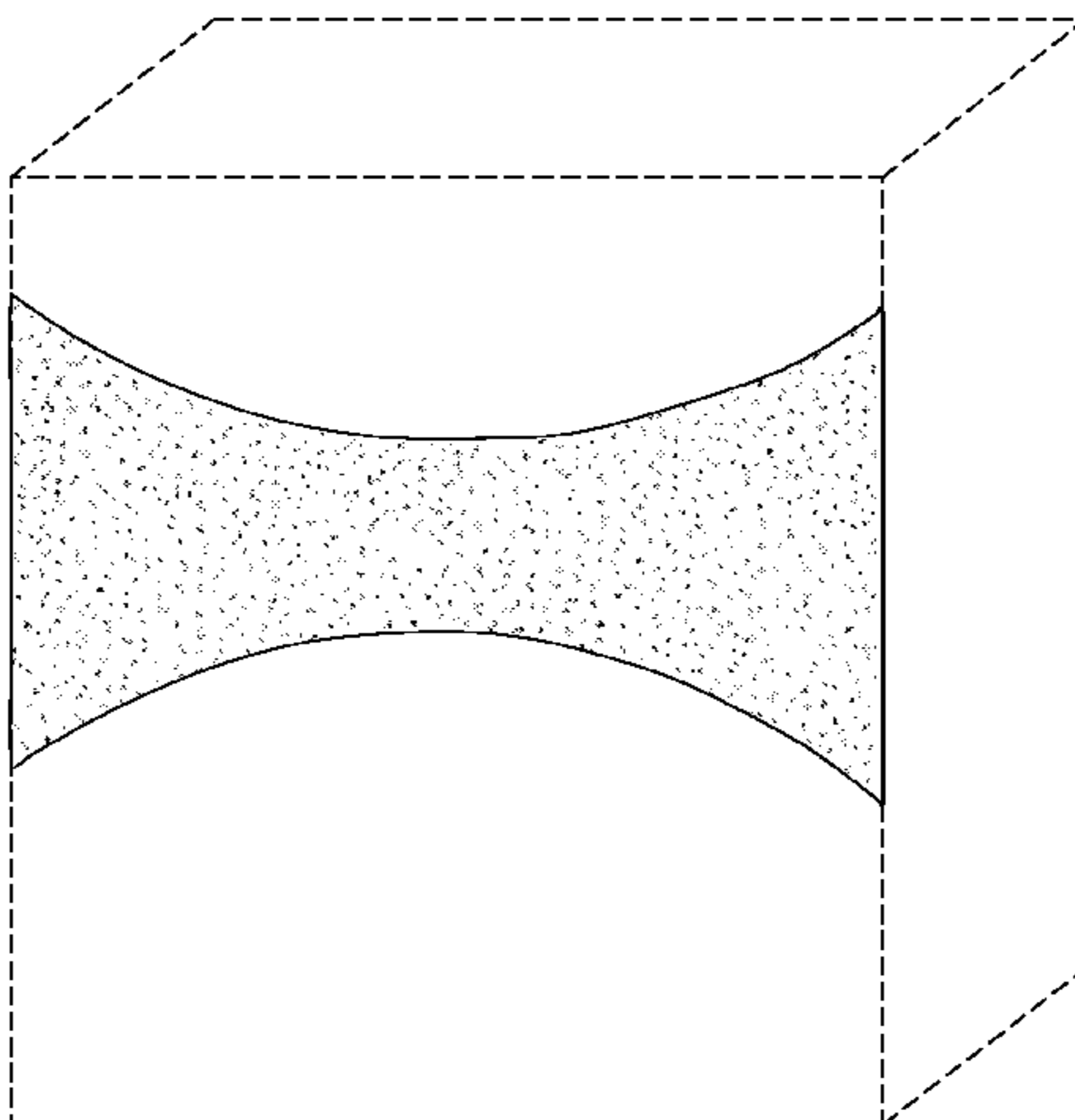
(57) **CLAIM**

The ornamental design for feminine hygiene product package with surface graphics, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a feminine hygiene product package with surface graphics showing our new design; FIG. 2 is a front view of the feminine hygiene product package with surface graphics as shown in FIG. 1; FIG. 3 is a left side view of the feminine hygiene product package with surface graphics as shown in FIG. 1; FIG. 4 is a right side view of the feminine hygiene product package with surface graphics as shown in FIG. 1; FIG. 5 is a top view of the feminine hygiene product package with surface graphics as shown in FIG. 1; FIG. 6 is a bottom view of the feminine hygiene product package with surface graphics as shown in FIG. 1; and, FIG. 7 is a back view of the feminine hygiene product package with surface graphics as shown in FIG. 1. The broken lines depict environmental subject matter only and form no part of the claimed design.

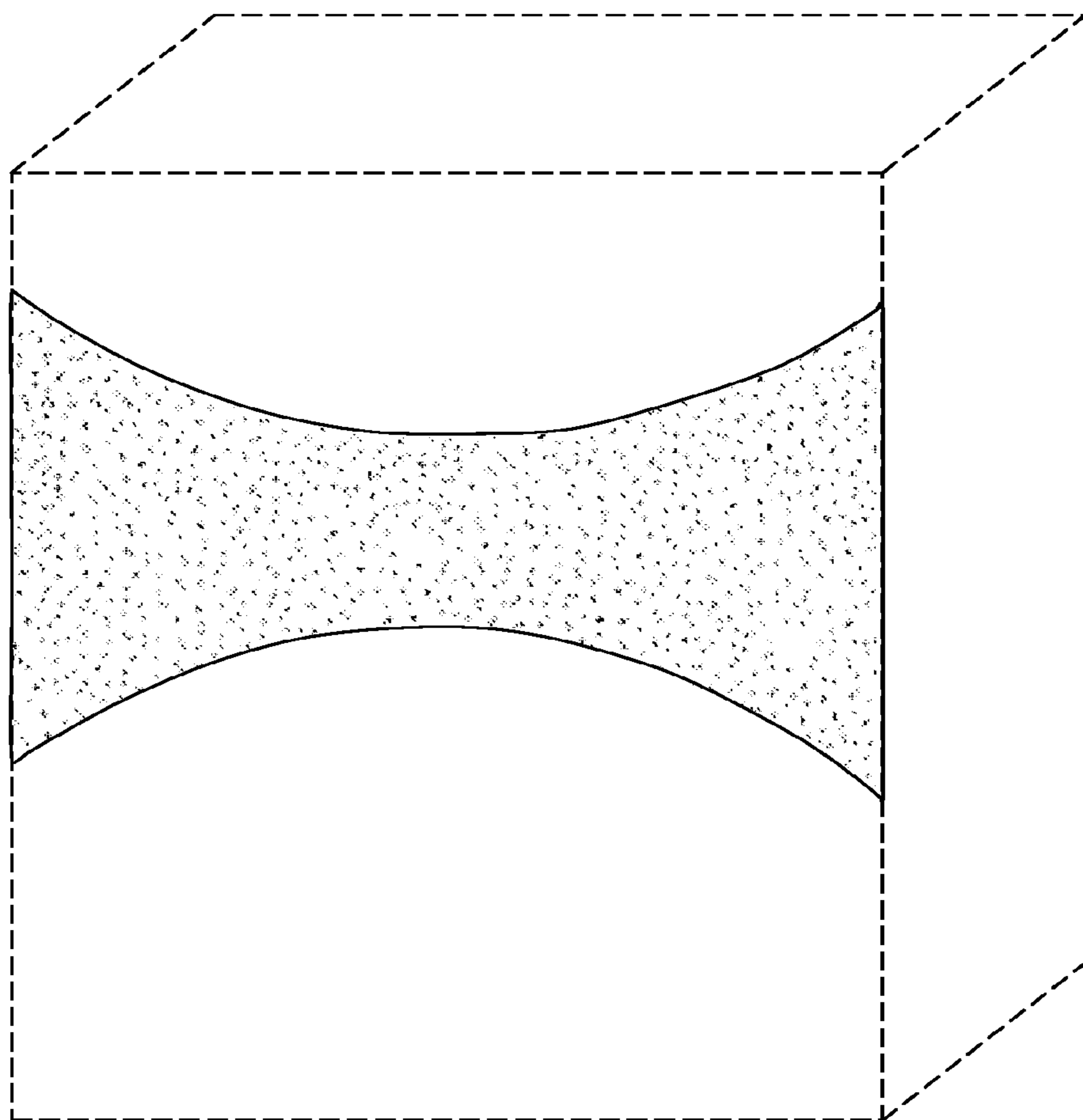

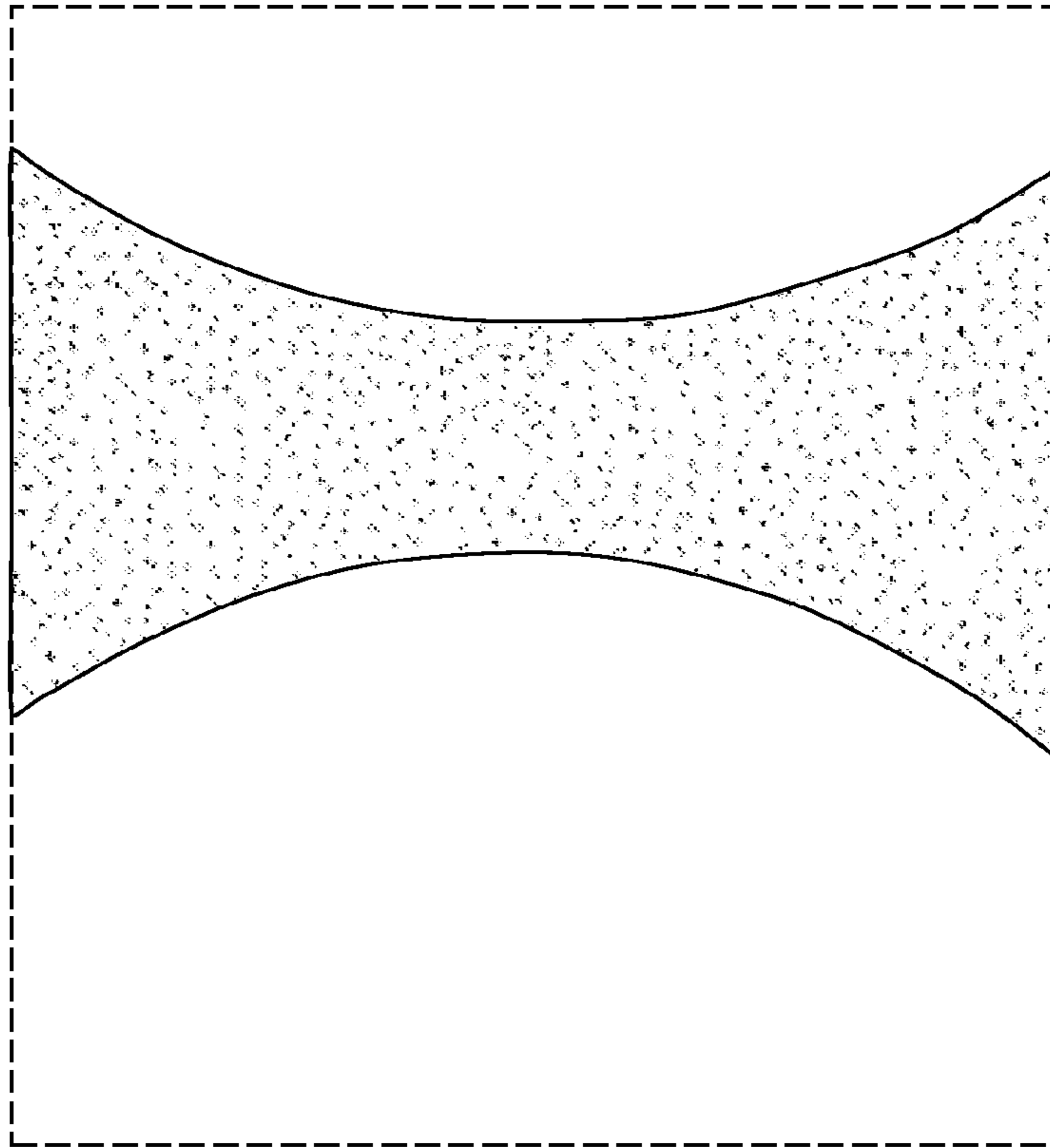

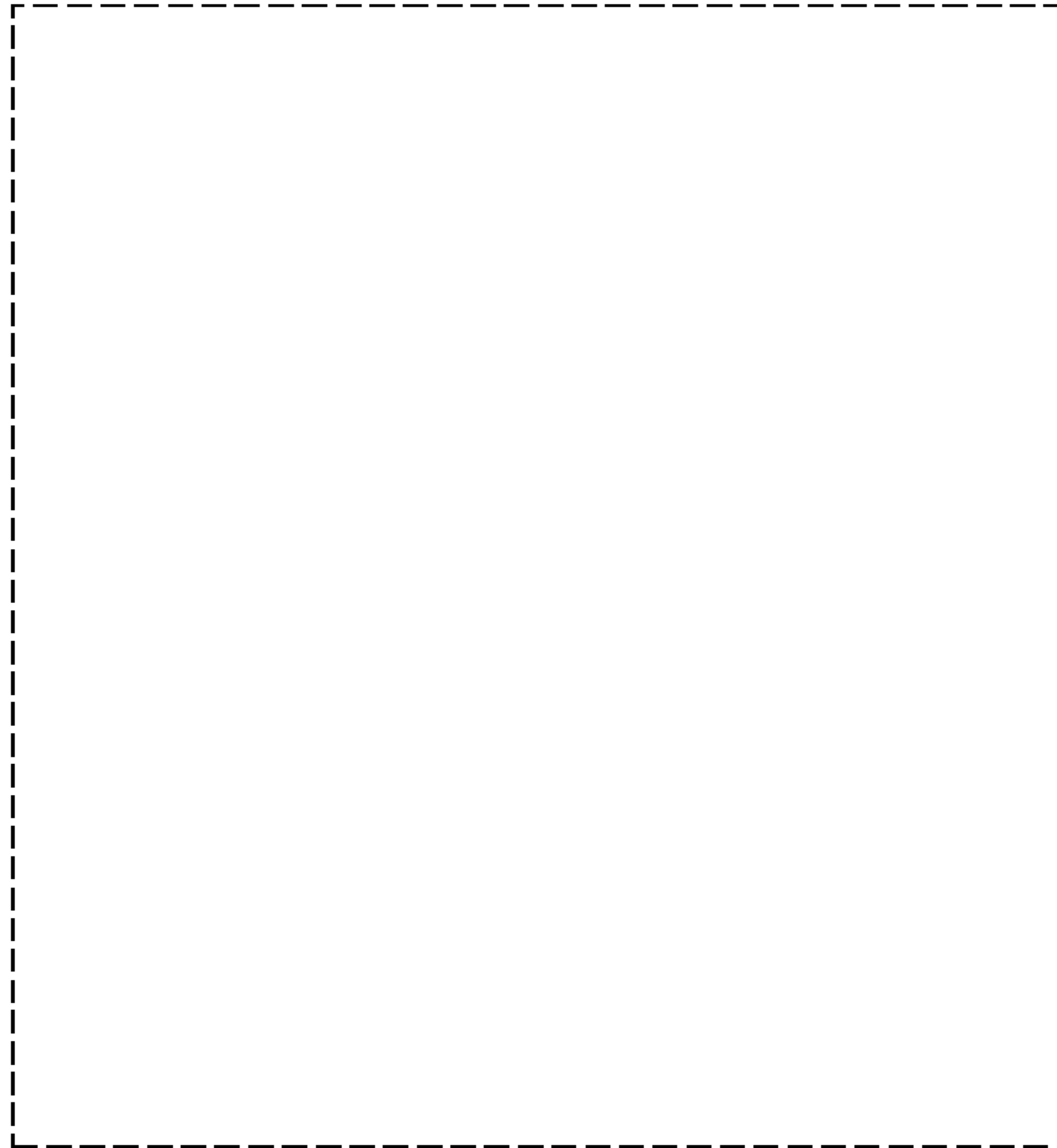

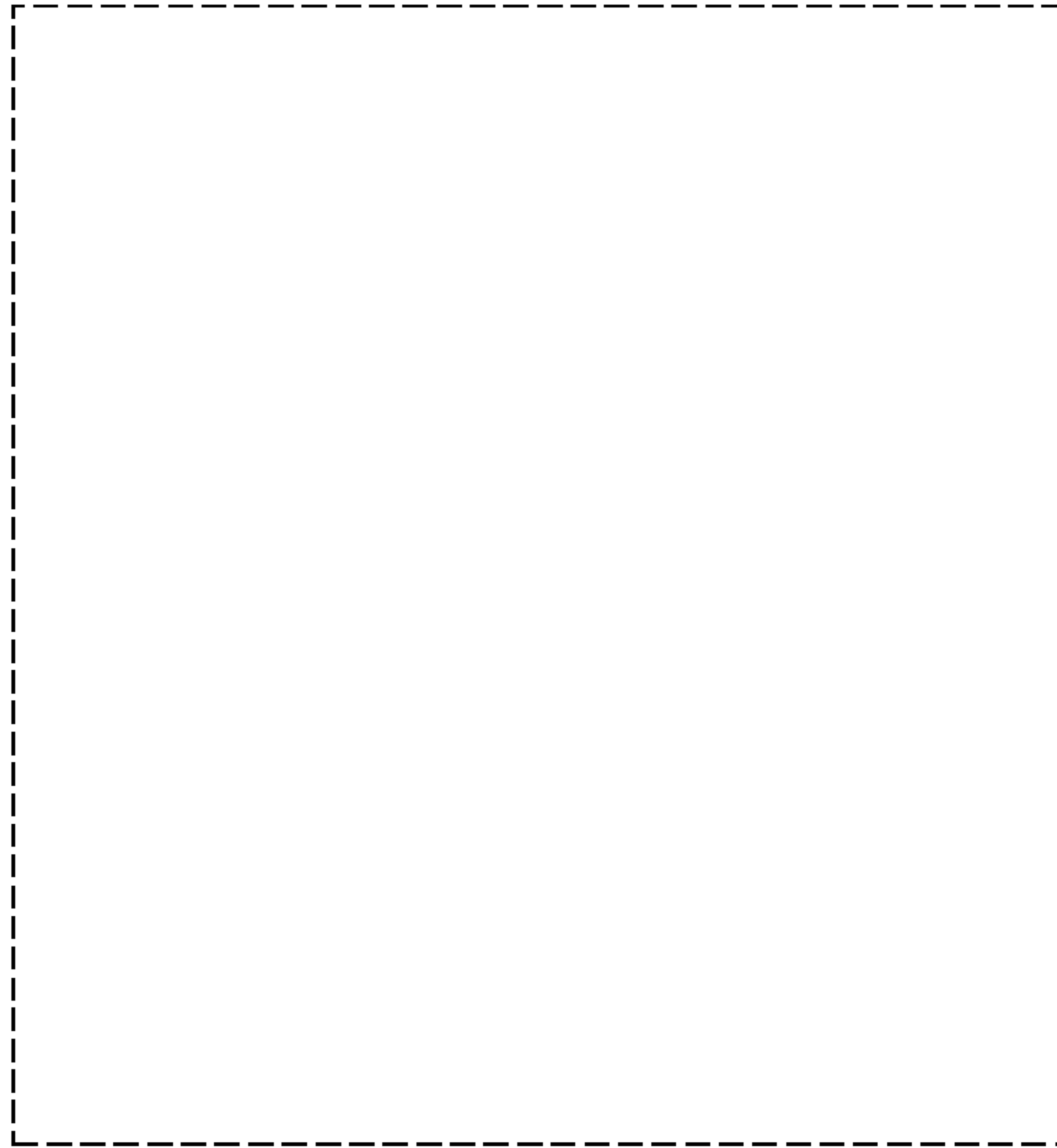

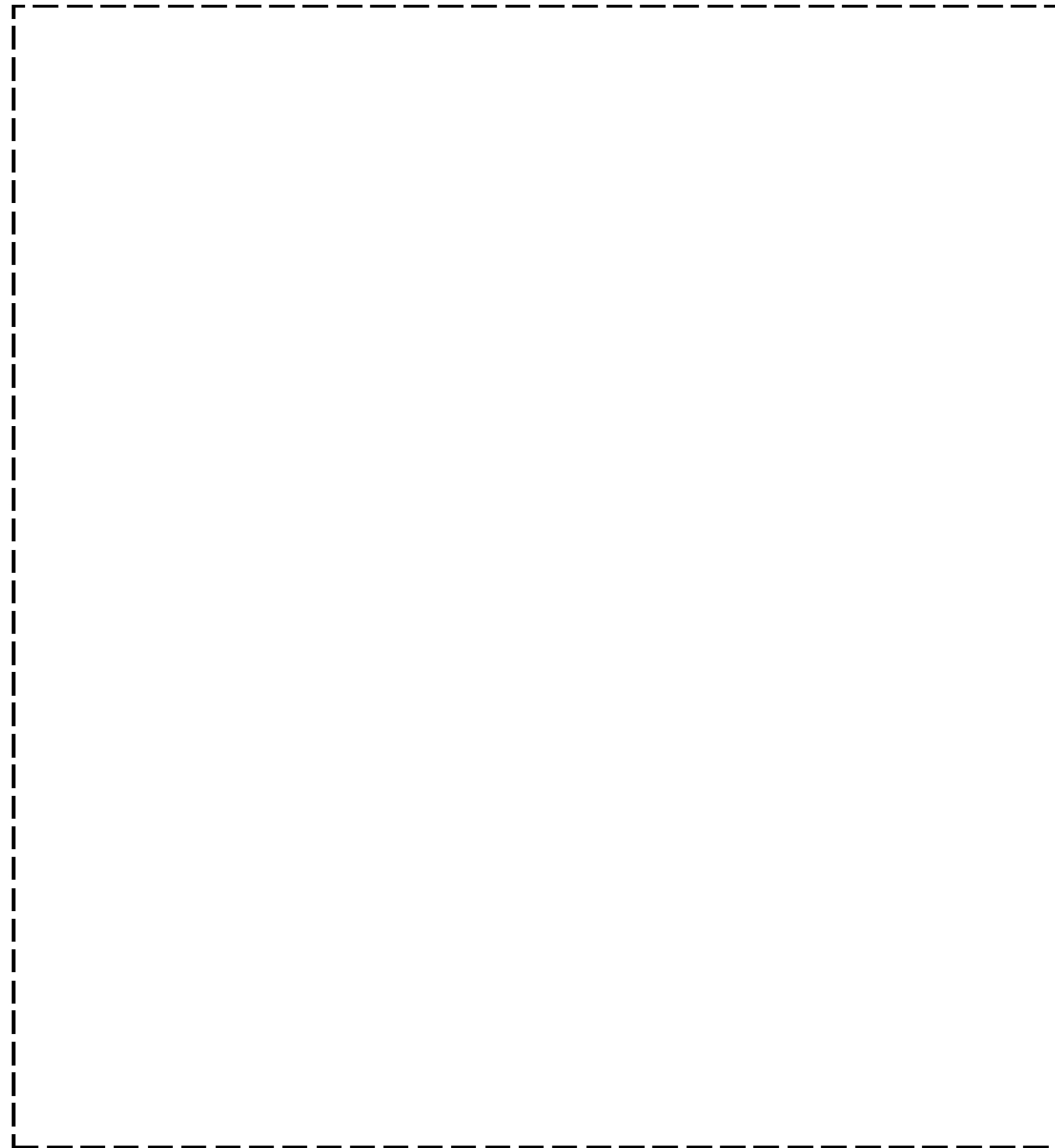
