The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle showing our new design;

FIG. 2 is a front elevational view thereof, the rear elevational view being an identical image;

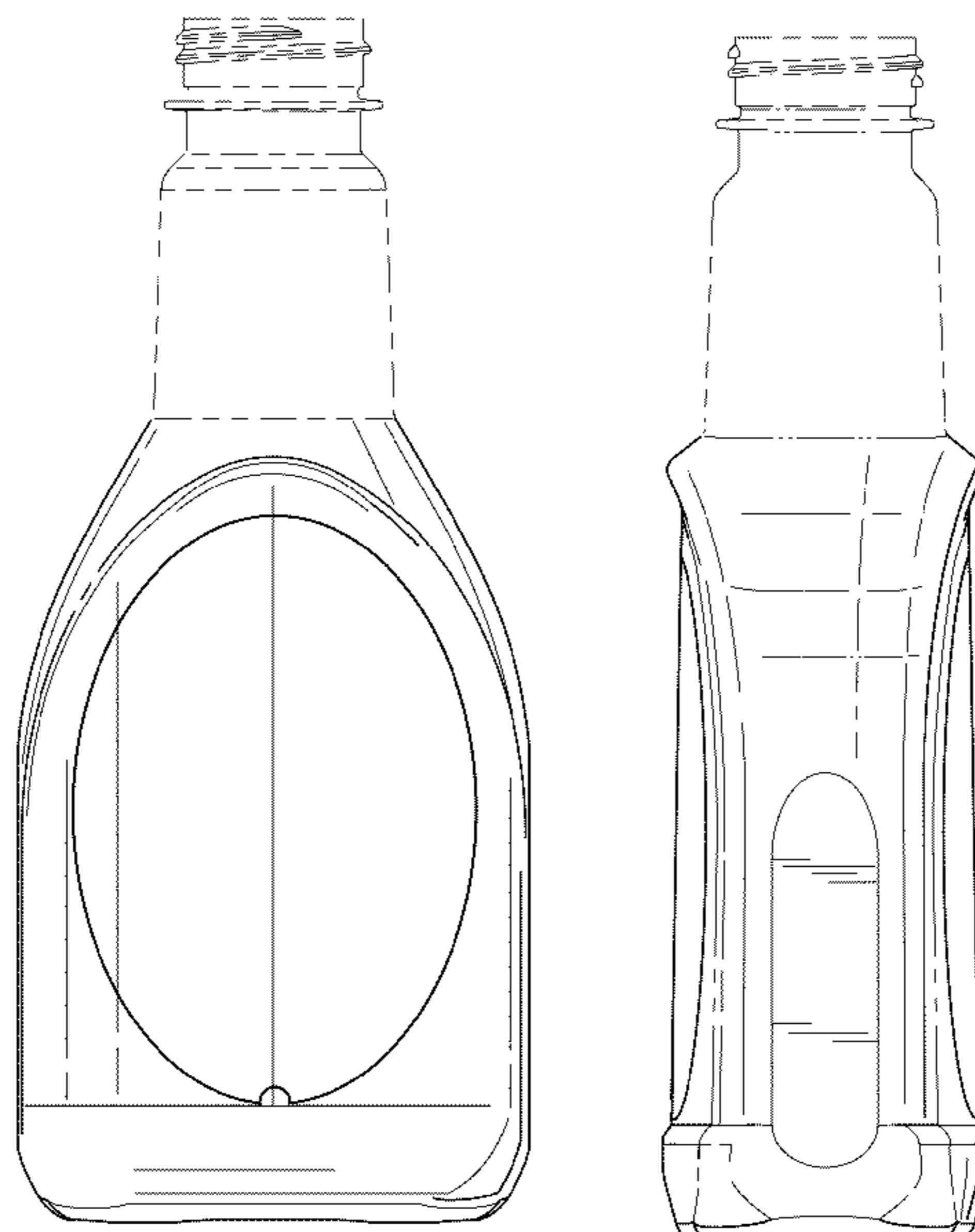
FIG. 3 is a top plan view thereof;

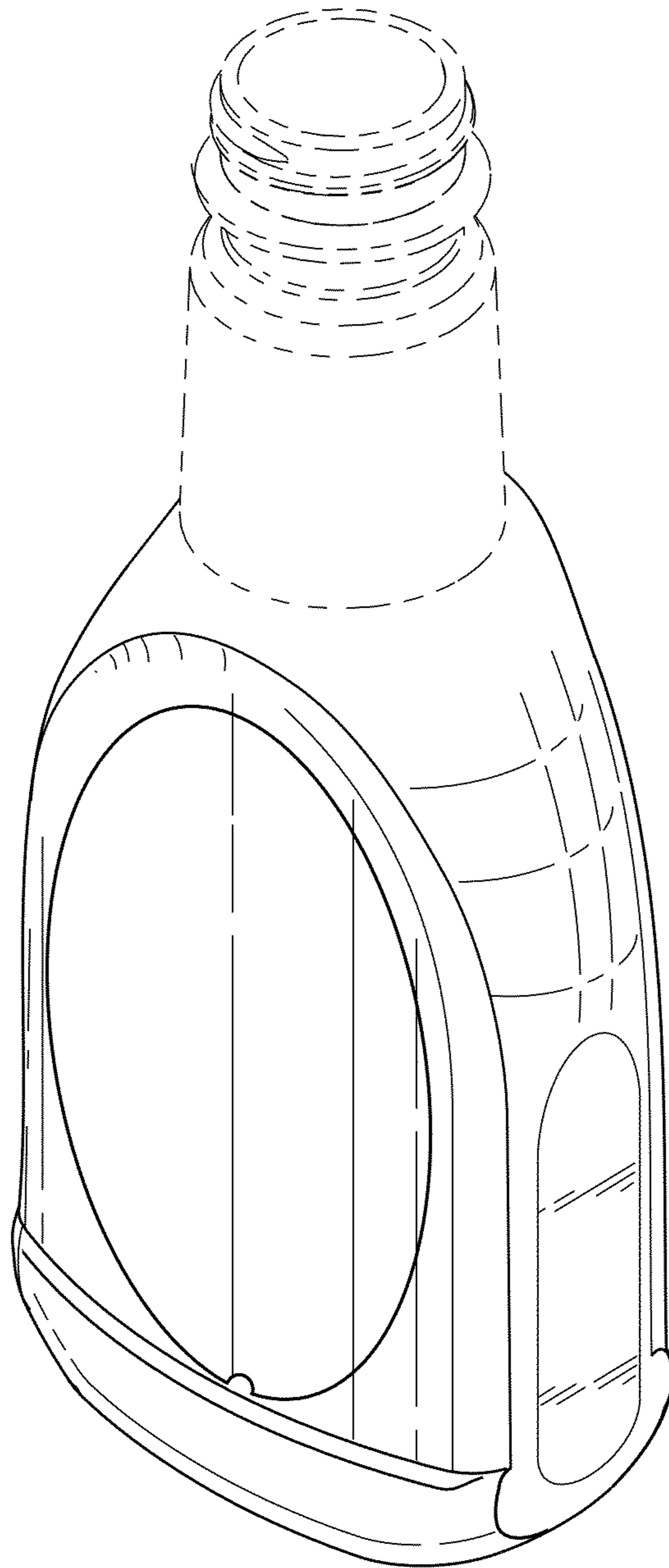

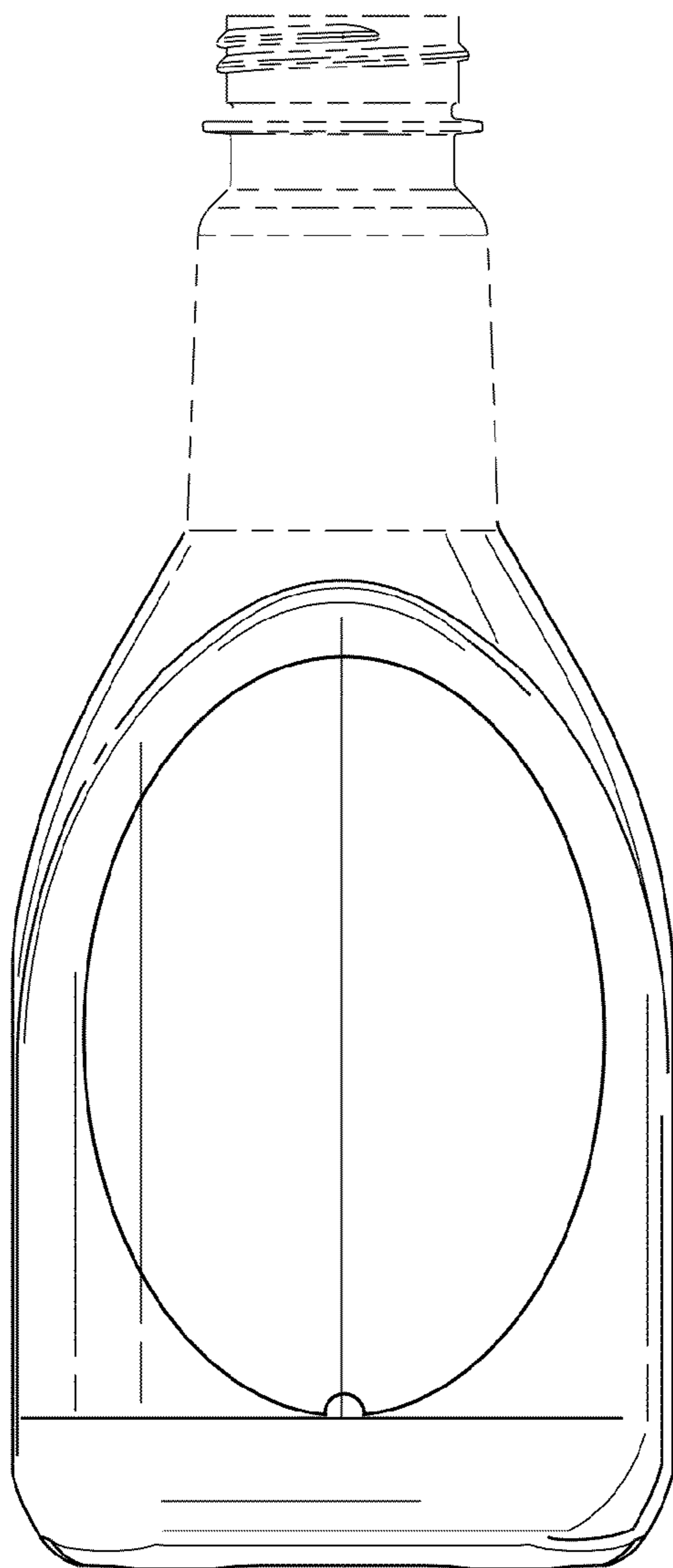

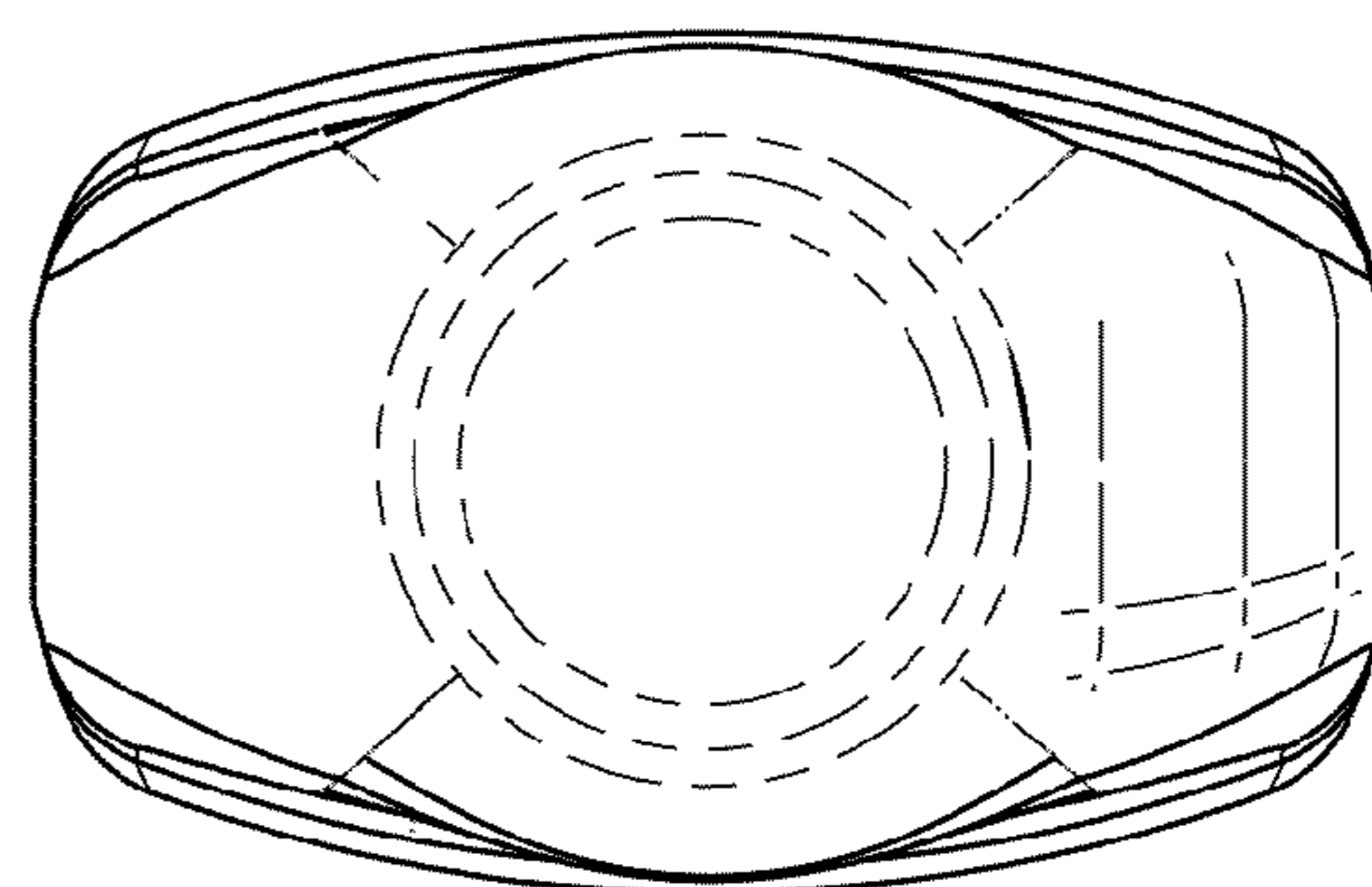

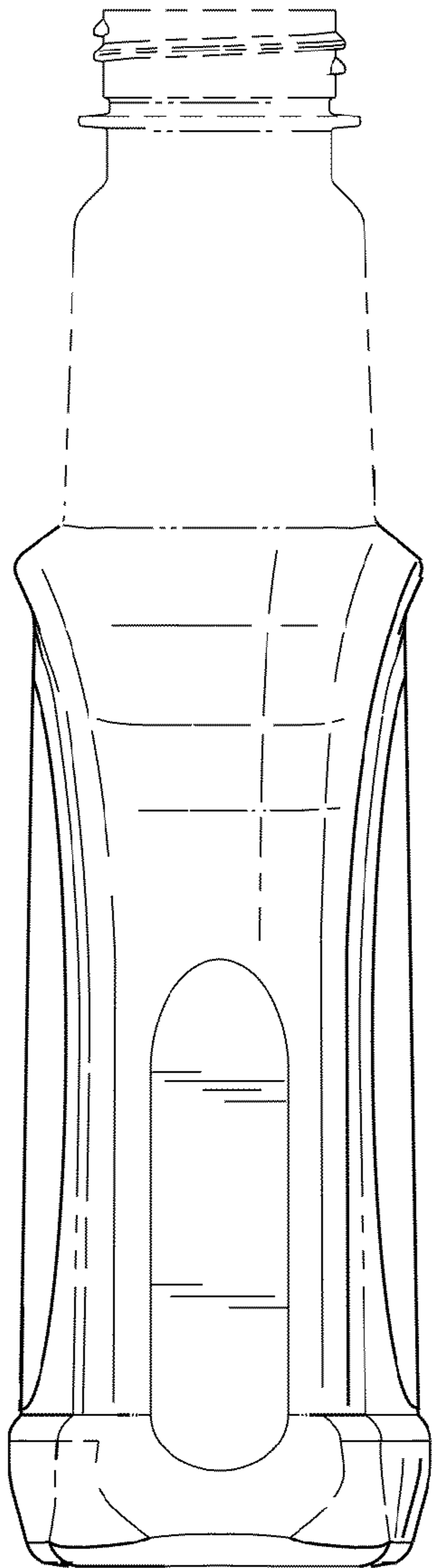
