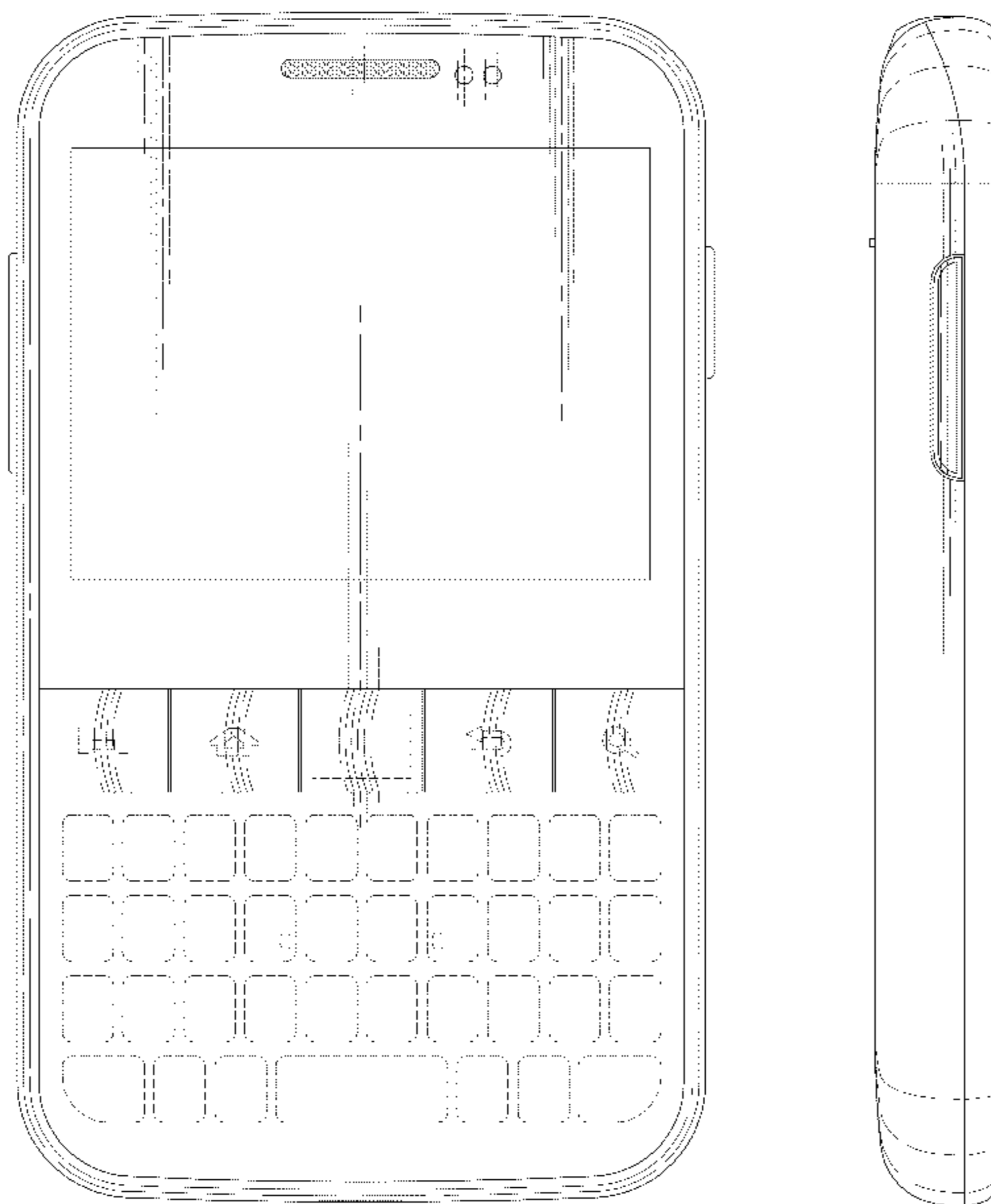
(57) **CLAIM**

The ornamental design for a mobile terminal, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mobile terminal; FIG. 2 is a front view of the mobile terminal of FIG. 1; FIG. 3 is a rear view of the mobile terminal of FIG. 1; FIG. 4 is a left-side view of the mobile terminal of FIG. 1; FIG. 5 is a right-side view of the mobile terminal of FIG. 1; FIG. 6 is a top plan view of the mobile terminal of FIG. 1; and, FIG. 7 is a bottom plan view of the mobile terminal of FIG. 1. The broken lines showing the keys and the unshaded regions therein, as well as the additional broken lines in the views, are for illustrative purposes only and form no part of the claimed design. The shade lines in the figures show contour and not surface ornamentation.

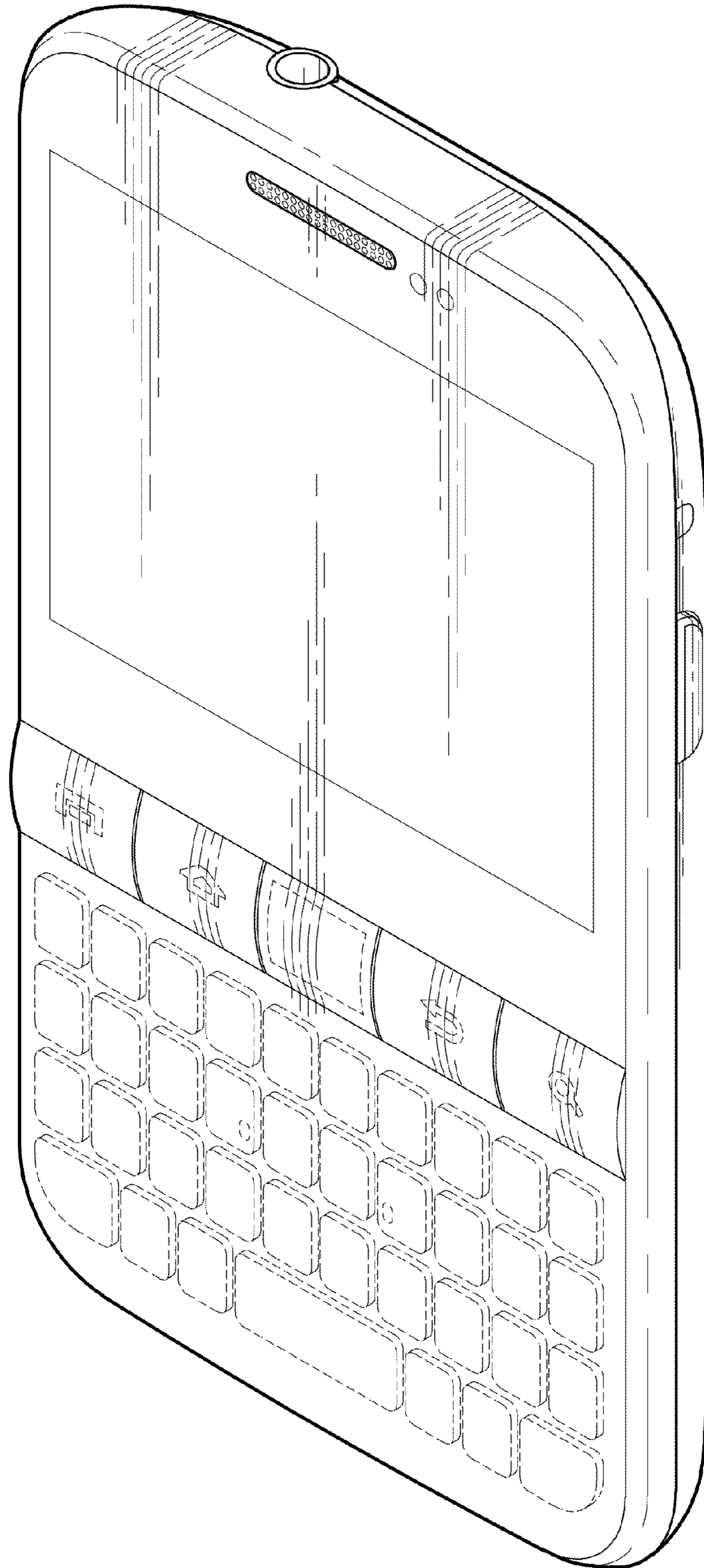

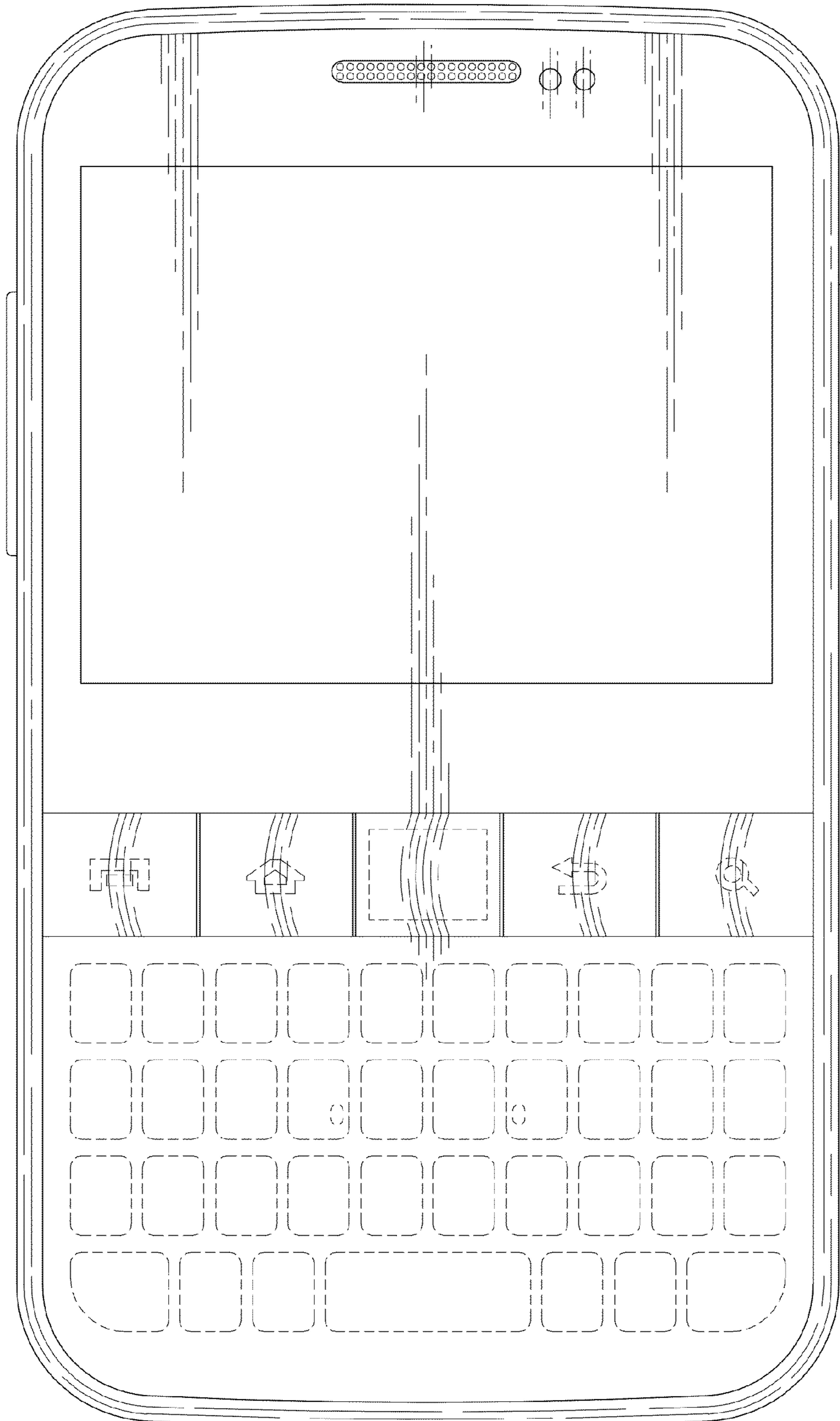

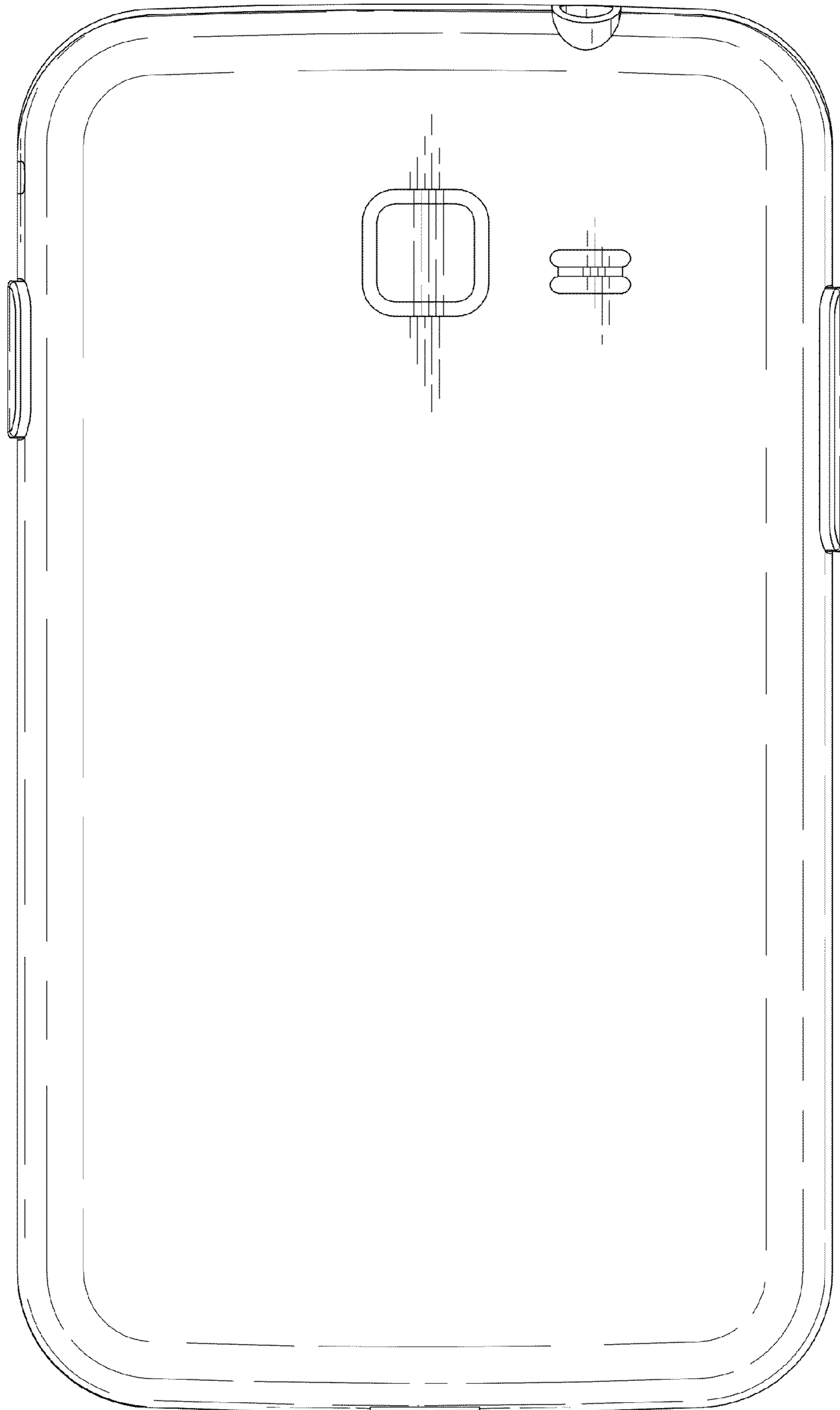

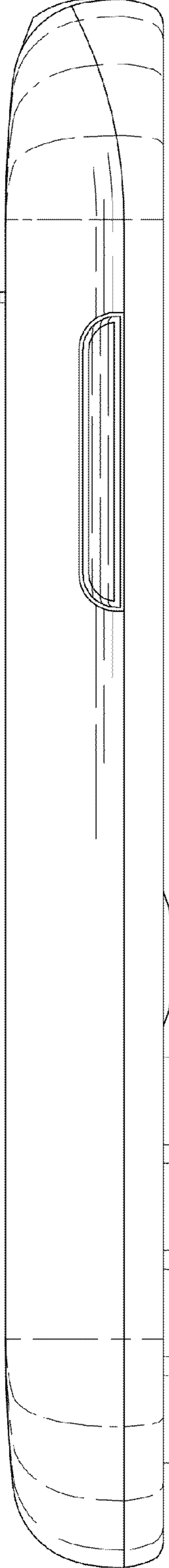

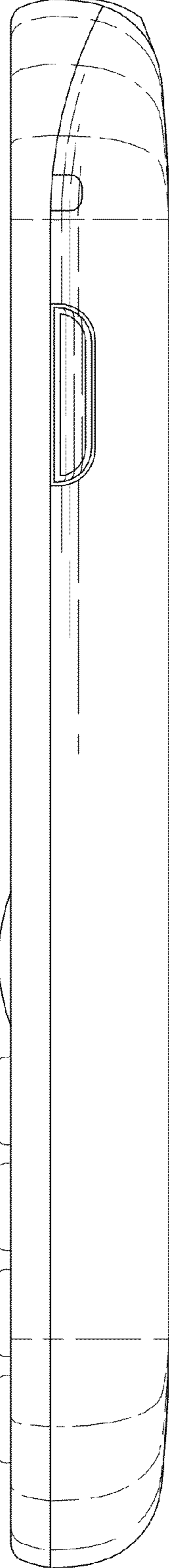

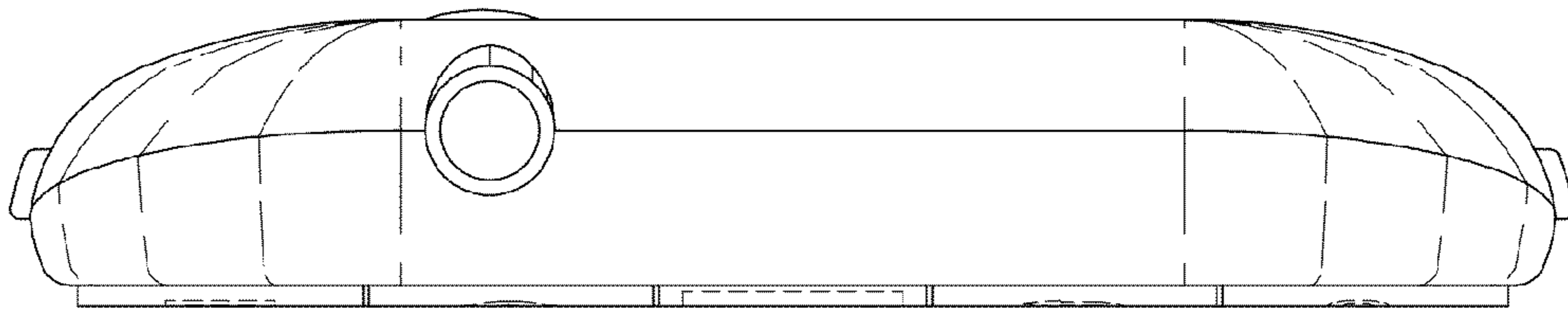
