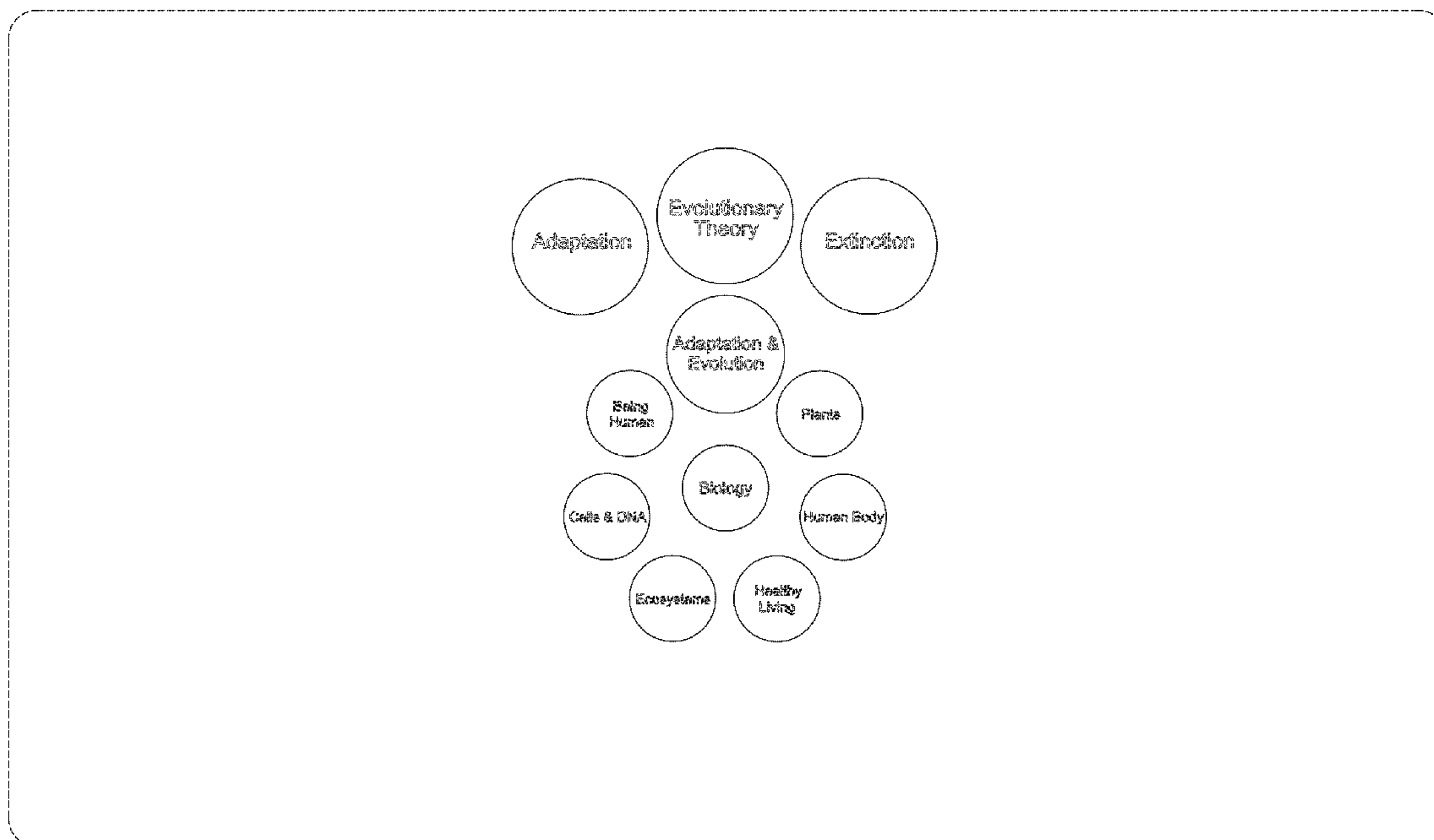

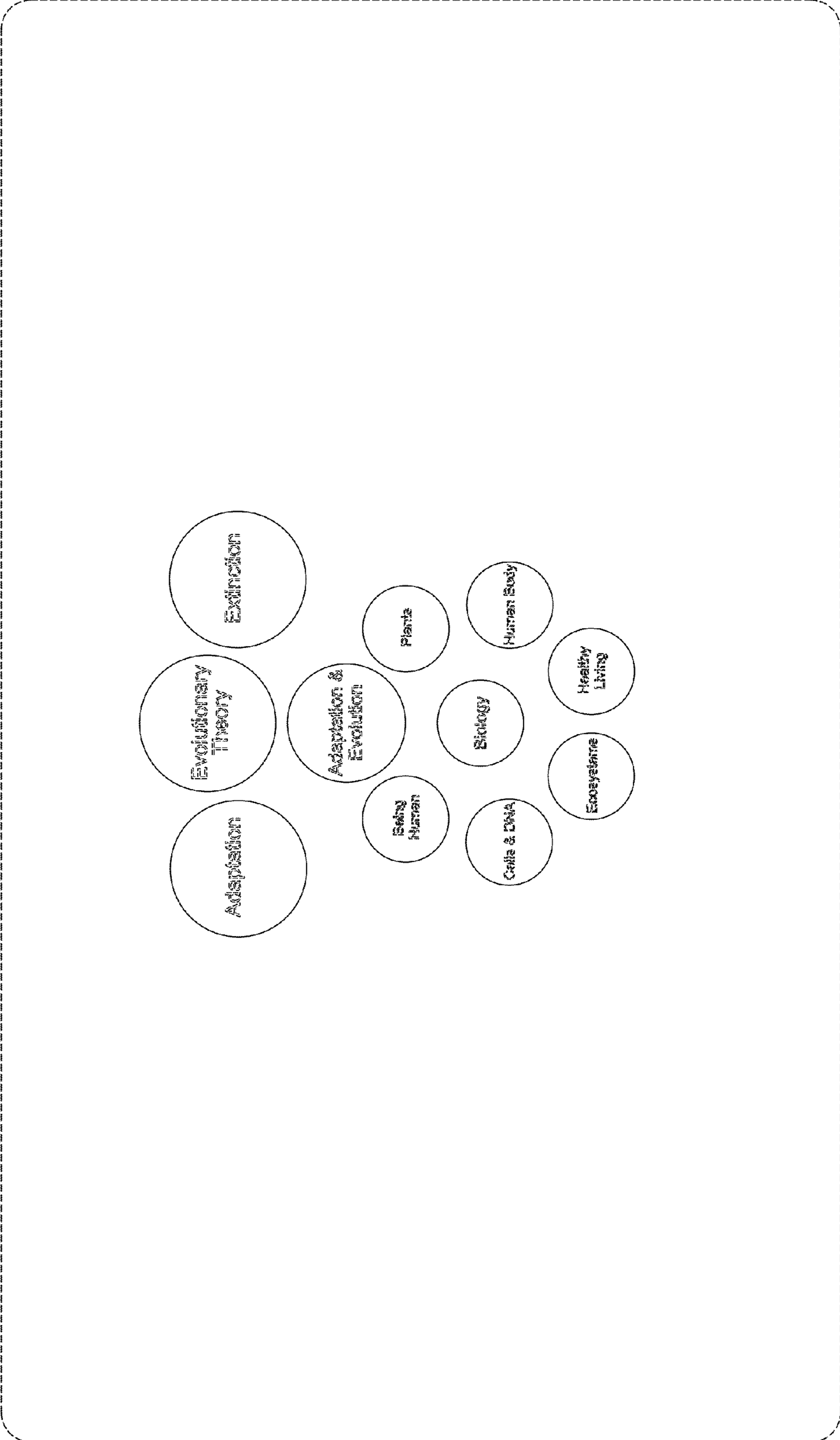
The ornamental design for a portion of a display screen with user interface, as shown and described.
