FIG. 10 is an enlarged left side elevation view thereof.

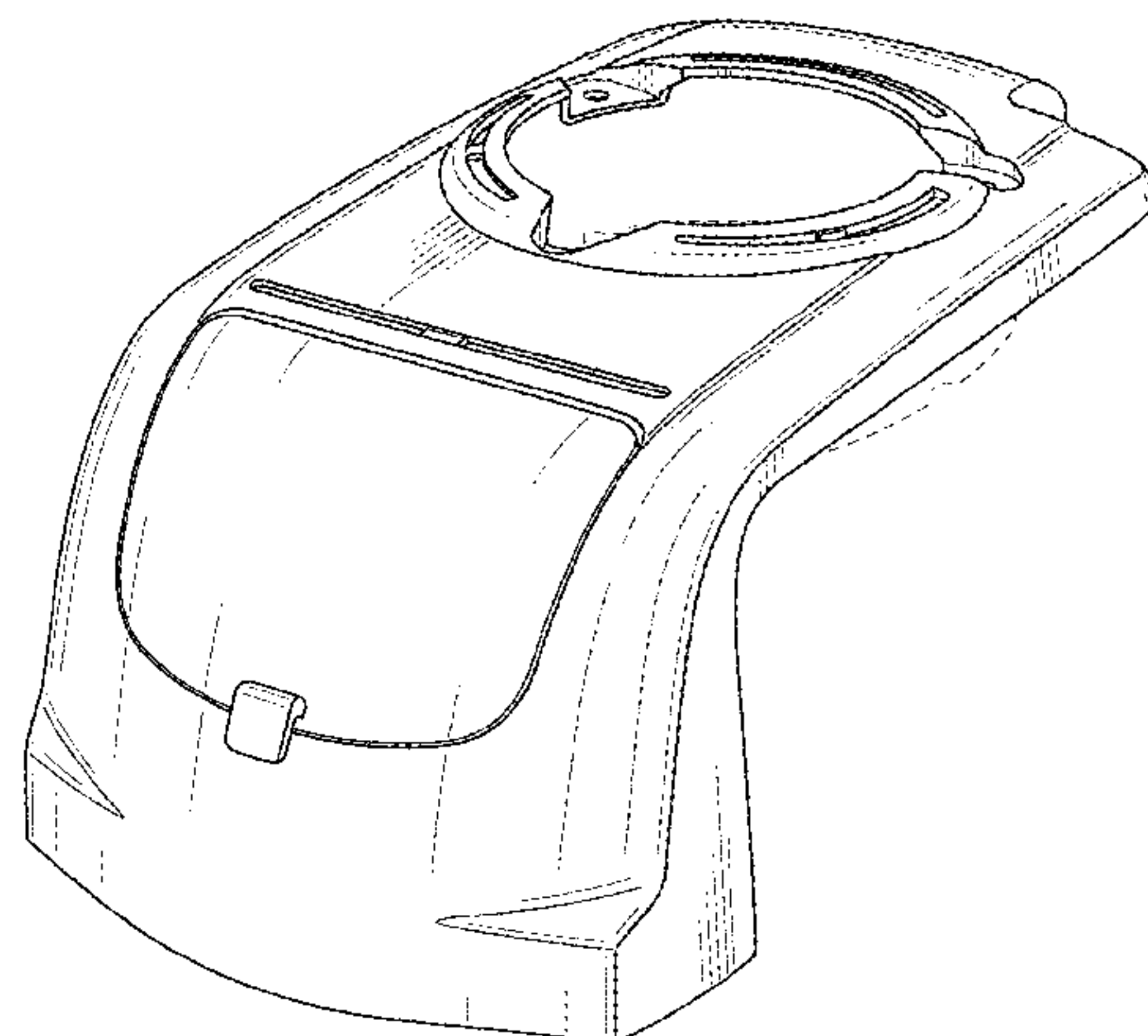
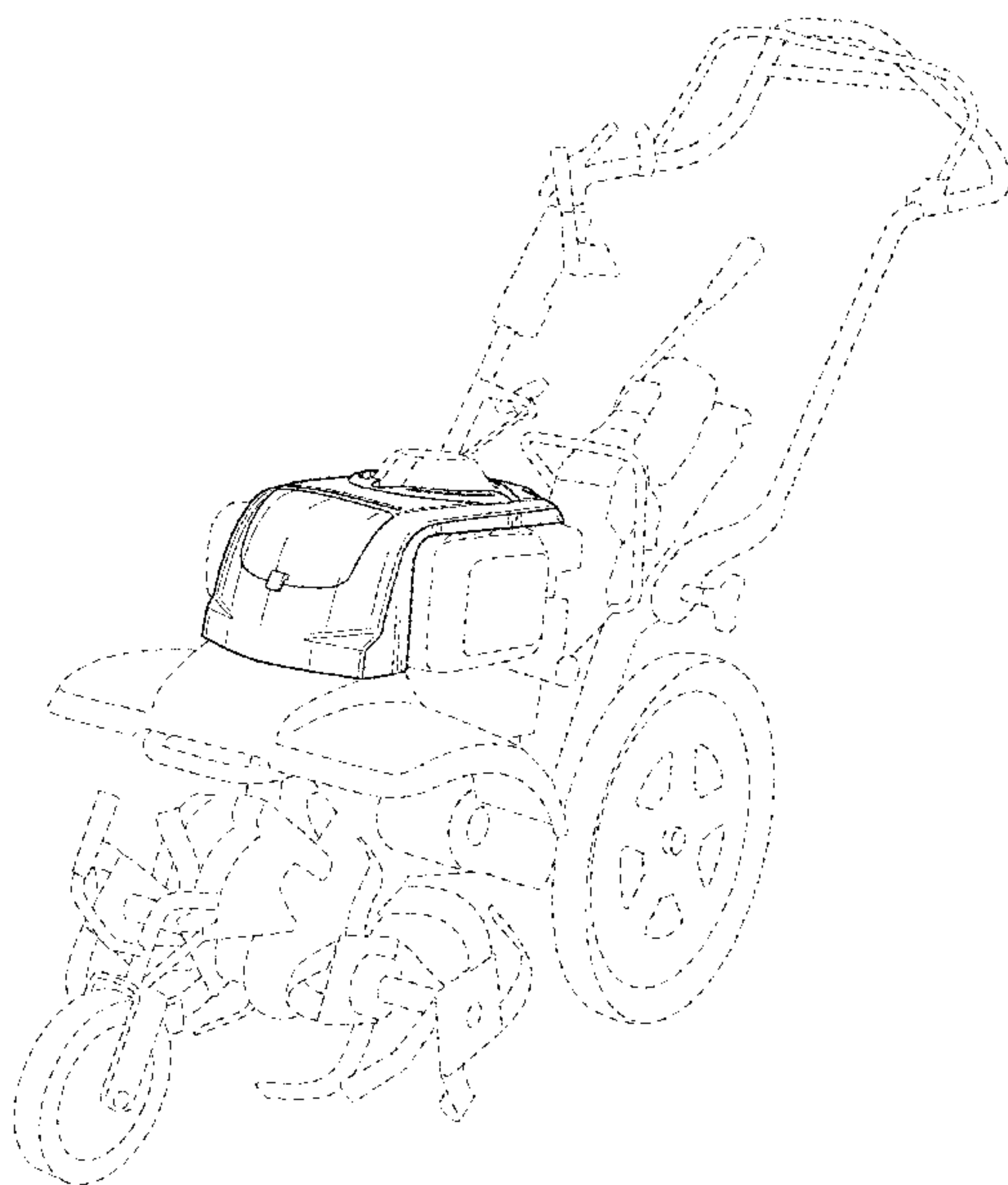
FIG. 11 is an enlarged rear elevation view thereof.

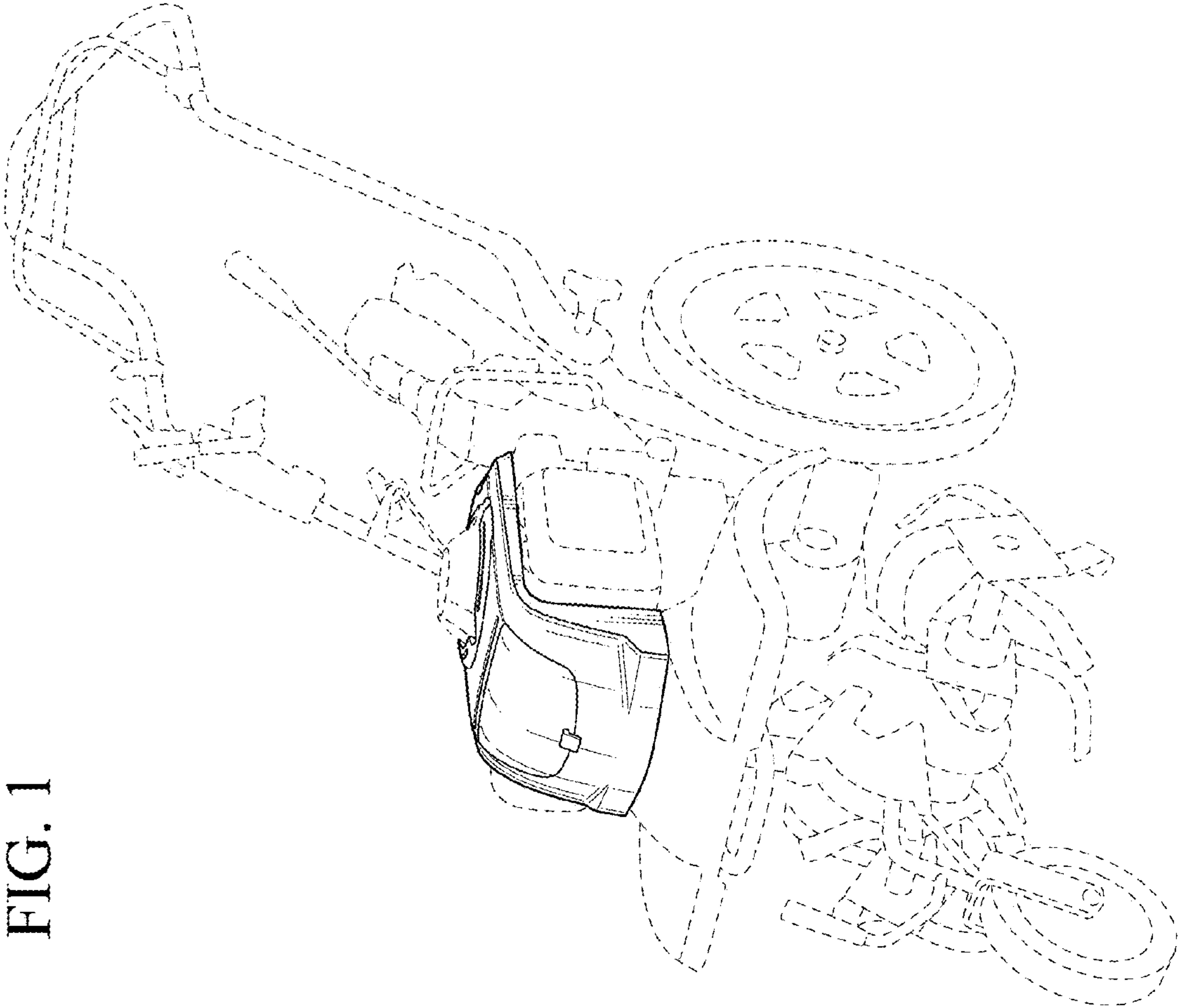

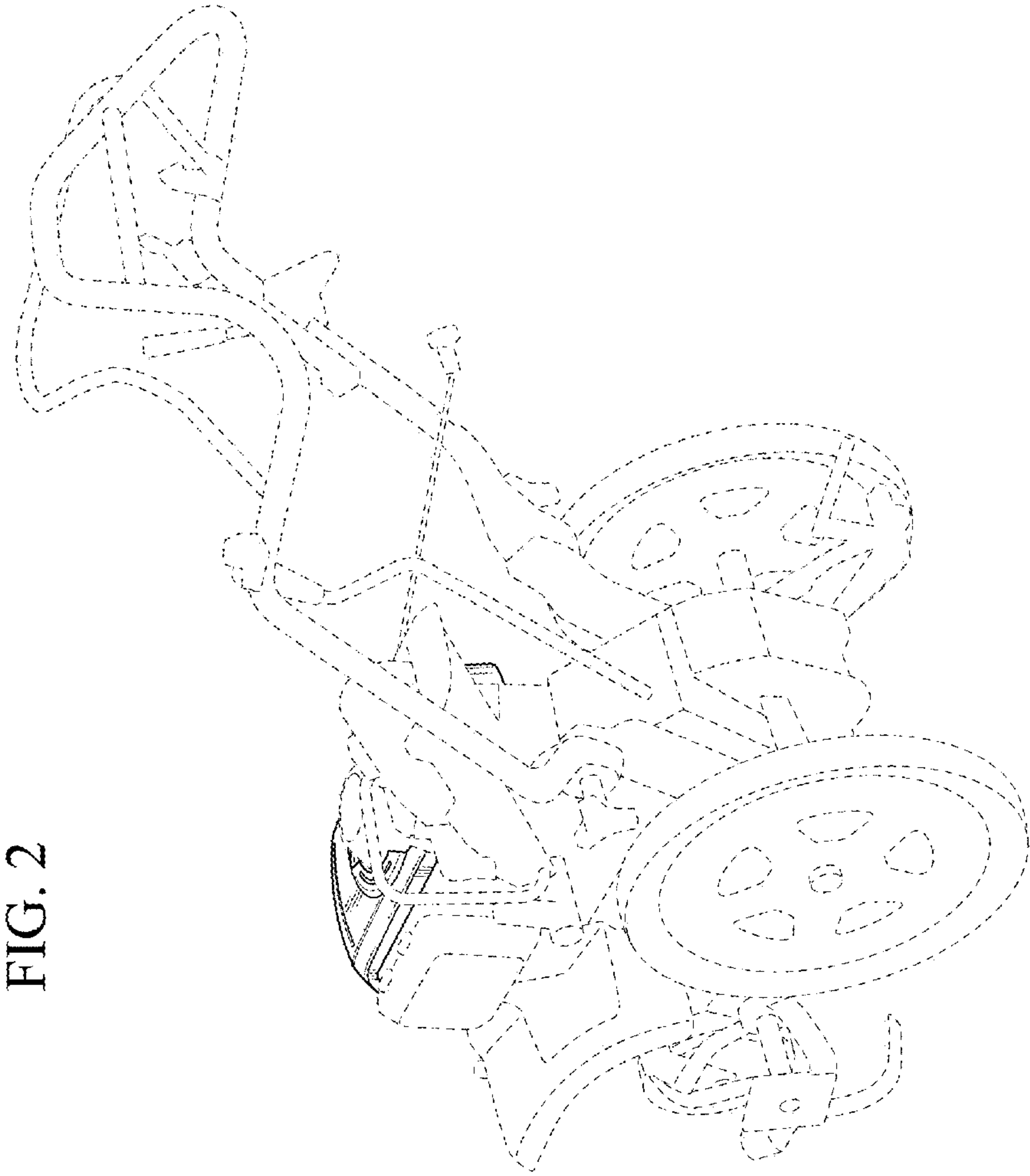

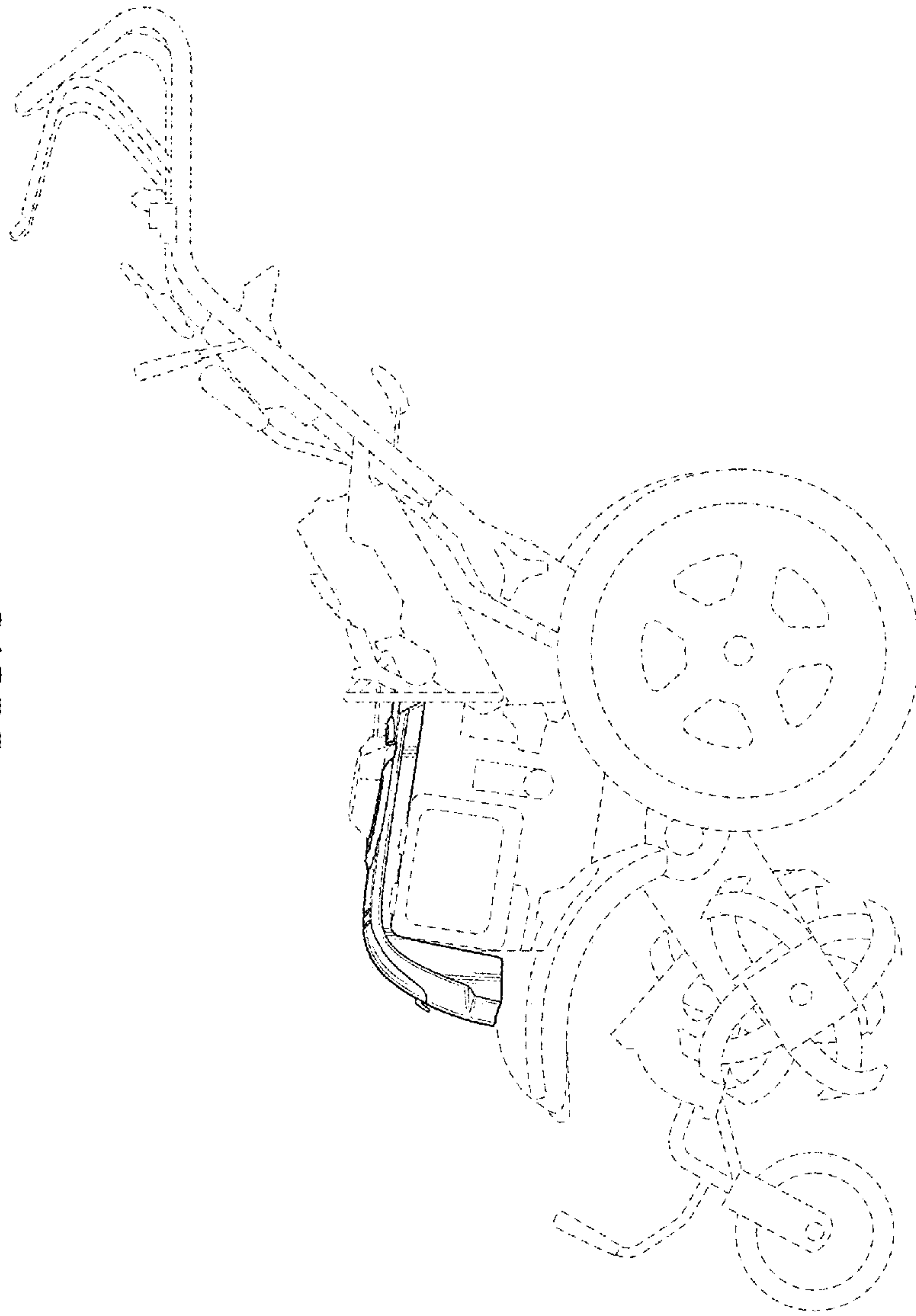

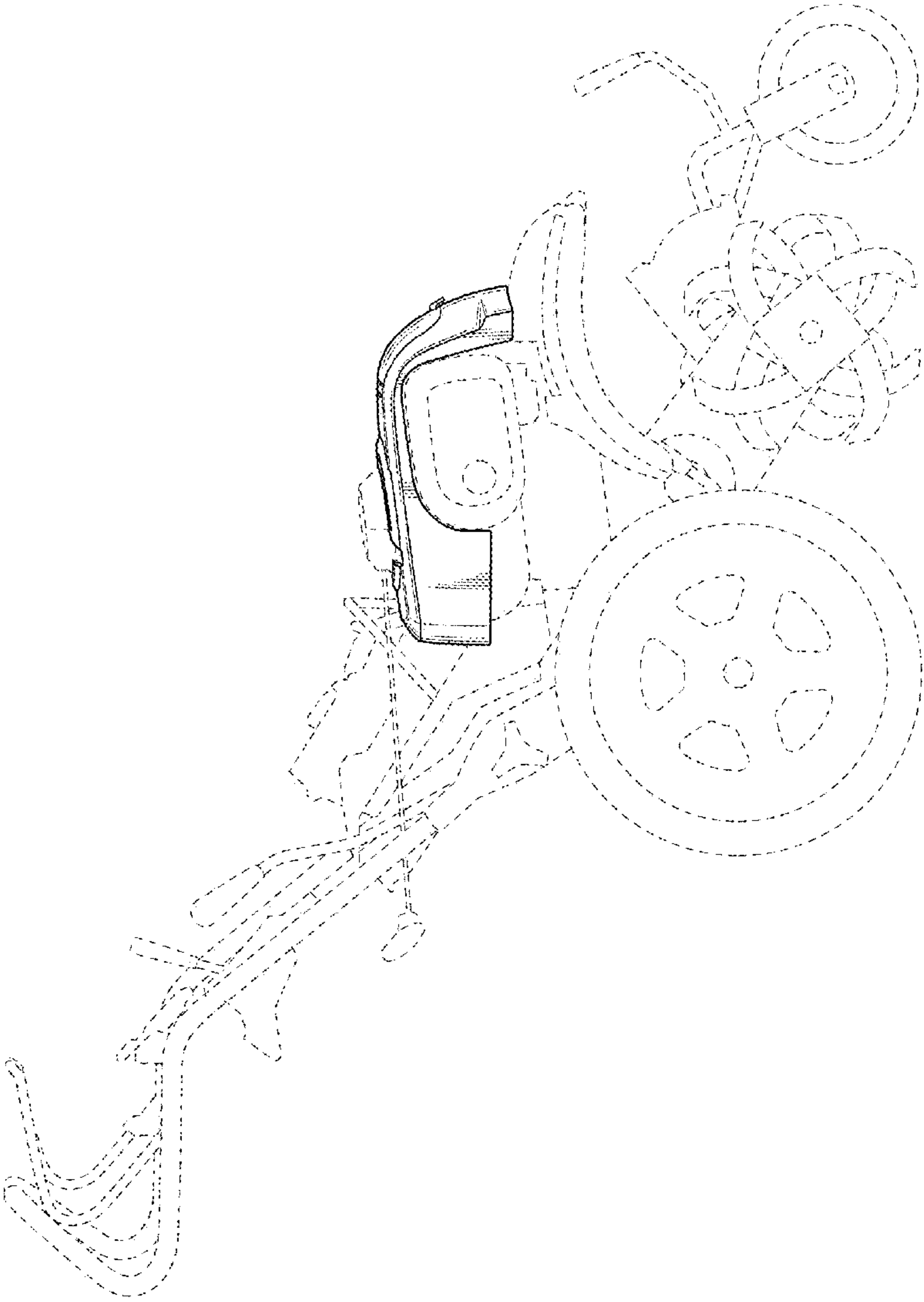

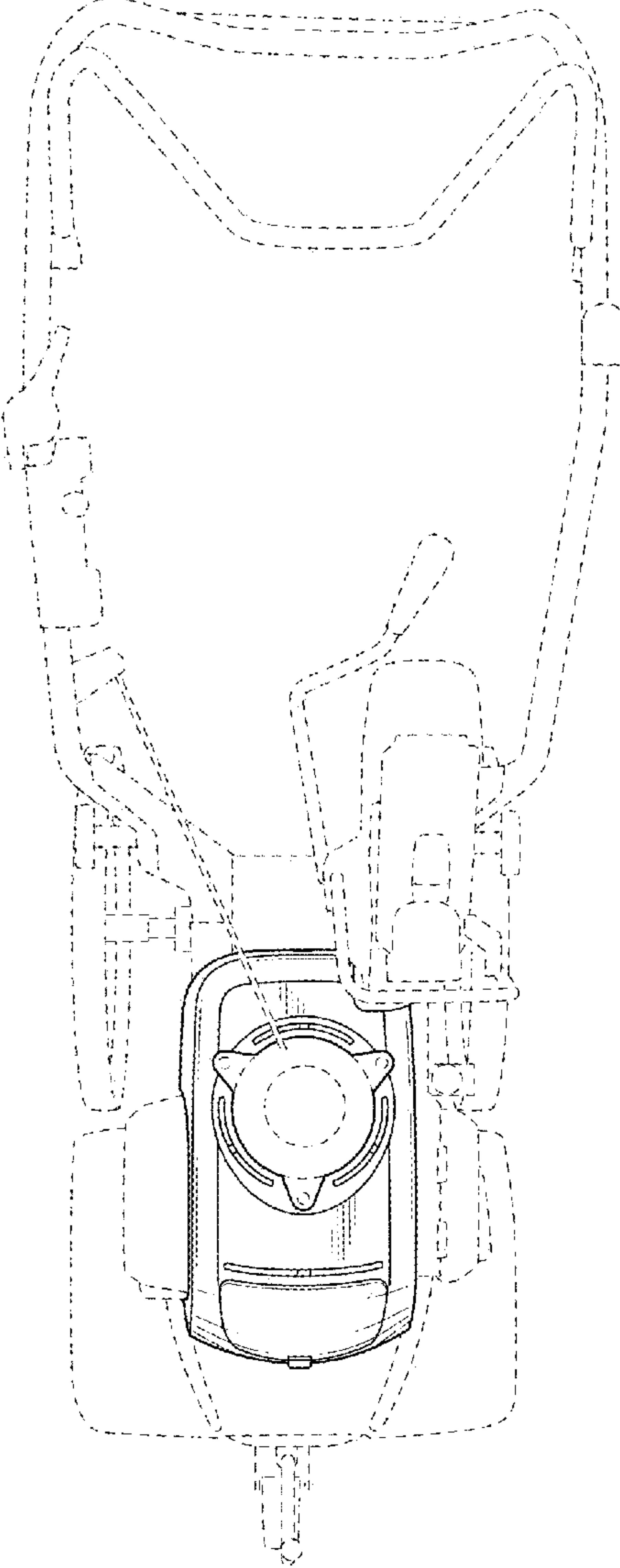
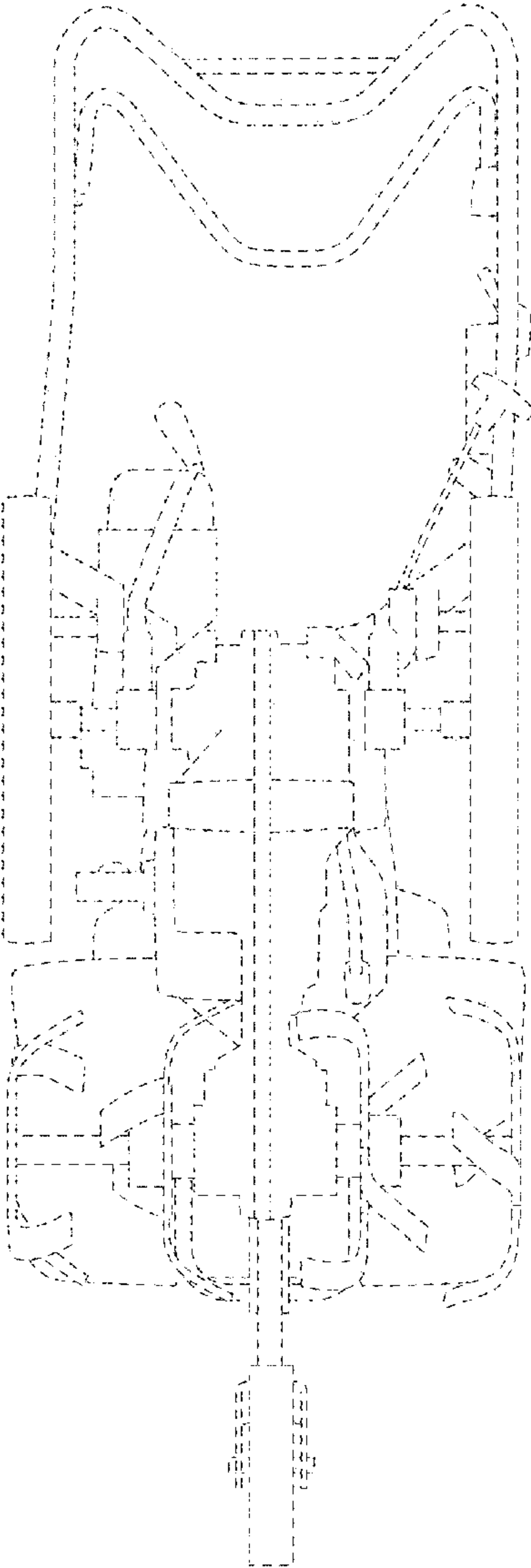

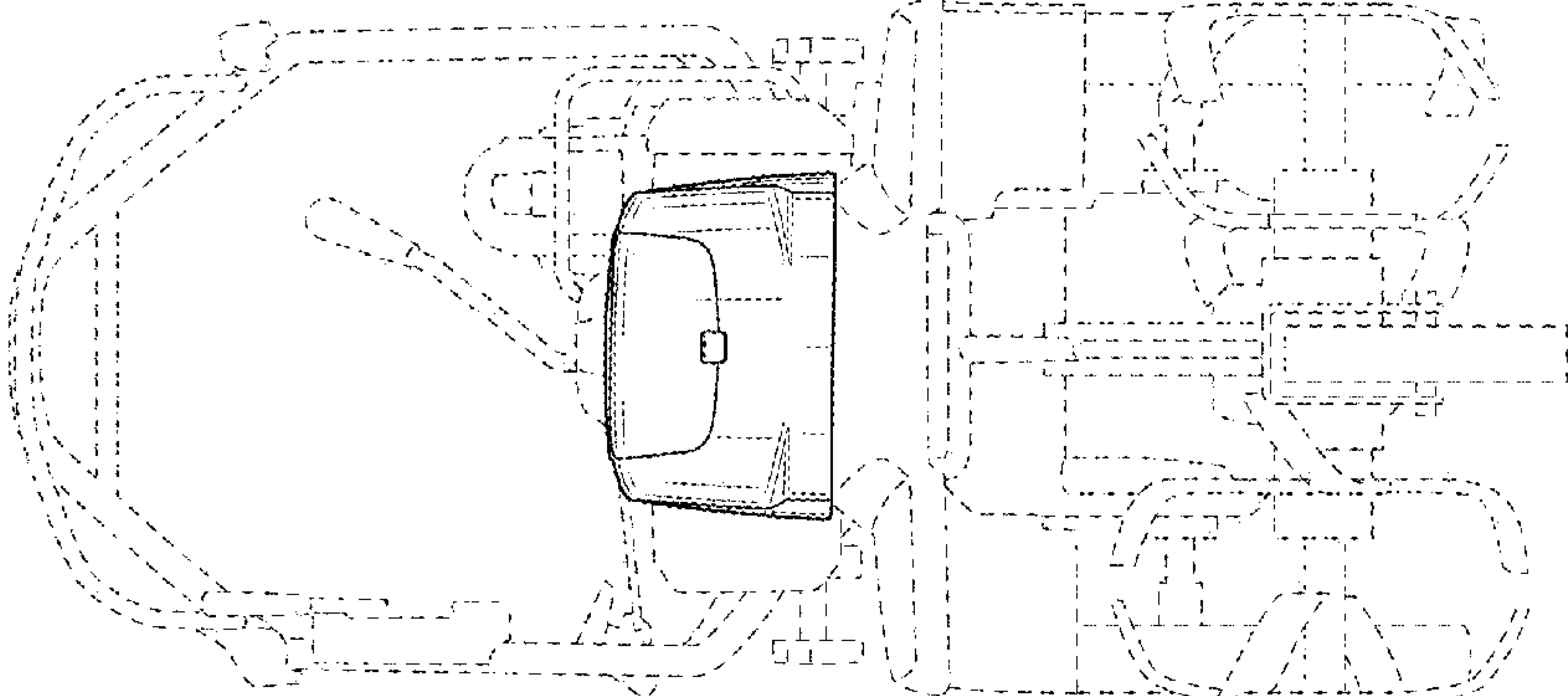

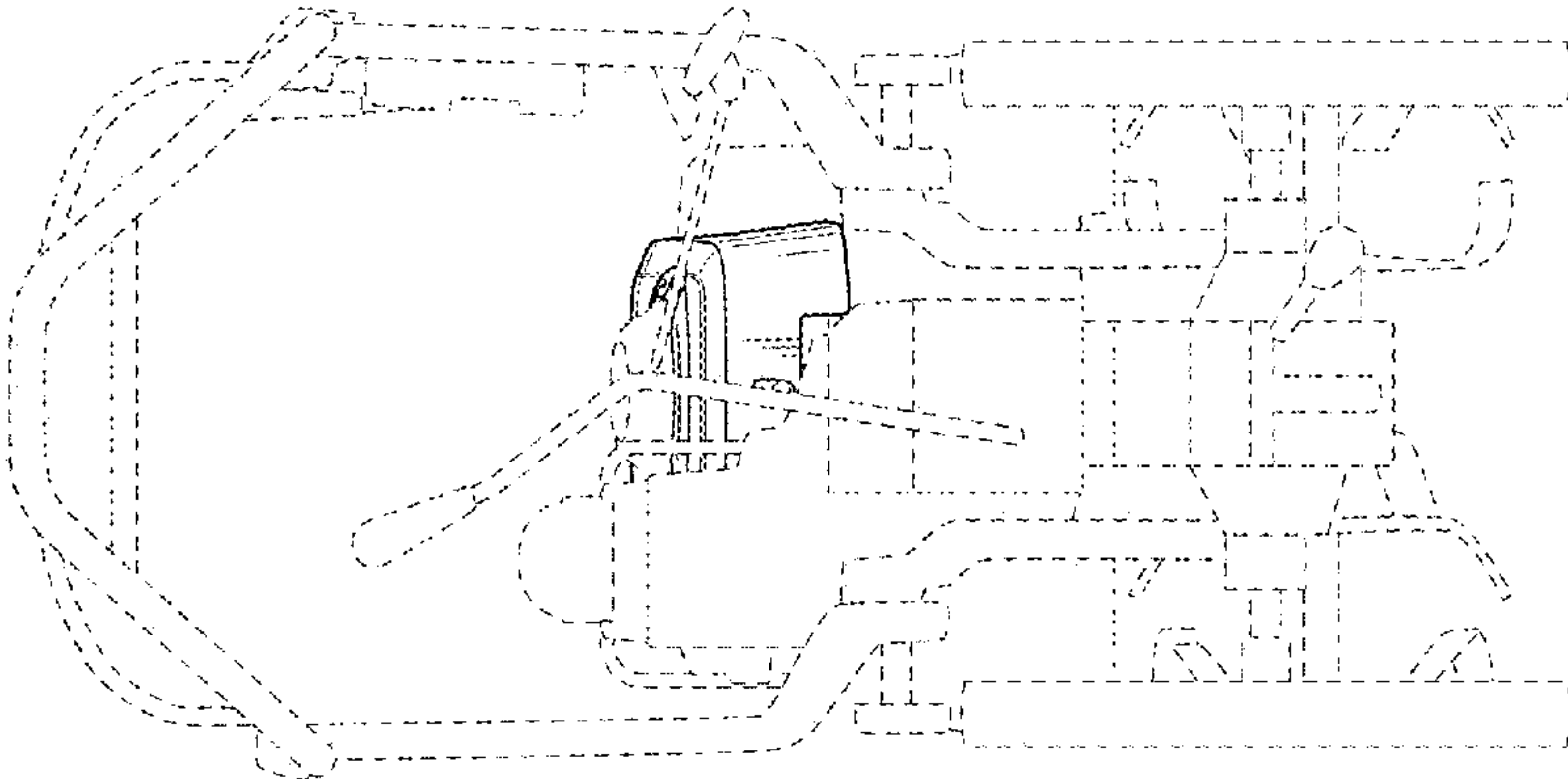

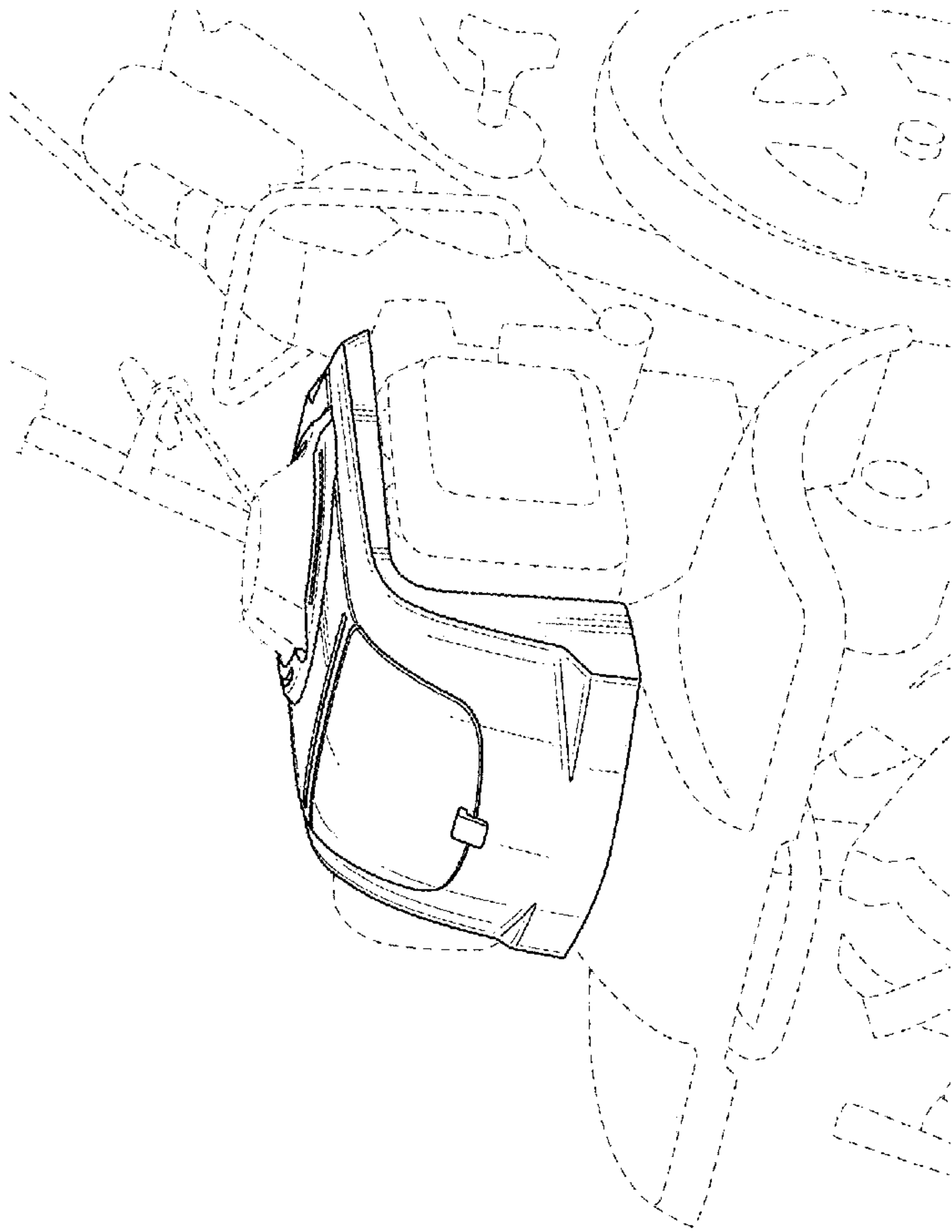

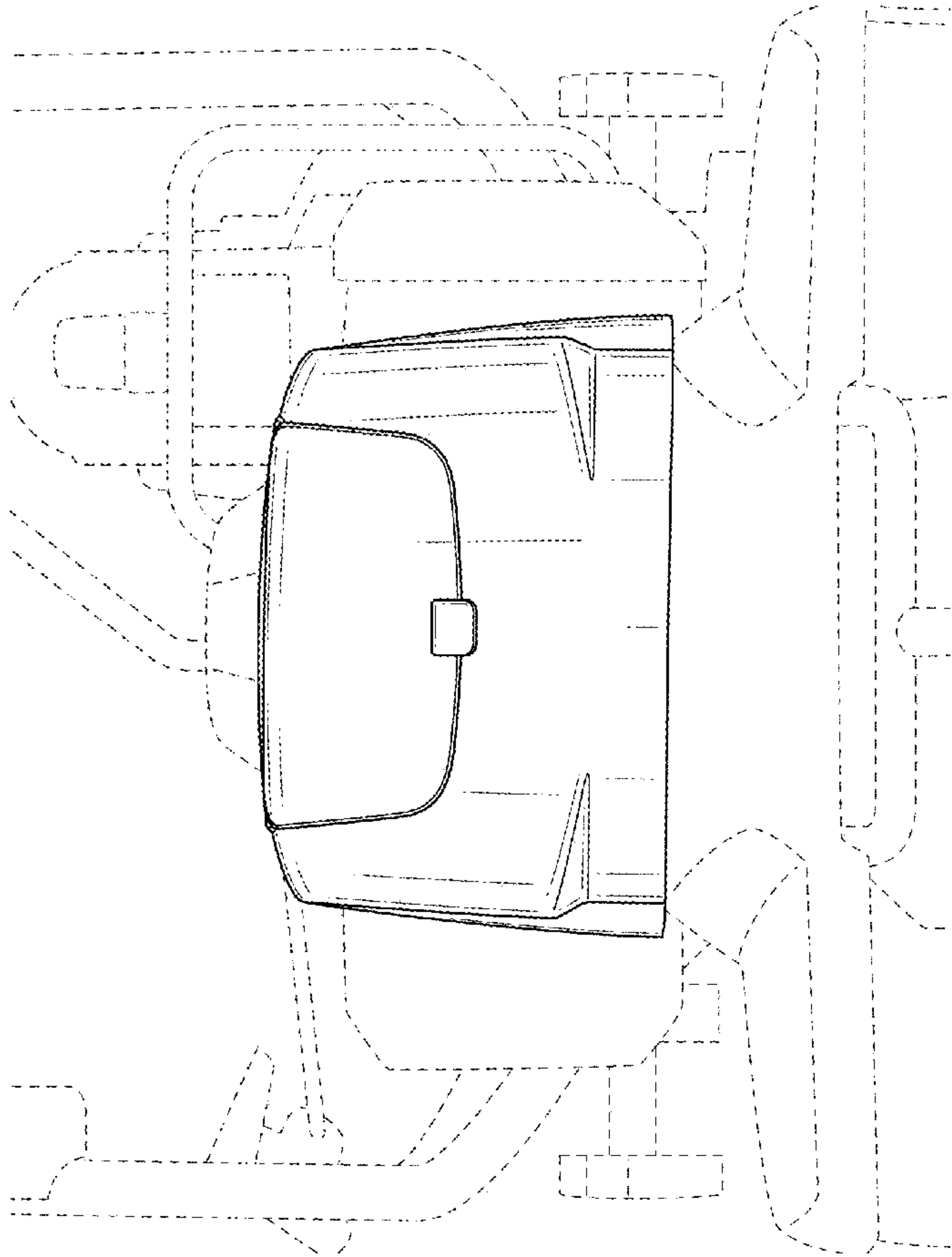

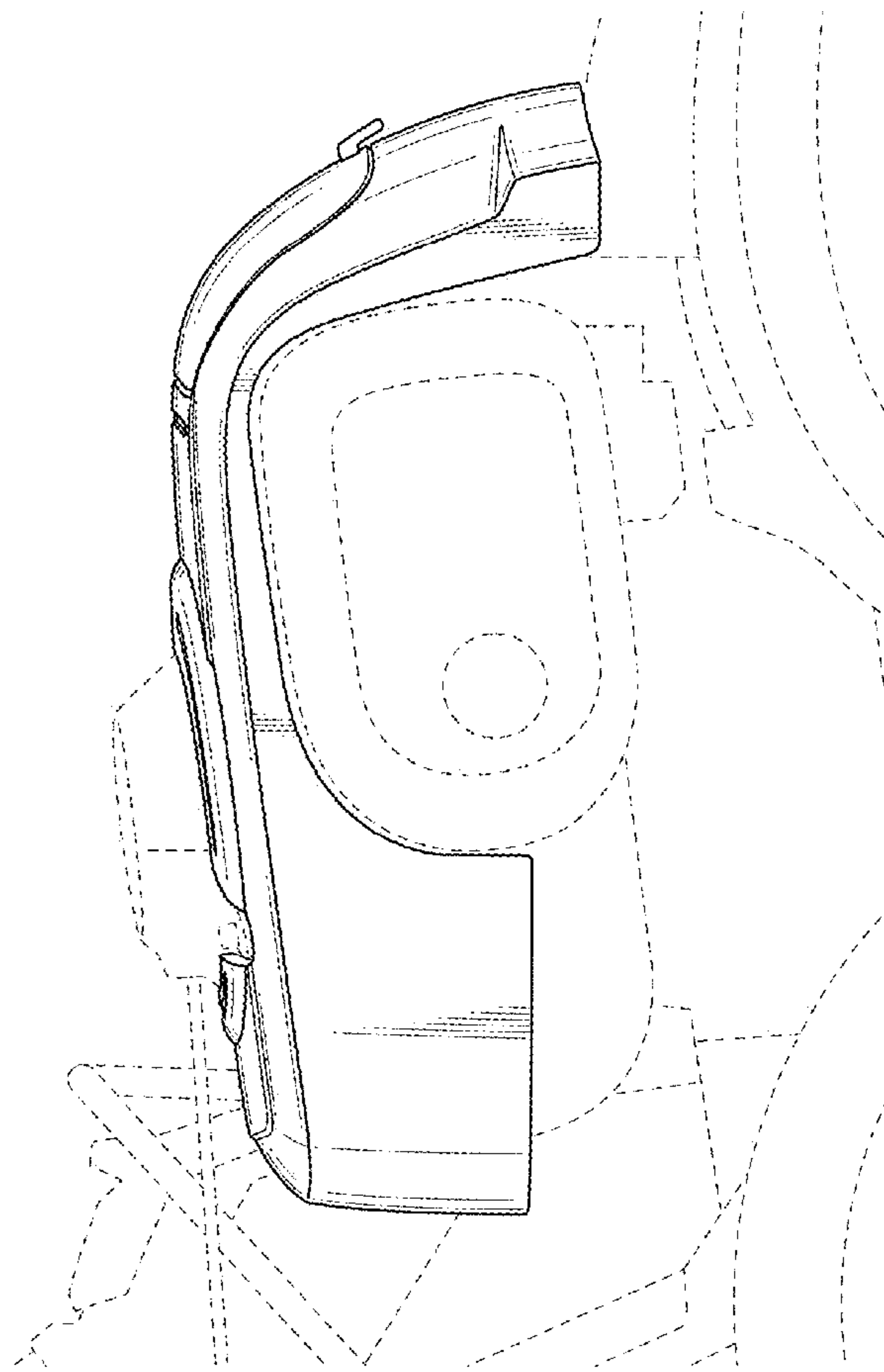

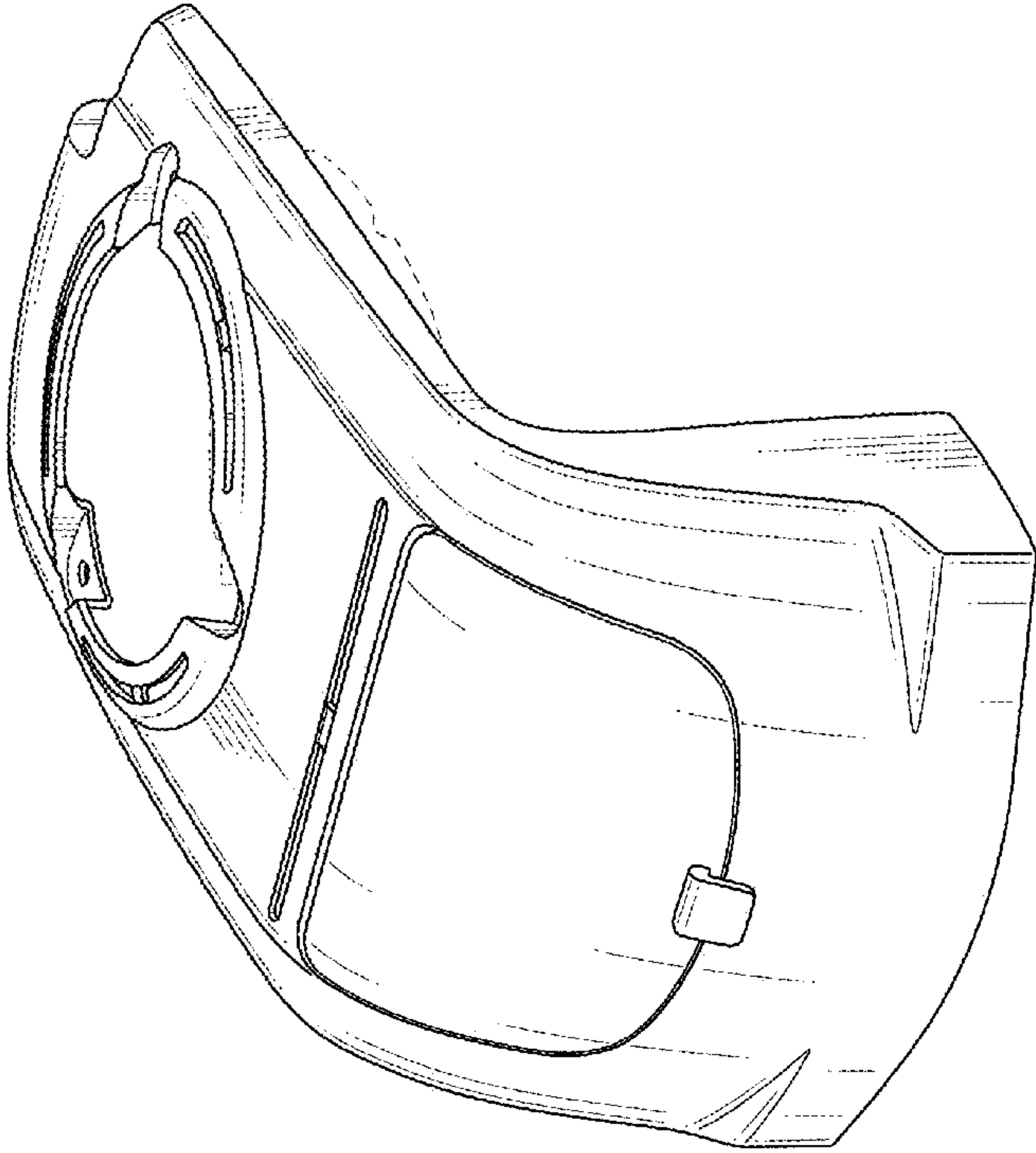
