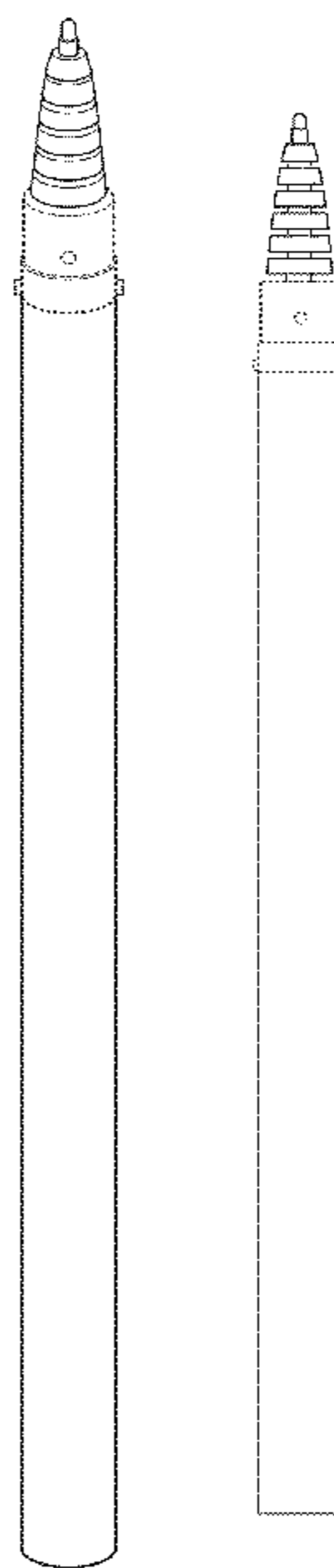
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view showing our new design for a writing instrument;

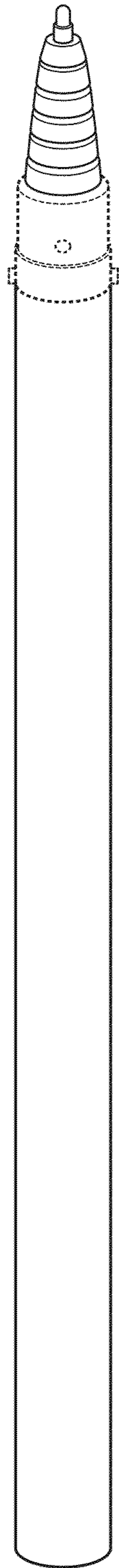

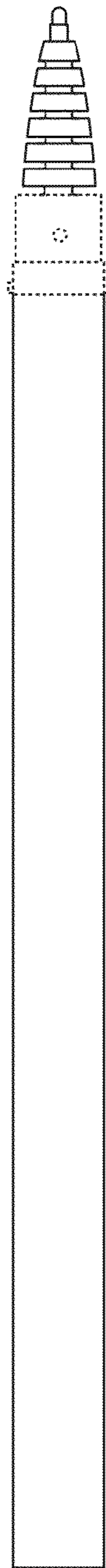

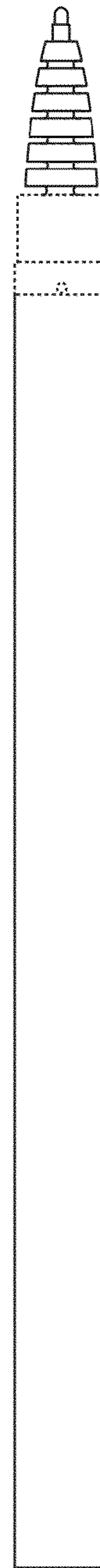

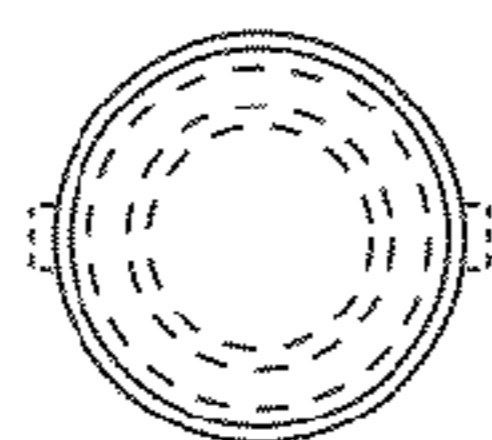

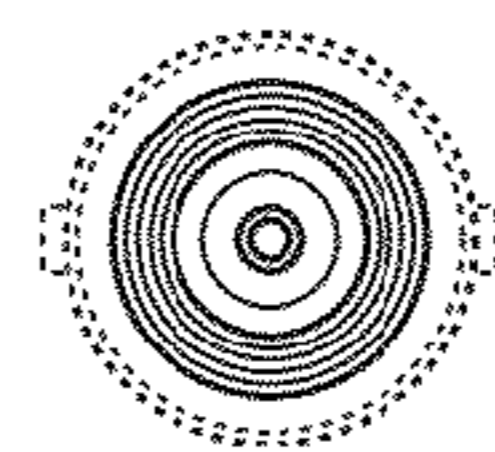
