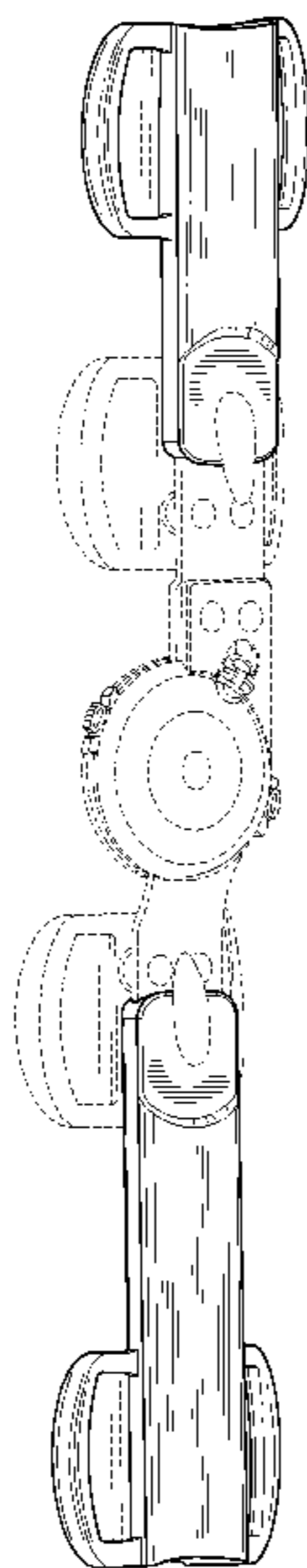

The ornamental design for a pair of struts for an orthopedic device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pair of struts for an orthopedic device showing the design.  
FIG. 2 is a front elevational view showing the strut of FIG. 1.  
FIG. 3 is a top plan view showing the strut of FIG. 1; and,  
FIG. 4 is a bottom plan view showing the strut of FIG. 1.  
The broken lines are included for the purpose of illustrating environmental structure and form no part of the claimed design.

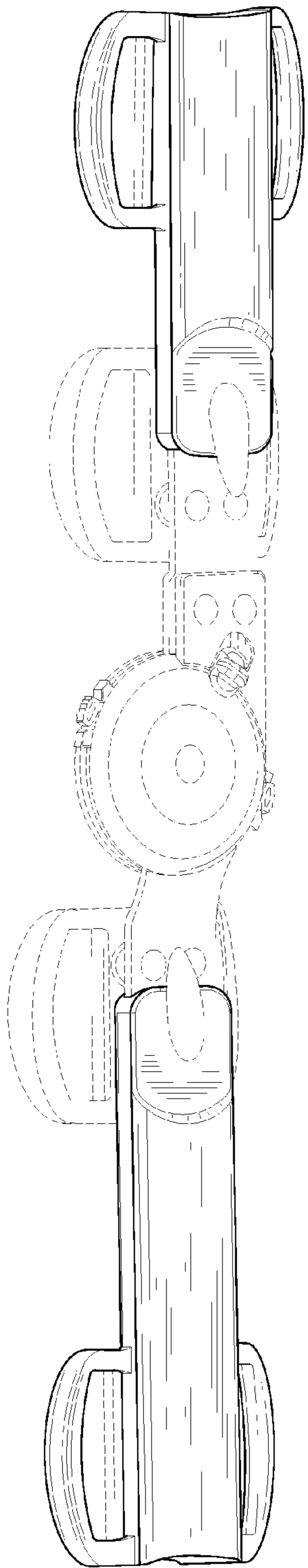

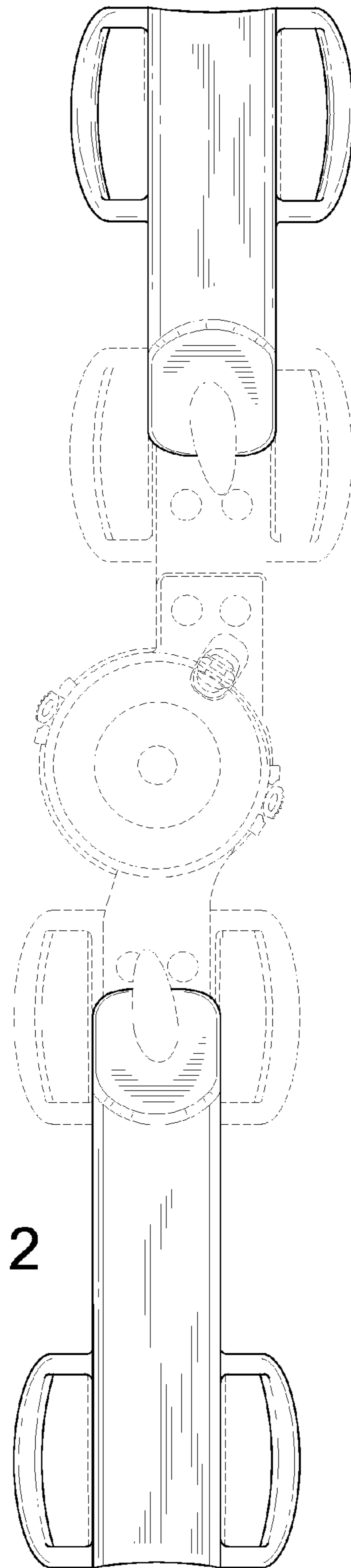

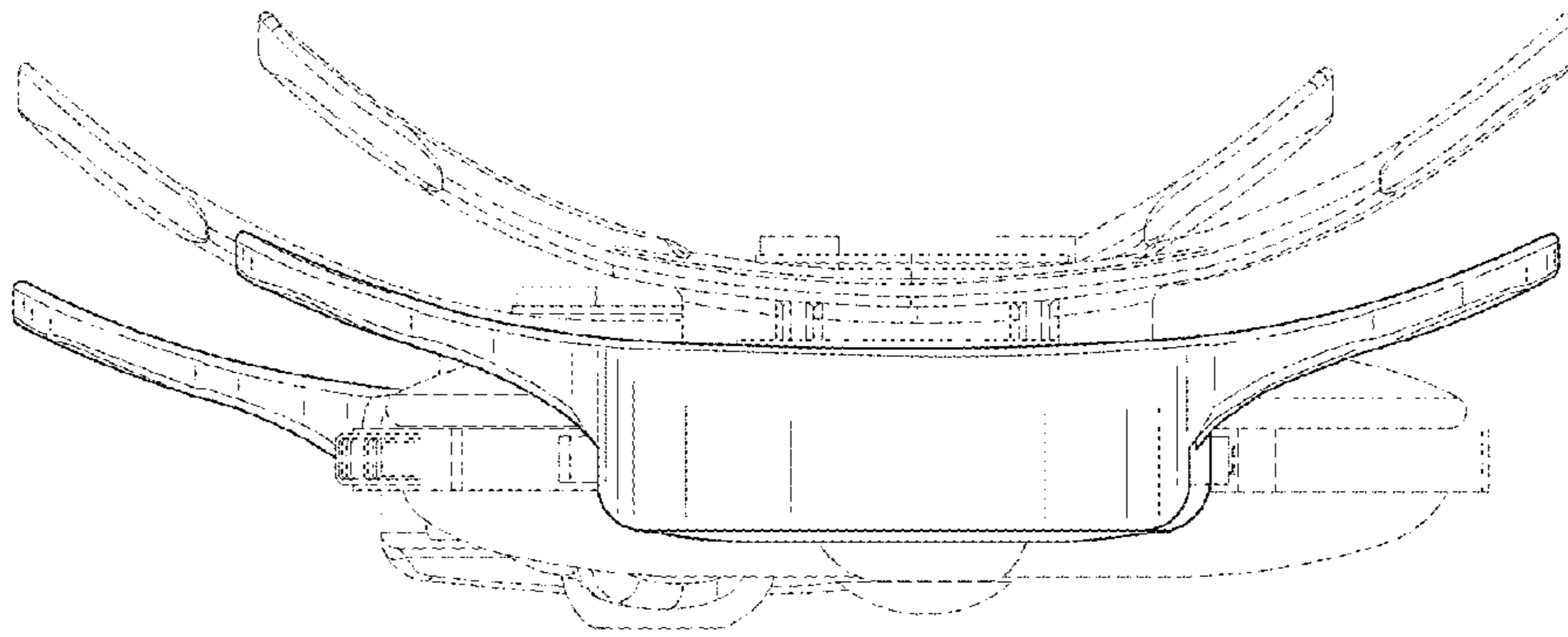

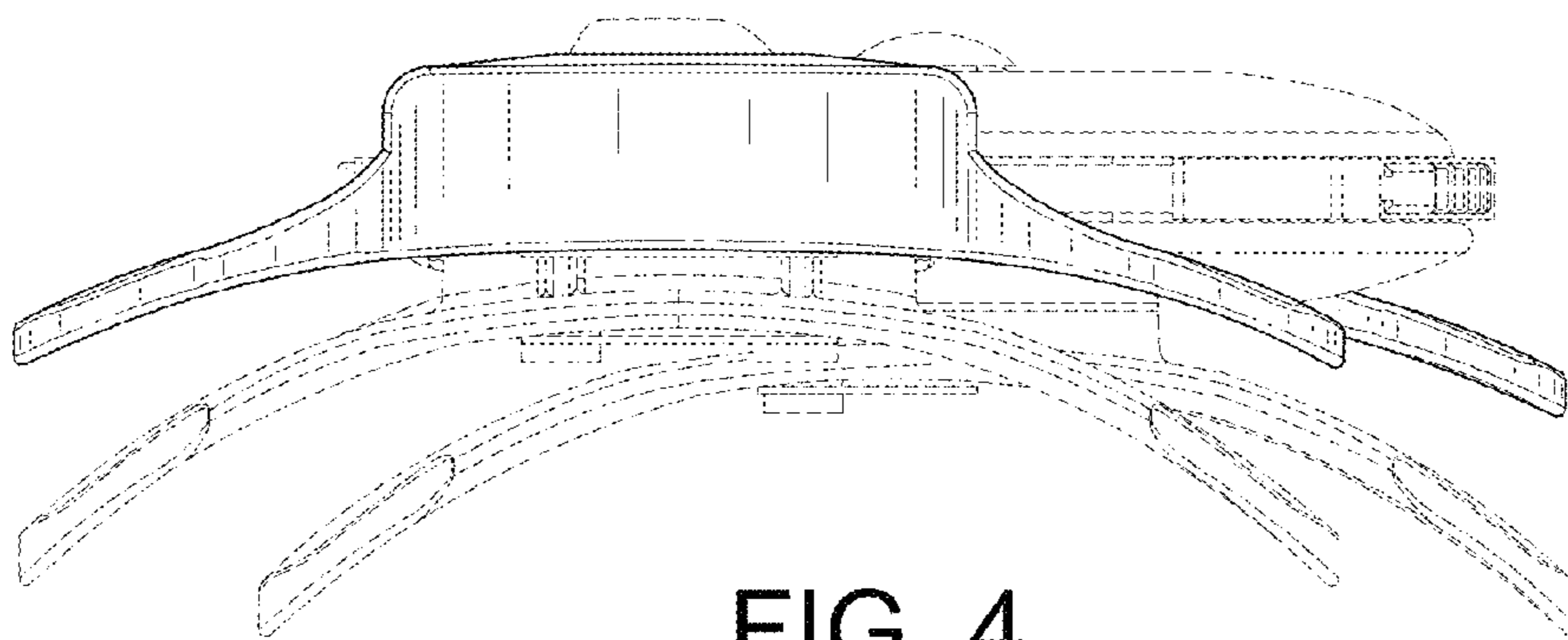
