(57) **CLAIM**

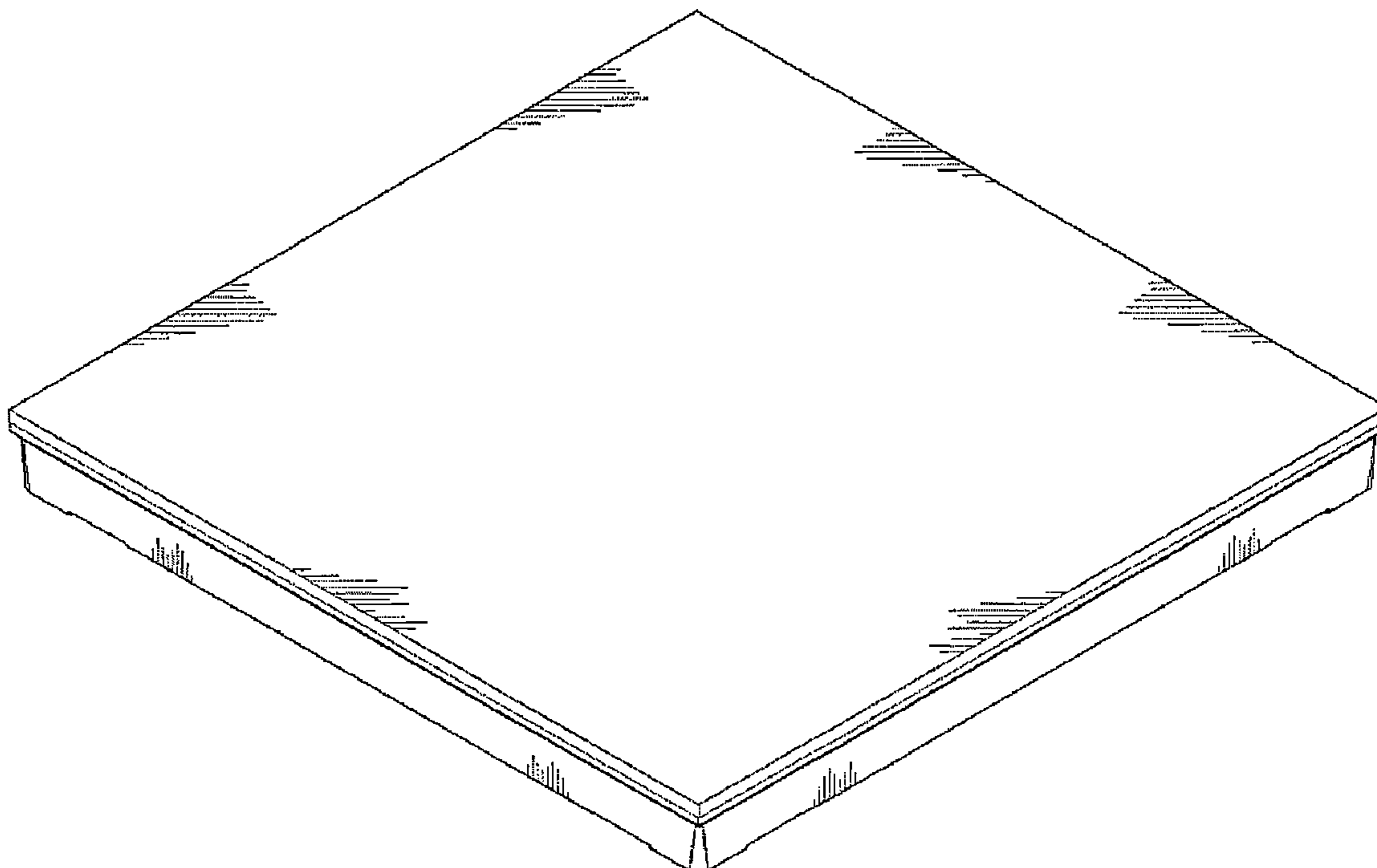
The ornamental design for a floor panel for a clean room, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a floor panel for a clean room showing my new design;

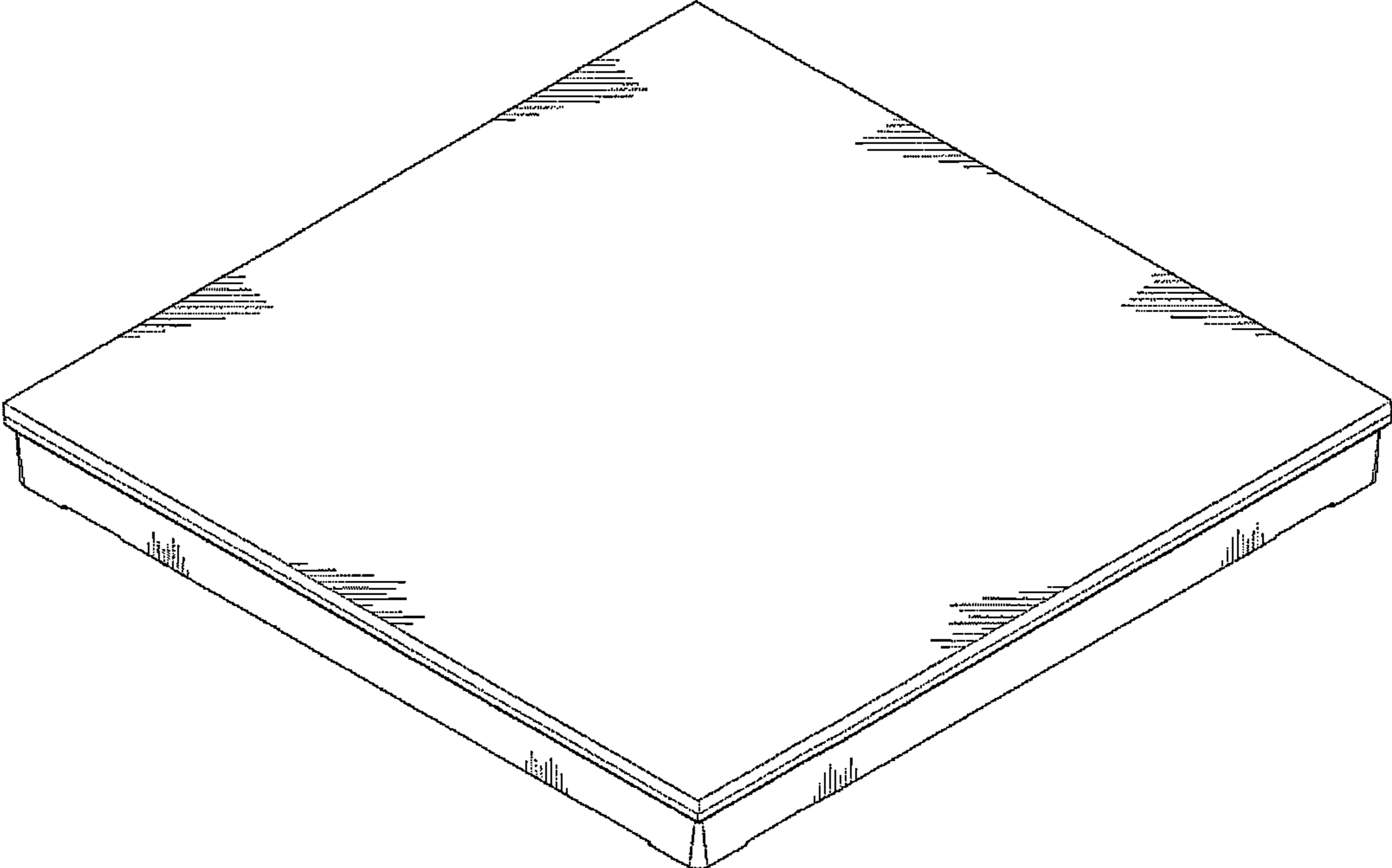

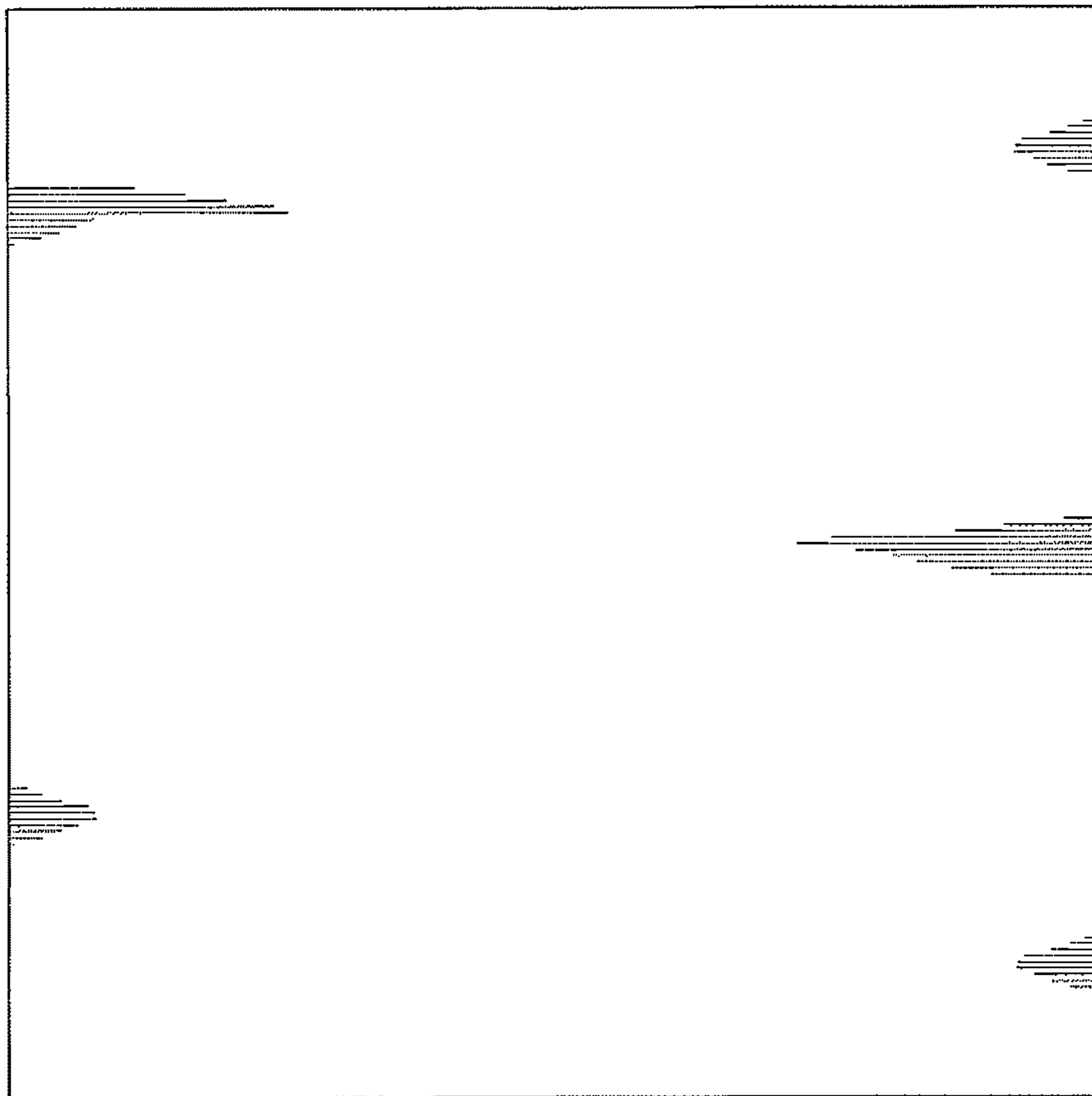

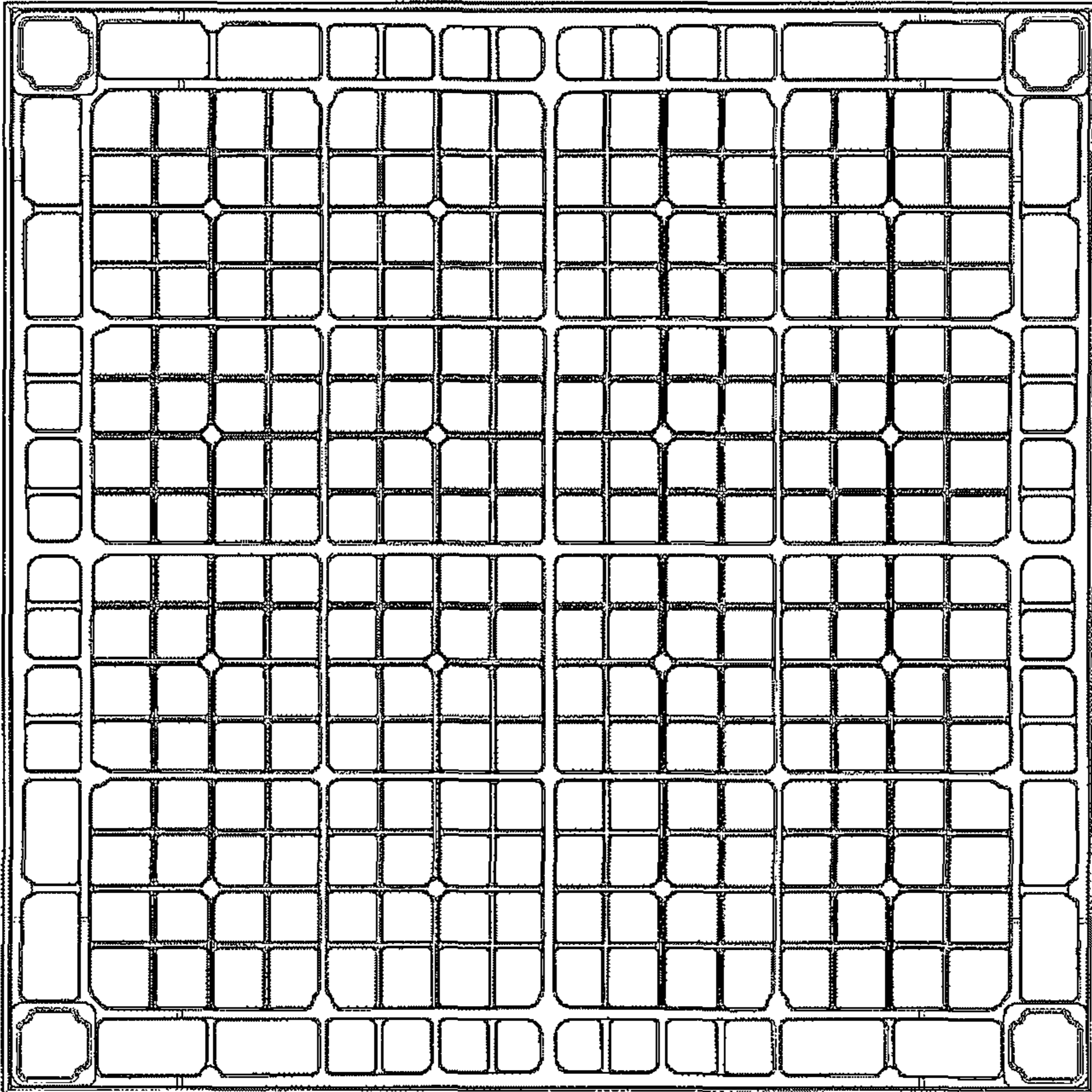

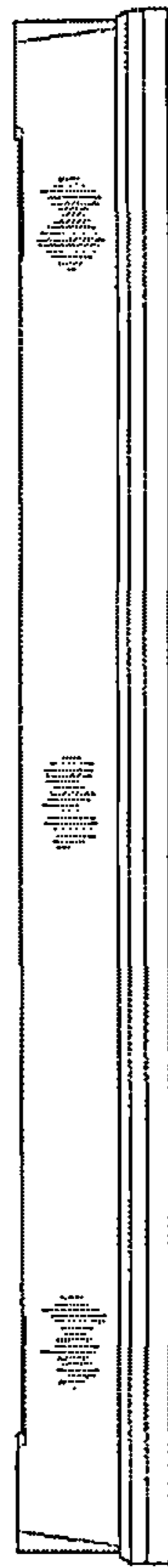

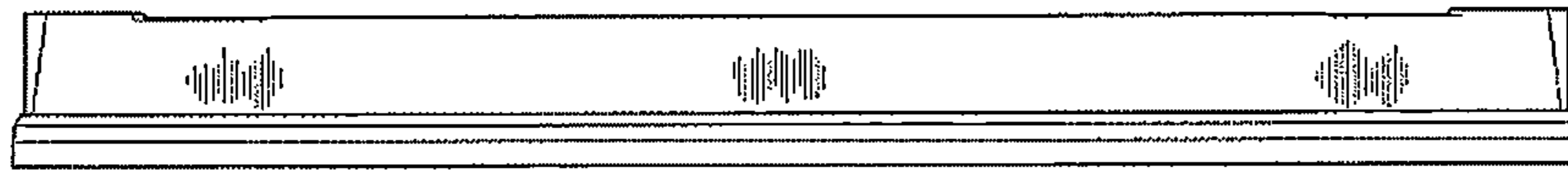

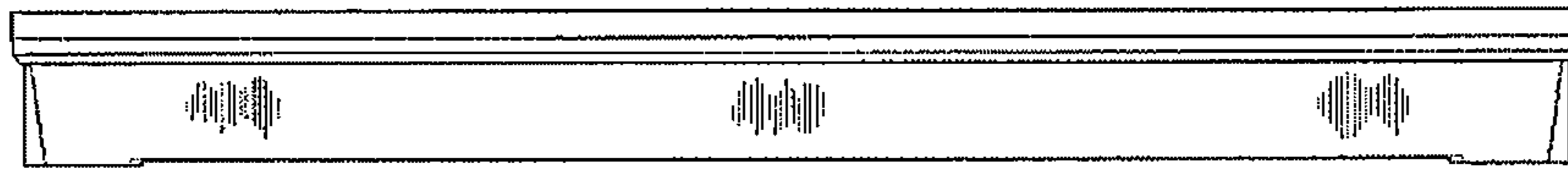

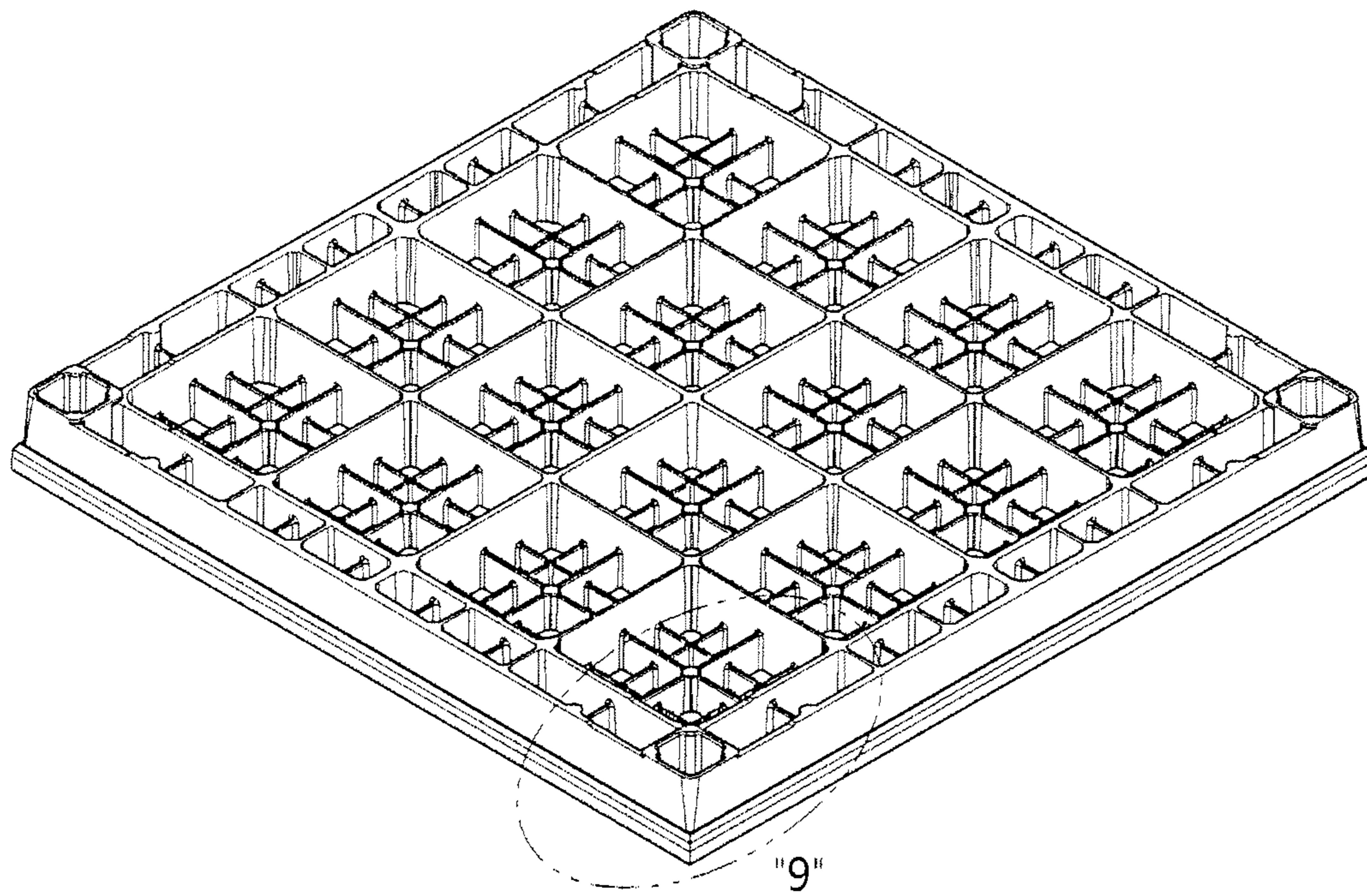

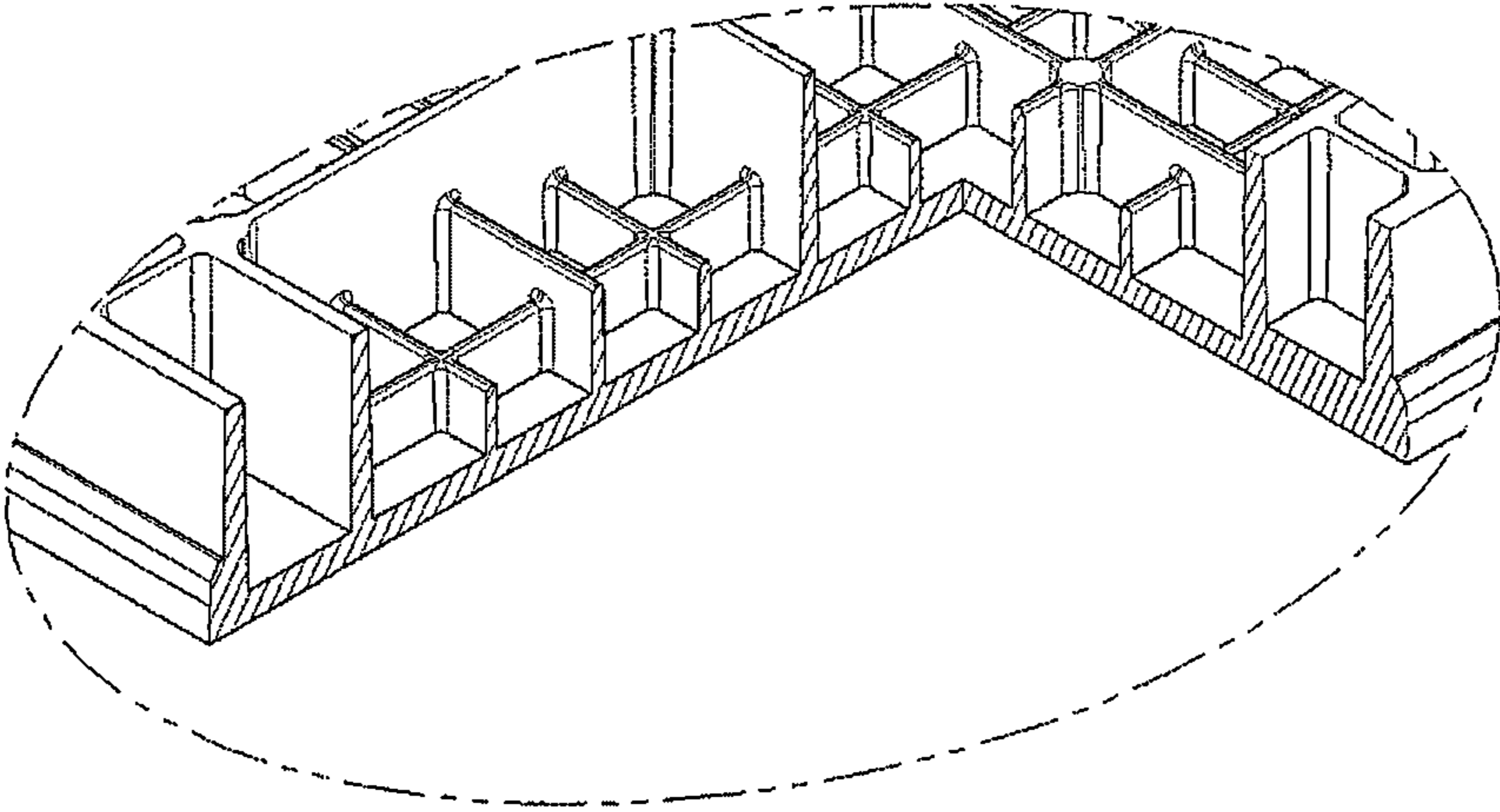
