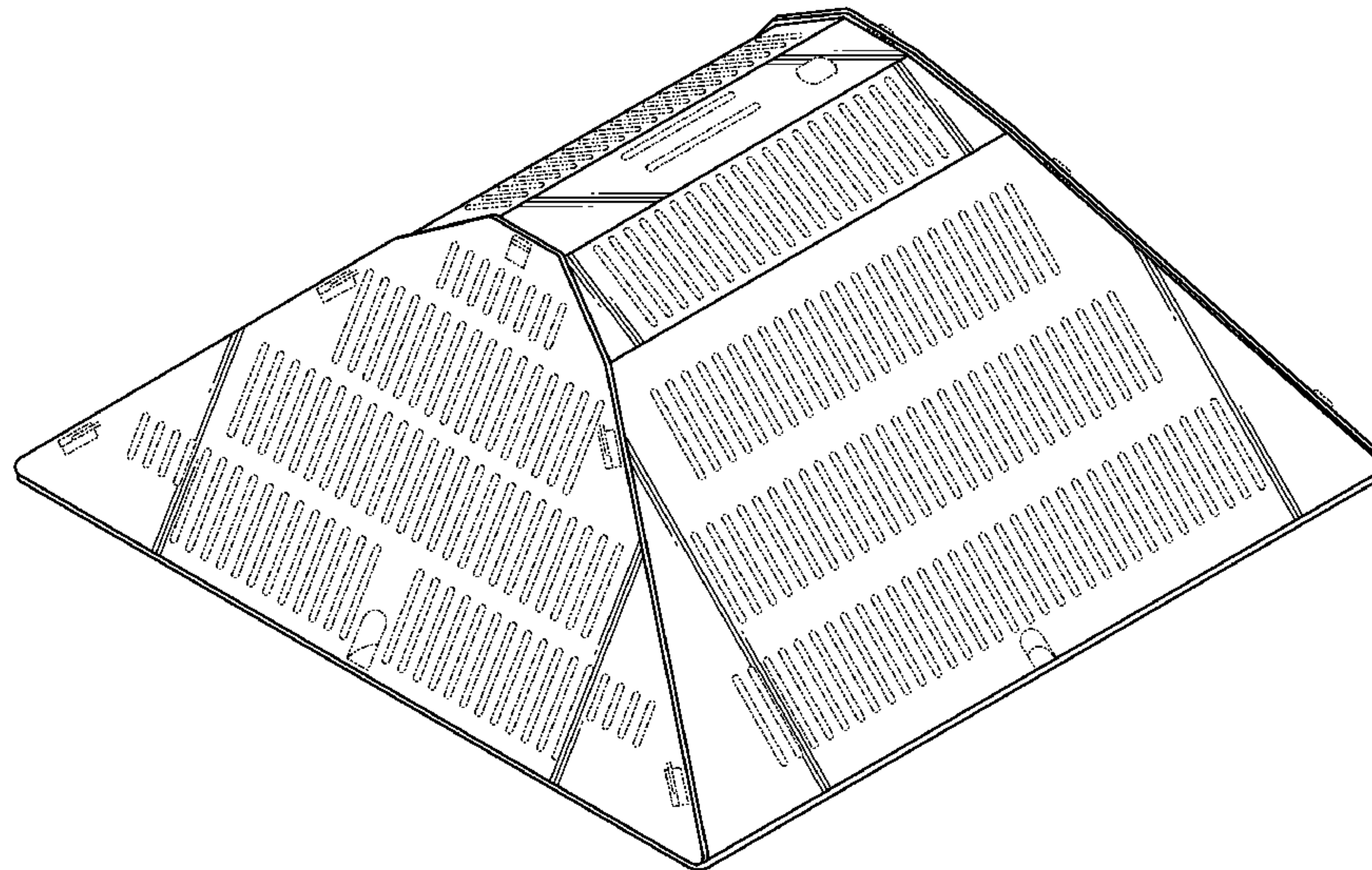
(57) **CLAIM**

The ornamental design for lighting, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of lighting showing the present design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a left side view thereof, the right side view being identical to the left side view; and,
FIG. 5 is a front view thereof, the rear view being identical to the front view.
Those portions of the present invention which are presented in phantom illustrate the environment of the design only and form no part of the claimed design. Moreover, the shading presented in the accompanying drawings is provided merely to highlight the contour of the invention and is not intended to be illustrative of texture or gloss.

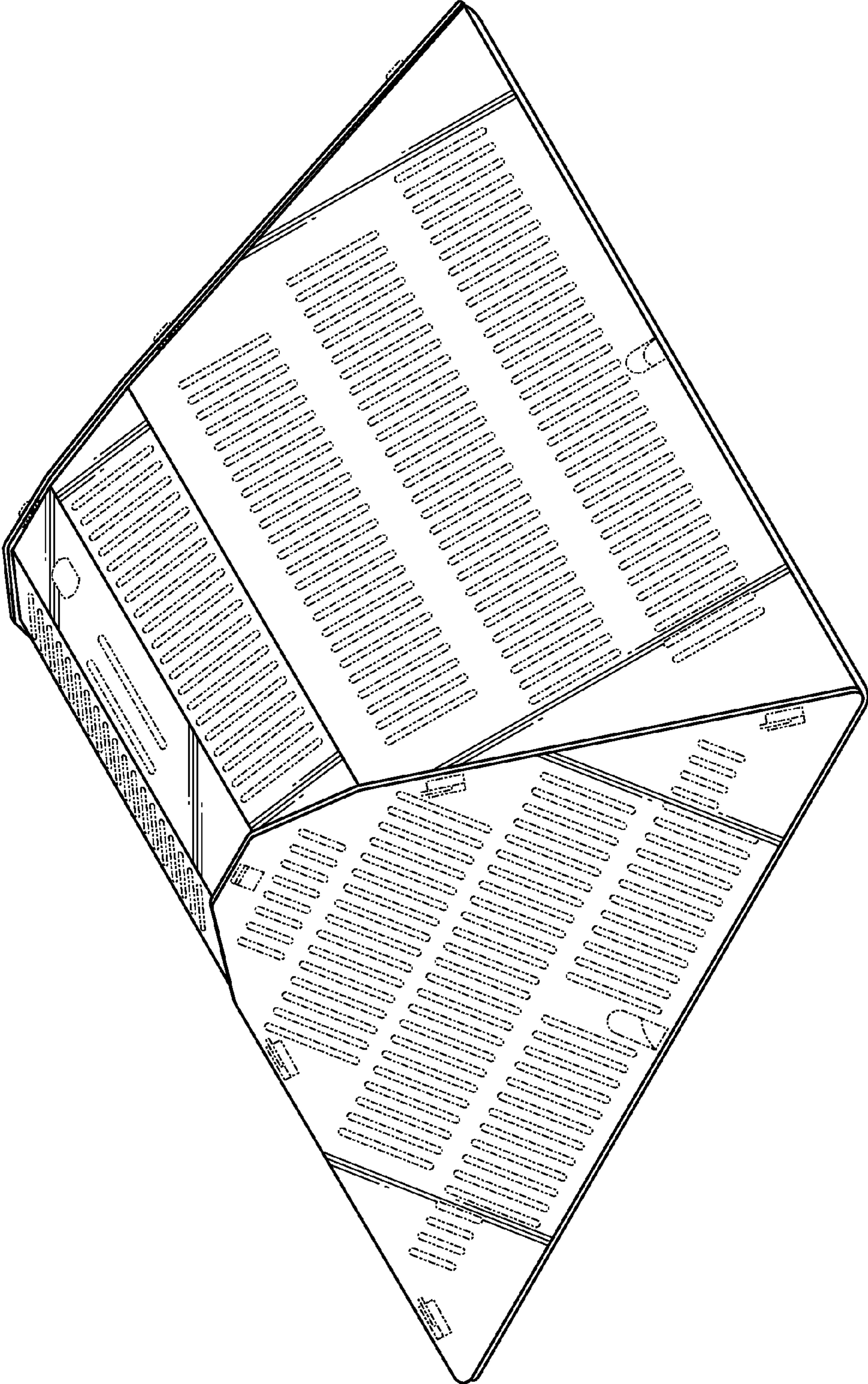

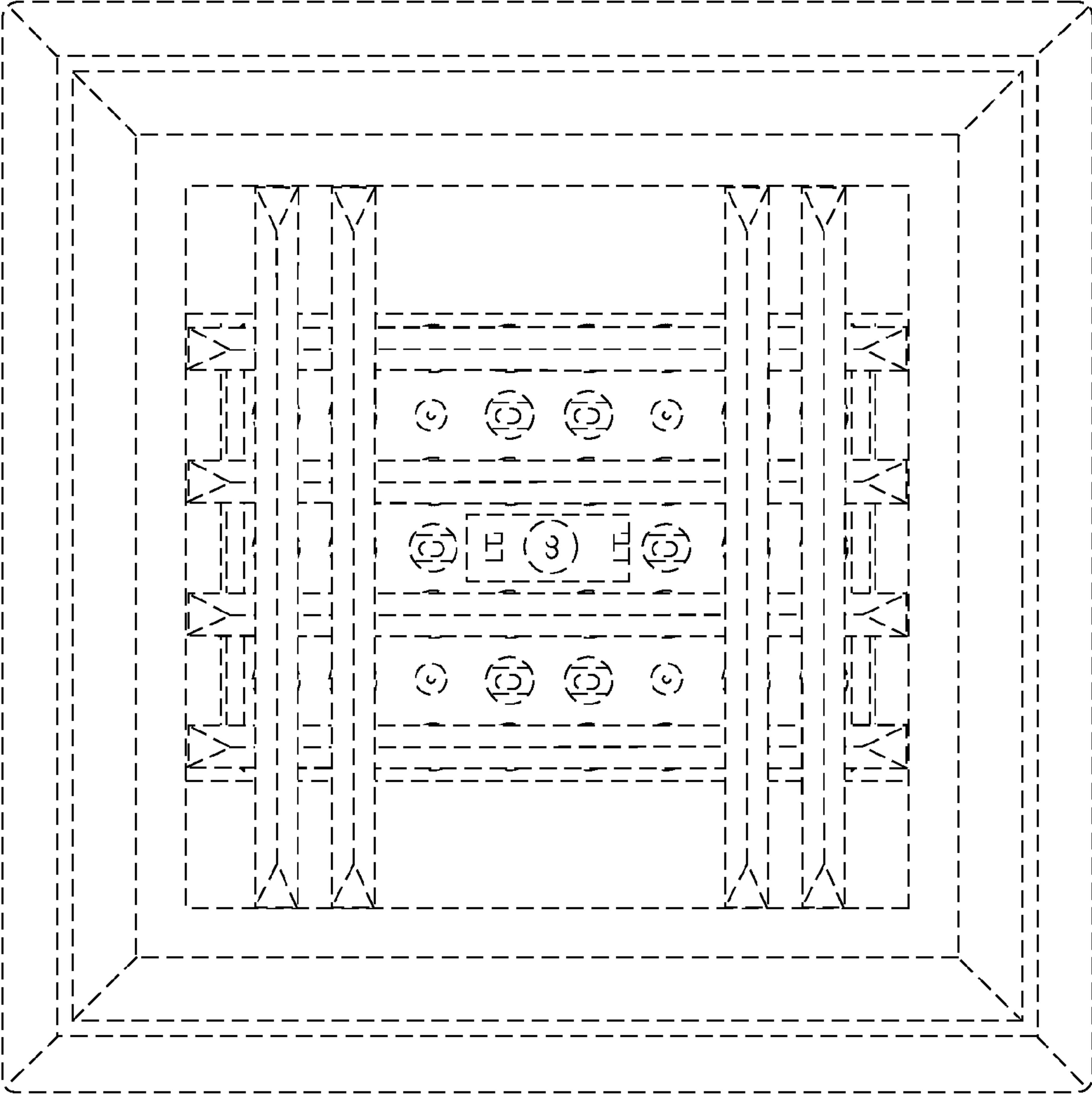

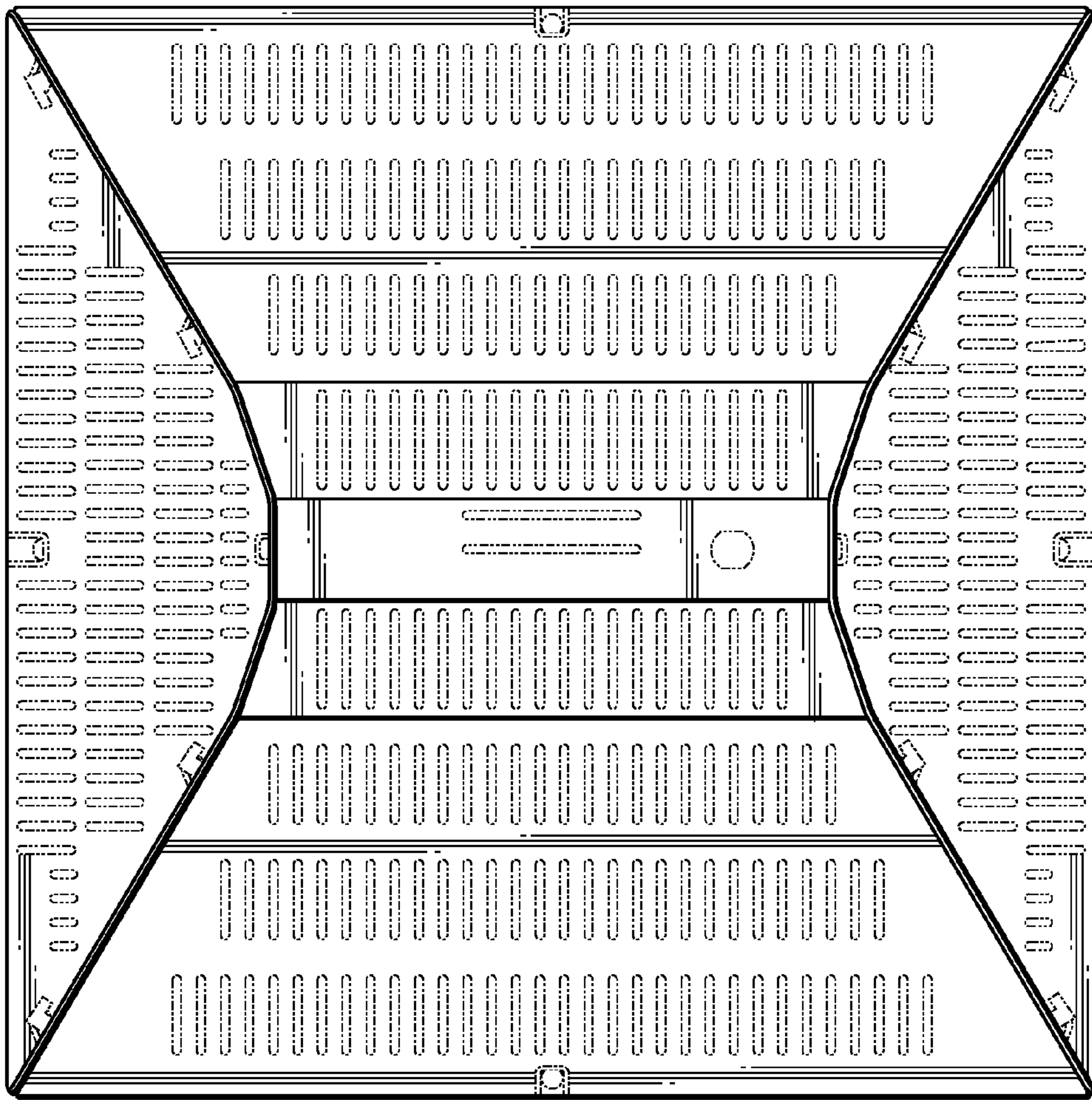

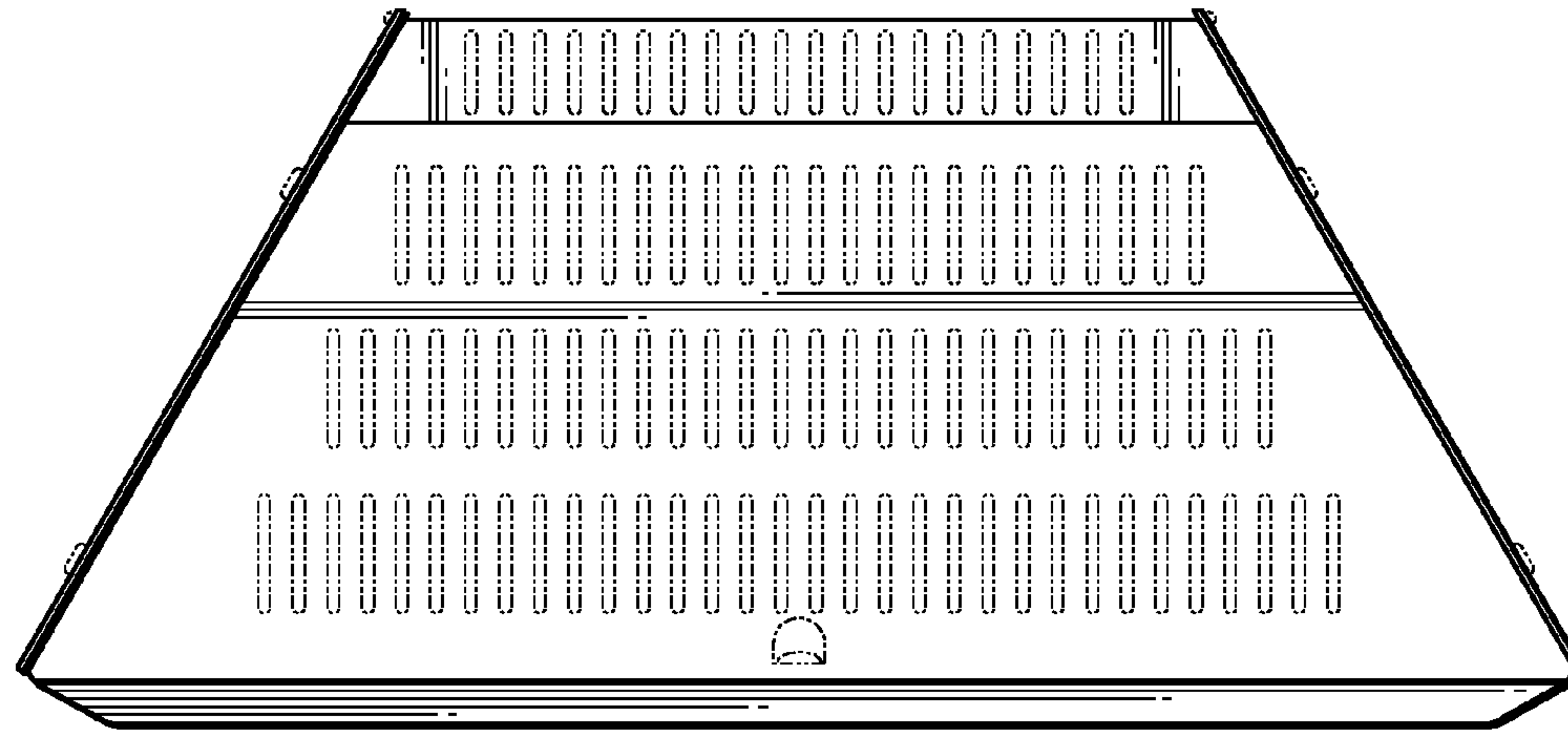

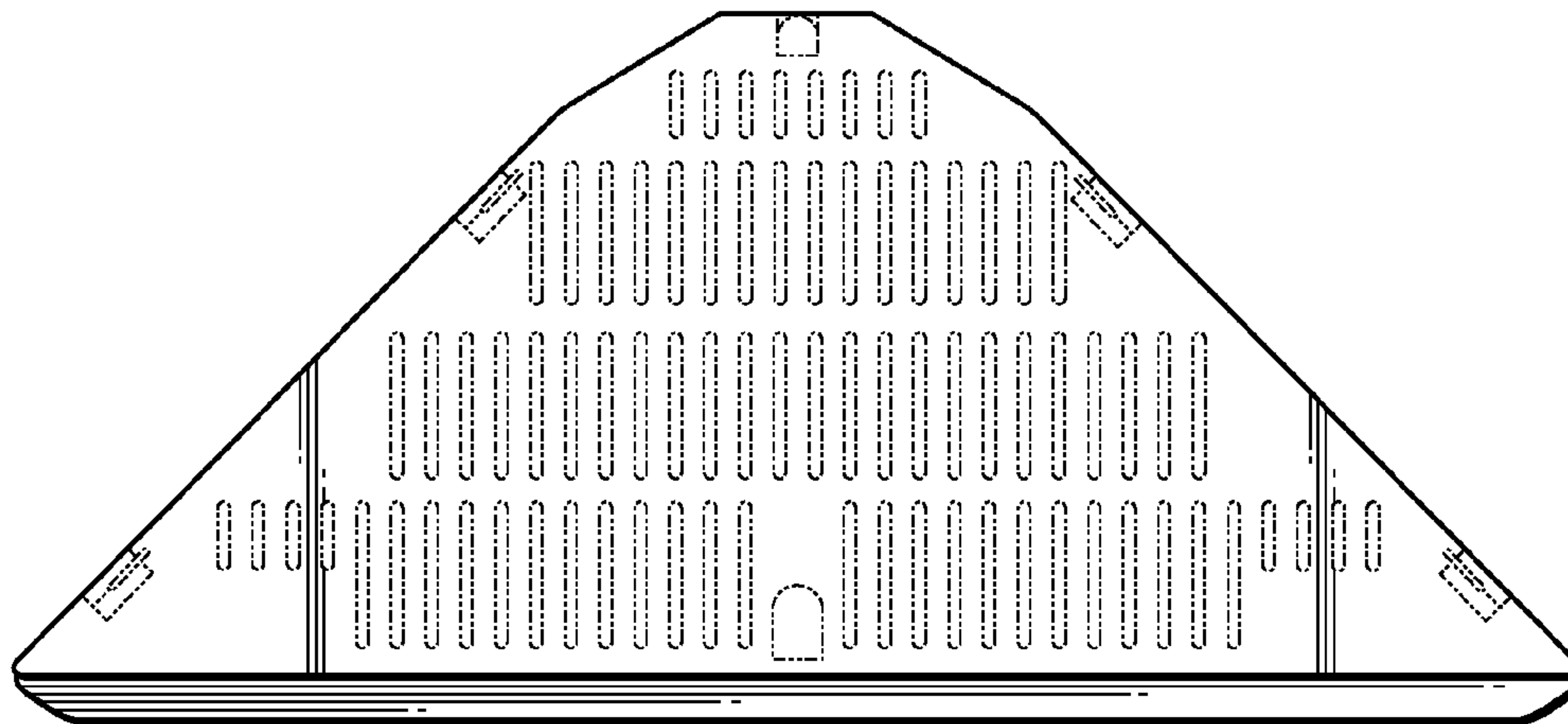
