(57) **CLAIM**

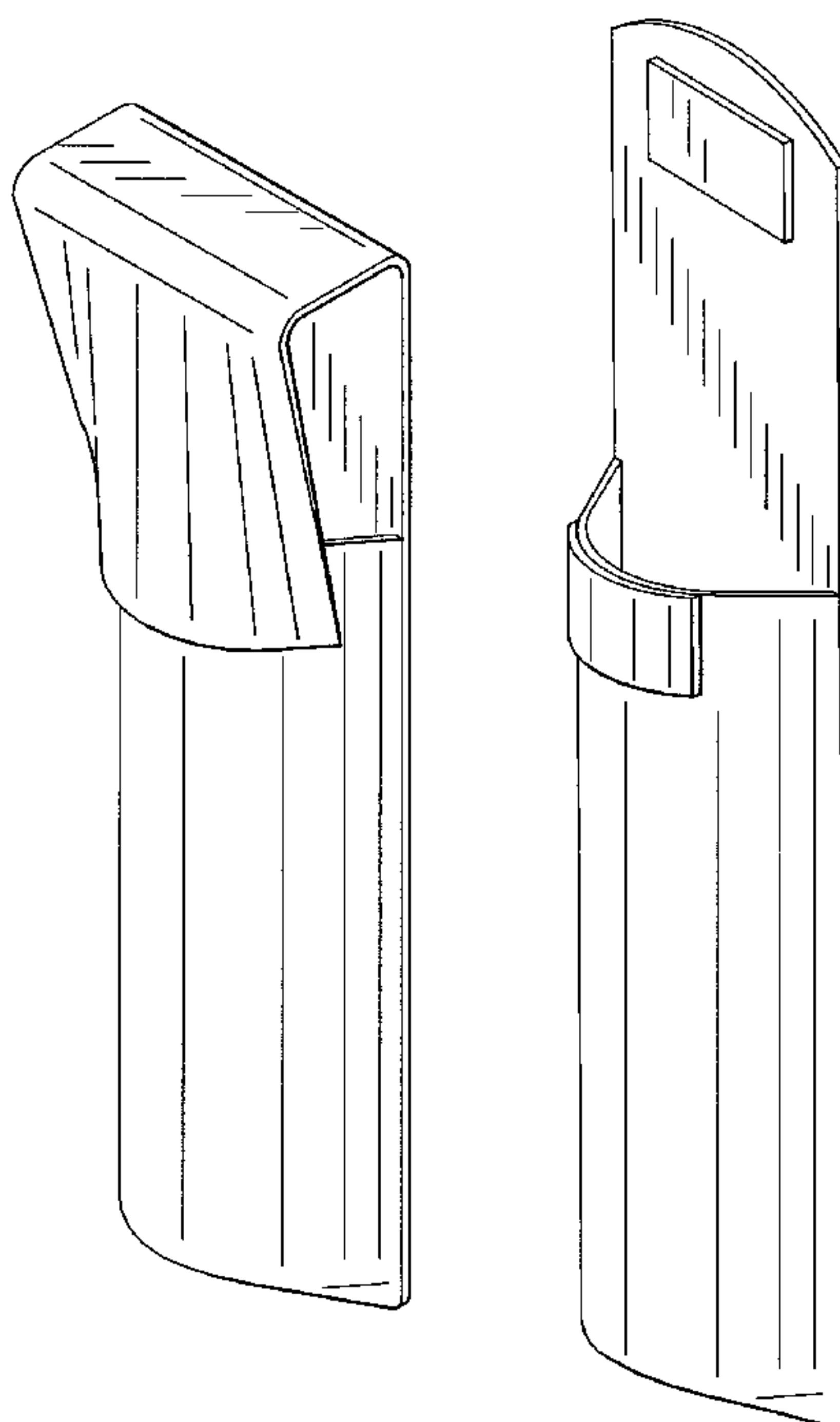
The ornamental design for an e-cigarette case, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an e-cigarette case showing my new design;  
FIG. 2 is another perspective view of an e-cigarette case as in FIG. 1 showing the case in an open configuration;  
FIG. 3 is a front view thereof;  
FIG. 4 is a back side view thereof;  
FIG. 5 is a right side view thereof;

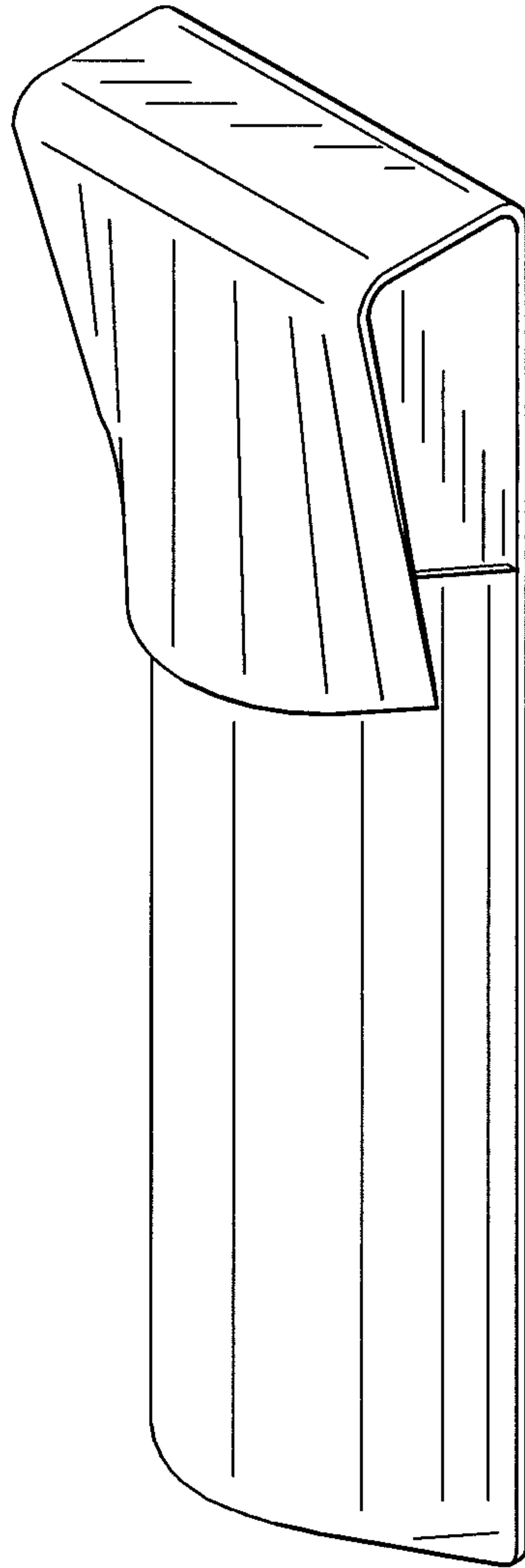

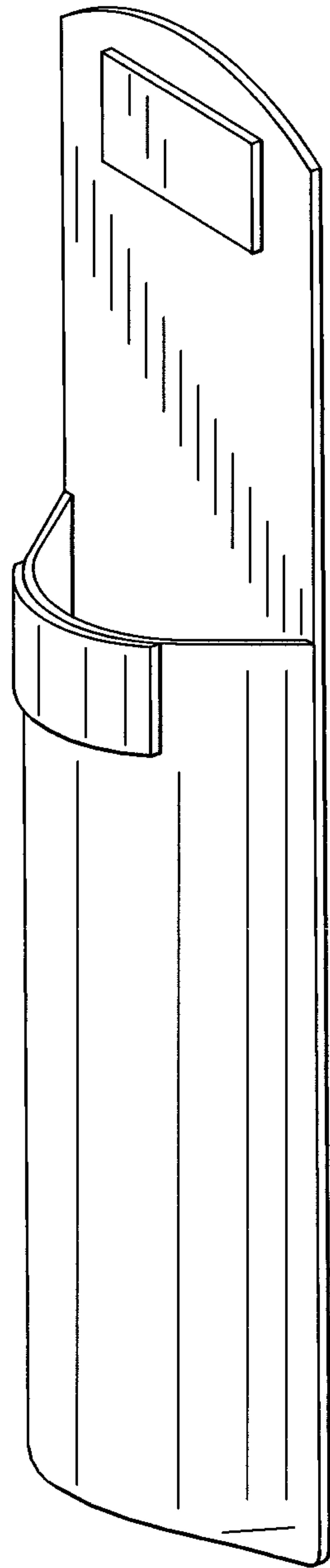

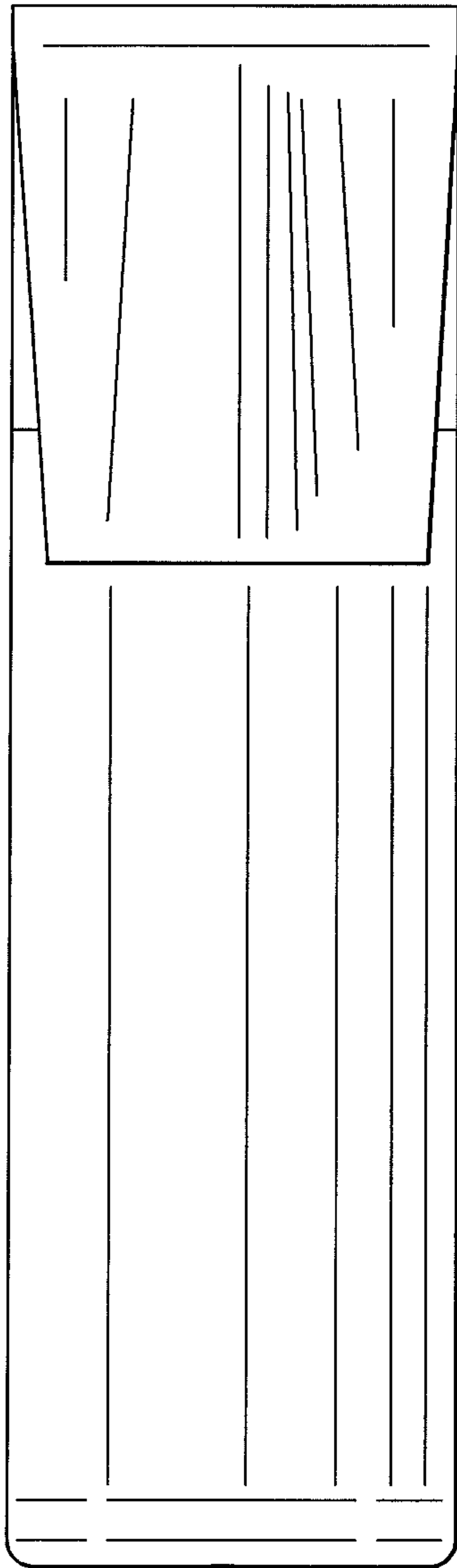

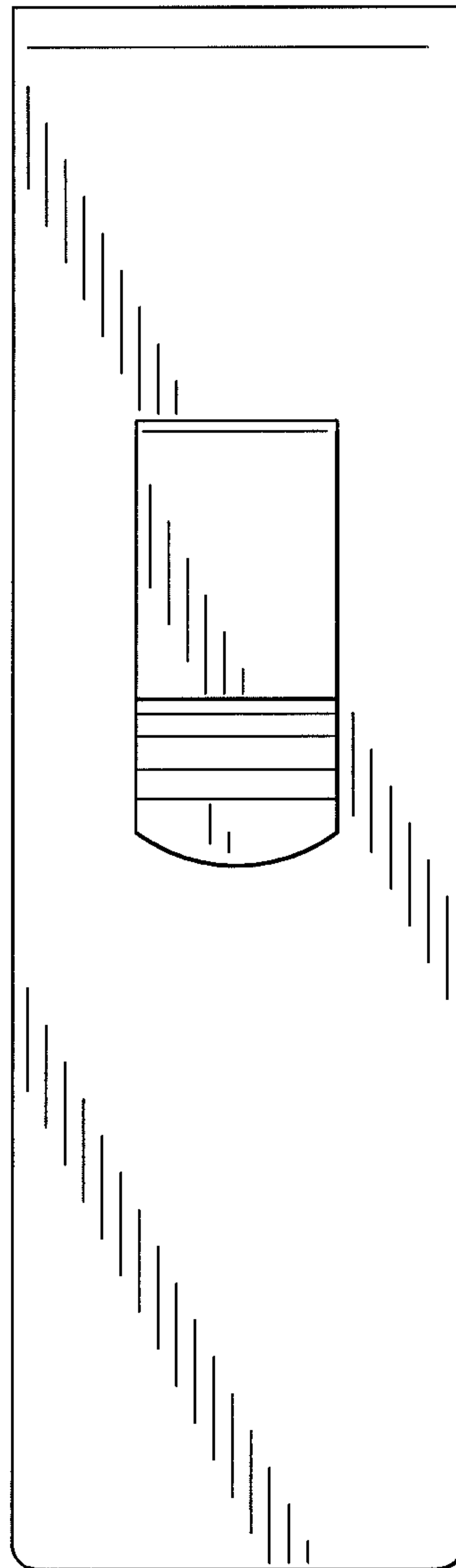

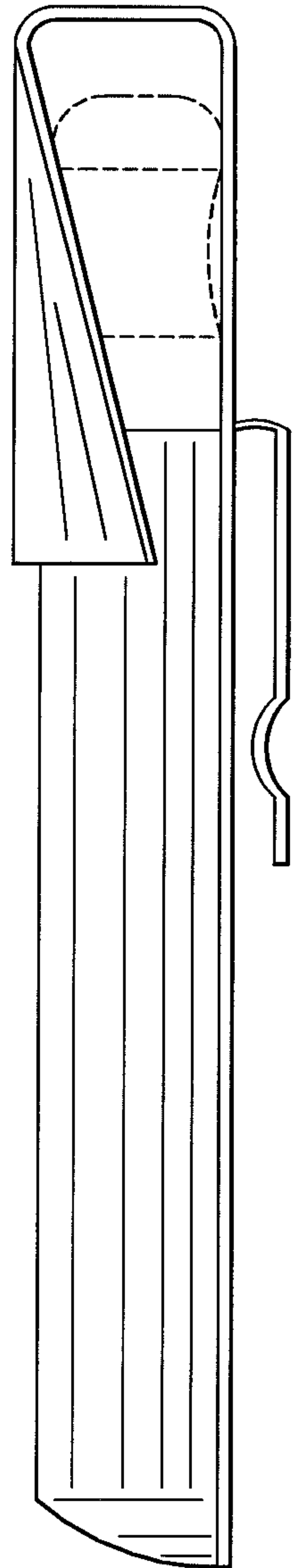

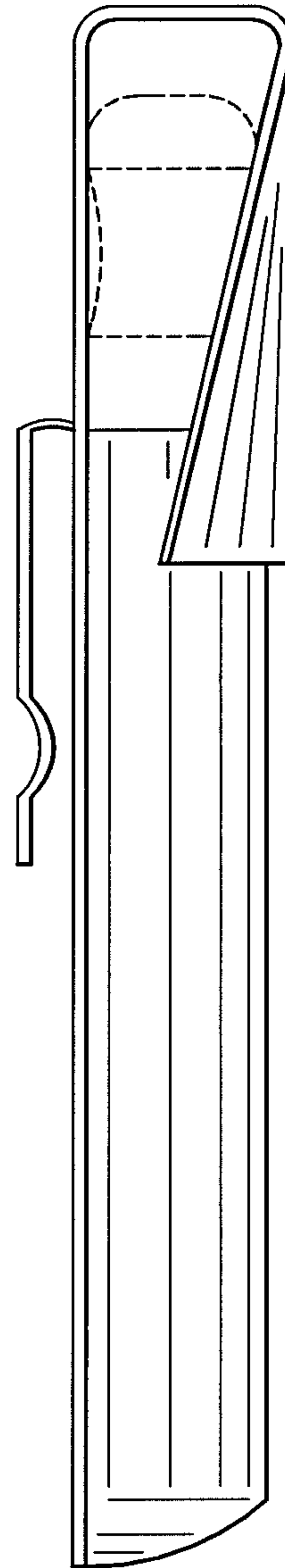

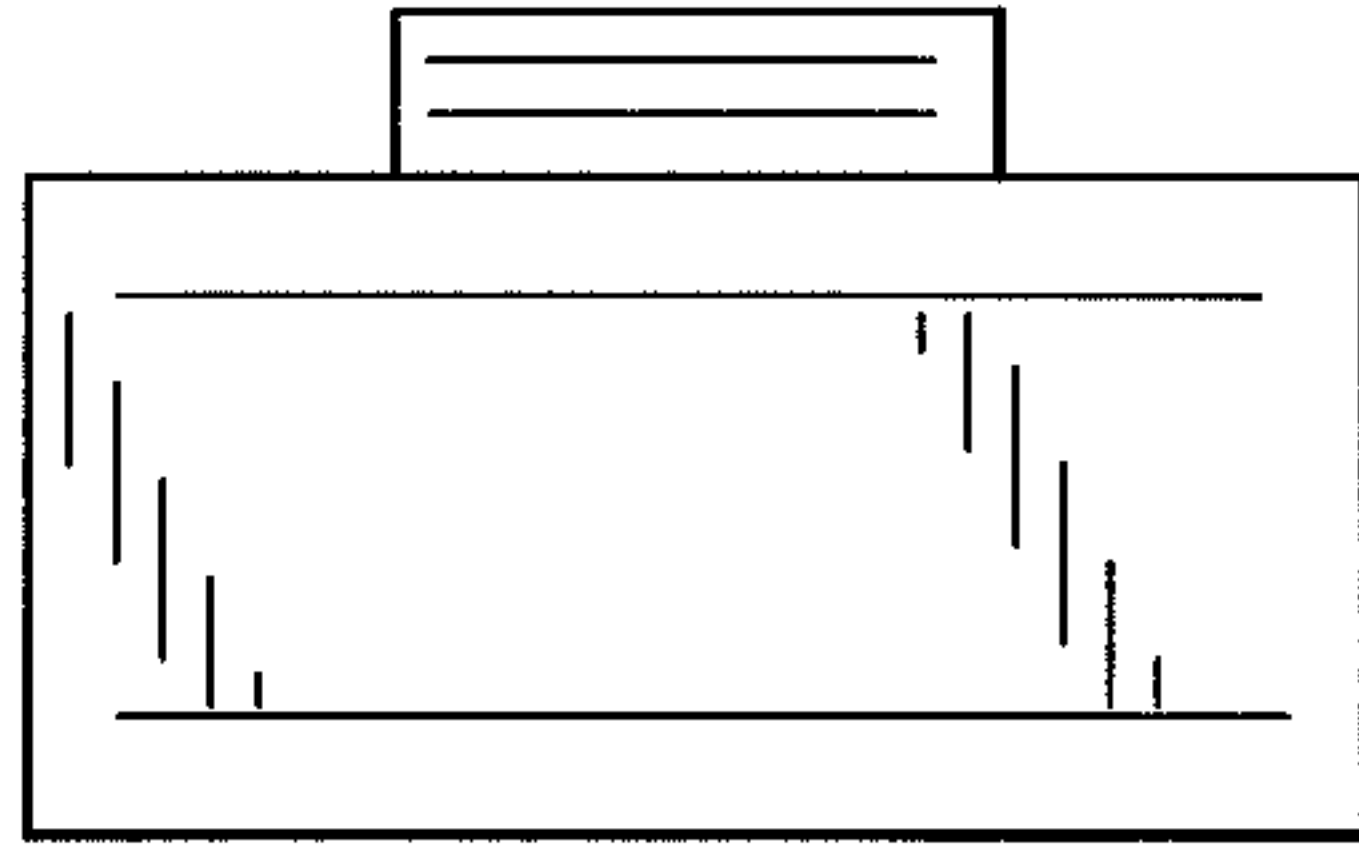

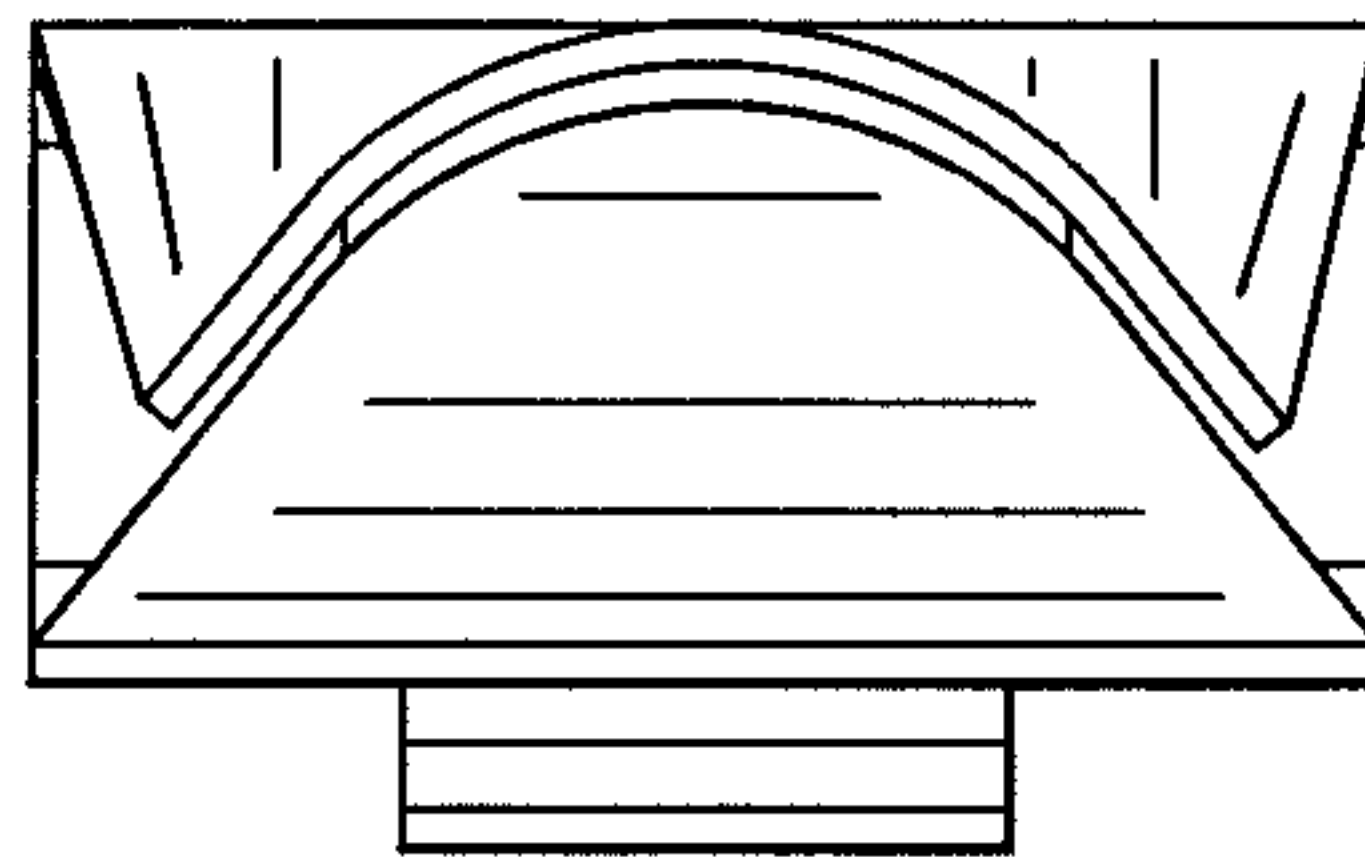
