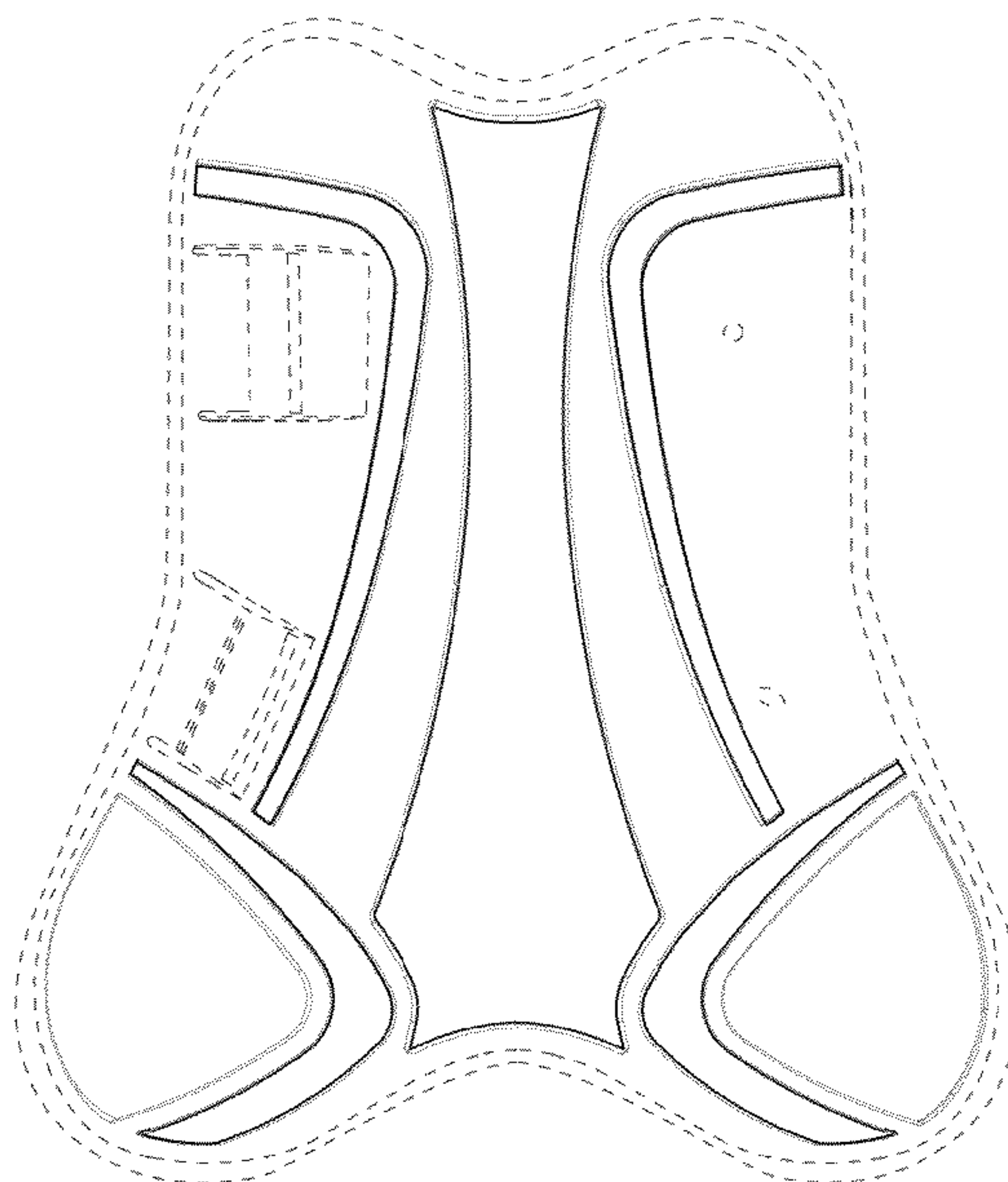
(57) **CLAIM**

The ornamental design for joint protector for horses with surface features, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of surface features for joint protectors for horses showing my new design;  
FIG. 2 is a right side perspective view, the opposite side being a mirror image thereof; and,  
FIG. 3 is a bottom left perspective view thereof.  
The broken line showing of structural elements is included for the purpose of illustrating environment that forms no part of the claimed design.

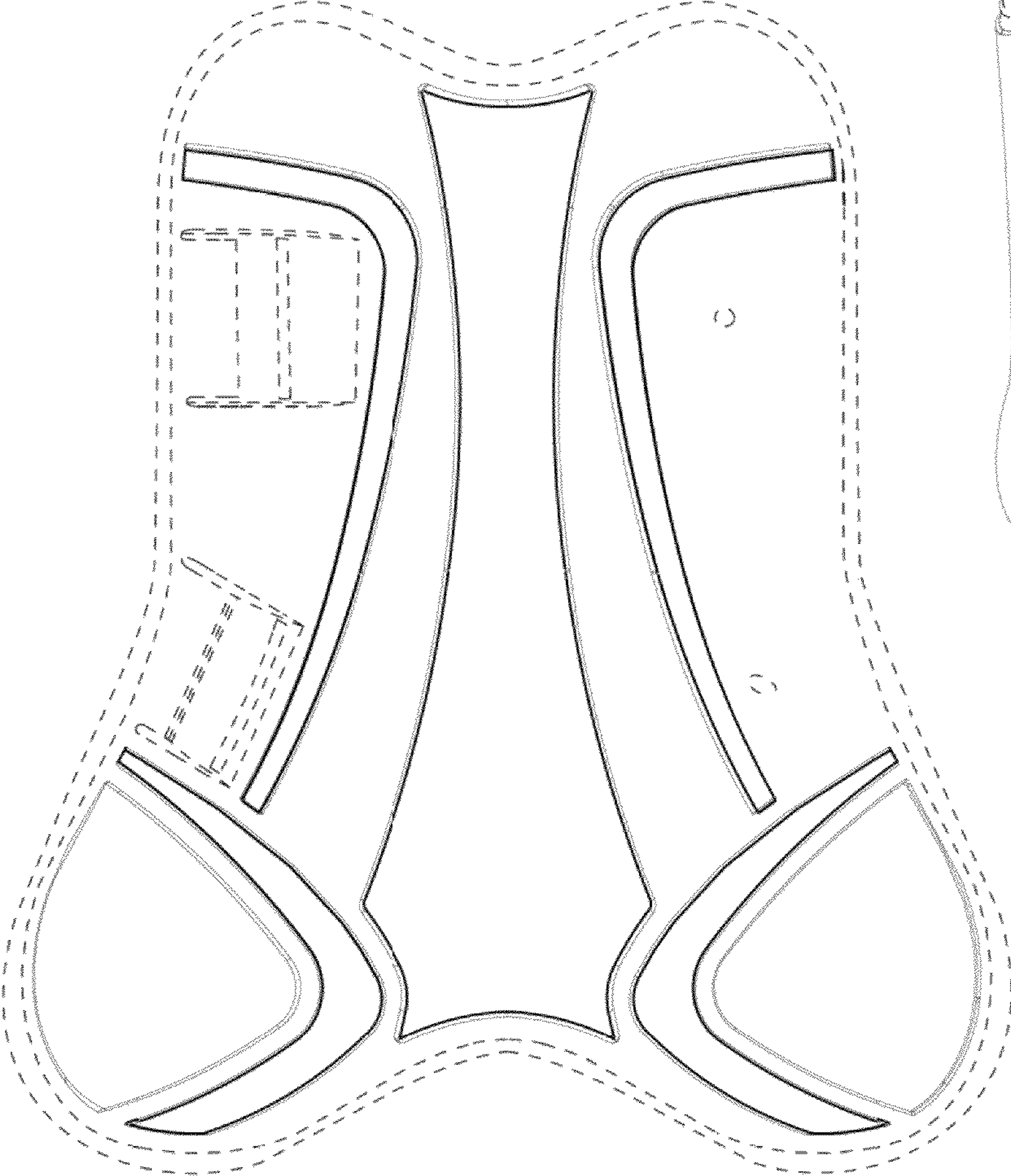

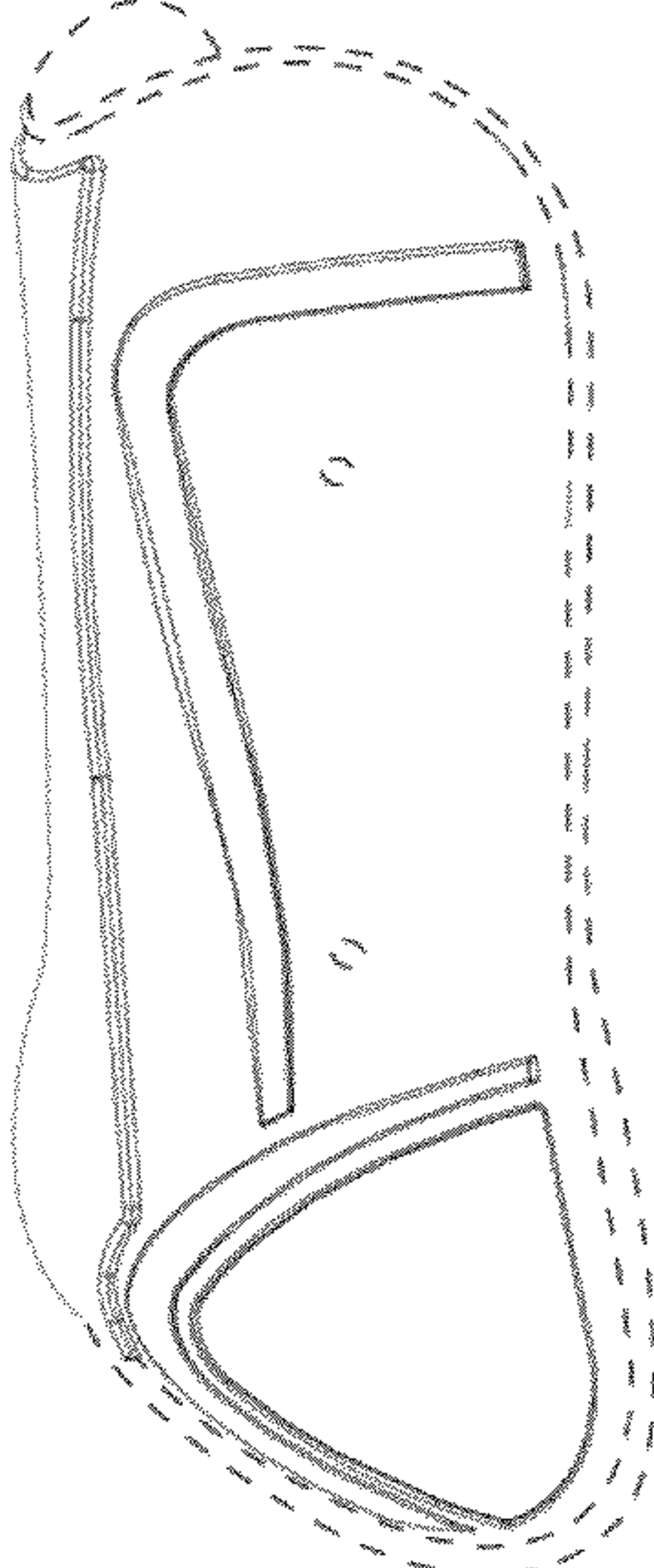
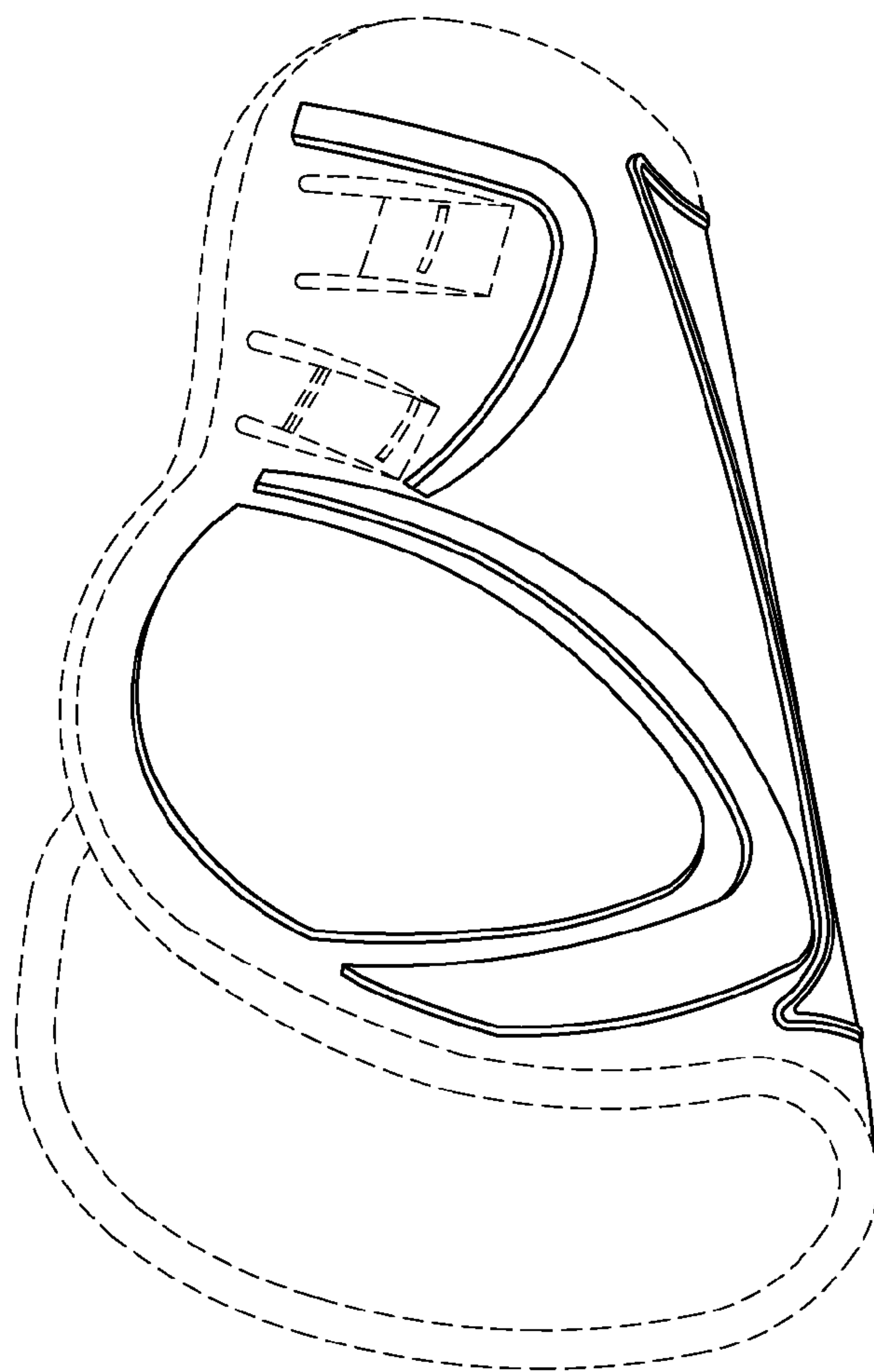
