**DESCRIPTION**

FIG. 21 is a front view of the cross wrap of FIG. 20;

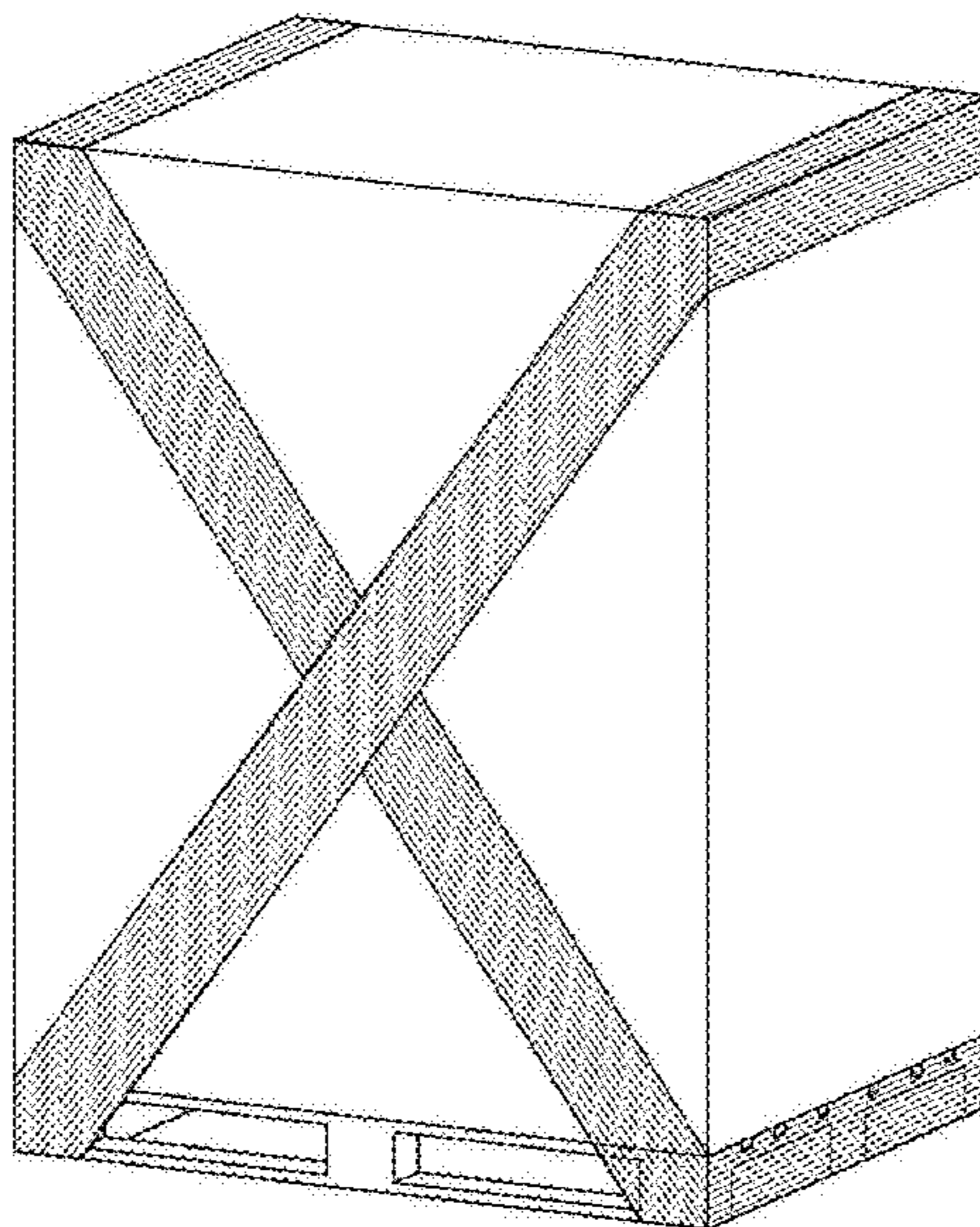
FIG. 22 is a right side view of the cross wrap of FIG. 20;

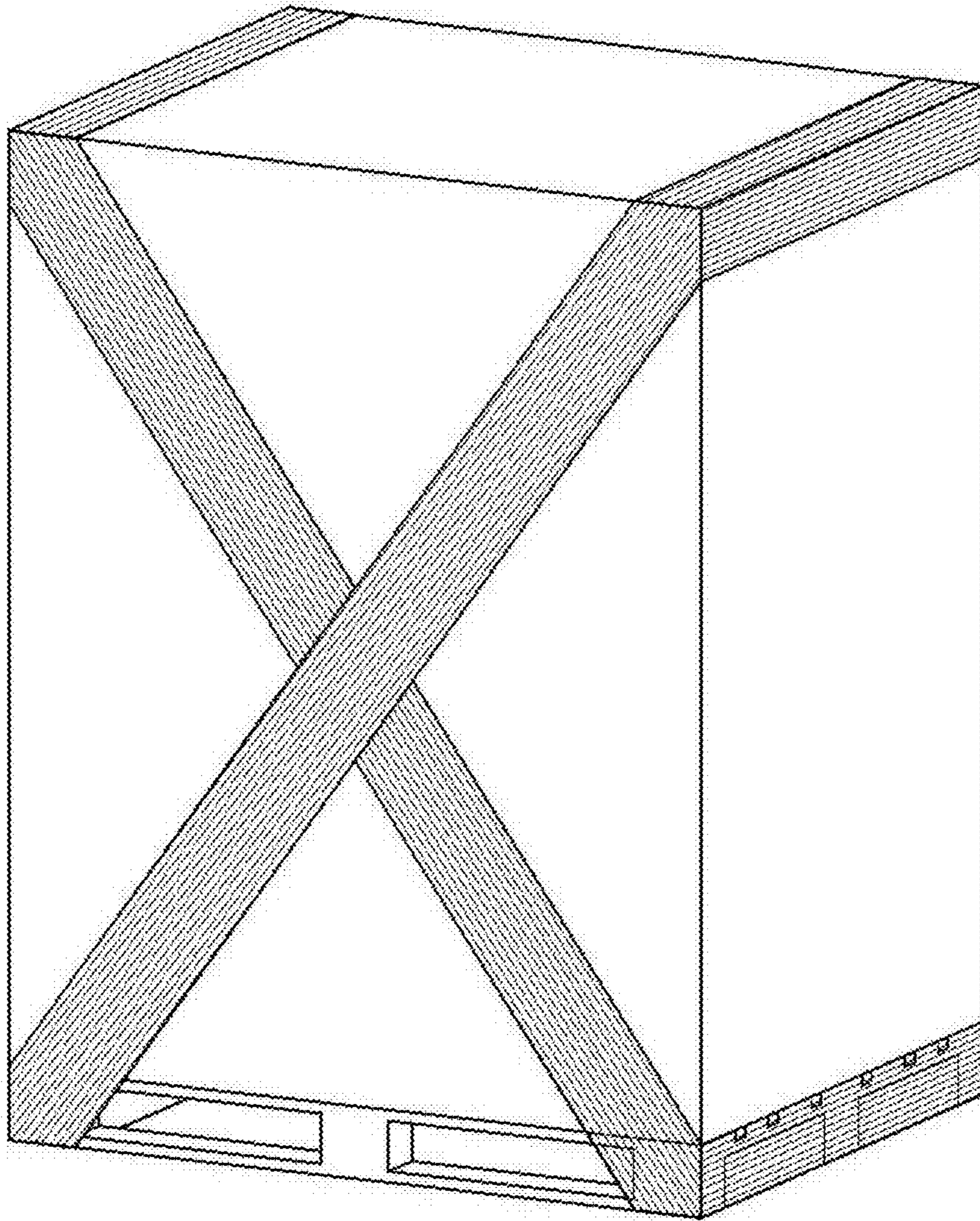

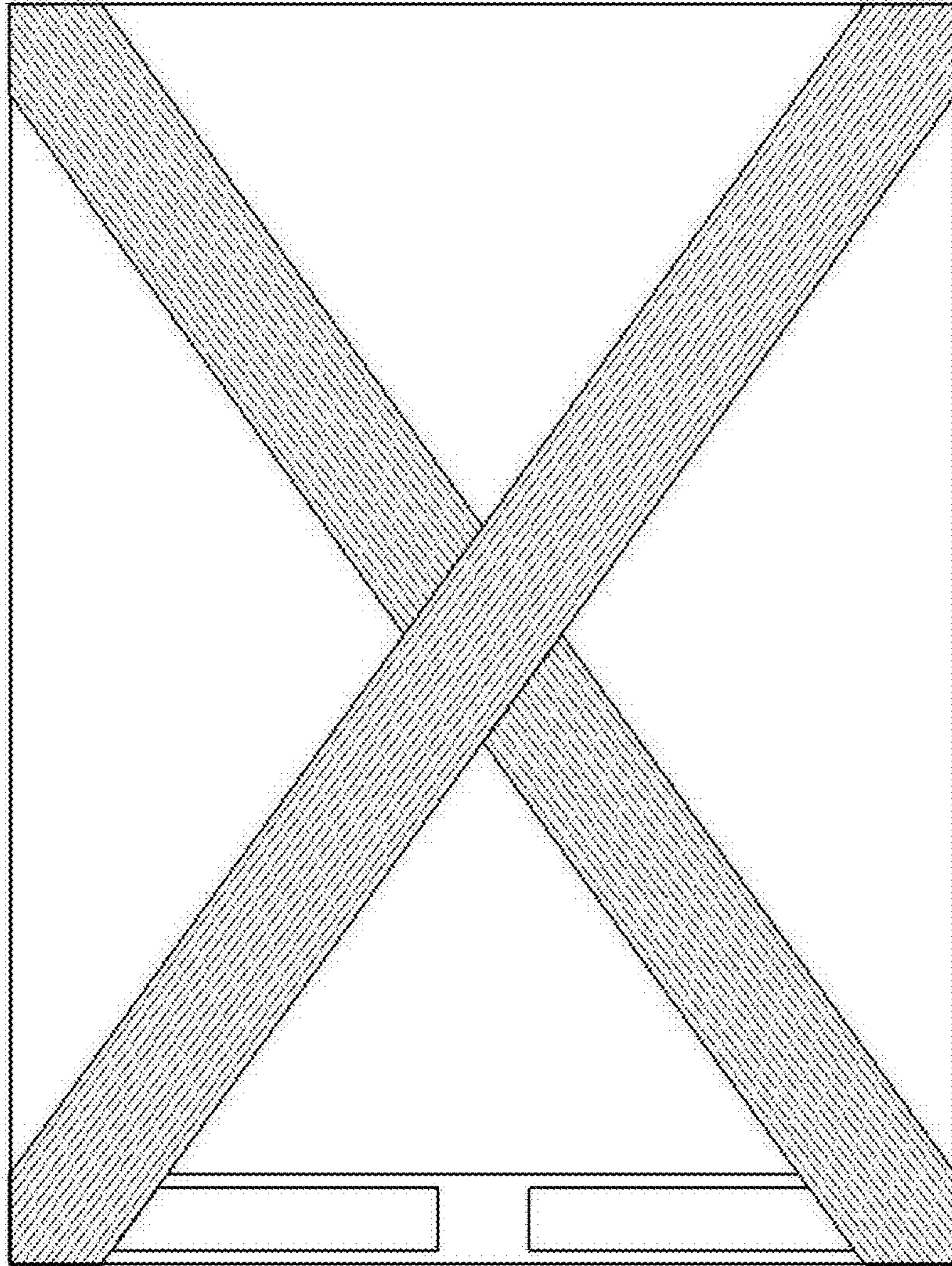

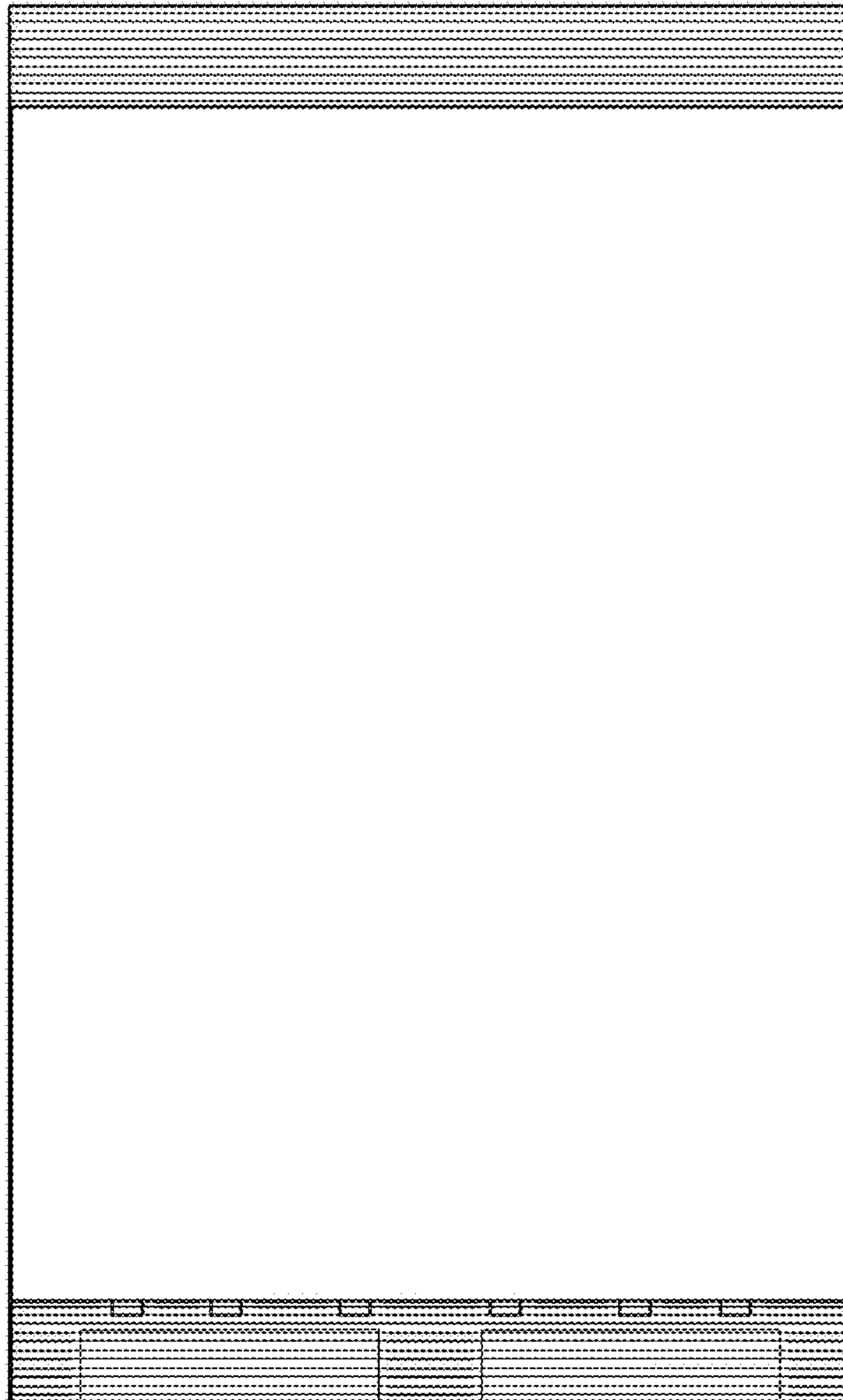

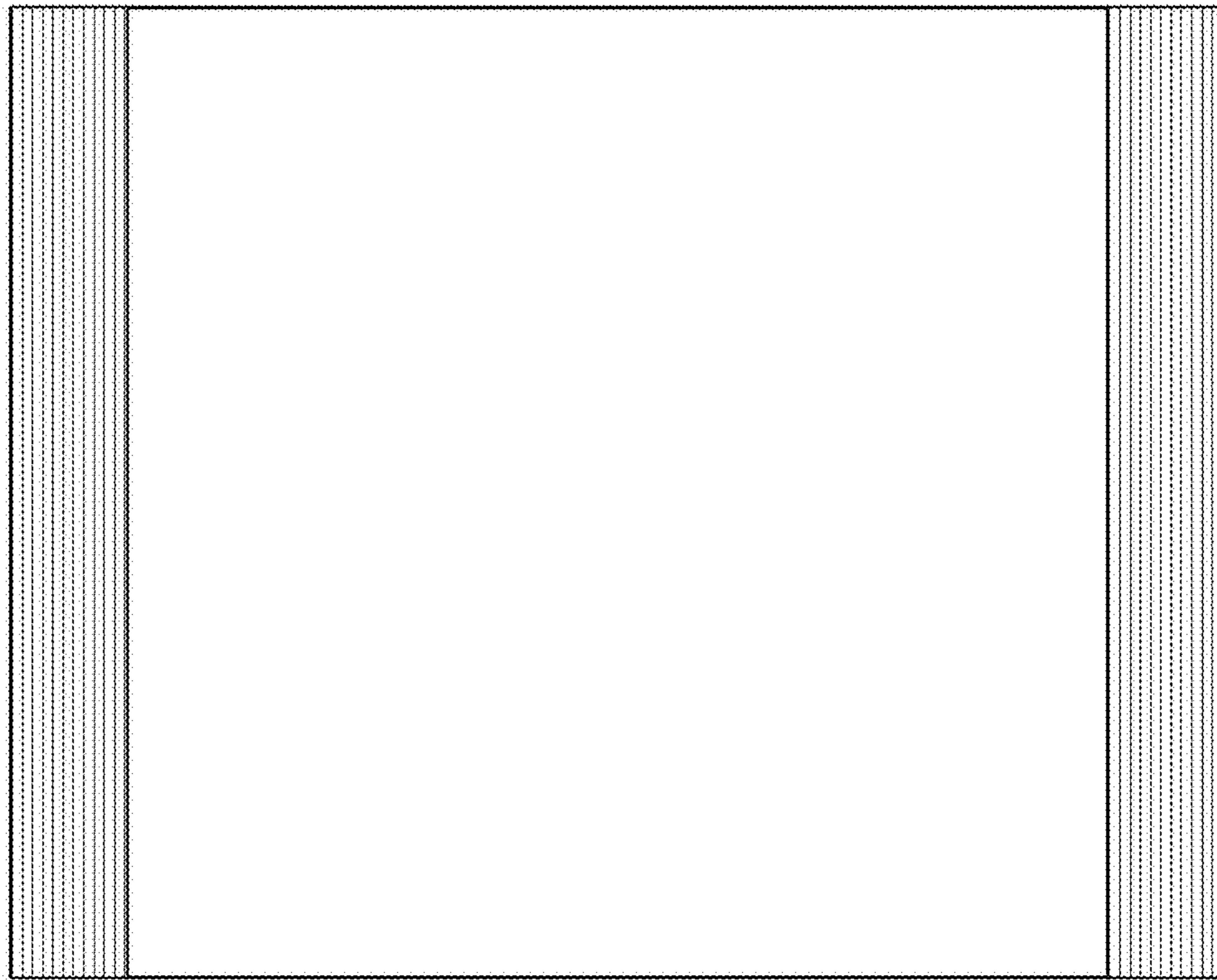

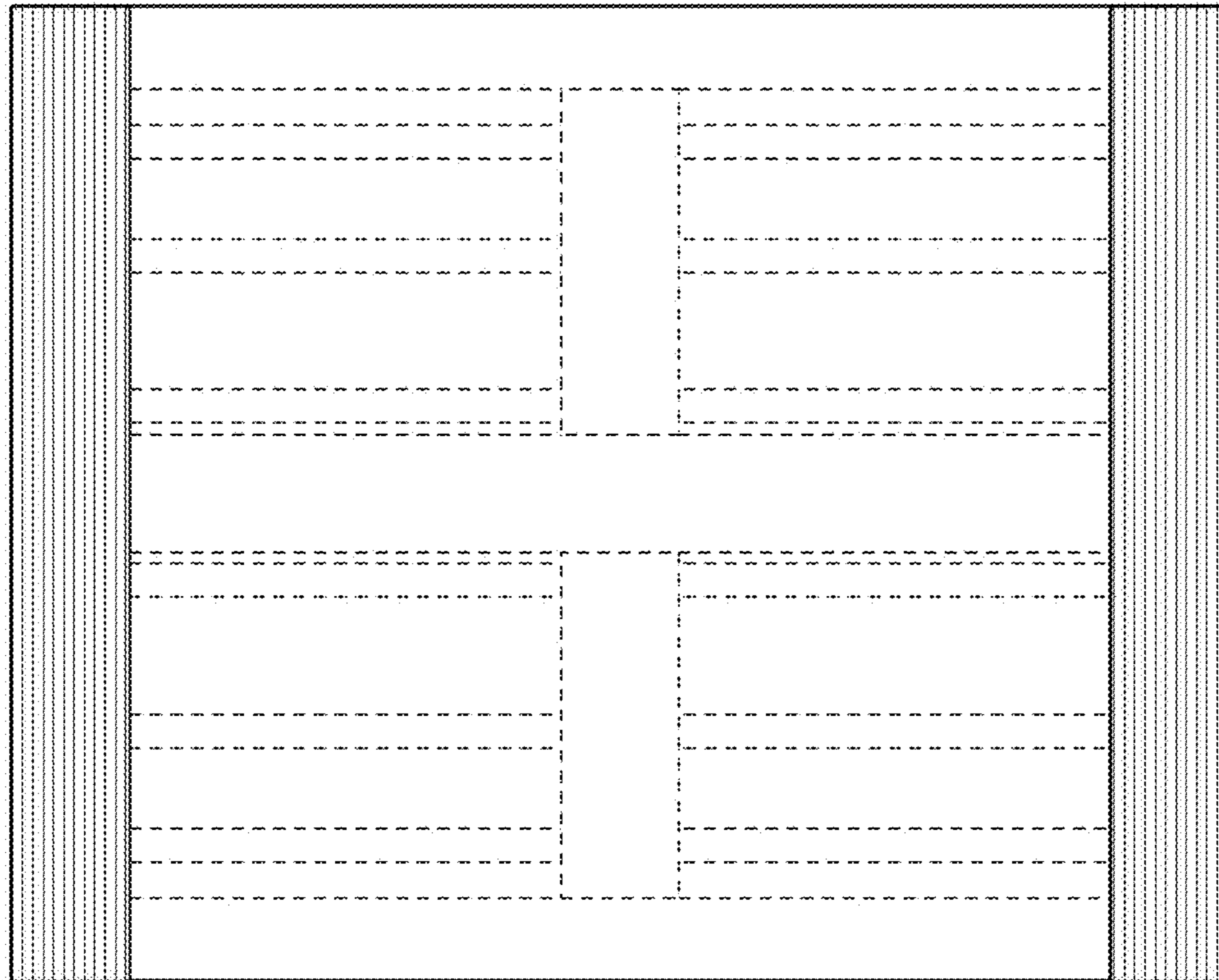

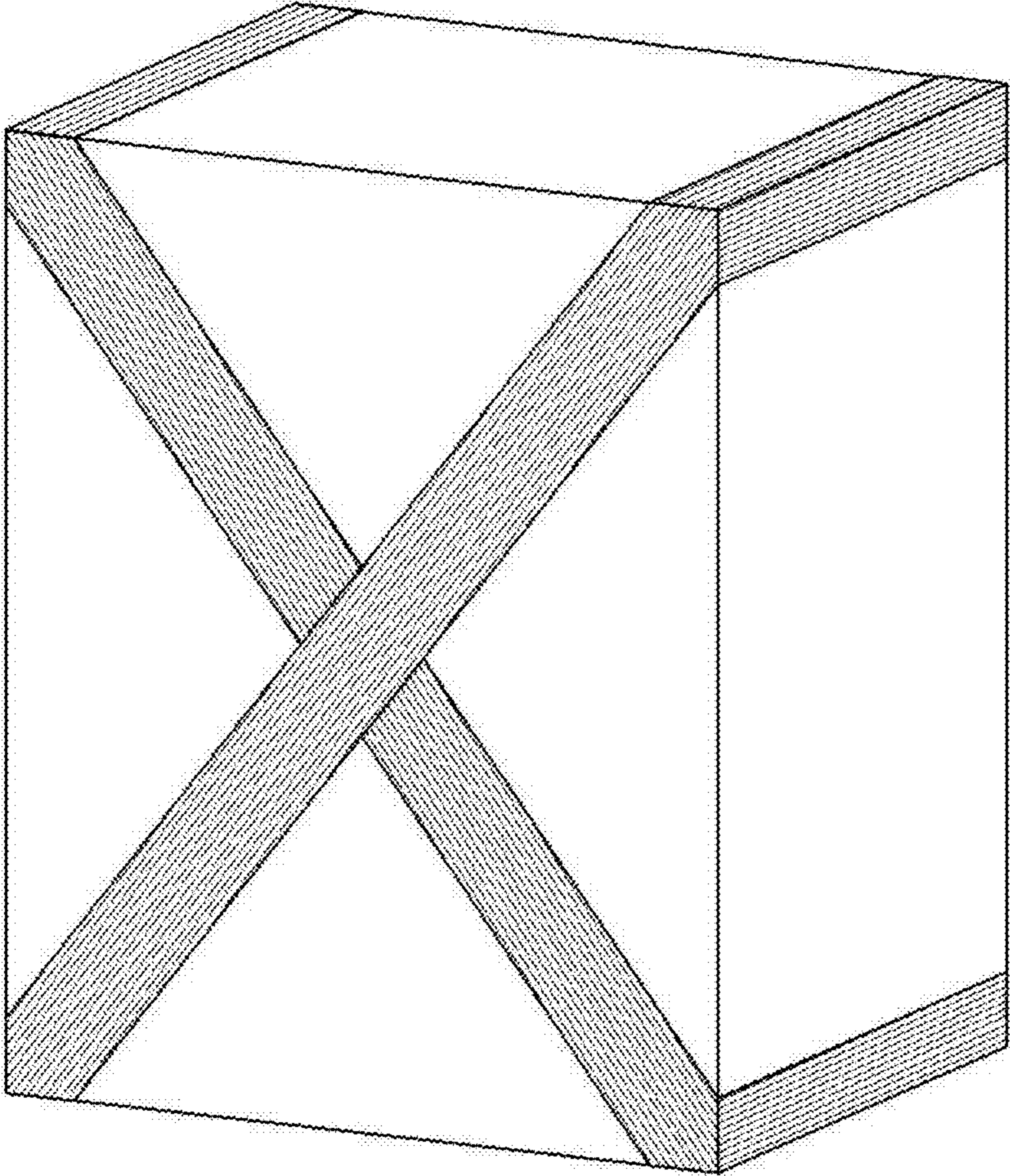

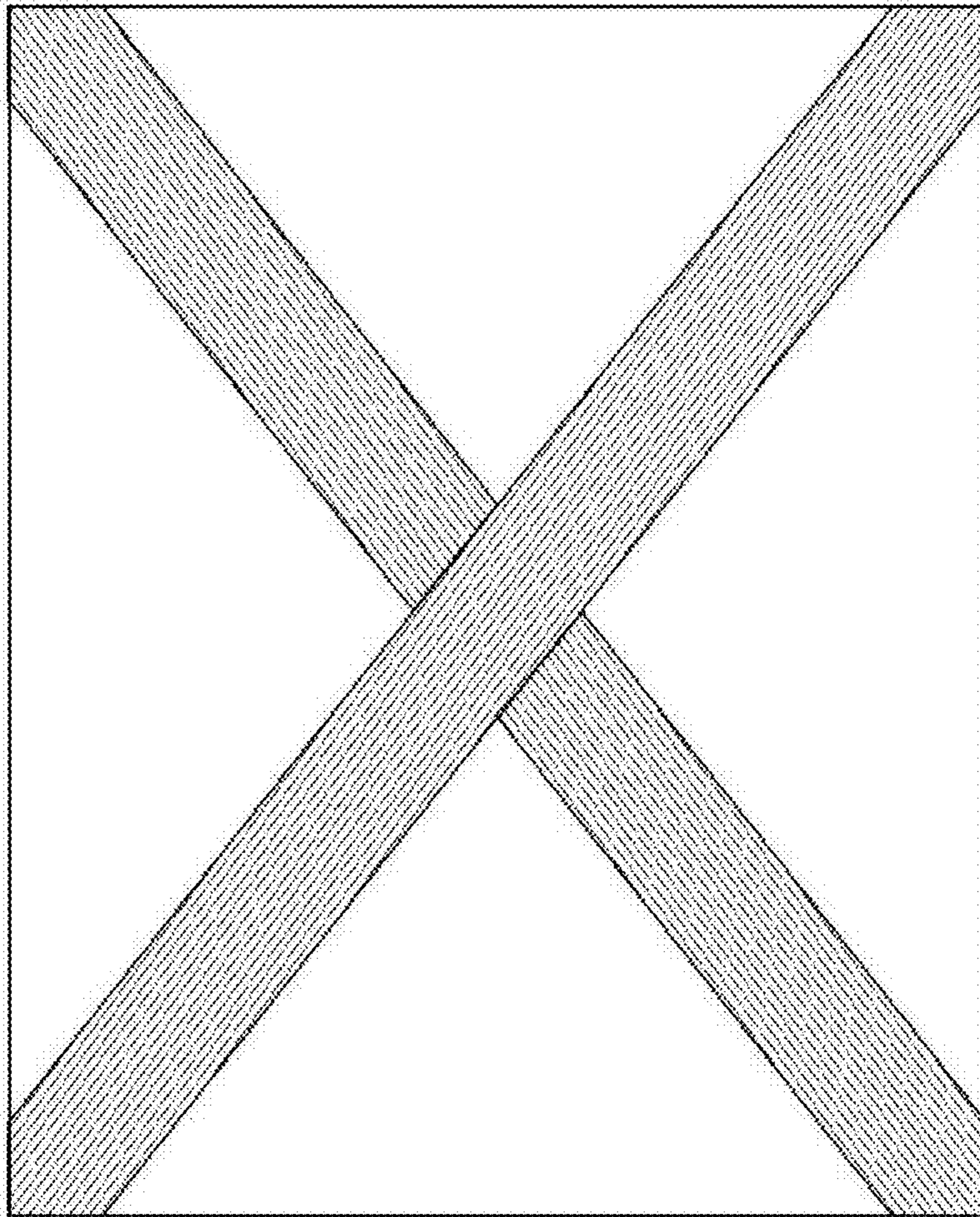

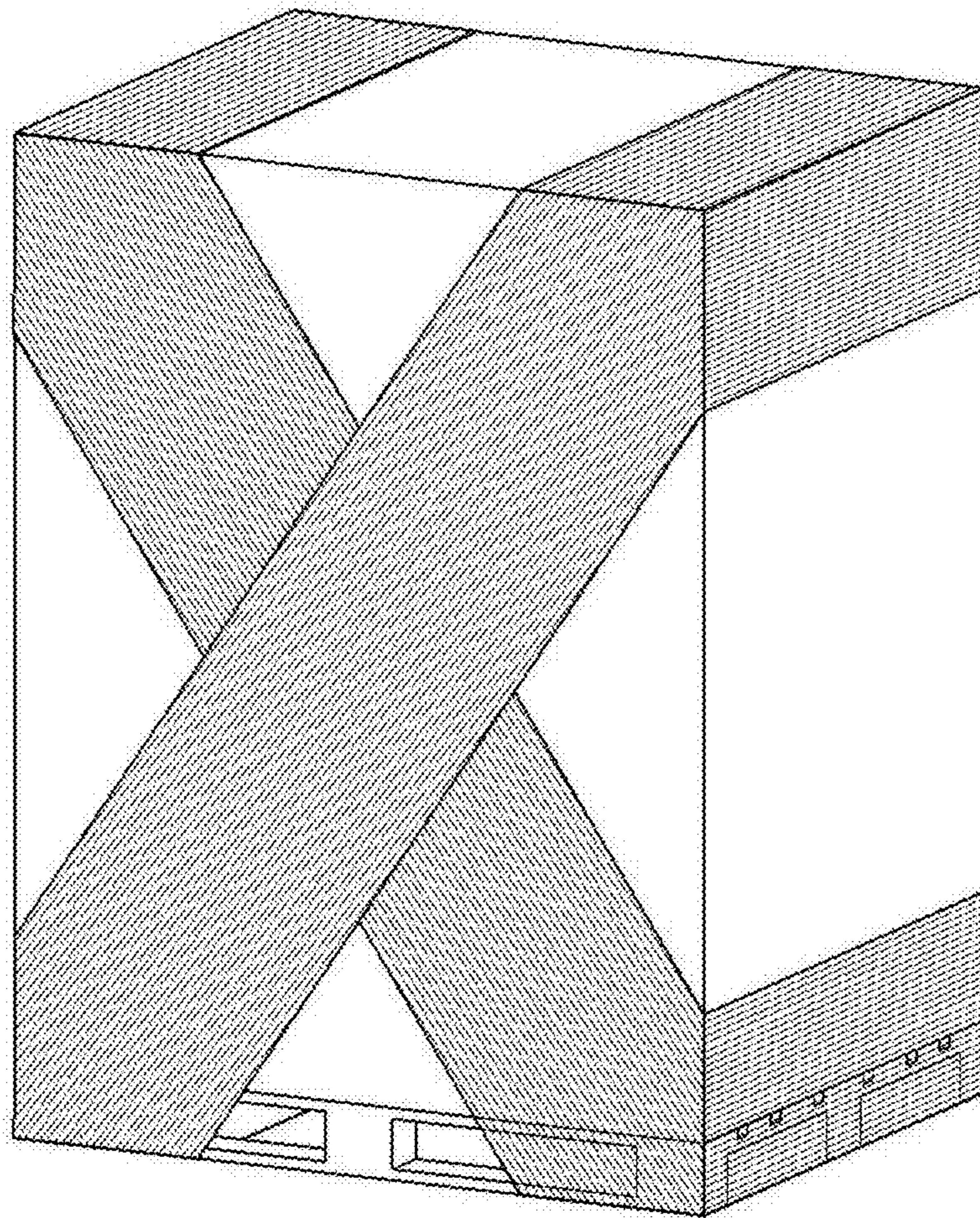

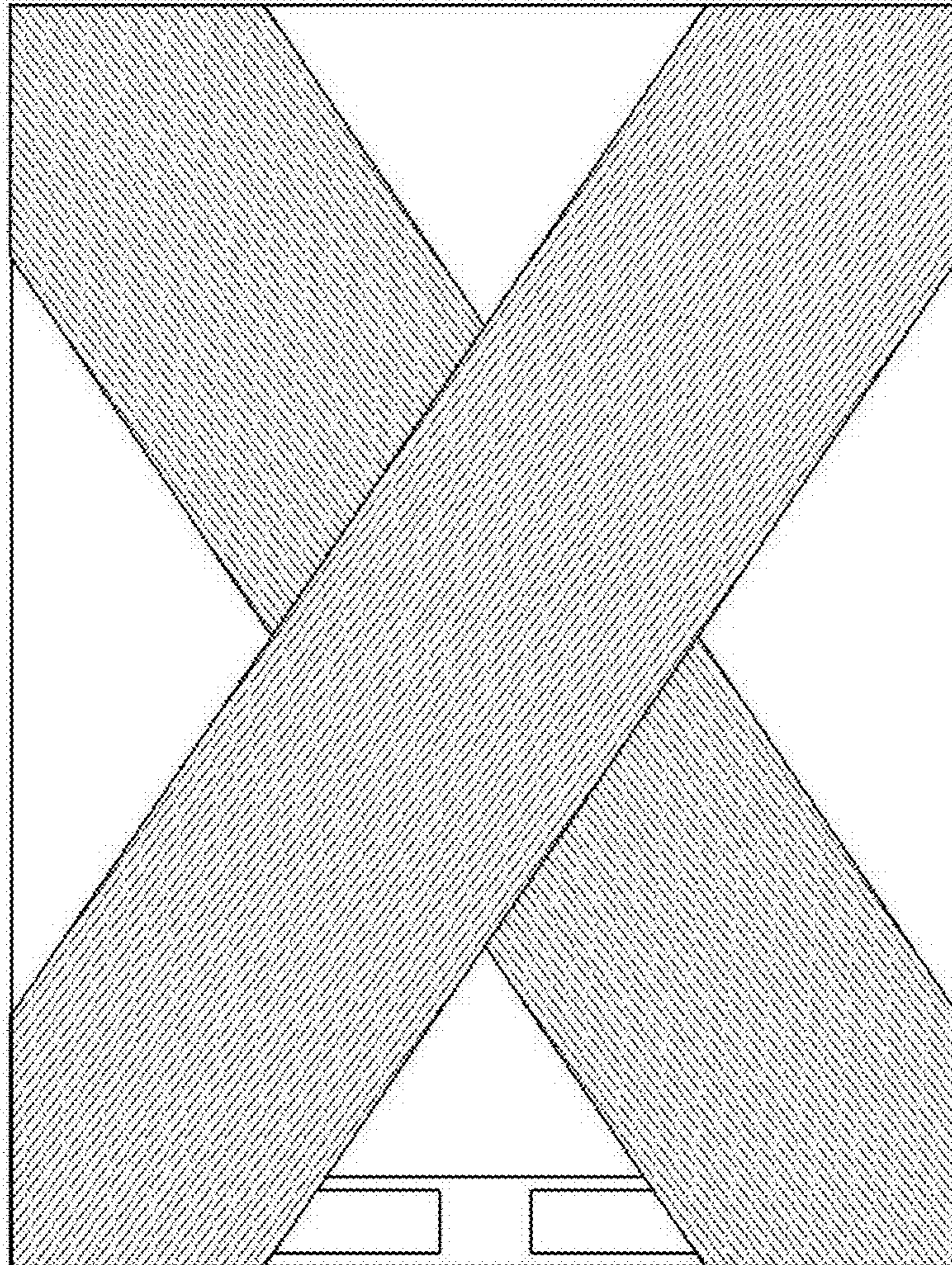

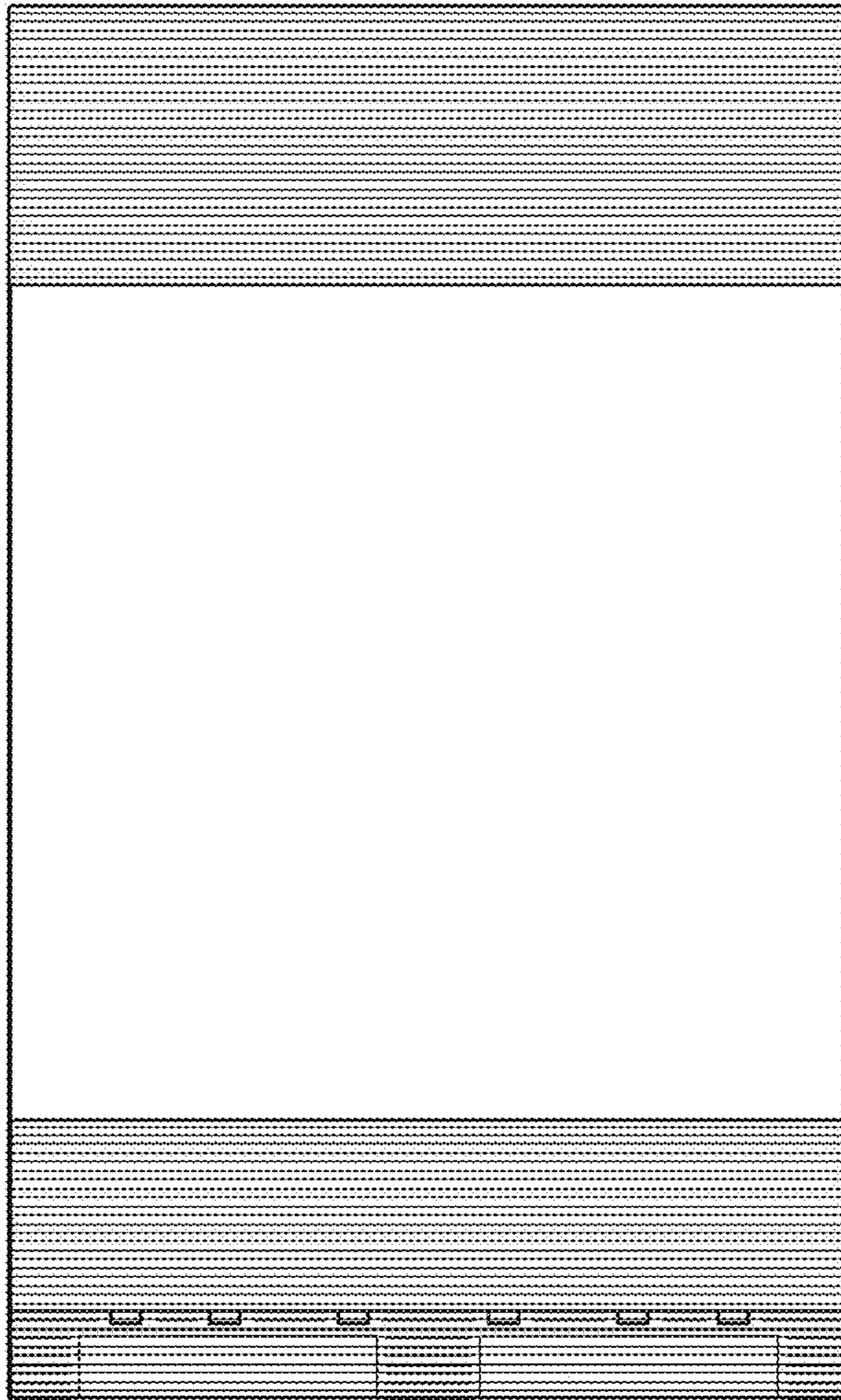

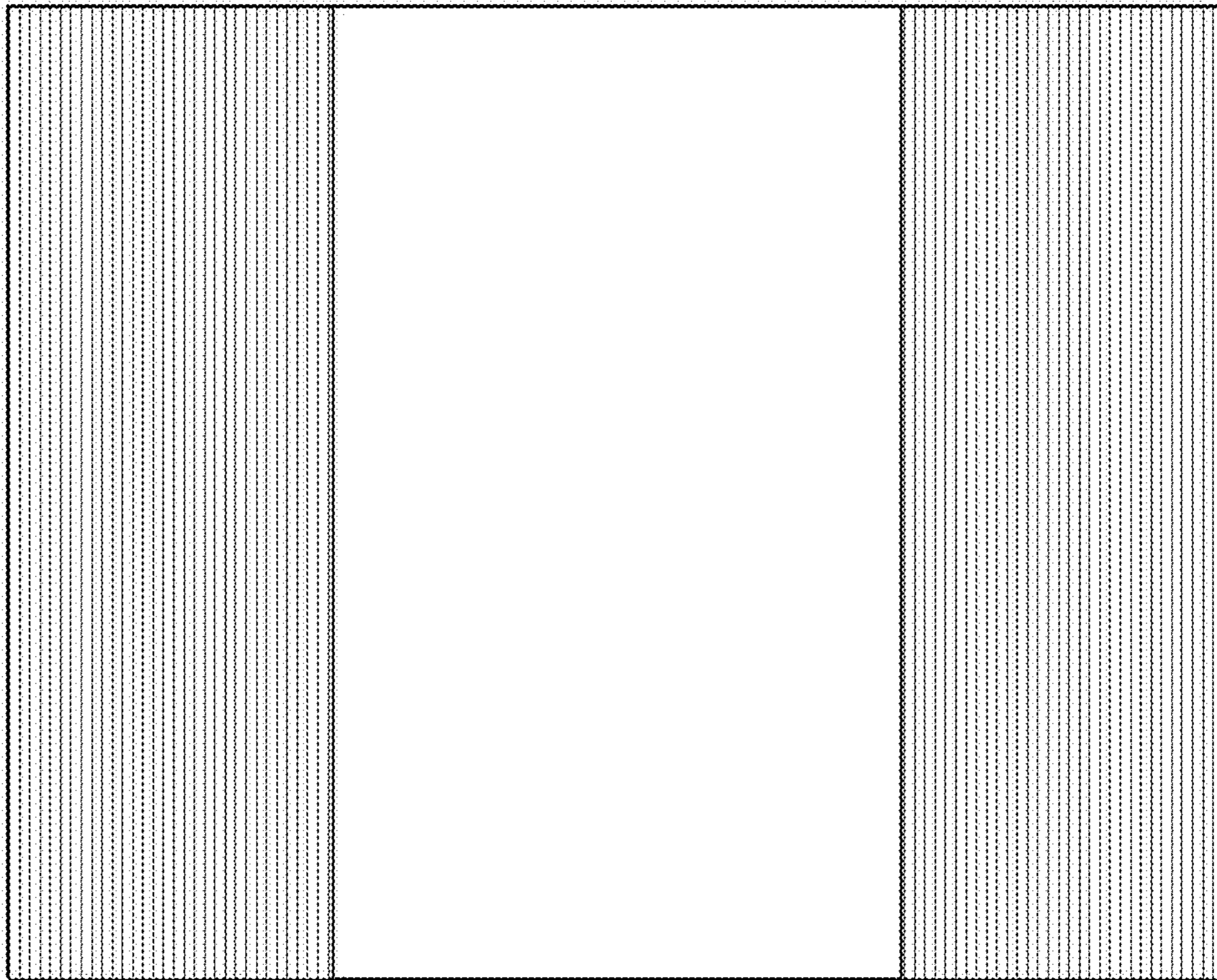

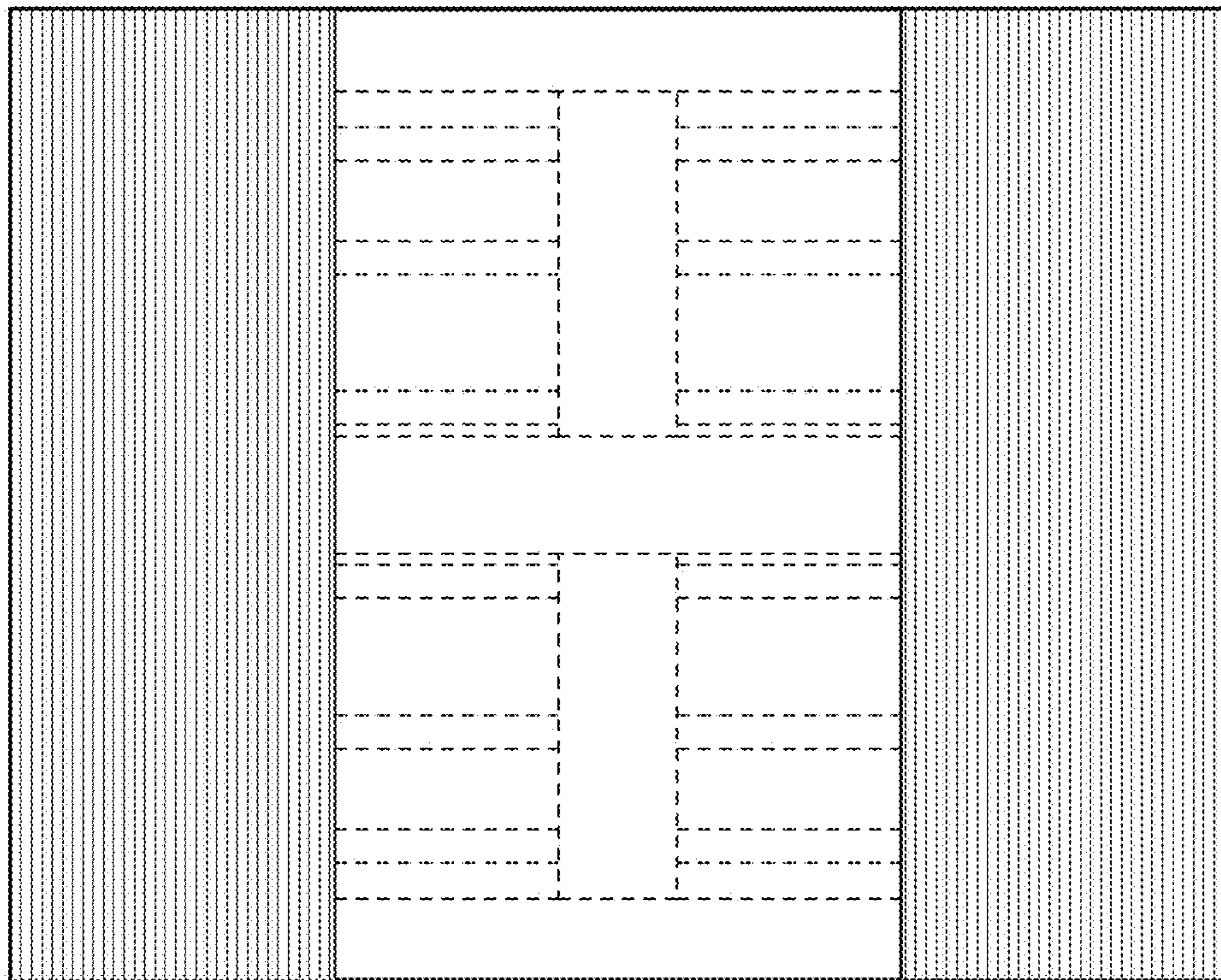

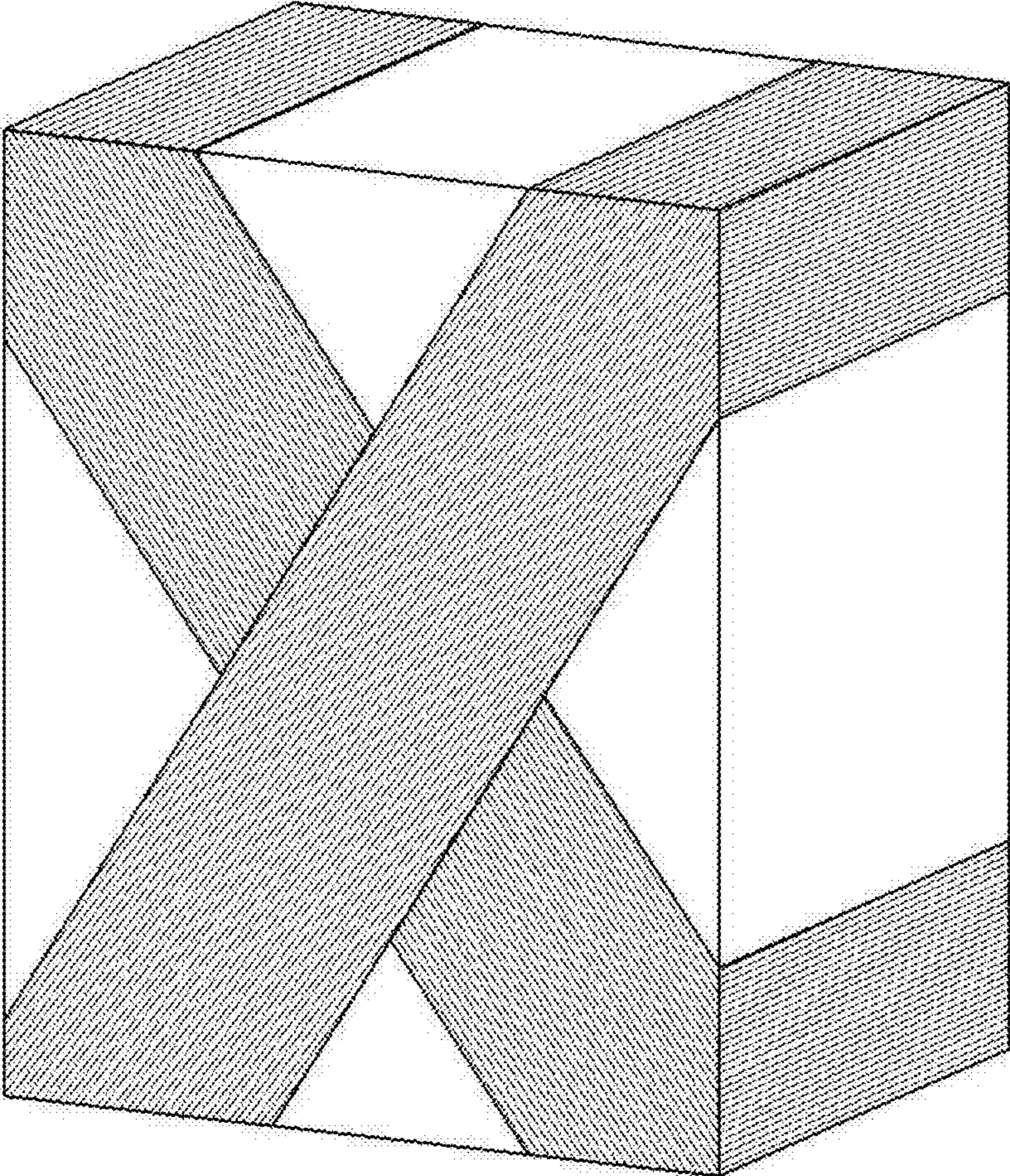

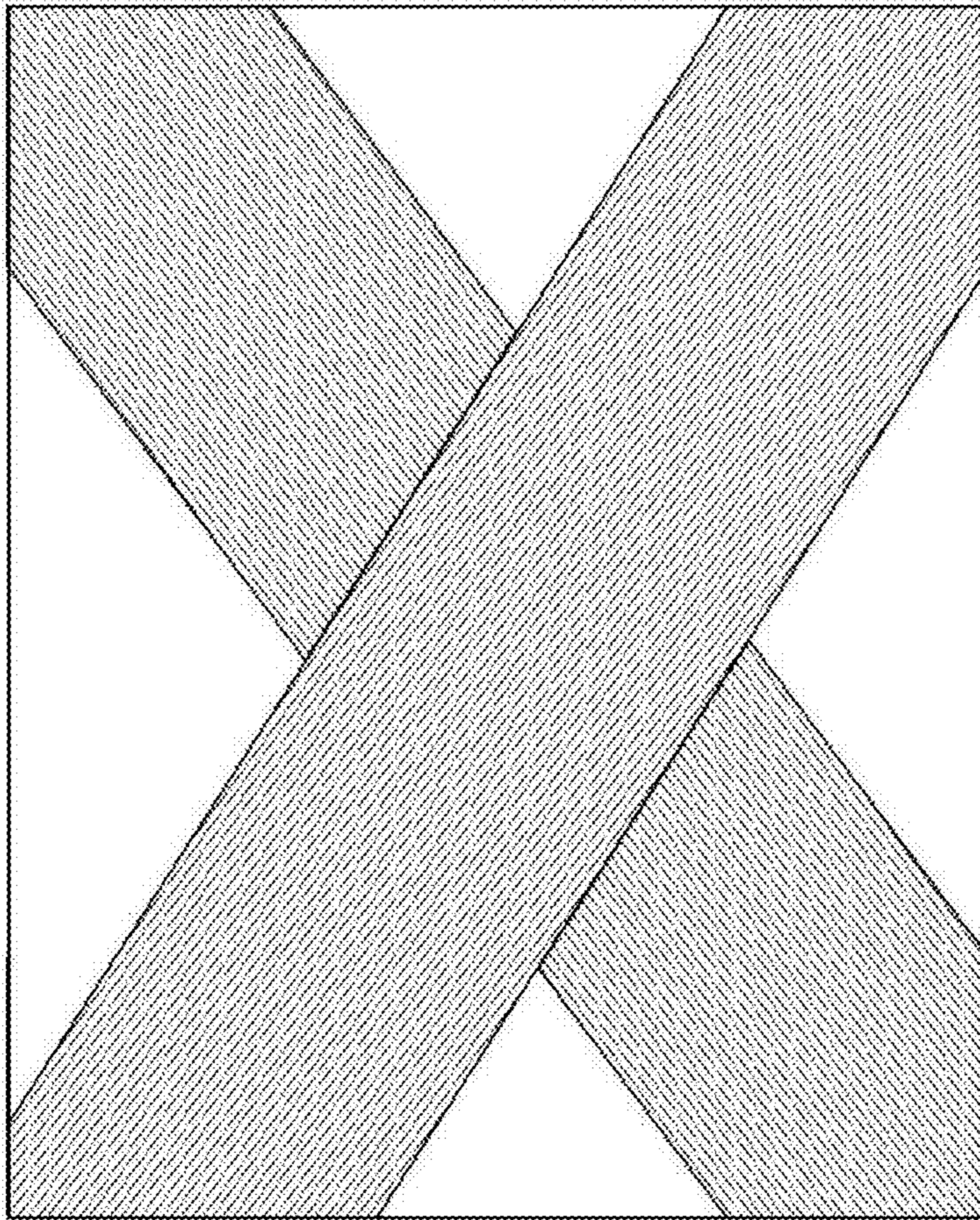

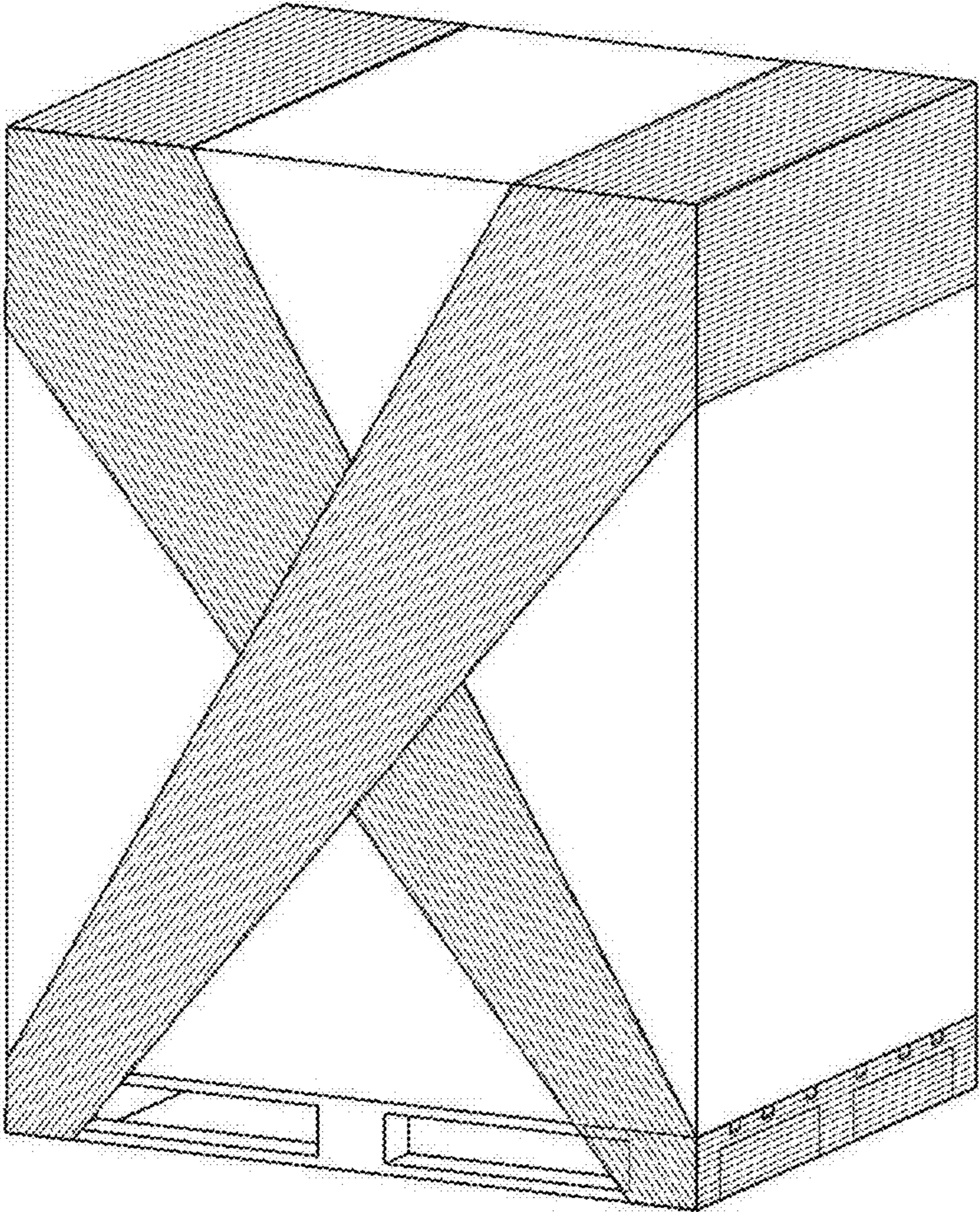

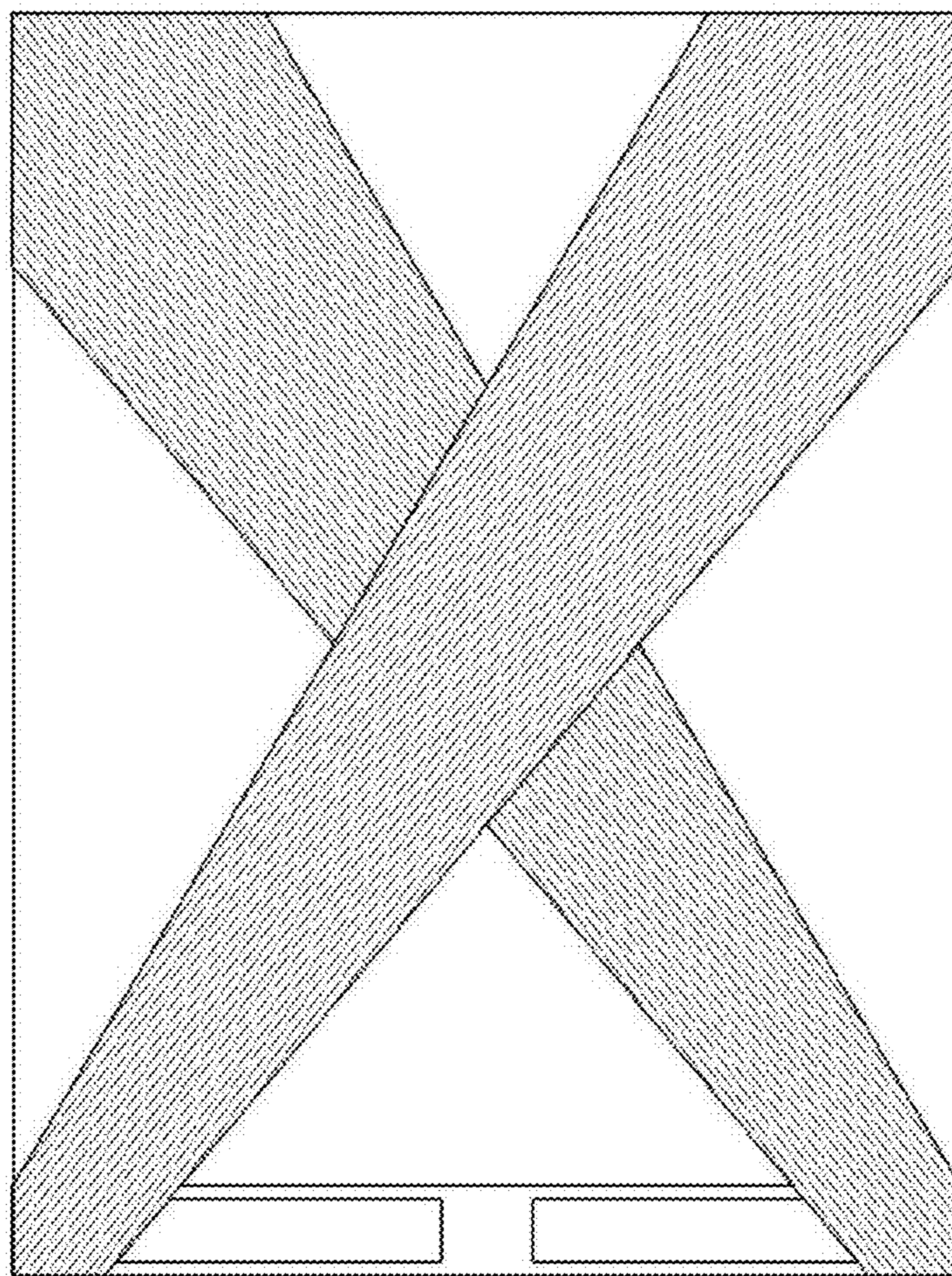

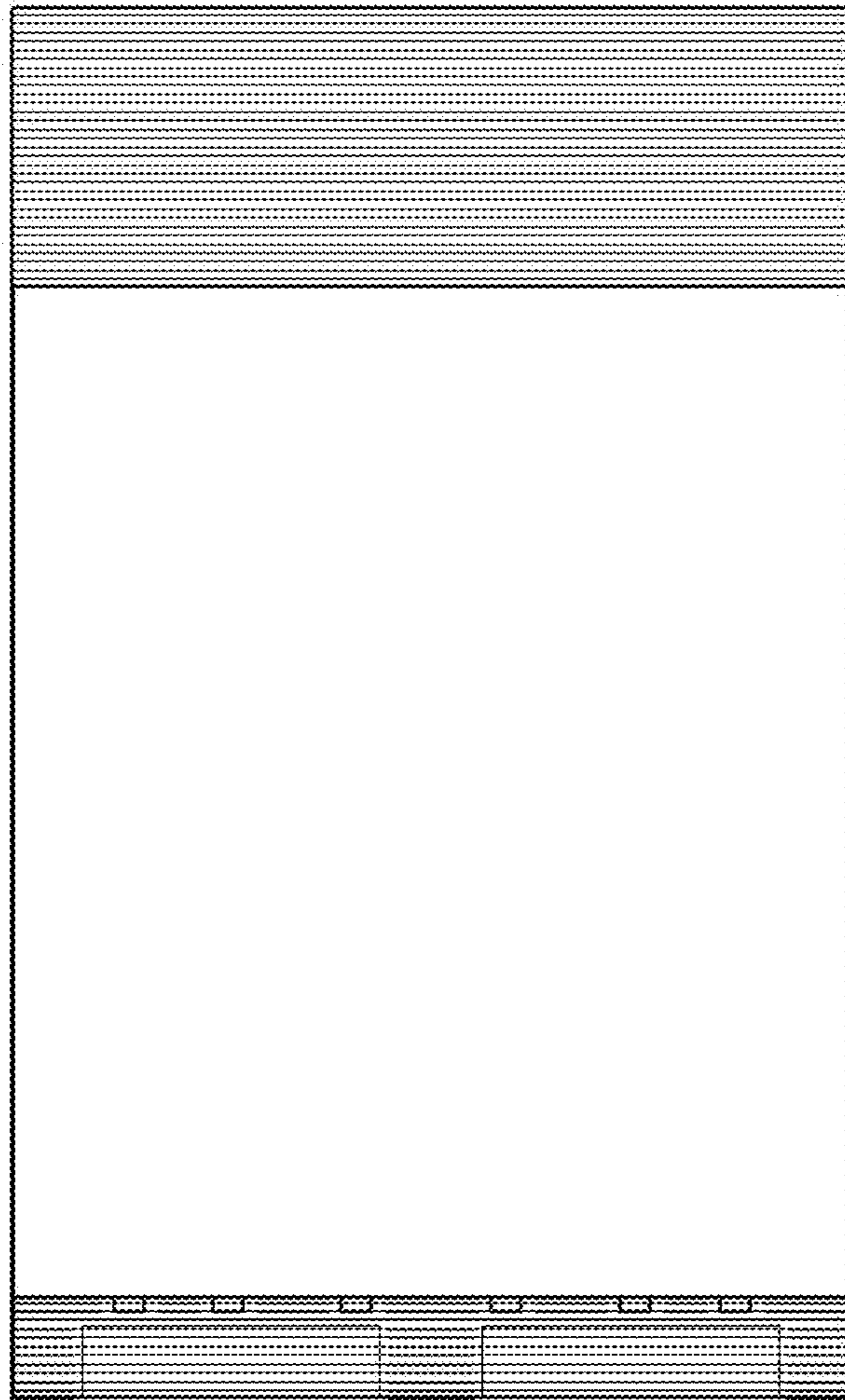

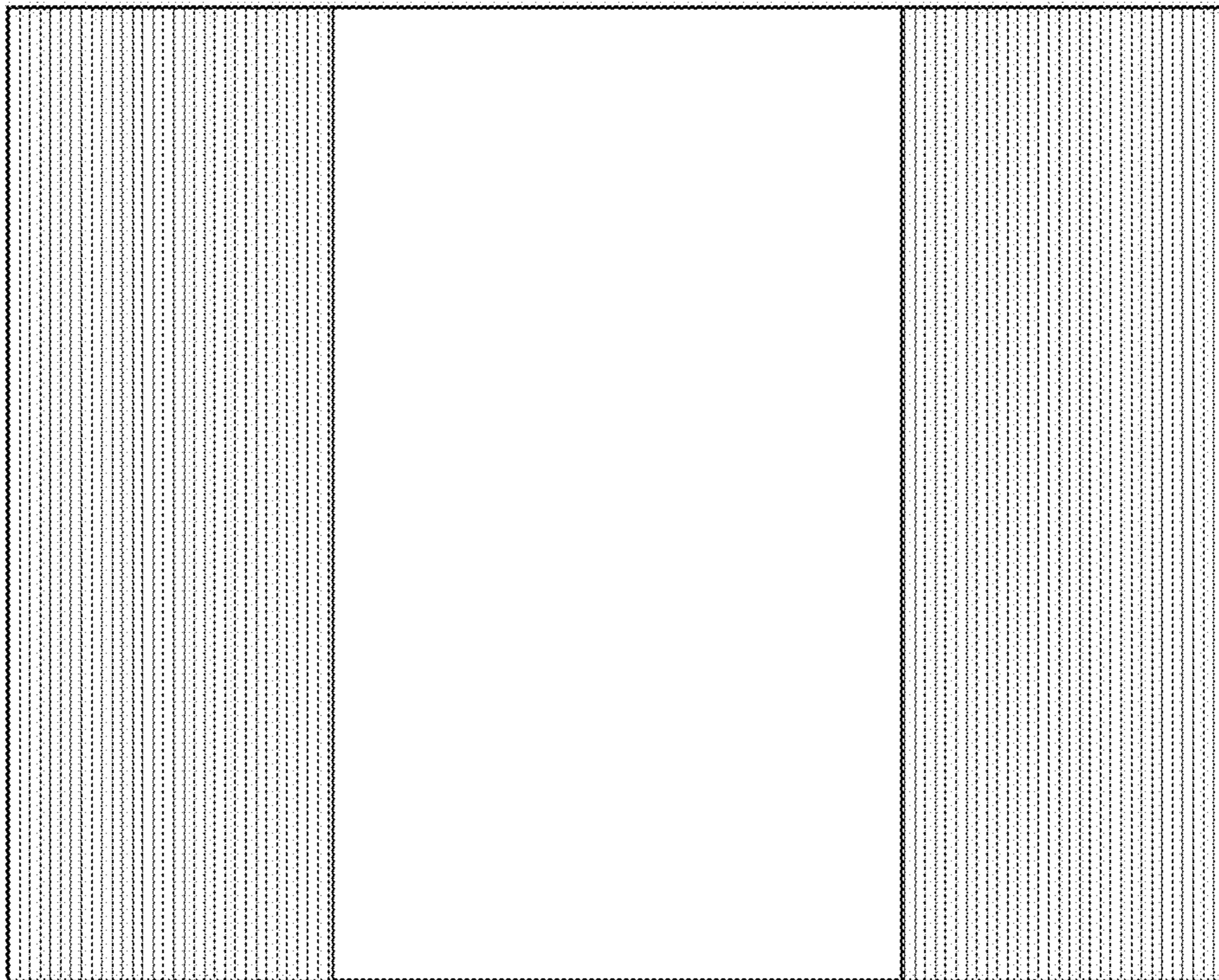

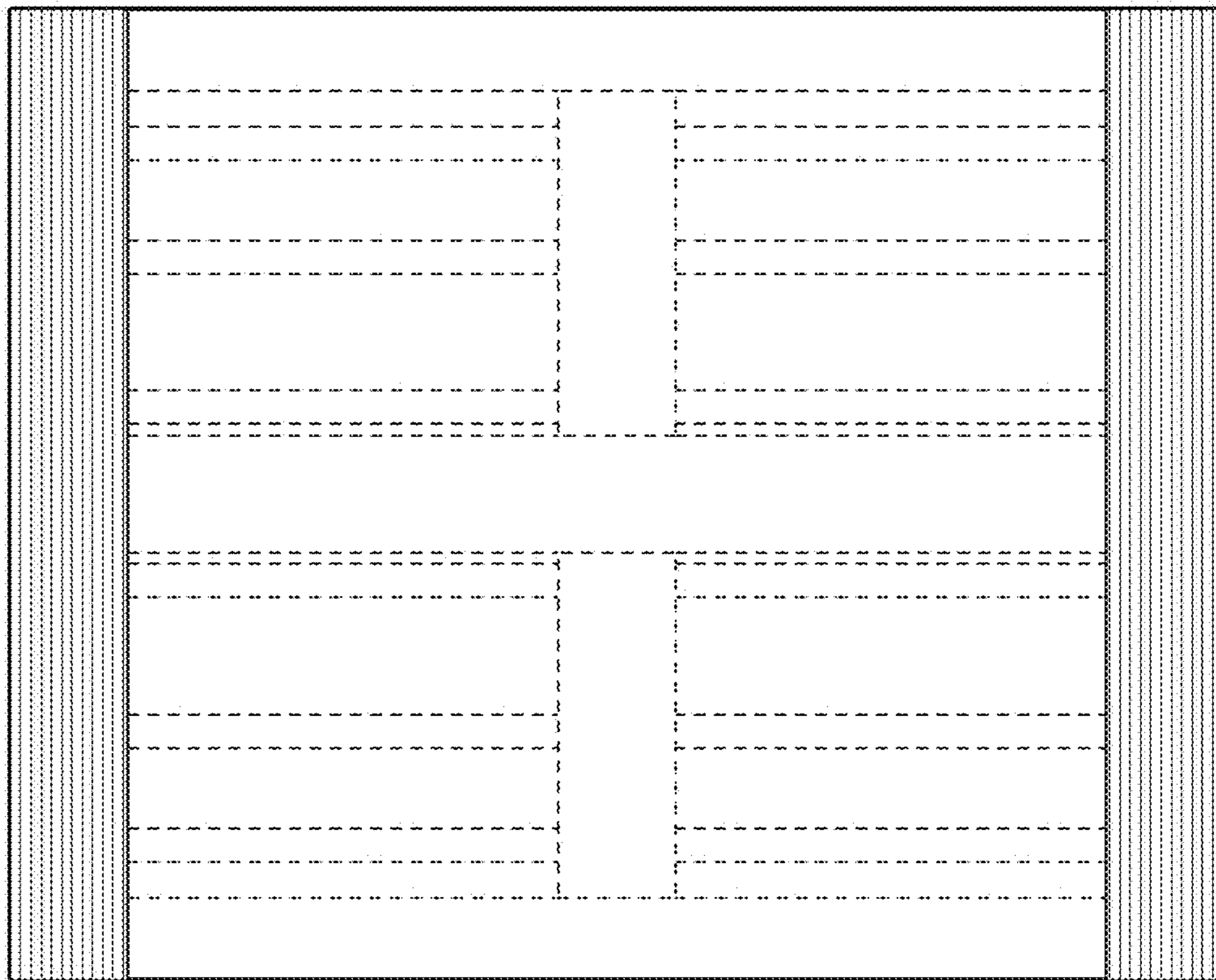

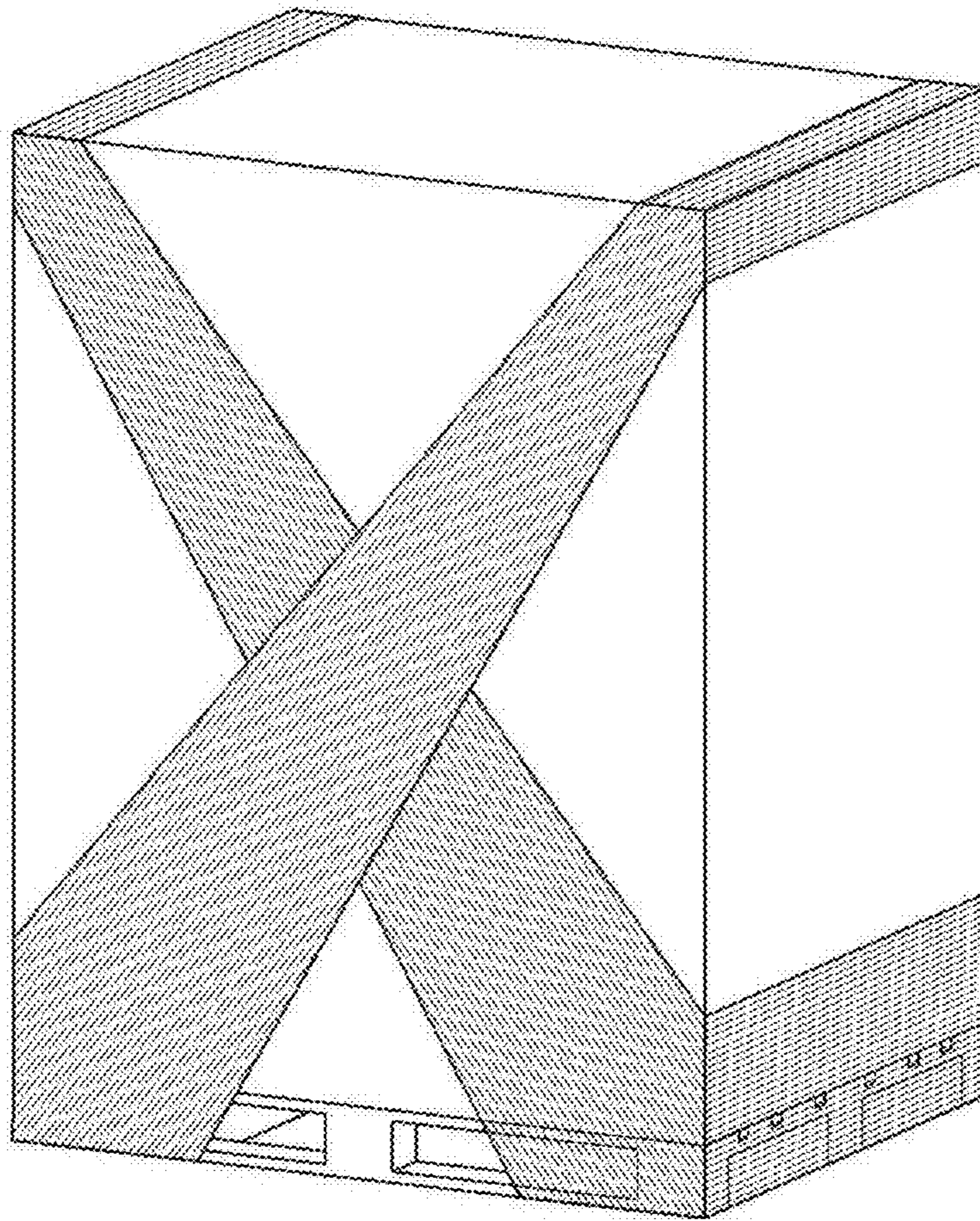

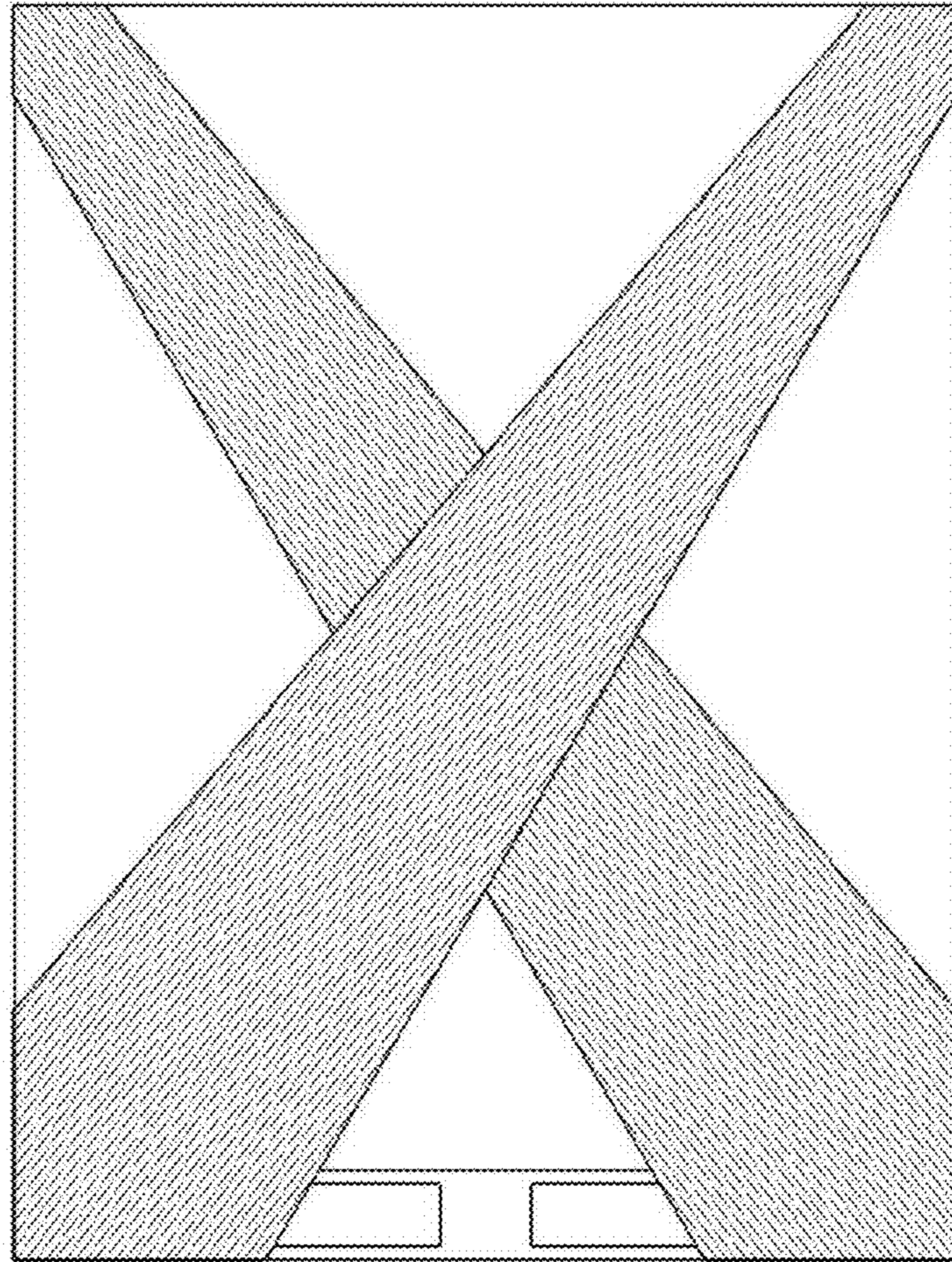

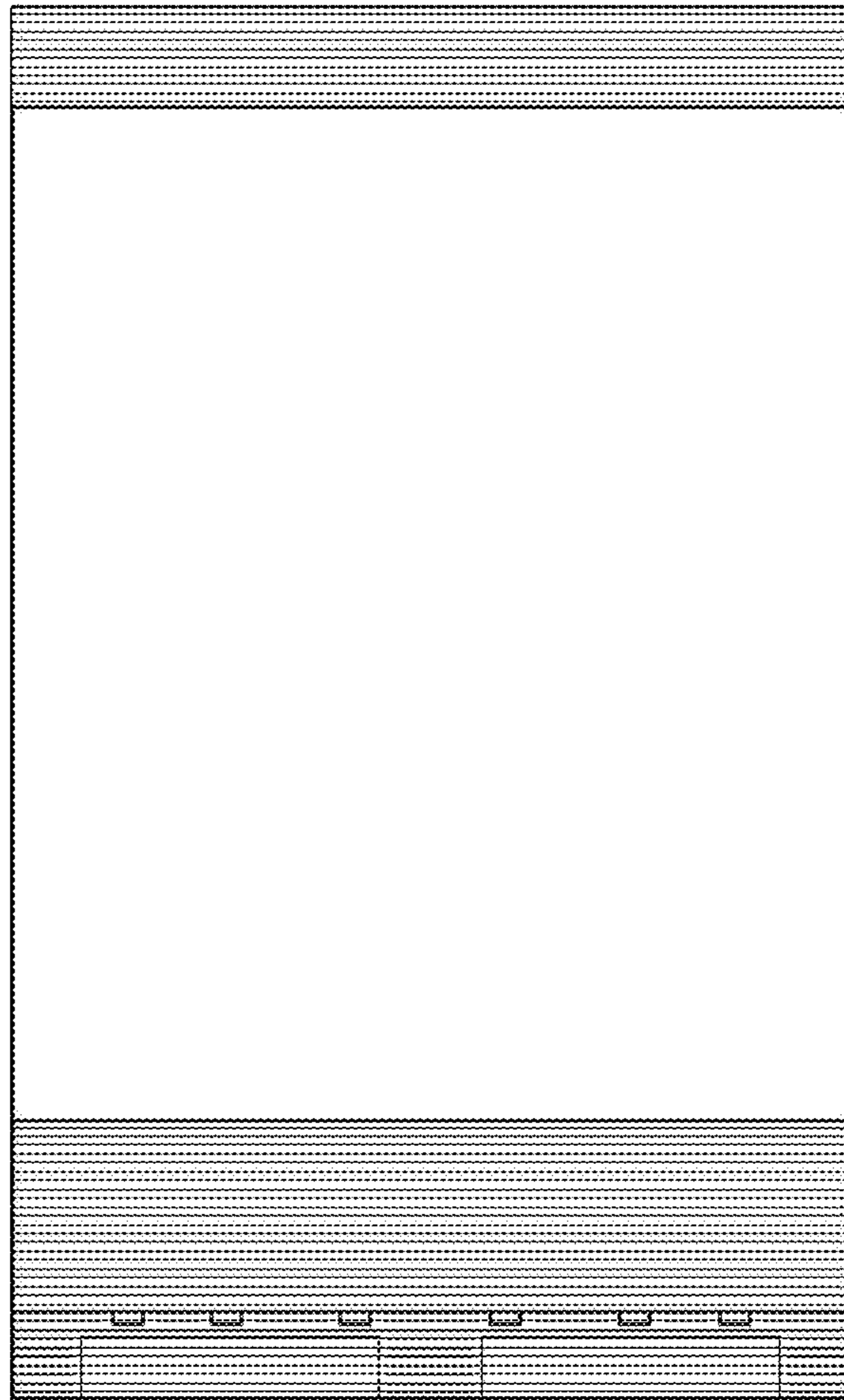

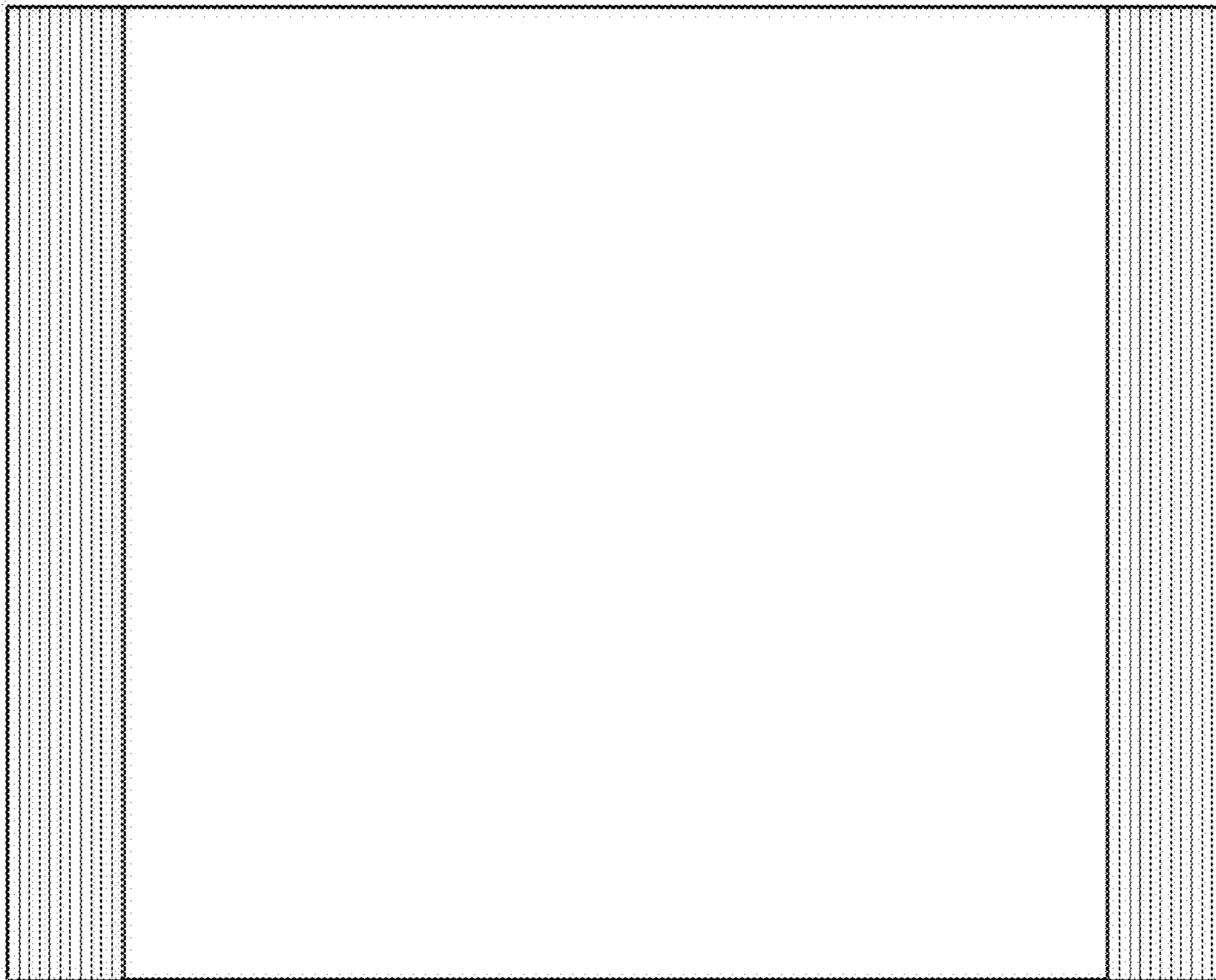

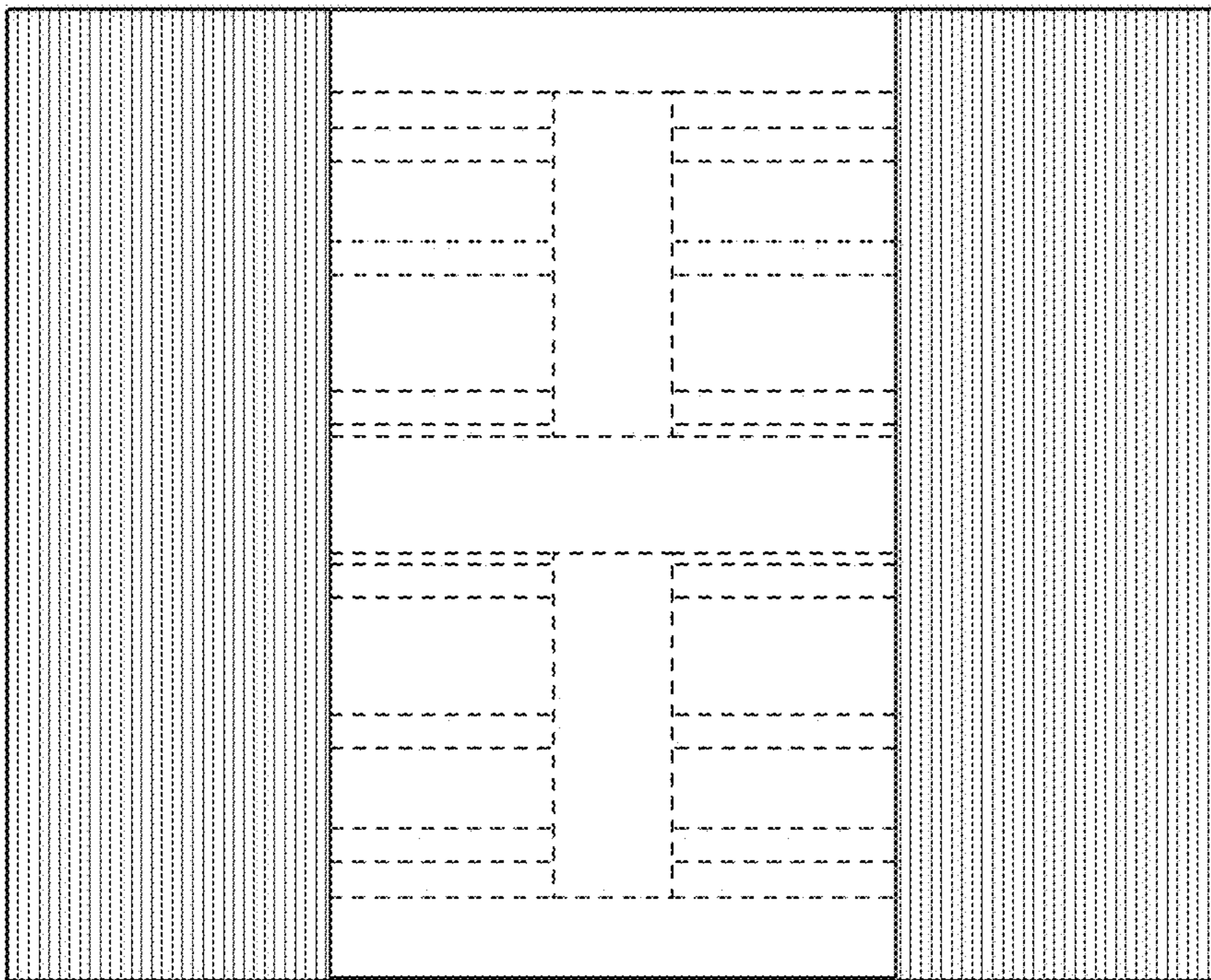
