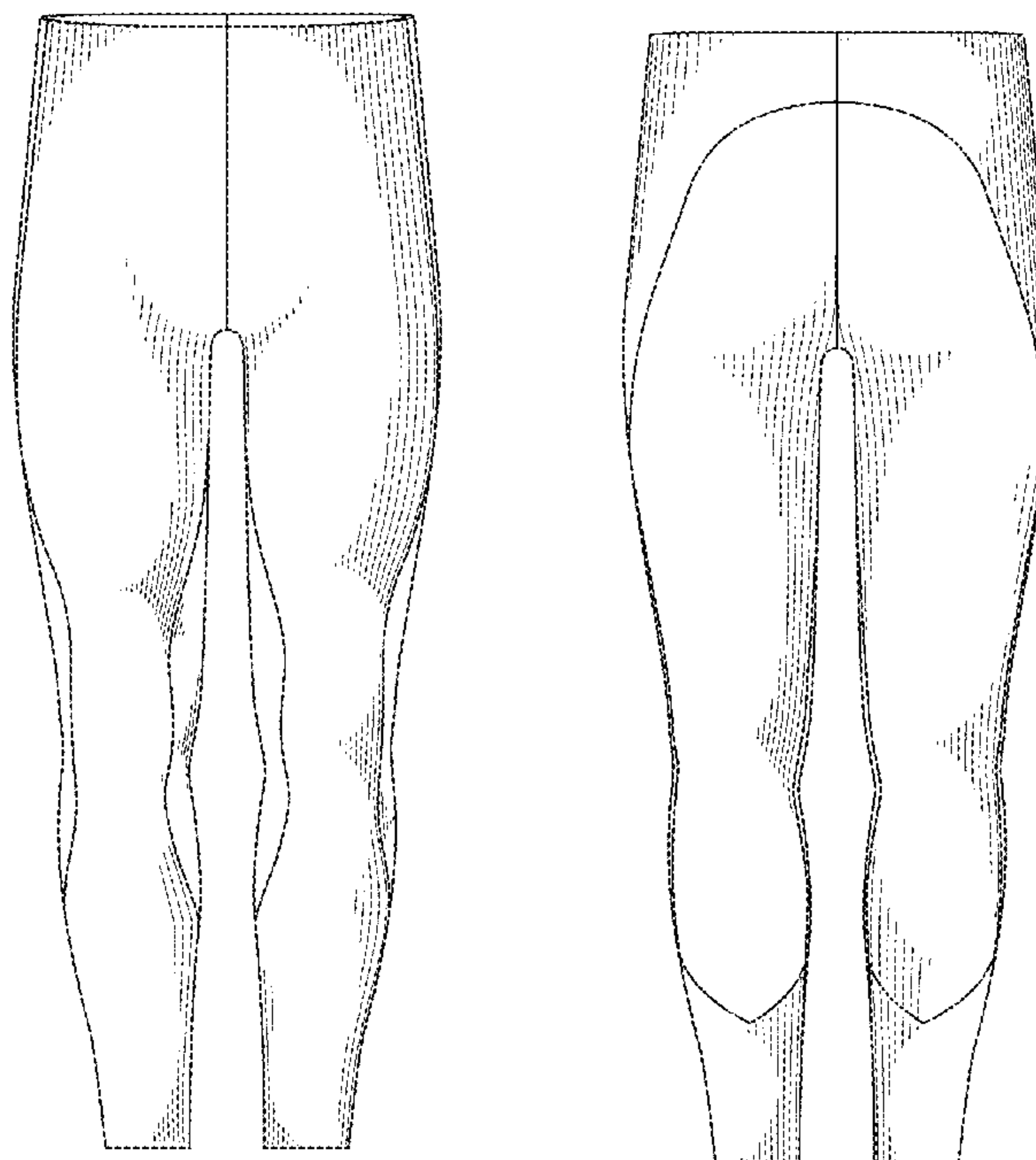
(57) **CLAIM**

The ornamental design for a sport tights, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a sport tights of the present invention. FIG. 2 is a rear view of the sport tights of FIG. 1. FIG. 3 is a top plan view of the sport tights of FIG. 1. FIG. 4 is a bottom side view of the sport tights of FIG. 1. FIG. 5 is a right side view of the sport tights of FIG. 1. FIG. 6 is a left side view of the sport tights of FIG. 1. FIG. 7 is a front perspective view of the sport tights of FIG. 1. FIG. 8 is a rear perspective view of the sport tights of FIG. 1. FIG. 9 is a front view of the sport tights of FIG. 1 in a laid flat position. 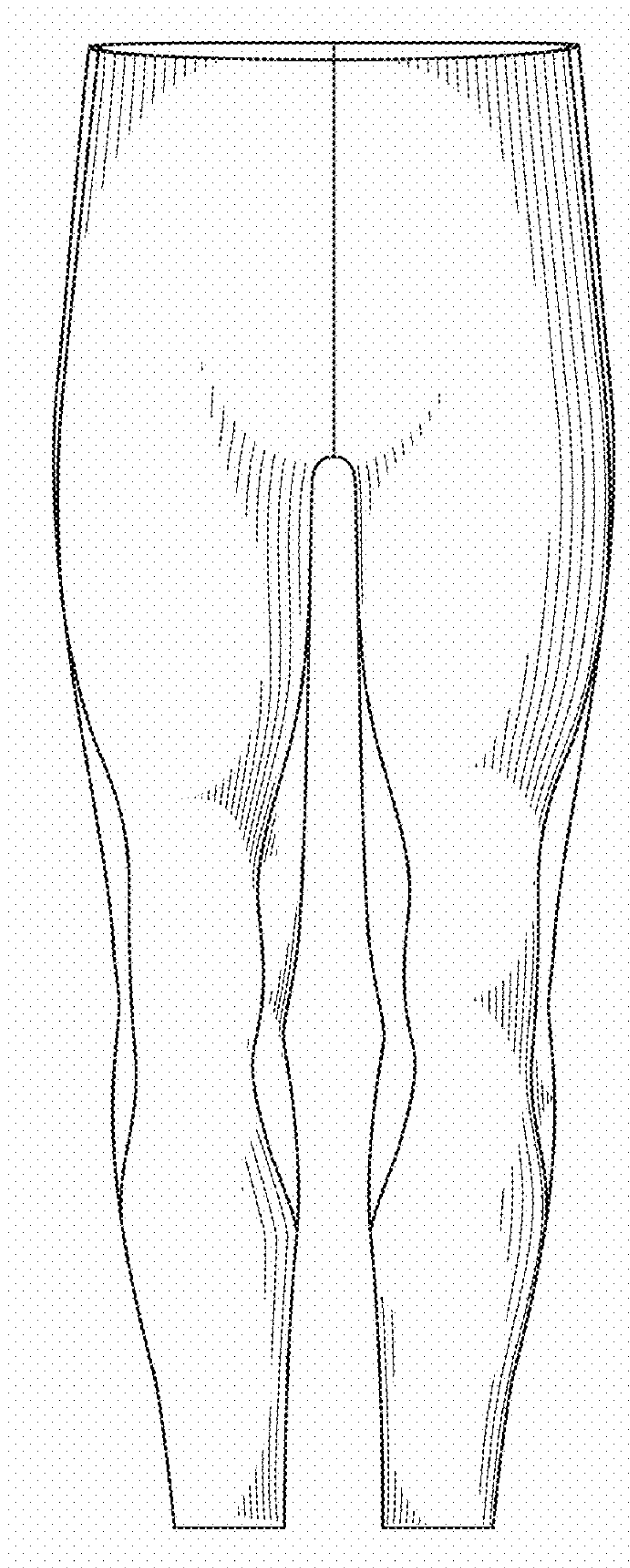

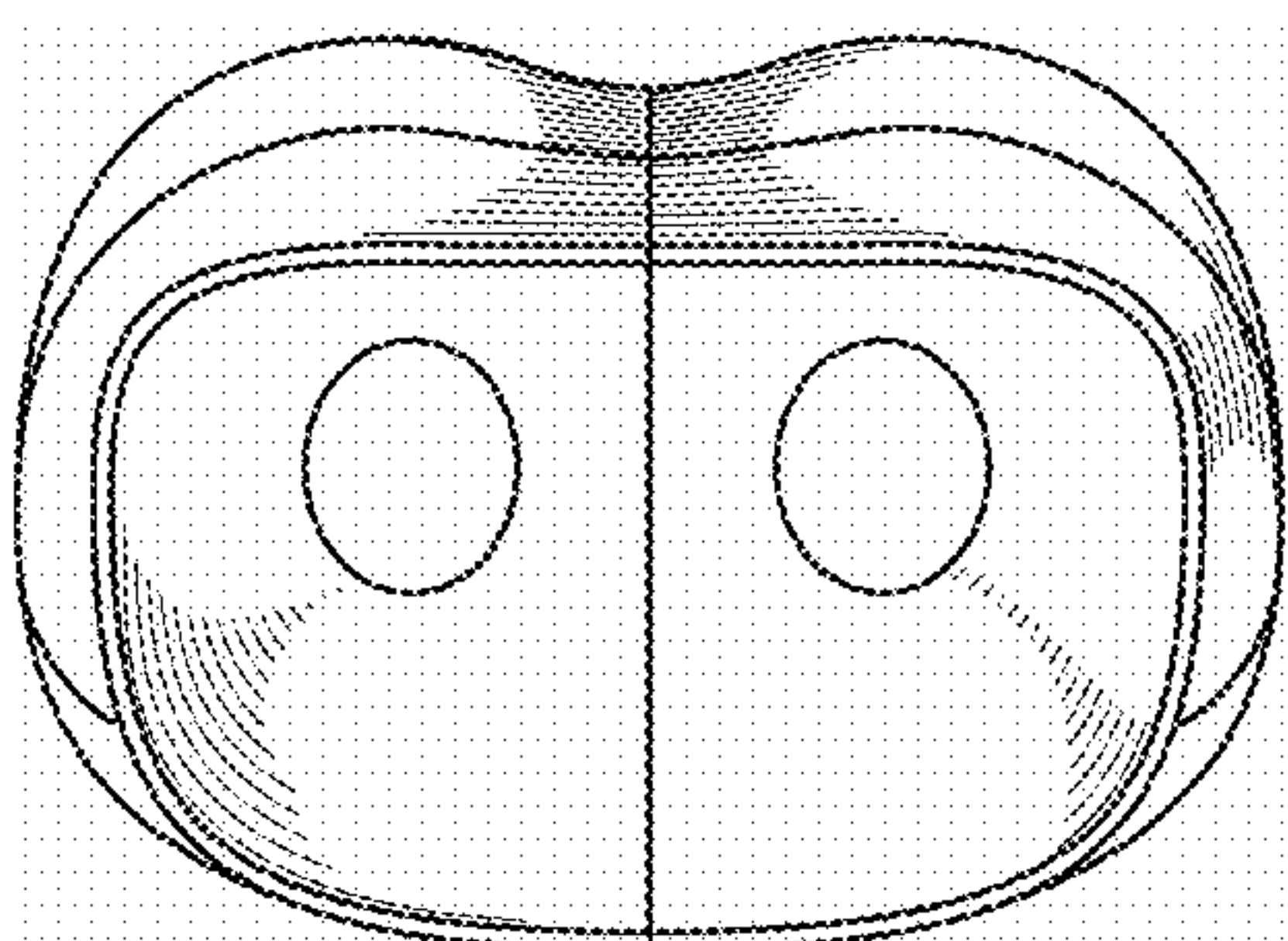

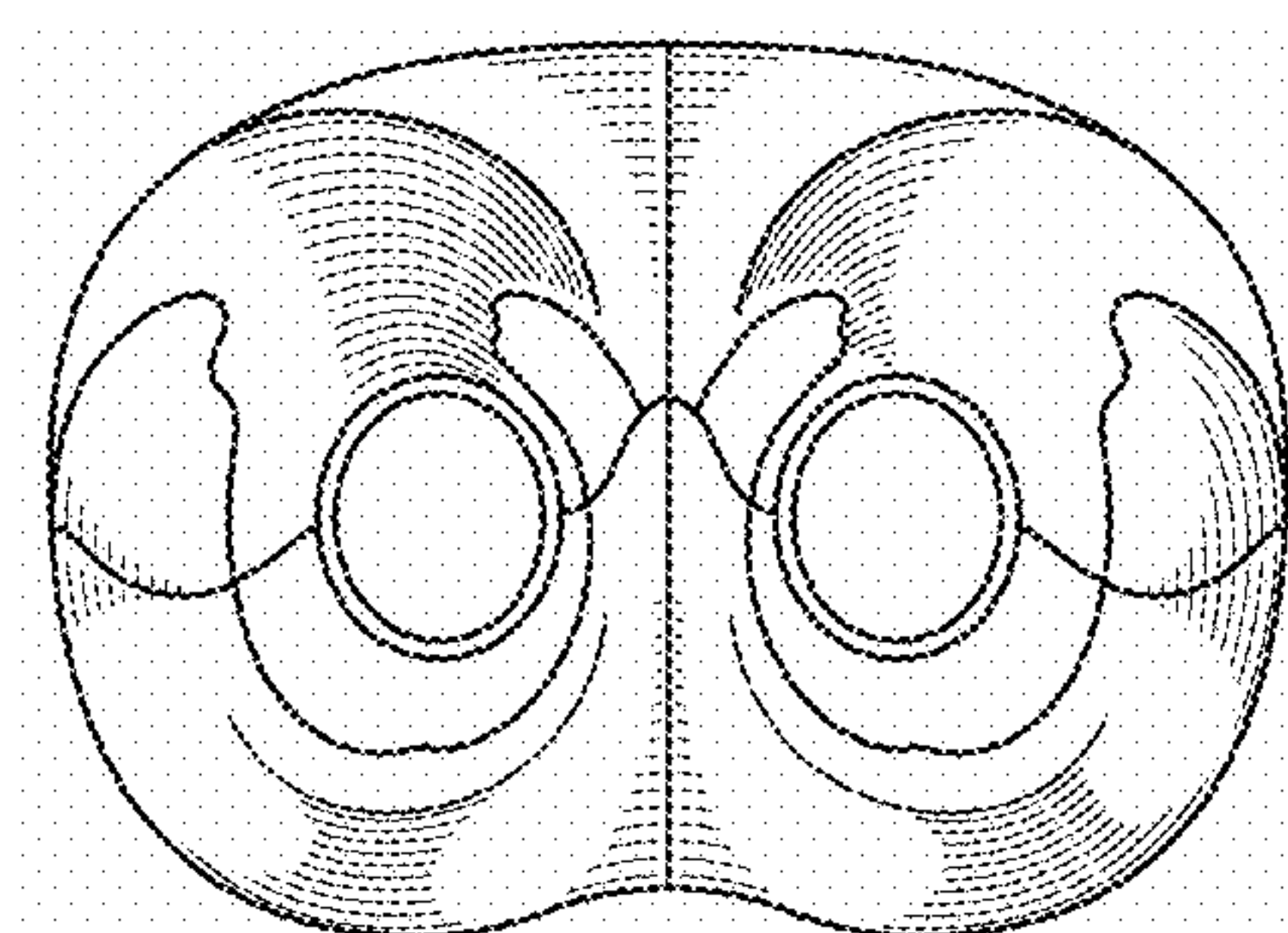

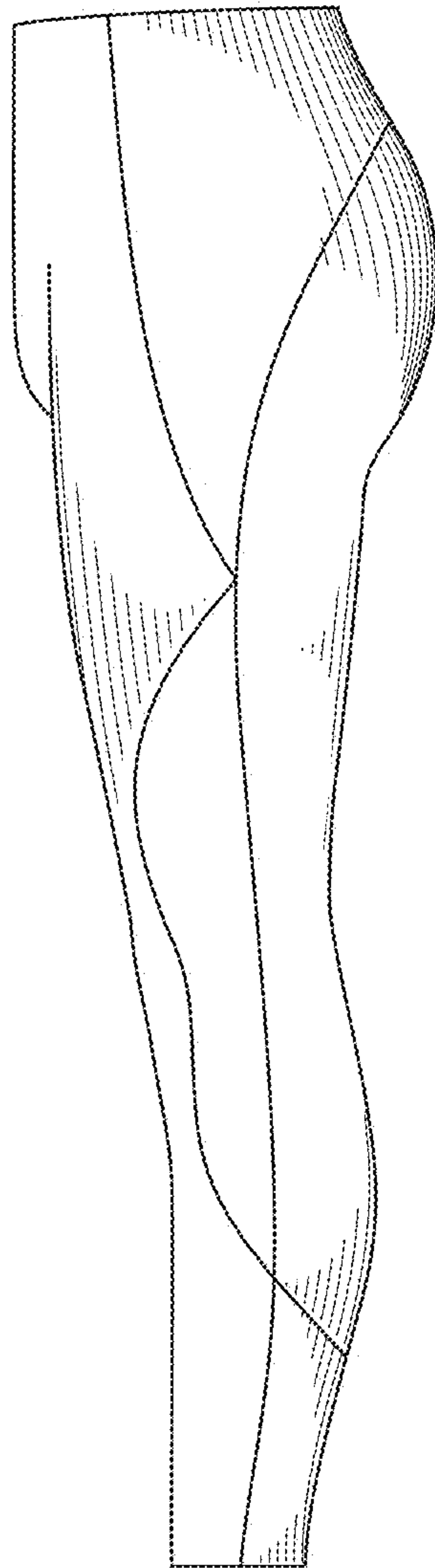

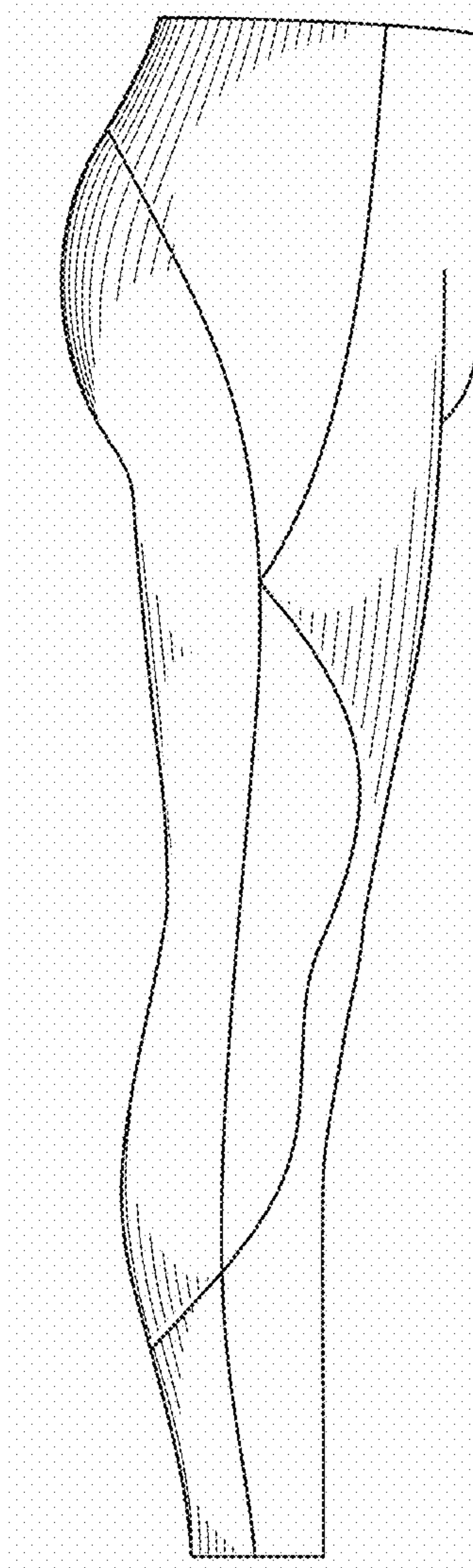

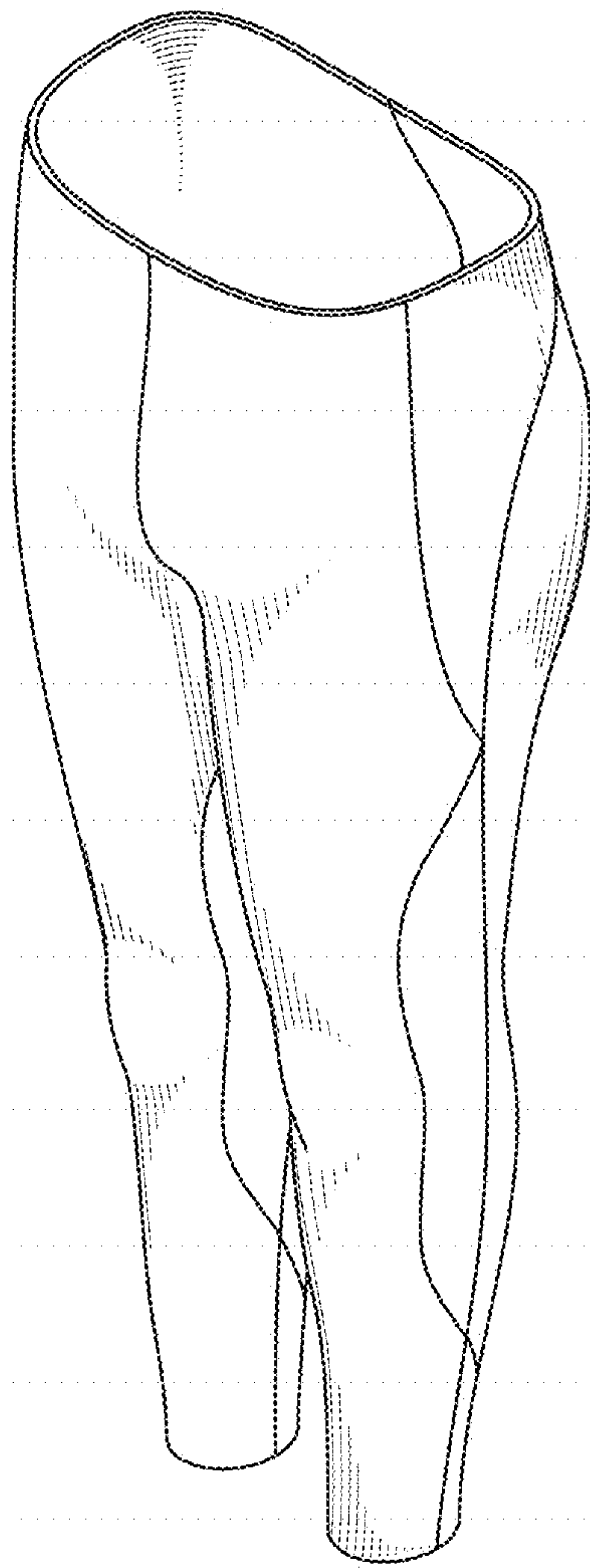

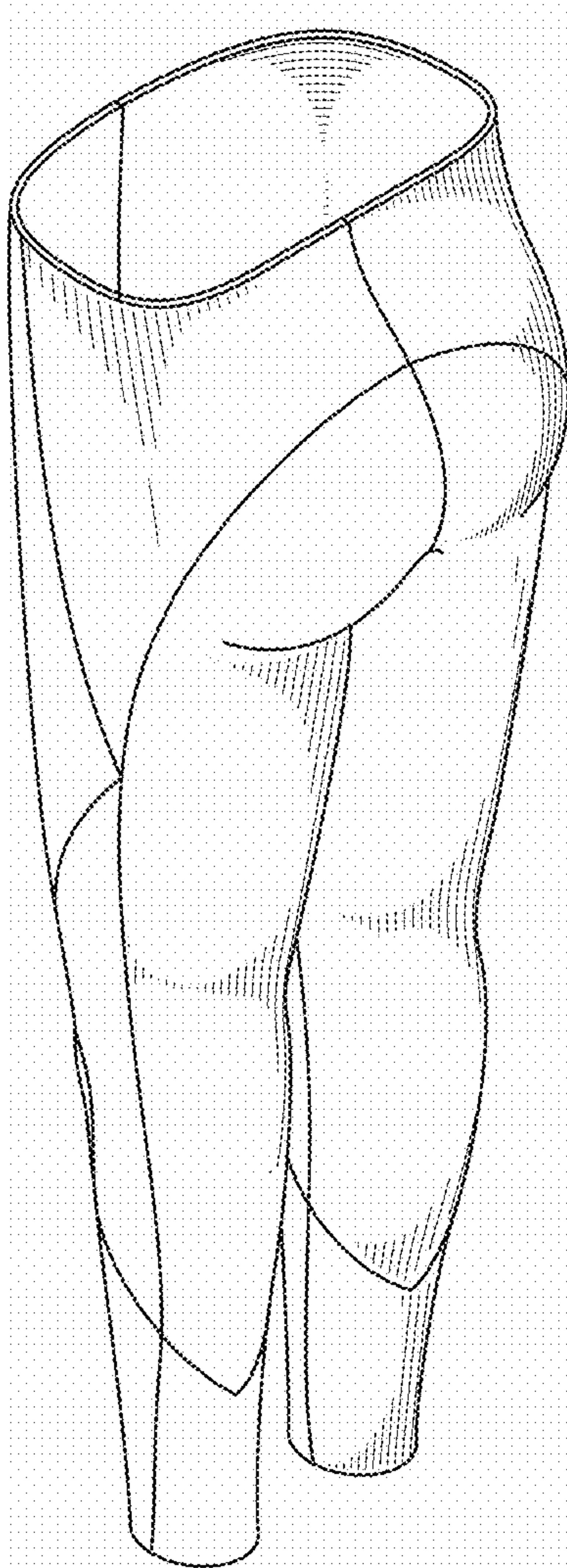

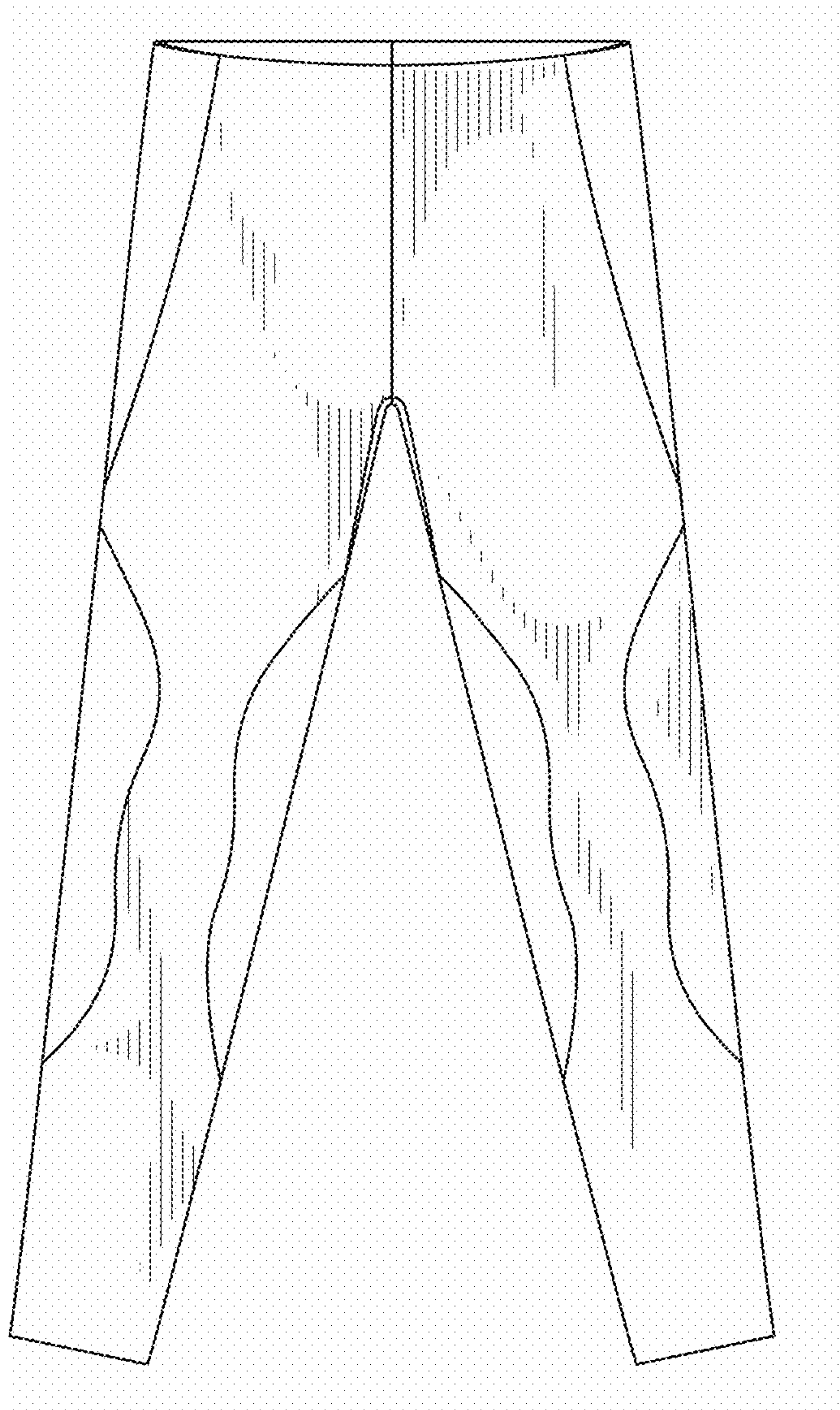

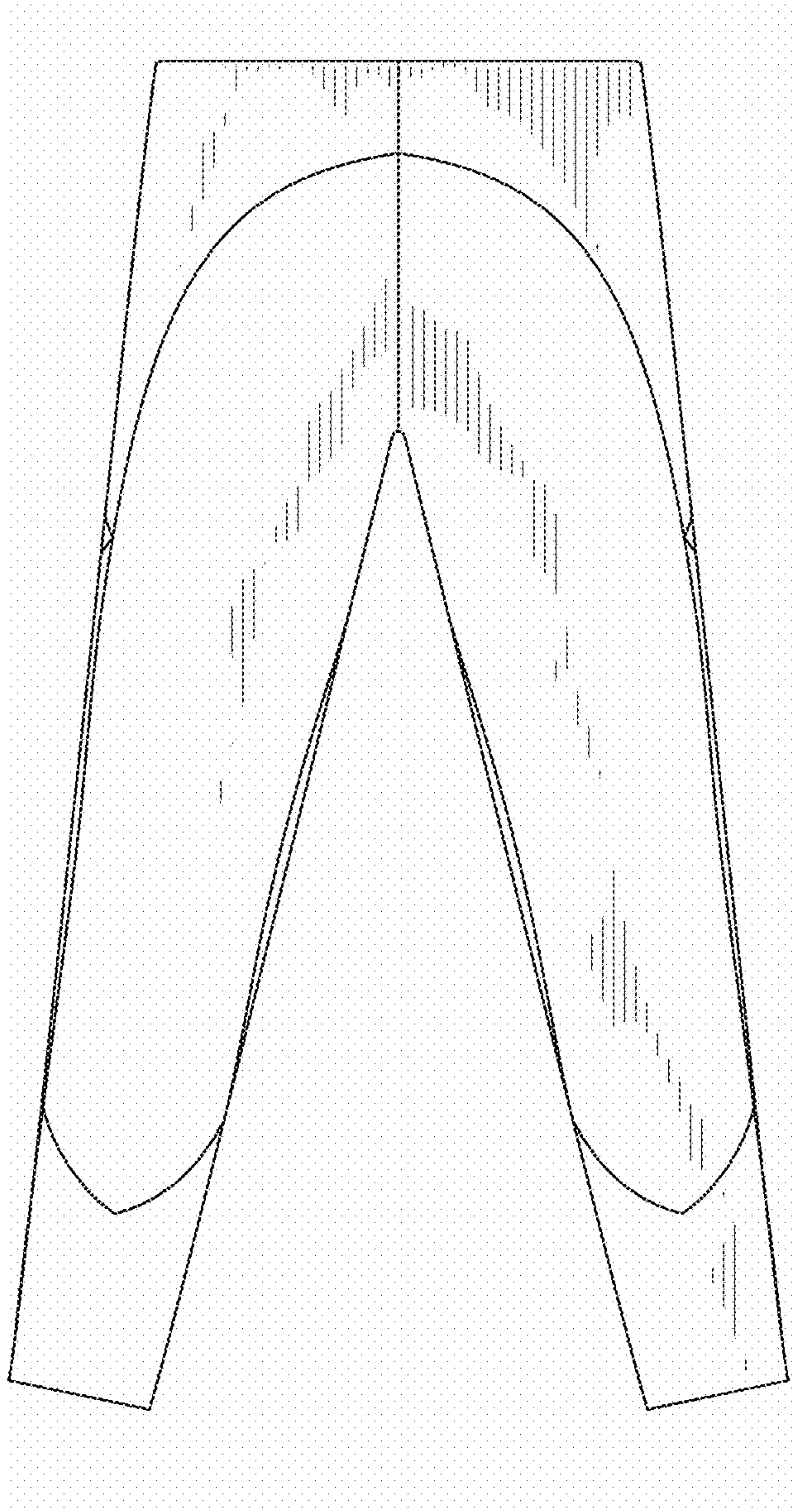

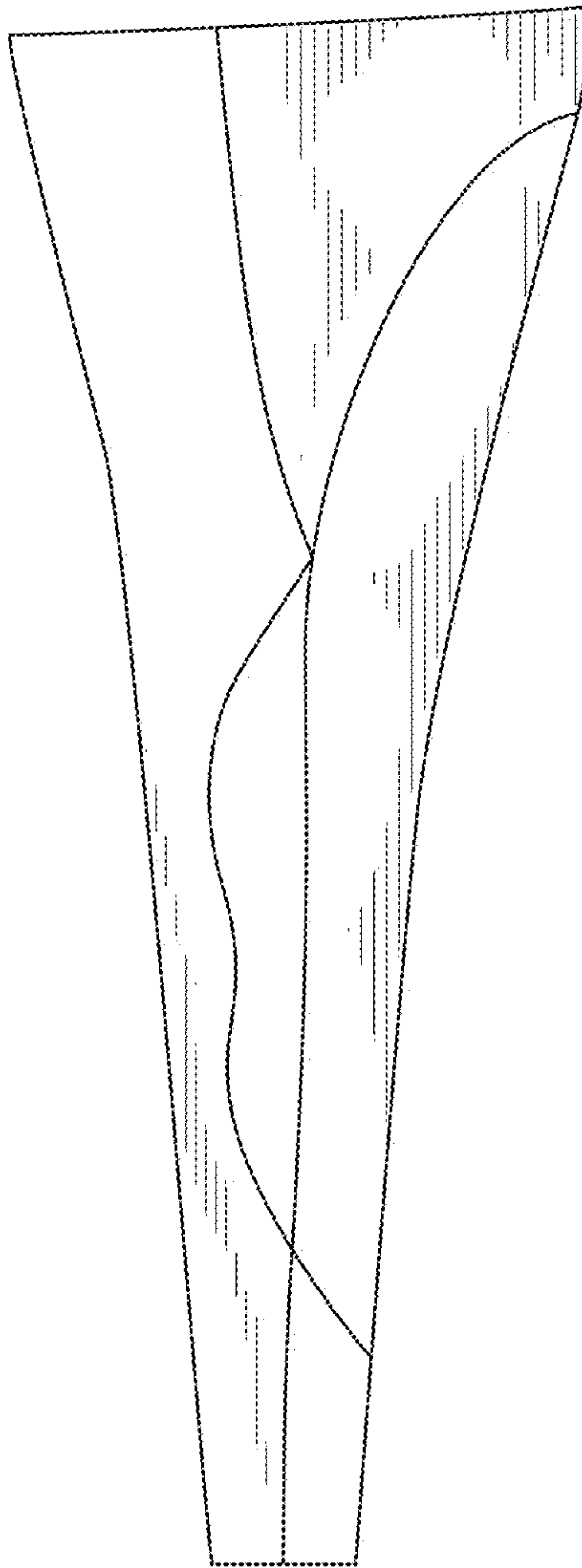
