DESCRIPTION

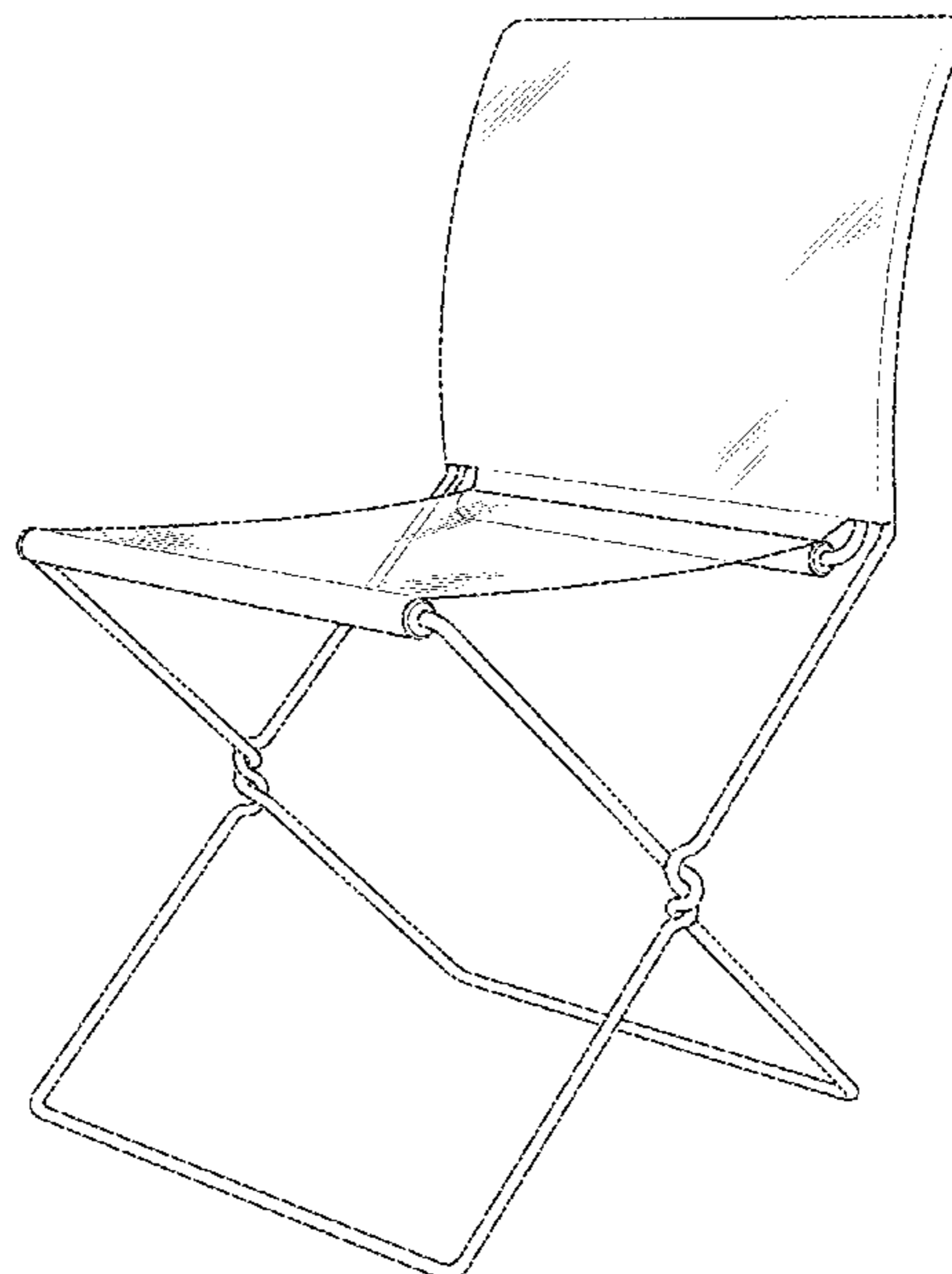
FIG. 1 is a perspective view of a folding chair in one position showing my new design;

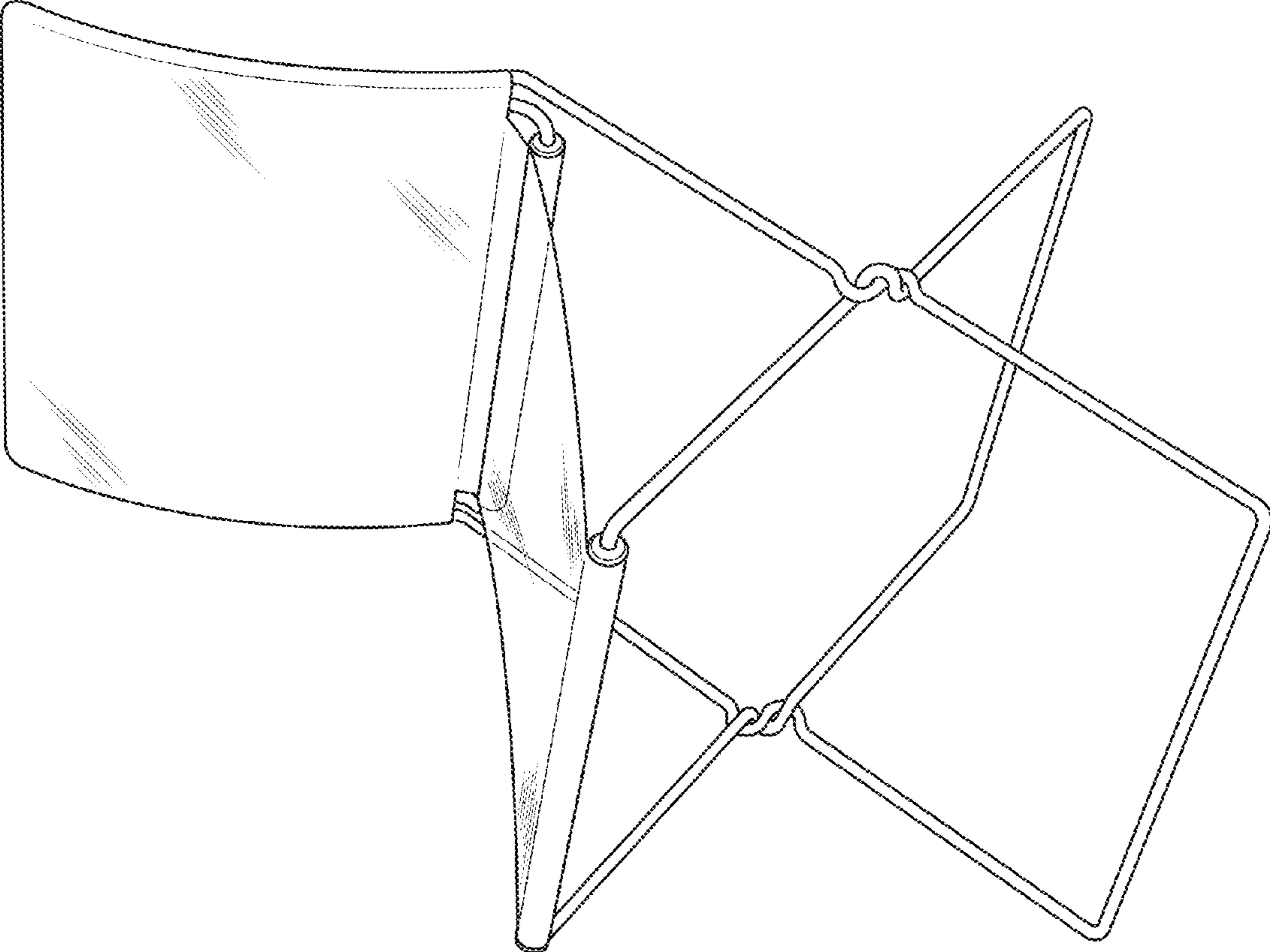

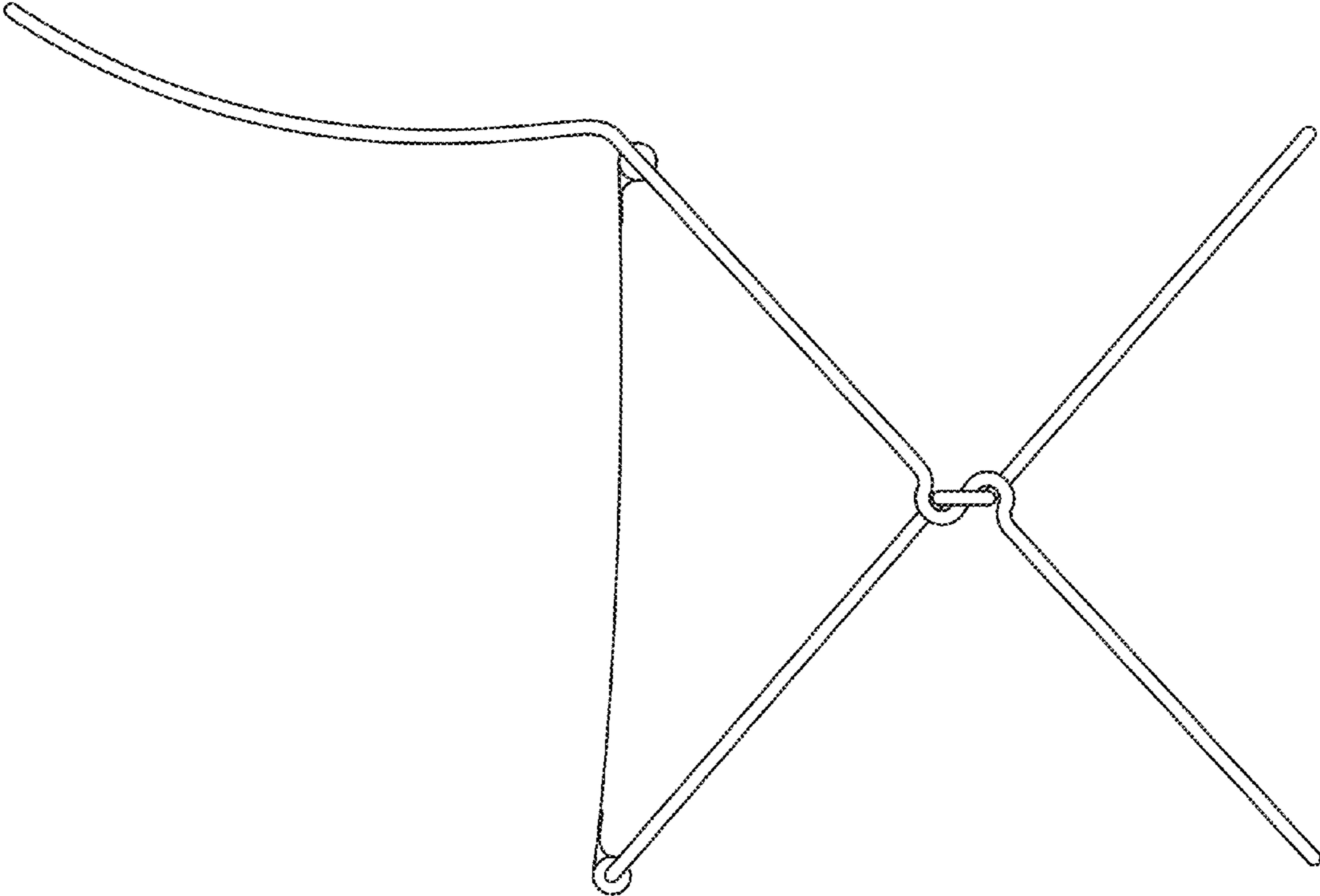

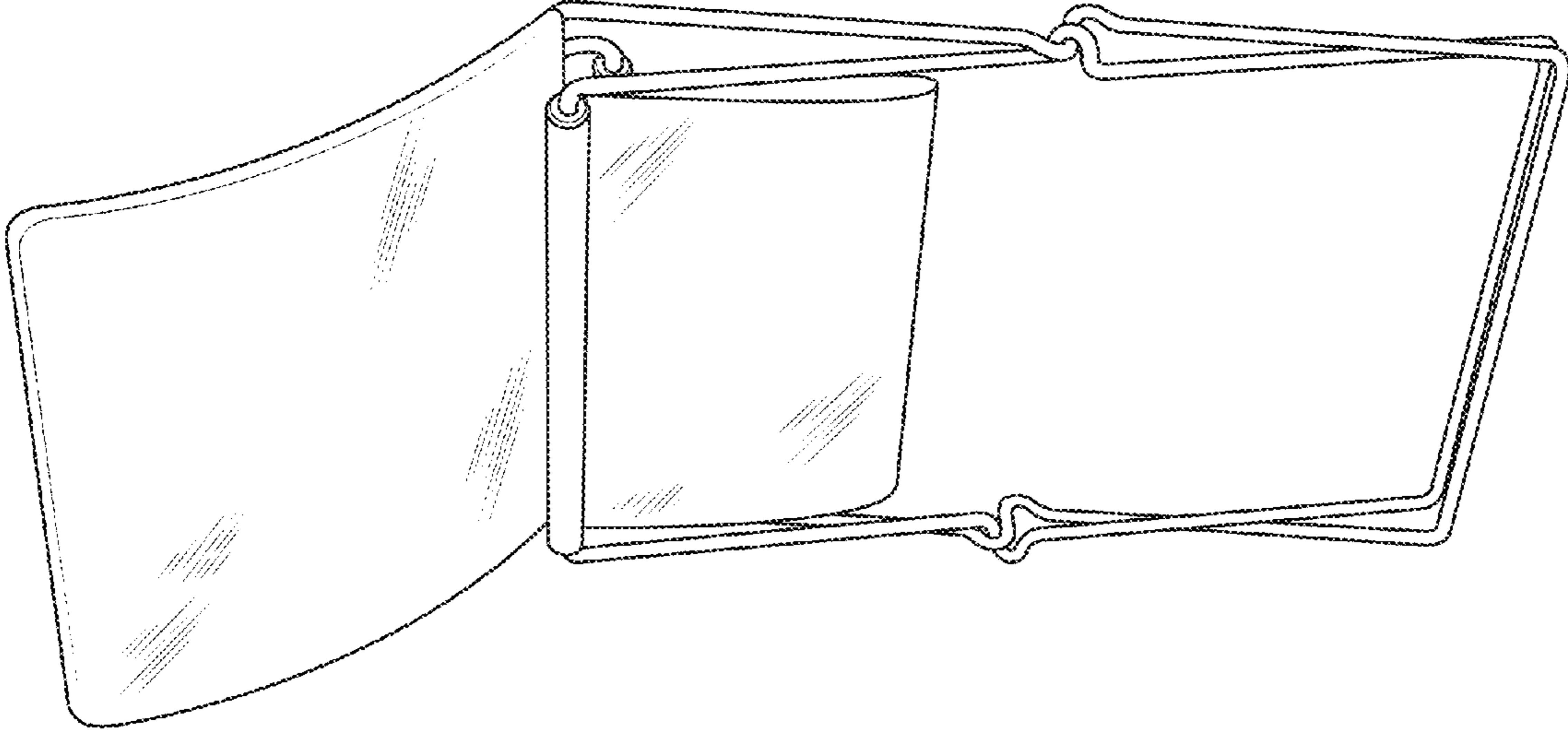

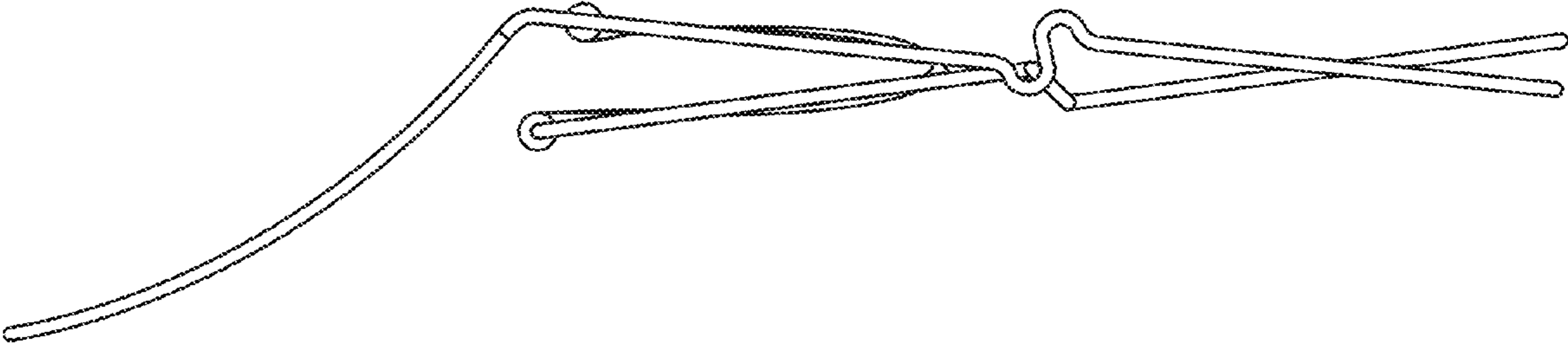
