(57) **CLAIM**

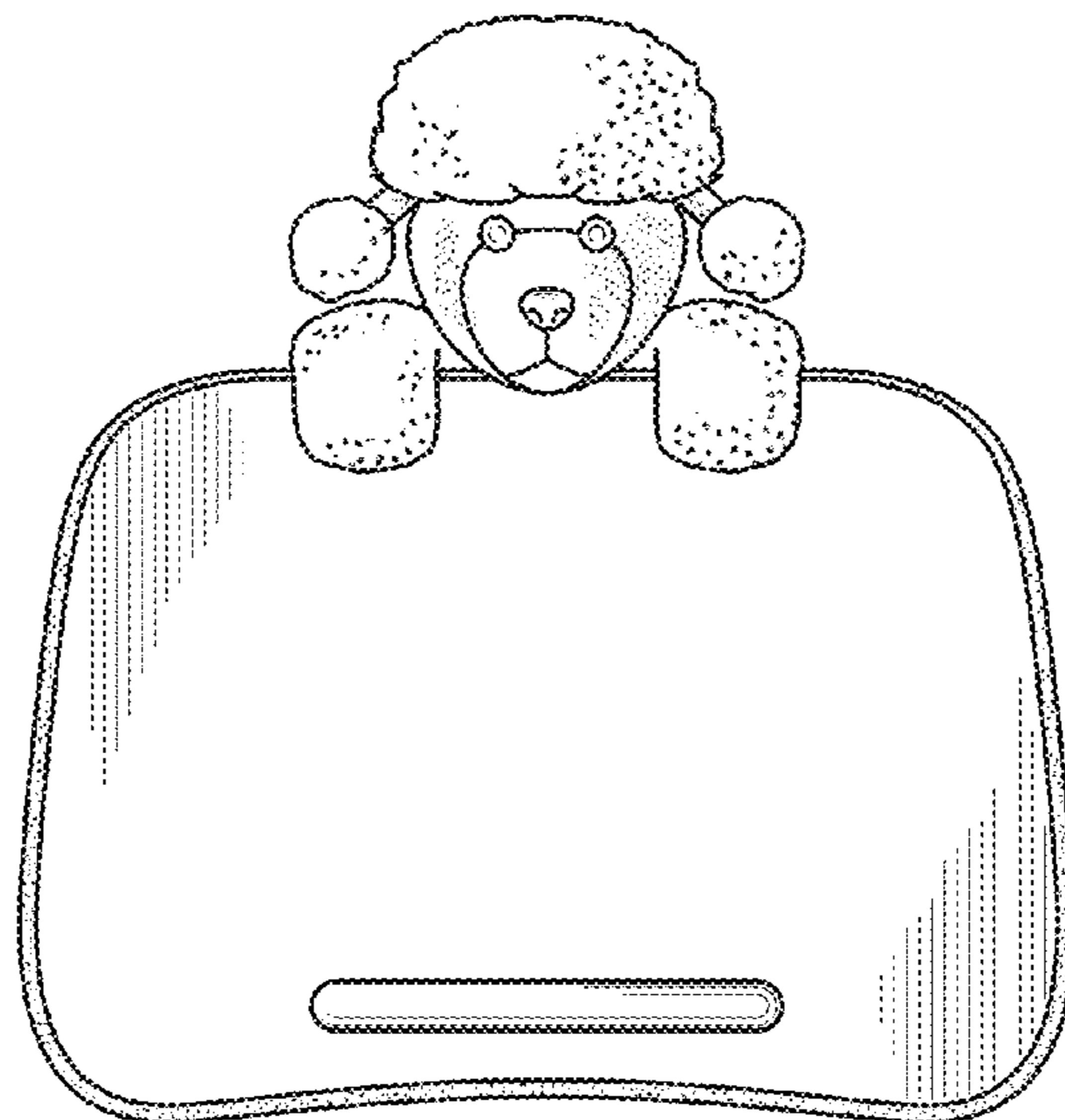
The ornamental design for a lap desk with a stuffed dog attached, as shown and described.

**DESCRIPTION**

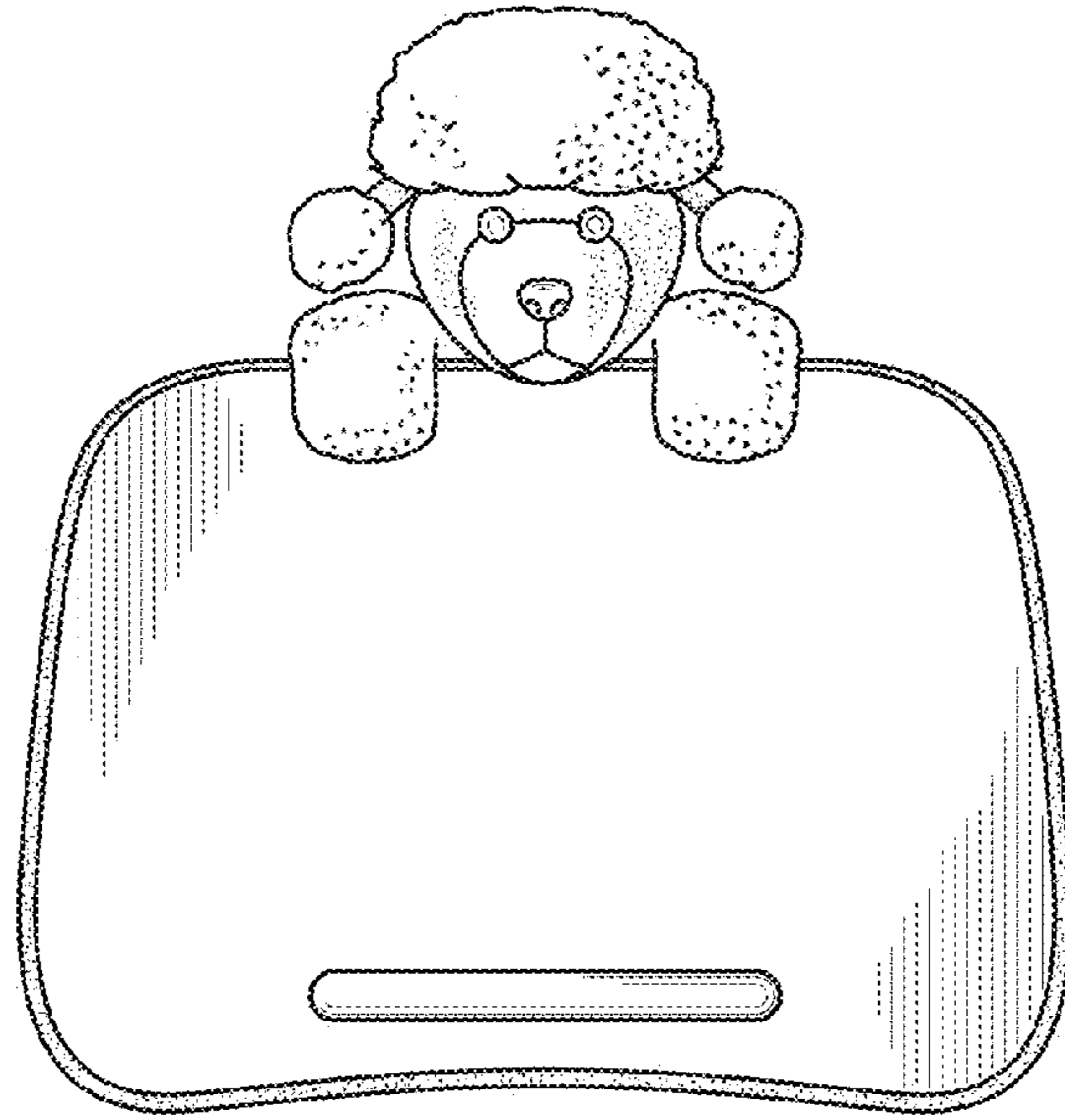

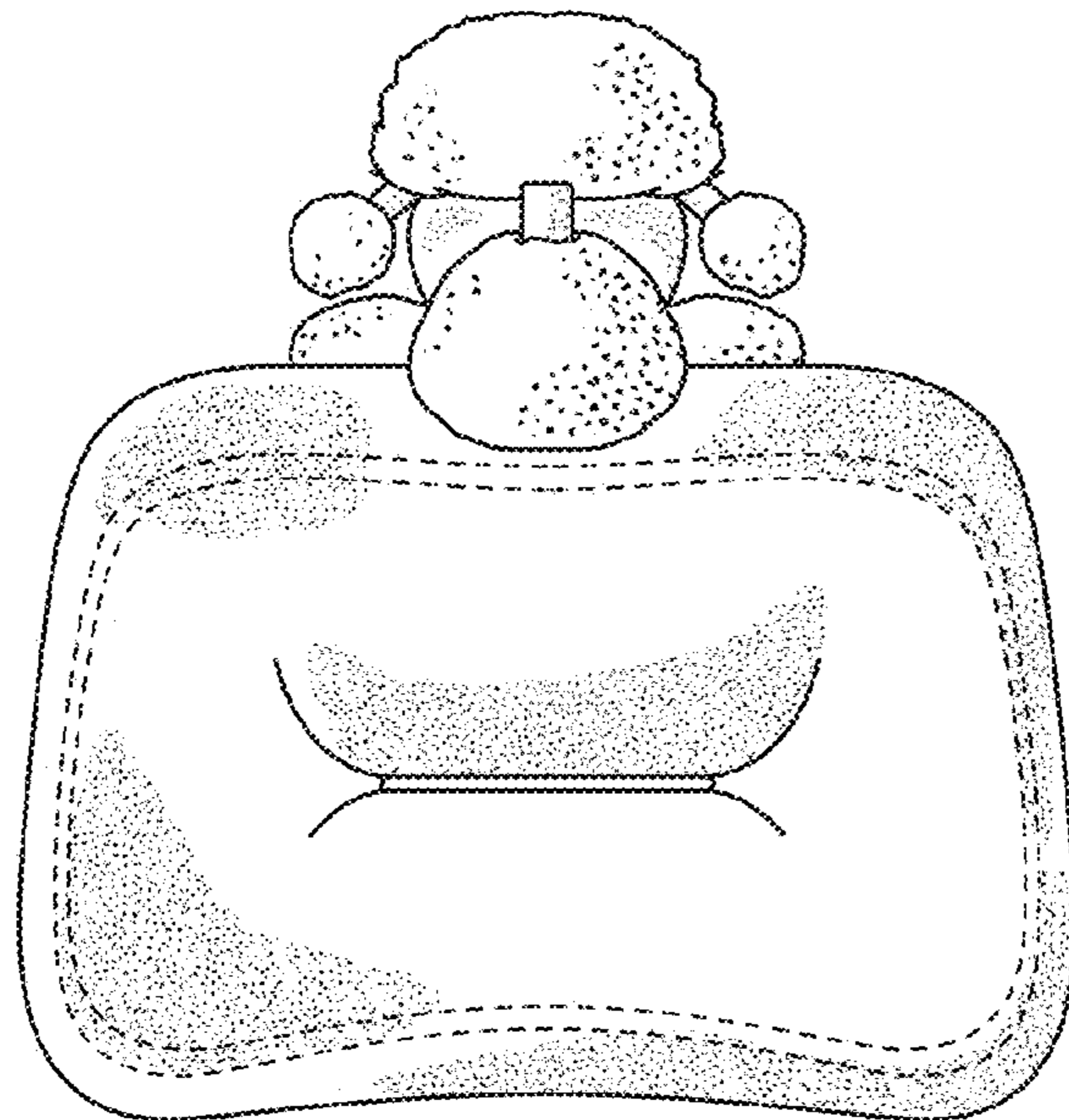

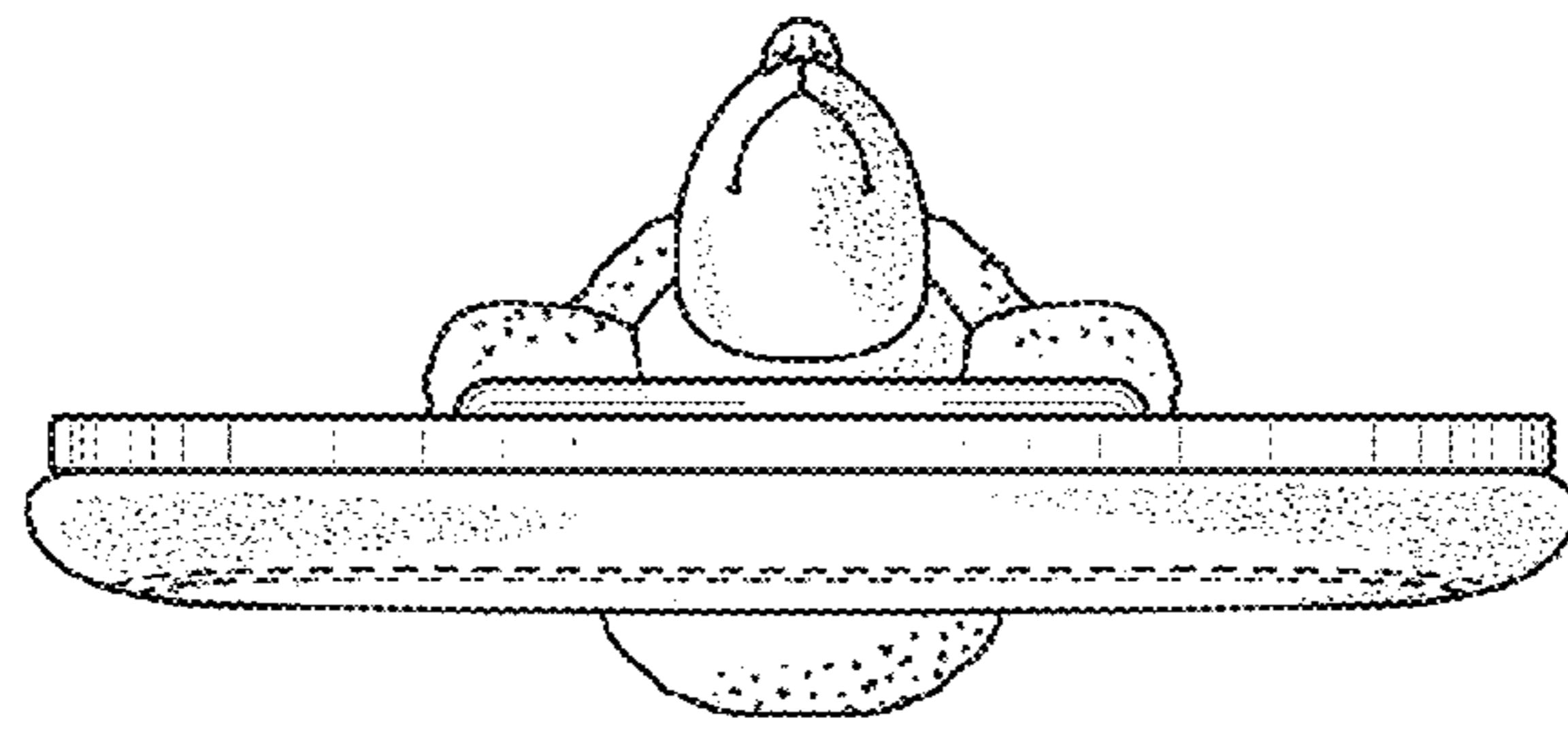

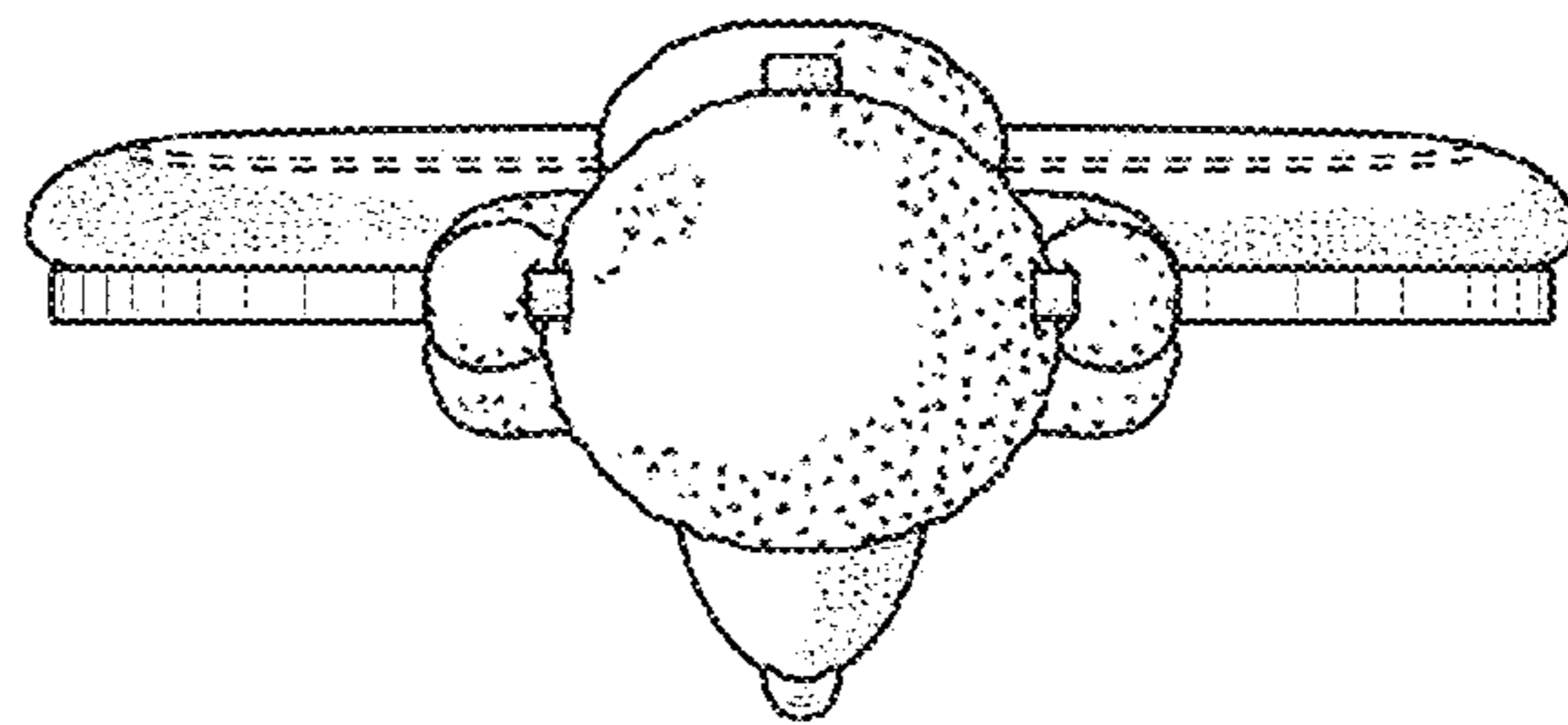

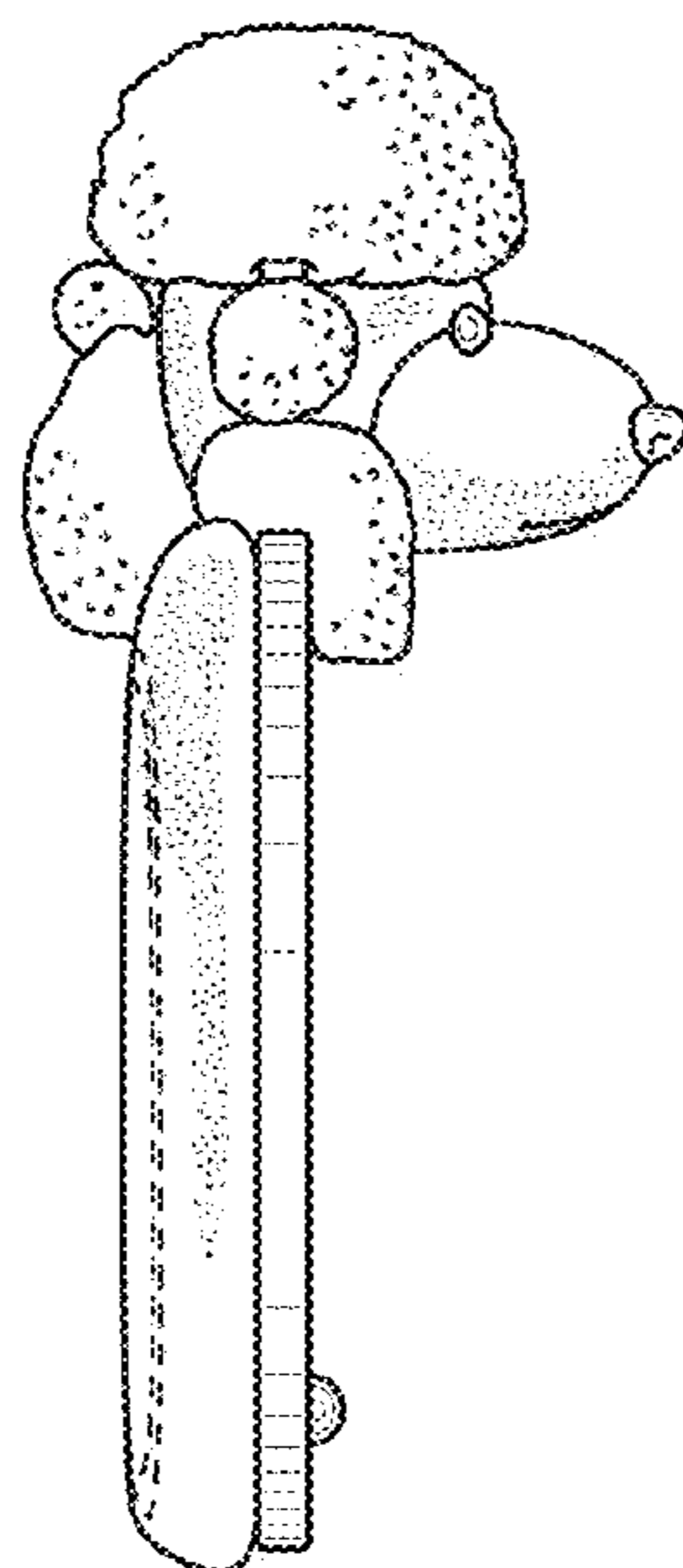
