FIG. 3 is a front edge view thereof;

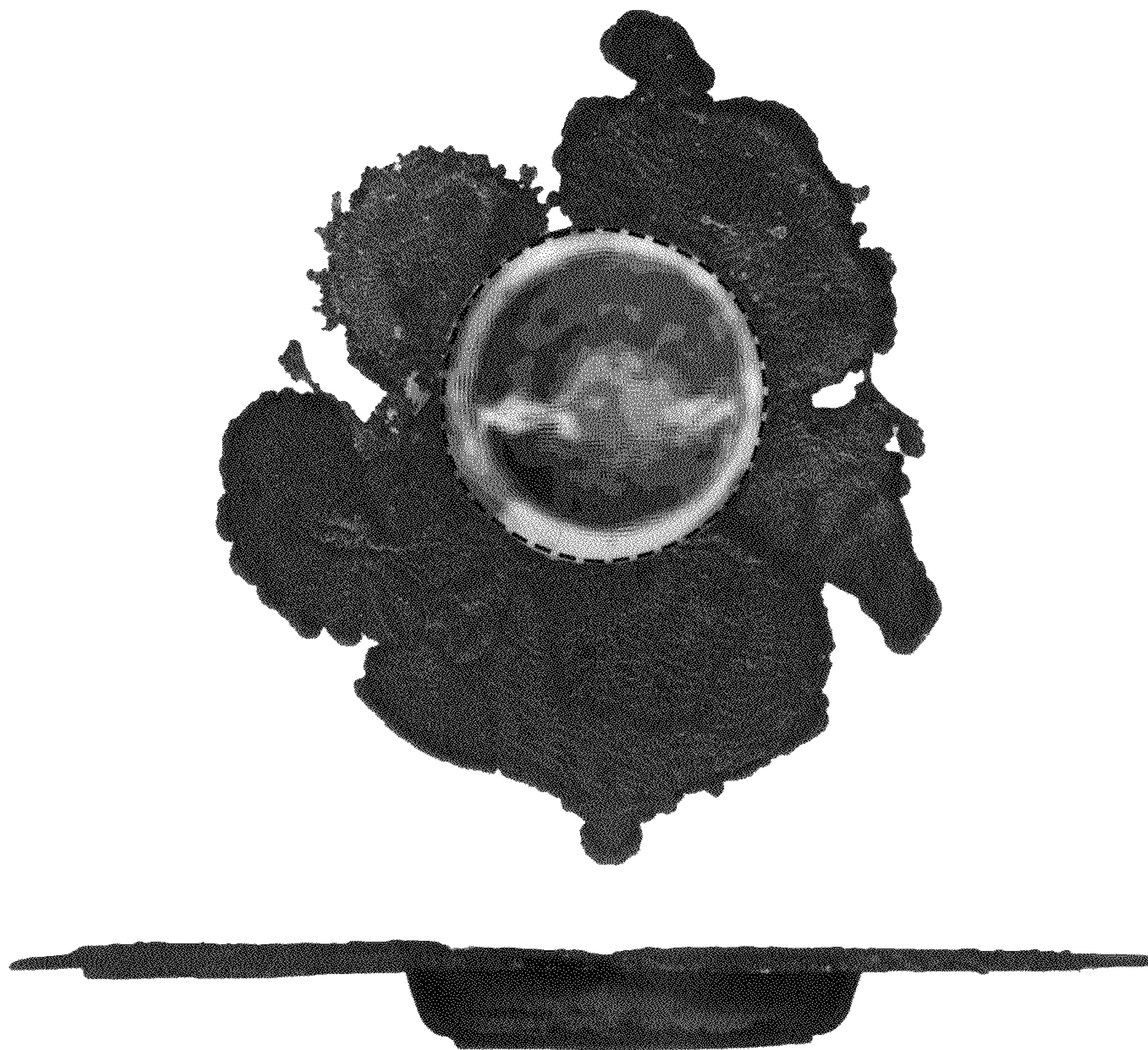
FIG. 4 is a right edge view thereof;

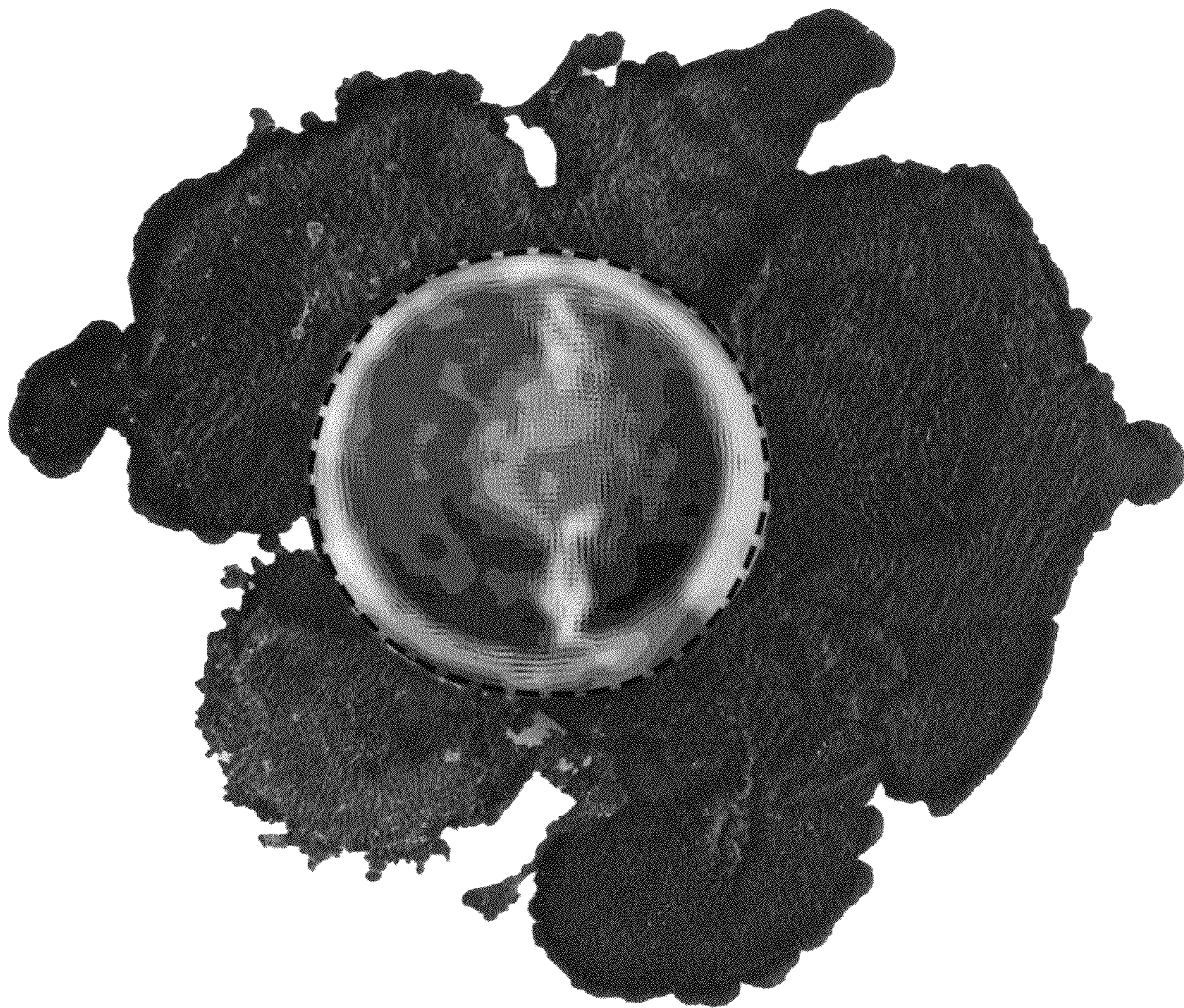

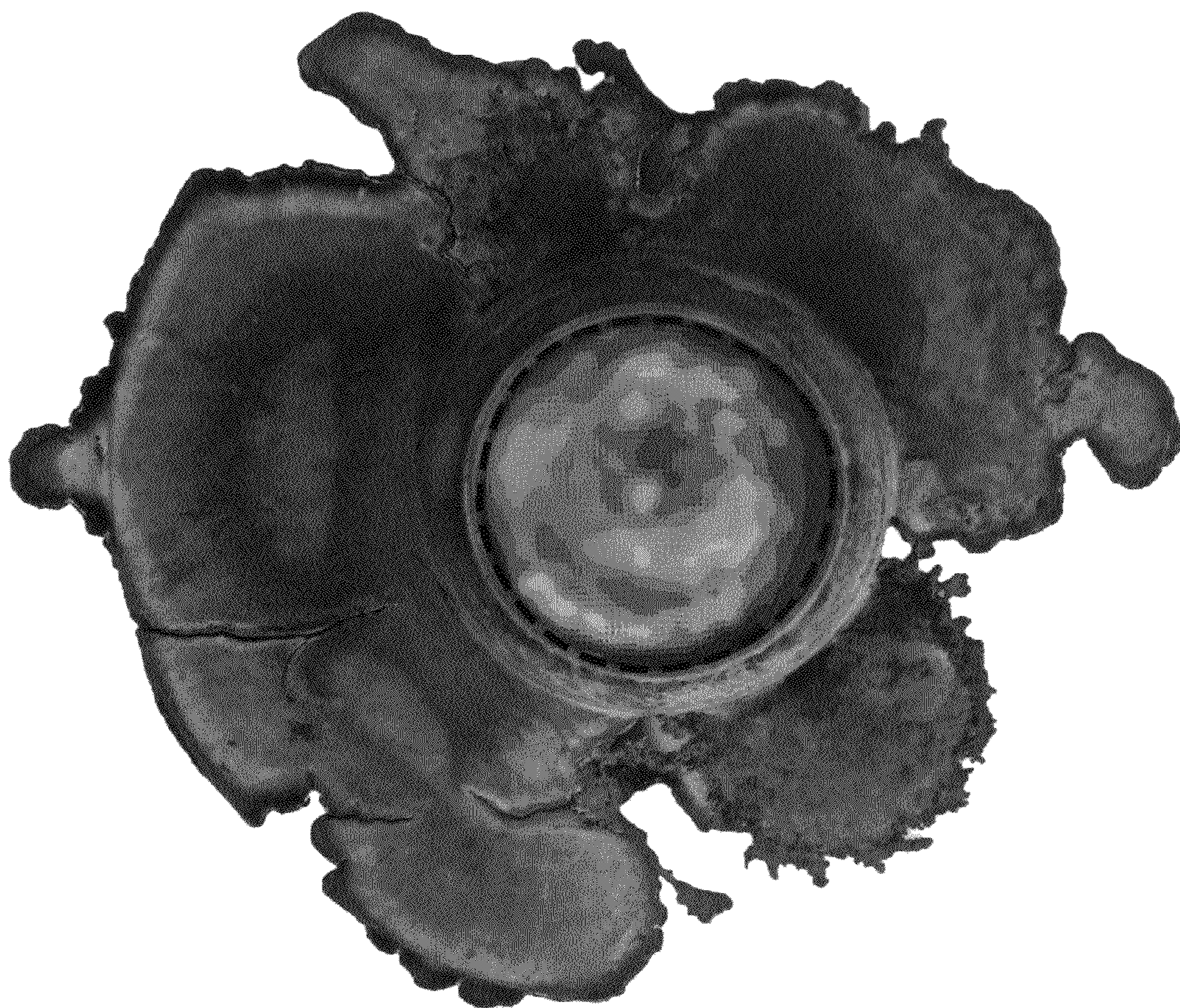

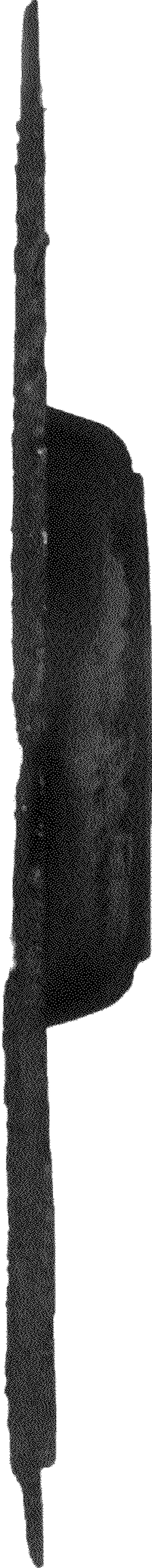

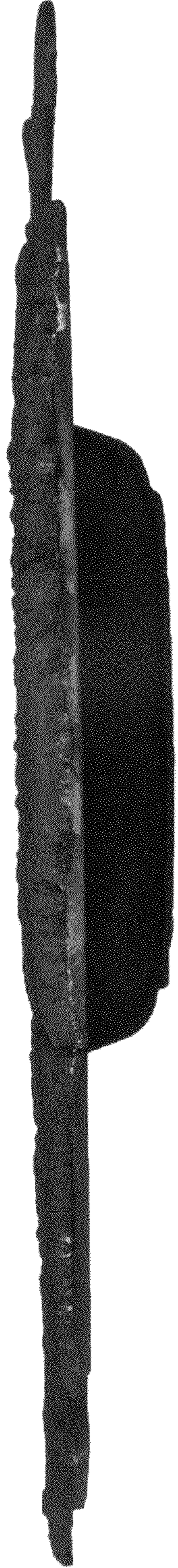

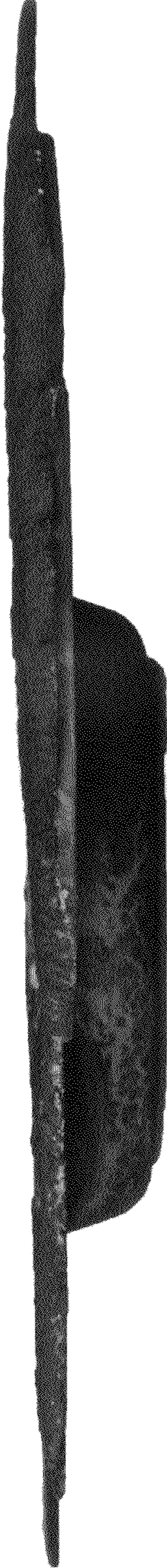
