The ornamental design for a knife, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view as seen from the upper left of a knife showing my new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a left side view thereof, the right side view being a mirror image thereof;
FIG. 5 is an end view thereof as seen from the blade end; and,
FIG. 6 is an end view thereof as seen from the handle end.

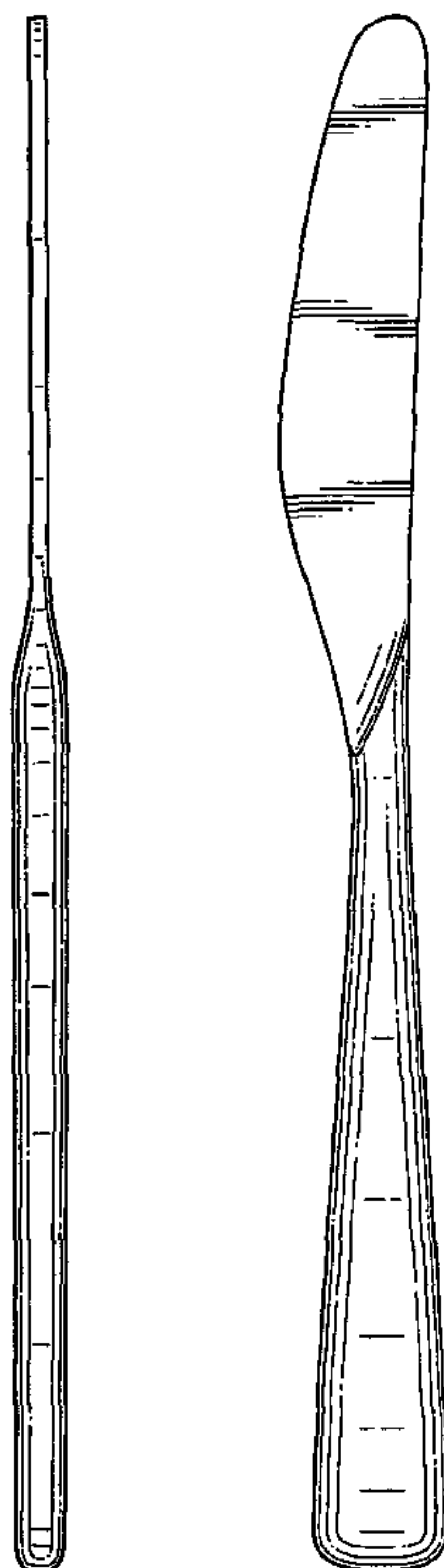

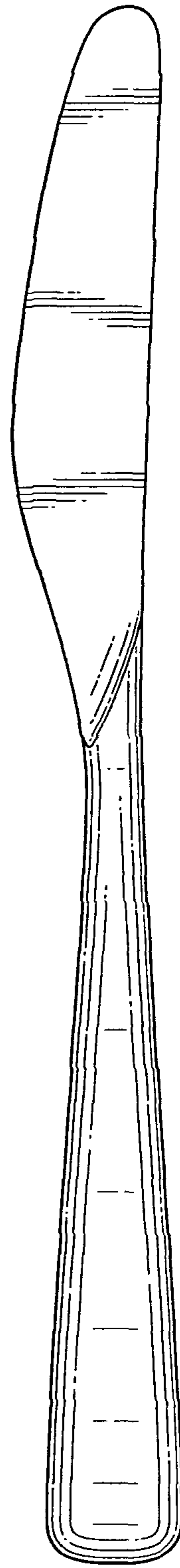

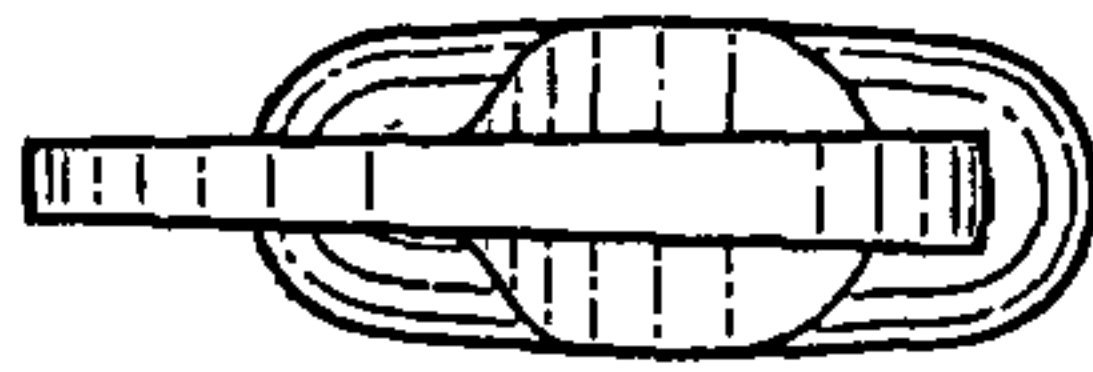

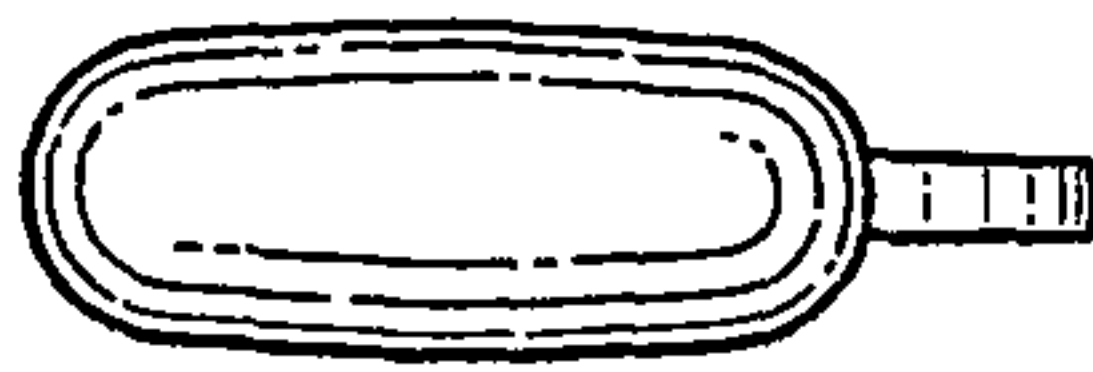
