We claim the ornamental design of a beverage carafe having  
a handle, as shown and described.

**DESCRIPTION**

FIG. 3;

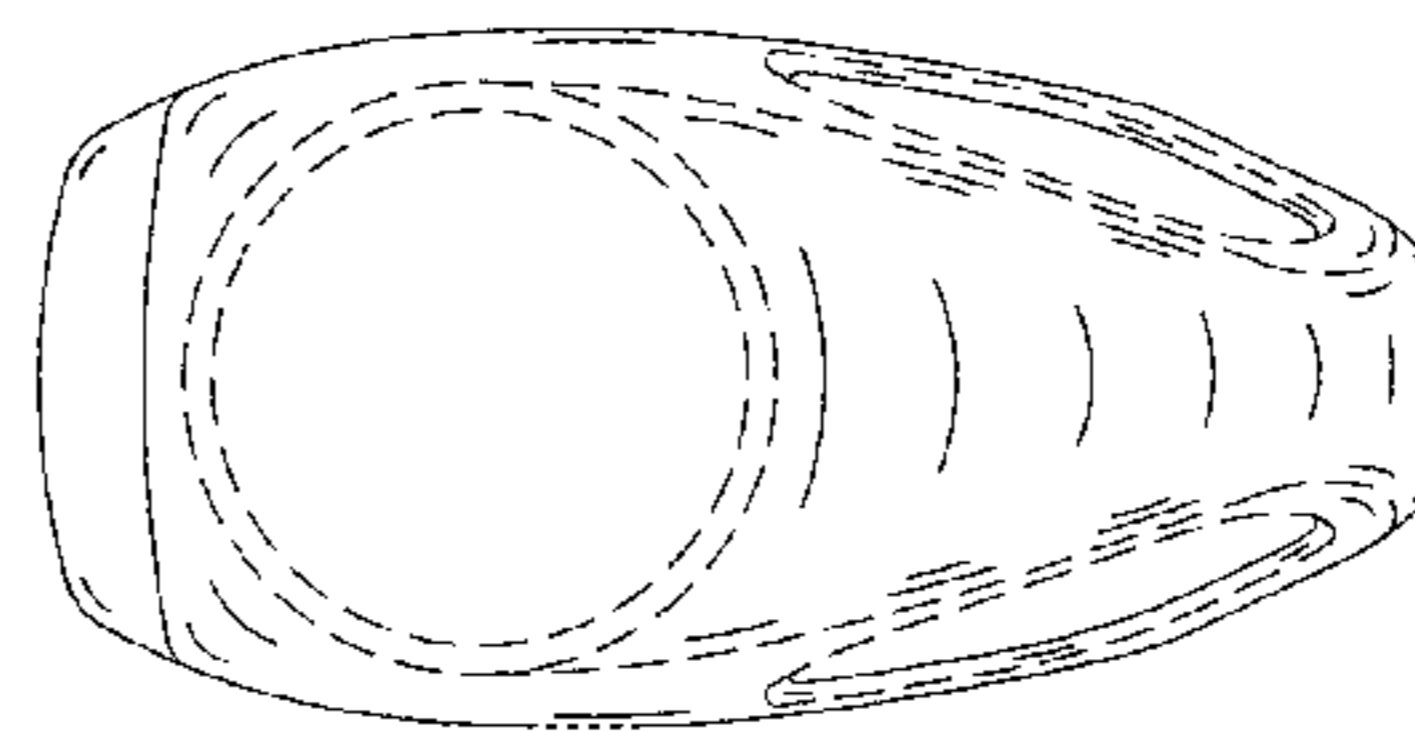
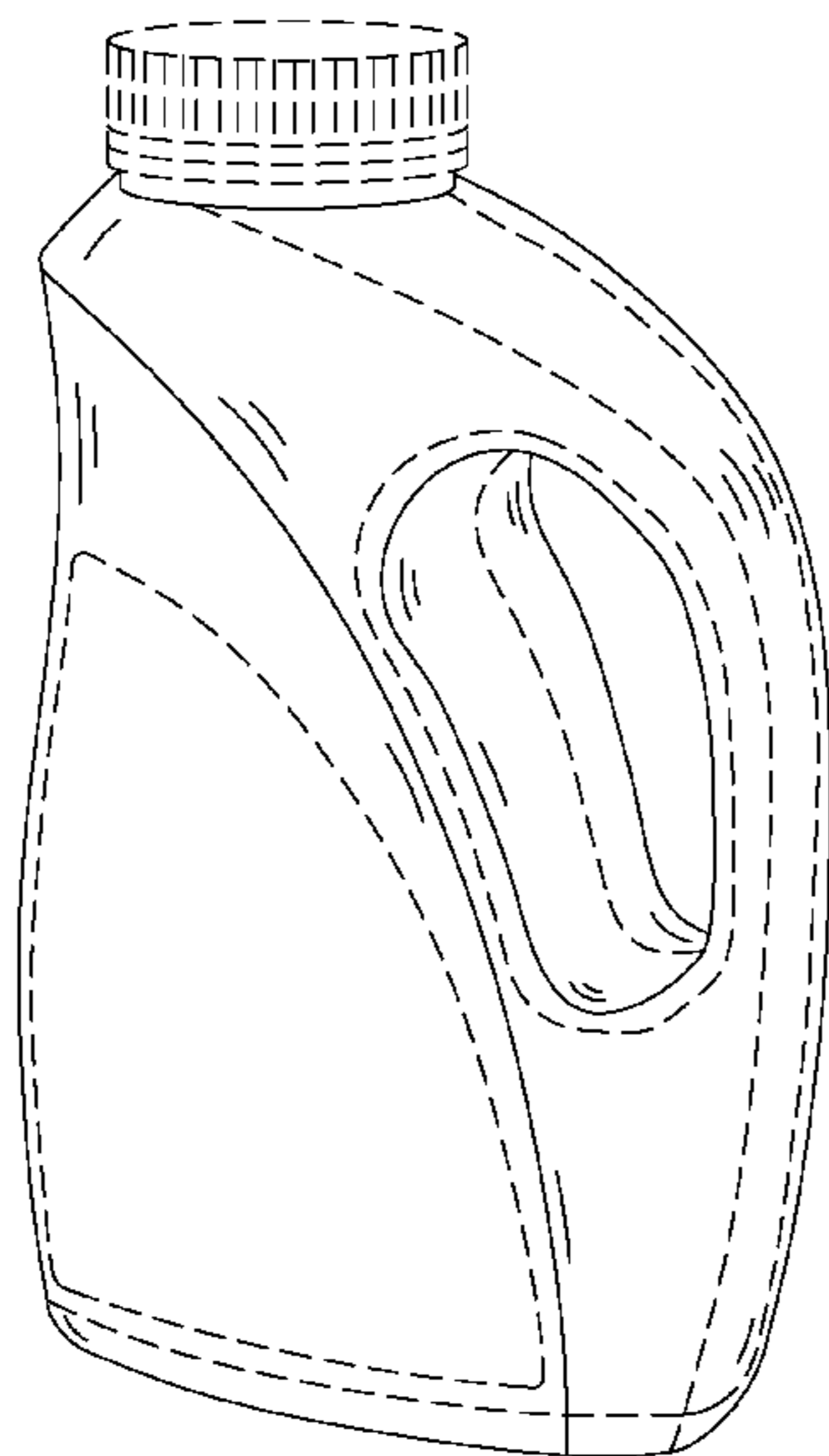
FIG. 5 is a fourth side view thereof, being the opposite side of

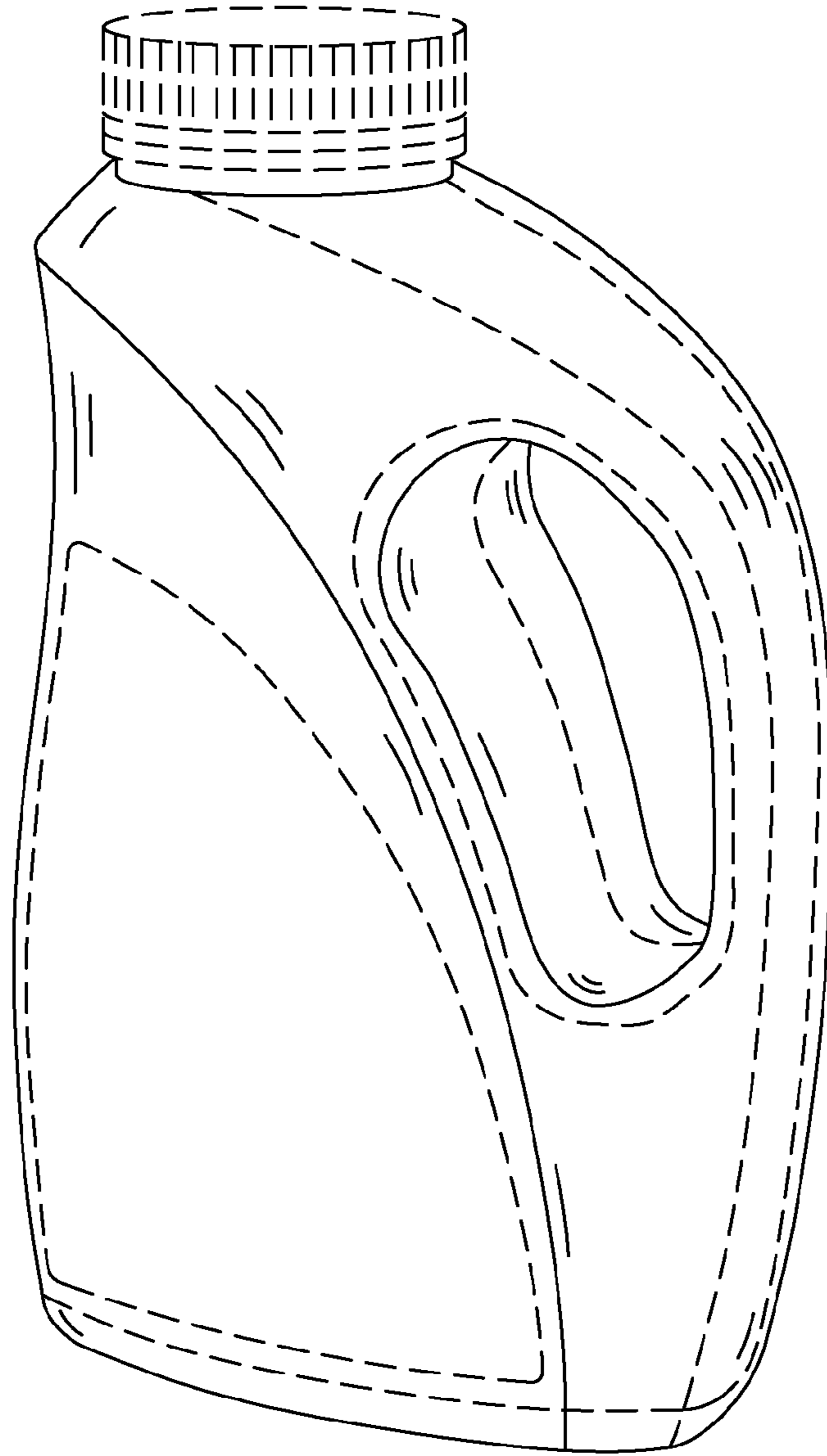

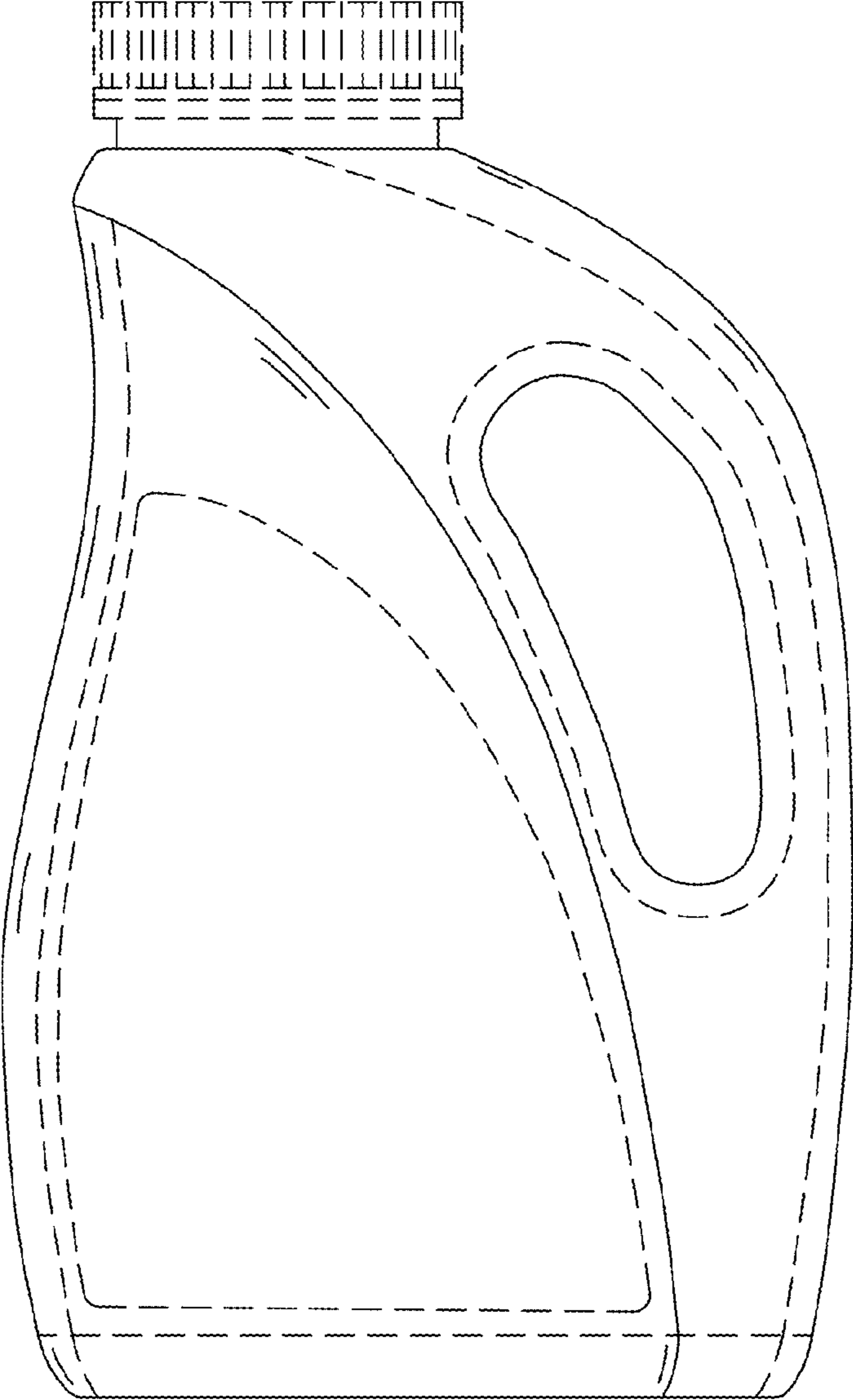

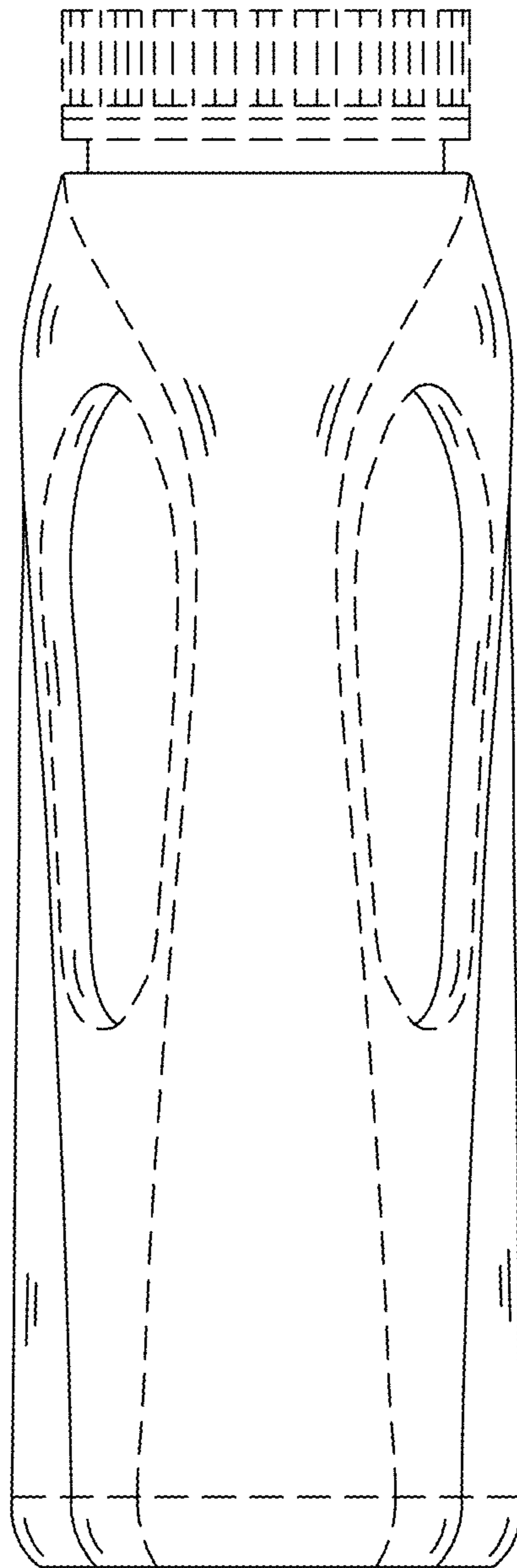

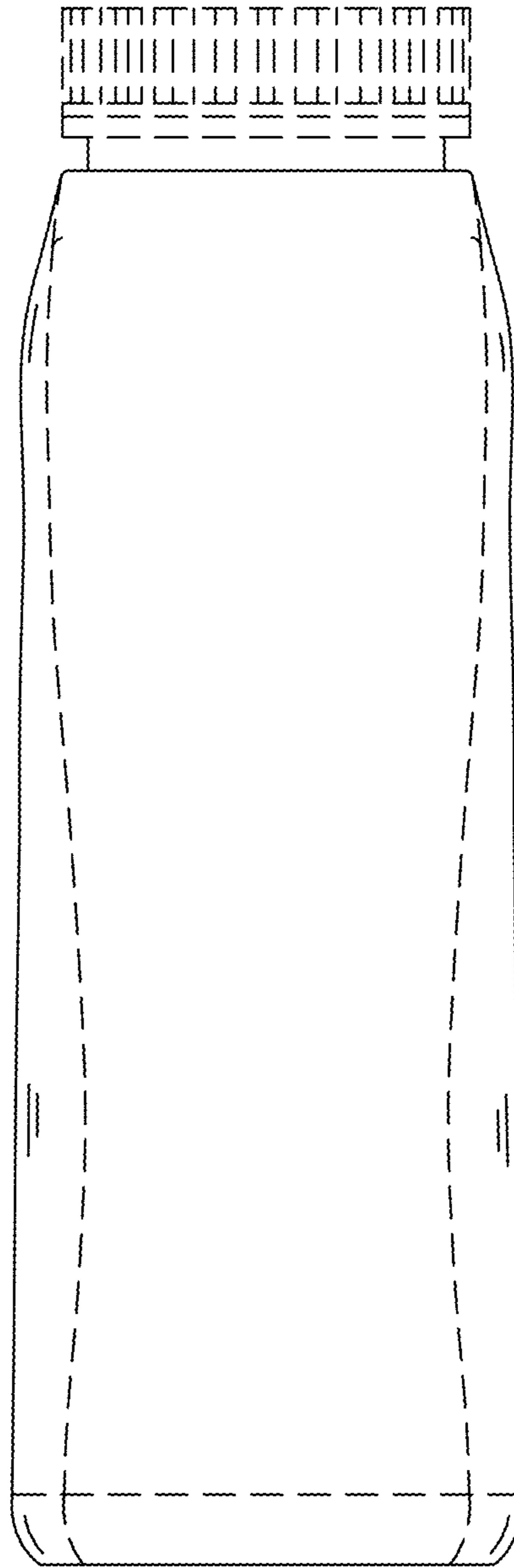

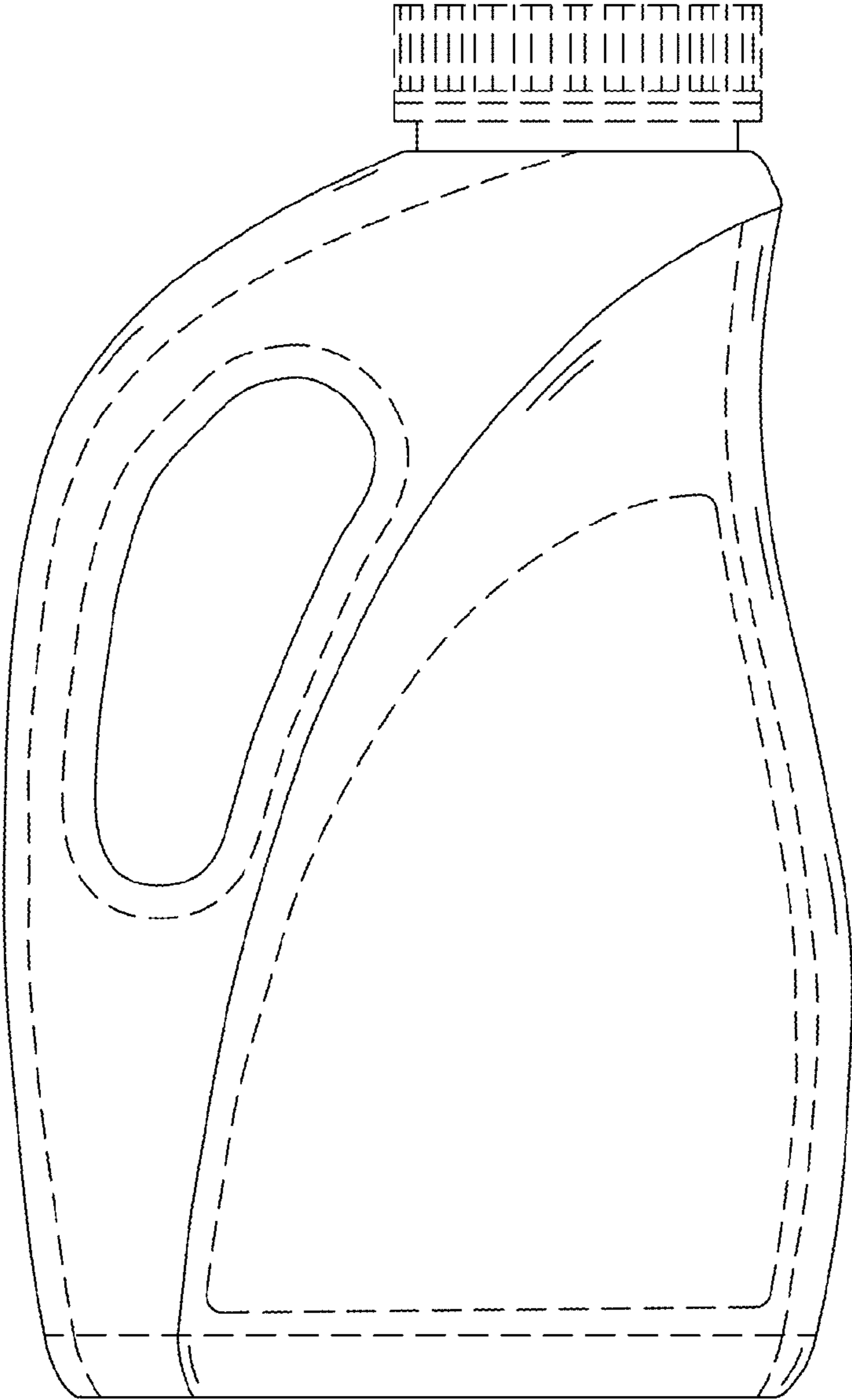

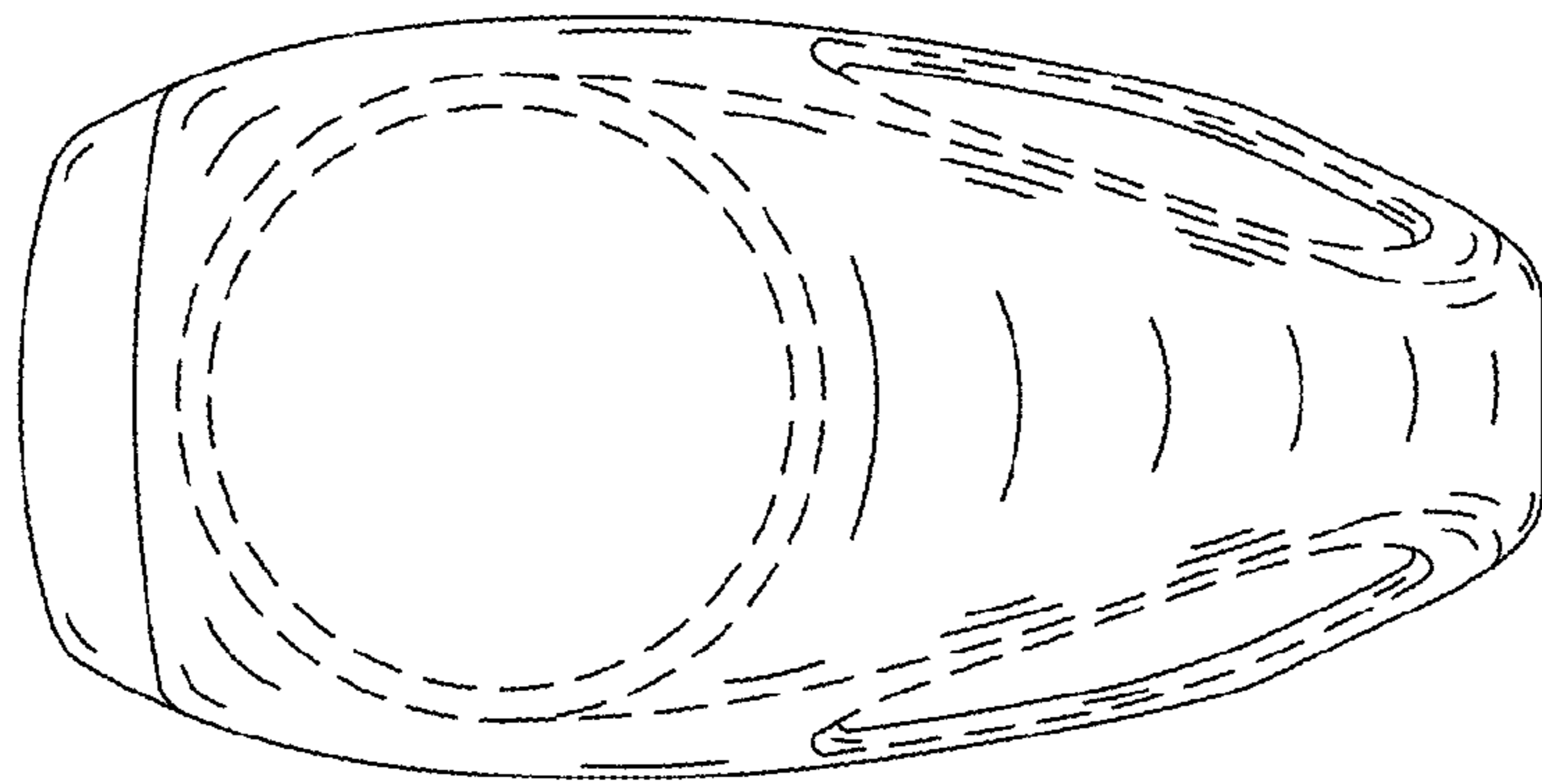

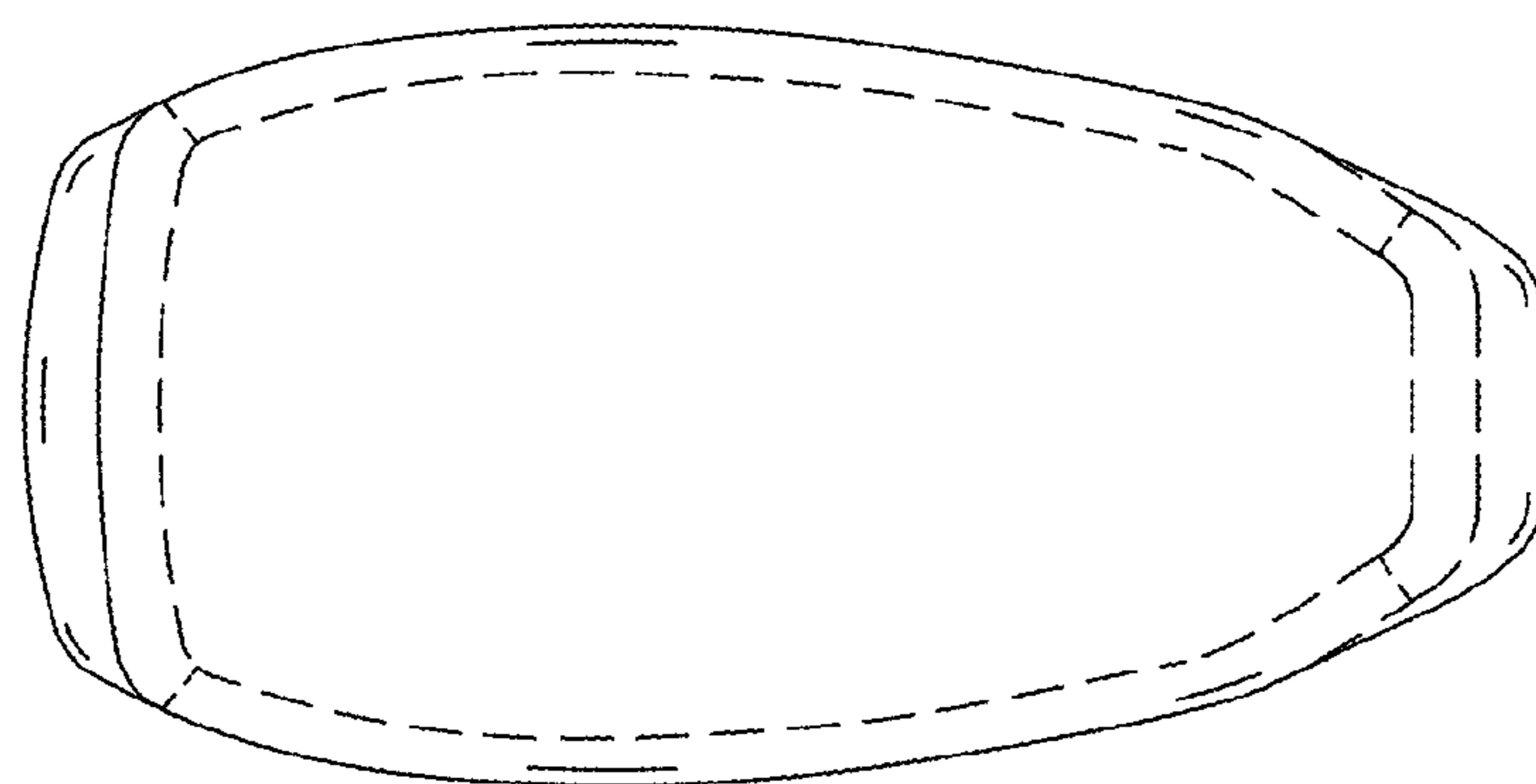
