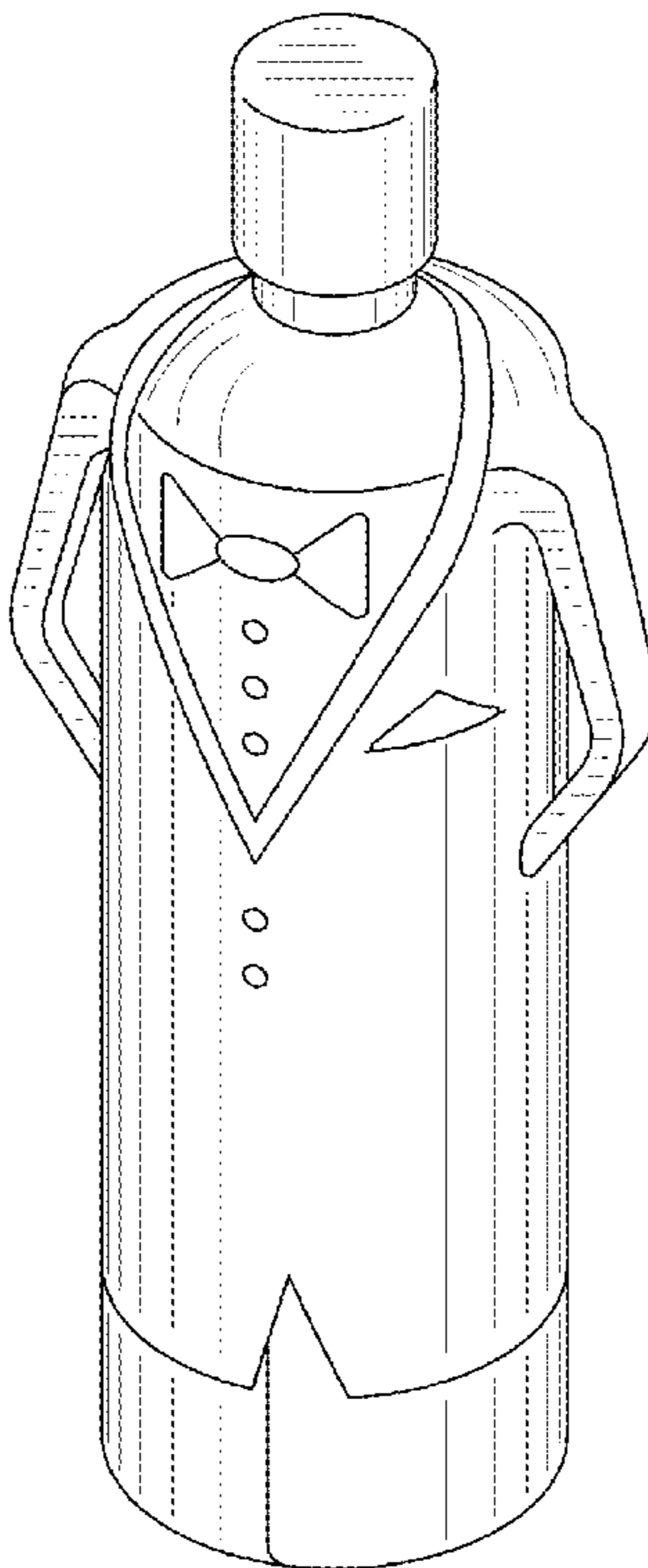
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an exploded top perspective view of a bottle, showing my new design;

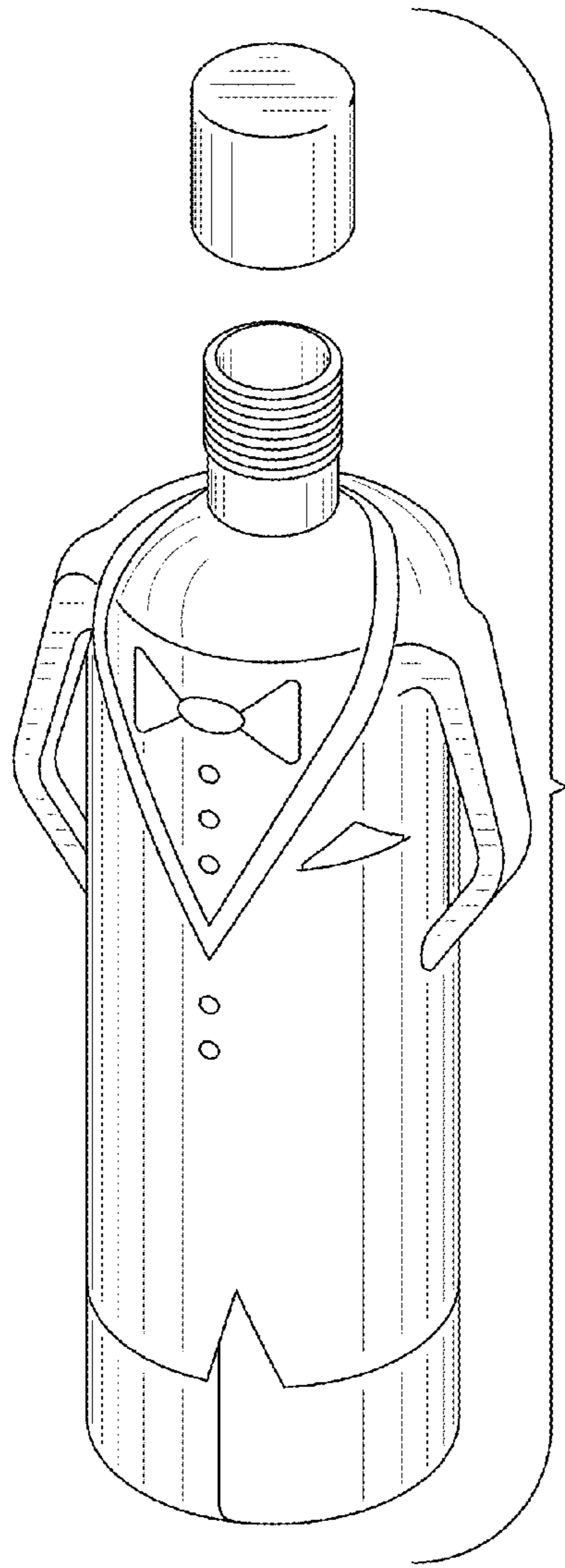

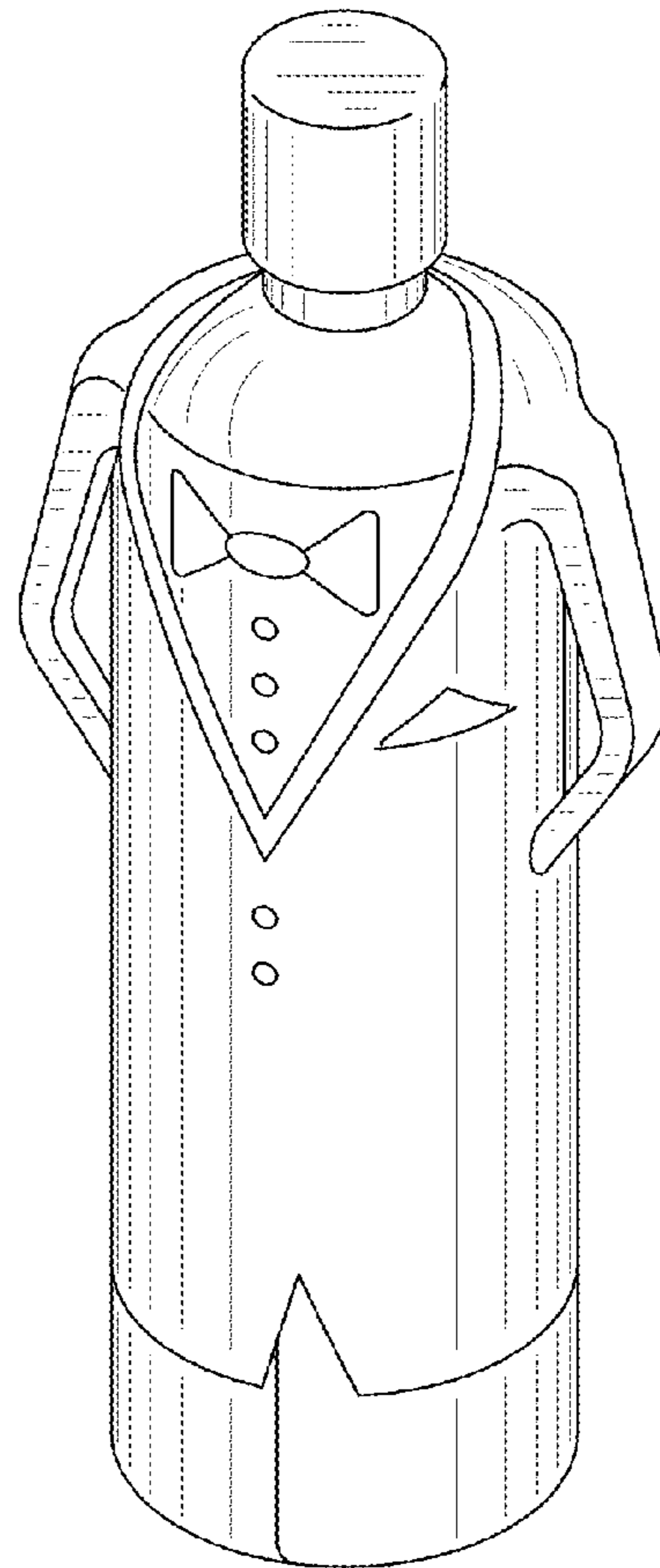

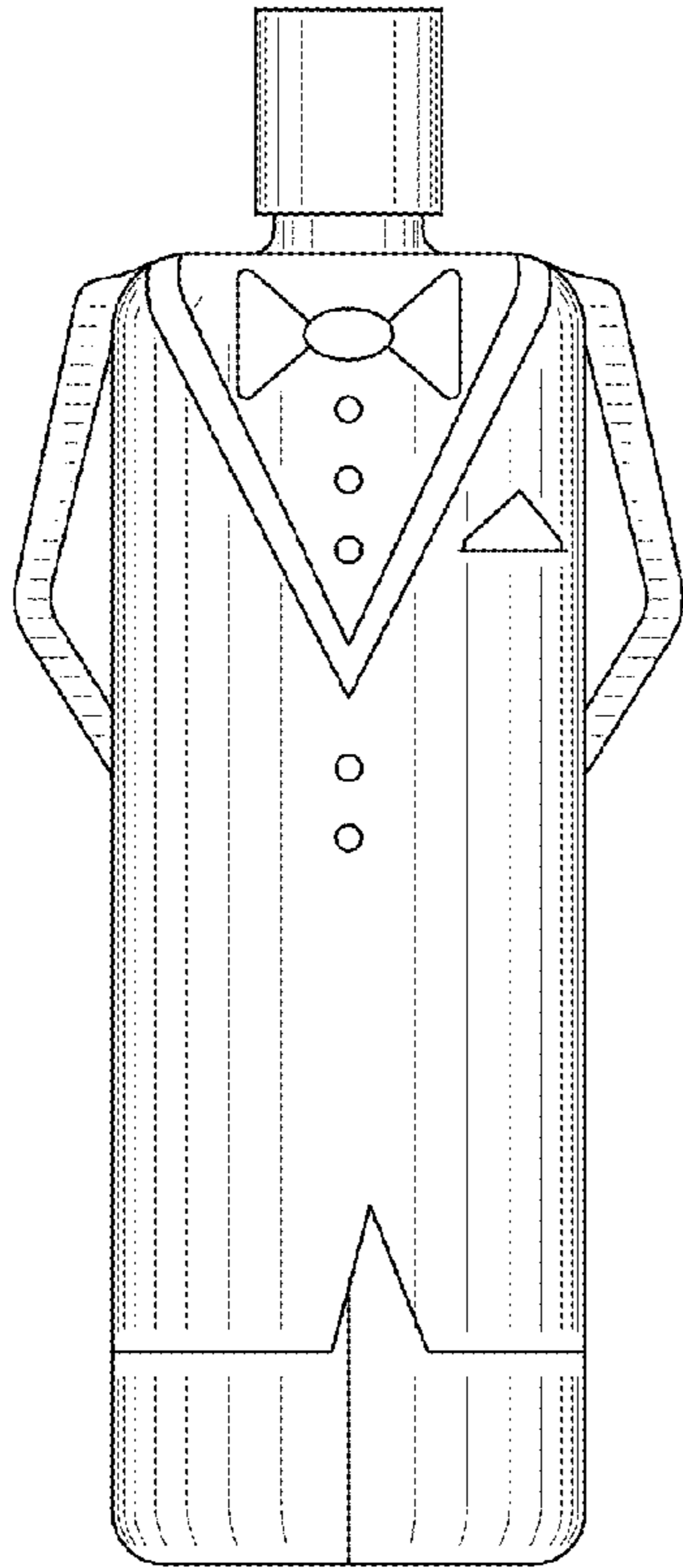

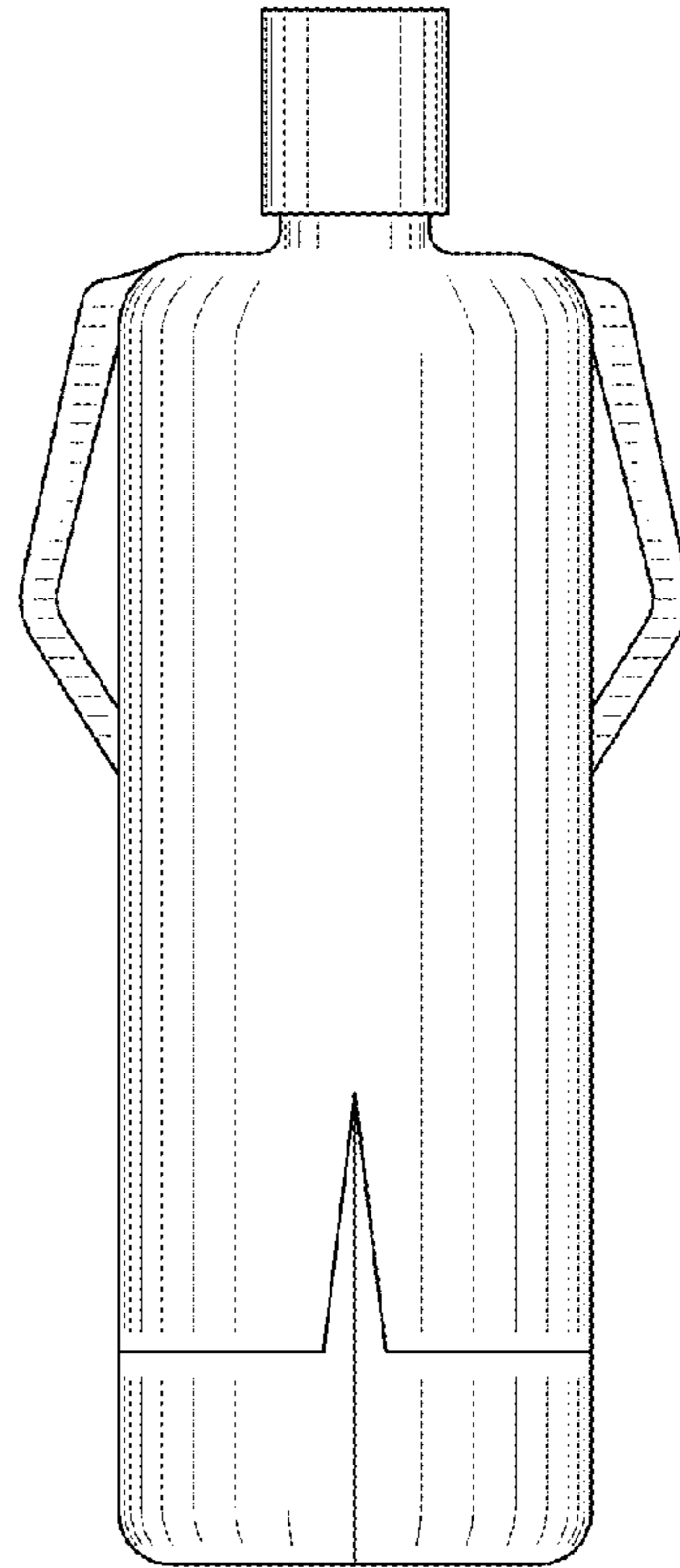

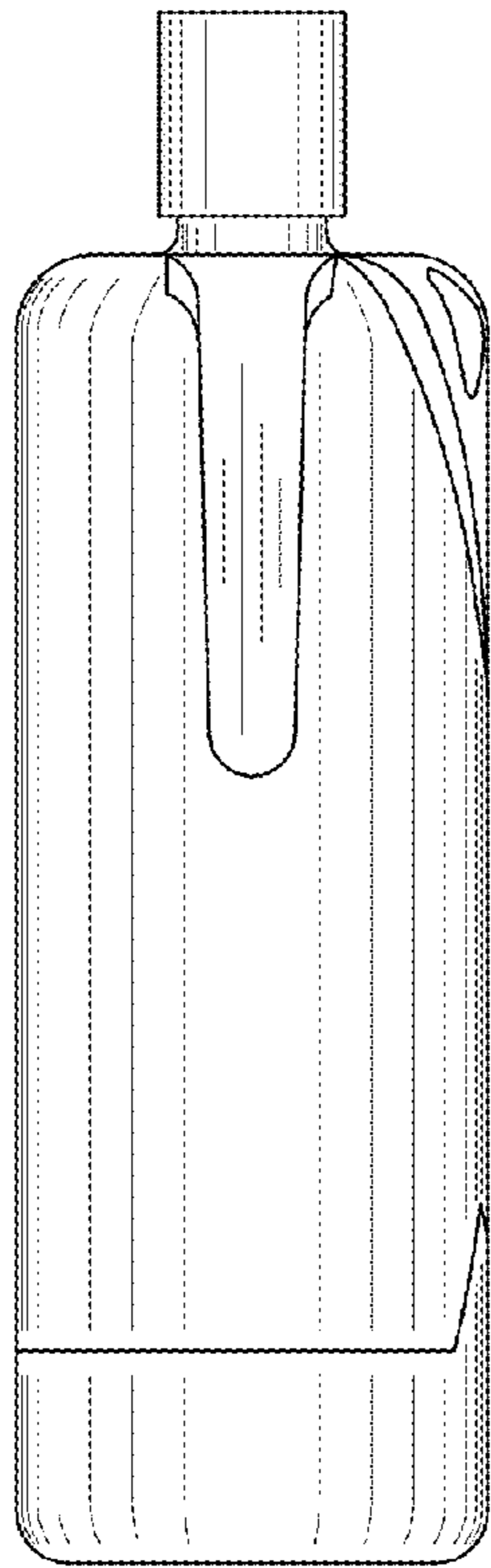

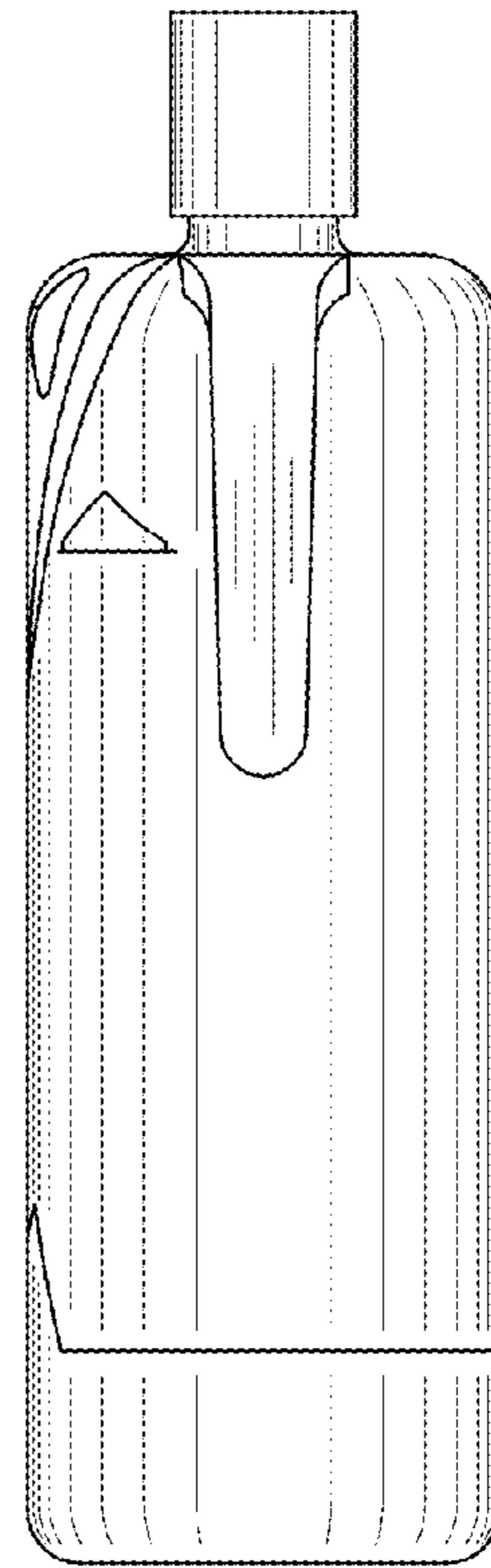

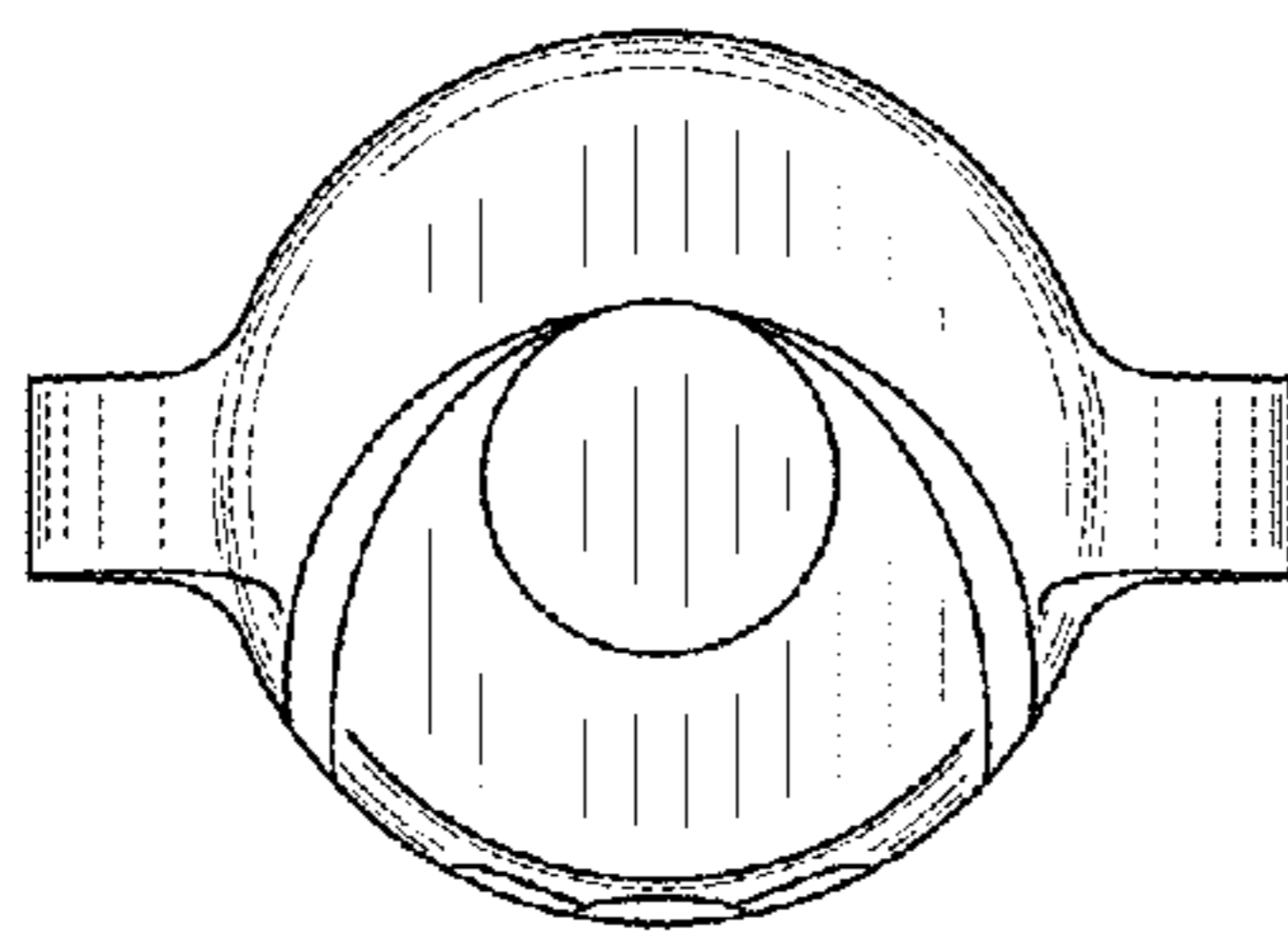

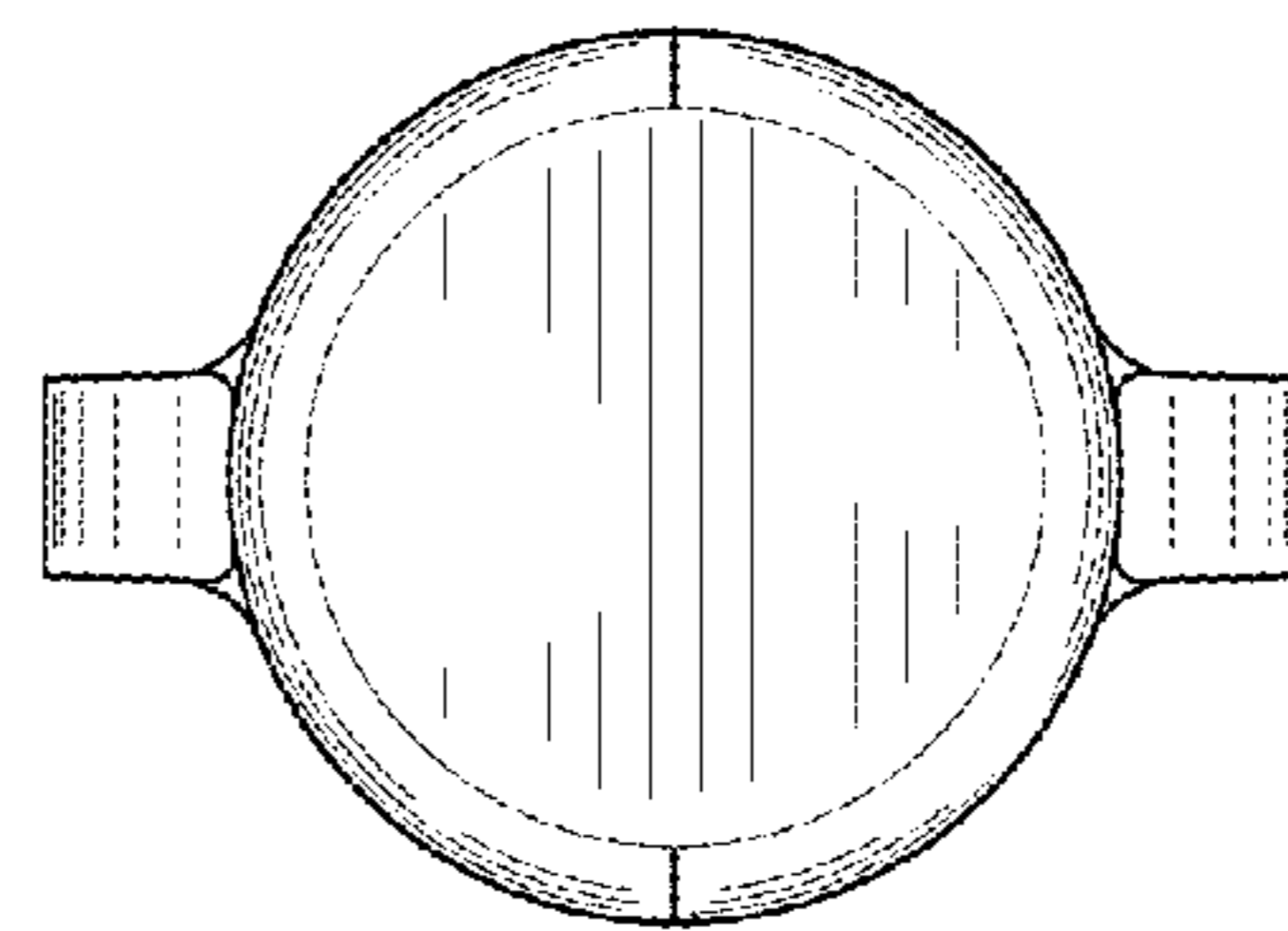
