(57) **CLAIM**

The ornamental design for a band for a display of gift bags, as shown and described.

**DESCRIPTION**

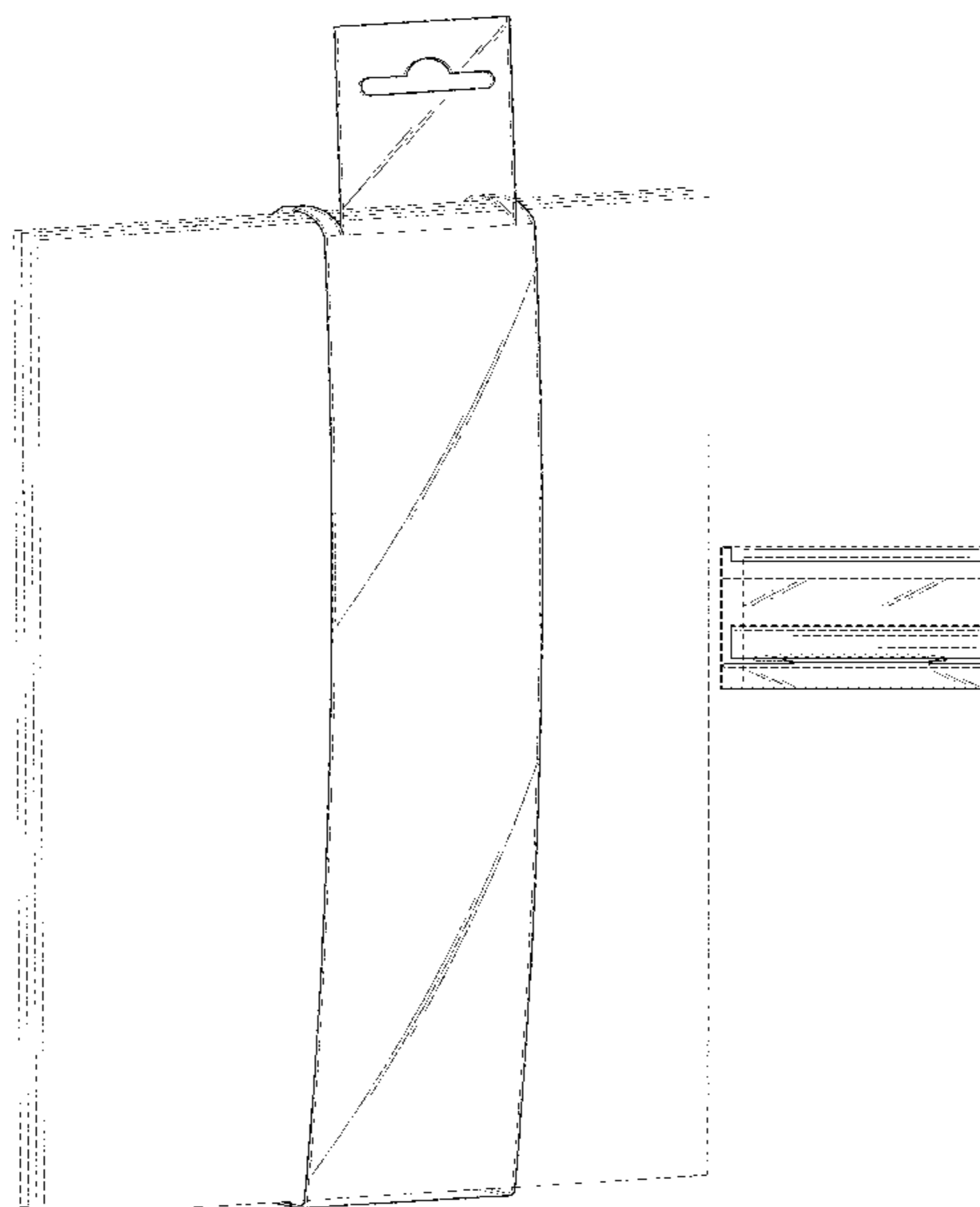
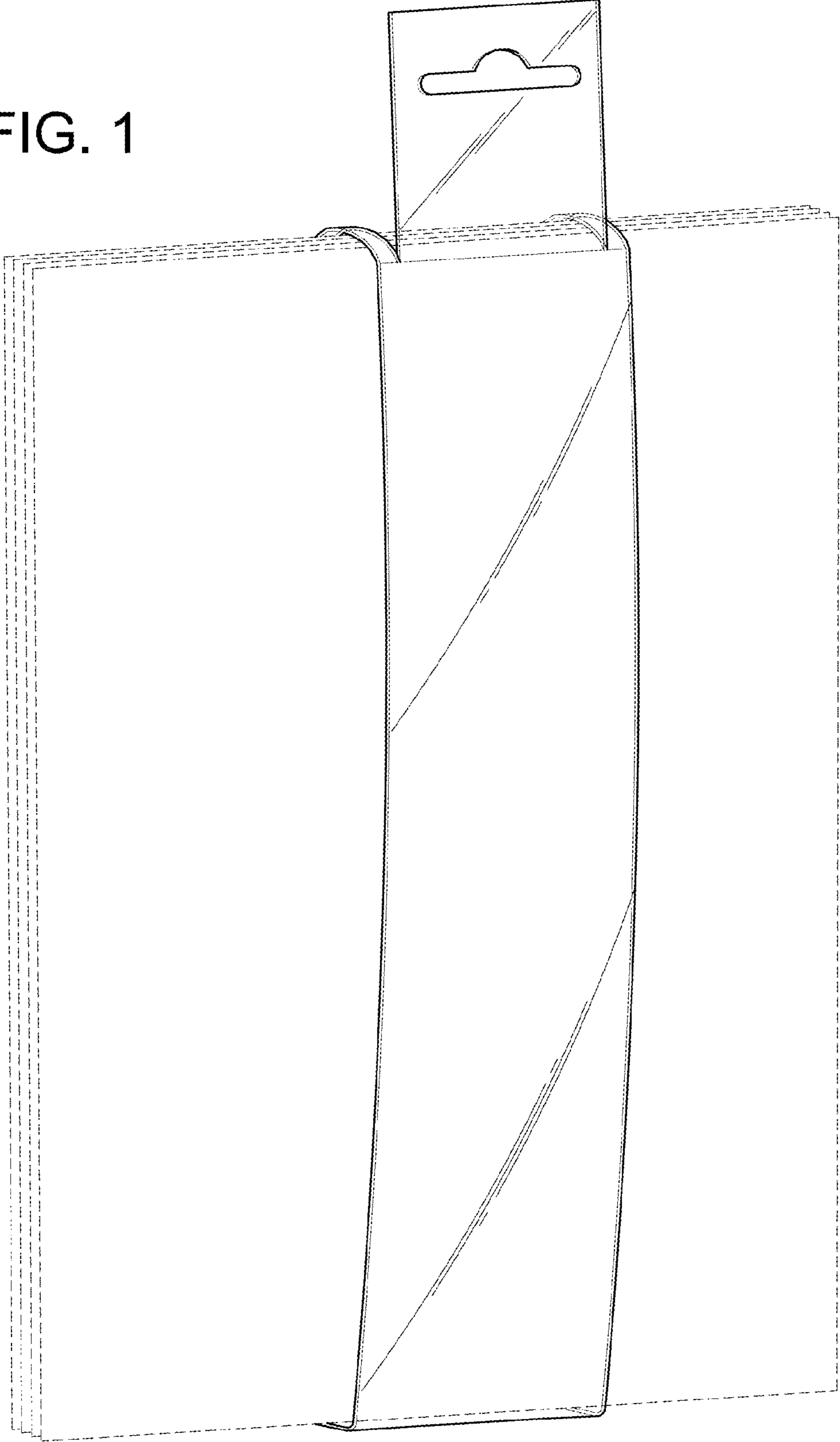

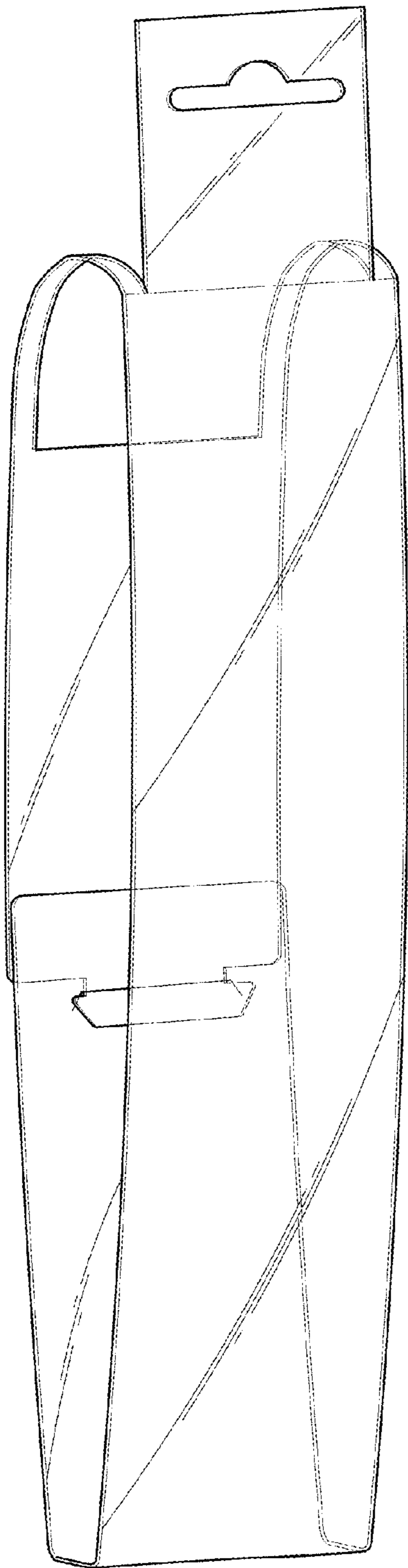

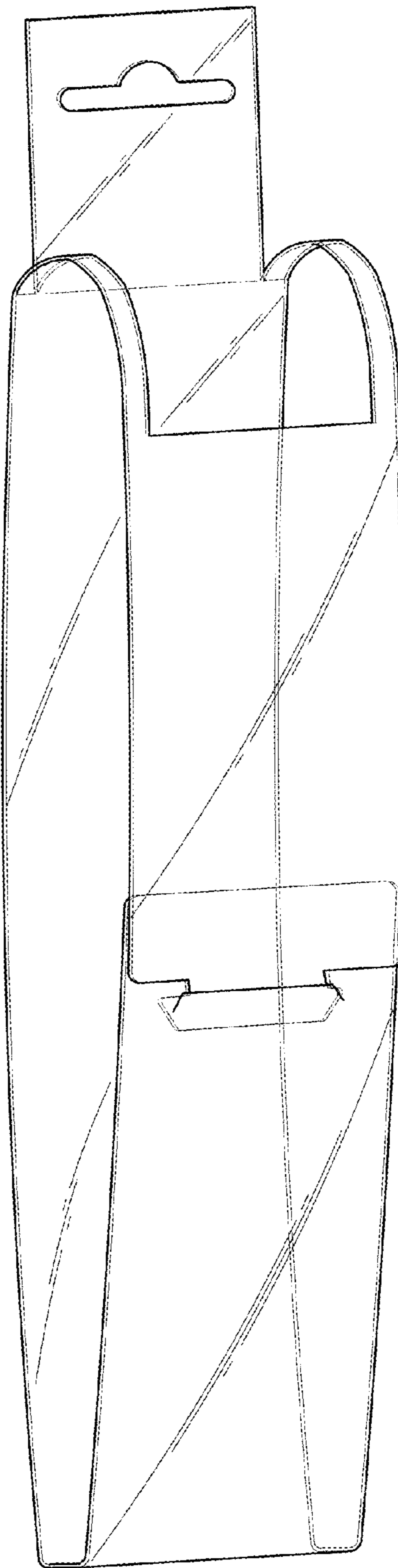

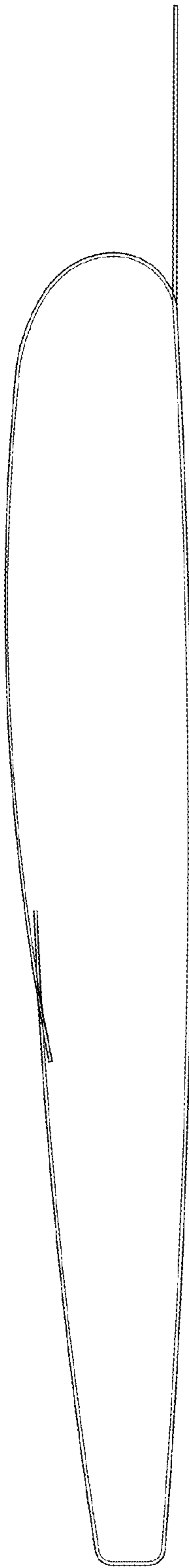

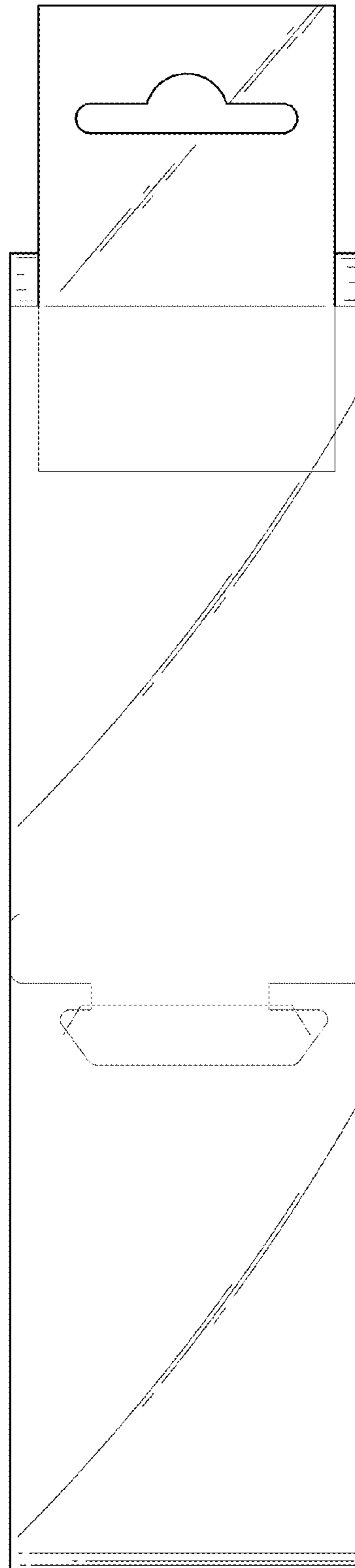

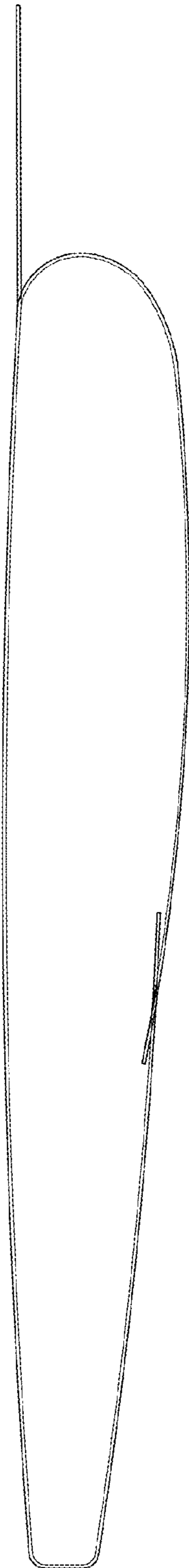

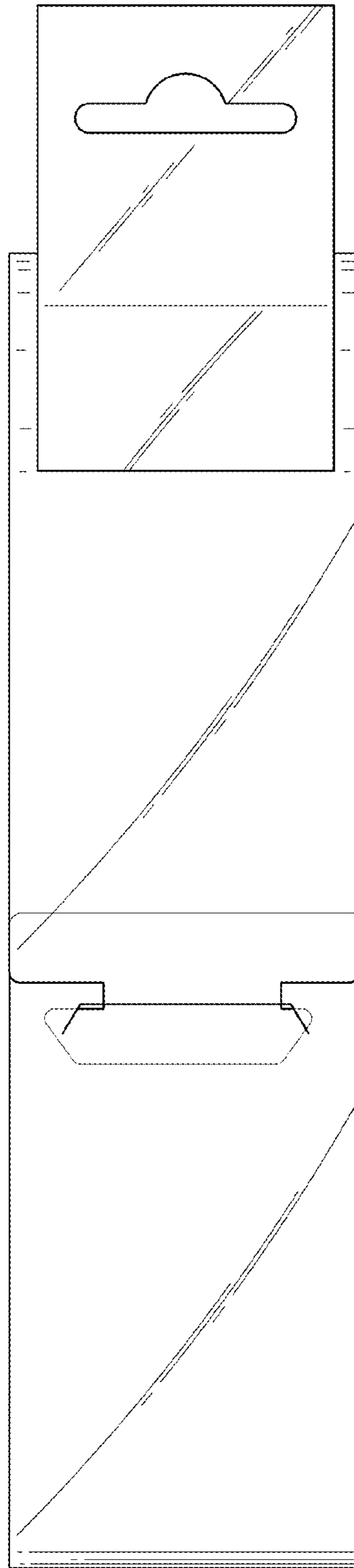

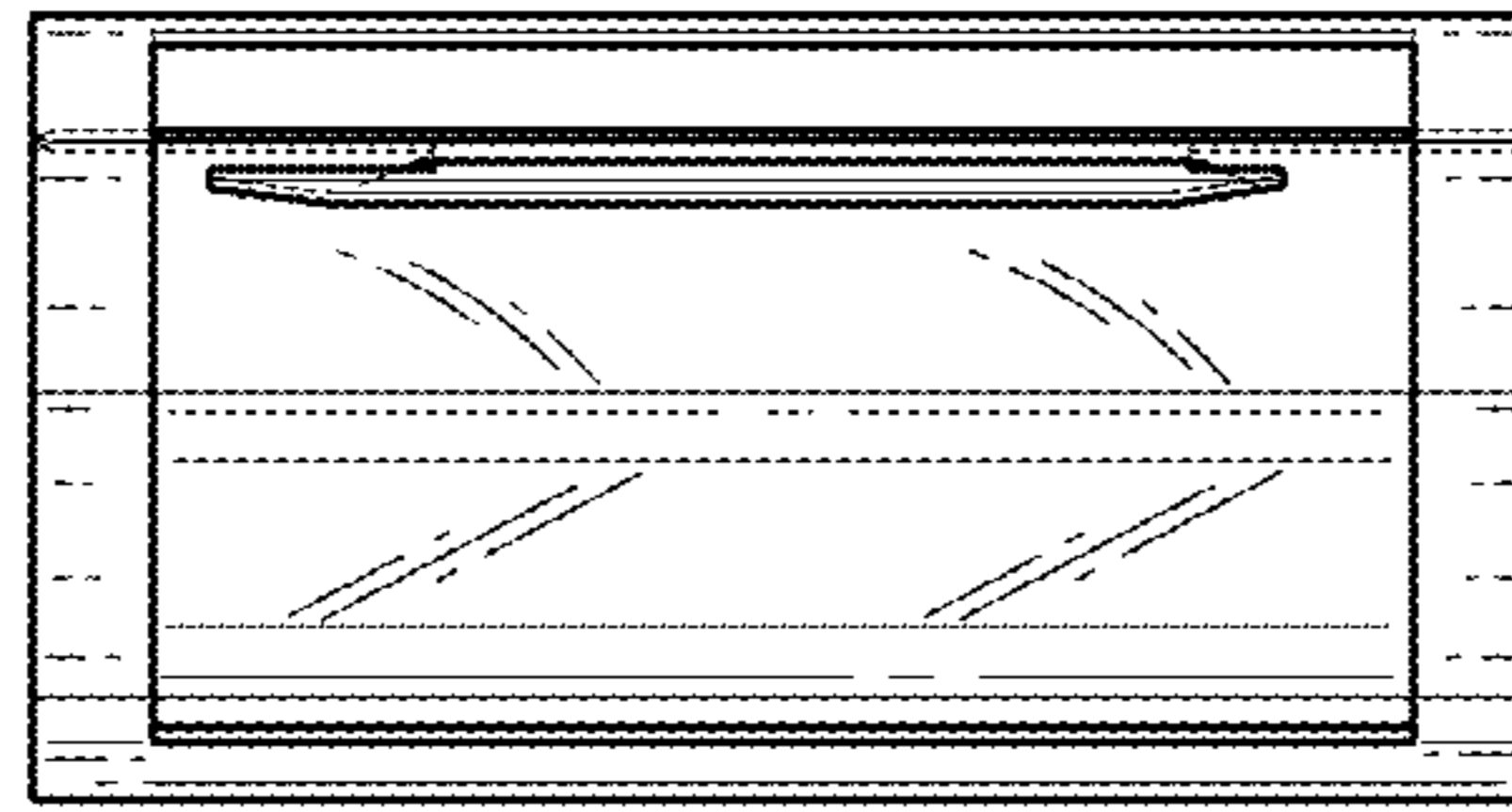

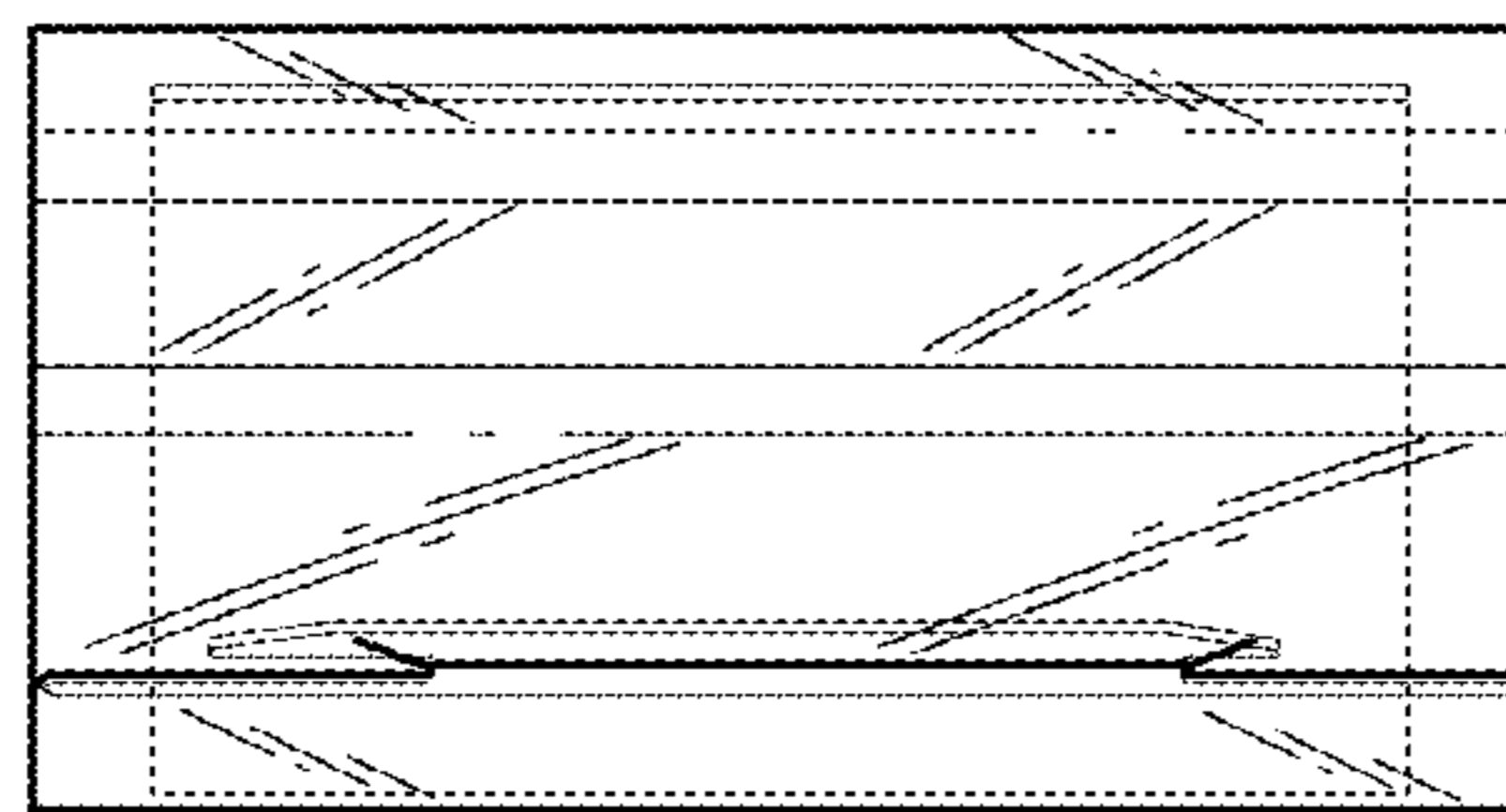
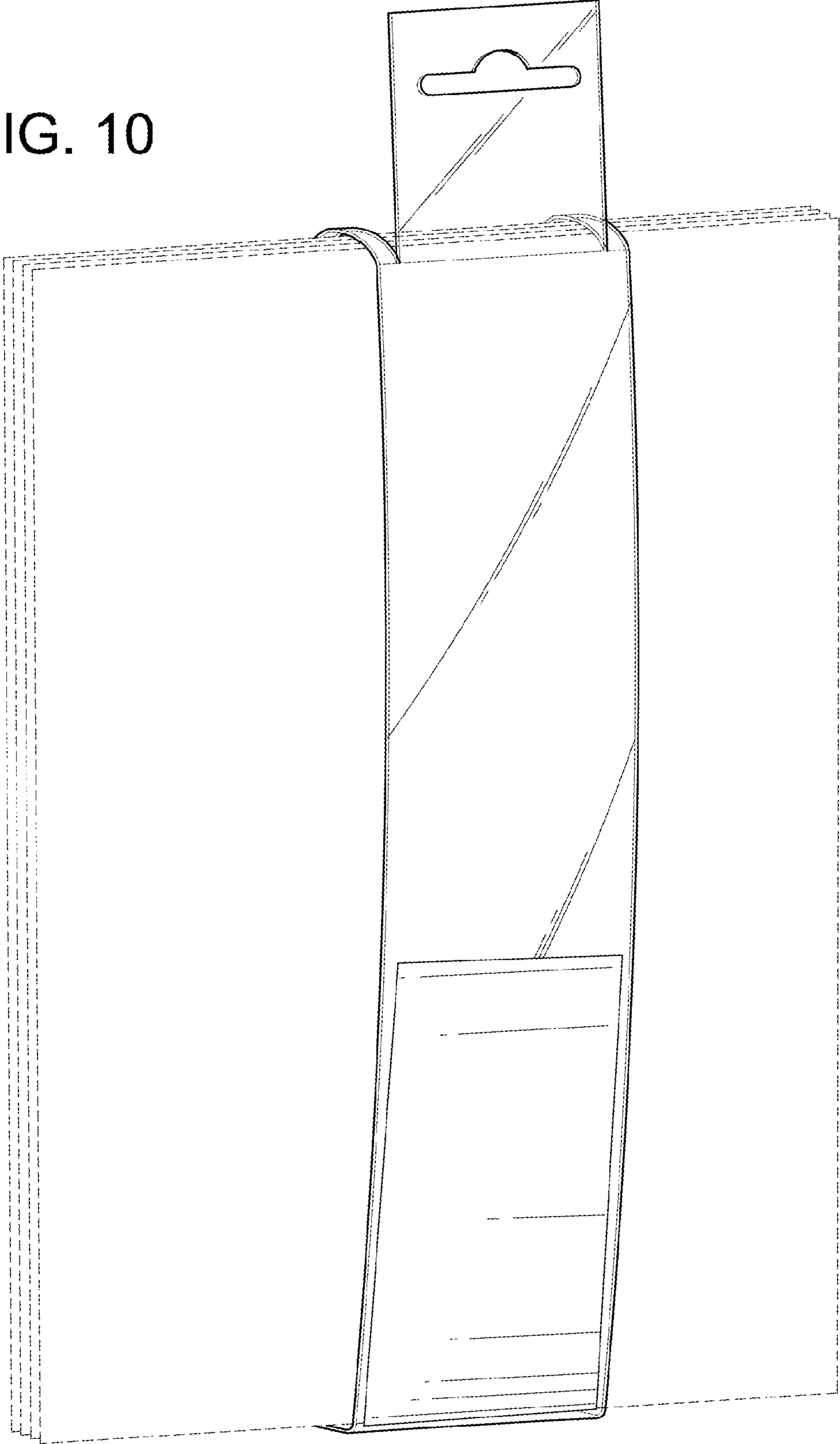

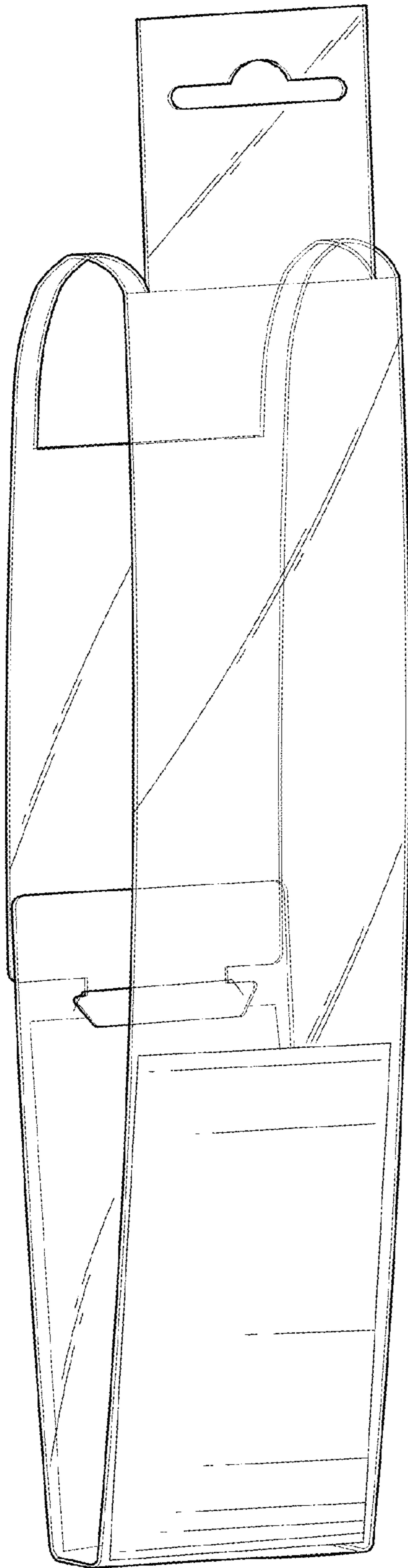

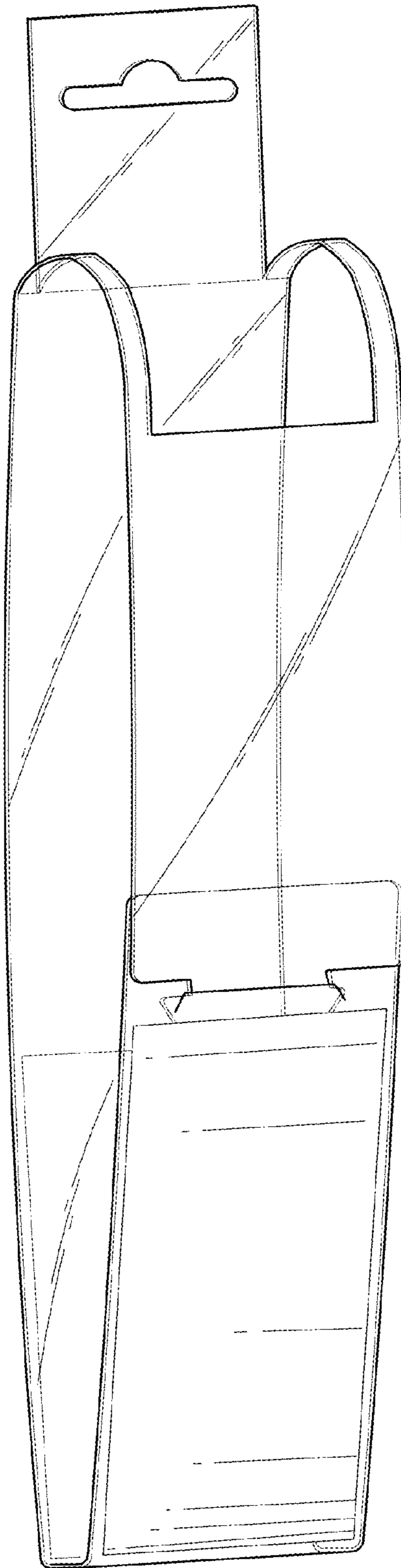

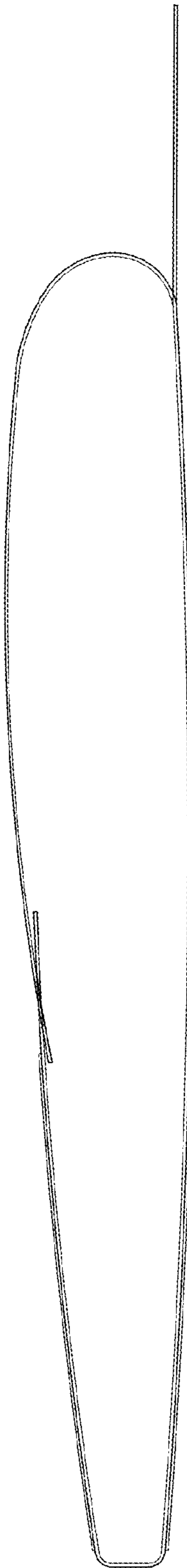

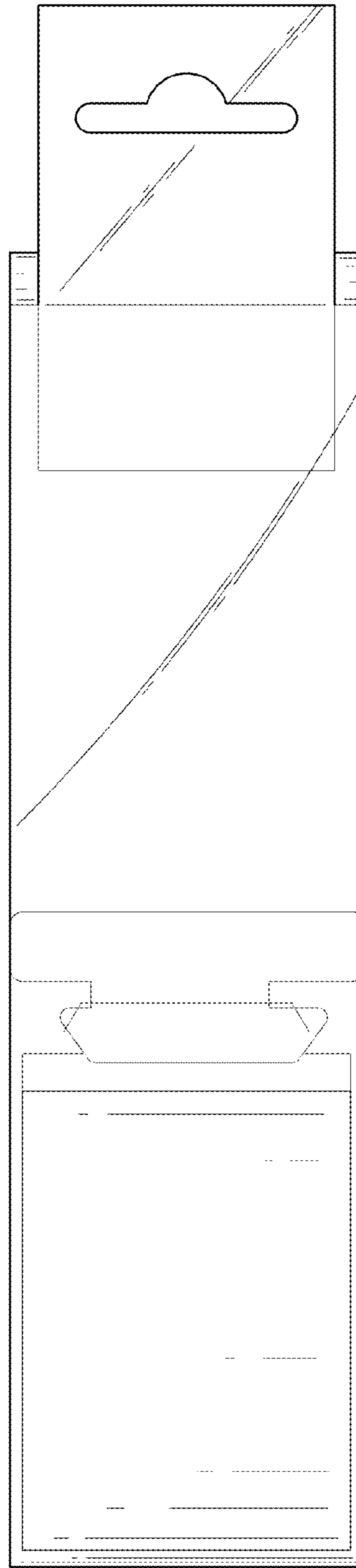

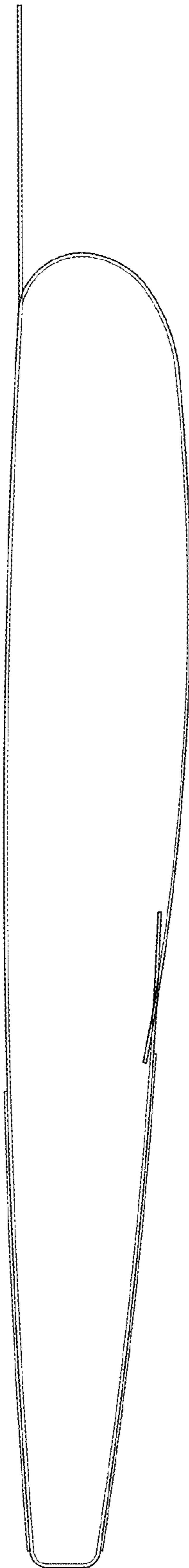

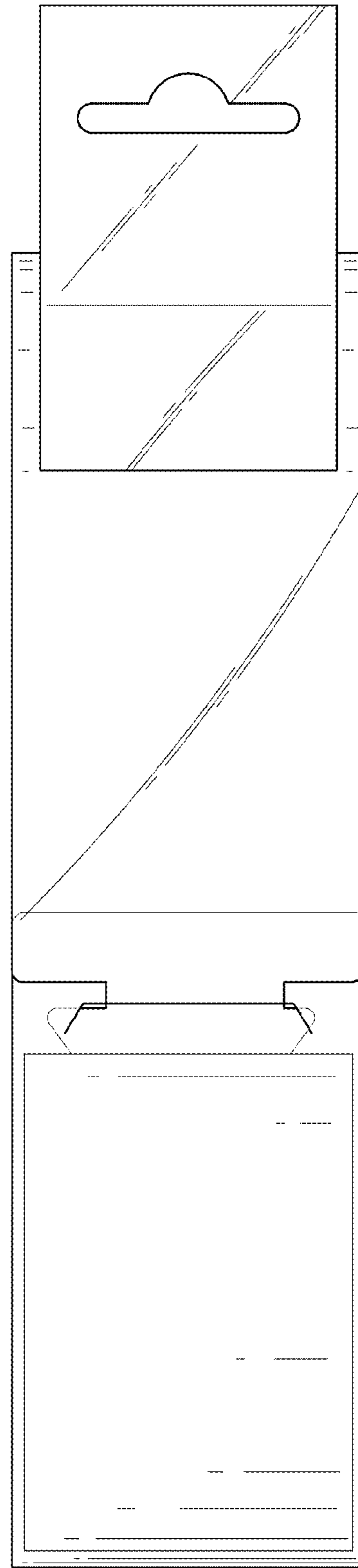

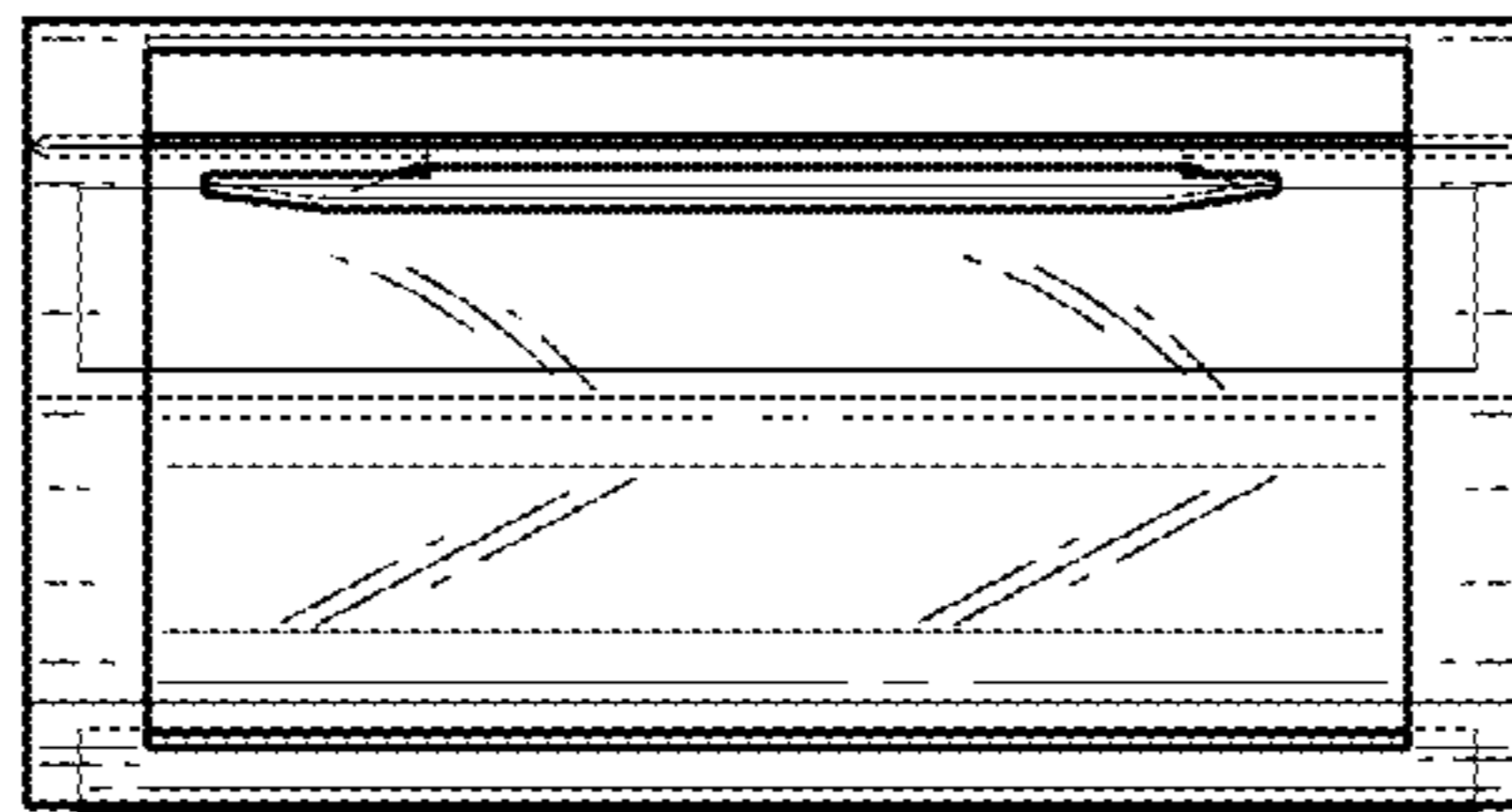

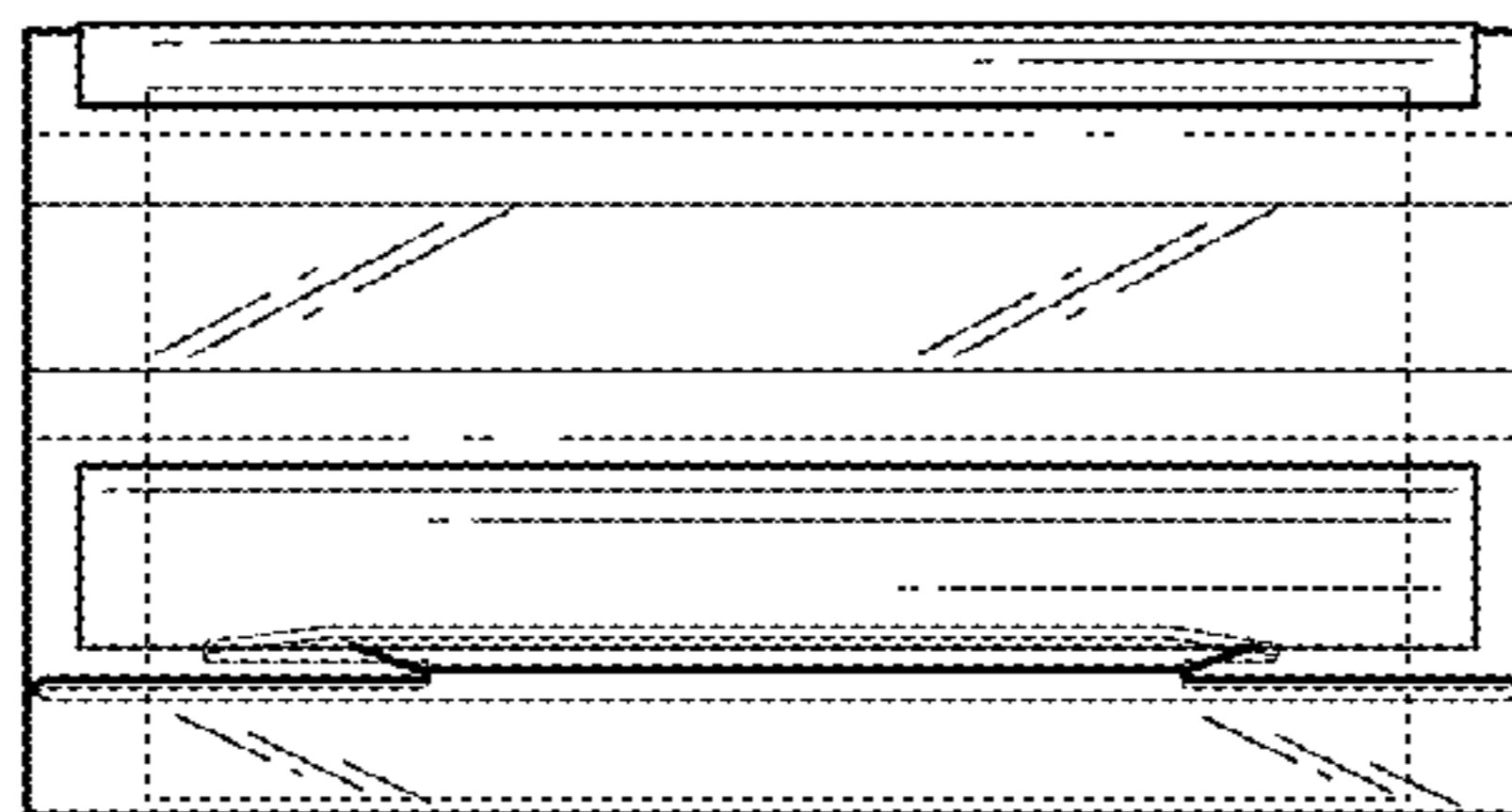
