FIG. 2 is a top view of the watch dial;

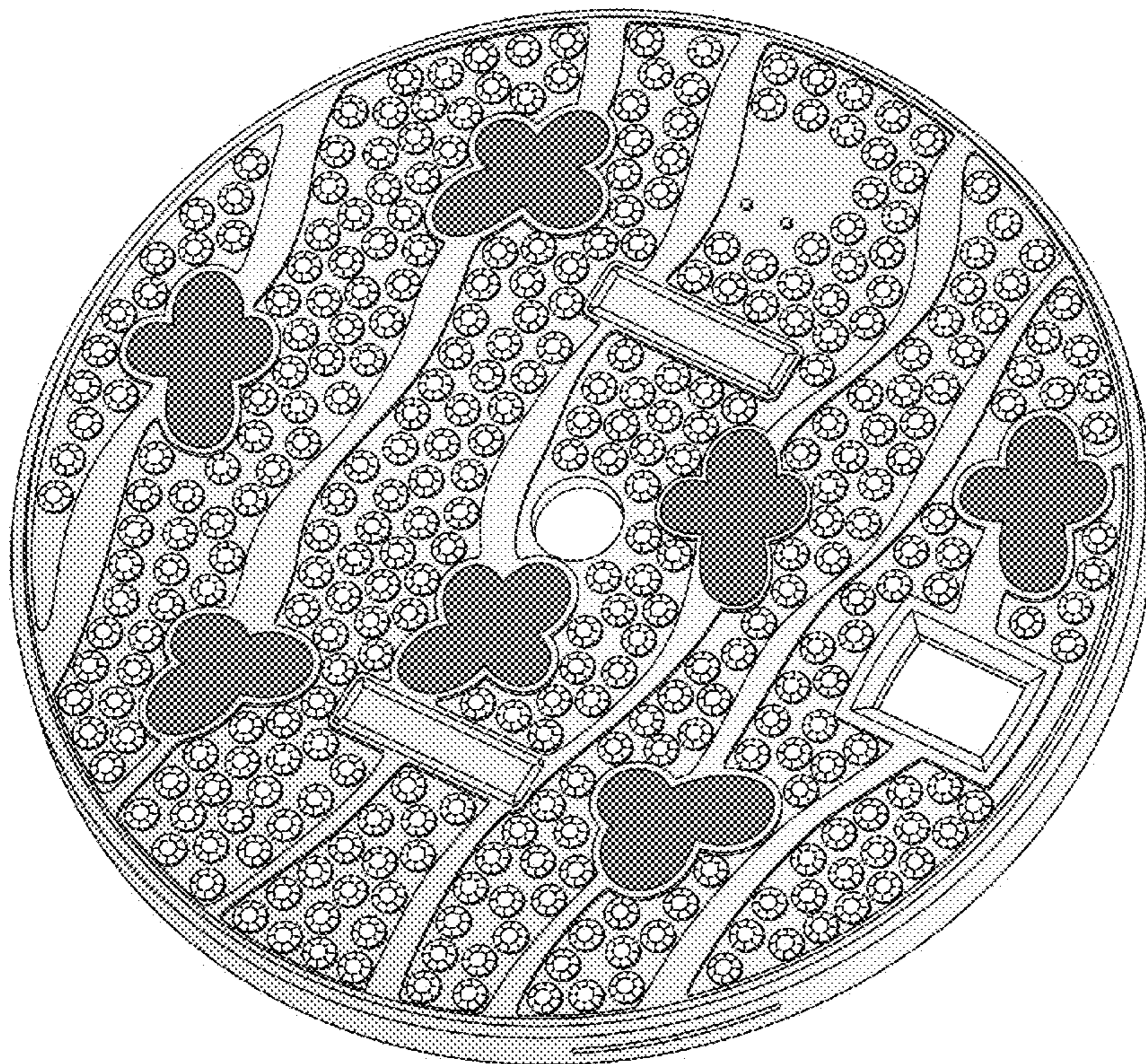
FIG. 3 is a front view of the watch dial;

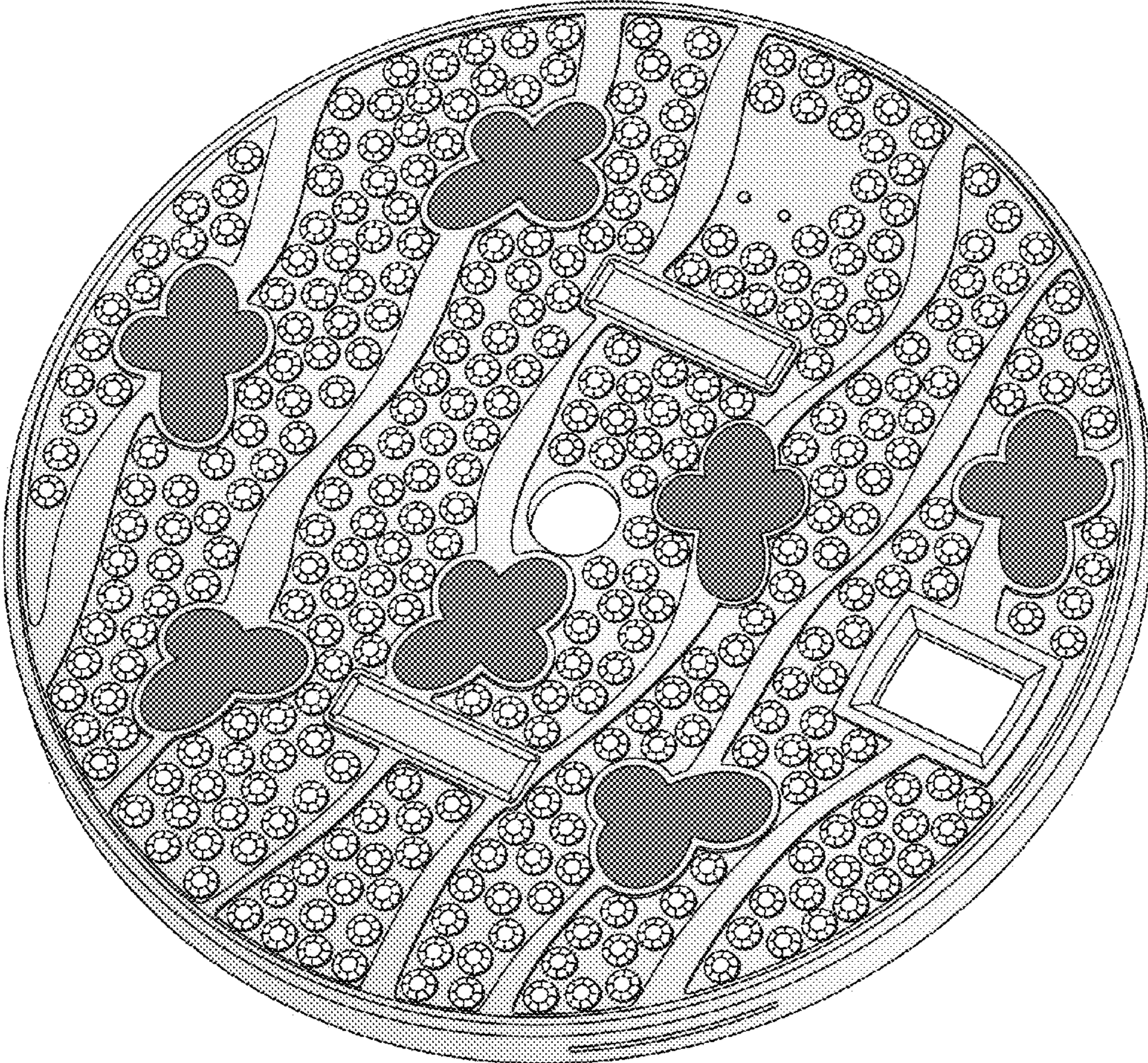

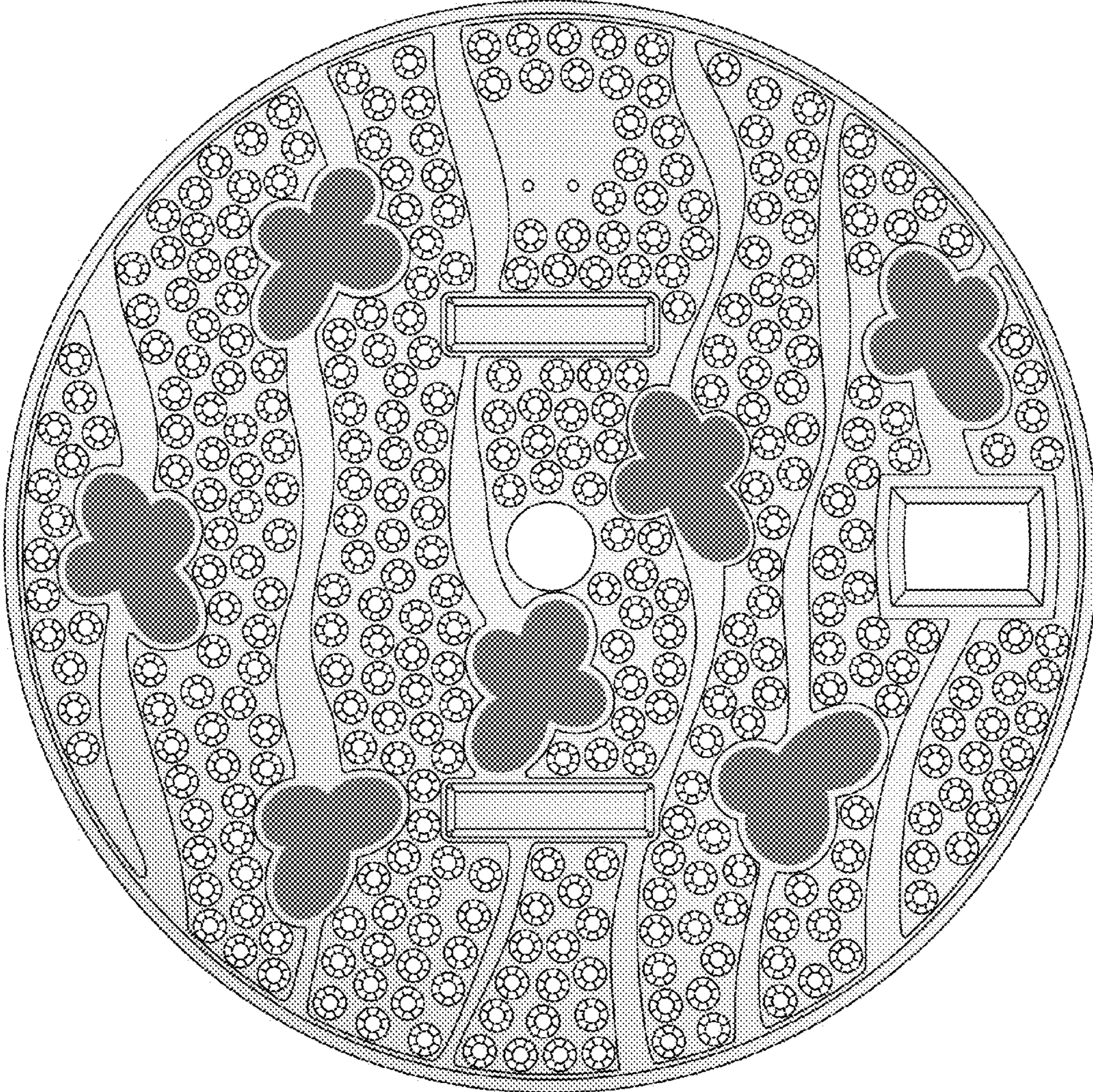

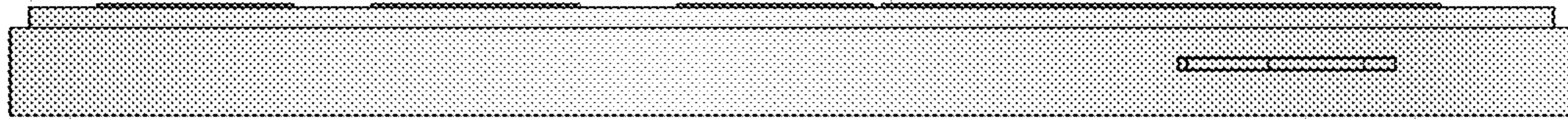

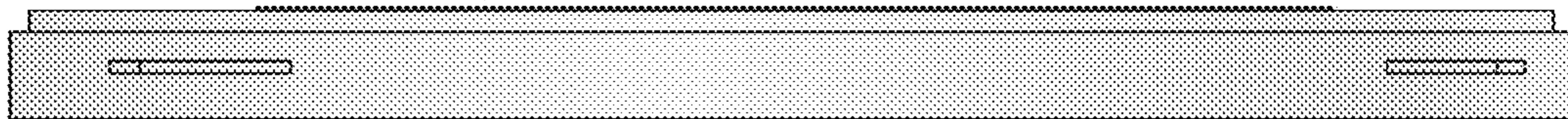

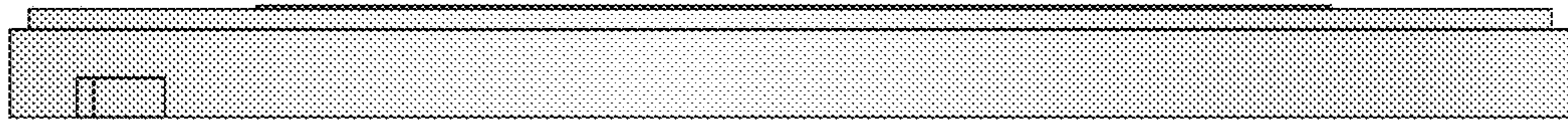

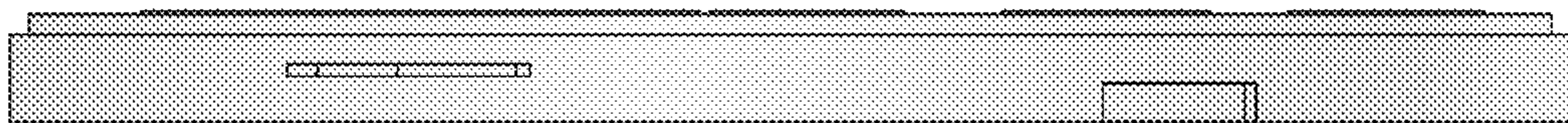
