FIG. 2 is a rear exploded perspective view;

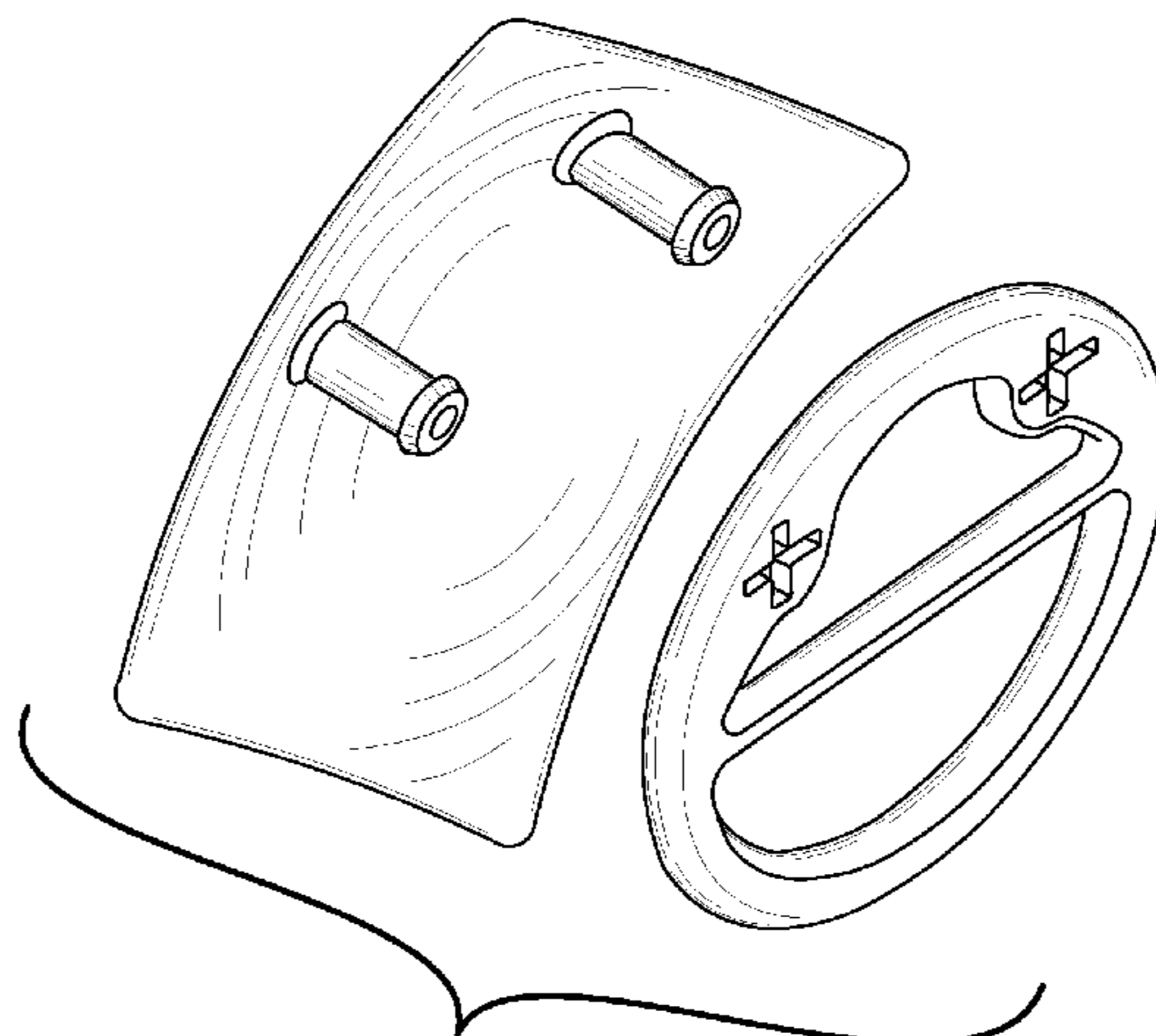
FIG. 3 is a front view;

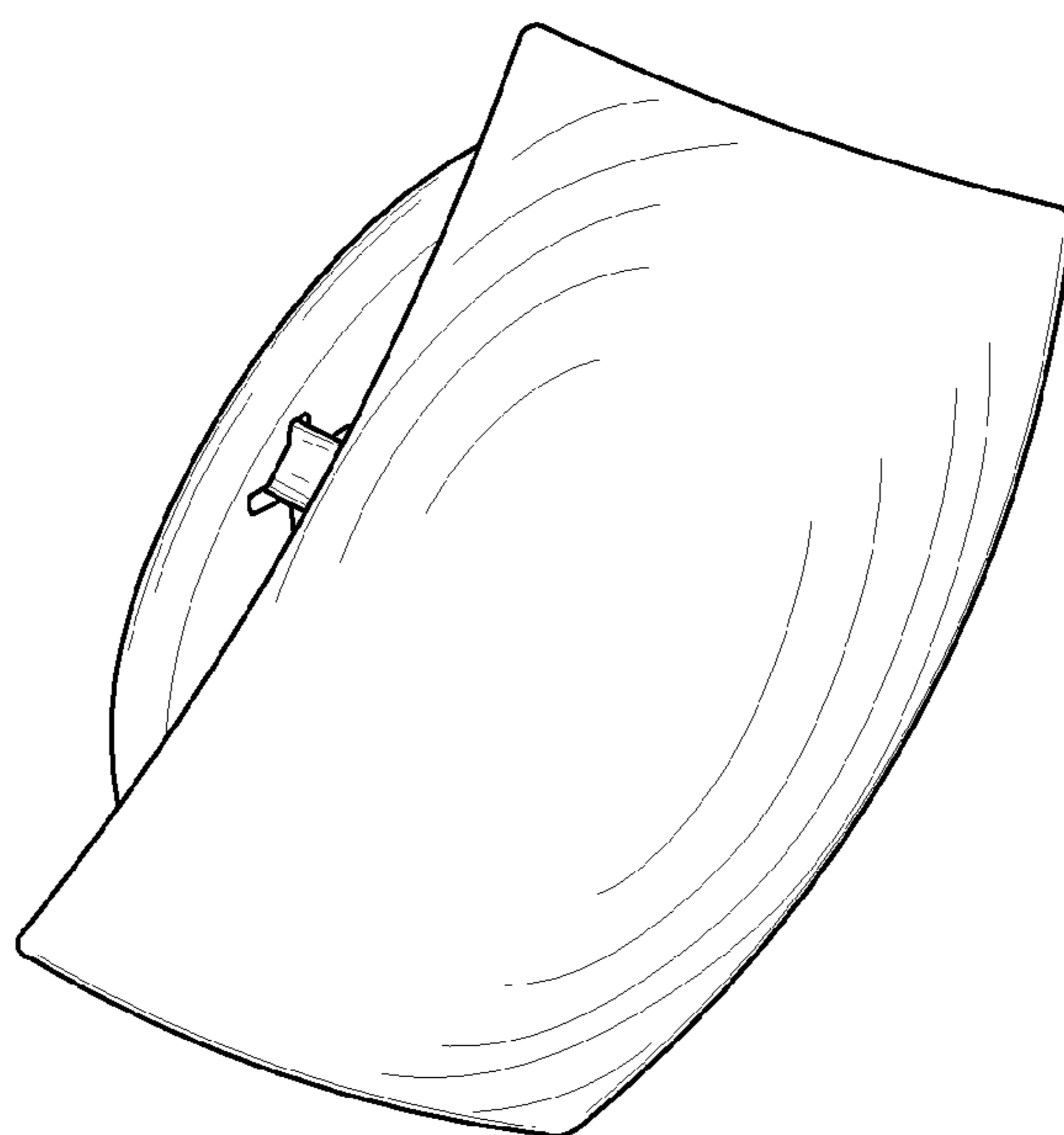

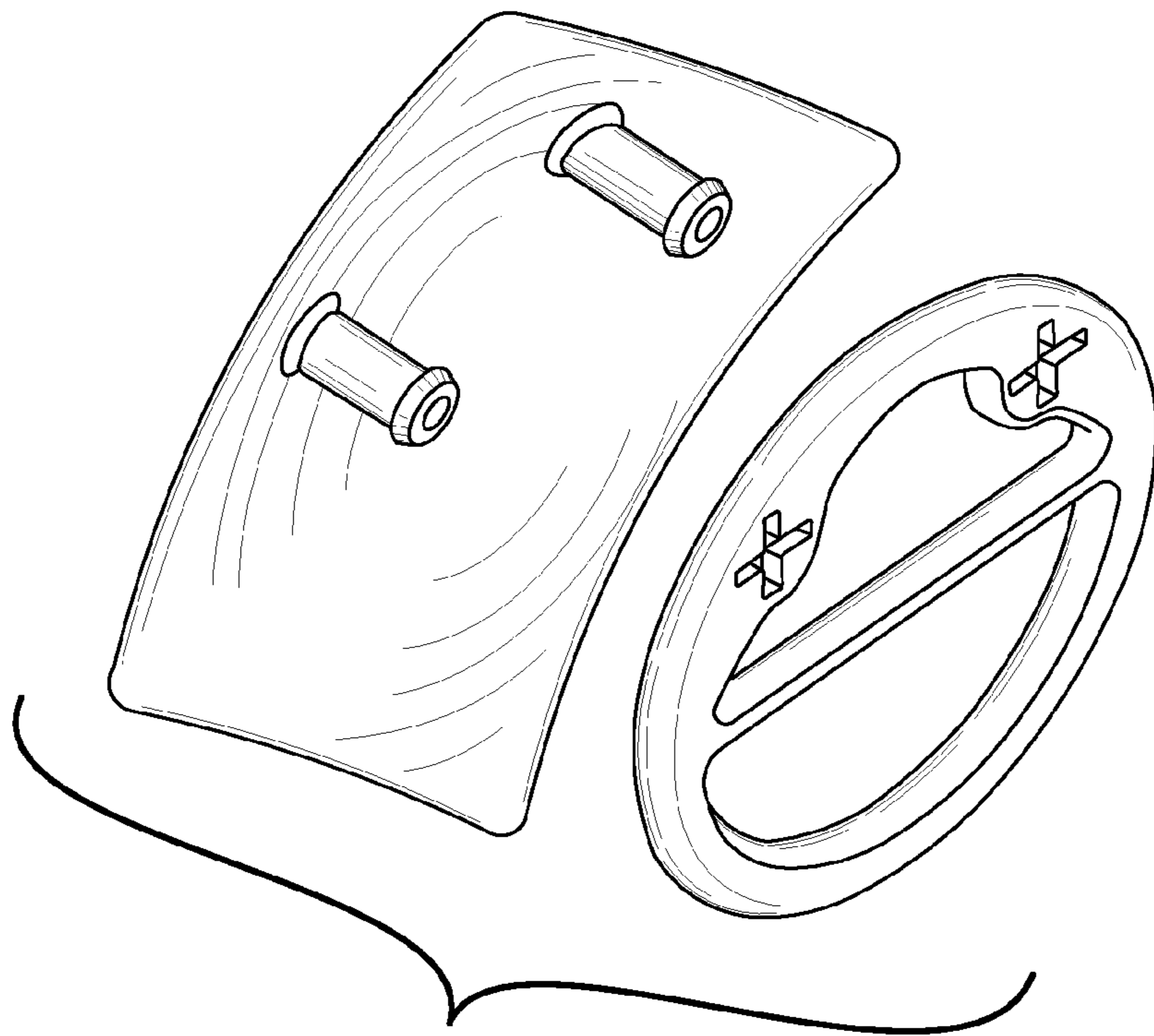

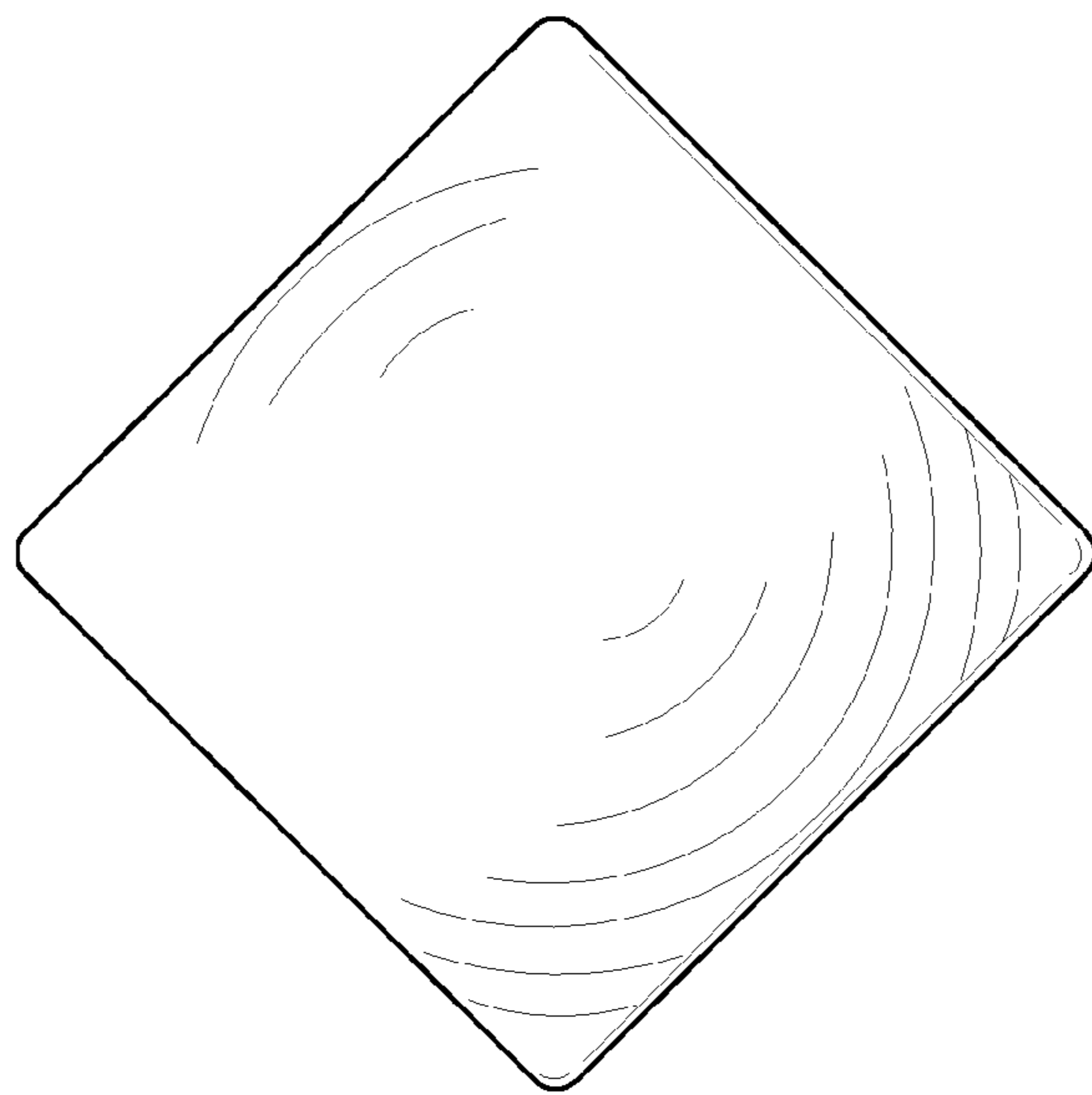

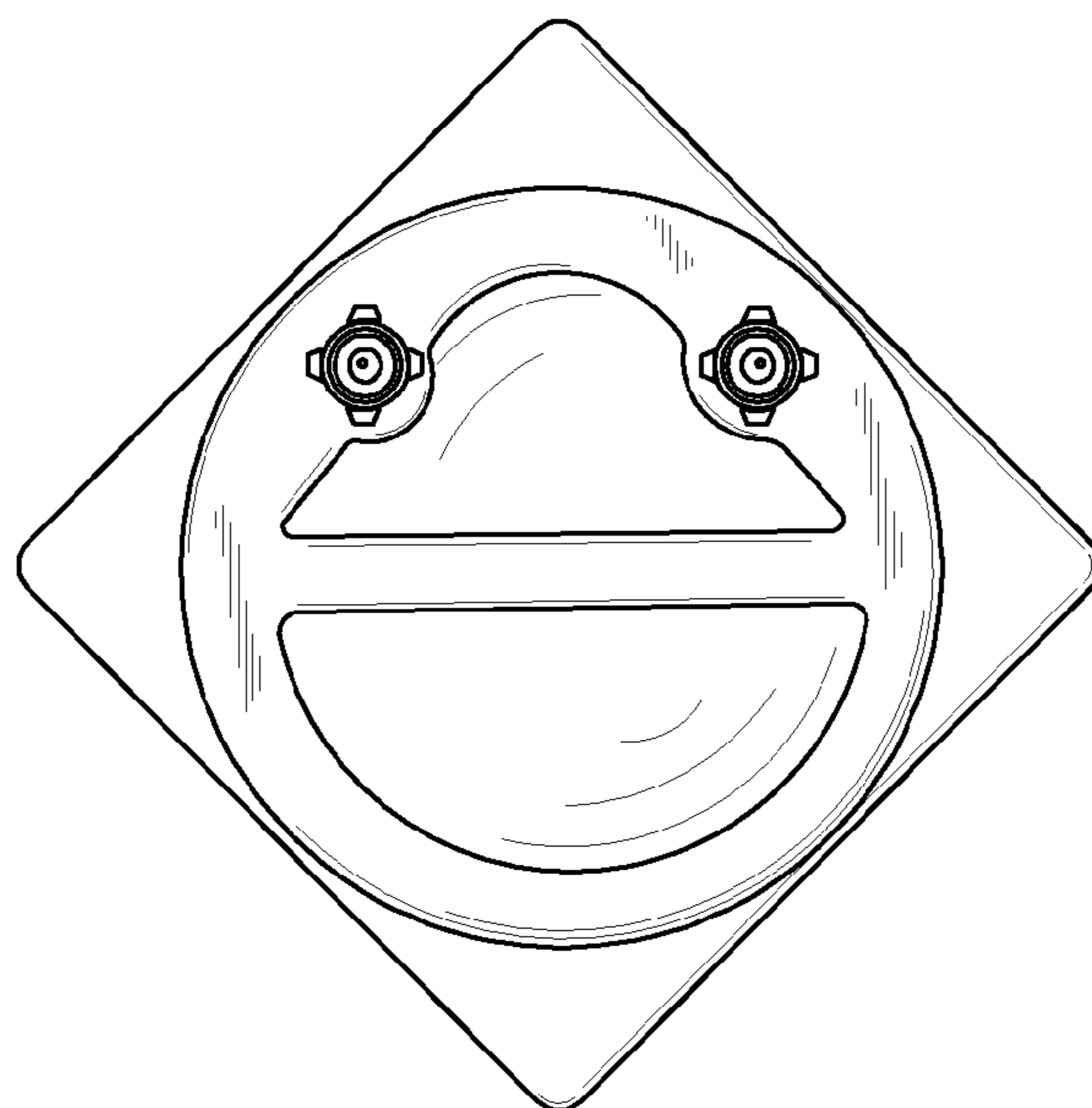

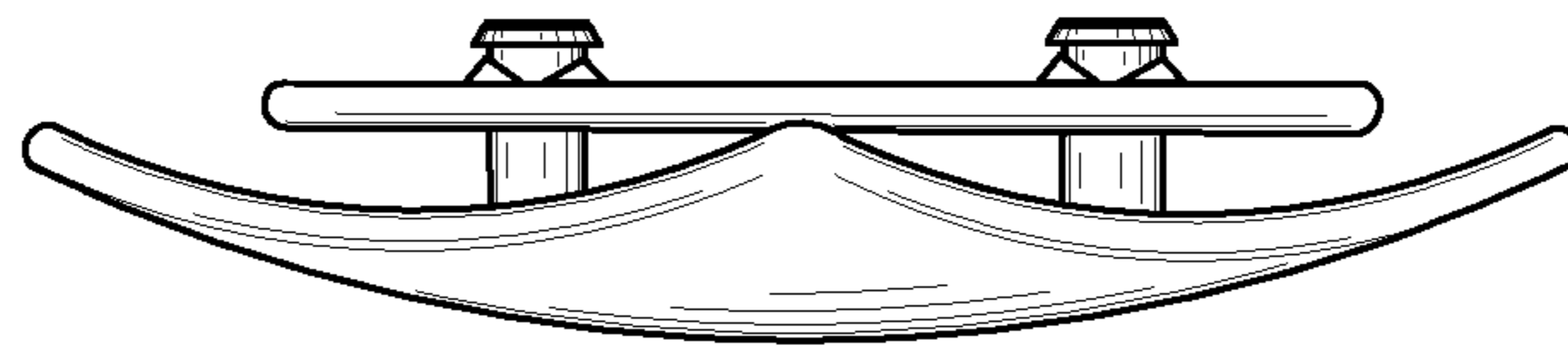
