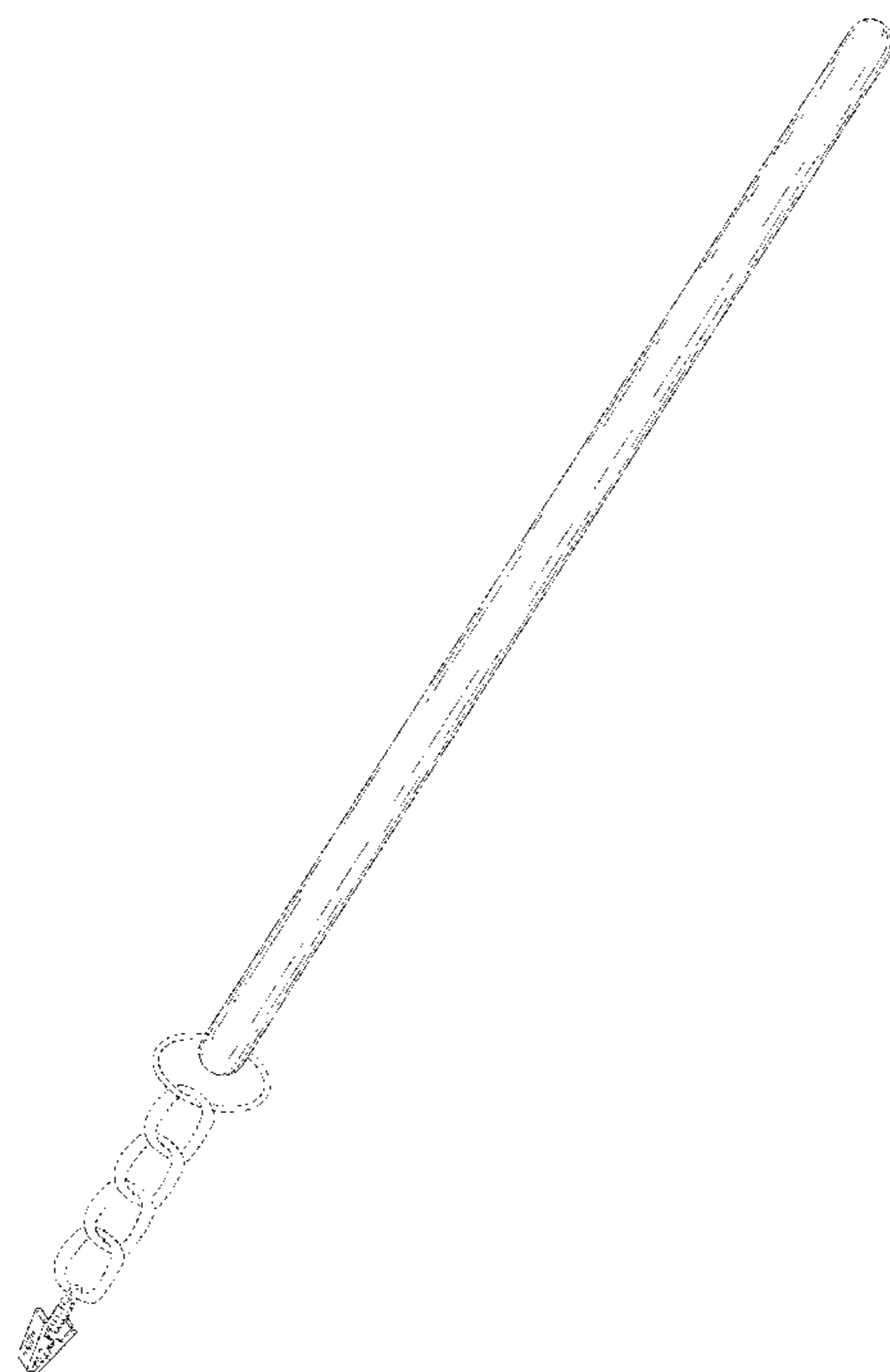
(57) **CLAIM**

The ornamental design for a zipper pull assist device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an exemplary embodiment of my new zipper pull assist device design; FIG. 2 is a front view thereof; FIG. 3 is a back view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof. The broken line showing of chain in FIGS. 1-7 are for the purpose of illustrating environmental matter and forms no part of the claimed design.

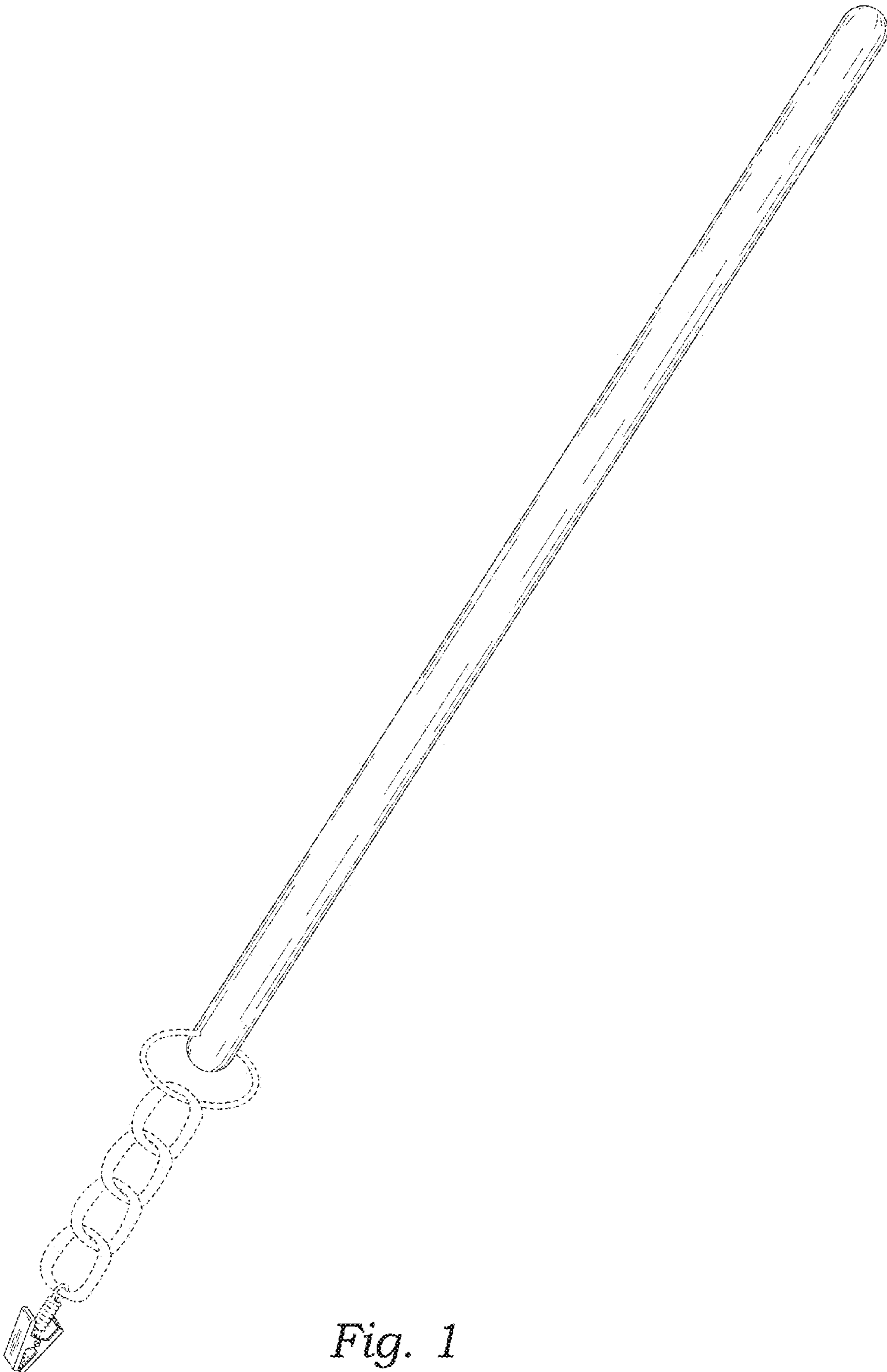

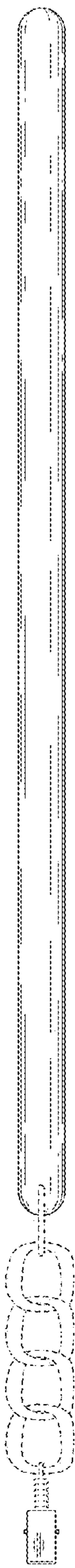

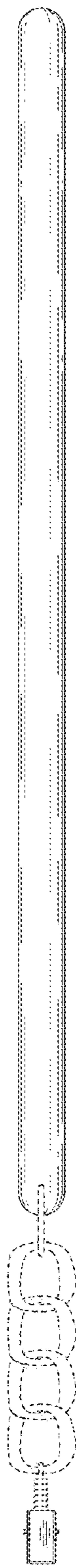

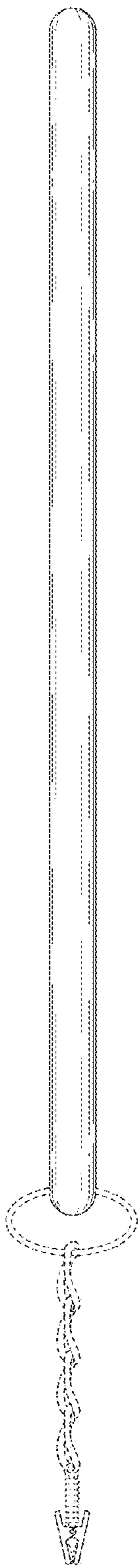

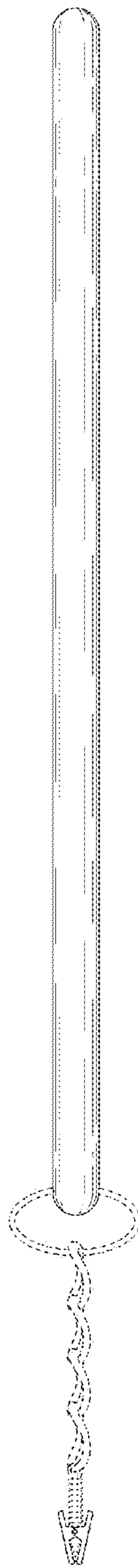

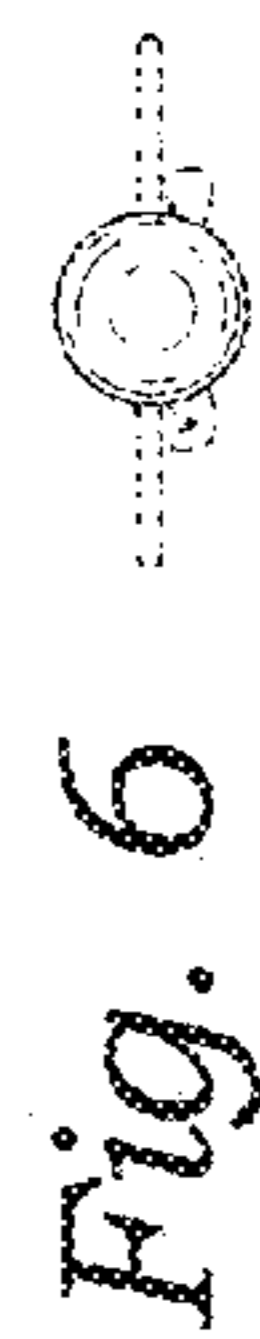

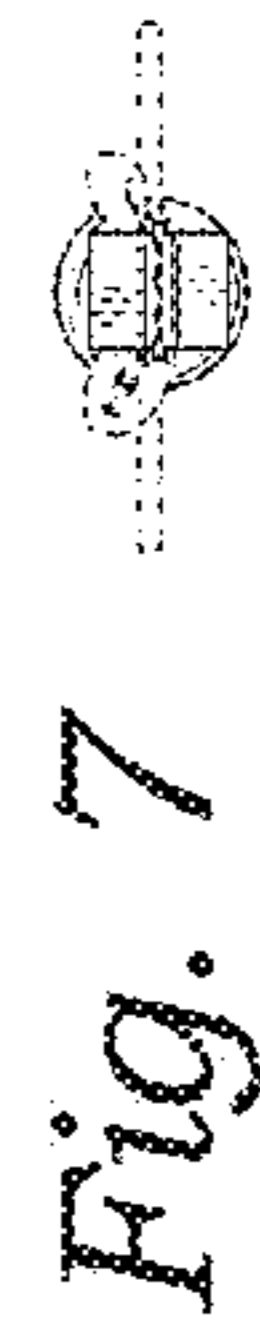
