(57) **CLAIM**

The ornamental design for a motorcycle or motorcycle replica, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the right side of a motorcycle or motorcycle replica showing our new design. FIG. 2 is a perspective view from the left side thereof. FIG. 3 is a perspective view from the right side thereof. FIG. 4 is a perspective view from the left side thereof. FIG. 5 is a front elevation view thereof. FIG. 6 is a rear elevation view thereof. FIG. 7 is a right side elevation view thereof. FIG. 8 is a left side elevation view thereof; and, FIG. 9 is a top plan view thereof.

The bottom is not ornamental.

The portions of the motorcycle shown in broken lines are for the purpose of showing environmental structure only and faun no part of the claimed design.

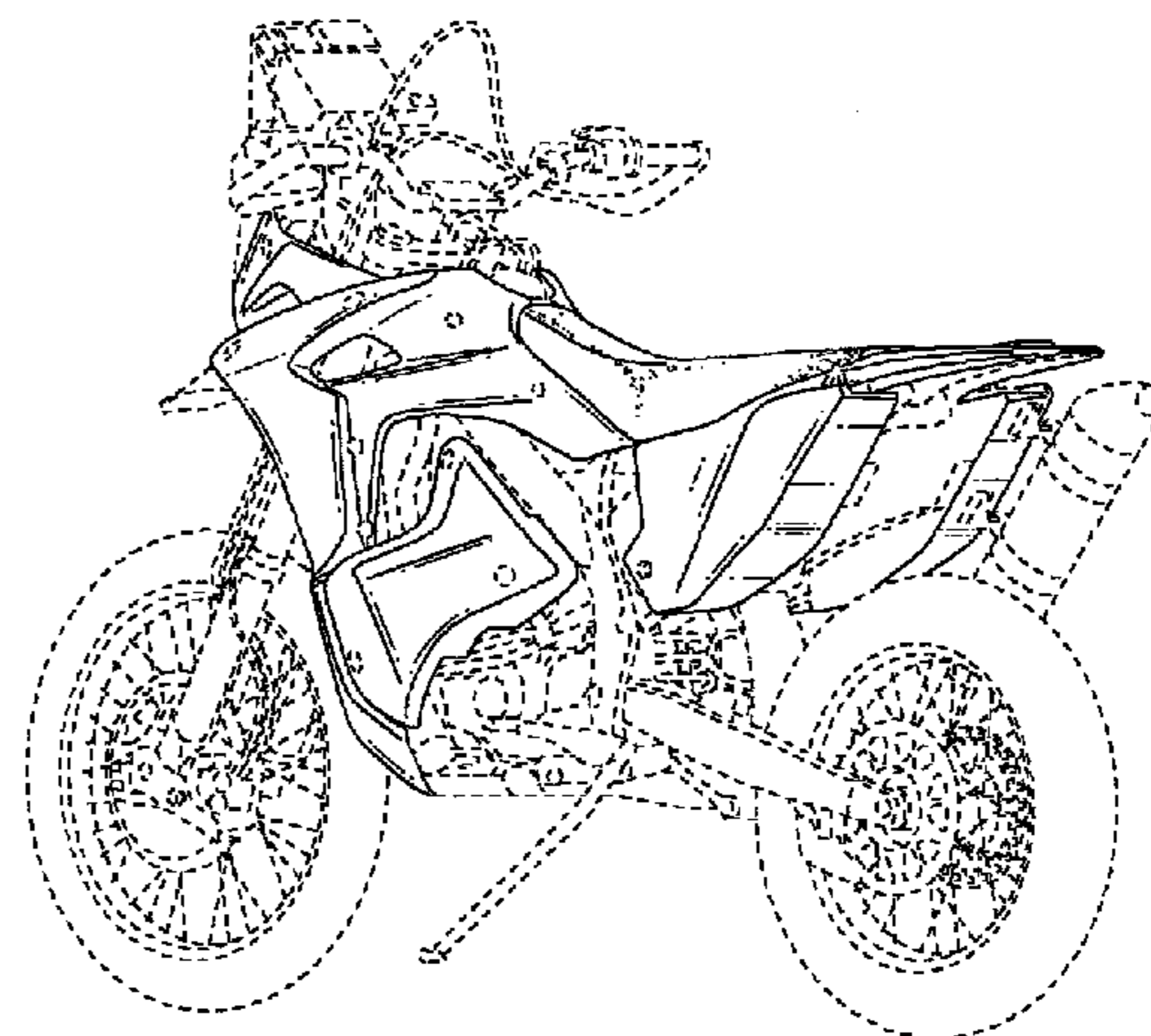
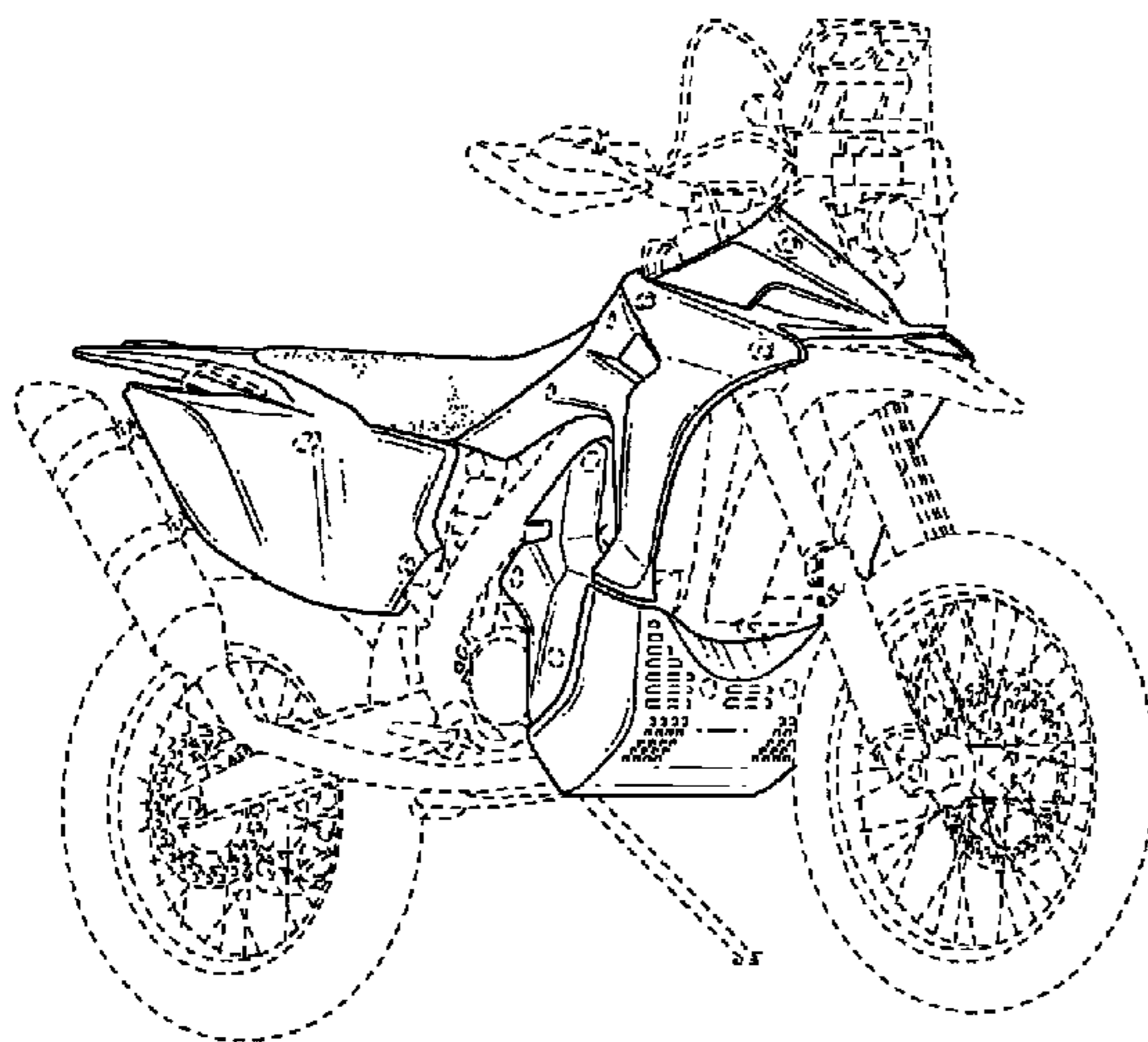

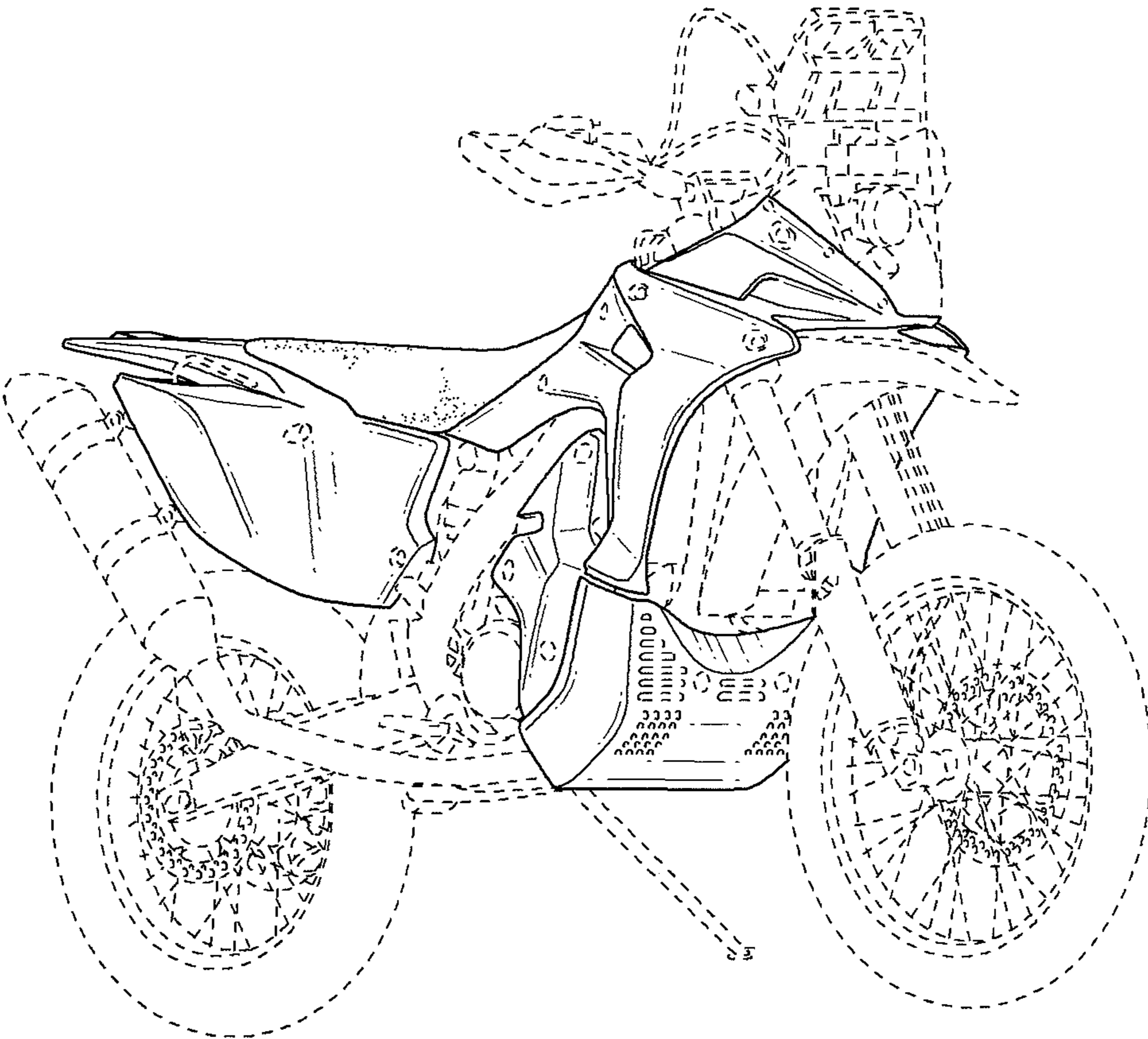

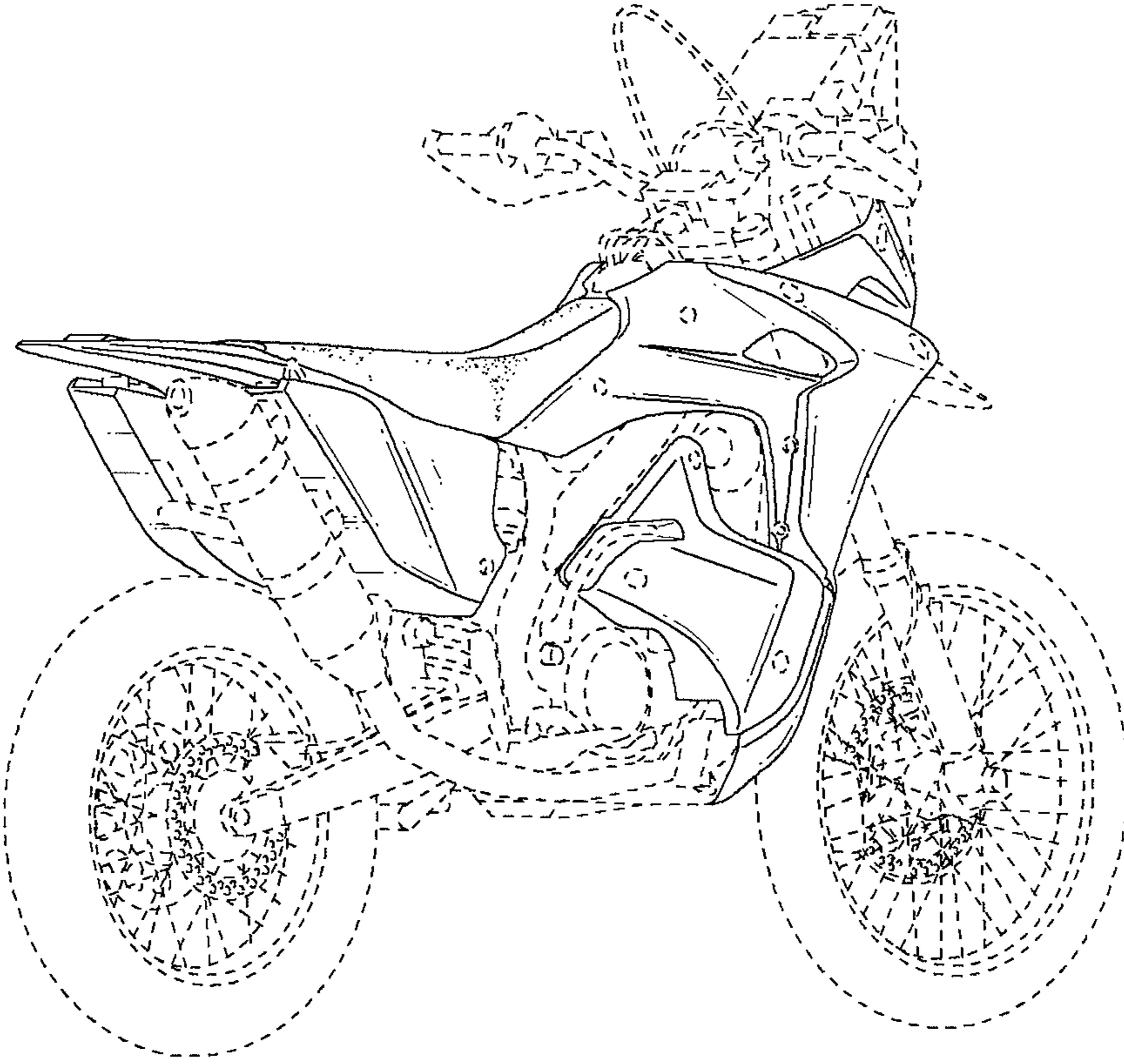

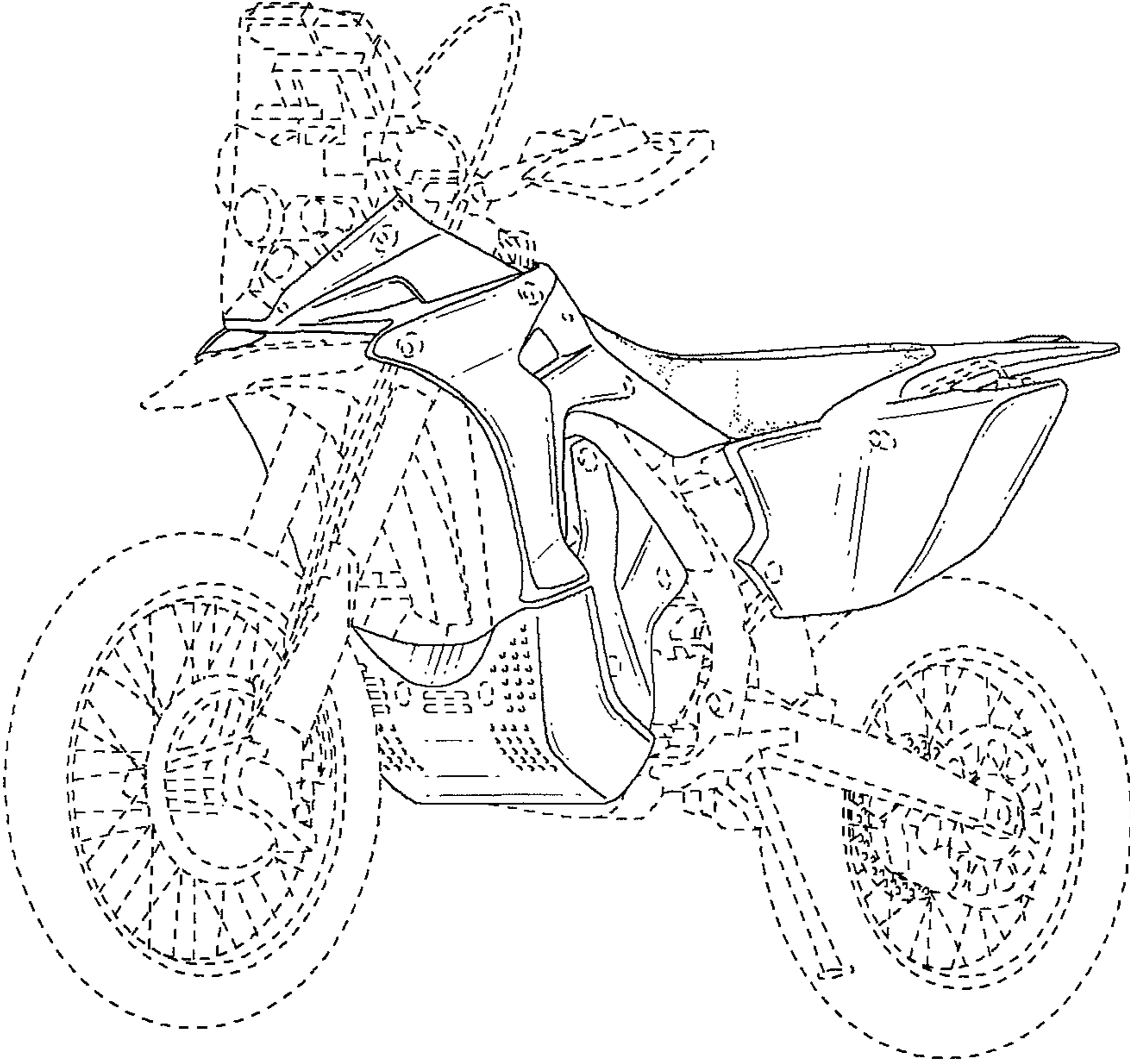

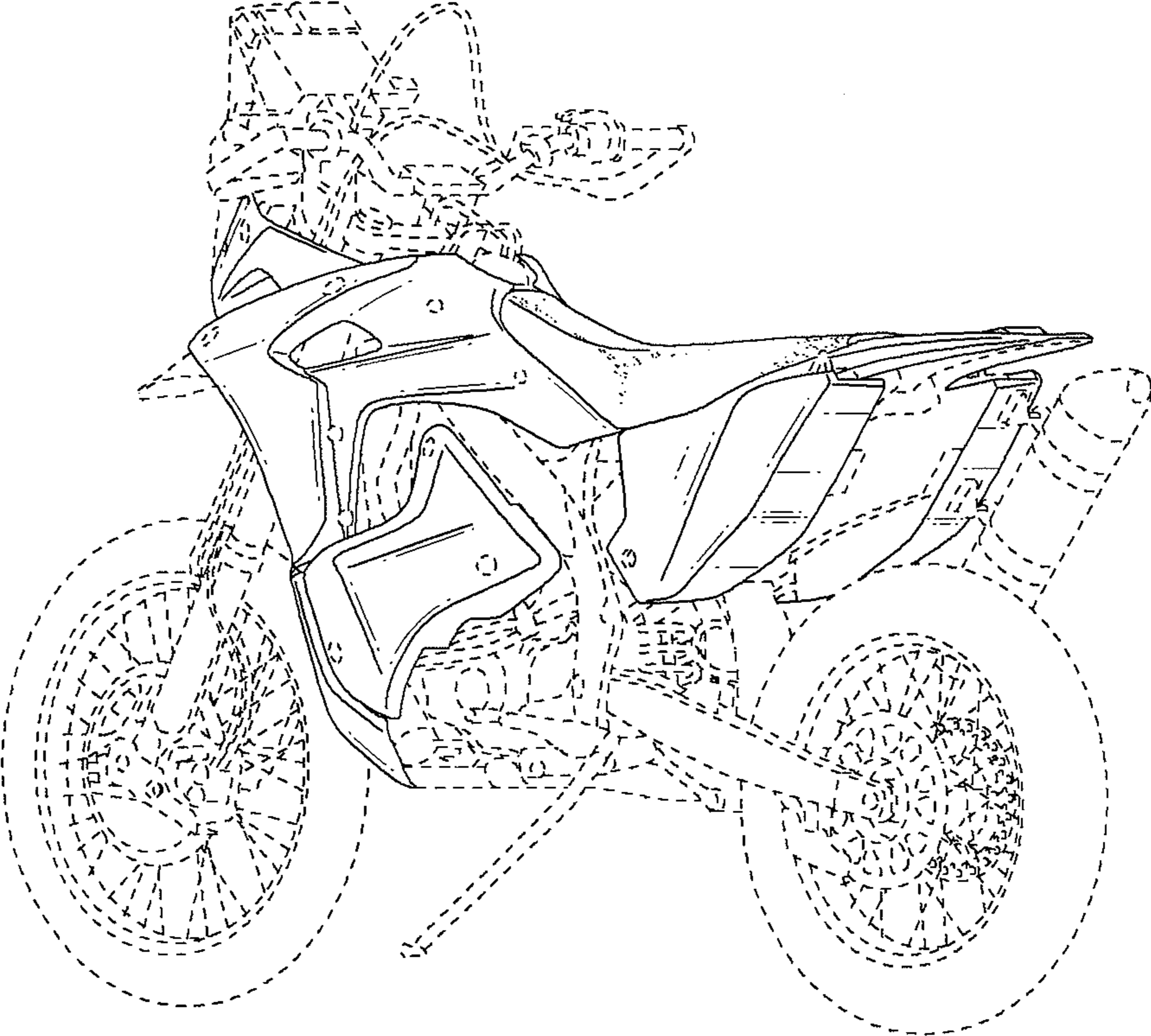

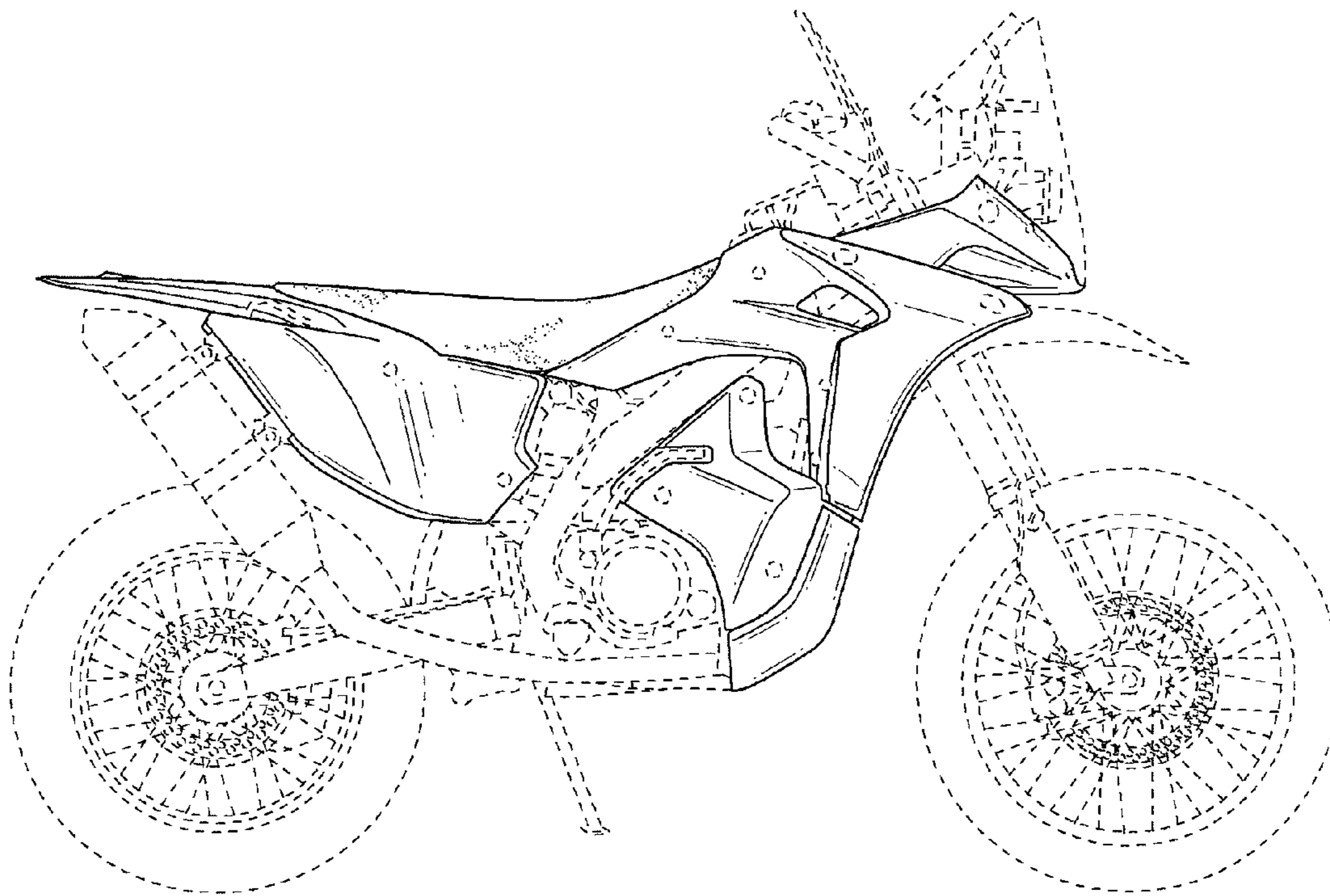

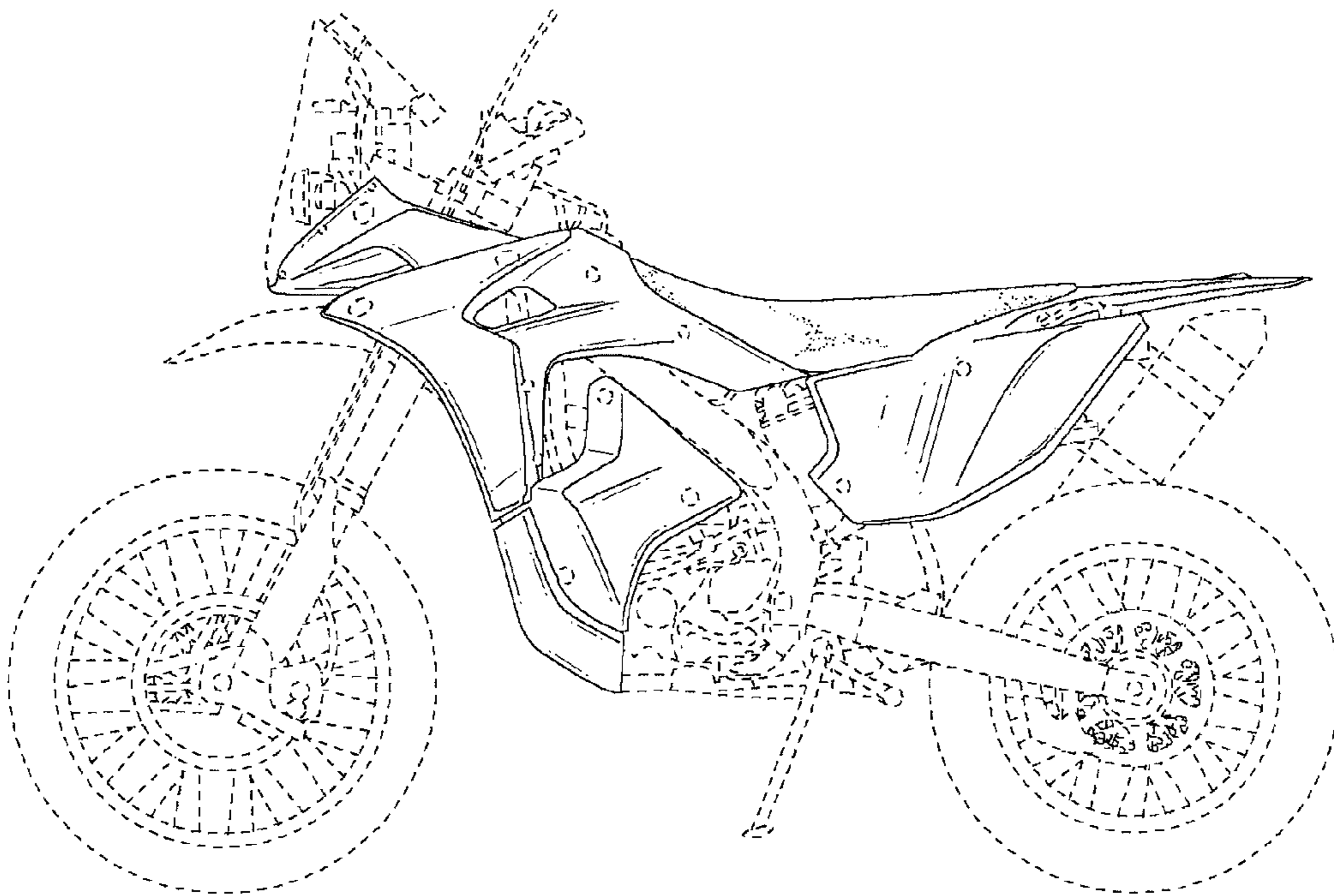

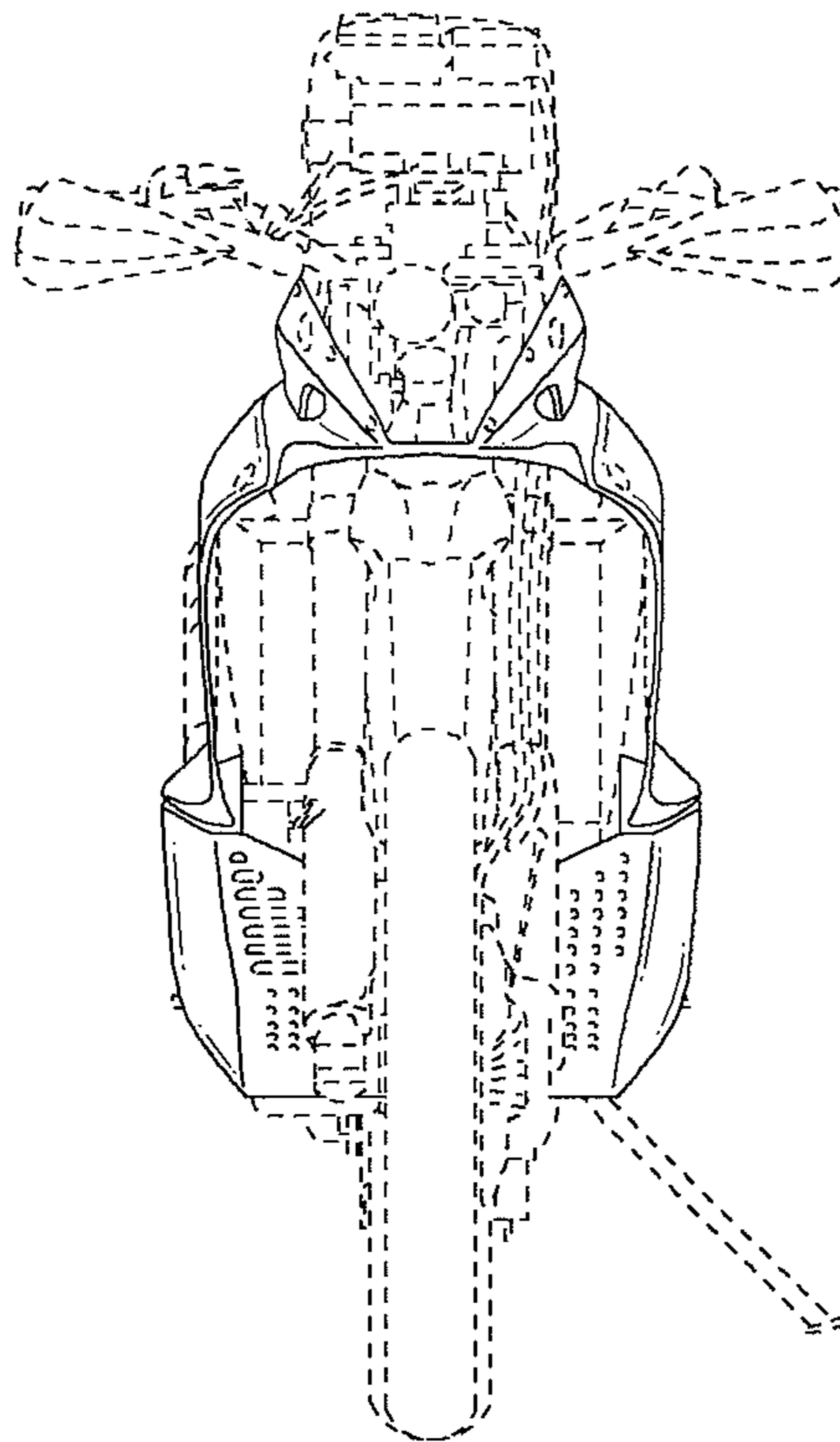

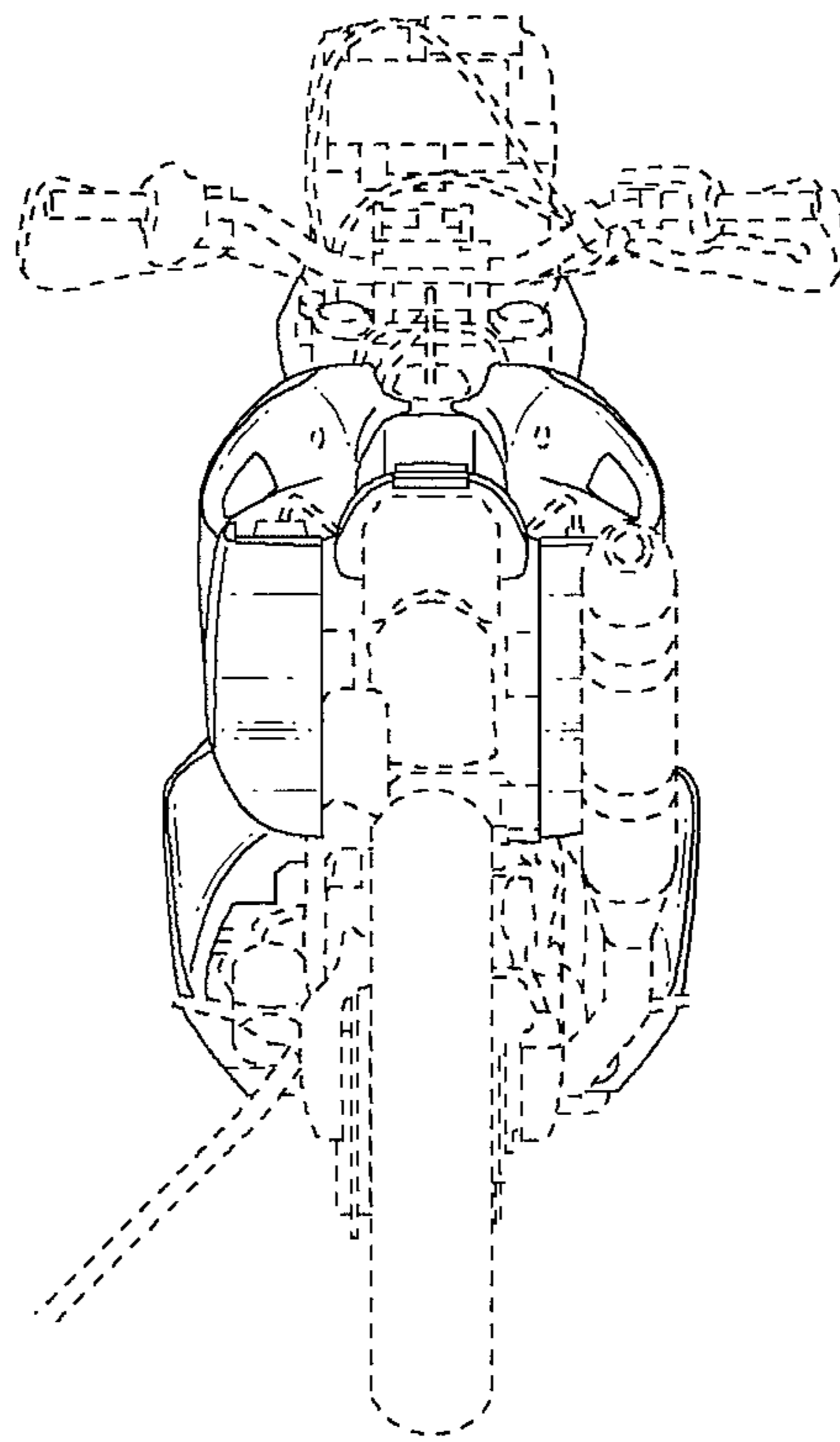
