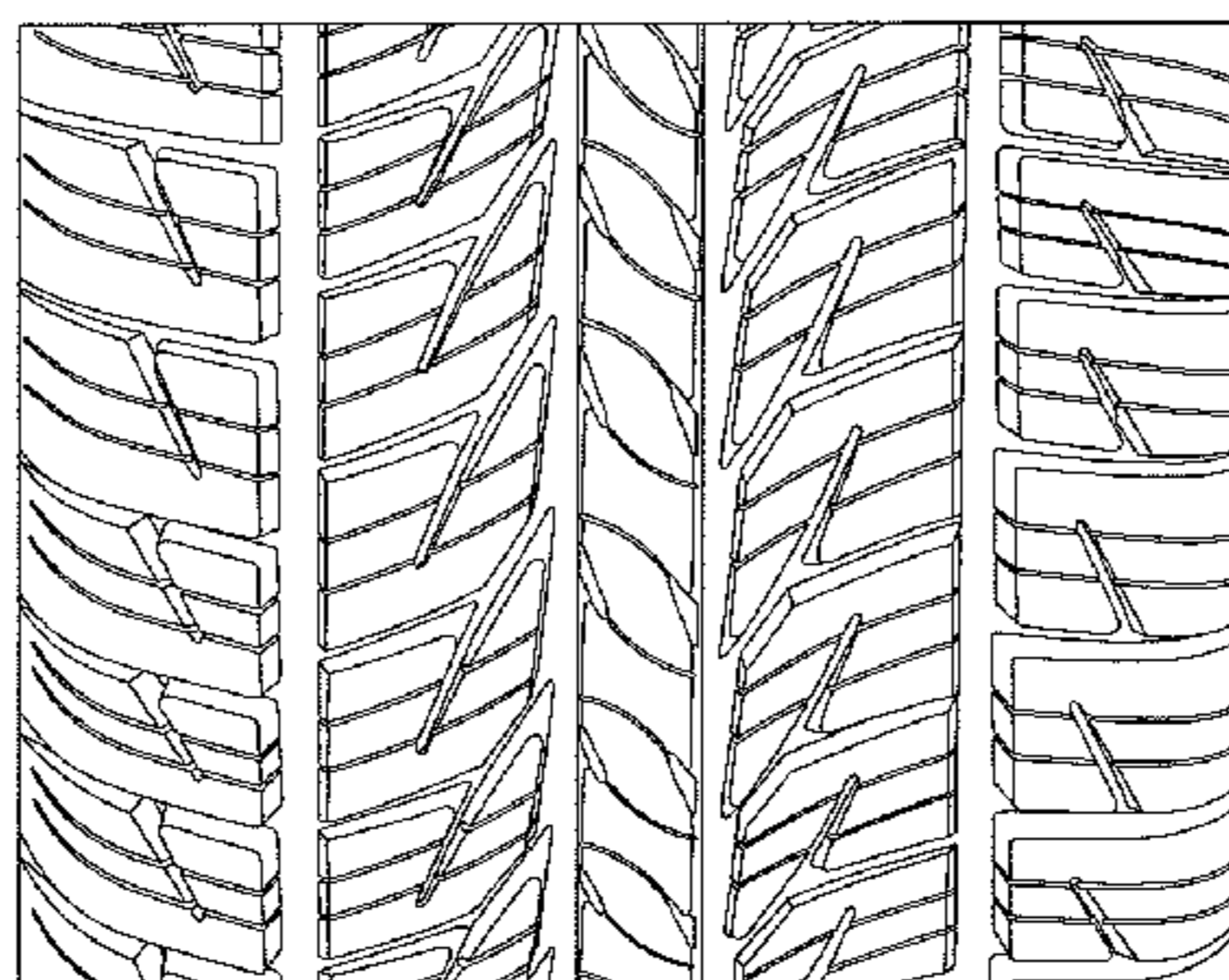
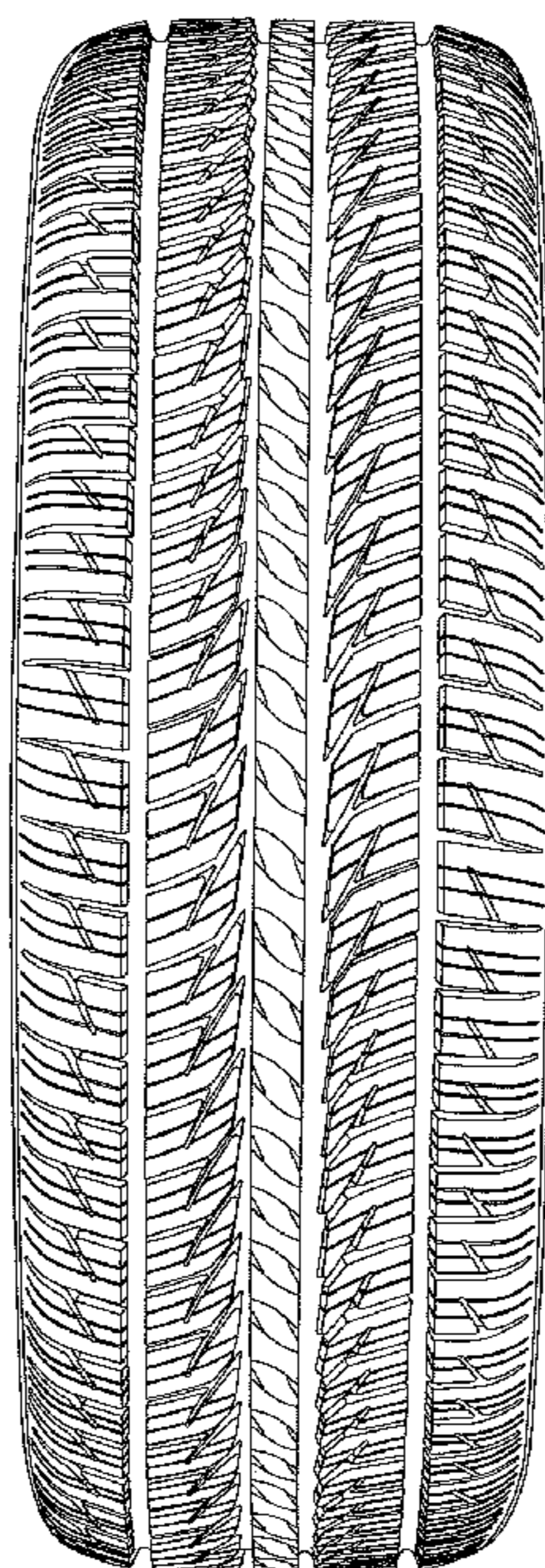
(57) **CLAIM**

I claim the ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a front side perspective view of one embodiment of the tire tread;
FIG. 2 is a front view of FIG. 1;
FIG. 3 shows a left side view of FIG. 1;
FIG. 4 shows a right side view of FIG. 1; and,
FIG. 5 shows an enlarged section of the tire tread of FIG. 1.
The lines defining a box surrounding the section form no part of the design.
Any surfaces of the design not shown, including interior surfaces, form no part of the claimed invention.

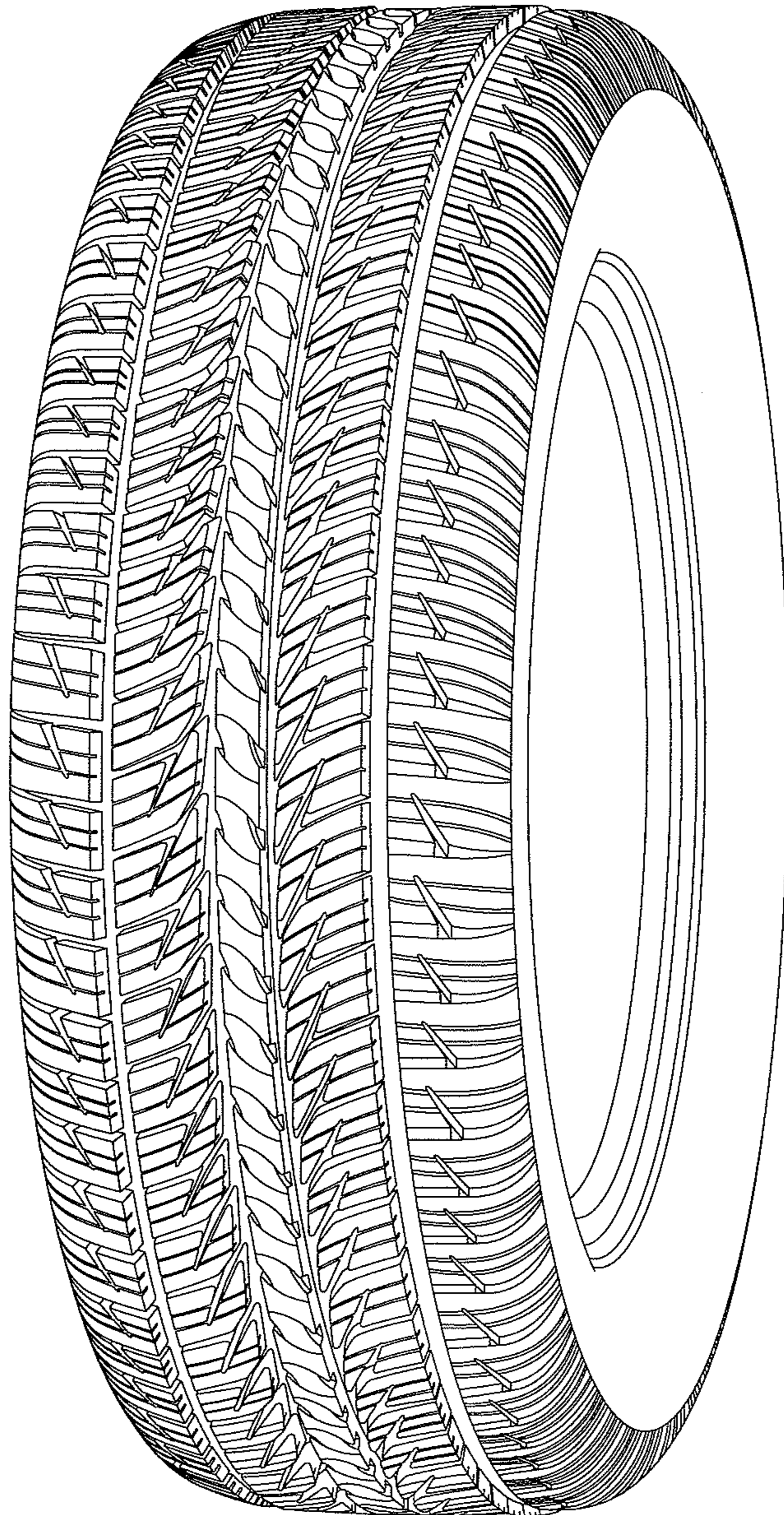

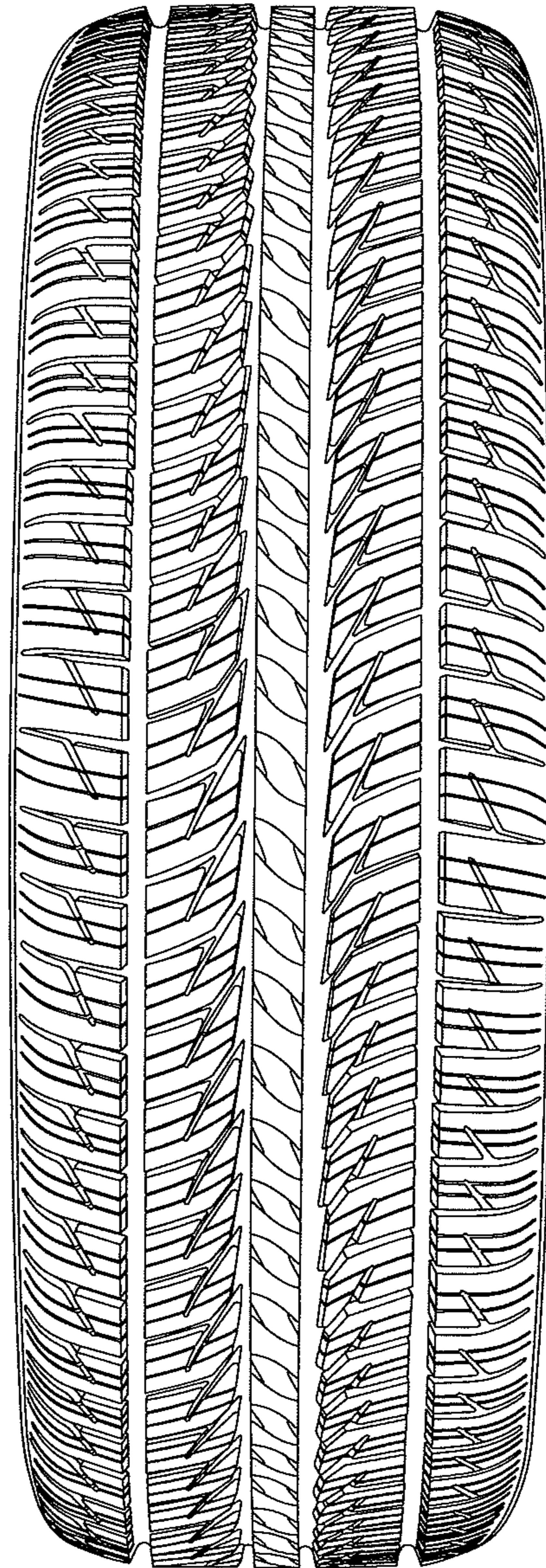

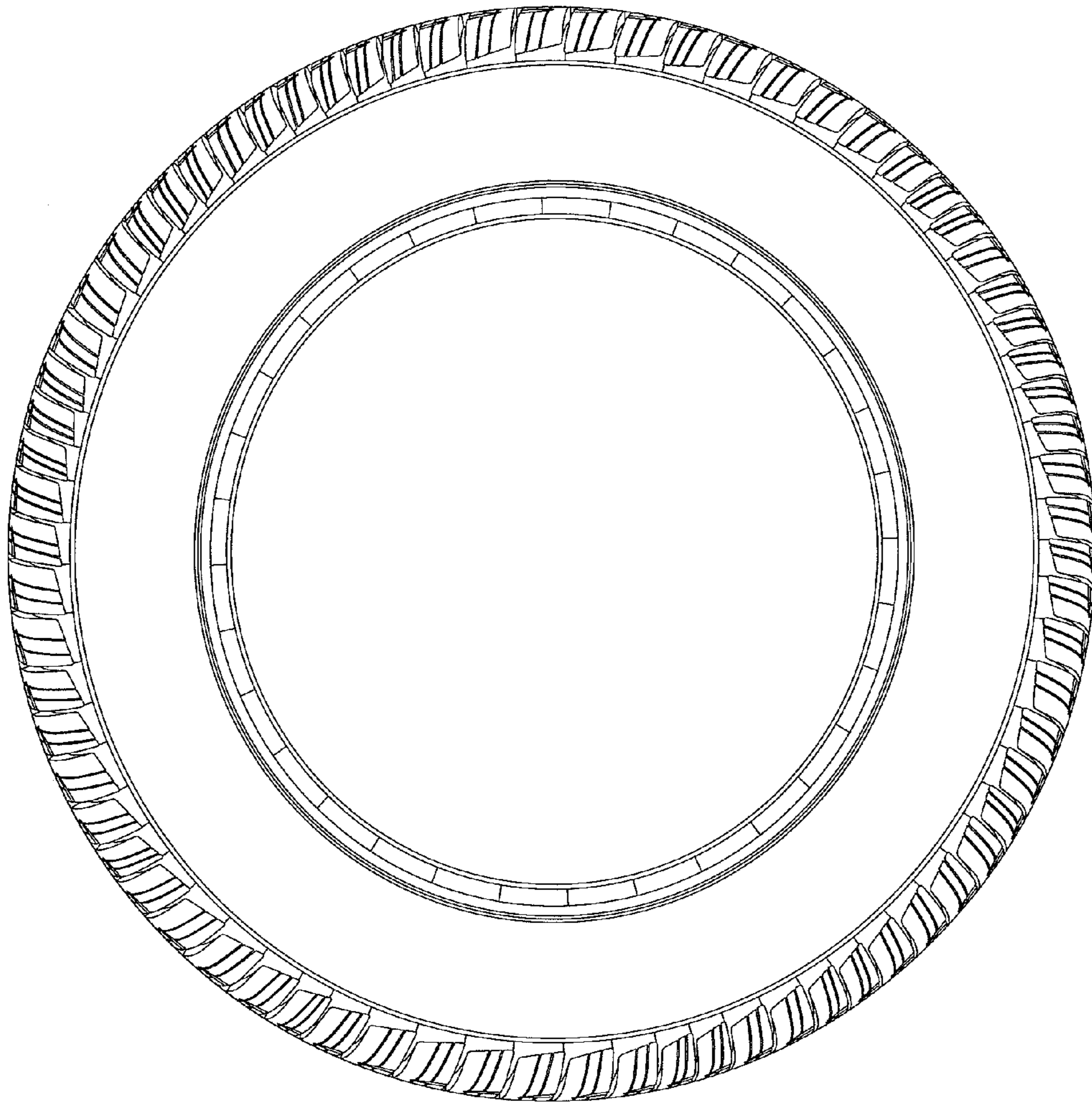

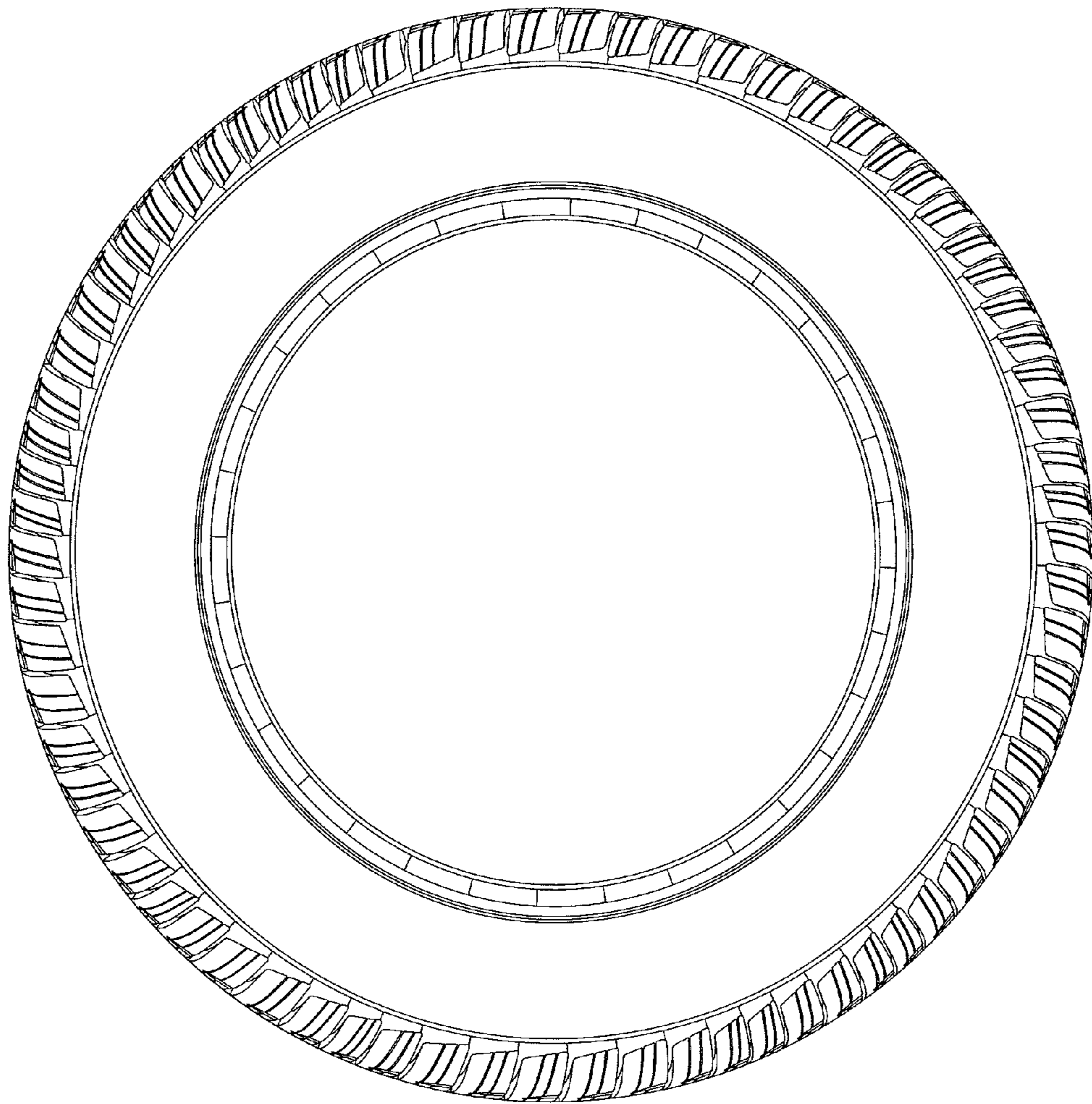

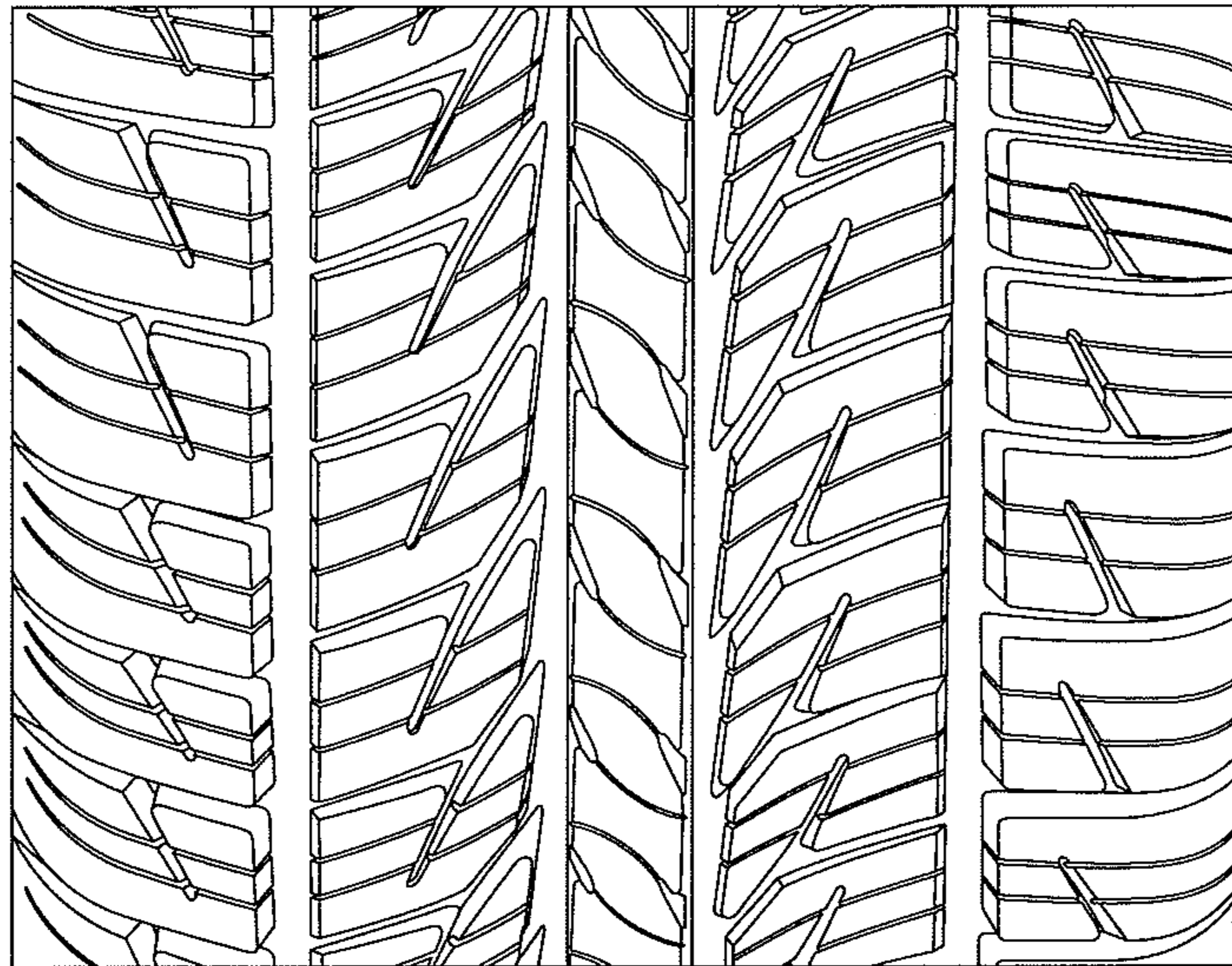
