FIG. 5 is an opposing side view thereof;

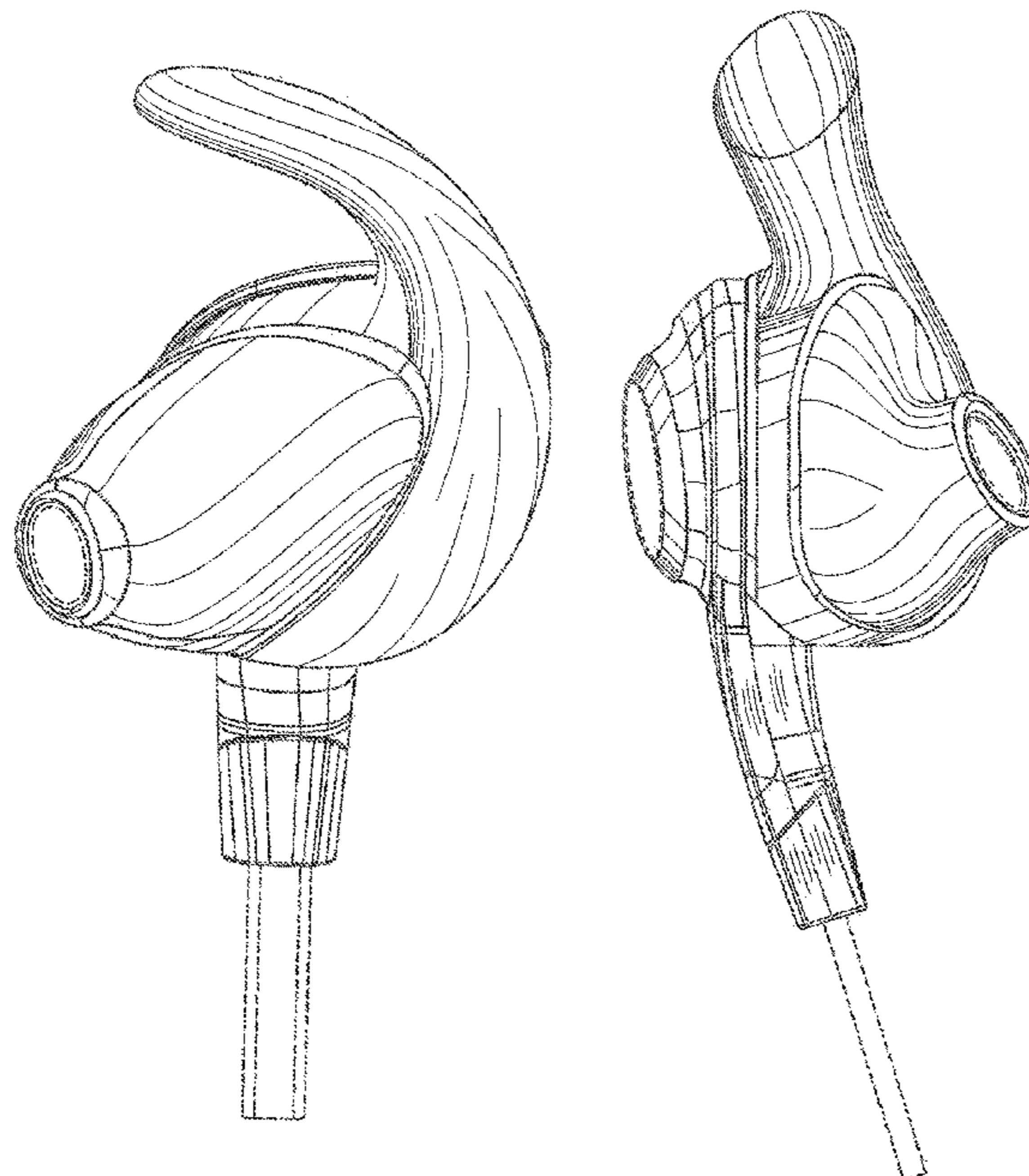
FIG. 6 is a top view thereof;

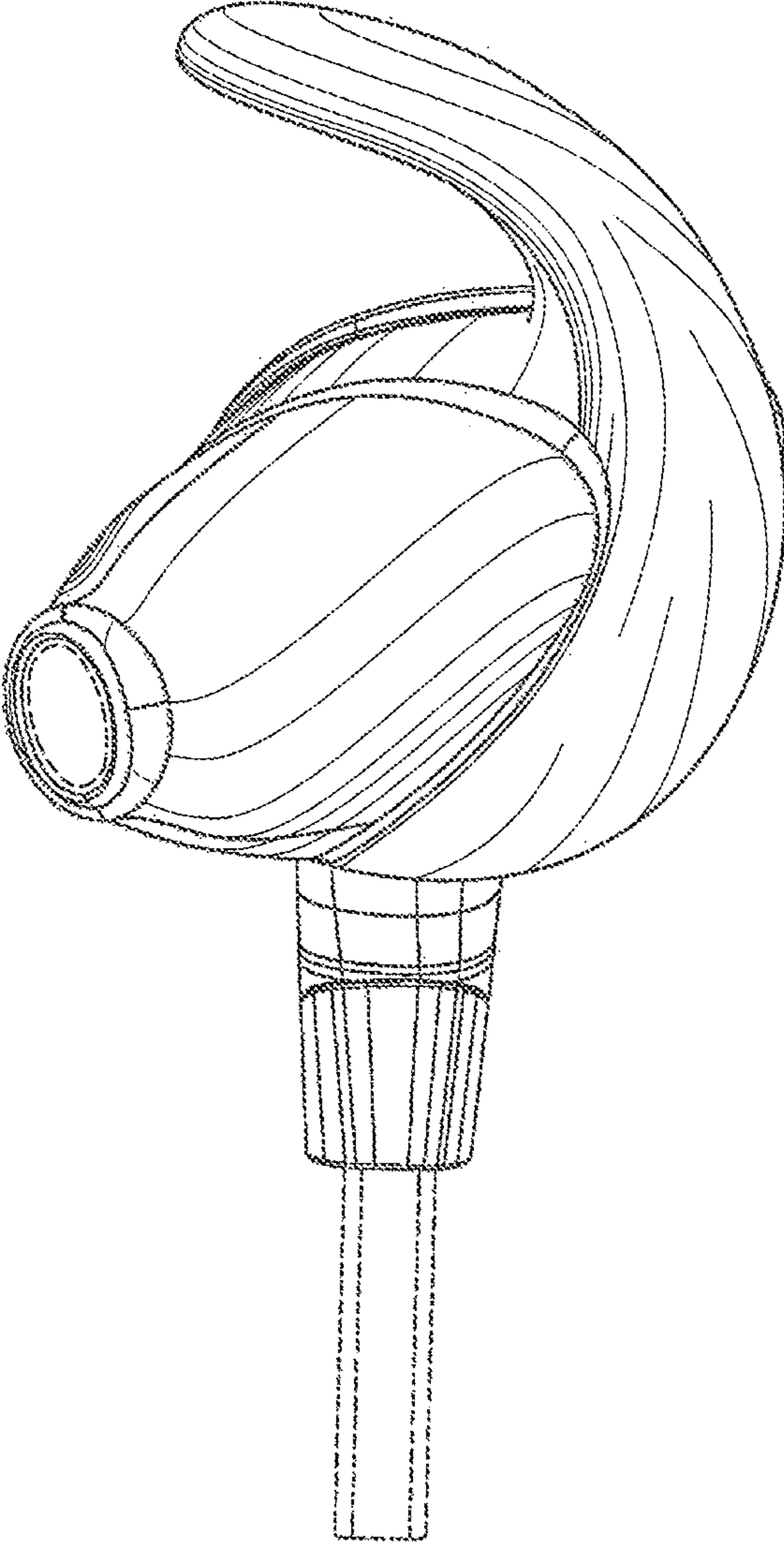

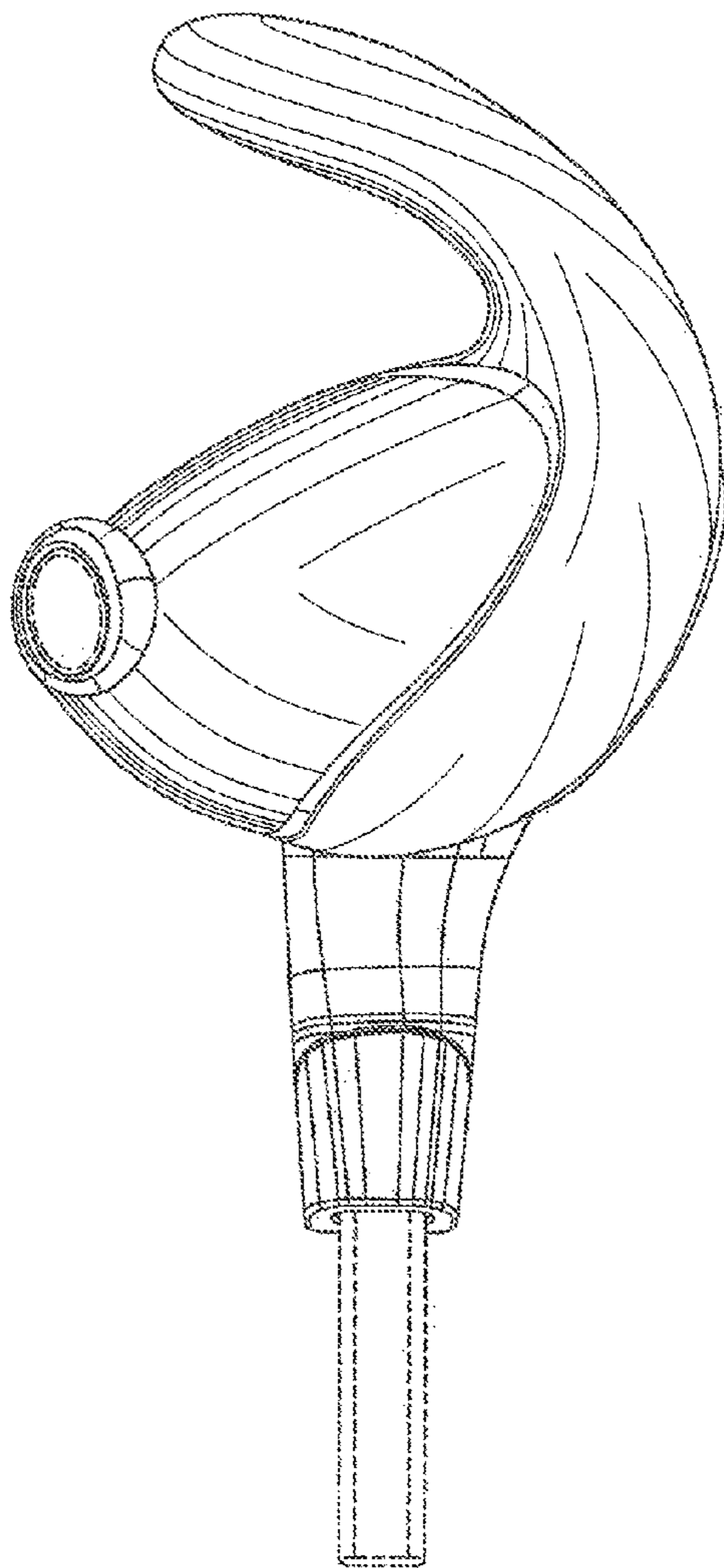

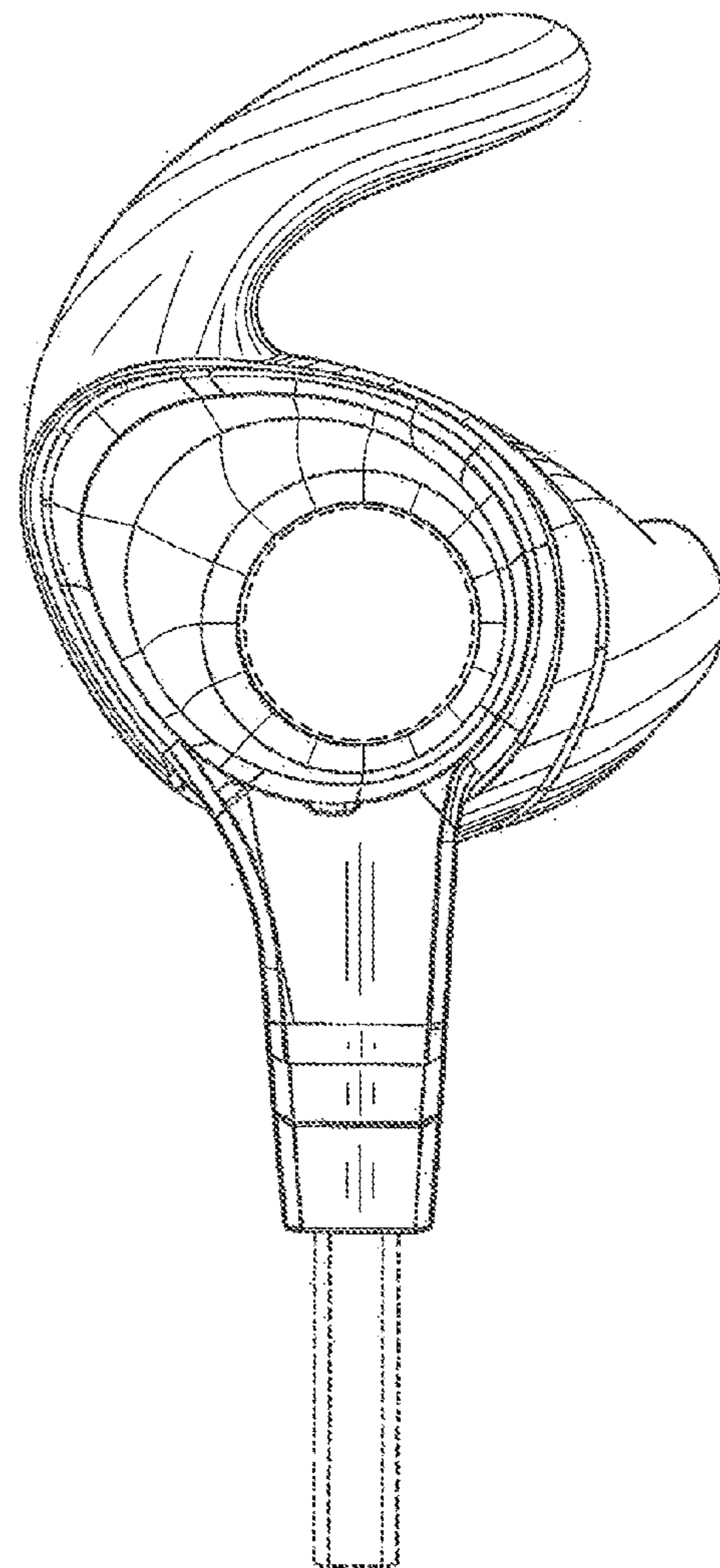

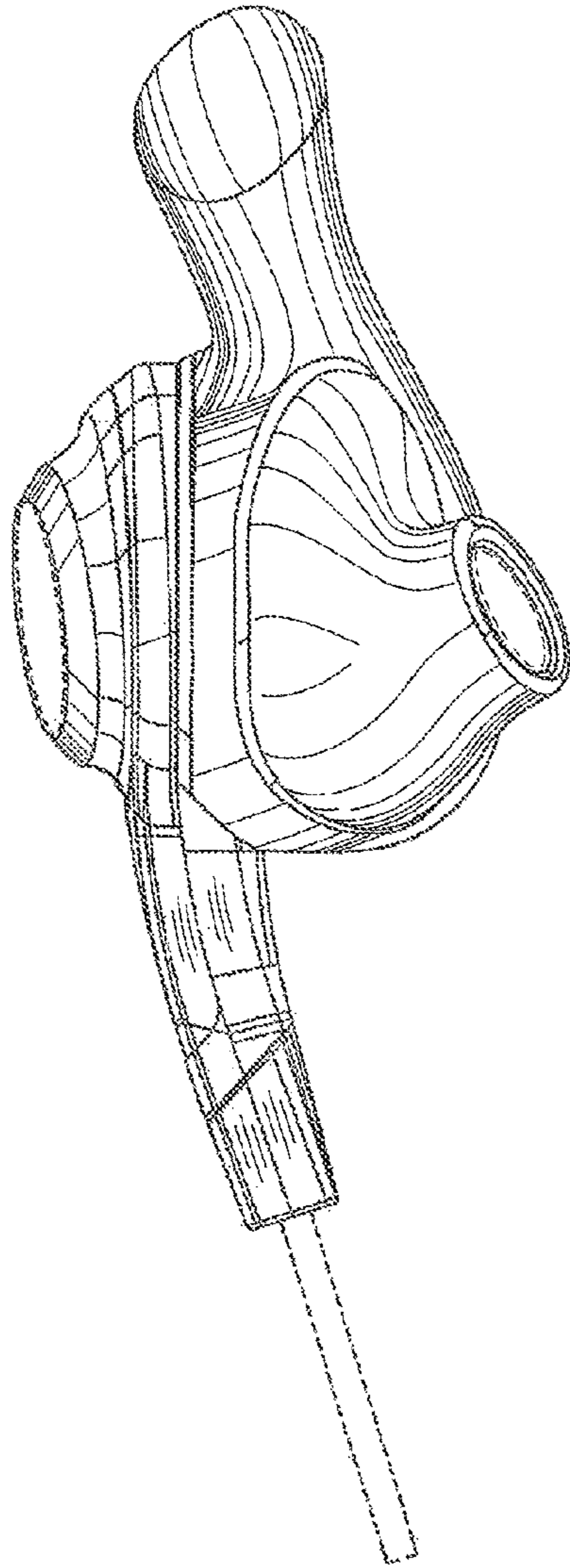

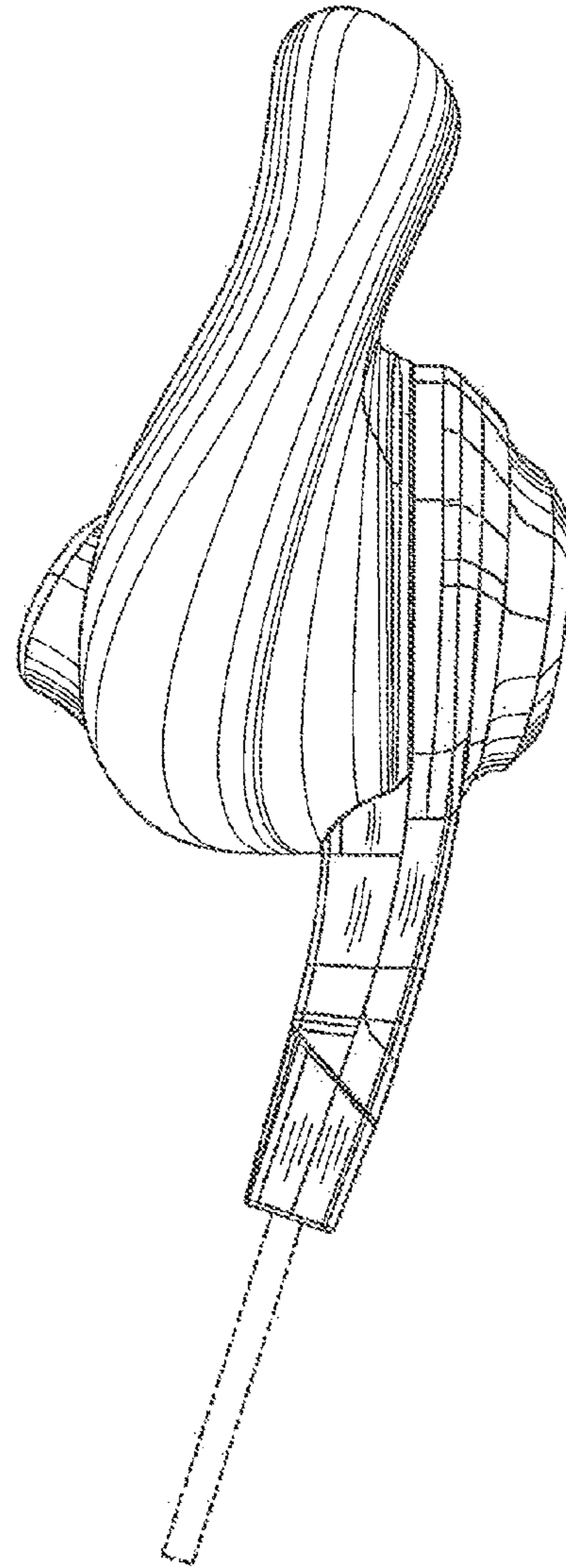

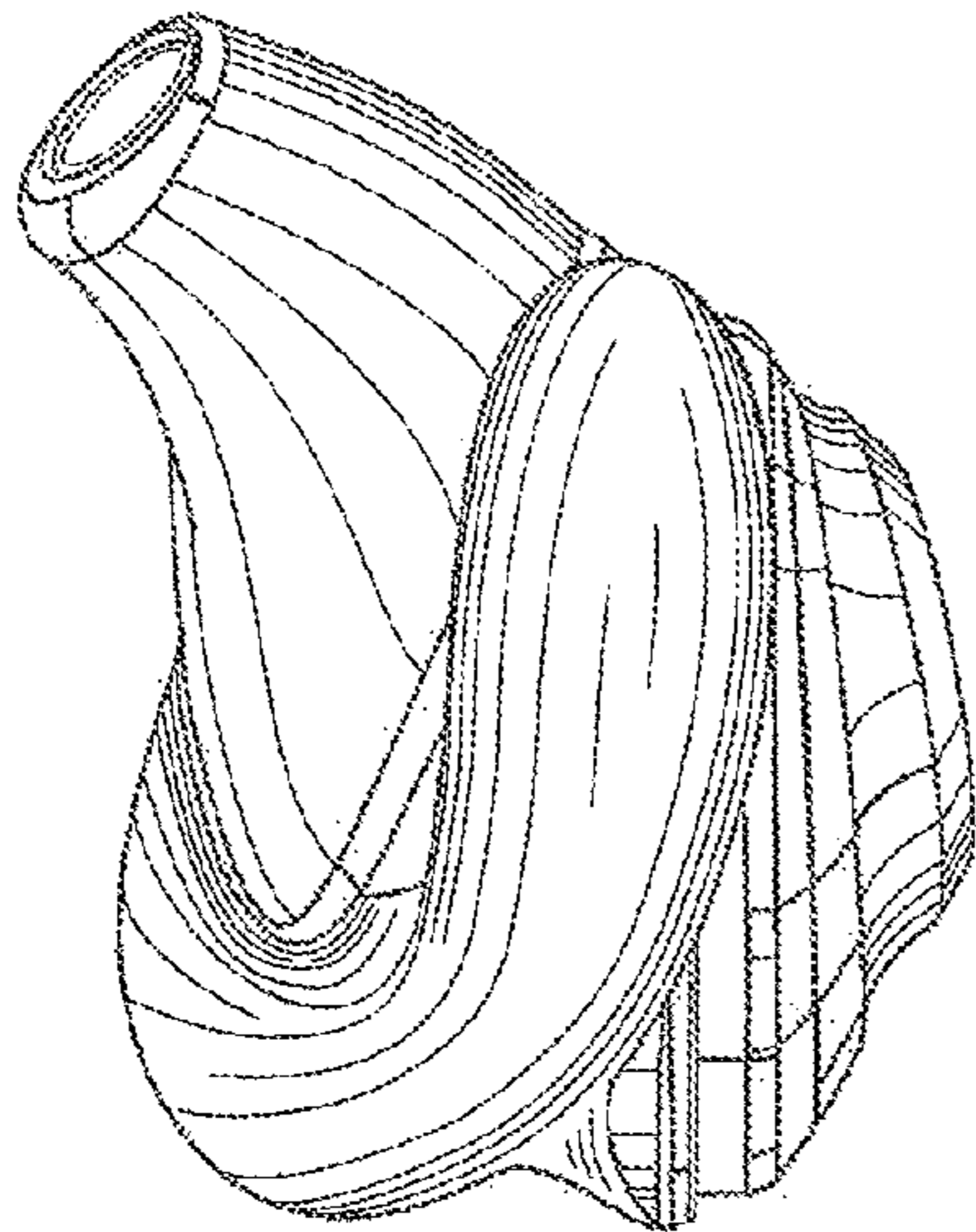

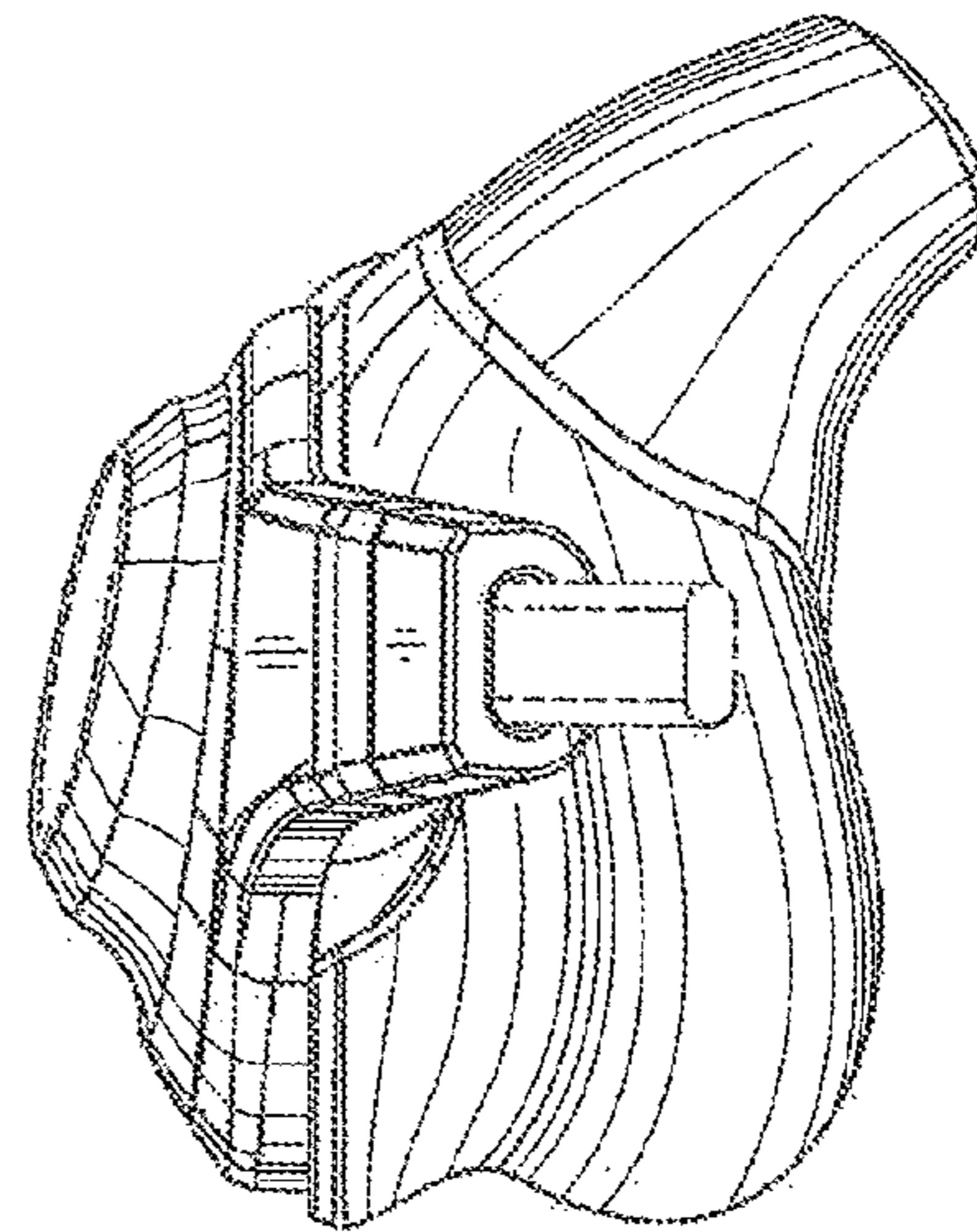

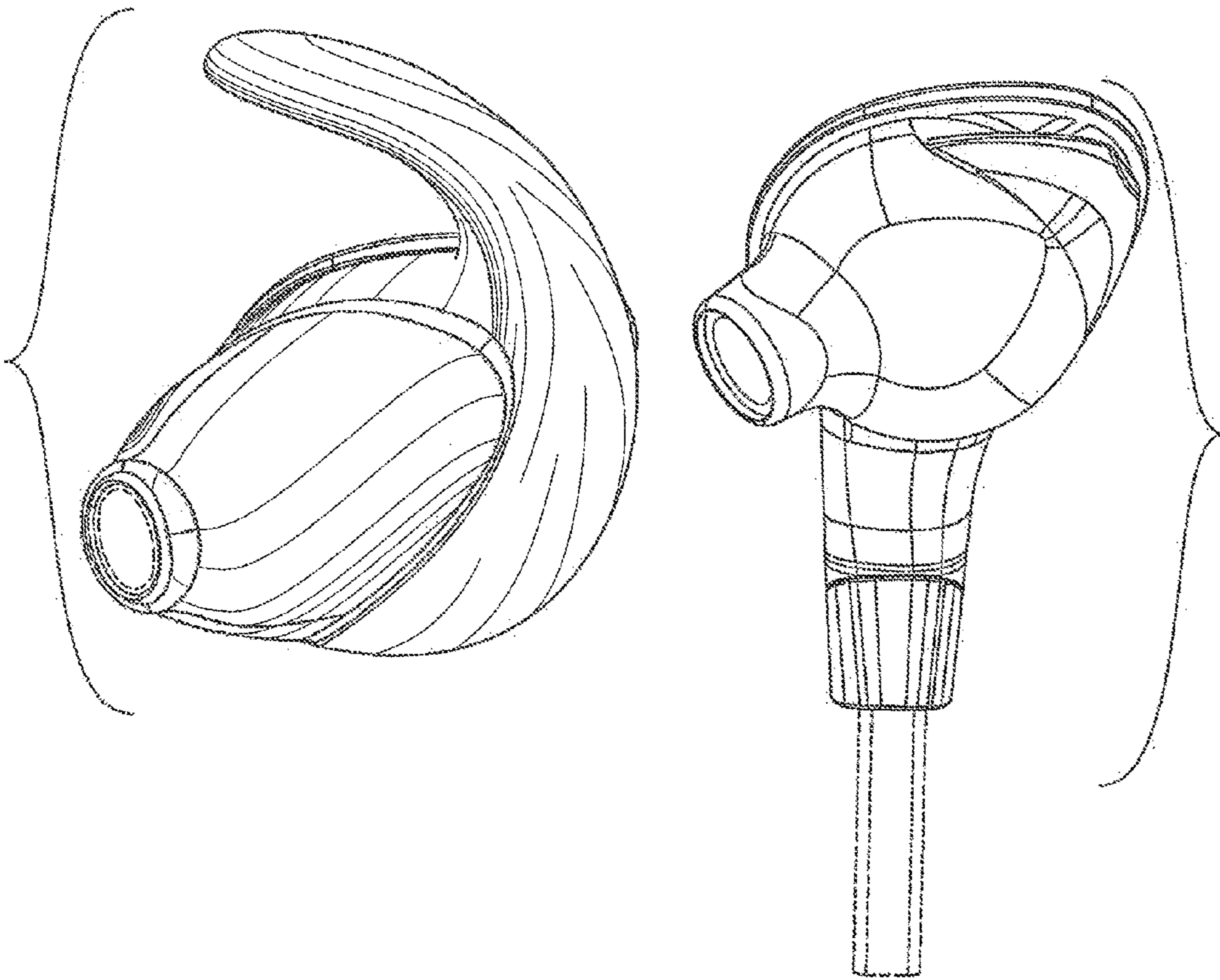
