DESCRIPTION

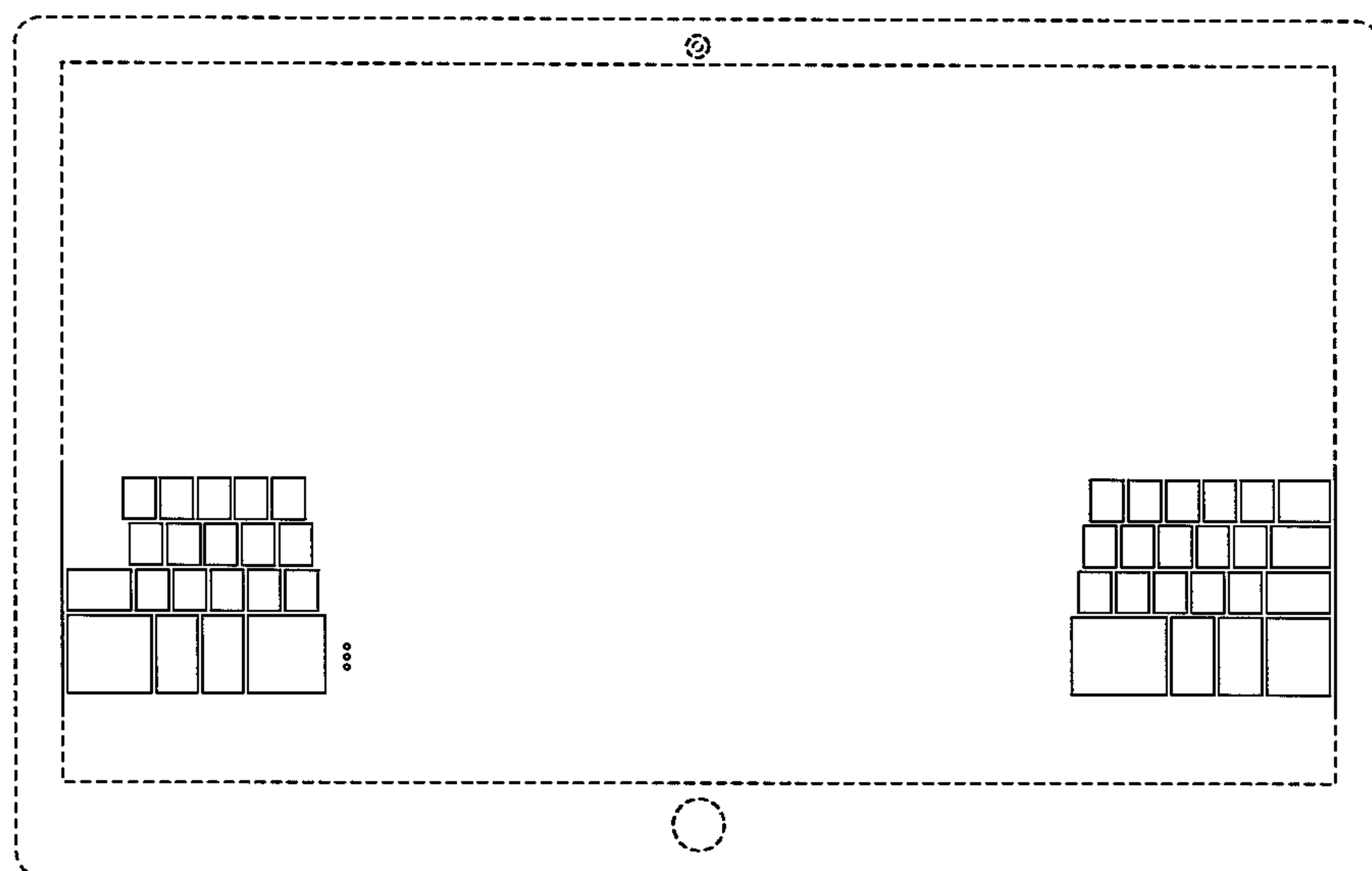
FIG. 1 is the first image in a sequence for a display screen with a transitional graphical user interface showing the new design; and

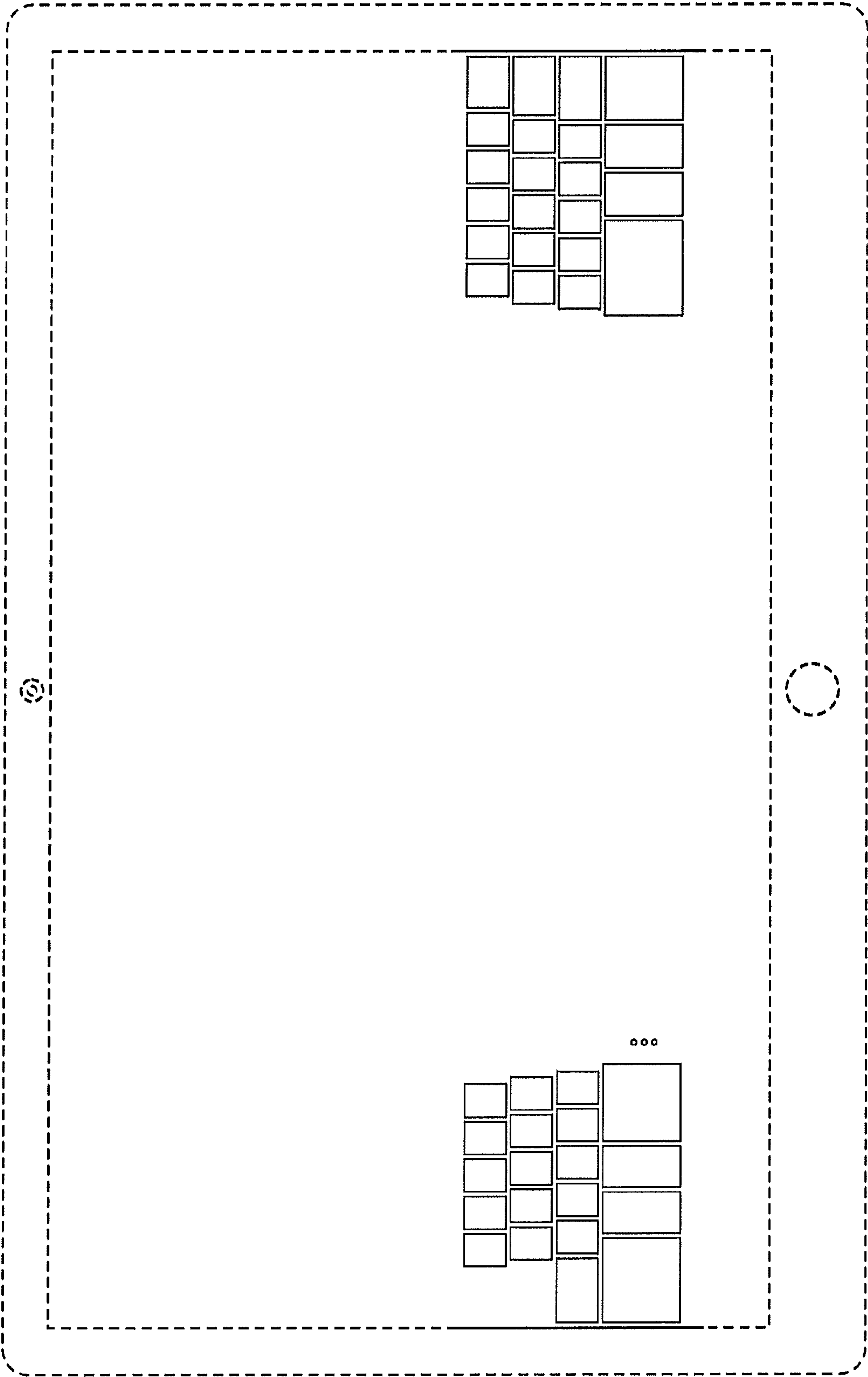

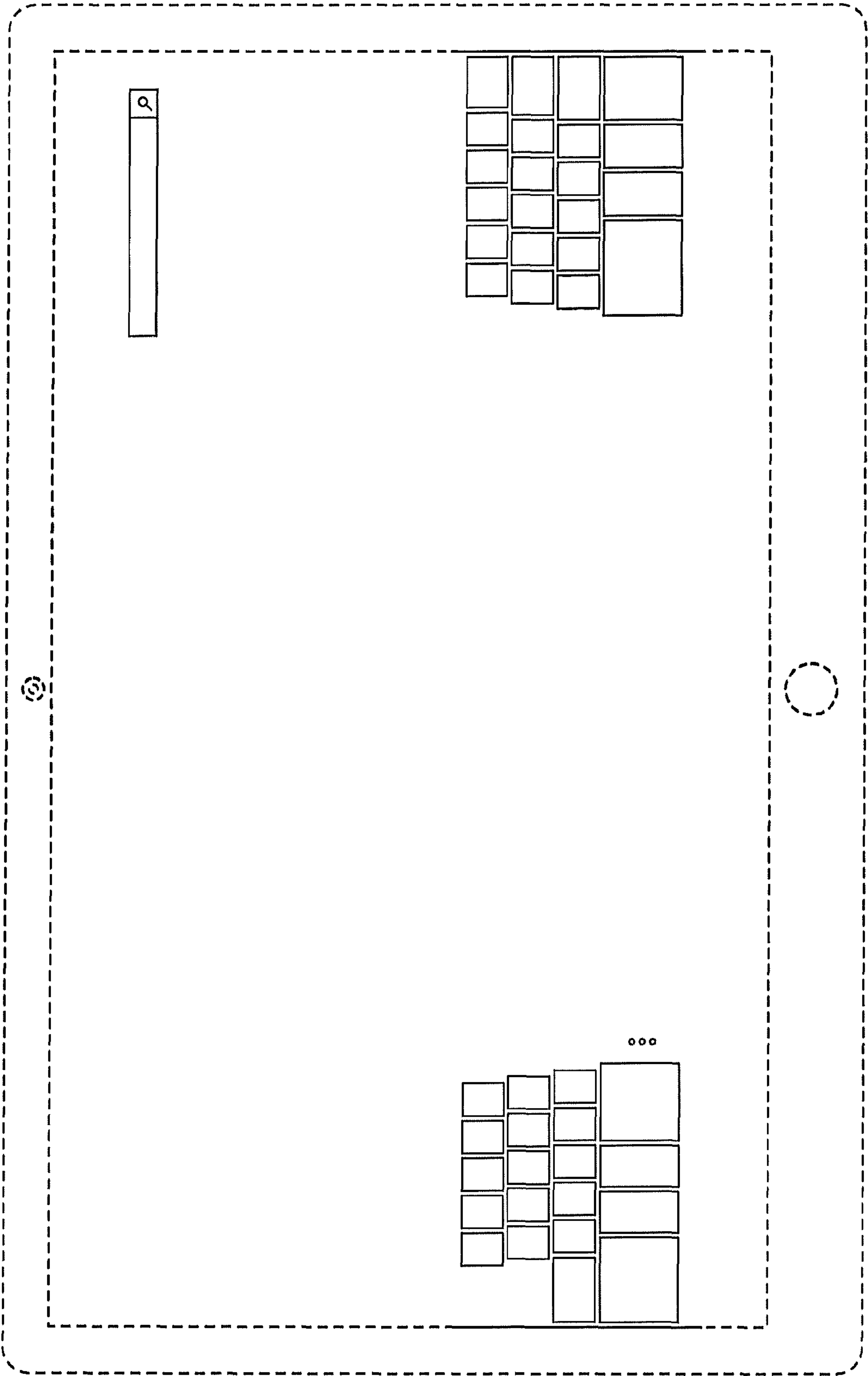

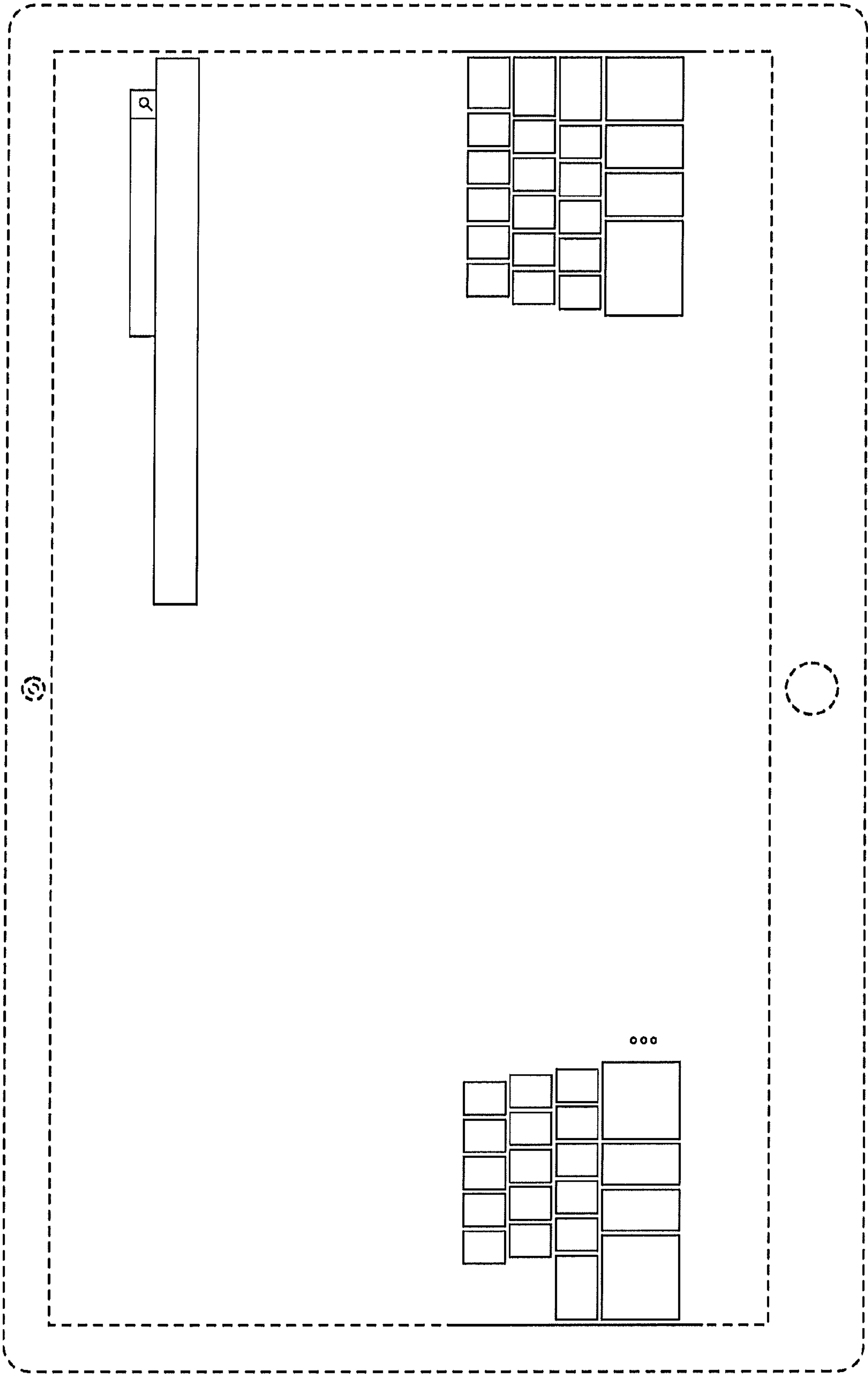
