The ornamental design for a no-mar workpiece support, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view from above of a no-mar workpiece support showing our new design; FIG. 2 is a top plan view of the embodiment of FIG. 1; FIG. 3 is a rear elevational view of the embodiment of FIG. 1; FIG. 4 is a front elevation view of the embodiment of FIG. 1; FIG. 5 is a right-side elevational view of the embodiment of FIG. 1; and, FIG. 6 is a left-side elevational view of the embodiment of FIG. 1. The phantom lines shown in the drawings are for illustrative purposes only and form no part of the claimed design.

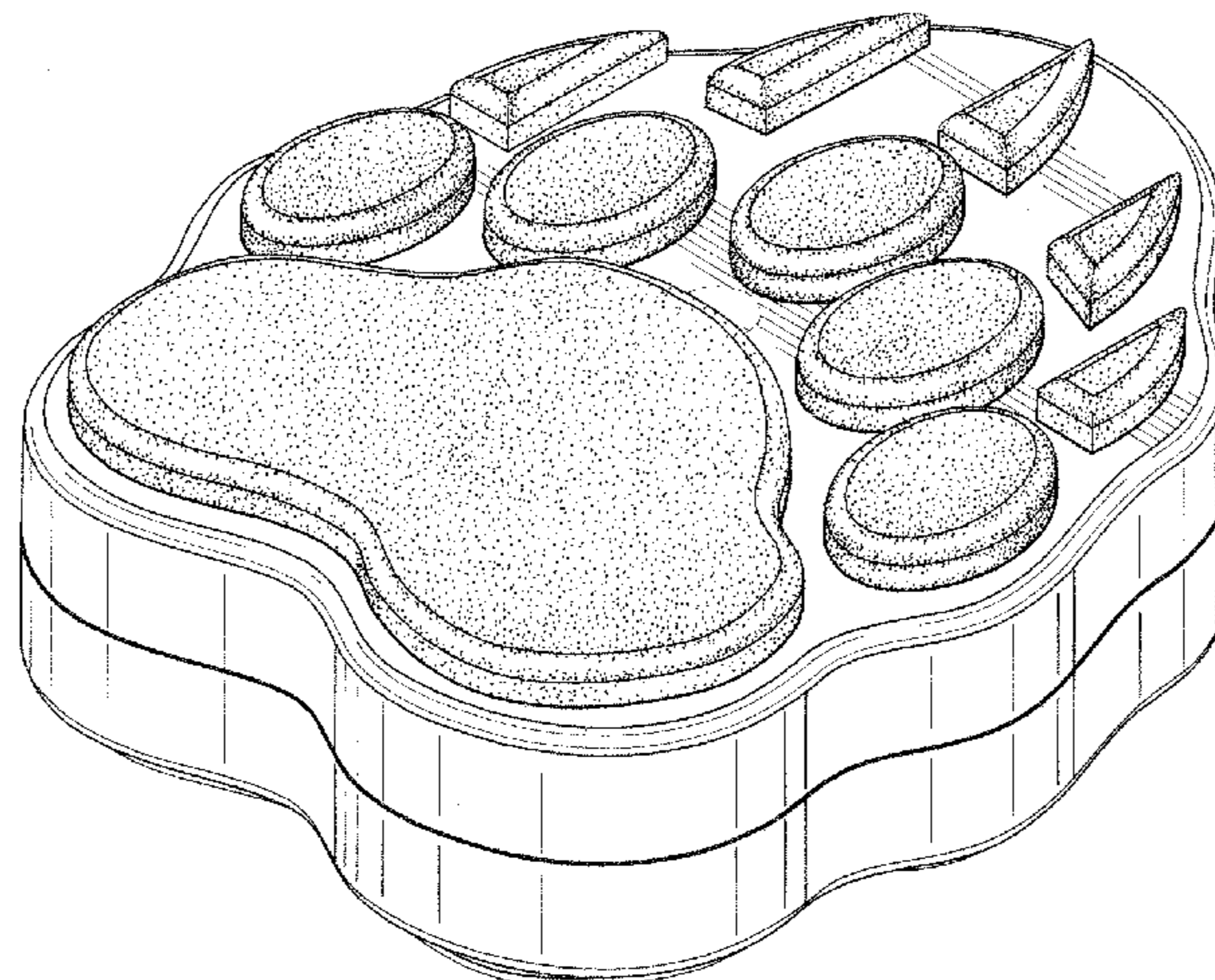

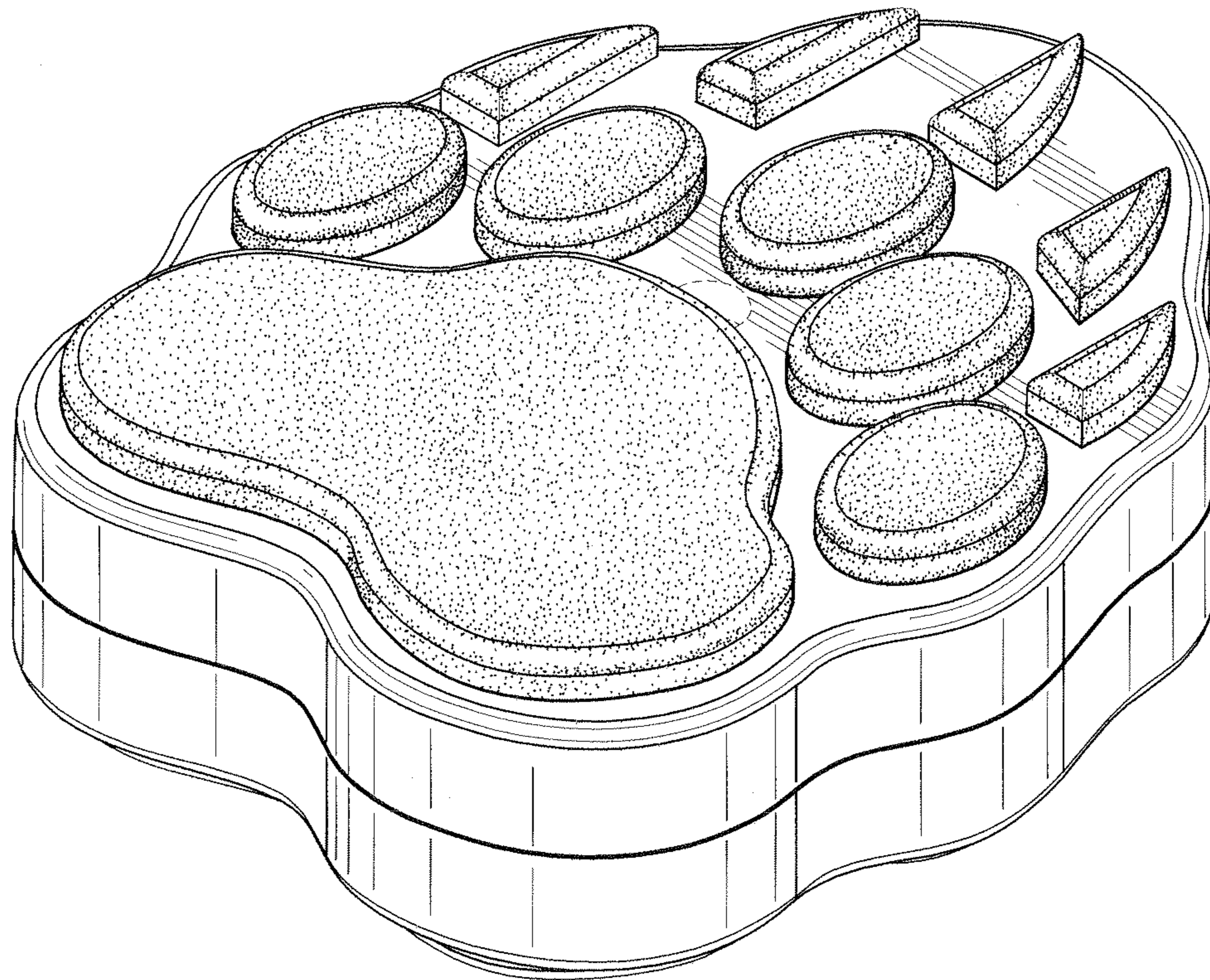

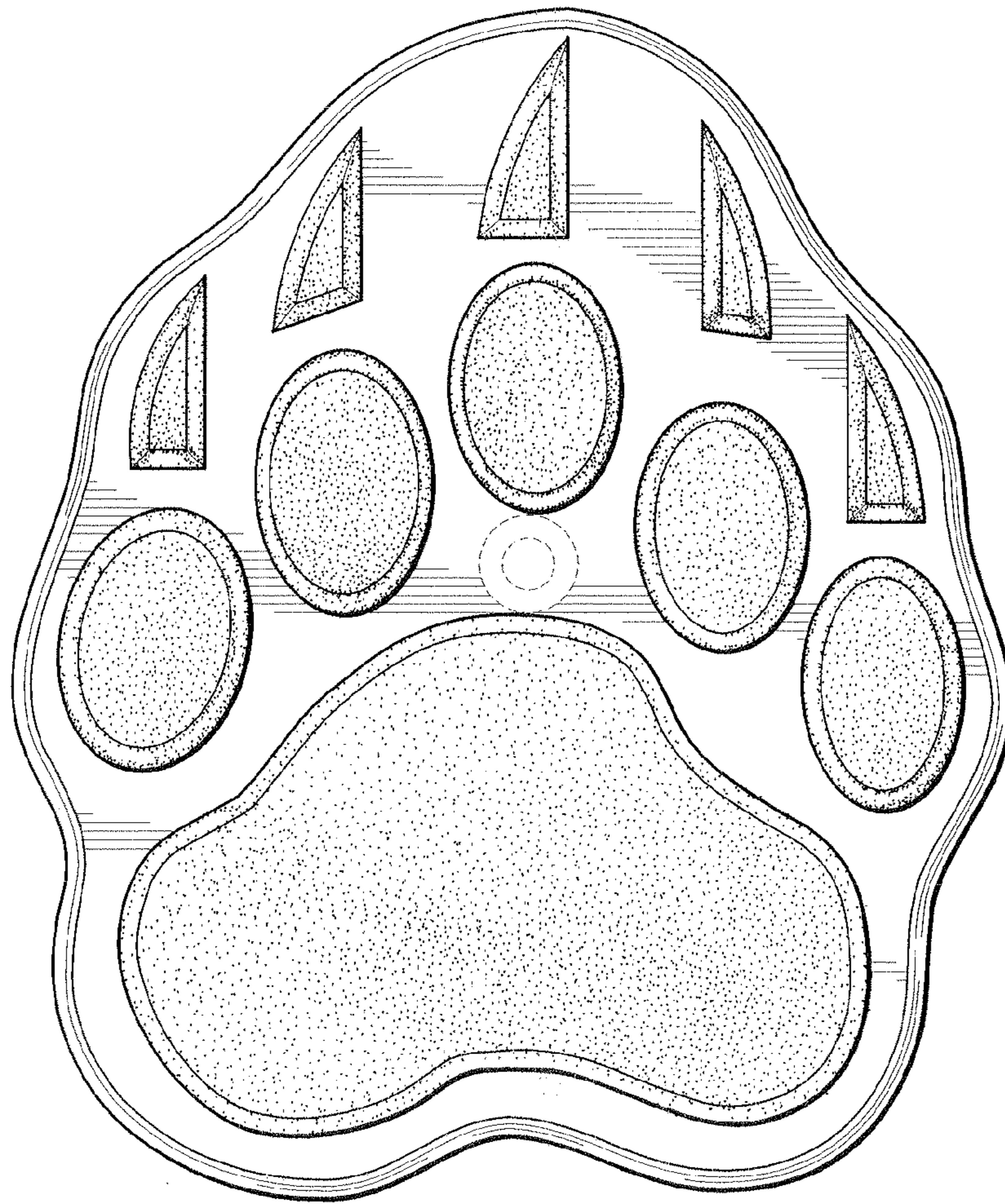

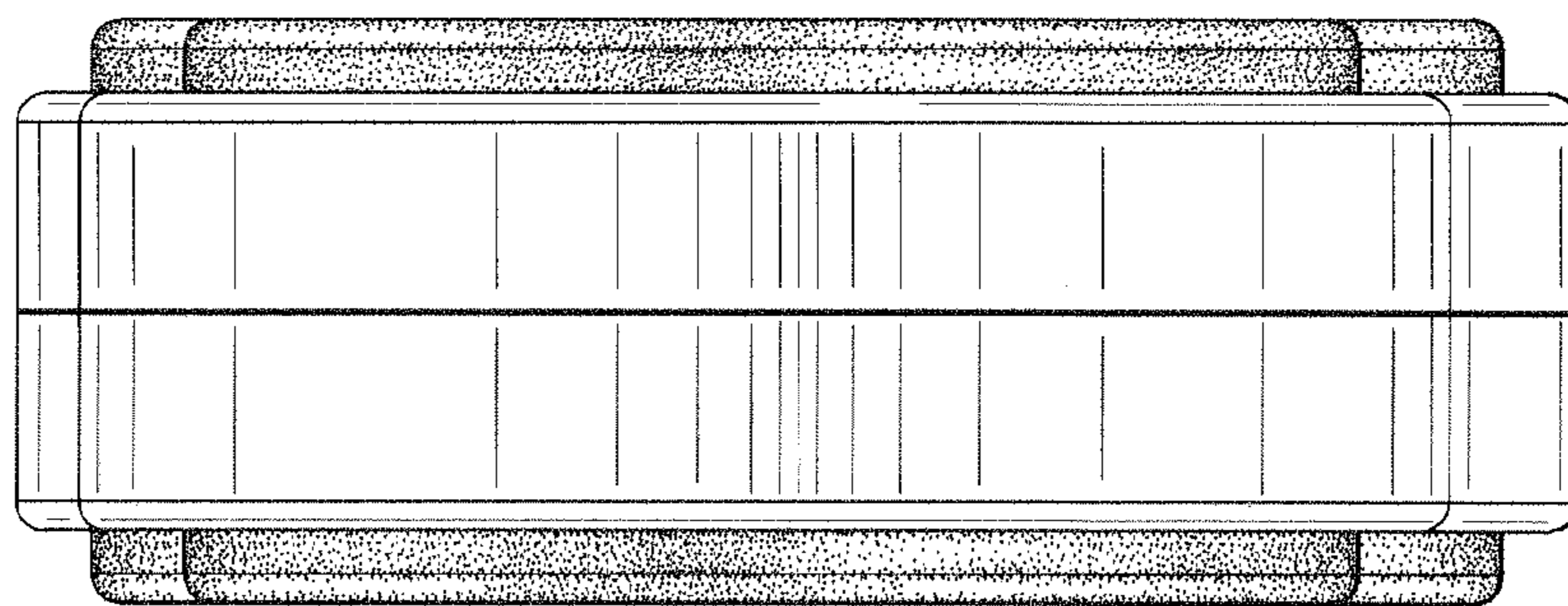

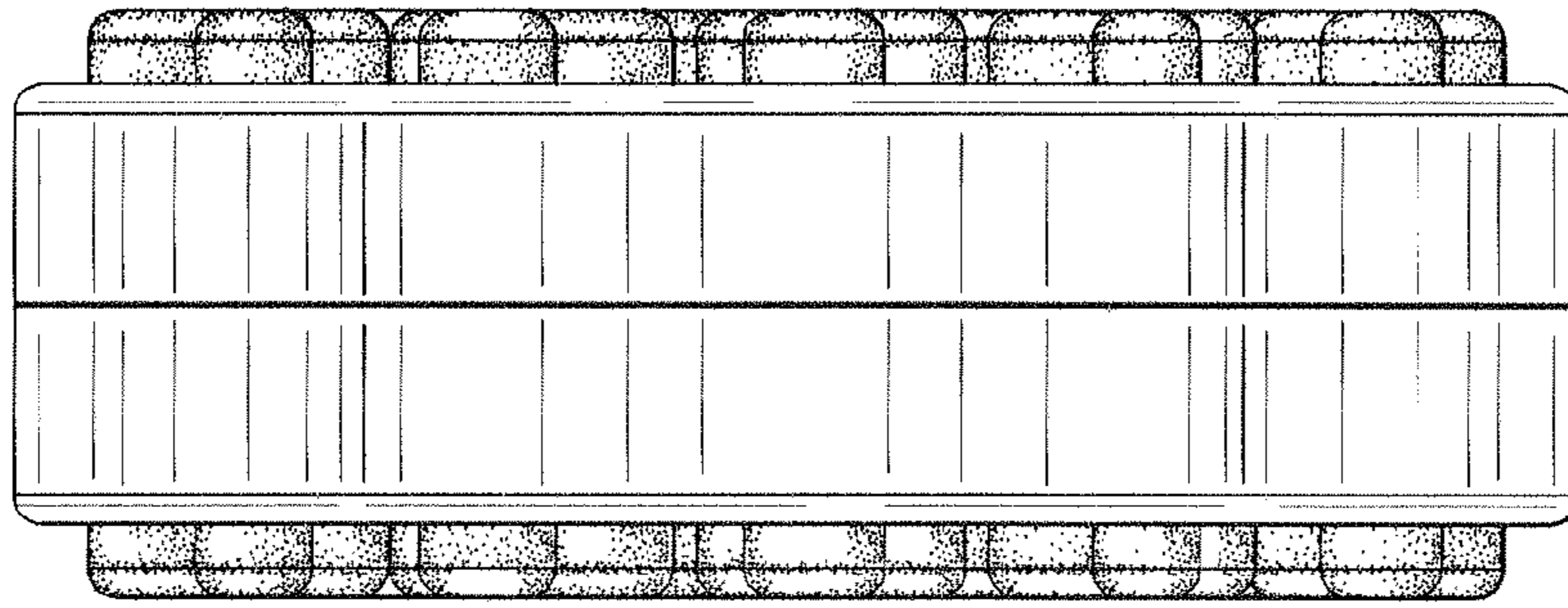

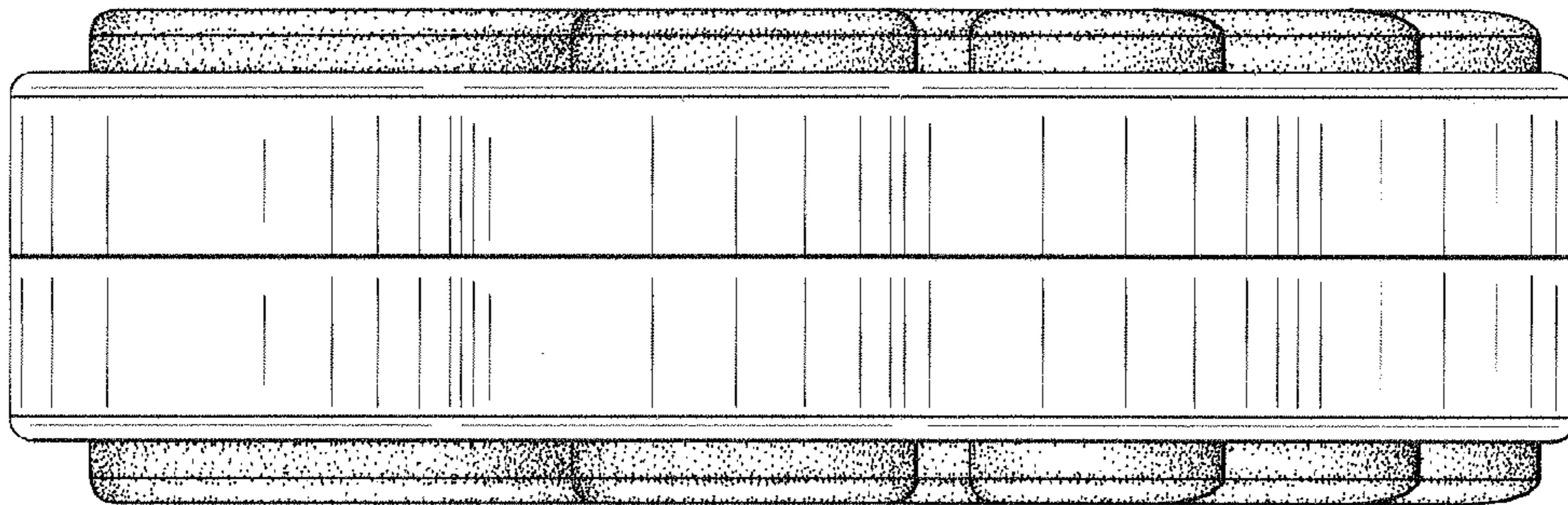

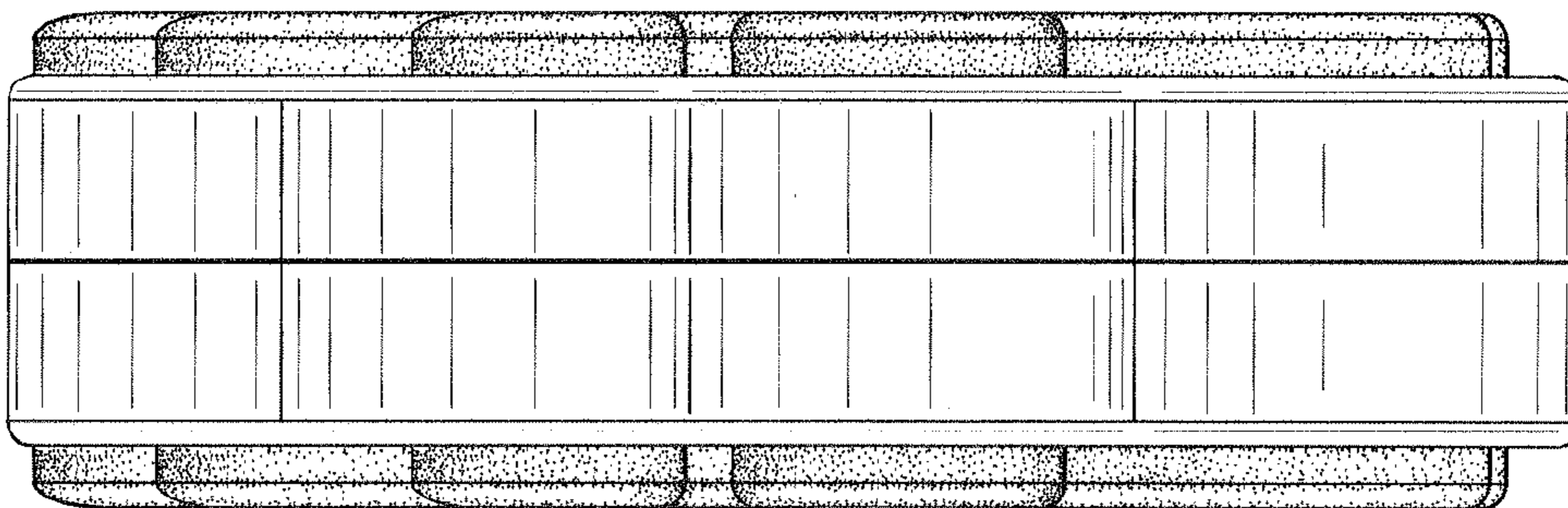
