DESCRIPTION

FIG. 1 is a perspective view of a presently preferred embodiment of the spray painter eyewear of my new design from the front left;

FIG. 4 is a top plan view thereof;

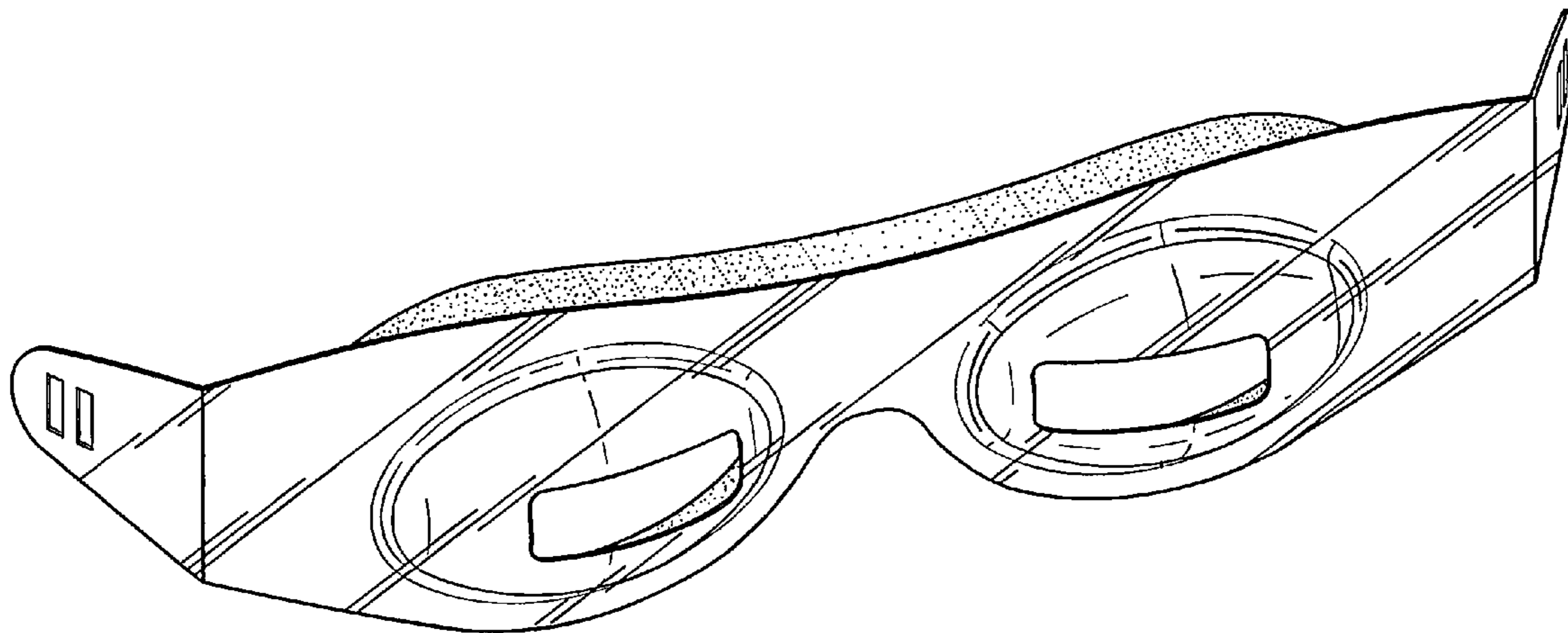
FIG. 5 is a bottom plan view thereof;

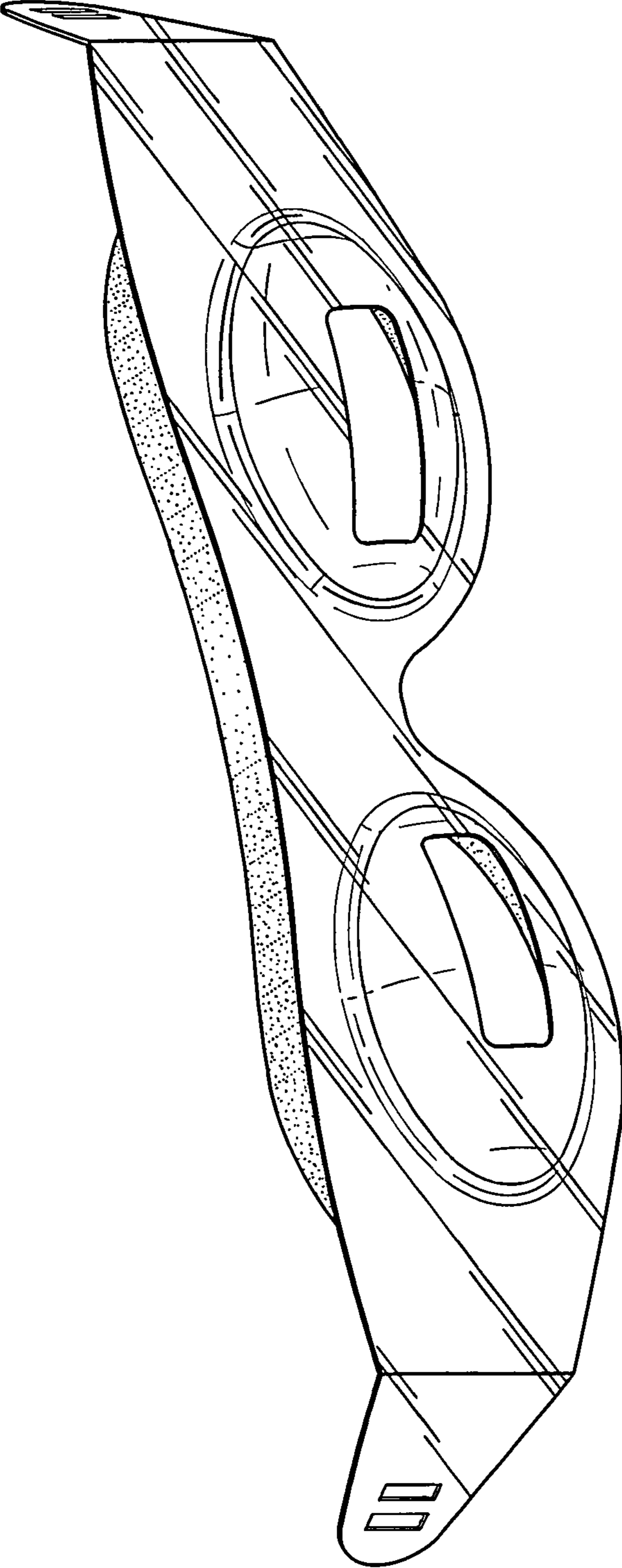

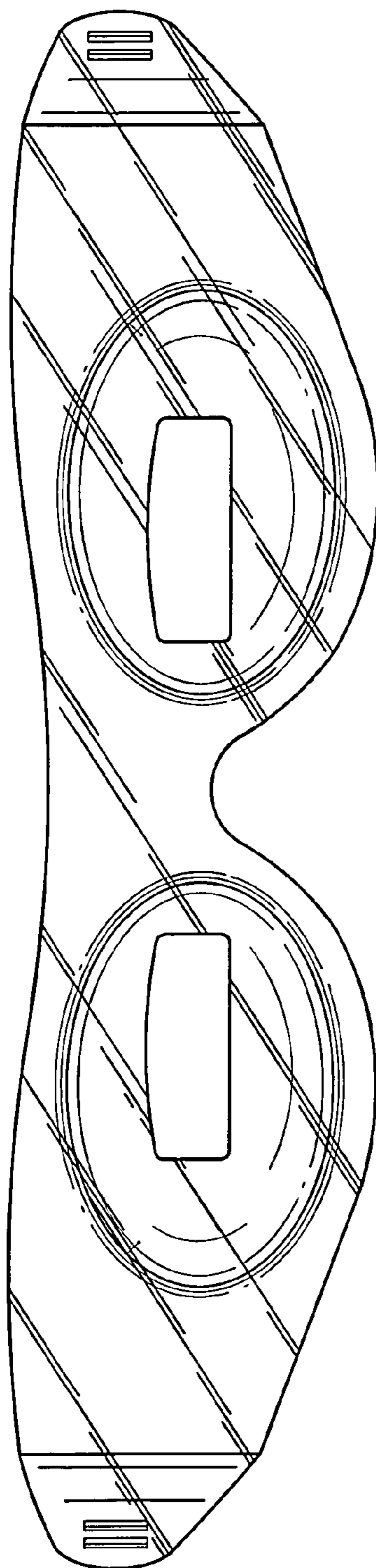

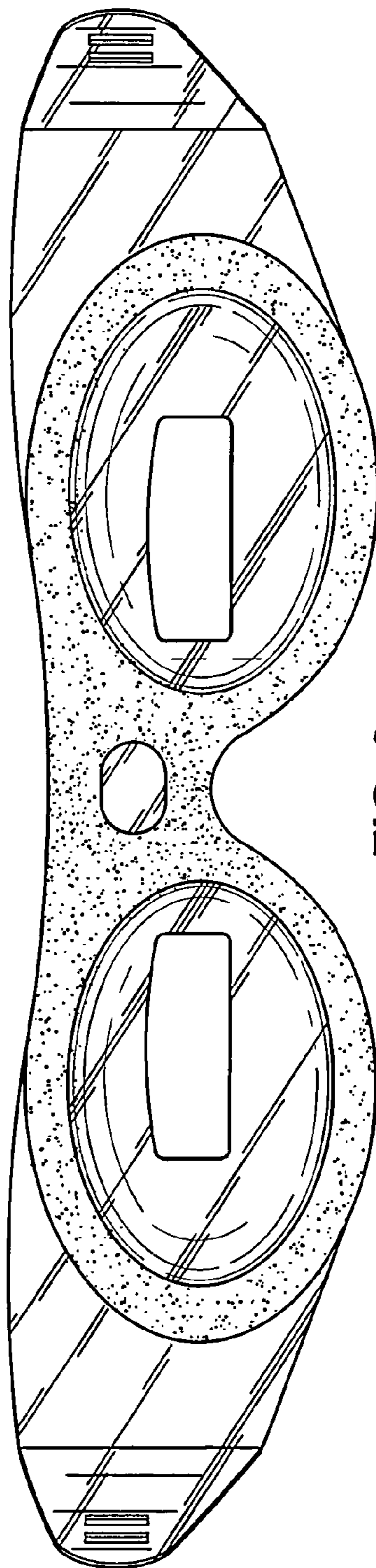

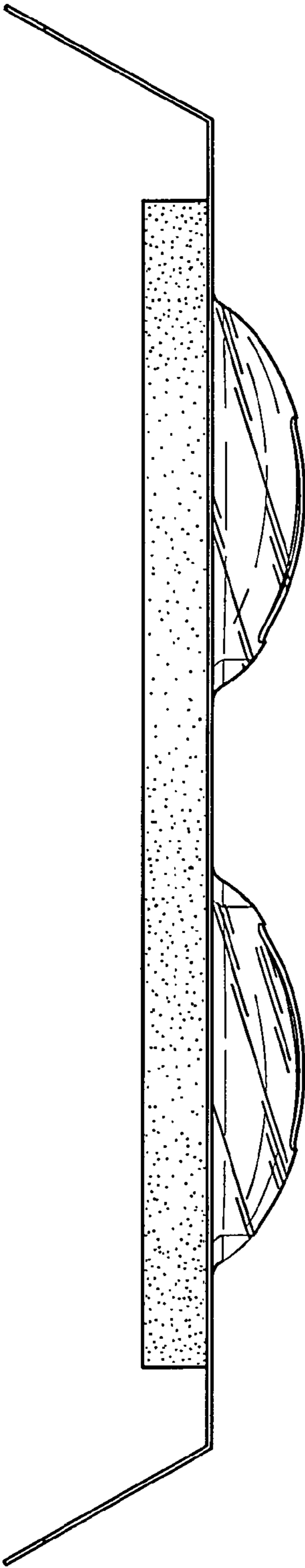

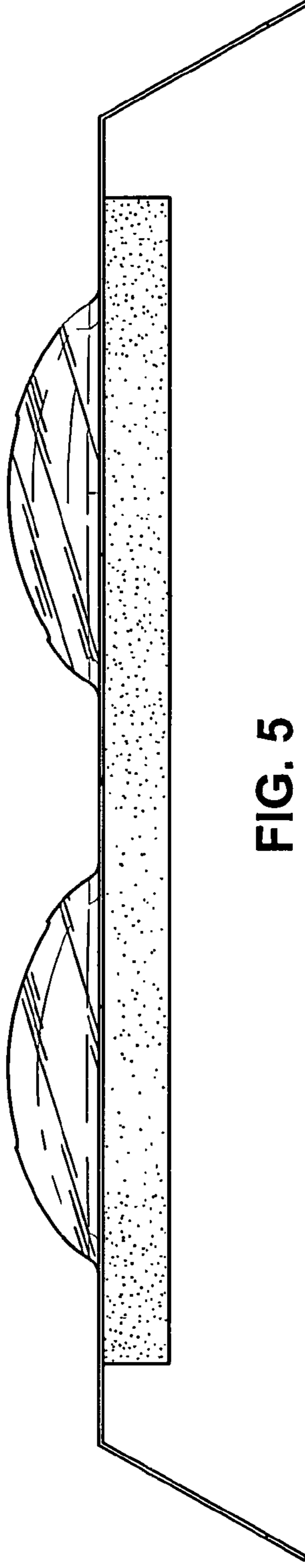

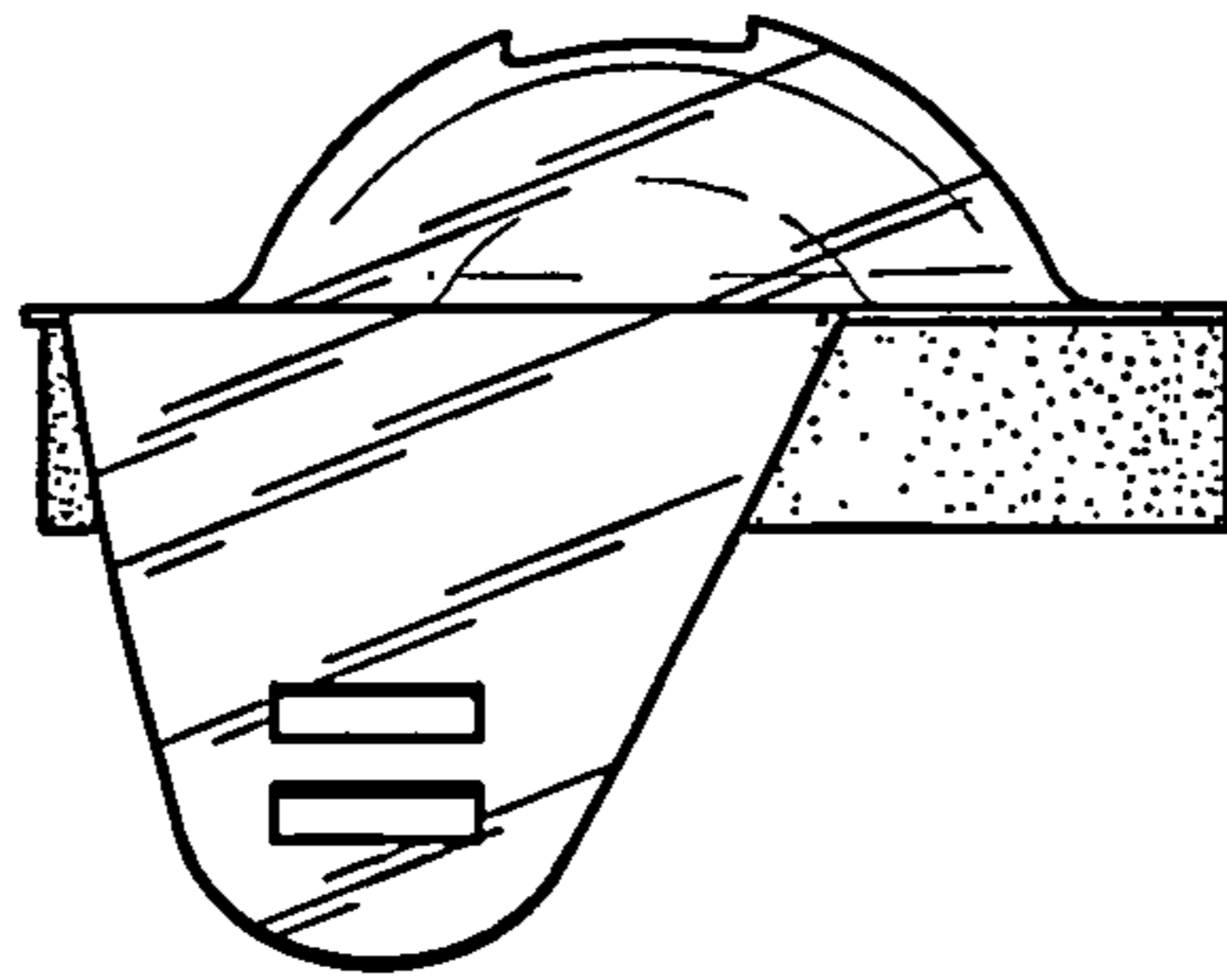

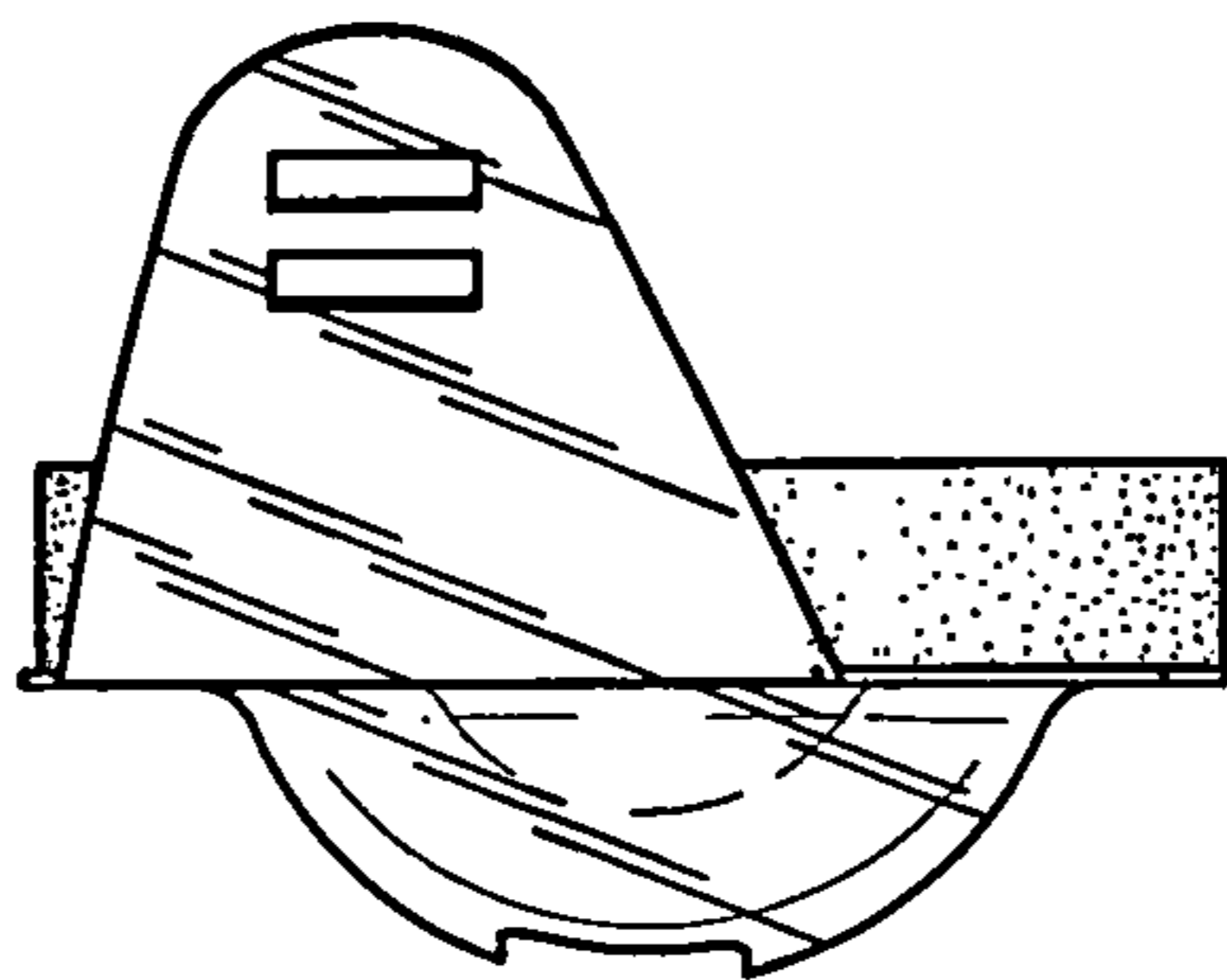

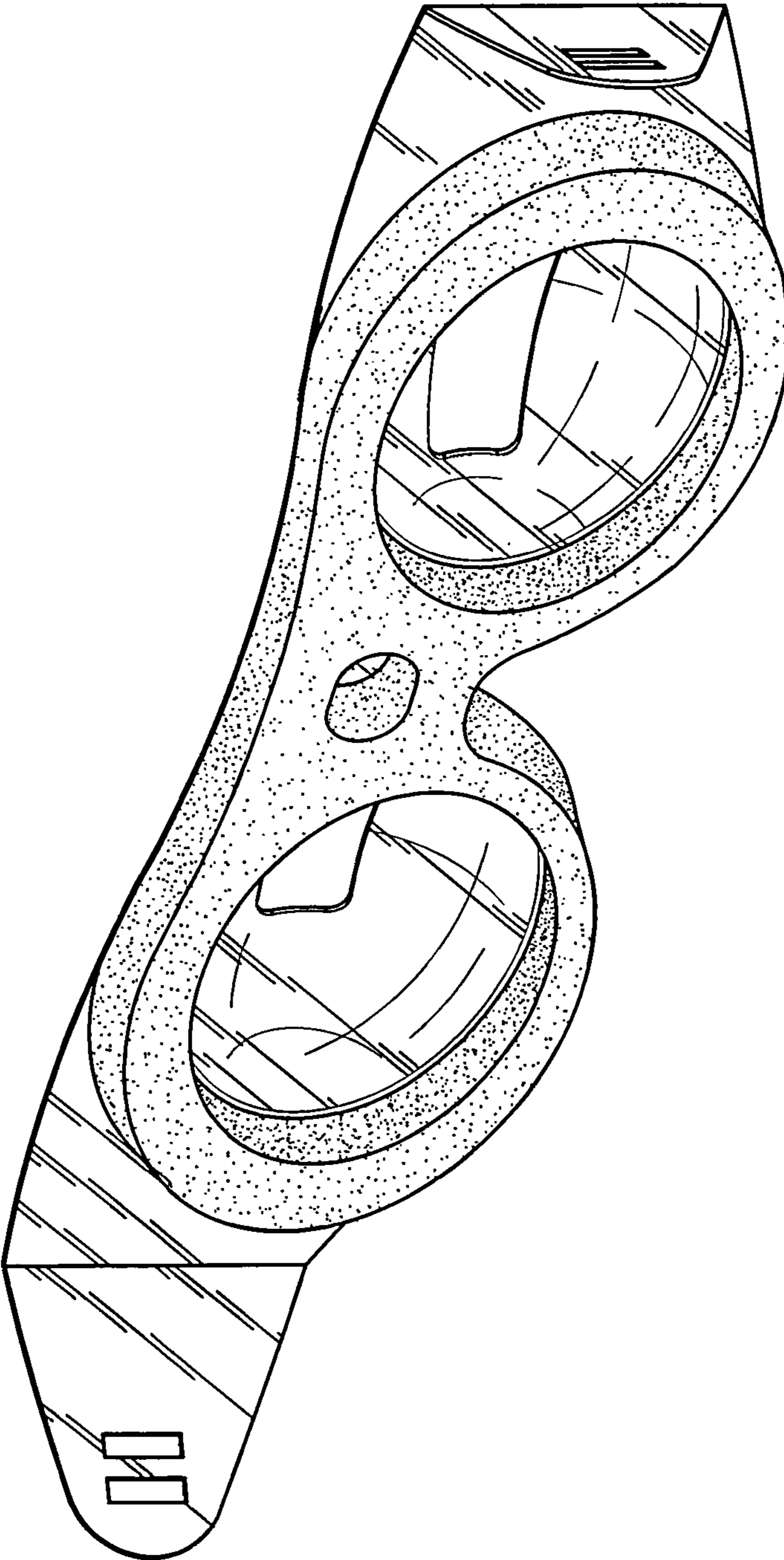
