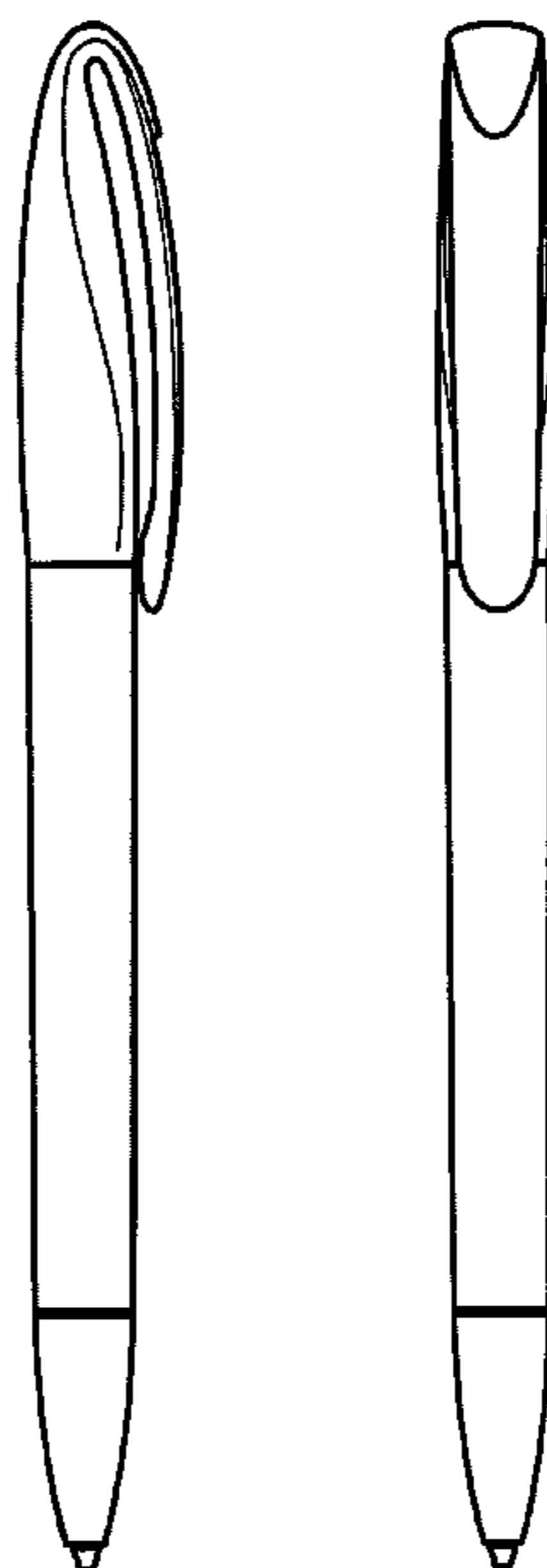
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a left side elevation view of a ballpoint pen in accordance with my design

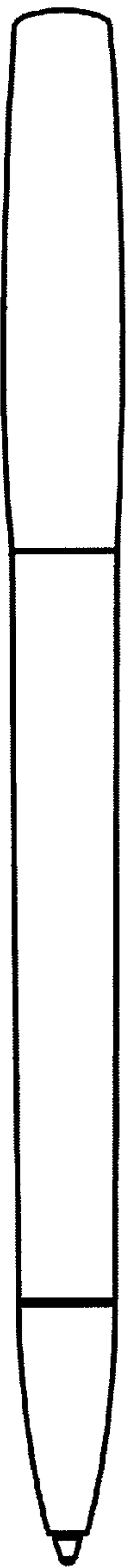

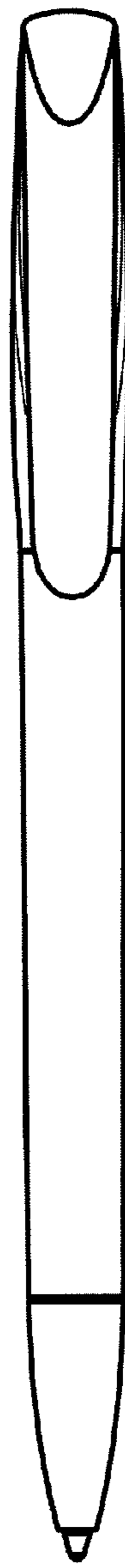

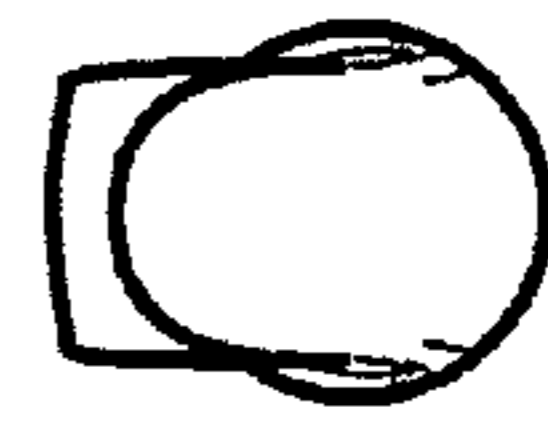

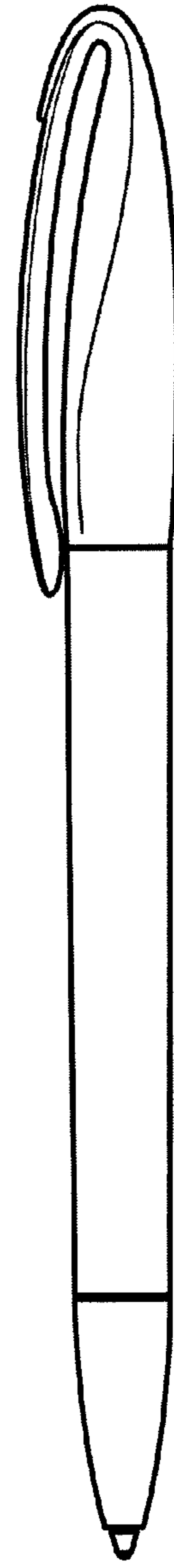

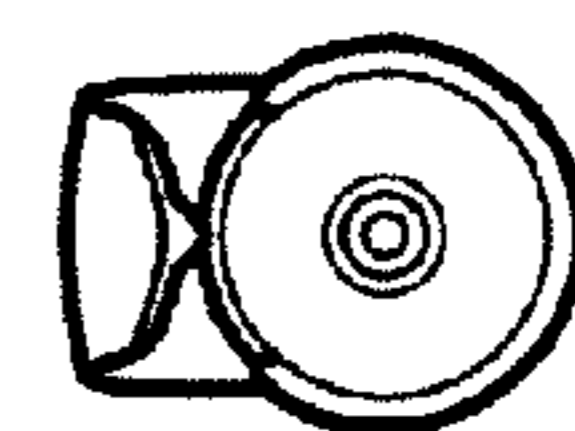

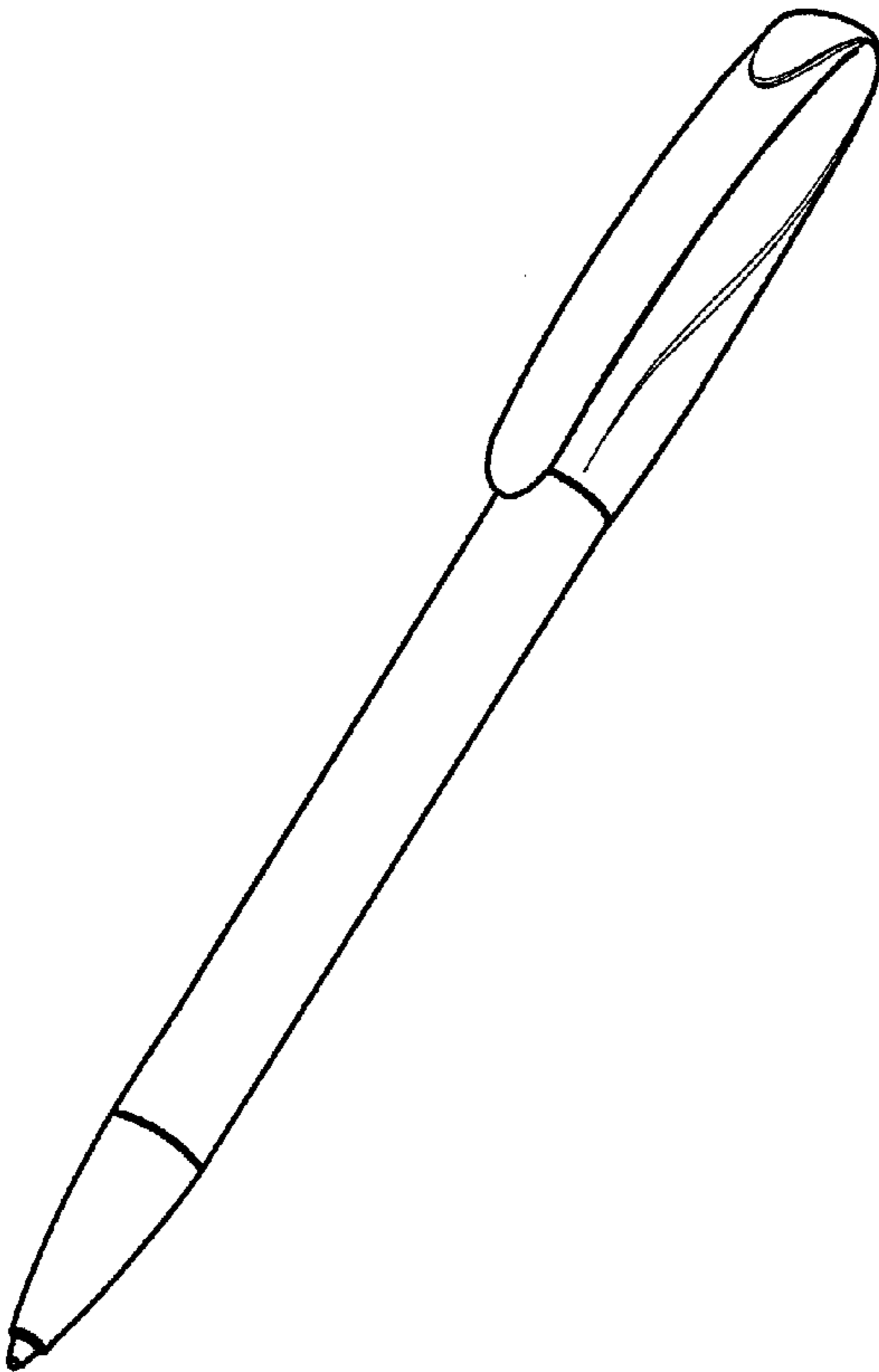

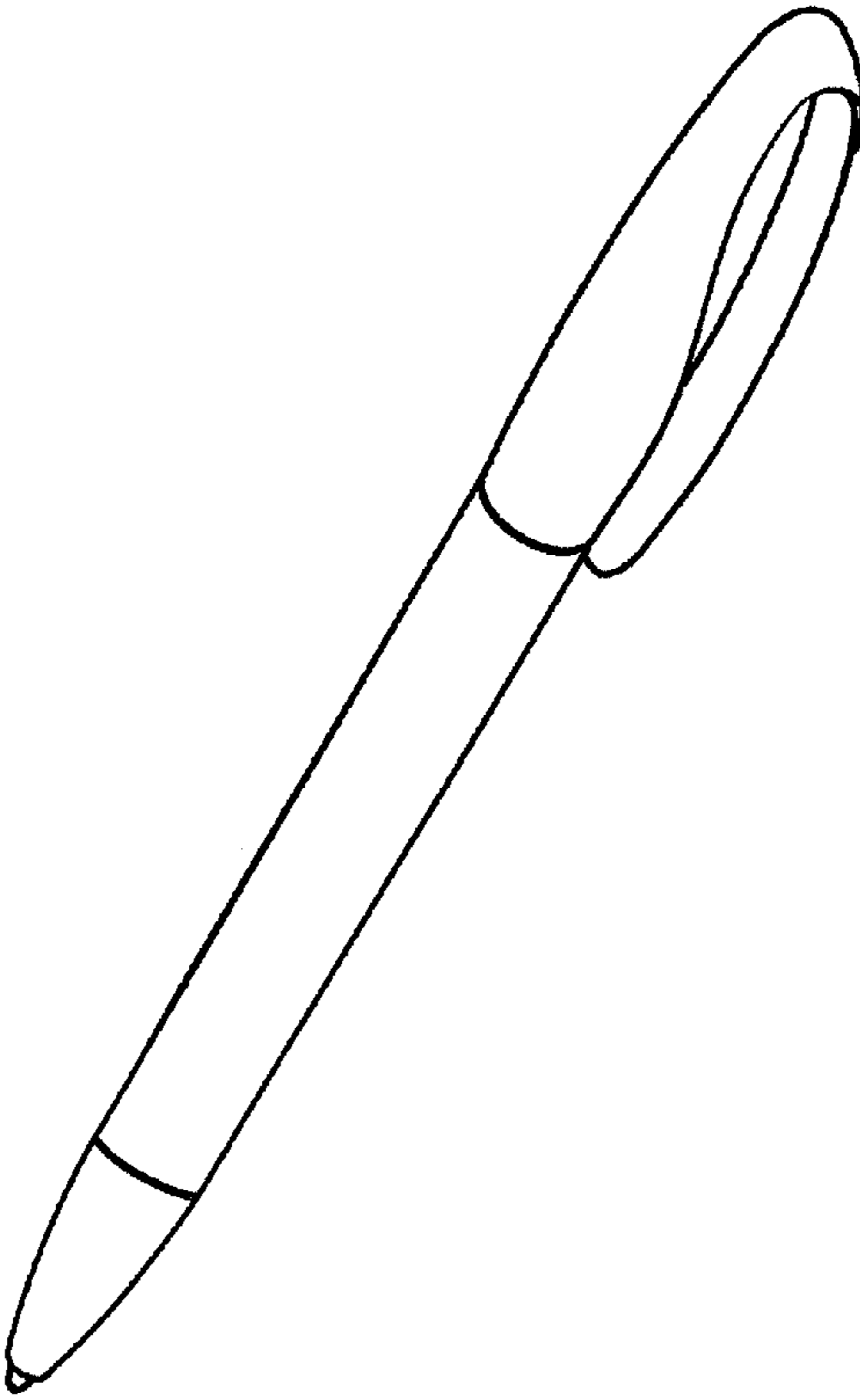
